PRECAUTIONARY MEASURES FOR ANNUAL GENERAL MEETING

In view of the ongoing COVID-19 pandemic and recent requirements for prevention and control of its spread, the Company will implement the following preventive measures at the Annual General Meeting to protect attending Shareholders, staff and other stakeholders from the risk of infection:

- (i) Compulsory body temperature checks will be conducted on every Shareholder, proxy and other attendee at the entrance of the Annual General Meeting venue. Any person with a body temperature of over 37.4 degrees Celsius, or is exhibiting flu-like symptoms may be denied entry into the Annual General Meeting venue and be required to leave the Annual General Meeting venue.
- (ii) Every attendee will be required to wear surgical face masks throughout the Annual General Meeting and sit at a safe distance from other attendees. Please note that no masks will be provided at the Annual General Meeting venue and attendees should bring and wear their own masks.
- (iii) No refreshment will be provided and no distribution of gift at the Annual General Meeting.

To the extent permitted under law, the Company reserves the right to deny entry into the Annual General Meeting venue or require any person to leave the Annual General Meeting venue in order to ensure the safety of the attendees at the Annual General Meeting.

In the interest of all stakeholders' health and safety and consistent with recent COVID-19 guidelines for prevention and control, the Company reminds all Shareholders that physical attendance in person at the Annual General Meeting is not necessary for the purpose of exercising voting rights. As an alternative, by using proxy forms with voting instructions inserted, Shareholders may appoint the Chairman of the Annual General Meeting as their proxy to vote on the relevant resolutions at the Annual General Meeting instead of attending the Annual General Meeting in person.

**PROPOSALS FOR
RE-ELECTION OF DIRECTORS AND
GENERAL MANDATES TO BUY BACK SHARES
AND TO ISSUE NEW SHARES**

1. INTRODUCTION

The purpose of this circular is to provide the Shareholders with information in respect of certain resolutions to be proposed at the Annual General Meeting for, among others, (i) the re-election of Directors; and (ii) the granting to the Directors of the Share Buy-back Mandate and the Issue Mandate to buy back Shares and to issue new Shares, respectively.

LETTER FROM THE BOARD

2. PROPOSED RE-ELECTION OF DIRECTORS

Pursuant to Article 105(A) of the Articles of Association, one-third of the Directors shall retire from office by rotation at each annual general meeting of the Company and every Director shall be subject to retirement by rotation at least once every three years. Mr. Wu Zhanjiang, Mr. Wang Dongbin and Mr. Wu Hongyuan shall retire from office by rotation at the Annual General Meeting and, being eligible, offer themselves for re-election as Directors at the Annual General Meeting.

Details of the Directors proposed for re-election at the Annual General Meeting are set out in Appendix I to this circular. The re-election of these retiring Directors will be individually voted on by the Shareholders.

Pursuant to code provision A.5.5 of the Corporate Governance Code and Corporate Governance Report in Appendix 14 of the Listing Rules, where the board proposes a resolution to elect an individual as an independent non-executive director at the general meeting, it should set out in the circular (among others): (i) the process used for identifying the individual and why the board believes the individual should be elected and the reasons why it considers the individual to be independent; (ii) the perspectives, skills and experience that the individual can bring to the board; and (iii) how the individual contributes to diversity of the board.

In reviewing the structure, size and composition of the Board and in proposing individuals for re-election as Directors at the Annual General Meeting, the Nomination Committee considered the Board diversity from a number of factors, including but not limited to gender, age, cultural and educational background, professional and industry experience, skills, knowledge and time commitments. All Board appointments will be based on merit, and candidates will be considered against criteria including character and integrity, skills and experience as may be necessary for the operation of the Board as a whole, with a view to maintaining a sound balance of the Board's composition.

The Nomination Committee has reviewed the structure and composition of the Board, the confirmations and disclosures given by the Directors, the qualifications, skills and experience, time commitment and contribution of the retiring Directors with reference to the nomination principles and criteria set out in the Company's Board Diversity Policy and Director Nomination Policy and the Company's corporate strategy. The Nomination Committee has recommended to the Board on re-election of all the retiring Directors.

Separate ordinary resolution relating to the re-election of each retiring Director will be proposed at the Annual General Meeting for Shareholders' consideration and approval.

Details of the Directors proposed to be re-elected at the Annual General Meeting are set out in Appendix I to this circular.

3. PROPOSED GRANTING OF GENERAL MANDATES TO BUY BACK AND ISSUE SHARES

In order to give the Company the flexibility to buy back and issue Shares if and when appropriate, the following ordinary resolutions will be proposed at the Annual General Meeting to approve:

- (a) the granting of the Share Buy-back Mandate to the Directors to buy back Shares on the Stock Exchange of not exceeding 10% of the number of issued shares of the Company as at the date of the passing of the proposed ordinary resolution contained in item 4 of the notice of the Annual General Meeting as set out on pages 16 to 19 of this circular (i.e. equivalent to 50,392,718 Shares on the basis that the issued share capital of the Company remains unchanged on the date of the Annual General Meeting);
- (b) the granting of the Issue Mandate to the Directors to allot, issue and deal with additional Shares of not exceeding 20% of the number of issued shares of the Company as at the date of the passing of the proposed ordinary resolution contained in item 5 of the notice of the Annual General Meeting as set out on pages 16 to 19 of this circular (i.e. equivalent to 100,785,435 Shares on the basis that the issued share capital of the Company remains unchanged on the date of the Annual General Meeting); and
- (c) the extension of the Issue Mandate by adding the aggregate number of issued shares bought back by the Company pursuant to the Share Buy-back Mandate.

With reference to the Share Buy-back Mandate and the Issue Mandate, the Directors wish to state that they have no immediate plan to buy back any Shares or issue any new Shares pursuant thereto.

An explanatory statement required by the Listing Rules to provide the Shareholders with requisite information reasonably necessary for them to make an informed decision on whether to vote for or against the granting of the Share Buy-back Mandate is set out in Appendix II to this circular.

4. ANNUAL GENERAL MEETING AND PROXY ARRANGEMENT

The notice of the Annual General Meeting is set out on pages 16 to 19 of this circular.

Pursuant to Rule 13.39(4) of the Listing Rules and Article 72(A) of the Articles of Association, any vote of Shareholders at a general meeting must be taken by poll except where the chairman, in good faith, decides to allow a resolution which relates purely to a procedural or administrative matter to be voted on by a show of hands. An announcement on the poll vote results will be published by the Company after the Annual General Meeting in the manner prescribed under Rule 13.39(5) of the Listing Rules.

Whether or not Shareholders are able to attend and vote at the Annual General Meeting, the form of proxy must be completed and signed in accordance with the instructions printed thereon and deposited, together with the power of attorney or other authority (if any) under which it is signed or a certified copy of that power of attorney or authority at the Company's branch share registrar in Hong Kong, Tricor Investor Services Limited, at Level 54, Hopewell Centre, 183 Queen's Road East, Hong Kong as soon as possible but in any event not later than 10:00 am on Tuesday, 14 September 2021 (Hong Kong time). Completion and delivery of the form of proxy as instructed will not preclude you from attending and voting at the Annual General Meeting if you so wish.

5. RESPONSIBILITY STATEMENT

This circular, for which the Directors collectively and individually accept full responsibility, includes particulars given in compliance with the Listing Rules for the purpose of giving information with regard to the Company. The Directors, having made all reasonable enquiries, confirm that to the best of their knowledge and belief, the information contained in this circular is accurate and complete in all material respects and not misleading or deceptive, and there are no other matters the omission of which would make any statement herein or this circular misleading.

6. RECOMMENDATION

The Directors consider that the proposed resolutions as set out in the notice of the Annual General Meeting are in the best interests of the Company and the Shareholders as a whole. Accordingly, the Directors recommend the Shareholders to vote in favour of all the resolutions to be proposed at the Annual General Meeting.

The following are details of the Directors who are proposed to be re-elected at the Annual General Meeting.

(1) Mr. Wu Zhanjiang

Mr. WU Zhanjiang (“Mr. Wu”), aged 52, is a founder of the Group, Chief Executive Officer and executive Director of the Company. Mr. Wu is primarily responsible for technological research and development and commercial application of the Group’s smart city IoT and smart energy IoT businesses.

Experience

Mr. Wu graduated from North China Electric Power University and obtained a master’s degree in Automation of Electric Power System in March 1996. In 2015, Mr. Wu graduated from China Europe International Business School and obtained EMBA certificate.

Mr. Wu has over 20 years of experience in the electric power industry in the PRC and has accumulated abundant experience in technological research and development and commercial application of smart city IoT and smart energy IoT related areas. Mr. Wu started his career as a teaching staff in the North China Electric Power University between July 1996 and January 1999.

In May 2011, Mr. Wu founded 北京愛朗格瑞科技有限公司 (Beijing Along Grid Technology Company Limited*) through 北京艾格瑞德科技有限公司 (Beijing iGrid Technology Company Limited*), together with Mr. Wang Dongbin, Mr. Li Kangying and Mr. Cao Wei to engage in the sale of Software Systems for electric power grid companies and electric power distribution companies in the PRC. As at the Latest Practicable Date, Mr. Wu was a director of UNION SINO HOLDINGS LIMITED (“UNION SINO”), an immediate parent of the Group, 北京艾普智城網絡科技有限公司 (Beijing iPole Smart City Internet Technology Company Limited*) and 北京愛朗格瑞科技有限公司 (Beijing Along Grid Technology Company Limited*), wholly-owned subsidiaries of the Group.

Length of service and emoluments

Mr. Wu has entered into a service contract with the Company pursuant to which Mr. Wu agreed to act as executive Director for an initial term of three years with effect from 24 July 2018, subject to re-election at general meetings in accordance with the Company’s Articles of Association. The term of service shall be renewed and extended automatically by one year on the expiry of such initial term and on the expiry of every successive period of one year thereafter, unless either party has given at least three months’ written notice of non-renewal before the expiry of the then existing term. Besides, Mr. Wu has been appointed as Chief Executive Officer of the Company on 1 June 2019 and has entered into a new service contract with the Company, pursuant to which Mr. Wu agreed to act as Chief Executive Officer for a term of three years with effect from the 1 June 2019.

Mr. Wu is entitled to a basic salary of HK\$360,000 per annum (subject to an annual increment at the discretion of the Directors of not more than 5% of the annual salary immediately prior to such increase). In addition, Mr. Wu is also entitled to a discretionary

management bonus provided that the aggregate amount of the bonuses payable to all the executive Directors for any financial year of the Company may not exceed 10% of the audited consolidated net profit of the Group (after taxation and minority interests and payment of such bonuses but before extraordinary items) in respect of that financial year of the Company.

Relationships

Save as disclosed above, Mr. Wu did not hold any other directorship in other listed public companies in Hong Kong or overseas in the last three years, and Mr. Wu is not related to any Directors, senior management, other substantial or controlling Shareholders (as defined in the Listing Rules) of the Company, nor does Mr. Wu hold any other positions with the Company or any of its subsidiaries.

Interests in Shares

As at the Latest Practicable Date, Mr. Wu was beneficially interested in 60,000,000 Shares within the meaning of Part XV of the SFO, all of which were held by UNION SINO. Mr. Wu is the sole shareholder of UNION SINO. Mr. Wu had other interest in 1,000,000 Shares, representing the underlying Shares under the options granted by the Company on 30 July 2018 pursuant to the share option scheme adopted by the Company on 5 February 2018. Save as disclosed above, Mr. Wu did not have any interest in the Shares or underlying Shares within the meaning of Part XV of the SFO as at the Latest Practicable Date.

Matters that need to be brought to the attention of the Shareholders

There is no information that needs to be disclosed pursuant to any of the requirements of the provisions under Rules 13.51(2)(h) to 13.51(2)(v) of the Listing Rules, and there are no other matters concerning Mr. Wu that need to be brought to the attention of the Shareholders.

(2) Mr. Wang Dongbin

Mr. Wang Dongbin (“Mr. Wang”), aged 53, is a founder of the Group, the chairman and executive Director of the Company. Mr. Wang is also the chairman of Nomination Committee and a member of Remuneration Committee of the Company. He is primarily responsible for the overall business corporate strategies planning and development of our Group.

Experience

Mr. Wang obtained a bachelor’s degree in modern physics application from Tsinghua University in the PRC in July 1990. He obtained a master’s degree in nuclear physics from Tsinghua University in July 1992.

Mr. Wang has over 20 years of experience in the information technology industry. Prior to founding of the Group, Mr. Wang started his career in the industry when he was first employed as a technical director by Beijing Teletron Internet Technology Company Ltd. between May 1996

and June 2001. He then joined Becom Software Co, Ltd. as the general manager between July 2001 and April 2008. Between May 2008 and July 2012, he was the executive director and the general manager of Beijing Jietong Yishin Technology Development Company Limited. Through his industry-related working experience, Mr. Wang has accumulated industry knowledge and market understanding for the information technology related industry.

As at the Latest Practicable Date, Mr. Wang was a director of Smart East Limited (“Smart East”), an immediate parent of the Group and Chairman of 北京愛朗格瑞科技有限公司 (Beijing Along Grid Technology Company Limited*), a wholly-owned subsidiary of the Company.

Length of service and emoluments

Mr. Wang has entered into a service contract with the Company pursuant to which Mr. Wang agreed to act as executive Director for a term of three years with effect from 21 June 2019, subject to re-election at general meetings in accordance with the Company’s Articles of Association. The term of service shall be renewed and extended automatically by one year on the expiry of such initial term and on the expiry of every successive period of one year thereafter, unless either party has given at least three months’ written notice of non-renewal before the expiry of the then existing term.

Mr. Wang is entitled to an annual remuneration of HK\$360,000 (subject to an annual increment at the discretion of the Directors of not more than 5% of the annual salary immediately prior to such increase). In addition, Mr. Wang is also entitled to a discretionary management bonus provided that the aggregate amount of the bonuses payable to all the executive Directors for any financial year of the Company may not exceed 10% of the audited consolidated net profit of the Group (after taxation and minority interests and payment of such bonuses but before extraordinary items) in respect of that financial year of the Company.

Relationships

Save as disclosed above, Mr. Wang did not hold any other directorship in other listed public companies in Hong Kong or overseas in the last three years, and Mr. Wang is not related to any Directors, senior management, other substantial or controlling Shareholders (as defined in the Listing Rules) of the Company, nor does Mr. Wang hold any other positions with the Company or any of its subsidiaries.

Interests in Shares

As at the Latest Practicable Date, Mr. Wang was beneficially interested in 60,000,000 Shares within the meaning of Part XV of the SFO, all of which were held by Smart East. Mr. Wang is the sole shareholder and sole director of Smart East. Mr. Wang had other interest in 1,000,000 Shares, representing the underlying Shares under the options granted by the Company on 30 July 2018 pursuant to the share option scheme adopted by the Company on 5 February 2018. Save as disclosed above, Mr. Wang did not have any interest in the Shares or underlying Shares within the meaning of Part XV of the SFO as at the Latest Practicable Date.

Matters that need to be brought to the attention of the Shareholders

There is no information that needs to be disclosed pursuant to any of the requirements of the provisions under Rules 13.51(2)(h) to 13.51(2)(v) of the Listing Rules, and there are no other matters concerning Mr. Wang that need to be brought to the attention of the Shareholders.

(3) Mr. Wu Hongyuan

Mr. Wu Hongyuan (“Mr. Wu”), aged 48, is the Executive President of the Group and Executive Director of the Company. Mr. Wu was the Chief Executive Officer of the Company and he was re-designated as the Executive President of the Company on 1 June 2019 due to strategic planning. He is primarily responsible for and focus on the operation and management of the Group’s IoT.

Experience

Mr. Wu joined the Group in December 2011 as the general manager of research and development and customer service department of Beijing Along Grid Technology Co., Ltd and was promoted to the general manager in April 2014. Mr. Wu graduated from Beijing Electricity College (being incorporated into the Beijing Jiaotong University in 2000) in the PRC in July 1994, majoring in electricity system communication.

Mr. Wu has over 20 years of experience in the electric power selling and management system industry. Prior to joining of our Group, he started his career as a teaching staff in the information engineering department of North China Electric Power University between July 1994 and October 2007. He was then employed by the Beijing Puhua Yalong Technology Company Limited as the deputy general manager between November 2007 and December 2011.

Length of service and emoluments

Mr. Wu has been re-designated as Executive President of the Company on 1 June 2019 and has re-entered into a new service contract with the Company, pursuant to which Mr. Wu agreed to act as executive president for a term of three years with effect from the 1 June 2019, subject to re-election at general meetings in accordance with the Company’s Articles of Association. The term of service shall be renewed and extended automatically by one year on the expiry of such initial term and on the expiry of every successive period of one year thereafter, unless either party has given at least three months’ written notice of non-renewal before the expiry of the then existing term.

Mr. Wu is entitled to an annual remuneration of HK\$360,000 (subject to an annual increment at the discretion of the Directors of not more than 5% of the annual salary immediately prior to such increase). In addition, Mr. Wu is also entitled to a discretionary management bonus provided that the aggregate amount of the bonuses payable to all the executive Directors for any financial year of the Company may not exceed 10% of the audited consolidated net profit of the Group (after taxation and minority interests and payment of such bonuses but before extraordinary items) in respect of that financial year of the Company.

Relationships

Mr. Wu did not hold any directorship in other listed public companies in Hong Kong or overseas in the last three years, and Mr. Wu is not related to any Directors, senior management, other substantial or controlling Shareholders (as defined in the Listing Rules) of the Company. Save as disclosed above, Mr. Wu did not hold any other positions with the Company or any of its subsidiaries.

Interests in Shares

As at the Latest Practicable Date, Mr. Wu was deemed under the SFO to be interested in 1,200,000 Shares, representing the underlying Shares under the options granted by the Company on 30 July 2018 pursuant to the share option scheme adopted by the Company on 5 February 2018. Save as disclosed above, Mr. Wu did not have any interest in the Shares or underlying Shares within the meaning of Part XV of the SFO as at the Latest Practicable Date.

Matters that need to be brought to the attention of the Shareholders

There is no information that needs to be disclosed pursuant to any of the requirements of the provisions under Rules 13.51(2)(h) to 13.51(2)(v) of the Listing Rules, and there are no other matters concerning Mr. Wu that need to be brought to the attention of the Shareholders.

The following is an explanatory statement required by the Listing Rules to provide the Shareholders with requisite information reasonably necessary for them to make an informed decision on whether to vote for or against the ordinary resolution to be proposed at the Annual General Meeting in relation to the granting of the Share Buy-back Mandate.

1. SHARE CAPITAL

As at the Latest Practicable Date, the issued share capital of the Company comprised 503,927,177 Shares.

Subject to the passing of the ordinary resolution set out in item 4 of the notice of the Annual General Meeting in respect of the granting of the Share Buy-back Mandate and on the basis that the issued share capital of the Company remains unchanged on the date of the Annual General Meeting, i.e. being 503,927,177 Shares, the Directors would be authorized under the Share Buy-back Mandate to buy back, during the period in which the Share Buy-back Mandate remains in force (equivalent to 50,392,718 Shares, representing 10% of the number of issued shares of the Company as at the date of the Annual General Meeting).

2. REASONS FOR BUY-BACK OF SHARES

The Directors believe that the granting of the Share Buy-back Mandate is in the best interests of the Company and the Shareholders as a whole.

Buy-back of Shares may, depending on the market conditions and funding arrangements at the time, lead to an enhancement of the net asset value per Share and/or earnings per Share and will only be made when the Directors believe that such a buy-back will benefit the Company and the Shareholders as a whole.

3. FUNDING OF BUY-BACK

In buying back Shares, the Company will only apply funds legally available for such purpose in accordance with its Articles of Association and the laws of the Cayman Islands which is ensured by internal resources of the Group.

4. IMPACT OF BUY-BACK

There might be a material adverse impact on the working capital or gearing position of the Company (as compared with the position disclosed in the audited consolidated financial statements of the Company for the year ended 31 March 2021) in the event that the Share Buy-back Mandate was to be carried out in full at any time during the proposed buy-back period. However, the Directors do not intend to exercise the Share Buy-back Mandate to such extent as would, in the circumstances, have a material adverse effect on the working capital requirements of the Company or the gearing levels which in the opinion of the Directors are from time to time appropriate for the Company.

6. DIRECTORS, THEIR CLOSE ASSOCIATES AND CORE CONNECTED PERSONS
