To be valid, this form of proxy together with the power of attorney or other authority (if any) under which it is signed, or a certified copy thereof, must be deposited at the Company's Hong Kong branch share registrar, Tricor Investor Services Limited, at Level 54, Hopewell Centre, 183 Queen's Road East, Hong Kong not less than 48 hours before the time appointed for holding the Meeting or adjournment thereof.
- 8. The proxy need not be a member of the Company but must attend the Meeting in person to represent you.
- 9. Completion and delivery of this form of proxy will not preclude you from attending and voting at the Meeting if you so wish and, in such event, this form of proxy shall be deemed to be revoked.

Shareholders are strongly encouraged to note the COVID-19 precautionary measures and special arrangements to be implemented at the 2021 AGM which are set out in the cover page and the section headed under "Precautionary Measures for the Annual General Meeting" in the Company's circular dated 27 July 2021 and that NO gifts, beverage and refreshments will be provided.
