#### **CHANGE OF COMPANY NAME**

The Board is pleased to announce that the English name of the Company has been changed to “Net-a-Go Technology Company Limited” and “網譽科技有限公司” has been adopted as the new dual foreign name of the Company.

#### **CHANGE OF STOCK SHORT NAME**

The stock short name for trading in the Shares on the Stock Exchange will be changed from “U BANQUET GP” to “NET-A-GO TECH” in English and from “譽宴集團” to “網譽科技” in Chinese with effect from 9:00 a.m. on 13 August 2021. The stock code of the Company remains unchanged as “1483”.

Reference is made to the announcement dated 12 April 2021 and the circular (the “**Circular**”) dated 7 May 2021 of U Banquet Group Holding Limited (now known as Net-a-Go Technology Company Limited) (the “**Company**”) in relation to the proposed change of the name of the Company (the “**Change of Company Name**”). Unless the context requires otherwise, capitalised terms used herein shall have the same meanings as defined in the Circular.

## **CHANGE OF COMPANY NAME**

The Board is pleased to announce that the English name of the Company has been changed to “Net-a-Go Technology Company Limited” and “網譽科技有限公司” has been adopted as the new dual foreign name of the Company.

Subsequent to the passing of a special resolution in relation to the Change of Company Name by the Shareholders at the AGM held on 16 June 2021, the Certificate of Incorporation on Change of Name was issued by the Registrar of Companies in the Cayman Islands on 18 June 2021 certifying that the Company has changed its name to “Net-a-Go Technology Company Limited 網譽科技有限公司”.

The Certificate of Registration of Alteration of Name of Registered Non-Hong Kong Company was issued by the Registrar of Companies in Hong Kong on 6 August 2021 certifying that the new English name and the new dual foreign name in Chinese of the Company have been registered in Hong Kong under Part 16 of the Companies Ordinance (Chapter 622 of the Laws of Hong Kong).

## **CHANGE OF STOCK SHORT NAME**

Following the Change of Company Name becoming effective, the stock short name for trading in the Shares on the Stock Exchange will be changed from “U BANQUET GP” to “NET-A-GO TECH” in English and from “譽宴集團” to “網譽科技” in Chinese with effect from 9:00 a.m. on 13 August 2021. The stock code of the Company remains unchanged as “1483”.
