CEO'S STATEMENT 行政總裁的聲明

Dear Shareholders,

Over the past year and a half of living with the persistent COVID-19 pandemic, many business and social practices have changed dramatically, which have now emerged as the “new normal”. These are undoubtedly unprecedented times – a combination of global economic uncertainty, coupled with the impact of the COVID-19 pandemic. Many enterprises have had to address how to do business with customers who avoid crowded venues, or have changed their activities to outdoor or online, and have now settled in to the new methods of business-customer interaction that many of us have now become accustomed to. Vongroup upholds the belief that we must consistently deliver a “stable” of reliable, top-notch “technology-for-business” services and solutions that address this “new normal”, both in Hong Kong and regionally outside Hong Kong.

During the past 14 years since 2007, Vongroup has refined and developed our main business as a “technology service and solutions provider” under this dynamic environment that focuses primarily on “technology-for-business”, notably services relating to fintech, ecommerce, online payment, cloud technology and enterprise solutions. This now extends to Vongroup operating our business that provides services in relation to enterprise architecture, technology transformation, custom platforms and solutions, including transformational “new normal” solutions, such as virtual reality (VR) and augmented reality (AR) technologies for the COVID-19 pandemic and expected post-pandemic era, which endeavour to support our enterprise customers as they adjust to doing business in more remote and online ways. Our diversified client base in Hong Kong, and regionally in Mainland China, South Korea, Japan, Macau, and Southeast Asia, amongst others, has demonstrated to us that there is significant demand for our “technology-for-business” services and solutions. We are proud that our clients range from SMEs to international businesses. These include businesses that are involved in financial services, wealth management, ecommerce, education, media and entertainment industries, amongst others.

It is inherent in the nature of this sector that new and emerging technologies are continually developed in the market for business performance enhancement, and therefore the nature of our business is that we continually add to our service and solutions offerings. Each new or emerging technology that we deploy or acquire is not a new business, but is the next step in the continuing upgrade or enhancement of our “stable” of offerings that is expected to improve our ability to generate more revenue and profits. Likewise, although we have been focusing on addressing the significant client demand in the face of the “new normal”, as anything to do with the pandemic is new to everybody and every business, nevertheless, the business-driven technology skill sets that we deploy are not new. We have been doing so zealously, and we intend to continue to do so to grow our presence in Hong Kong and also expand regionally outside Hong Kong.

Vongroup has met the surge in demand for technology to address business needs, by focusing on being one of Hong Kong's fastest-growing technology services and solutions providers, and by helping clients execute their digital transformation that has already increasingly become an essential part in the “new normal” of the COVID pandemic and the expected post-pandemic era. A 2020 McKinsey survey shows that, to address the “new normal”, “companies have accelerated the digitization of their customer and supply-chain interactions and of their internal operations by three to four years”. Our services and solutions enable our enterprise clients to continue to do business in newer ways and efficiently, as business and market behaviour has changed towards distance, remote and virtual, and which we expect will continue to change.

I am pleased to report that Vongroup has delivered significantly improved performance, especially in our Technology business, for the year ended 30 April 2021. There were two major reasons for the Group's substantial improvement in business:

- (1) Our Technology revenue increased significantly from HK\$30.7 million to HK\$107.2 million, a 249% increase as compared with last year.
- (2) Our Technology profit also increased significantly from HK\$23.9 million to HK\$36.6 million, a 53% increase as compared with last year.

Driven mainly by these two reasons, the Group recorded profit before tax for the year of HK\$21.8 million, and total comprehensive income for the year of HK\$22.3 million, reflecting 120% and 159% growth, respectively, as compared with last year.

親愛的股東，

在過去與反復出現的新冠病毒疫情大流行共存的一年半，許多商業及社交行為發生了巨大變化，成為「新常態」。這無疑是前所未有的時代－全球經濟的不確定性，加上新冠疫情的影響。許多企業必須解決如何與避免擁擠場地的客戶開展業務，或者將其業務活動改為戶外或線上，以及現在已適應我們許多人現在習慣的企業與客戶互動的新方法。黃河實業堅信，無論是在香港還是在香港以外地區，我們必須始終如一提供「穩定」可靠、一流的「商業科技」服務及解決方案，以應對這一「新常態」。

自2007年以來的14年中，黃河實業在這種動態環境下將我們的主要業務改進和發展為「科技服務和解決方案服務商」，主要專注於「商業科技」，尤其是與金融科技、電子商務、在線支付、雲端科技和企業解決方案有關的服務。這現在擴展到黃河實業可運營提供有關企業架構、科技轉型、自訂平台和解決方案有關服務的業務，包括虛擬實境(VR)和擴增實境(AR)科技等「新常態」解決方案的轉換，以應對新冠疫情及預期的後疫情時代，努力支持我們的企業客戶適應以更多遠程及在線方式開展業務。我們在香港及中國大陸、南韓、日本、澳門及東南亞等地的多元化客戶群證實，對這類「商業科技」的服務及解決方案有重大需求。我們引以自豪的是，我們的客戶範圍從中小企業到國際企業。其中包括金融服務、財富管理、電子商務、教育、媒體和娛樂等行業。

在提高業務績效的市場中不斷開發新的和新興的科術是我們科技業務的根本，因此，我們一直不斷增添我們的服務和解決方案產品。我們新增或收購的每項新科技或新興科技都不是全新之業務，而是我們將「穩定」的產品不斷升級或提升的最新版本，預計將提高我們的績效，為我們創造更多收入和利潤的能力。同樣，面對「新常態」，專注於解決客戶大量的新需求，因為與新冠病毒疫情大流行出現的個人和企業需求都是新的，但我們的商業為本的科技能力卻並不新的。我們一直殷切地經營，並打算繼續努力，擴大我們在香港和香港以外地區的業務。

為解決業務需要，黃河實業滿足了激增的科技需求，專注於成為香港發展最快的科技服務及解決方案服務商之一，並協助客戶進行數碼轉型，而數碼轉型已日益成為新冠病毒疫情大流行和預期大流行後時代「新常態」的重要組成部分。2020年麥肯錫的一項調查顯示，為了解決「新常態」，「公司已經將客戶和供應鏈互動以及內部運營的數位化速度加快了三到四年」。我們的服務和解決方案使我們的企業客戶能夠繼續以更新的方式和更高效率的科技開展業務，因為業務和市場行為已轉向遙距、遠端和虛擬，並且我們預期將繼續發生變化。

本人欣然報告，黃河實業於截至二零二一年四月三十日止年度的業績顯著改善，特別是我們的科技業務。集團業務顯著改善的主要原因有兩個：

- (1) 我們的科技收入由30,700,000港元大幅增長至107,200,000港元，與去年相比增長了249%。
- (2) 我們的科技利潤亦由23,900,000港元增加至36,600,000港元，與去年相比增長了53%。

受以上兩個因素的推動，本集團於本年度錄得除稅前溢利21,800,000港元，而本年度錄得全面收益總額22,300,000港元，分別較去年增長120%及159%。

Our “technology-for-business” business growth to meet client demands to transform in the pandemic and post-pandemic era

Over the past year, the Group has further strengthened our market position in providing one-stop technology service and solution that covers enterprise architecture, technology advisory, enterprise solutions and fully-managed IT services businesses. Not only have we achieved accelerated growth in different indicators including order number, sales turnover, repeat business, and the development of sales channels and strategic partnerships, we have also gained customer loyalty and recognition in the technology market for our innovation and success.

We will expect to continue to solidify our technology-for-business industry research capabilities and knowledge, particularly with a view to understanding businesses' commercial and performance needs, and then identifying or developing software and other technological tools that enhance our ability to execute projects for them. We anticipate that this would lead our entry into newer client industries, and newer technologies to enable their commercial needs.

For many of our projects, we have witnessed how our industry market research and understanding have differentiated us from our competitors, have positioned us well for winning cannot-fail projects amidst an ever-evolving technology environment, and have therefore broadened our client coverage to many industries. This is one important differentiation between our convergence of technology-and-business expertise, and many other providers who focus on the traditional delivery of technology.

According to a 2016 Innatas survey, half of the enterprises surveyed admitted that they focus on delivering a technology project on time, rather than on how to maximise business value from it. The Innatas survey also highlighted that the problem of not being able to align business goals with technology goals has led to a 55% failure to meet business needs. In fact, frequently, a client's technology architecture may have evolved chaotically. This means that changes may have been applied sporadically over a period of time, and on different levels. While their systems may be technologically sound and may have been delivered on time, they may either lack sufficient business evaluation or lack maximized connection with one another, or both. And after running into a problem, managers may, very naturally, decide to apply their own skills in an ad hoc way to improve the situation at hand. Many of these managers may not have adequate technical knowledge while the technology professionals may lack knowledge or appreciation of these business considerations.

This is the current position that we frequently see in many of our clients, and we will continue with our strategy that, in contrast with many others, focuses on blended business-and-technology services and solutions so as to address business needs, not just simply doing technology jobs.

Long term business development and competitive strength

The pandemic has been an accelerator for technological change across businesses. And while many companies are still assessing their future plans, what is evident is that many businesses, including ourselves, must become more digitally-driven in the post-pandemic era. It will be the decisive enterprises who enhance their digital systems now and use data analytics to improve how to service the 'new' customer, who are best positioned to stay ahead of the game and be sustainable in the long-term.

This means that we can and must use our current competitive advantage to continue to stay ahead of the pack. The evolution of transformational technology and the availability of data helps us better understand the needs of our customers, while continually beating back the competition.

What are some of our best offence and strongest defence strategies in terms of knowing the needs of our customers, while keeping many of our competitors at a distance? We stress the following:

- Identify and capture pockets of profitable growth
- Expand our offerings of services and solutions
- Differentiate against competitors
- Form partnerships and alliances with leading-edge companies
- Magnify growth through sales channel partnerships
- Make the most of data analytics

我們「商業科技」的業務增長滿足客戶於大流行及大流行後時代的轉型需求

過去一年，集團進一步加強了市場地位，提供涵蓋企業架構、科技諮詢、企業解決方案和全面管理的科技服務業務的一站式科技服務和解決方案。不僅在訂單數量、銷售營業額、回頭業務、銷售渠道和戰略合作夥伴等不同指標均實現了迅速增長，而且憑藉我們的創新和口碑成功建立忠誠的客戶群和贏得市場的認可。

我們將持續鞏固我們對商業科技行業的研究能力和知識，特別是為了瞭解企業的商業和績效需求，而發展或開發的軟件產品和其他技術工具，以提高我們為他們執行專案的能力。這將引導我們進入新的客戶行業，以及以更新的科技技術，滿足他們的商業需求。

於我們的許多業務項目中，我們見證了我們的行業市場研究和理解如何讓我們與競爭對手區別開來，使我們在不斷發展的科技環境中能夠贏得必勝不敗的業務項目，因此我們的客戶範圍擴大到許多行業。這是我們科技與業務專業知識的融合，以及與許多其他專注於傳統技術交付的服務商之間的一個重要區別。

根據2016年Innotas的調查，半數受訪企業承認，他們專注於按時交付科技項目，而不是如何從中實現業務價值最大化。Innotas的調查還強調，無法將業務需求與科技目標結合的問題導致55%的企業無法滿足業務需求。事實上，客戶的科技架構可能經常發生混亂的演變。這意味著變化可能在一段時間內和不同級別上偶爾應用。雖然他們的系統可能在技術上是健全的，而且可能已按時交付，但它們可能缺乏足夠的業務評估，或者彼此之間缺乏最大化的聯繫，或者兩方面的問題兼有。遇到問題後，管理者自然會決定以臨時方式運用自己的科技能力來改善手頭的情況。許多這些管理人員可能沒有足夠的科技知識，而科技專業人員可能缺乏這些業務考慮的知識或認同。

這是我們經常在許多客戶中看到的景況，我們將繼續執行我們的戰略，與其他許多客戶相比，我們專注於混合的業務和科技服務和解決方案，以滿足業務需求，而不僅提供單純的科技服務

長期業務發展及競爭優勢

新冠疫情是整個企業科技變革的加速器。儘管許多公司仍在評估其未來計劃，但顯而易見的是，在後疫情時代，包括我們自己在內的很多企業都必須變得更加數碼化。必須迅速決定並立即增強其數碼系統，並利用數據分析來改善如何為「新」客戶提供服務的企業，將最有能力保持領先地位並長期保持可持續發展。

這意味著我們應該並且必須利用我們當前的競爭優勢來繼續保持領先地位。變革性科技的發展和數據的分析可幫助我們更好地了解客戶的需求，同時不斷擊敗競爭對手。

在了解客戶需求的同時，讓我們的許多競爭對手保持距離的話，我們最好的進攻和最強大的防禦策略有哪些？我們強調以下幾點：

- 找出並抓住有利的增長點
- 擴展我們的服務和解決方案產品
- 與競爭對手區分開
- 與領先公司建立合作夥伴關係和聯盟
- 通過銷售渠道夥伴關係擴大增長
- 充分利用數據分析

Therefore, we are actively negotiating and incorporating a number of advanced and commercially-drive technology services and solutions to add to our “stable”, in order to create further synergy and to generate greater business opportunities for our Group.

Continuing acquisitions and technology additions to boost digital transformation capability

To meet the growing technology needs to address business and social changes, we plan to continue to add to the range of our offerings of business-driven technology services and solutions in order to reinforce our position as one of the preferred “digital ecosystem partners for the new normal”. We aim to brand this as a digital ecosystem of technology services and solutions for distance, remote, work-for-home, learn-from-home, shop-from home, transactional and behavioural changes. This will capitalise upon enterprises that need to re-visit or digitally transform their business operations in light of the “new normal” of consumer and market behaviour resulting from the COVID-19 pandemic and post-pandemic. We will promote our additions to existing clients for repeat business, as well as to new clients.

We add to our range in a number of ways. One example is our acquisition of a controlling interest in Claman Global Limited, which owns the FringeBacker multi-business fintech management platform software. FringeBacker operates technology services and platforms for one of the world's biggest marathons and other major events. We therefore now own a majority interest in this exciting business which has processed transactions for over 200,000 online customers, in order to enhance our platform software offerings. Other examples include (a) strategic operations partnerships, like our solutions services partnership with award-winning web and mobile providers to provide further specialist services in these areas, (b) “joint go to market” partnerships like the one we have entered into with an award-winning mobile marketing technology provider to provide mobile marketing technologies, and (c) “joint self-development” partnership with a leading overseas AR/VR solutions provider to design, develop and launch a pioneering integrated virtual expo/trade show and virtual showroom software.

Looking Ahead

We believe that the calendar year 2020 was the real starting point for the technological transformations that many clients are undergoing or are now assessing, given the COVID-19 pandemic and the expected post-pandemic era. The COVID-19 pandemic has awakened more and more companies, alerting them to pay more attention to distance and virtual technologies, fintech, cloud, etc. Over the past several years of challenges in our technology business, as well as our turnaround to profit a few years ago, Vongroup has evolved into a strong business-and-technology service and solutions provider. And we will continue towards the path of being a digital ecosystem partner for the “new normal”.

In terms of business model, R&D, marketing and promotions, operational strategies, technology systems development, commercial performance indicators fueled by business-oriented technologies, as well as sales channel partnerships, we have accumulated substantial knowledge and experience, which we believe puts us in a competitive advantage versus many traditional IT providers. We believe that this is a time which presents business opportunities for Vongroup to continue to expand and extend, both in Hong Kong and regionally outside Hong Kong.

While the economic outlook in Hong Kong and globally is clouded by the pandemic, trade wars and regional conflict, Vongroup is determined to continue deploying technology and business acumen and expertise, together with creativity and innovation, to support our enterprise customers as they navigate their technology transformations. We will remain tirelessly in discussions for appropriate acquisitions, partnerships and sales channels, that would help boost our revenue, and enhance shareholder value.

At the same time, one of our priorities is to take precautionary measures to safeguard our team members to ensure their safety during the pandemic.

Finally, I would like to sincerely thank all our team members and our sales channel partners and other business associates for their tireless and dedicated work in an extremely challenging year to make this successful year happen.

持續收購及新增科技以促進數碼化轉型能力

為滿足日益增長的科技需求以應對商業和社會的變化，我們計劃繼續增大我們所提供的商業為本的科技服務和解決方案的範圍，以鞏固我們作為客戶首選的「新常态數碼化生態系統合作夥伴」的地位。我們的目標是將此科技服務標立為數碼化生態系統，並針對遙距、遠端、在家工作、在家學習、在家購物、以及各類型交易和行為的變化提供解決方案。因為新冠疫情大流行和大流行後導致的消費者和市場行為的「新常态」，我們將從急需檢討或進行數碼化改造其業務運營的企業中獲益。我們將向現有客戶推廣我們的新增業務以及產品。

我們在很多方面增強了我們的業務範圍。例如，我們收購了 Claman Global Limited 的控股權，其擁有 FringeBacker 的跨行業金融科技管理平台，FringeBacker 為世界最大的馬拉松賽事之一及其他大型活動提供科技支持及平台。因此，我們現在擁有這一振奮的業務的大部分權益，其曾處理超過20萬在線客戶的交易，將增強我們的平台產品。其他示例包括(a)戰略運營夥伴關係，例如我們與屢獲殊榮的網上和手機程式服務商建立解決方案服務夥伴關係，以在這些領域提供進一步的專業服務；(b)「聯合走向市場」夥伴關係，例如我們與屢獲殊榮的手機營銷科技服務商合作提供手機行銷科技的夥伴關係；(c)與領先的海外虛擬實景／擴增實景解決方案服務商建立「聯合自我開發」夥伴關係，以設計、開發和推出開創性的集成式虛擬博覽會／貿易展和虛擬展廳軟體。

展望未來

我們相信，鑑於新冠疫情和預期的後疫情時代，二零二零年是許多客戶正在進行或正在評估的科技轉型的真正起點。新冠疫情已經喚醒了越來越多的公司，提醒他們更多地關注遠程和虛擬科技，金融科技，雲端科技等。在過去的幾年中，我們的科技業務曾面臨挑戰，但我們在數年前已實現扭虧為盈，本集團已發展成為一家強大的業務及科技服務與解決方案服務商。我們將繼續朝著成為「新常态」的數碼生態系統合作夥伴的方向邁進。

在業務模式、研發、市場營銷和宣傳、運營策略、科技系統開發、以業務為導向的科技推動的商業績效指標以及銷售渠道合作夥伴方面，我們相信我們已積累了相比許多傳統的科技服務商使我們能在競爭中處於優勢的豐富知識和經驗。我們相信，這是本集團在香港和香港以外其他地區內繼續擴展的商機。

管理層討論與分析

OVERALL PERFORMANCE

This past year has seen the continuation of business growth for the Group, especially in relation to our technology business, focusing on providing “technology-for-business” services. This means we have achieved significantly higher revenue and profit in the year ended 30 April 2021.

Over the past year and a half of living with COVID-19, many of the business and social practices have changed dramatically, emerging as the “new normal”. During the past 14 years since 2007, The Group has refined and developed its main business as a “technology service and solutions provider” under this dynamic environment that focuses primarily on being a “business-driven technology services and solutions provider”, like fintech, ecommerce, payment, cloud technology and enterprise solutions. This now extends to providing enterprise architecture, technology transformation, custom platforms and solutions, including transformation “new normal” solutions. Our diversified client base in Hong Kong, and regionally in Mainland China, South Korea, Japan, Macau, and Southeast Asia, amongst others, demonstrates that there is significant demand for such “technology-for-business” services and solutions. Our clients range from SMEs to international businesses. These include businesses that are involved in financial services, wealth management, ecommerce, education, media and entertainment industries, amongst others.

Building upon the Group's past few years of steady growth in providing technology services and solutions, we have seen growth that is now accelerated by the “new normal” resulting from the COVID-19 pandemic.

Due mainly to the performance of our technology business, the Group recorded revenue of approximately HK\$110.7 million (2020: approximately HK\$34 million) during the year (226% growth) and profit for the year of approximately HK\$20.2 million (2020: approximately HK\$10.2 million) (98% growth). This continues the Group's successful record of profit into the fourth successive year following its turnaround during the year ended 30 April 2018.

It is frequently acknowledged that the “new normal” brought about by the pandemic is not limited to sudden changes in consumer and business behaviour. Instead, many enterprises agree that the pandemic accelerated these changes, which were likely to have been inevitable anyway. It would probably have been just a matter of time that technology and usage behaviour would have taken us there. The Group expects that enterprises will continue to accelerate their investment in digital transformation to address this “new normal”. For example, to quote a senior economist at Swiss Re, he takes the view that the increased use of digital tools is blurring the lines between work, lifestyle and social interaction, and between domains like mobility, health and finance, and that this is expected to continue in the post-COVID world. The Group shares this view of the post-COVID world.

BUSINESS REVIEW

Technology – Meeting “New Normal” Demands

We have been engaged in technology business for 14 years, since 2007 when we began to provide technology services.

One of our earlier projects in 2007 involved consulting, developing and managing in relation to an electronic ticketing system to manage and operate electronic admissions and payments for parks and tourist attractions in Mainland China.

Since that time our technology business has evolved, especially since 2014, into focusing on being a “business-driven technology services and solutions provider”.

Since 2017, we have been providing full one-stop service to clients to analyse, design, develop, operate and maintain integrated e-commerce and other online commercial platforms and products, for different business models and industries. Our full one-stop service includes technology-for-business consultancy services, software application development services, technical and maintenance services.

In 2020, after the dramatic changes brought about by the COVID-19 pandemic, we focused on addressing enterprise solutions for doing business in the “new normal” environment, like fintech, ecommerce, payment, enterprise solutions, enterprise architecture, technology transformation, customised business platforms and cloud technologies.

整體表現

過去一年本集團的業務持續增長，尤其是我們的科技業務，專注於提供「商業科技」服務。這表示，我們在截至二零二一年四月三十日止年度中實現了顯著更高的收入和利潤。

在過去一年半生活於新冠疫情，許多商業和社會實踐發生了巨大變化，形成「新常態」。自二零零七年以來的十四年中，本集團在這個主要專注於成為「業務為先的科技服務和解決方案服務商」的動態環境下，完善和發展其作為「商業為本的科技服務和解決方案服務商」的主營業務，如金融科技、電子商務、支付、雲端科技和企業解決方案。這現在擴展到提供企業科技體系架構，科技轉型，定制平台和解決方案，包括轉型「新常態」解決方案。我們在香港、中國大陸、韓國、日本、澳門和東南亞等地區的多元化客戶群反映對這類「科技支持業務」服務和解決方案的需求很大。我們的客戶範圍從中小企業到國際企業。其中包括涉及金融服務、財富管理、電子商務、教育、媒體和娛樂行業等的企業。

在本集團過去幾年提供科技服務和解決方案業務穩步增長的基礎上，新冠疫情造成的「新常態」正在急劇地加速了業務增長。

於本年度，主要由於我們科技業務的表現，本集團錄得收益約110,700,000港元（二零二零年：約34,000,000港元）（增長226%）及年內溢利約20,200,000港元（二零二零年：約10,200,000港元）（增長98%）。截至二零一八年四月三十日止年度扭虧為盈後，維持本集團成功連續第四年錄得溢利之記錄。

市場普遍認為，新冠疫情帶來的「新常態」並不限於消費者和商業行為突如其來的變化。反而，許多企業都認為新冠疫情加速了這些變化，而這些變化無論如何都是不可避免的。科技和用戶行為的演變只是時間問題。本集團認為企業將會繼續加快對數碼轉型的投資，以應變這「新常態」。例如，引用瑞士再保險公司的高級經濟學家的觀點，他認為數碼工具的普及使用正在令工作，生活方式和社會互動之間以及交通，健康和金融等領域之間的界限變得模糊，並預期在後新冠疫情世界中持續。本集團也認同其對後新冠疫情時代的看法。

業務回顧

科技 – 滿足「新常態」需求

自2007年開始提供科技服務以來，我們從事科技業務已有14年。

我們在2007年的早期項目之一涉及電子票務系統的諮詢、開發和管理，以管理和運營中國大陸公園和旅遊景點的電子門票及支付。

從那時起，我們的科技業務已經發展，特別是自2014年以來，專注於成為一家「商業為本的科技服務和解決方案服務商」。

自二零一七年起，我們一直為客戶提供面向不同商業模式及行業全面的一站式服務，分析、設計、開發、運營及維護綜合電子商務及其他在線商業平台及產品。我們全面的一站式服務包括商業科技諮詢服務、軟件應用開發服務、技術及維護服務。

二零二零年，在新冠疫情大流行帶來巨大變化之後，我們專注於解決在「新常態」環境下開展業務的企業解決方案，例如金融科技、電子商務、支付、企業解決方案、企業架構、科技轉型、定制業務平台、以及雲端科技。

MANAGEMENT DISCUSSION AND ANALYSIS 管理層討論與分析

It is inherent in the nature of the digital technology business that technologies evolve and become obsolete, and get replaced by newer technologies at much shorter intervals than commonly is the case for many other tools or skillsets in other industries. Therefore, we believe that the business, management and sales skills that the Group brings to clients and projects are just as important as traditional technology skills, and these are some of the key areas that our staff are highly experienced in and contribute significantly to the Group's business growth.

We intend to strengthen our business model by adding to the breadth and depth of the technology services and solutions that we operate. Therefore, we are actively negotiating and incorporating a number of advanced and commercially-drive technology services and solutions to add to our "stable", in order to create further synergy and to generate greater business opportunities for the Group.

The technology business recorded revenue of approximately HK\$107.2 million (2020: approximately HK\$30.7 million) (249% growth) with profit for the year of approximately HK\$36.6 million (2020: approximately HK\$23.9 million) (53% growth). As the Group has taken new initiatives to seek to explore and expand this business, we aim to achieve good performance during the upcoming year.

Technology – Additions and potential Additions

To further our technology business and to expand rapidly to exploit the window of opportunities in the shifting economy, and paradigm changes brought about by the "new normals", we are currently engaged in preliminary discussions to make possible acquisitions of or enter into business partnerships with established, highly-reputable, and high-growth technology services and products, which would present synergistic value with our existing technology services and solutions, and which would add to and deepen our business scope. The details of recent additions and possible additions are referred to in our announcements, for example, regarding (a) a controlling interest in Claman Global Limited which owns leading SaaS platforms whose enterprise clients include major international events and virtual business exhibitions and trade shows, and which has processed online FinTech services for over 200,000 transacted customers, (b) TeamTech Digital Corporation, which owns TeamSoft, an Enterprise Team Collaboration software and an Ecommerce business, in addition to strategic co-operation alliance to grow our technology solutions business, (c) an Education Technology business, and (d) investment in Rosarini International Limited, a FashionTech business. These additions and possible additions (if these materialise) would be expected to further strengthen the Group's technology and management business, and the Group would look forward to further growth in our technology business results.

Other Business

Our property operations are managed with a two-pronged approach of value gain and rental income to optimize value creation for our shareholders. We have continued to manage our operations by identifying optimal opportunities to acquire, manage and operate undervalued properties, including (i) commercial properties (retail and offices), especially in Kowloon East CBD, in line with the government's CBD 2.0 policy to transform Kowloon East, (ii) residential properties, especially at prime locations, and (iii) carpark properties, especially at locations with a low carpark density. These properties are located at regional locations that we believe are considered to be higher quality for property demand, primarily in Hong Kong, but also in Mainland China and Macau. These properties are acquired, managed, operated and disposed for both value gain and rental income strategies. As a result, (a) income from our properties can be from both disposal proceeds as well as from rental receipts, and (b) change of fair value from our properties are recorded and contribute towards profit or loss for the year.

Rental income for the year has been fairly steady at approximately HK\$4.7 million (2020: approximately HK\$4.9 million). As many property values in Hong Kong have been seriously affected by the COVID-19 pandemic, we recorded a relatively small decrease in unrealized fair value of investment properties during the year, being approximately HK\$2.3 million decrease (2020: loss of approximately HK\$0.8 million). This decrease is approximately 0.9% of the HK\$245.4 million fair value of investment properties as at 30 April 2020. When such changes in fair value of investment properties are excluded, our property business recorded stable profit HK\$3.9 million in profit during the year (2020: approximately HK\$4.2 million).

Given market conditions, we believe that the optimum times and values for disposing of selected properties may be during the coming 12 months, however we also believe that there would be undervalued opportunities regionally outside Hong Kong. For example, on 29 July 2021, after the end of the financial year under review, we issued an announcement in relation to our disposal of one property asset at consideration of HK\$11.88 million.

與其他行業的其他工具或技術要求相比，科技的變革發展與過時以及被更新的科技取代的時間間隔更加短暫，這是數碼科技行業固有的性質。因此，我們認為集團為客戶和項目帶來的業務、管理及銷售技能與傳統科技技術同等重要，而我們的員工於這些若干關鍵領域具有豐富經驗並為集團的業務增長作出重大貢獻。

我們打算通過增加我們運營的科技服務和解決方案的廣度和深度來繼續加強我們的業務模式。因此，我們正在積極協商並採用多種先進的、商業驅動的科技服務和解決方案，以增大我們「穩定」的根基，以創造進一步的協同效應並為集團創造更多的商機。

科技業務錄得收益約107,200,000港元(二零二零年：約30,700,000港元)(增長249%)及本年度溢利約36,600,000港元(二零二零年：約23,900,000港元)(增長53%)。由於集團採取了新的舉措，尋求探索和擴大是項業務，我們致力於來年取得好的表現。

科技 – 新增及可能新增業務

為了進一步發展我們的科技業務並迅速擴展以利用變化中的經濟中的機會之窗以及「新常態」帶來的範式變化，我們目前正在進行初步討論，以使與已建立的業務夥伴有可能進行收購或建立業務夥伴關係，信譽卓著且增長迅速的科技服務和產品，將與我們現有的科技服務和解決方案呈現協同增值作用，並將增加及加深我們的業務範圍。有關近期增加及可能增加的內容的詳細信息，請參見我們的公告，例如內容涉及(a)Claman Global Limited的控股權，該公司擁有領先的SaaS平台，其企業客戶包括大型國際活動，虛擬商業展覽和貿易展覽，並為超過200,000名交易客戶處理在線金融科技服務，(b)TeamTech Digital Corporation，其擁有TeamSoft，除戰略合作聯盟以發展我們的科技解決方案業務外，企業團隊協作軟件和電子商務業務，(c)教育科技業務，以及(d)對時尚科技企業Rosarini International Limited的投資。這些新增及可能新增的業務，如作實，則有望進一步加強本集團的科技和管理業務，並且本集團期待我們的科技業務業績進一步增長。

其他業務

我們的物業業務在雙管齊下同時著重增值收益與租金收入的管理下，為我們股東優化了價值創造。我們繼續優化我們的業務，根據政府關於改造九龍東的CBD 2.0政策，尋求合適的機遇去收購、管理和運營被低估的物業，包括(i)商用物業(零售和辦公室)，特別是位於九龍東CBD；(ii)住宅物業，特別是位於黃金地段；及(iii)停車場物業，特別是位於低停車場密度的地區。該等物業處於我們認為對物業質素需求較高的區域，主要位於香港，同時亦有位於中國大陸及澳門的。收購、管理、經營及出售該等物業的策略旨在為增值以及租金收入。因此，(a)我們的物業收入可來自出售所得款項以及租金收入，以及(b)我們物業的公平值收益入賬並為期內溢利作出貢獻。

本年度的租金收入一直相當穩定，約4,700,000港元(二零二零年：約4,900,000港元)。由於香港的許多物業價值都受到近期新冠疫情的嚴重影響，我們於年內錄得投資物業未實現公平值相對較小減少，即減少約2,300,000港元(二零二零年：虧損約800,000港元)。截至二零二一年四月三十日，投資物業公平價值245,400,000港元，下跌約0.9%。其反映投資物業公平值的非現金影響。倘撇除投資物業的公平值變動後，我們的物業業務於本年度錄得穩定溢利3,900,000港元(二零二零年：約4,200,000港元)。

鑒於市場環境，我們認為未來十二個月可能是出售一些物業的最佳時間及價值，同時我們亦相信香港以外地區可能會有物業被低估的投資機會。例如，於二零二一年七月二十九日，於回顧財政年度結束後，我們就以1,188萬港元的代價出售一項物業資產發佈公告。

MANAGEMENT DISCUSSION AND ANALYSIS

管理層討論與分析

The financial services business provides securities trading and other financial related services. During the year, we recorded negative revenue of approximately HK\$1.3 million (2020: approximately negative HK\$1.5 million), resulting in loss of approximately HK\$0.8 million (2020: loss of approximately HK\$2.4 million). We expect to continue to reduce the weighting of this segment, as compared with the growth in the technology sector.

RISKS AND UNCERTAINTIES

The Group is exposed to the risk of negative, volatile or of uncertain developments, including but not limited to negative, volatile or uncertain developments in the global, regional and local economies, in the financial and property markets, and in the changes in patterns of consumption. These developments might reduce revenue or result in reduced valuations of the Group's investment properties or in the Group being unable to meet its strategic objectives or in negative effect to its financial condition, results of operations and businesses. The Company will continue to adopt prudent financial policies to cope with the impact of uncertain factors.

FUND RAISING EXERCISES

The Company did not have any equity fund raising activity during the year.

SIGNIFICANT INVESTMENT, MATERIAL ACQUISITIONS AND DISPOSALS

Acquisition of Additional Equity Interest and Subscription for Additional Equity Interest in Claman Global Limited – FinTech & Management Platforms

Claman is a company incorporated in the British Virgin Islands with limited liability. Claman and its subsidiaries are engaged in the financial technology industry including in relation to technologies and services that seek to increase the efficiency of online financial transactions.

On 22 October 2020, VG Investment Assets Holdings Limited ("VG Investment"), a wholly-owned subsidiary of the Company, and Allyking International Limited entered into a share purchase agreement in relation to the acquisition of approximately 17.8% equity interest in Claman at a consideration of approximately HK\$15.7 million payable by the allotment and issue of 34,885,000 new shares of the Company at the issue price of HK\$0.45 per share.

On 27 November 2020, VG Investment and Claman entered into a subscription agreement in relation to subscription of approximately 20.2% equity interest in Claman at a consideration of approximately HK\$14.1 million, payable in cash.

On 11 June 2021, the completion of such acquisition and subscription took place. Following the completion, the Company indirectly owns approximately 50.3% equity interest in Claman, and its financial results will be consolidated into the financial statements of the Group. Details of the above were disclosed in the announcements of the Company dated 22 October 2020, 27 November 2020, 27 May 2021 and 11 June 2021.

As at 30 April 2021, the carrying value of Claman as financial assets at FVOCI of the Group was approximately HK\$23.9 million (2020: approximately HK\$23.8 million). For the year ended 30 April 2021, a fair value gain of approximately HK\$0.1 million (2020: a fair value loss of approximately HK\$0.3 million) was recognised in financial assets at FVOCI reserve.

Save as disclosed above, the Group had no discloseable investment, acquisition of subsidiaries, associates and joint ventures during the year ended 30 April 2021.

SUBSEQUENT EVENTS

Subsequent to the reporting period, the Group had the following material acquisitions and disposal:

(1) Acquisition of 40% Equity Interest in Rosarini International Limited ("Rosarini") – FashionTech

Rosarini is a company incorporated in the British Virgin Islands with limited liability. Rosarini is principally engaged in the FashionTech business, operating its proprietary-branded smart-textile apparel line, and has been operating in the Hong Kong and Asian markets for over 15 years, including having developed its wrinkle-resistant apparel lines.

金融服務業務提供證券交易及其他金融相關服務。於本年度，我們錄得負收入約1,300,000港元(二零二零年：約負1,500,000港元)，從而錄得虧損約800,000港元(二零二零年：虧損約2,400,000港元)。相比科技分部的增長，我們預期將繼續減少此分部的比重。

風險及不明朗因素

本集團面臨負面、波動及不明朗發展的風險，包括但不限於全球及地區經濟體以及金融及物業市場之負面、波動及不明朗發展，以及消費模式的轉變。該等發展可能減少收益或導致本集團投資物業之估值下降或本集團不能達成其策略目標或對其財務狀況產生負面影響。本公司將繼續採取審慎的財務政策以應對不明朗因素的影響。

集資活動

本年度，本公司並無進行任何股本集資活動。

重大投資、重大收購及出售

收購及認購於Claman Global Limited之額外股權 – 金融科技及管理平台

Claman為於英屬處女群島註冊成立之有限公司。Claman及其附屬公司主要從事金融科技業，包括尋求提高網上財務交易效率的科技與服務。

於二零二零年十月二十二日，本公司之全資附屬公司VG Investment Assets Holdings Limited(「VG Investment」)與Allyking International Limited就以代價約15.7百萬港元收購Claman約17.8%的股權訂立股權買賣協議，並將透過按發行價每股0.45港元配發及發行34,885,000股本公司新股份之方式支付代價。

於二零二零年十一月二十七日，VG Investment與Claman就以代價約14.1百萬港元認購Claman約20.2%的股權訂立認購協議，並以現金支付代價。

於二零二一年六月十一日，收購及認購完成。於完成後，本公司間接持有Claman約50.3%的股權，且其財務業績將併入本集團的財務報表內。上述詳情於本公司日期為二零二零年十月二十二日、二零二零年十一月二十七日、二零二一年五月二十七日及二零二一年六月十一日之公佈內披露。

於二零二一年四月三十日，透過其他全面收入按公平值列賬之金融資產之Claman之賬面值約為23,900,000港元(二零二零年：約23,800,000港元)。截至二零二一年四月三十日止年度，公平值收益約100,000港元(二零二零年：公平值虧損約300,000港元)於按公平值計入其他全面收入之金融資產儲備內確認。

除上文披露者外，截至二零二一年四月三十日止年度，本集團並無進行須予披露之投資、收購或出售附屬公司、聯營公司及合營企業。

期後事項

於報告期後，本集團擁有下列重大收購及出售：

(1) 收購Rosarini International Limited(「Rosarini」)的40%權益 – 時尚科技

Rosarini為於英屬處女群島註冊成立之有限公司。Rosarini主要從事經營其專有品牌的智能紡織服裝業務，並已在香港和亞洲市場運營超過十五年，其中包括開發了抗皺服裝系列。

On 27 May 2021, a wholly-owned subsidiary of the Company, Vongroup Consumer Finance Corporation (“VCFC”), entered into the Share Purchase and Strategic Alliance Agreement with Karen Michelle Scheinecker (the “Rosarini Vendor”), pursuant to which VCFC conditionally agreed to acquire, and the Rosarini Vendor has conditionally agreed to sell, 40% equity interest in Rosarini at a consideration of HK\$22,000,000, which shall be satisfied as to HK\$10,950,000 in cash and as to HK\$11,050,000 by the allotment and issue of 17,000,000 Consideration Shares credited as fully paid, pursuant to the General Mandate.

Upon completion of the acquisition, the Company will hold 40% of Rosarini. The financial results of Rosarini would therefore then be accounted for using equity method as an associated company in the accounts of the Group.

Pursuant to the Share Purchaser and Strategic Alliance Agreement, the Rosarini Vendor has additionally conditionally granted to VCFC the right to acquire up to a further 11% equity interest in Rosarini from the Rosarini Vendor, which right is exercisable at the discretion of VCFC within 2 years of the completion of the acquisition, at an exercise consideration of HK\$6,050,000, or pro rata amount for partial exercise.

If VCFC fully exercises its right in respect of such additional acquisition, and assuming no change in the shareholding of Rosarini, the Company will hold 51% of Rosarini, in which case the financial results of Rosarini would then be consolidated into the accounts of the Group. As at date of the report, the acquisition of Rosarini has not yet completed. Details of the above were disclosed in the announcement of the Company dated 27 May 2021.

(2) Disposal of an investment property

On 29 July 2021, United Luck Limited, an indirectly wholly-owned subsidiary of the Company, entered into a provisional agreement with independent third parties to dispose of an investment property with carrying amount as at 31 October 2020 and 30 April 2021 of approximately HK\$10,780,000 and HK\$11,088,000 respectively at a consideration of HK\$11,880,000. As at date of this report, the transaction was not yet completed. Details of the above were disclosed in the announcement of the Company dated 29 July 2021.

(3) Acquisition of the entire equity interest in TeamTech Digital Corporation (“TeamTech”) – Team Collaboration software

On 17 August 2021, a wholly-owned subsidiary of the Company, VG Investment Assets Holdings Inc. (“VGIAH”) and Faith Honest International Co. Ltd., an independent third party (the “TeamTech Vendor”), entered into the share purchase agreement and strategic alliance co-operation, pursuant to which VGIAH conditionally agreed to acquire, and the TeamTech Vendor conditionally agreed to sell, the entire equity interest in TeamTech Digital Corporation (“TeamTech”) at a consideration of up to HK\$16,500,000 (the “Acquisition of TeamTech”). Upon completion of the Acquisition of TeamTech, TeamTech will become an indirectly wholly-owned subsidiary of the Company, and the results of TeamTech will be consolidated in the accounts of the Group. The Acquisition of TeamTech was not yet completed up to the date of this report. Details of the above were disclosed in the announcement of the Company dated 17 August 2021.

FUTURE PROSPECTS

Going forward, we will strive to further increase the breadth and depth of our spectrum of digital services and solutions that we offer. We intend to achieve this by both our internal R&D, as well as by acquisitions and operational business partnerships, in order to be a “digital ecosystem partner for the new normal”, so that when enterprises need to revisit or digitally transform their business operations in light of the “new normal” of consumer and market behaviour resulting from the COVID-19 pandemic, the Group will be one of the potential partners they should consider talking to. At the same time, as these transformation needs occur almost all over the world, we will seek to further expand internationally, including leveraging upon our experience to provide consultancy services to improve or develop customers’ technology-focused commercial models. Following 14 years of technology experience, coupled with even longer commercial operation experience, we are optimistic that we will continue to grow our presence in Hong Kong and regionally.

於二零二一年五月二十七日，本公司之全資附屬公司 Vongroup Consumer Finance Corporation (「VCFC」) 與 Karen Michelle Scheinecker (「Rosarini 賣方」) 訂立股權買賣及戰略結盟協議，據此 VCFC 有條件同意收購而 Rosarini 賣方有條件同意出售 Rosarini 40% 的股權，代價為 22,000,000 港元，當中 10,950,000 港元將會以現金支付及 11,050,000 港元將根據一般授權以配發及發行 17,000,000 股代價股份入賬列作繳足。

至收購完成後，本公司將持有 Rosarini 約 40% 的股權。Rosarini 之財務業績將以權益法作為聯營公司入賬至本集團賬目。

根據股權買賣及戰略聯盟協議，Rosarini 賣方額外有條件地授予 VCFC 從賣方中收購 Rosarini 額外上限為 11% 股權的權利，該權利可由 VCFC 在收購完成日 2 年內任意行使，行使價為 6,050,000 港元，或部分行使則按比例計算。

倘 VCFC 就有關額外收購事項行使其全部權利，且假設 Rosarini 的股權並無變動，則本公司將持有 Rosarini 的 51% 股權，在此情況下，Rosarini 的財務業績將合併為本集團的賬目。於本報告日期，收購 Rosarini 尚未完成。上述詳情於本公司日期為二零二一年五月二十七之公佈中披露。

(2) 出售投資物業

於二零二一年七月二十九日，本公司之間接全資附屬公司聯禮有限公司與獨立第三方訂立臨時協議，以 11,880,000 港元之代價出售賬面值於二零二零年十月三十一日及二零二一年四月三十日分別約為 10,780,000 港元及 11,088,000 港元之投資物業。於本報告日期，交易尚未完成。上述詳情於本公司日期為二零二一年七月二十九日之公佈中披露。

(3) 收購 TeamTech Digital Corporation (「TeamTech」) 之全部股權 – 團隊協作軟件

於二零二一年八月十七日，本公司全資附屬公司 VG Investment Assets Holdings Inc. (「VGIAH」) 與獨立第三方 Faith Honest International Co. Ltd. (「TeamTech 賣方」) 訂立股份購買協議及戰略結盟合作，據此 VGIAH 有條件同意收購及 TeamTech 賣方有條件同意出售於 TeamTech Digital Corporation (「TeamTech」) 之全部股權，代價最高為 16,500,000 港元 (「收購 TeamTech」)。於完成收購 TeamTech 後，TeamTech 將成為本公司之間接全資擁有附屬公司，TeamTech 之業績將於本集團賬目綜合入賬。直至本報告日期收購 TeamTech 仍未完成。上述事項詳情披露於本公司日期為二零二一年八月十七日之公告。

未來展望

展望未來，我們將努力進一步提高我們提供的數碼服務和解決方案範圍的廣度和深度。我們打算通過內部研發以及收購和運營業務合作夥伴關係來實現這一目標，以便成為「新常態的數碼生態系統合作夥伴」，以便企業需要重新審視或以數碼方式轉變其業務運營時，鑑於新冠疫情導致的消費者和市場行為的「新常態」，本集團將成為他們應考慮與之討論的潛在合作夥伴之一。同時，由於這些轉型的需求幾乎遍布世界各地，因此我們將尋求進一步的國際擴張，包括利用我們的經驗提供諮詢服務，以改善或開發客戶以科技為中心的商業模式。憑藉十四年的科技經驗，再加上更長的商業運營經驗，我們對我們將繼續在香港和地區擴大業務表示樂觀。

MANAGEMENT DISCUSSION AND ANALYSIS

管理層討論與分析

In the coming months and year, to realise this mission, we intend to expand our technology services and solutions to launch software and leading-edge services, including online platforms. These initiatives are intended to bring the Group closer to becoming the “digital ecosystem partner for the new normal”. We seek to continue to expand our services and solutions, both in Hong Kong and regionally outside Hong Kong.

FINANCIAL REVIEW

Liquidity and Financial Resources

The Group maintained cash and bank balances as at 30 April 2021 amounting to approximately HK\$37.9 million (2020: approximately HK\$19.6 million). The Group's current ratio as at 30 April 2021 was 4.7 (2020: 4.2). The total equity of the Group amounted to HK\$413.9 million (2020: HK\$391.7 million) as at 30 April 2021.

Gearing

The gearing ratio, as a ratio of bank borrowings to total equity, was 0.05 as at 30 April 2021 (2020: 0.06).

Exchange Rate Exposure

The Group's assets, liabilities and cash flow from operations are mainly denominated in Hong Kong dollars and Renminbi. The Group currently does not have any related foreign exchanges hedges, however the Company monitors its foreign exchange exposure and will consider hedges should the need arise.

Treasury Policies

The Group generally finances its operations with internally generated resources and bank borrowings. The interest rates of borrowings, if applicable, are generally charged by reference to prevailing market rates.

As at 30 April 2021, there were bank borrowings, which were denominated in Hong Kong dollars, of approximately HK\$22.1 million (2020: approximately HK\$24.3 million). All bank borrowings were subject to interest rate of 0.7%-1.5% per annum over 1-month to 3-month HIBOR, and capped at 2.45%-2.7% per annum below prime rate. The bank borrowings are not repayable within one year from the end of the reporting period but contains a repayment on demand clause, therefore all bank borrowings were classified into current liabilities of the Group.

Contingent Liabilities

As at 30 April 2021, the Group did not have any material contingent liability (2020: Nil).

Pledge of assets

As at 30 April 2021, the bank borrowings are secured and guaranteed by investment properties of the Group with an aggregate net carrying amount of approximately HK\$118.6 million (2020: approximately HK\$121.3 million) and leasehold land and buildings with an aggregate net carrying amount of approximately HK\$11.2 million (2020: approximately HK\$11.6 million).

Commitments

The Group had no capital commitments during the year (2020: Nil).

EMPLOYMENT AND REMUNERATION POLICY

As at 30 April 2021, the Group had 50 (2020: 30) employees in Hong Kong and Mainland China. The Group has not experienced any significant problems with its employees or disruptions due to labour disputes nor has it experienced difficulties in the recruitment and retention of experienced staff. The Group remunerates its employees based on industry practices. Its staff benefits, welfare, share options and statutory contributions, if any, are made in accordance with individual performance and prevailing labour laws of its operating entities.

本集團一般依靠內部產生資源及銀行貸款為其經營業務提供所需資金。借貸之利率(如適用)乃一般參照現行市場利率計算。

於二零二一年四月三十日，以港元計值之銀行借貸約為22,100,000港元(二零二零年：24,300,000港元)。所有銀行借貸按一個月至三個月香港銀行同業拆息加0.7厘至1.5厘之年利率計息，而年利率上限為最優惠利率減2.45厘至2.7厘。該等銀行借貸毋須於報告期末起一年內償還，但載有按要求償還條款，因此所有銀行借貸分類為本集團之流動負債。

In addition, the Company's capital redemption reserve in the amount of approximately HK\$0.26 million may be distributed in the form of fully paid bonus shares.

Permitted Indemnity Provision

During the year ended 30 April 2021, the Company did not take out insurance cover in respect of legal action against the Directors because it is believed that this legal risk to the Directors is quite low.

CORPORATE GOVERNANCE PRACTICES

The Company is firmly committed to maintaining and improving the quality of corporate governance so to ensure better transparency of the Company, protection of shareholders' and stakeholders' rights and enhance shareholder value.

During the year under review, the Company has complied with the code provisions of the CG Code and periodically reviews its corporate governance practices to ensure that these continue to meet the requirements of the CG Code, except for the deviation from code provisions A.1.8, A.2.1, A.4.1 and A.6.7 of the CG Code as described below.

Under code provision A.1.8, the Company should arrange appropriate insurance cover in respect of legal action against its directors. However, the Company did not take out insurance cover in respect of legal action against the Directors during the year ended 30 April 2021 because it is believed that this legal risk to the Directors is quite low.

Under code provision A.2.1, the role of chairman and chief executive officer ("CEO") should be performed by different individuals. Since September 2005, Vong Tat leong David, who is a director and CEO of the Company, has also carried out the responsibilities of the chairman of the Company. The Board considers the present structure is more suitable to the Company for it can provide strong and consistent leadership and allow for more efficient formulation and implementation of the Company's development strategies.

Under code provision A.4.1, non-executive Directors should be appointed for a specific term, subject to re-election. The non-executive Directors of the Company, including the independent non-executive Directors, are not appointed for a specific term but are subject to retirement by rotation and re-election at the annual general meetings of the Company at least once every three years as specified in the provisions of the Company's articles of association. As such, the Board considers that sufficient measures have been taken to ensure that the Company's corporate governance practices are no less exacting than those in the CG Code.

Under code provision A.6.7, independent non-executive Directors shall attend general meetings and develop a balanced understanding of the views of shareholders. Two independent non-executive Directors of the Company were unable to attend the 2020 annual general meeting of the Company held on 30 October 2020 due to their engagement with their other commitments.

DIRECTORS' SECURITIES TRANSACTIONS

The Company has adopted the Model Code for Securities Transactions by Directors of Listed Issuers (the "Model Code") as set out in Appendix 10 of the Listing Rules as the code of conduct regarding securities transactions of the Directors. Having made specific enquiry of all Directors, the Company confirms that all Directors have complied with the required standards set out in the Model Code during the year ended 30 April 2021.

BOARD OF DIRECTORS

Composition

As at 30 April 2021, the Board of Directors (the "Board") comprises five members: two executive Directors, namely Vong Tat leong David (Chief Executive Officer) and Xu Siping; and three independent non-executive Directors, namely Lee G. Lam and Fung Ka Keung David, who both have the appropriate professional qualifications or accounting or related financial management expertise required by the Listing Rules, and Wong Man Ngar Edna.

The biographical details of the Board members are set out on page 11 of this report.

The Audit Committee members performed their duties within written terms of reference formulated by the Company in accordance with the requirements of the Listing Rules. Its primary duties are as below:

- (1) make recommendations to the Board on the appointment, reappointment and removal of the external auditor, and to approve the remuneration and terms of engagement of the external auditor, and any questions of its resignation or dismissal;
- (2) review and monitor the external auditor's independence and objectivity and the effectiveness of the audit process in accordance with applicable standards;
- (3) review the Company's financial controls, internal control and risk management systems;
- (4) review the Group's financial and accounting policies and practices; and
- (5) discuss the risk management and internal control systems with management of the Company to ensure that management has performed its duty to have an effective systems, including the adequacy of resources, staff qualifications and experience, training programmes and budget of the Company's accounting and financial reporting function.

Internal Audit Function

The Group's internal audit function is performed by the internal auditor who reports directly to the Audit Committee. Internal auditor plays an important part in the assessment of the effectiveness of the risk management and internal control systems of the Group and reports directly to the Audit Committee on a regular basis.

The internal auditor conducts internal reviews on material controls and compliance with policies and procedures of the Group at both operational and corporate levels. Plans and tools for corrective actions and control improvement are identified and communicated with operations management to address an issue, non-compliance or deficiencies identified. The internal auditor monitors the implementation of his recommendations by operations management and reports the outcomes to the Audit Committee.

The Company has a policy to assess the likely impact of any unexpected and significant event that may impact the price of the Shares or their trading volume and to decide whether the relevant information is considered as inside information that needs to be disclosed as soon as reasonably practicable pursuant to Rules 13.09 and 13.10 of the Listing Rules and the Inside Information Provisions under Part XIVA of the SFO.

The declaration and payment of dividends shall be determined at the sole discretion of the Board after taking into account, among others, the general financial condition of the Group, the capital and debt level of the Group, the future cash requirements and availability for business operations, business strategies and future development needs, the general market conditions and any other factors that the Board deems appropriate. The payment of dividends by the Company is also subject to any restrictions under the all applicable laws, rule and regulations and the articles of association of the Company.

SHAREHOLDERS' RIGHTS

1) Procedures for shareholders to convene an extraordinary general meeting ("EGM")

Pursuant to the Articles 58 of the Articles of the Company, an EGM can be convened on the requisition of one or more shareholders of the Company holding at the date of deposit of the requisition not less than one-tenth (10%) of the paid up capital of the Company carrying the right of voting at general meetings of the Company shall at all times have the right, by written requisition to the Board or the secretary of the Company, to require an EGM to be called by the Board for the transaction of any business specified in such requisition; and such meeting shall be held within two (2) months after the deposit of such requisition. If within twenty-one (21) days of such deposit, the Board fails to proceed to convene such meeting, the requisitionist(s) himself (themselves) may do so in the same manner, and all reasonable expenses incurred by the requisitionist(s) as a result of the failure of the Board shall be reimbursed to the requisitionist(s) by the Company.

2) Procedures for putting forward proposals at shareholders' meeting

There are no provisions in the Articles of the Company or the Companies Law of the Cayman Islands for shareholders to move new resolutions at general meetings. Shareholders who wish to move a resolution may request the Company to convene a general meeting in accordance with the procedures set out in the preceding paragraph.

However, shareholders are requested to follow Article 88 of the Articles of the Company for including a resolution at any general meeting. Pursuant to Article 88 of the Articles of the Company, no person other than a retiring Director shall, unless recommended by the Directors for election, be eligible for election to the office of Director at any general meeting, unless notice in writing by a Member (not being the person to be proposed) entitled to attend and vote at the meeting for which such notice is given of his intention to propose such person for election as a Director and notice in writing by that person of his willingness to be elected shall have been lodged at the office or head office of the Company at least seven days before the date of the general meeting, such period for lodgment of the notices shall commence no earlier than the day after the despatch of the notice of the general meeting appointed for such election and end no later than seven days prior to the date of such meeting provided that such period shall be at least seven days.

Shareholders may send requisitions and requests to the Board or the secretary of the Company in written form to the principal place of business of the Company at 17A, EGL Tower, 83 Hung To Road, Kwun Tong, Kowloon, Hong Kong.

Overview

We know that the quality of environmental protection procedures is very important to achievement of long-term success of our Company. Our priority is to protect the environment and our target is to minimise adverse impact on the environment by adopting world class environmental protection practices in our operational activities.

We do our best to ensure that the concept of environmental sustainability is integrated into every part of our daily business operations.

We keep on monitoring all types of changes in the ways of producing waste and/or utilising energy during the process of carrying on our business activities with the aim of mitigating any unfavourable impact of our operations on the environment. We continually review and update our ESG policies, if applicable, to ensure that there is a balance between sustainable corporate development and environmental protection.

It is often our great desire to minimise the negative impact of our operational activities on the environment by improving energy efficiency, reducing all kinds of waste and supporting education as to environmental protection.

Emissions

The Group understands the importance of environmental protection. It actively implements multiple measures for environmental protection in its operations and formulates various management policies to reduce emissions.

我們竭力確保環境可持續性概念融入我們日常業務營運之每個部分。

我們持續監控業務經營中產生廢物及／或能源使用之各種變動，藉此減低經營對環境之任何不利影響。我們一直適時檢討及更新環境、社會及管治政策，以確保可持續企業發展及環境保護間之平衡。

我們冀望透過提高能源效益、減少各類廢物及支持環境保護教育，降低經營活動對環境造成之不利影響。

排放物

本集團深明保護環境的重要性。在營運過程中，本集團積極推行多項環境保護措施，並制定了各項管理政策，實行減排。

While the main business of the Group is not production, its operations do not impose much impact on water, land or air by way of greenhouse gas emissions, discharges into water and land, and/or generation of hazardous and non-hazardous wastes. We do not produce any hazardous waste and we strive to minimise volume of non-hazardous waste that we produce during the course of our daily operations. Our greenhouse gases emissions are indirectly, principally resulting from electricity consumed at the Company's workplace as well as from business travel by employees.

During the reporting period, the Group did not generate any significant hazardous waste during its operations. Therefore, no relevant internal regulations have been formulated.

Use of resources

The Group encourages the reduction of energy consumption. Energy saving light bulbs and LED lighting systems are used in all offices of the Group. The Group encourages making use of natural daylight and refrain from turning on unnecessary lights during daytime. Meanwhile, rules on energy saving are implemented to ensure that all equipment and lights of conference rooms are turned off when they are not in use. Equipment and office machinery including but not limited to computers, printers and photocopiers are to be switched to sleep mode immediately after use. Employees are required to turn off lights and computers before leaving the office. Energy saving devices are installed to reduce consumption of electricity and water after office hours. The total electricity energy consumption during the Reporting Period was 34,943 KWh (2020: 40,621 KWh).

We try our best to avoid unnecessary wastage of paper and promote effective usage of paper. In our daily operations, we maximise usage of e-versions instead of hardcopies wherever it is possible. We encourage our staff to work more effectively in a paperless environment. In case there is still a need for printing, we make use of double-sided printing generally, and reuse the recycled paper with one side of it already used for those documents used internally. The total paper consumption during the Reporting Period was 175 kg (2020: 324 kg).

Meanwhile, the Group also adopts policy to reduce the use of disposable consumables, such as disposable cutlery and plastic bottled water. Measures to promote separation of waste for reuse and recycle are in place pursuant to which certain consumables of photocopiers and printers such as cartridges and toners, waste paper that cannot be reused and discarded computers are to be separated from other daily solid waste for recycling.

(B) SOCIAL ASPECTS*Employment*

As at 30 April 2021, the total number of employees being employed by the Group was 50 (2020: 30). The Group understands that human resource is one of its most valuable assets, the provision of a stimulating and harmonious working environment can improve the sense of belongings to its employees. Employees and Directors are remunerated based on their educational qualifications, industry experience, performance, current industry practices and prevailing market conditions and in accordance with pertinent labour laws and regulations. Apart from the basic package, for instance, severance payment, mandatory provident fund, employment compensation insurance, annual leaves, sick leaves, additional remuneration and benefits such as performance-based bonuses and other staff welfare benefits are provided.

Health and Safety

Our Company complies with the relevant laws and regulations regarding industrial safety, hygiene and health and other caring arrangements for employees. The Company's business operations do not involve any high-risk work activities that could lead to serious industrial events or occupational health problems. We care about our staff members' health and safety. In this respect, the Company provides relevant updates of occupational safety and health to its employees by means of leaflets and training courses which are conducted by the Labour Department. During the year, there was no case of injuries reported.

本公司主要業務並非生產，本公司運營並無透過溫室氣體排放、向水及土地排污及／或產生有害及無害廢物對水、土地或空氣造成重大影響。我們並無生產任何有害廢物且我們力求將日常營運中產生之無害廢物數量減至最少。我們的溫室氣體排放主要及間接來自辦公室用電及員工商務差旅。

於報告期間，本集團在營運過程中並沒有產生任何大量有害廢棄物，因此沒有制定相關的規定。

資源使用

本集團鼓勵減低能源消耗，在其各辦公室換上較節能的慳電燈泡及LED照明系統，白天盡量採用天然日光，不開啟非必要的燈光，同時也制定節約能源的守則，確保會議室的所有設備及燈光在使用後馬上關閉，電腦、打印機及複印機等辦公室器材在使用後即時切換至休眠模式，員工下班前必須關閉電燈及電腦，也安裝節能功能的裝置以節約下班後的電能及水資源。於報告期間，總電力消耗為34,943千瓦時(2020：40,621千瓦時)。

我們竭力避免不必要的紙張浪費及提倡紙張使用效益。於我們日常營運中，我們在可行情況下盡最大可能使用電子文件而非複印文件。我們鼓勵員工於無紙化環境中更有效地工作。倘仍須列印，我們一般會雙面列印，並善用已使用的單頁內部文件之背頁。於報告期間，紙張總消耗量為175千克(2020：324千克)。

同時，本集團也採取減少使用即棄用品(如即棄餐具及膠樽裝水)的政策，並推行可再用及可回收廢棄物分類的措施，複印機、打印機使用完的若干耗材(如墨盒及碳粉匣)、不能再重用的廢紙及廢棄的電腦等均與其他日常固體廢棄物進行分類，並安排回收。

(乙) 社會方面*僱傭*

於二零二一年四月三十日，本集團僱用合共50名(二零二零年：30名)僱員。本集團明白人力資源乃其最寶貴的資產，提供具競爭力及和諧的工作環境可加強僱員的歸屬感。僱員及董事的薪酬乃根據彼等的學歷、行業經驗、工作表現、現時行業慣例及當前市況，按照有關勞工法例及法規而釐定。除基本薪金待遇，例如遣散費、強制性公積金、員工補償保險、年假及病假外，亦提供額外酬金及福利，例如績效花紅及其他福利待遇。

健康及安全

Development and Training

The Group encourages lifelong learning and offer trainings to its employees to enhance their performance and to provide support to their personal development. The objective of the Group's human resource management is to reward and recognise performing staff by a sound performance appraisal system with appropriate incentives, salaries and wages are reviewed annually based on performance appraisals, qualifications, experience, position and seniority.

Labour Standard

The Group's recruitment management system measures clearly on the staff's age requirement. Review and verification of applicant's identity information is required during the recruitment process, and recruitment of child labor is strictly prohibited. Applicant is also required to provide document proofs of academic qualifications and working experience for verifications, applicant who is suspected to have false academic qualifications and working experience will not be employed. The Group provides its staff with a safe, health, comfortable working environment with labor protection, reasonable remuneration and various welfare. The Group enters employment contract with each of its employees in accordance with relevant laws and regulations in the PRC and Hong Kong, and has strictly complied with such laws relating to preventing child and forced labour.

Supply Chain Management

It is the Group's policy to undertake procurement so as to advance our economic, environmental and social objectives. New suppliers will be assessed and their products will be evaluated before engagement. Preference will be given to socially responsible entities, energy efficient equipment and environmental friendly products. Ongoing quality monitoring and supervision is in place to ensure procurements are conducted specific to the Group's requirement.

Product responsibility

The quality of the product is very important to the Group. The Group has establishes various communication channels including company's website, e-mail and telephone for customers to give their feedback to the Group. Customer's satisfaction will become the driving force for the Group to increase the quality of the product. Also, the Group respects the privacy of the customer, protecting customer's and supplier's data and privacy of client information. They are kept in confidentiality and destroyed in accordance with the Group's policy on document retention.

Anti-corruption and Anti-Fraud

The Company maintains a high standard of business integrity throughout its operations and tolerates no corruption or bribery in any form. We encourage the reporting of suspected business irregularities and provide clear channels specifically for this purpose. When suspected wrongdoings are identified, such as breach of duty, abuse of power, receiving bribes, staff should report for investigation and verification, and report to the regulator and/or to law enforcement authority when necessary.

The Group engaged an independent professional valuer for ECL assessment on accounts receivable, loan receivables and deposits and other receivables.

1. CORPORATE INFORMATION

Vongroup Limited (the “Company”) was incorporated in the Cayman Islands as an exempted company with limited liability under the Companies Law of the Cayman Islands. The shares of the Company are listed on the Main Board of The Stock Exchange of Hong Kong Limited (the “Stock Exchange”). The registered office of the Company is situated at Cricket Square, Hutchins Drive, P.O. Box 2681, Grand Cayman KY1-1111, Cayman Islands and its principal place of business is situated at 17A, EGL Tower, 83 Hung To Road, Kwun Tong, Kowloon, Hong Kong.

The principal activity of the Company is an investment holding. The principal activities of its subsidiaries are set out in Note 33 to the consolidated financial statements.

In the opinion of the directors of the Company, Vongroup Holdings Limited, a company incorporated in British Virgin Islands (“BVI”), is the immediate and ultimate holding company and Mr. Vong Tat leong David is the ultimate controlling party (the “Ultimate Controlling Party”) of the Company, who is also the chief executive officer and an executive director of the Company.

The consolidated financial statements of the Company and its subsidiaries (collectively referred to as the “Group”) are presented in Hong Kong dollars (“HK\$”), which is also the functional currency of the Company.

2. PRINCIPAL ACCOUNTING POLICIES

Statement of compliance

The consolidated financial statements have been prepared in accordance with Hong Kong Financial Reporting Standards (“HKFRSs”), which collective term includes all individual applicable HKFRSs, Hong Kong Accounting Standards (“HKASs”) and Interpretations issued by the Hong Kong Institute of Certified Public Accountants (the “HKICPA”), accounting principles generally accepted in Hong Kong. The consolidated financial statements also comply with the disclosure requirements of the Hong Kong Companies Ordinance and the applicable disclosure provisions of the Rules Governing the Listing of Securities on the Stock Exchange (the “Listing Rules”).

All amounts have been rounded to the nearest thousand (“HK\$’000”), unless otherwise indicated.

The consolidated financial statements have been prepared on a basis consistent with the accounting policies adopted in the 2020 consolidated financial statements except for the adoption of the new/revised HKFRSs that are relevant to the Group and effective from the current period as detailed below.

Adoption of new/revised HKFRSs

Amendments to HKASs 1 and 8: Definition of Material

The amendments clarify the definition of material and align the definition used across HKFRSs.

Amendments to HKAS 39, HKFRSs 7 and 9: Interest Rate Benchmark Reform – Phase 1

The amendments modify some specific hedge accounting requirements to provide relief from potential effects of the uncertainties caused by interest rate benchmark reform (the market-wide reform of an interest rate benchmark, including the replacement of an interest rate benchmark with an alternative benchmark). In addition, the amendments require companies to provide additional information to investors about their hedging relationships which are directly affected by these uncertainties.

本公司及其附屬公司(統稱「本集團」)之綜合財務報表以港元(「港元」)呈列，而港元亦為本公司之功能貨幣。

合規聲明

A summary of the principal accounting policies adopted by the Group in preparing the consolidated financial statements is set out below.

Basis of measurement

The measurement basis used in the preparation of the consolidated financial statements is historical cost basis, except for investment properties, financial assets at FVPL and financial assets at FVOCI which were stated at fair value as explained in the accounting policies set out below.

Basis of consolidation

The consolidated financial statements comprise the financial statements of the Company and all of its subsidiaries. The financial statements of the subsidiaries are prepared for the same reporting period as that of the Company using consistent accounting policies.

All intra-group balances, transactions, income and expenses and profits and losses resulting from intra-group transactions are eliminated in full. The results of subsidiaries are consolidated from the date on which the Group obtains control and continue to be consolidated until the date that such control ceases.

Allocation of total comprehensive income

Profit or loss and each component of other comprehensive income are attributed to the owners of the Company and to the non-controlling interests (if applicable). Total comprehensive income is attributed to the owners of the Company and the non-controlling interest (if applicable) even if this results in the non-controlling interest having a deficit balance.

Changes in ownership interest

Changes in the Group's ownership interest in a subsidiary that do not result in a loss of control are accounted for as equity transactions. The carrying amounts of the controlling and non-controlling interests are adjusted to reflect the changes in their relative interests in the subsidiary. Any difference between the amount by which the non-controlling interests are adjusted and the fair value of the consideration paid or received is recognised directly in equity and attributed to the owners of the Company.

When the Group loses control of a subsidiary, the profit or loss on disposal is calculated as the difference between (i) the aggregate of the fair value of the consideration received and the fair value of any retained interest determined at the date when control is lost and (ii) the carrying amount of the assets (including goodwill), and liabilities of the subsidiary and any non-controlling interests at the date when control is lost. The amounts previously recognised in other comprehensive income in relation to the disposed subsidiary are accounted for on the same basis as would be required if the holding company had directly disposed of the related assets or liabilities. Any investment retained in the former subsidiary and any amounts owed by or to the former subsidiary are accounted for as a financial asset, associate, joint venture or others as appropriate from the date when control is lost.

Subsidiaries

A subsidiary is an entity that is controlled by the Group. The Group controls an entity when it is exposed, or has rights, to variable returns from its involvement with the entity and has the ability to affect those returns through its power over the entity. The Group reassesses whether it controls an investee if facts and circumstances indicate that there are changes to one or more of the elements of control.

In the Company's statement of financial position which is presented in Note 34 to the consolidated financial statements, investments in subsidiaries are stated at cost less impairment loss. The carrying amount of the investments is reduced to its recoverable amount on an individual basis, if it is higher than the recoverable amount. The results of subsidiaries are accounted for by the Company on the basis of dividends received and receivable.

附屬公司

附屬公司指本集團控制的實體。當本集團因參與實體業務而承擔可變動回報的風險或因此享有可變動回報，且有能透過向實體施加權力而影響該等回報時，則本集團控制該實體。當有事實及情況顯示一項或以上控制元素有變時，本集團重新評估是否控制被收購方。

於本公司財務狀況(載於綜合財務報表附註34中)表中，於附屬公司之投資按成本扣除減值虧損列賬。該投資的賬面值如高於可收回金額，則按個別基準調減至可收回金額。附屬公司的業績由本公司按已收及應收股息的基準列賬。

Goodwill

Goodwill arising on an acquisition of a business is measured at the excess of the consideration transferred and the fair value of any previously held equity interest in the acquiree over the acquisition date amounts of the identifiable assets acquired and the liabilities assumed of the acquired business.

Goodwill on acquisition of business is recognised as a separate asset and is carried at cost less accumulated impairment losses, which is tested for impairment annually or more frequently if events or changes in circumstances indicate that the carrying value may be impaired. For the purpose of impairment test and determination of gain or loss on disposal, goodwill is allocated to cash-generating units. An impairment loss on goodwill is not reversed.

On the other hand, any excess of the acquisition date amounts of identifiable assets acquired and the liabilities assumed of the acquired business over the sum of the consideration transferred and the fair value of the acquirer's previously held interest in the acquiree, if any, after reassessment, is recognised immediately in profit or loss as an income from bargain purchase.

Any resulting gain or loss arising from remeasuring the previously held equity interests in the acquiree at the acquisition-date fair value is recognised in profit or loss or other comprehensive income, as appropriate.

Property, plant and equipment

Property, plant and equipment are stated at cost less accumulated depreciation and impairment losses. The cost of an item of property, plant and equipment comprises its purchase price and any directly attributable costs of bringing the asset to its working condition and location for its intended use. Repairs and maintenance are charged to profit or loss during the period in which they are incurred.

Depreciation is provided to write off the cost less accumulated impairment losses of property, plant and equipment over their estimated useful lives as set out below from the date on which they are available for use and after taking into account their estimated residual values, using the straight-line method. Where parts of an item of property, plant and equipment have different useful lives, the cost or valuation of the item is allocated on a reasonable basis and depreciated separately:

Leasehold improvements	5 years or the lease term, whichever is shorter
Furniture, fixtures and equipment	5 to 10 years
Motor vehicles	5 years

An item of property, plant and equipment is derecognised upon disposal or when no future economic benefits are expected to arise from the continued use of the asset. Any gain or loss arising on derecognition of the asset (calculated as the difference between the net disposal proceeds and the carrying amount of the item) is included in profit or loss in the period in which the item is derecognised.

商譽

收購業務產生之商譽按所轉撥之代價及任何早前於被收購方所持股本權益之公平值(如適用)超出已收購業務所購入可識別資產及所承擔負債之收購日金額間之差額計量。

收購業務產生之商譽確認為一項獨立資產，並按成本減累計減值虧損列賬，並須每年進行減值檢測，或倘有事件發生或情況有變而顯示賬面值可能出現減值時，則須進行較頻密之減值檢測。就減值檢測及釐定出售之盈虧而言，商譽會被分配至創現單位。商譽之減值虧損不可撥回。

另一方面，於重新評估後，已收購業務所購入可識別資產及所承擔負債之收購日金額超出所轉撥代價及收購方早前於被收購方所持權益之公平值之總額間之任何差額(如有)，即時於損益中確認為議價收購之收入。

物業、廠房及設備

物業、廠房及設備按成本減累計折舊及減值虧損入賬。物業、廠房及設備項目的成本包括其購買價及任何使資產達致其使用狀態及現存地點作預定用途所產生的直接應佔成本。維修及保養開支乃於其產生的期間內於損益中支銷。

物業、廠房及設備於下述估計可使用年期內，在考慮到其估計剩餘價值後，由其可供使用之日起以直線法計算折舊，以撇銷成本減累計減值虧損。倘物業、廠房及設備項目之各部分擁有不同的可使用年期，該項目之成本或估值會獨立按合理基準分配及計算折舊：

Investment properties are properties that are held by owner to earn rental income and/or for capital appreciation. These include properties held for a currently undetermined future use and properties that are held under operating lease, which satisfy the definition of investment property and carry at fair value.

Investment properties are stated at fair value at the end of the reporting period. Any gain or loss arising from a change in fair value is recognised in profit or loss.

An investment property is derecognised upon disposal or when the investment property is permanently withdrawn from use and no future economic benefits are expected from its disposals. Any gain or loss arising on derecognition of the asset (calculated as the difference between the net disposal proceeds and the carrying amount of the asset) is included in profit or loss in the period in which the item is derecognised.

Forfeited collaterals held for sales

Forfeited collaterals are initially recognised at the amortised cost of the related outstanding loans on the date of repossession, which is generally below the net realisable value of the repossessed assets. Upon repossession of the assets, the related loans and advances together with the related impairment allowances, if any, are derecognised from the consolidated statement of financial position. Subsequently, forfeited collaterals are carried at the lower of the amount initially recognised or net realisable value and are therefore written down if and when the net realisable value falls to below the carrying amount of the asset. The excess of the net proceeds over the carrying amount of the forfeited collaterals is recognised as a gain upon the disposal of the assets.

Financial instruments**Financial assets*****Recognition and derecognition***

Financial assets are recognised when and only when the Group becomes a party to the contractual provisions of the instruments and on a trade date basis.

A financial asset is derecognised when and only when (i) the Group's contractual rights to future cash flows from the financial asset expire or (ii) the Group transfers the financial asset and either (a) it transfers substantially all the risks and rewards of ownership of the financial asset, or (b) it neither transfers nor retains substantially all the risks and rewards of ownership of the financial asset but it does not retain control of the financial asset.

If the Group retains substantially all the risks and rewards of ownership of a transferred financial asset, the Group continues to recognise the financial asset.

If the Group neither transfers nor retains substantially all the risks and rewards of ownership and continues to control the transferred asset, the Group recognises the financial asset to the extent of its continuing involvement and an associated liability for amounts it may have to pay.

Classification and measurement

Financial assets (except for trade receivables without a significant financing component which are initially measured at their transaction price) are initially recognised at their fair value plus, in the case of financial assets not carried at FVPL, transaction costs that are directly attributable to the acquisition of the financial assets.

On initial recognition, a financial asset is classified as (i) measured at amortised cost; (ii) debt investment measured at FVOCI; (iii) equity investment measured at FVOCI ("Designated FVOCI"); or (iv) measured at FVPL.

投資物業乃由業主持有以賺取租金收入及／或實現資本增值之物業，包括持有現時未釐定將來用途之物業以及根據經營租約持有之物業，而此等物業須符合投資物業之定義並按公平值列賬。

投資物業乃按於報告期末之公平值列賬。因公平值變動而產生之任何損益乃於損益確認。

投資物業乃自出售起或投資物業永不再使用並預期出售投資物業將不會產生未來經濟利益時終止確認。終止確認該物業時產生之任何收益或虧損(以出售所得款項淨額與資產之賬面值之差額計算)乃計入該項目終止確認期間之損益。

待售被沒收抵押品

被沒收抵押品最初按相關尚未償還貸款於收回日之攤銷成本確認，一般低於經收回資產之可變現淨值。於收回資產後，有關貸款及墊款連同相關減值撥備(如有)自綜合財務狀況表取消確認。其後，倘可變現淨值降至低於資產賬面值時，則被沒收抵押品按最初已確認金額或可變現淨值之較低者入賬，並就此作出撇減。於出售資產後，所得款項淨額超過被沒收抵押品賬面值之差額認為收益。

財務工具**金融資產*****確認及終止確認***

金融資產乃當及僅當本集團成為工具合約條文的訂約方時按交易日基準確認。

金融資產於且僅於以下情況時取消確認：(i)本集團對金融資產產生的未來現金流的合約權利屆滿時；或(ii)本集團轉讓金融資產及(a)本集團已轉移金融資產擁有權的絕大部分風險及回報；或(b)本集團既無轉移亦無保留該項金融資產擁有權的絕大部分風險及回報，但並無保留該項金融資產之控制權時。

倘本集團保留所轉讓金融資產之擁有權之絕大部分風險及回報，則本集團繼續確認該金融資產。

倘本集團既無轉讓亦無保留擁有權之絕大部分風險及回報，並繼續控制所轉讓資產，則本集團以其持續參與程度及其可能須支付相關負債之金額為限確認金融資產。

分類及計量

金融資產(沒有重大融資成分的初步按交易價格計量之貿易應收款項除外)初步按公平值加(就並非透過損益按公平值列賬的金融資產而言)直接歸屬於收購金融資產的交易成本確認。

於初步確認時，金融資產分類為(i)按攤銷成本計量；(ii)透按公平值計入其他全面收益計量之債務投資；(iii)按公平值計入其他全面收益計量之股本投資(「指定按公平值計入其他全面收益」)；或(iv)透過損益按公平值列賬。

The classification of financial assets at initial recognition depends on the Group's business model for managing the financial assets and the financial asset's contractual cash flow characteristics. Financial assets are not reclassified subsequent to their initial recognition unless the Group changes its business model for managing them, in which case all affected financial assets are reclassified on the first day of the first annual reporting period following the change in the business model.

1) Financial assets measured at amortised cost

A financial asset is measured at amortised cost if it meets both of the following conditions and is not designated as FVPL:

- (i) it is held within a business model whose objective is to hold financial assets in order to collect contractual cash flows; and
- (ii) its contractual terms give rise on specified dates to cash flows that are solely payments of principal and interest on the principal amount outstanding.

Financial assets at amortised cost are subsequently measured using the effective interest method and are subject to impairment. Gains and losses arising from impairment, derecognition or through the amortisation process are recognised in profit or loss.

The Group's financial assets at amortised cost include accounts receivable, loan receivables, deposits, prepayments and other receivables, and bank balances and cash.

2) Designated FVOCI

Upon initial recognition, the Group may make an irrevocable election to present subsequent changes in the fair value of an investment in an equity instrument that is neither held for trading nor contingent consideration recognised by an acquirer in a business combination to which HKFRS 3 applies in other comprehensive income. The classification is determined on an instrument-by-instrument basis.

These equity investments are subsequently measured at fair value and are not subject to impairment. Dividends are recognised in profit or loss unless the dividend clearly represents a recovery of part of the cost of the investment. Other gains or losses are recognised in other comprehensive income and shall not be subsequently reclassified to profit or loss. Upon derecognition, the cumulative gain or loss is transferred directly to accumulated profits or losses.

The Group's financial assets at Designated FVOCI include unlisted equity investments not held for trading.

3) Financial assets at FVPL

These investments include financial assets that are not measured at amortised cost or FVOCI, including financial assets held for trading, financial assets designated upon initial recognition as at FVPL, financial assets resulting from a contingent consideration arrangement in a business combination to which HKFRS 3 applies and financial assets that are otherwise required to be measured at FVPL. They are carried at fair value, with any resultant gain or loss recognised in profit or loss, which does not include any dividend or interest earned on the financial assets. Dividend or interest income is presented separately from fair value gain or loss.

於初步確認後，本集團或會作出不可撤銷選擇，以呈列權益工具投資公平值的其後變動。該等權益工具並非為持作買賣亦並無由收購人於業務合併(就此香港財務報告準則第3號適用於其他全面收益)內確認為或然代價。該分類乃按工具基準釐定。

該等權益投資其後按公平值計量且毋須作出減值。除非股息明確表明可收回部分投資成本，否則股息於損益確認。其他收益或虧損於其他全面收益確認，且其後不會重新分類至損益。於終止確認時，累計收益或虧損直接轉移至累計損益。

A financial asset is classified as held for trading if it is:

- (i) acquired principally for the purpose of selling it in the near term;
- (ii) part of a portfolio of identified financial instruments that are managed together and for which there is evidence of a recent actual pattern of short-term profit-taking on initial recognition; or
- (iii) a derivative that is not a financial guarantee contract or not a designated and effective hedging instrument.

Financial assets are designated at initial recognition as at FVPL only if doing so eliminates or significantly reduces a measurement or recognition inconsistency that would otherwise arise from measuring assets or liabilities or recognising the gains or losses on them on different bases.

The Group's financial assets measured at FVPL include listed equity securities and unlisted debt securities of club memberships.

Financial liabilities*Recognition and derecognition*

Financial liabilities are recognised when and only when the Group becomes a party to the contractual provisions of the instruments.

A financial liability is derecognised when and only when the liability is extinguished, that is, when the obligation specified in the relevant contract is discharged, cancelled or expired.

Classification and measurement

Financial liabilities are initially recognised at their fair value plus, in the case of financial liabilities not carried at FVPL, transaction costs that are direct attributable to the issue of the financial liabilities.

The Group's financial liabilities include accruals and deposits received and bank borrowings. All financial liabilities are recognised initially at their fair value and subsequently measured at amortised cost, using the effective interest method, unless the effect of discounting would be insignificant, in which case they are stated at cost.

Impairment of financial assets and other items under HKFRS 9

The Group recognises loss allowance for expected credit losses ("ECL") on financial assets that are measured at amortised cost and contract assets to which the impairment requirements apply in accordance with HKFRS 9. Except for the specific treatments as detailed below, at each reporting date, the Group measures a loss allowance for a financial asset at an amount equal to the lifetime ECL if the credit risk on that financial asset has increased significantly since initial recognition. If the credit risk on a financial asset has not increased significantly since initial recognition, the Group measures the loss allowance for that financial asset at an amount equal to 12-month ECL.

Measurement of ECL

ECL is a probability-weighted estimate of credit losses (i.e. the present value of all cash shortfalls) over the expected life of the financial instrument.

For financial assets, a credit loss is the present value of the difference between the contractual cash flows that are due to an entity under the contract and the cash flows that the entity expects to receive.

Lifetime ECL represents the ECL that will result from all possible default events over the expected life of a financial instrument while 12-month ECL represents the portion of lifetime ECL that is expected to result from default events on a financial instrument that are possible within 12 months after the reporting date.

Where ECL is measured on a collective basis, the financial instruments are grouped based on the following one or more shared credit risk characteristics:

- (i) past due information
- (ii) nature of instrument
- (iii) nature of collateral
- (iv) industry of debtors
- (v) geographical location of debtors
- (vi) external credit risk ratings

Loss allowance is remeasured at each reporting date to reflect changes in the financial instrument's credit risk and loss since initial recognition. The resulting changes in the loss allowance are recognised as an impairment gain or loss in profit or loss with a corresponding adjustment to the carrying amount of the financial instrument.

Definition of default

The Group considers the following as constituting an event of default for internal credit risk management purposes as historical experience indicates that the Group may not receive the outstanding contractual amounts in full if the financial asset that meets any of the following criteria.

- (i) information developed internally or obtained from external sources indicates that the debtor is unlikely to pay its creditors, including the Group, in full (without taking into account any collaterals held by the Group); or
- (ii) there is a breach of financial covenants by the counterparty.

Irrespective of the above analysis, the Group considers that default has occurred when a financial asset is more than 90 days past due unless the Group has reasonable and supportable information to demonstrate that a more lagging default criterion is more appropriate.

In assessing whether the credit risk on a financial instrument has increased significantly since initial recognition, the Group compares the risk of a default occurring on the financial instrument at the reporting date with the risk of a default occurring on the financial instrument at the date of initial recognition. In making this assessment, the Group considers both quantitative and qualitative information that is reasonable and supportable, including historical experience and forward-looking information that is available without undue cost or effort. In particular, the following information is taken into account in the assessment:

- the debtor's failure to make payments of principal or interest on the due dates;
- an actual or expected significant deterioration in the financial instrument's external or internal credit rating (if available);
- an actual or expected significant deterioration in the operating results of the debtor; and
- actual or expected changes in the technological, market, economic or legal environment that have or may have a significant adverse effect on the debtor's ability to meet its obligation to the Group.

Irrespective of the outcome of the above assessment, the Group presumes that the credit risk on a financial instrument has increased significantly since initial recognition when contractual payments are more than 30 days past due.

Notwithstanding the foregoing, the Group assumes that the credit risk on a financial instrument has not increased significantly since initial recognition if the financial instrument is determined to have low credit risk at the reporting date.

Low credit risk

A financial instrument is determined to have low credit risk if:

- (i) it has a low risk of default;
- (ii) the borrower has a strong capacity to meet its contractual cash flow obligations in the near term; and
- (iii) adverse changes in economic and business conditions in the longer term may, but will not necessarily, reduce the ability of the borrower to fulfil its contractual cash flow obligations.

Bank balances and cash are determined to have low credit risk.

Simplified approach of ECL

For accounts receivable and contract assets without a significant financing component or otherwise for which the Group applies the practical expedient not to account for the significant financing components, the Group applies a simplified approach in calculating ECL. The Group recognises a loss allowance based on lifetime ECL at each reporting date and has established a provision matrix that is based on its historical credit loss experience, adjusted for forward-looking factors specific to the debtors and the economic environment.

Credit-impaired financial asset

A financial asset is credit-impaired when one or more events that have a detrimental impact on the estimated future cash flows of that financial asset have occurred. Evidence that a financial asset is credit-impaired includes observable data about the following events:

- significant financial difficulty of the issuer or the borrower;
- a breach of contract, such as a default or past due event;
- the lender(s) of the borrower, for economic or contractual reasons relating to the borrower's financial difficulty, having granted to the borrower a concession(s) that the lender(s) would not otherwise consider;
- it is becoming probable that the borrower will enter bankruptcy or other financial reorganisation;
- the disappearance of an active market for that financial asset because of financial difficulties; or
- the purchase or origination of a financial asset at a deep discount that reflects the incurred credit losses.

Write-off

The Group writes off a financial asset when the Group has no reasonable expectations of recovering the contractual cash flows on a financial asset in its entirety or a portion thereof. The Group has a policy of writing off the gross carrying amount based on historical experience of recoveries of similar assets. The Group expects no significant recovery from the amount written off. However, financial assets that are written off could still be subject to enforcement activities under the Group's procedures for recovery of amounts due, taking into account legal advice if appropriate. Any subsequent recovery is recognised in profit or loss.

Cash equivalents

For the purpose of the consolidated statement of cash flows, cash equivalents represent short-term highly liquid investments which are readily convertible into known amounts of cash and which are subject to an insignificant risk of changes in value.

Revenue recognition

Rental income

Rental income under operating leases is recognised when the assets are let out and on the straight-line basis over the lease term. Variable lease payments that depend on an index or a rate are initially measured using the index or rate at the commencement date and subsequently adjusted when such index or rate changes. Such payments are recognised as income on the straight-line basis over the lease term. Other variable lease payments are recognised as income in the period in which the event or condition that triggers those payments occurs.

Dividend income

Dividend income from financial assets is recognised when the Group's rights to receive dividend is established, it is probable that the economic benefits associated with the dividend will flow to the Group and the amount of the dividend can be measured reliably. Dividend income from investments is recognised when the shareholders' rights to receive payments have been established.

Disposal of forfeited collaterals held for sale

Disposal gain or loss is recognised when the buyer of the forfeited collaterals take control of and accepts the goods.

現金等值項目

就綜合現金流量表而言，現金等值項目指短期高流通量投資，其可隨時轉換為已知金額之現金，且須承受之價值變動風險不屬重大。

收益確認

租金收入

經營租賃項下之租金收入於資產出租時及於租期內以直線法確認。取決於某一指數或比率之可變租賃付款於開始日期初步使用該指數或比率計量，並其後於該指數或比率變動時作出調整。該等付款於租期內以直線法確認為收入。其他可變租賃付款於觸發該等付款之事件或狀況出現期間確認為收入。

股息收入

當本集團收取股息的權利獲確立後，來自金融資產的股息收入乃被確認，即股息相關經濟利益很有可能流向本集團，且股息金額能可靠計量。投資股息收入於股東收取款項之權利確立時確認。

The nature of the goods or services provided by the Group is provision of technology & management services and financial consultancy services.

Identification of performance obligations

At contract inception, the Group assesses the goods or services promised in a contract with a customer and identifies as a performance obligation each promise to transfer to the customer either:

- (a) a good or service (or a bundle of goods or services) that is distinct; or
- (b) a series of distinct goods or services that are substantially the same and that have the same pattern of transfer to the customer.

A good or service that is promised to a customer is distinct if both of the following criteria are met:

- (a) the customer can benefit from the good or service either on its own or together with other resources that are readily available to the customer (i.e. the good or service is capable of being distinct); and
- (b) the Group's promise to transfer the good or service to the customer is separately identifiable from other promises in the contract (i.e. the promise to transfer the good or service is distinct within the context of the contract).

Timing of revenue recognition

Revenue is recognised when (or as) the Group satisfies a performance obligation by transferring a promised good or service (i.e. an asset) to a customer. An asset is transferred when (or as) the customer obtains control of that asset.

The Group transfers control of a good or service over time and, therefore, satisfies a performance obligation and recognises revenue over time, if one of the following criteria is met:

- (a) the customer simultaneously receives and consumes the benefits provided by the Group's performance as the Group performs;
- (b) the Group's performance creates or enhances an asset (for example, work in progress) that the customer controls as the asset is created or enhanced; or
- (c) the Group's performance does not create an asset with an alternative use to the Group and the Group has an enforceable right to payment for performance completed to date.

If a performance obligation is not satisfied over time, the Group satisfies the performance obligation at a point in time when the customer obtains control of the promised asset. In determining when the transfer of control occurs, the Group considers the concept of control and such indicators as legal title, physical possession, right to payment, significant risks and rewards of ownership of the asset, and customer acceptance.

Revenue from provision of technology & management services is recognised at a point in time in the accounting period when the actual service provided.

Commission income from provision of financial consultancy services on capital funding is recognised at a point in time in accordance with the terms of the underlying agreement or deal mandate when relevant significant act has been completed.

提供資本融資金融諮詢服務之佣金收入於完成相關重大行動時根據相關協議或交易授權之條款隨時間確認。

Transaction price: significant financing components

When the contract contains a significant financing component (i.e. the customer or the Group is provided with a significant benefit of financing the transfer of goods or services to the customer), in determining the transaction price, the Group adjusts the promised consideration for the effects of the time value of money. The effect of the significant financing component is recognised as an interest income or interest expense separately from revenue from contracts with customers in profit or loss.

The Group has applied the practical expedient in paragraph 63 of HKFRS 15 and does not adjust the consideration for the effect of the significant financing component if the period of financing is one year or less.

Interest income

Interest income from financial assets is recognised using the effective interest method. For financial assets measured at amortised cost that are not credit-impaired, the effective interest rate is applied to the gross carrying amount of the assets while it is applied to the amortised cost (i.e. the gross carrying amount net of loss allowance) in case of credit-impaired financial assets.

Contract assets and contract liabilities

If the Group performs by transferring goods or services to a customer before the customer pays consideration or before payment is due, the contract is presented as a contract asset, excluding any amounts presented as a receivable. Conversely, if a customer pays consideration, or the Group has a right to an amount of consideration that is unconditional, before the Group transfers a good or service to the customer, the contract is presented as a contract liability when the payment is made or the payment is due (whichever is earlier). A receivable is the Group's right to consideration that is unconditional or only the passage of time is required before payment of that consideration is due.

For a single contract or a single set of related contracts, either a net contract asset or a net contract liability is presented. Contract assets and contract liabilities of unrelated contracts are not presented on a net basis.

Foreign currency translation

Items included in the financial statements of each of the Group's entities are measured using the currency of the primary economic environment in which the entity operates (the "functional currency"). The consolidated financial statements are presented in the currency of HK\$, which is also the functional currency of the Company and most of the subsidiaries, and rounded to the nearest thousands unless otherwise indicated.

Foreign currency transactions are translated into the functional currency using the exchange rates prevailing at the dates of the transactions. Foreign exchange gains and losses resulting from the settlement of such transactions and from the translation at period-end exchange rates of monetary assets and liabilities denominated in foreign currencies are recognised in profit or loss. Foreign exchange gains and losses resulting from the retranslation of non-monetary items carried at fair value are recognised in profit or loss except for those arising on the retranslation of non-monetary items in respect of which gains and losses are recognised directly in equity, in which cases, the gains or losses are also recognised directly in equity.

來自金融資產之利息收入使用實際利率法確認。就按攤銷成本計量且並無信貸減值之金融資產而言，實際利率適用於資產之總賬面值，而就具信貸減值之金融資產而言，其適用於攤銷成本(即扣除虧損撥備之總賬面值)。

合約資產及合約負債

倘本集團透過於客戶支付代價前或在付款到期應付前將貨品或服務轉移予客戶，合約將呈列為合約資產，不包括呈列為應收款項之任何金額。相反，倘客戶支付代價，或本集團有權無條件取得代價金額，則於本集團向客戶轉讓貨品或服務前，合約將於作出付款或付款到期應付(以較早者為準)時呈列為合約負債。應收款項為本集團無條件或在支付到期代價前所需時間流逝之取得代價權利。

單一合約或一組相關合約以合約資產淨值或合約負債淨額呈列。無關合約之合約資產及合約負債並不按淨額基準呈列。

外幣換算

本集團各實體之財務報表所列項目乃按實體經營所在之主要經濟環境之貨幣(「功能貨幣」)計量。綜合財務報表以港元呈列，港元亦為本公司及大部分附屬公司的功能貨幣，除另有指明外已湊整至最接近之千位。

外幣交易均按交易當日之現行匯率換算為功能貨幣。因該等交易結算及按期末匯率換算以外幣計值之貨幣資產及負債而產生之匯兌損益，均於損益中確認。因重新換算按公平值列賬之非貨幣項目產生之匯兌損益於損益中確認，惟因重新換算其損益直接於權益中確認之非貨幣項目除外，在該情況下，損益亦直接於權益中確認。

The results and financial position of all the group entities that have a functional currency different from the presentation currency ("foreign operations") are translated into the presentation currency as follows:

- assets and liabilities for each statement of financial position presented are translated at the closing rate at the end of the reporting period;
- income and expenses for each statement of profit or loss and other comprehensive income are translated at average exchange rate;
- all resulting exchange differences arising from the above translation and exchange differences arising from a monetary item that forms part of the Group's net investment in a foreign operation are recognised as a separate component of equity;
- on the disposal of a foreign operation, which includes a disposal of the Group's entire interest in a foreign operation, a disposal involving the loss of control over a subsidiary that includes a foreign operation, or a partial disposal of an interest in a joint arrangement or an associate that includes a foreign operation of which the retained interest is no longer equity-accounted for, the cumulative amount of the exchange differences relating to the foreign operation that is recognised in other comprehensive income and accumulated in the separate component of equity is reclassified from equity to profit or loss when the gain or loss on disposal is recognised;
- on the partial disposal of the Group's interest in a subsidiary that includes a foreign operation which does not result in the Group losing control over the subsidiary, the proportionate share of the cumulative amount of the exchange differences recognised in the separate component of equity is re-attributed to the non-controlling interests in that foreign operation and are not reclassified to profit or loss; and
- on all other partial disposals, which includes partial disposal of associates that do not result in the Group losing significant influence, the proportionate share of the cumulative amount of exchange differences recognised in the separate component of equity is reclassified to profit or loss.

Impairment of non-financial assets, other than goodwill

At the end of each reporting period, the Group reviews internal and external sources of information to assess whether there is any indication that the Group's property, plant and equipment (including right-of-use assets) and the Company's investment in subsidiaries may be impaired or impairment loss previously recognised no longer exists or may be reduced. If any such indication exists, the recoverable amount of the asset is estimated, based on the higher of its fair value less costs of disposal and value in use. Where it is not possible to estimate the recoverable amount of an individual asset, the Group estimates the recoverable amount of the smallest group of assets that generates cash flows independently (i.e. cash-generating unit).

If the recoverable amount of an asset or a cash-generating unit is estimated to be less than its carrying amount, the carrying amount of the asset or cash-generating unit is reduced to its recoverable amount. Impairment losses are recognised as an expense in profit or loss immediately.

A reversal of impairment loss is limited to the carrying amount of the asset or cash-generating unit that would have been determined had no impairment loss been recognised in prior periods. Reversal of impairment loss is recognised as an income in profit or loss immediately.

Government grants

Government grants are recognised at their fair value where there is reasonable assurance that the grant will be received and all attaching conditions will be complied with. When the grant relates to an expense item, it is recognised as income over the years necessary to match the grant on a systematic basis to the costs that it is intended to compensate. Where the grant relates to an asset, the fair value is credited to a deferred income account/recognised as a deduction from the carrying amount of the relevant asset and is released to profit or loss over the expected useful life of the relevant asset by equal annual instalments.

所有功能貨幣有別於呈列貨幣之集團實體之業績及財務狀況(「海外業務」)均按以下方式換算為呈列貨幣:

- 於各財務狀況表呈列之資產及負債乃按報告期末之收市匯率換算;
- 於各損益及其他全面收益表呈列之收入及開支乃按平均匯率換算;
- 所有因以上換算產生之匯兌差額及因構成本集團於海外業務之淨投資一部分之貨幣項目產生之匯兌差額,均於權益內以獨立項目入賬;
- 出售海外業務時(包括出售本集團於海外業務的全部權益,涉及失去包含海外業務的附屬公司的控制權的出售事項,或出售包含外國業務而其保留權益不再以權益入賬之合營安排或聯營公司之部分權益),與有關海外業務相關而於其他全面收入中確認並於權益中個別部分累計的匯兌差額累計金額,於確認出售損益時由權益重新分類至損益;

除商譽外之非金融資產減值

於各報告期末,本集團會審閱內部及外間資訊資源,以評估是否有跡象顯示本集團的物業、廠房及設備(包括使用權資產)以本公司於附屬公司之投資可能出現減值,或之前確認的減值虧損是否已不再存在或可能減少。若出現任何有關跡象,將會根據資產的公平值減出售成本及使用價值(以較高者為準)估計資產的可收回金額。如未能估計個別資產的可收回金額,則本集團會估計能獨立產生現金流量的最小組別資產(即現金產生單位)的可收回金額。

倘本集團估計某項資產或現金產生單位的可收回金額將低於其賬面值,則該項資產或現金產生單位的賬面值會下調至其可收回金額。減值虧損即時於損益內確認為開支。

所撥回的減值虧損以該項資產或現金產生單在以往期間並無確認減值虧損而原應釐定的賬面值為限。減值虧損撥回即時於損益中確認為收入。

政府補助

倘能合理保證將可收取政府補助及將符合所有附帶條件,則政府補助按其公平值確認。倘補助與開支項目有關,則按有系統基準將補助與其擬補償之成本配合之年度確認為收入。倘補助與資產有關,則公平值計入遞延收入賬/確認為相關資產賬面值之扣減,並於有關資產之預期可用年限中按等額年金撥往損益。

The lease payments included in the measurement of the lease liability comprise the following payments for the right to use the underlying asset during the lease term that are not paid at the commencement date:

- (a) fixed payments (including in-substance fixed payments), less any lease incentives receivable;
- (b) variable lease payments that depend on an index or a rate;
- (c) amounts expected to be payable under residual value guarantees;
- (d) exercise price of a purchase option if the Group is reasonably certain to exercise that option; and
- (e) payments of penalties for terminating the lease, if the lease term reflects the Group exercising an option to terminate the lease.

The lease payments are discounted using the interest rate implicit in the lease, or where it is not readily determinable, the incremental borrowing rate of the lessee.

Subsequently, the lease liability is measured by increasing the carrying amount to reflect interest on the lease liability and by reducing the carrying amount to reflect the lease payments made.

The lease liability is remeasured using a revised discount rate when there are changes to the lease payments arising from a change in the lease term or the reassessment of whether the Group will be reasonably certain to exercise a purchase option.

The lease liability is remeasured by using the original discount rate when there is a change in the residual value guarantee, the in-substance fixed lease payments or the future lease payments resulting from a change in an index or a rate (other than floating interest rate). In case of a change in future lease payments resulting from a change in floating interest rates, the Group remeasures the lease liability using a revised discount rate.

The Group recognises the amount of the remeasurement of the lease liability as an adjustment to the right-of-use asset. If the carrying amount of the right-of-use asset is reduced to zero and there is a further reduction in the measurement of the lease liability, the Group recognises any remaining amount of the remeasurement in profit or loss.

As lessor

The Group classifies each of its leases as either a finance lease or an operating lease at the inception date of the lease. A lease is classified as a finance lease if it transfers substantially all the risks and rewards incidental to ownership of the underlying asset. All other leases are classified as operating leases.

The Group accounts for each lease component within a lease contract as a lease separately from non-lease components of the contract. The Group allocates the consideration in the contract to each lease component on a relative stand-alone price basis.

As lessor – operating lease

The Group applies the derecognition and impairment requirements in HKFRS 9 to the operating lease receivables.

A modification to an operating lease is accounted for as a new lease from the effective date of the modification, considering any prepaid or accrued lease payments relating to the original lease as part of the lease payments for the new lease.

租賃付款使用租賃的隱含利率貼現，或倘該利率無法可靠地釐定，則採用承租人之增量借款利率。

隨後，租賃負債透過增加賬面值以反映租賃負債之利息及調減賬面值以反映已付的租賃付款進行計量。

當租期出現變動而產生租賃付款變動或重新評估本集團是否將合理確定行使購買選擇權時，租賃負債使用經修訂貼現率進行重新計量。

倘剩餘價值擔保、實質性固定租賃付款出現變動或一項指數或利率有變(浮動利率除外)而導致未來租賃付款出現變動，則使用原貼現率重新計量租賃負債。倘浮動利率有變而導致未來租賃付款出現變動，則本集團使用經修訂貼現率重新計量租賃負債。

本集團將租賃負債之重新計量金額確認為對使用權資產之調整。倘使用權資產賬面值減少至零且租賃負債計量有進一步調減，本集團將於損益中確認任何重新計量之剩餘金額。

作為出租人

本集團於租賃開始日期將租賃各自分類為融資租賃或經營租賃。倘租賃將相關資產之擁有權的絕大部分風險及回報轉移，則分類為融資租賃。所有其他租賃均分類為經營租賃。

本集團對於租賃合約內各個租賃組成部分入賬列作獨立於合約非租賃部分的一項租賃。本集團根據相對單獨價格將合約代價分配至各個租賃組成部分。

作為出租人 – 經營租賃

本集團將香港財務報告準則第9號終止確認及減值規定應用於經營租賃應收款項。

經營租賃之修改自該修改生效日期起入賬作為新租賃，而與原租賃相關之任何預付或應計租賃付款則作為新租賃租賃付款之一部分。

Employee benefits

Short term employee benefits

Salaries, annual bonuses, paid annual leave, and the cost of non-monetary benefits are accrued in the period in which the associated services are rendered by employees.

Defined contribution plans

The obligations for contributions to defined contribution retirement scheme are recognised as an expense in profit or loss as incurred. The assets of the scheme are held separately from those of the Group in an independently administered fund.

In accordance with the rules and regulations in the People's Republic of China (the "PRC"), the employees of the Group's entities established in the PRC are required to participate in defined contribution retirement plans organised by local governments. Contributions to these plans are expensed in profit or loss as incurred and other than these monthly contributions, the Group has no further obligation for the payment of retirement benefits to its employees.

Termination benefits

Termination benefits are recognised when, and only when, the Group demonstrably commits itself to terminate employment or to provide benefits as a result of voluntary redundancy by having a detailed formal plan which is without realistic possibility of withdrawal.

Share-based payment transactions

Equity-settled transactions

The fair value of services received determined by reference to the fair value of share options granted at the grant date is expensed on a straight-line basis over the vesting period, with a corresponding increase in capital reserve within equity.

At the end of each reporting period, the Group revises its estimates of the number of options that are expected to ultimately vest. The impact of the revision of the estimates, if any, is recognised in profit or loss with a corresponding adjustment to share options reserve.

At the time when the share options are exercised, the amount previously recognised in share options reserve will be transferred to share premium. When the share options are forfeited after the vesting date or are still not exercised at the expiry date, the amount previously recognised in share options reserve will be transferred to retained profits.

Where an equity-settled award is cancelled, it is treated as if it had vested on the date of cancellation, and any expense not yet recognised for the award is recognised immediately. However, if a new award is substituted for the cancelled award and designated as a replacement award on the date that it is granted, the cancelled and new awards are treated as if they were a modification of the original award.

短期僱員福利

薪金、年度花紅、有薪年假及非現金福利成本乃於僱員提供相關服務的期間累計。

定額供款計劃

向定額供款計劃作出供款的責任在產生時於損益內確認為開支。計劃資產與本集團的資產分開，由獨立管理的基金持有。

根據中華人民共和國(「中國」)規則及規例，本集團於中國成立的實體的僱員需要參與由地方政府設立的定額供款退休計劃。向該等計劃作出的供款在產生時於損益內支銷，而除該等每月供款外，本集團再無為僱員退休福利付款的其他責任。

終止福利

本集團於明確就終止僱用作出承擔或因在一項實際上不可能撤回的詳細正式計劃下僱員自願離職而提供利益及僅在此情況下，方始確認終止福利。

以股份支付交易

以權益結算的交易

所獲服務之公平值乃參考股份期權於授出日期之公平值釐定，以直線法於歸屬期內確認為開支，並於權益中的股份期權儲備中作出相應增加。

於各報告期末，本集團修訂其對預期最終歸屬之股份期權數目之估計。估計修訂之影響(如有)於損益確認，並於股份期權儲備作出相應調整。

於股份期權獲行使時，先前於股份期權儲備確認之數額，將轉撥至股份溢價。倘股份期權於歸屬日期後被沒收，或於到期日仍未行使，先前於股份期權儲備確認之數額，將撥至保留溢利。

倘權益結算獎勵被註銷，則被視為已於註銷日期歸屬，而任何尚未就獎勵確認之開支均即時確認。然而，倘授出新獎勵代替已註銷獎勵，並於授出日期指定為替代獎勵，則已註銷及新獎勵均被視為原有獎勵之修訂。

The charge for current income tax is based on the results for the period as adjusted for items that are non-assessable or disallowed. It is calculated using tax rates that have been enacted or substantively enacted by the end of the reporting period.

Deferred tax is provided, using the liability method, on all temporary differences at the end of the reporting period between the tax bases of assets and liabilities and their carrying amounts in the consolidated financial statements. However, any deferred tax arising from initial recognition of goodwill; or other asset or liability in a transaction other than a business combination that at the time of the transaction affects neither the accounting profit nor taxable profit or loss is not recognised.

The deferred tax assets and liabilities are measured at the tax rates that are expected to apply to the period when the asset is recovered or the liability is settled, based on tax rates and tax laws that have been enacted or substantively enacted at the end of the reporting period.

Deferred tax assets are recognised to the extent that it is probable that future taxable profit will be available against which the deductible temporary differences, tax losses and credits can be utilised.

Deferred tax is provided on temporary differences arising on investment in subsidiaries except where the timing of the reversal of the temporary differences is controlled by the Group and it is probable that the temporary difference will not reverse in the foreseeable future.

Related parties

A related party is a person or entity that is related to the Group,

- (a) A person or a close member of that person's family is related to the Group if that person:
- (i) has control or joint control over the Group;
 - (ii) has significant influence over the Group; or
 - (iii) is a member of the key management personnel of the Group or of a holding company of the Group.
- (b) An entity is related to the Group if any of the following conditions applies:
- (i) the entity and the Group are members of the same group (which means that each holding company, subsidiary and fellow subsidiary is related to the others).
 - (ii) one entity is an associate or joint venture of the other entity (or an associate or joint venture of a member of a group of which the other entity is a member).
 - (iii) both entities are joint ventures of the same third party.
 - (iv) one entity is a joint venture of a third entity and the other entity is an associate of the third entity.
 - (v) the entity is a post-employment benefit plan for the benefit of employees of either the Group or an entity related to the Group. If the Group is itself such a plan, the sponsoring employers are also related to the Group.
 - (vi) the entity is controlled or jointly controlled by a person identified in (a).
 - (vii) a person identified in (a)(i) has significant influence over the entity or is a member of the key management personnel of the entity (or of a holding company of the entity).
 - (viii) the entity, or any member of a group of which it is a part, provides key management personnel services to the Group or to the holding company of the Group.

即期所得稅支出乃根據期內業績計算，並就毋須課稅或不可扣減項目作出調整。計算時所使用之稅率為於各報告期末已頒行或實際上已頒行之稅率。

遞延稅項乃就資產及負債之稅基與其於綜合財務報表內所示之賬面值於各報告期末之所有暫時性差額，採用負債法計提撥備。然而，初步確認商譽或一項交易(業務合併除外)中之其他資產或負債所產生之任何遞延稅項，倘其於交易時不影響會計溢利或應課稅溢利或虧損，則不會確認。

遞延稅項資產及負債乃根據於各報告期末已頒行或實際上已頒行之稅率及稅法，按收回資產或清還負債之期間預期適用之稅率計量。

倘可能有未來應課稅溢利可用作抵銷可扣減暫時性差額、稅項虧損及抵免，則會確認遞延稅項資產。

遞延稅項乃就於附屬公司之投資產生之暫時性差額計提撥備，惟暫時性差額撥回之時間由本集團控制及暫時性差額於可見將來很可能不會被撥回則除外。

Related parties (Continued)

Close members of the family of a person are those family members who may be expected to influence, or be influenced by, that person in their dealings with the entity and include:

- (a) that person's children and spouse or domestic partner;
- (b) children of that person's spouse or domestic partner; and
- (c) dependants of that person or that person's spouse or domestic partner.

In the definition of a related party, an associate includes subsidiaries of the associate and a joint venture includes subsidiaries of the joint venture.

Segment reporting

Operating segments, and the amounts of each segment item reported in the consolidated financial statements, are identified from the financial information provided regularly to the Group's most senior executive management, which is the Group's chief operating decision maker, for the purpose of allocating resources to, and assessing the performance of, the Group's various lines of business and geographical locations.

Individual material operating segments are not aggregated for financial reporting purposes unless the segments have similar economic characteristics and are similar in respect of the nature of products and services, the nature of production processes, the type or class of customers, the methods used to distribute the products or provide the services, and the nature of the regulatory environment. Operating segments which are not individually material may be aggregated if they share a majority of these criteria.

Critical accounting estimates and judgements

Estimates and assumptions concerning the future and judgements are made by the management of the Group in the preparation of the consolidated financial statements. They affect the application of the Group's accounting policies, reported amounts of assets, liabilities, income and expenses, and disclosures made. They are assessed on an on-going basis and are based on experience and relevant factors, including expectations of future events that are believed to be reasonable under the circumstances. Where appropriate, revisions to accounting estimates are recognised in the period of revision and future periods, in case the revision also affects future periods.

Key sources of estimation uncertainty

(i) *Useful lives of property, plant and equipment (including right-of-use assets)*

The management of the Group determines the estimated useful lives of the Group's property, plant and equipment based on the historical experience of the actual useful lives of the relevant assets of similar nature and functions. The estimated useful lives could be different as a result of technical innovations which could affect the related depreciation charges included in profit or loss.

(ii) *Impairment of non-financial assets*

The management of the Group assesses whether there are any indicators of impairment for all non-financial assets, including property, plant and equipment (including right-of-use assets), at the end of each reporting period in accordance with the accounting policies as disclosed in Note 2 to the consolidated financial statements. In determining whether an asset is impaired or the event previously causing the impairment no longer exists, the management has to assess whether an event has occurred that may affect the asset value or such event affecting the asset value has not been in existence. If any such indication exists, the recoverable amounts of the asset would be determined as the greater of the fair value less costs of disposal and value in use, the calculations of which involve the use of estimates. Owing to inherent risk associated with estimations in the timing and amounts of the future cash flows and fair value less costs of disposal, the estimated recoverable amount of the asset may be different from the amount actually received and profit or loss could be affected by accuracy of the estimations.

關連人士(續)

一名個人的近親屬指預期可能影響該人士與該實體的往來或受此影響的家庭成員，包括：

- (a) 該人士的子女及配偶或家庭伴侶；

分類報告

個別重大之經營分類不會為財務報告目的而合計，除非有關分類具有類似經濟特性，並且具有類似之產品及服務性質、生產工序性質、客戶類型或類別、分銷產品或提供服務所用方法，以及監管環境性質。

個別非重大之經營分類倘符合上述大多數條件則可予合計。就財務報告而言，個別重大之經營分部不會彙集計算，惟擁有類似經濟特徵及在產品及服務性質、生產過程性質、客戶類別或種類、分銷產品或提供服務之方法以及監管環境性質方面類似之分部除外。個別不重大之經營分部倘具備大部分該等特質，亦可以彙集計算。

本集團管理層根據擁有類似性質及功能的相關資產的實際可使用年期的過往經驗，釐定本集團的物業、廠房及設備的估計可使用年期。估計可使用年期會因應技術革新而有所不同，並可能影響計入損益的相關折舊費用。

(ii) *非金融資產減值*

本集團管理層根據綜合財務報表附註2披露之會計政策於各報告期末評估是否有任何跡象顯示所有非金融資產(包括使用權資產)已出現減值。於釐定資產是否出現減值或過往導致減值之事件是否不再存在時，管理層須評估是否出現可能影響資產價值之事件，或該影響資產價值之事件是否不再存在。倘有跡象存在，資產可收回金額按公平值減出售成本與使用價值之較高者釐定，而有關計算涉及作出估計。由於未來現金流量及公平值減出售成本之時間及數額估計涉及固有風險，故該資產之估計可收回金額或會與實際收回金額有所不同，而此估計之準確度可能對損益造成影響。

The management of the Group estimates the loss allowance for financial assets at amortised cost including accounts receivable, loan receivables and deposits and other receivables by using various inputs and assumptions including risk of a default and expected loss rate. The estimation involves high degree of uncertainty which is based on the Group's historical information, recoverable amount of pledged collaterals, past collection history of debtors, concentration risk of debtors, the Group's actual loss experience, existing market conditions as well as forward-looking estimates at the end of each reporting period. Where the expectation is different from the original estimate, such difference will impact the carrying amount of the financial assets at amortised cost.

(iv) Fair value of investment properties

The fair value of investment properties located in Hong Kong, Macau and the PRC was determined by independent professional valuers. The valuation performed was arrived at with reference to recent market transaction prices at the end of reporting period and/or market rental value for similar properties at similar locations with total fair value of investment properties approximately HK\$243,828,000 at 30 April 2021 (2020: approximately HK\$245,428,000). Favourable or unfavourable changes to recent market prices would result in changes in the fair value of the Group's investment properties and corresponding adjustments to the amount of gain or loss reported in profit or loss.

(v) Fair value of financial assets at FVOCI

The fair value of financial assets at FVOCI that are not traded in active market is determined by valuation techniques. Fair value of financial assets at FVOCI is determined by independent professional valuer by using valuation techniques including the discounted cash flow valuation model. Valuation techniques that include inputs that are not based on observable market data and make assumptions that are primarily based on market conditions existing at the end of each reporting period.

(vi) Income taxes

Determining income tax provisions involves judgment on the future tax treatment of certain transactions. The Group carefully evaluates tax implications of transactions and tax provisions are set up accordingly. The tax treatment of such transactions is reconsidered periodically to take into account all changes in tax legislation. Deferred tax assets are recognised for deductible temporary differences and tax losses only to the extent that it is probable that future taxable profits will be available against which the deferred tax assets can be utilised. As a result, management's judgement is required to assess the probability of future taxable profits. Management reassesses these estimates at the end of each reporting period.

(iv) 投資物業之公平值

位於香港、澳門及中國的投資物業的公平值由獨立專業估值師釐定。估值乃參考於報告期末鄰近地點之同類物業的近期市場交易價格及/或市值租金而進行,於二零二一年四月三十日投資物業的總公平值約為243,828,000港元(二零二零年:約245,428,000港元)。近期市場價格的有利或不利變化可導致本集團投資物業之公平值出現變動並須對損益中匯報的收益或虧損金額作出相應調整。

(v) 按公平值計入其他全面收益之金融資產之公平值

不在活躍市場交易之按公平值計入其他全面收益之金融資產之公平值由估值技巧釐定。按公平值計入其他全面收益之金融資產之公平值由獨立專業估值師使用估值技巧(包括貼現現金流量估值模式)釐定。估值技巧包括並非以可見市場數據為基礎之輸入數據,並主要根據各呈報期末當時之市場情況作出假設。

(vi) 所得稅

釐定所得稅撥備涉及對若干交易日後稅務處理之判斷。本集團審慎檢驗交易之稅務影響,並據此訂立稅項撥備。對該等交易之稅務處理會定期重新考慮,以計及稅務法例之所有變更。遞延稅項資產乃就可扣減暫時差額及稅項虧損確認,惟須有日後應課稅溢利可用作抵銷遞延稅項資產。因此,評估未來應課稅溢利之可能性需要管理層之判斷。管理層在各報告期末重新評估該等估計。

The valuations were carried out by an independent firm of surveyors, AP Appraisal Limited (2020: AP Appraisal Limited), who have among their staff fellows of the Royal Institution of Chartered Surveyors (2020: Royal Institution of Chartered Surveyors) with recent experience in the location and category of properties being valued. The management of the Group has discussions with the surveyors on the valuation assumptions and valuation results when the valuation is performed at each interim and annual reporting date. In estimating the fair value of the investment properties, the highest and best use of the properties is their current use.

The property interests in investment properties thereon (including the whole or part of undivided share in the underlying land) in Hong Kong of approximately HK\$218,828,000 (2020: approximately HK\$220,712,000) are held by the Group as the registered owner. Those property interests were acquired from the previous registered owners by making lump sum payments at the upfront (which may be financed by a mortgage). Except for the variable amounts to be charged by the government subsequently that are reviewed regularly with reference to the rateable values, for example, there are no ongoing payments to be made under the terms of the land lease.

Leasing arrangement – as lessor

The investment properties are leased to independent third parties for a term of 1 to 3 years (2020: 2 to 3 years), which had an initial non-cancellable lease term of 1 to 3 years (2020: 1 to 3 years). Some leases do not include purchase or termination options and some leases provide the lessees with options to renew the leases upon expiry at new terms.

The details of the leasing income from operating leases are set out in Note 4 to the consolidated financial statements.

The investment properties are subject to residual value risk. The lease contract, as a result, includes a provision based on which the Group has the right to charge the tenant for any damage to certain of the investment properties at the end of the lease, unless the loss or damage caused through the act, neglect, omission or negligence of the Group. Besides, the Group has purchased insurance to protect it against any loss that may arise from accidents or physical damages of the properties.

As at 30 April 2020, included in other receivables is carrying amount before ECL of approximately HK\$22,153,000, with corresponding loss allowance for ECL of approximately HK\$1,898,000, which represents the right arising from termination of the investment in relation to Tian Da Energy Holdings Limited. The debtor agreed to transfer the title and ownership of a property located in the PRC, which had an estimated market value of approximately HK\$20,808,000 as at 30 April 2020 based on a professional valuation conducted by AP Appraisal Limited, to the Group for the settlement of the debt owing to the Group. This debt bore interest at a rate of 5% per annum. During the year ended 30 April 2021, the Group and the debtor entered into a supplementary agreement to settle the outstanding amount of approximately HK\$22,153,000 by cash of HK\$16,000,000, which was fully received by the Group during the year ended 30 April 2021. As a result, the remaining balance of approximately HK\$4,255,000 was written off in profit or loss during the year ended 30 April 2021. Given the extreme and sudden economic and social circumstances and uncertainties resulting from the COVID-19 pandemic during the first half of the financial year ended 30 April 2021, of a magnitude not encountered before in recent years, the Group considered that this settlement was in the best interests of the Group and its shareholders.

In addition to the abovementioned, included in the balance of other receivables are carrying amount before ECL of approximately HK\$7,754,000 (2020: approximately HK\$7,754,000), with corresponding loss allowance for ECL of approximately HK\$2,395,000 (2020: approximately HK\$457,000), which represents the consideration receivables for disposal of a financial asset at FVOCI, Partners K&K Limited ("PKKL"). PKKL is a company incorporated in the Republic of Korea with limited liability to pursue investment and institutional fund management related business. On 29 July 2018, the Group entered into a sale and purchase agreement to dispose all of the investment in PKKL to an independent third party at a consideration of United States dollars ("US\$") 1,000,000 (equivalent to approximately HK\$7,754,000).

Information about the Group's exposure to credit risks and loss allowance on deposits and other receivables are set out in Note 30 to the consolidated financial statements.

於二零二零年四月三十日，已於其他應收賬款入賬之除預期信貸虧損前賬面值約22,153,000港元，就預期信貸虧損之相應虧損撥備為約1,898,000港元，乃指終止有關天大能源控股有限公司之投資而產生之權利。債務人已同意將位於中國之物業(AP Appraisal Limited就該物業於二零二零年四月三十日進行專業估值之估計市價約20,808,000港元)之所有權及擁有權轉讓予本集團，以償付結欠本集團之債務。此債務按每年5%之利率計息。截至二零二一年四月三十日止年度，本集團與債務人訂立補充協定以現金16,000,000港元清償未償還金額約22,153,000港元，其於截至二零二一年四月三十日止年度已獲本集團悉數收取。因此，餘額約4,255,000港元已於截至二零二一年四月三十日止年度之損益內撇銷。考慮到截至二零二一年四月三十日止財政年度上半年新冠疫情引起的極端和突發經濟及社會情況及近年以前並未遭遇的重大不確定性，本集團認為此次結算符合本集團及其股東的最佳利益。

The Group regularly monitors its compliance with these covenants and has made payments according to the schedule of the loans and does not consider it probable that the banks will exercise its discretion to demand repayment so long as the Group continues to meet these requirements. 25. SHARE OPTION SCHEME

The Company adopted a share option scheme (the "Scheme") effective from 30 September 2011 for the purpose of providing incentives and rewards to eligible participants who contribute to the success of the Group's operations. Eligible participants of the Scheme include the Company's directors, including non-executive directors, employees of the Group, any other groups or classes of suppliers, customers, subcontractors or agents of the Group and the Company's shareholders determined by the directors of the Company as having contributed or who may contribute to the development and growth of the Group. The Scheme unless otherwise cancelled or amended, remains in force for 10 years from that effective date.

The maximum number of unexercised share options currently permitted to be granted under the Scheme is an amount equivalent, upon their exercise, to 10% of the shares of the Company in issue at any time. The maximum number of shares issuable under share options to each eligible participant in the Scheme within any 12-month period, is limited to 1% of the shares of the Company in issue at any time. Any further grant of share options in excess of this limit is subject to shareholder's approval in a general meeting.

Share options granted to any director, chief executive or substantial shareholder of the Company, or to any of their associates, are subject to approval in advance by the independent non-executive directors of the Company. In addition, any share options granted to a substantial shareholder or an independent non-executive director of the Company, or to any of their associates, in excess of 0.1% of the shares of the Company in issue at any time or with an aggregate value (based on the official closing price of the Company's shares at the date of the grant) in excess of HK\$5 million, within any 12-month period, are subject to shareholders' approval in advance in a general meeting.

The offer of a grant of share options may be accepted within 21 days from the date of offer, upon the payment of a nominal consideration of HK\$1 in total by the grantee. An option may be exercised in accordance with the terms of the Scheme at any time during the period commencing from the date on which the option is deemed to be granted and accepted and expiring on a date to be notified by the directors to each grantee, which shall not be more than 10 years from the date on which the option is deemed to be granted and accepted. There is no minimum holding period before an option may be exercised.

The exercise price of the share options is determinable by the directors of the Company, but may not be less than the higher of (i) the Stock Exchange closing price of the Company's shares on the date of grant of the share options; (ii) the average Stock Exchange closing price of the Company's shares for the five trading days immediately preceding the date of grant; and (iii) the nominal value of the Company's shares.

26. RESERVES*(a) Share premium*

The application of the share premium account is governed by the Companies Law of the Cayman Islands. Under the Companies Law of the Cayman Islands, the funds in share premium account are distributable to shareholders of the Company provided that immediately following the date on which the dividend is proposed to be distributed, the Company will be in a position to pay off its debts as they fall due in the ordinary course of business.

(b) Property revaluation reserve

Property revaluation reserve relates the property reclassified from owner-occupied to investment properties. For such reclassifications, the accumulative increase in fair value at the date of reclassification in excess of any previous impairment losses is included in the property revaluation reserve and will be transferred to retained earnings upon the retirement or disposal of the relevant property.

(c) Capital redemption reserve

The capital redemption reserve represents the amount by which the Company's issued share capital has been diminished on the cancellation of the shares purchased. Under the Companies Law of the Cayman Islands, the capital redemption reserve may be applied by the Company in paying up its unissued shares to be allocated to shareholders of the Company as fully-paid bonus shares.

(d) Statutory surplus reserve

According to the articles of association of the subsidiaries of the Company in the PRC, the PRC subsidiaries are required to transfer 10% of its net profit after tax, as determined in accordance with the PRC accounting rules and regulations, to the statutory surplus reserve. When the balance of the statutory surplus reserve reaches 50% of the subsidiaries' registered capital, any further appropriation is optional. The transfer to this reserve must be made before distribution of a dividend to the shareholders.

Statutory surplus reserve can be used to make up previous years' losses, if any, and may be converted into capital in proportion to their existing shareholdings, provided that the balance after such conversion is not less than 25% of the registered capital.

(e) Financial assets at FVOCI reserve

Financial assets at FVOCI reserve represents cumulative gains and losses on revaluation of financial assets at FVOCI recognised in other comprehensive income less those cumulative gains and losses recycled and transfers amounts from this reserve to accumulated losses upon derecognition of financial assets of FVOCI.

(f) Exchange translation reserve

The exchange translation reserve comprises all foreign exchange differences arising from the translation of the financial statements of operations outside Hong Kong. The reserve is dealt with in accordance with the accounting policy set out in Note 2 to the consolidated financial statements.

Credit risk

At 30 April 2021, the Group's maximum exposure to credit risk, which will cause a financial loss to the Group due to failure to discharge an obligation by the counterparties arising from the carrying amounts of the respective recognised financial assets as stated in the consolidated statement of financial position. The Group does not hold any collateral or other credit enhancements to cover its credit risks associated with its financial assets.

The Group applies the simplified approach to provide for ECL prescribed by HKFRS 9, which permits the use of the lifetime ECL provision for all accounts receivable and applies general approach to assess ECL on other financial assets at amortised cost including loan receivables and deposits and other receivables. To measure the ECL, loan receivables have been grouped based on shared credit risk characteristics. The Group has performed historical analysis and identified the key economic variables impacting credit risk and ECL. It considers available reasonable and supportive forwarding-looking information.

The Group's exposure to credit risk is influenced mainly by the individual characteristics of each customer and therefore significant concentrations of credit risk primarily arises when the Group has significant exposure to individual customers.

In respect of accounts receivable, and deposits and other receivables, the Group's exposure to credit risk is influenced mainly by the individual characteristics of each debtor. The default risk of the industry and country in which debtors operate also has an influence on credit risk. At the end of the reporting period, other than the accounts receivable gross carrying amount of approximately HK\$79,433,000 (2020: approximately HK\$43,850,000) (Note 17) as discussed below, the gross carrying amount of the refundable deposits of approximately HK\$10,644,000 (2020: approximately HK\$15,550,000) (Note 19), the gross carrying amount of other receivables of nil (2020: approximately HK\$22,153,000) (Note 19) and the gross carrying amount of loan receivables of approximately HK\$30,708,000 (2020: approximately HK\$30,454,000) (Note 18) as discussed below, the Group has no other significant concentrations of credit risk which individual balance at the end of the reporting period.

Credit evaluations are performed on all customers requiring credit terms. These evaluations focus on the customer's past history of making payments when due and current ability to pay, and take into account information specific to the customer as well as to the economic environment.

In order to minimise the credit risk, the management of the Group has delegated a team responsible for determination of credit limits, credit approvals and other monitoring procedures to ensure that follow up action is taken to recover overdue debts. In addition, the management of the Group reviews the recoverability of each trade debt at the end of each reporting period to ensure that adequate impairment losses are made for irrecoverable amounts. The Group applies simplified approach on accounts receivable to provide for the ECL prescribed by HKFRS 9. The Group measures loss allowance for accounts receivable at an amount equal to lifetime ECL, which is calculated using a provision matrix. As the Group's historical credit loss experience does not indicate significantly different loss patterns for different customer segments, the loss allowance based on past due status is not further distinguished between the Group's different customer bases.

For deposits and other receivables, the management of the Group makes periodic individual assessment on the recoverability of deposits and other receivables based on historical settlement records, past experiences, and also quantitative and qualitative information that is reasonable and supportive forward-looking information. As at 30 April 2021 and 2020, except for carrying amounts of approximately HK\$4,247,000 (2020: approximately HK\$4,247,000), with corresponding loss allowance for ECL of approximately HK\$4,247,000 (2020: approximately HK\$2,721,000) included in deposits and other receivables are based on lifetime ECL assessment and categorised as underperforming, all the remaining balance are based on 12-month ECL assessment.

Accounts receivable are written off when there is no reasonable expectation of recovery. Indicators that there is no reasonable expectation of recovery include, amongst others, the failure of a debtor to engage in a repayment plan with the Group, and a failure to make contractual payments for a period greater than agreed contract terms.

Impairment losses on accounts receivable are presented as net impairment losses within operating profit. Subsequent recoveries of amounts previously written off are credited against the same line item.

ECL rates are based on actual loss experience over the past 3 years. These rates are adjusted to reflect differences between economic conditions during the period over which the historic data has been collected, current conditions and the Group's view of economic conditions over the expected lives of the receivables.

Further quantitative disclosures in respect of the Group's exposure to credit risk arising from accounts receivable and deposits and other receivables are set out in Notes 17 and 19 to the consolidated financial statements.

The management monitored the financial background and creditability of those debtors on an ongoing basis. All of the Group's other financial assets at amortised cost are considered to have low credit risk, and loss allowance recognised during the year was therefore limited to 12-month expected losses. The other financial assets are considered to be low credit risk when they have a low probability of default and the issuer has a strong capacity to meet its contractual cash flow obligations in the near term.

Liquidity risk

Individual operating entities within the Group are responsible for its own cash management, including the short-term investment of cash surpluses and the raising of loans to cover expected cash demand, subject to board approval. The Group's policy is to regularly monitor current and expected liquidity requirements and its compliance with lending covenants to ensure that it maintains sufficient amount of cash and adequate committed lines of funding from major financial institutions to meet its liquidity requirements in the short and longer term. The Group relies on bank borrowings as a significant source of liquidity.

- (i) On 22 October 2020, VG Investment, a directly wholly-owned subsidiary of the Company and Allyking International Limited, an independent third party, (the "Vendor 1") entered into a share purchase agreement, pursuant to which VG Investment conditionally agreed to acquire, and the Vendor 1 conditionally agreed to sell, approximately 17.8% equity interest in Claman at a consideration of HK\$15,689,250 by allotment and issue of 34,885,000 consideration shares of the Company (the "Acquisition of Claman"). The Acquisition of Claman constitutes a discloseable transaction under the Listing Rules. Details are set out in the Company's announcement dated 22 October 2020.

On 27 November 2020, VG Investment and Claman entered into a subscription agreement, pursuant to which Claman conditionally agreed to issue, and VG Investment conditionally agreed to subscribe for, approximately 20.2% equity interest in Claman at a cash consideration of approximately HK\$14,100,000 (the "Subscription of Claman"). The Subscription of Claman constitutes a discloseable transaction under the Listing Rules. Details are set out in the Company's announcement dated 27 November 2020.
