- (e) No shareholder of the Company was required under the Listing Rules to abstain from voting on the resolutions at the AGM.
- (f) None of the shareholders of the Company have stated their intention in the Company’s circular dated 30 July 2021 to vote against or to abstain from voting on any of the resolutions at the AGM.
