In light of the payment of a final dividend of HK1 cent per Share and a special dividend of HK9 cents per Share on 27 August 2021, pursuant to the relevant terms and conditions of the warrant instrument of the above warrants, the strike price of the above warrants has been adjusted from HK\$1.6148 to HK\$1.54 with effect from 27 August 2021. For further details, please refer to the announcement of the Company dated 27 August 2021. As a result of the above-mentioned adjustment to the strike price of the warrants, the maximum number of Shares to be issued upon the full exercise of the subscription rights attached to these warrants with an aggregate amount of exercise moneys of US\$55,037,589 which remain outstanding as at the date hereof, will increase by 12,912,673 Shares from 265,849,141 Shares to 278,761,814 Shares.
