As at the date of the AGM, the number of issued Shares of the Company was 7,556,591,857. None of the Shareholders were required under the Listing Rules to abstain from voting in favour of the Ordinary Resolutions at the AGM or to abstain from voting. No Shareholders had stated their intention in the Circular to vote against or to abstain from voting on any of the Ordinary Resolutions proposed at the AGM. Accordingly, the total number of Shares entitling the holders thereof to attend and vote for or against the Ordinary Resolutions proposed at the AGM was 7,556,591,857 (representing 100% of the total issued share capital of the Company as at the date of the AGM).

The Company's branch share registrar and transfer office in Hong Kong, Computershare Hong Kong Investor Services Limited, was appointed as the scrutineer for the vote-taking at the AGM.
