ADJUSTMENT TO CONVERSION PRICE OF THE HK\$3,880,000,000 ZERO COUPON CONVERTIBLE BONDS DUE 2021

The Company announces that the Conversion Price of the 2016 CBs has been adjusted from HK\$5.28 per Share to HK\$5.06 per Share with effect from 24 September 2021 as a result of the distribution of interim dividend of HK9 cents per Share in cash for the 6 months ended 30 June 2021 ("**Interim Dividend**").

References are made to:

- (i) the announcements of Haitong International Securities Group Limited (the "**Company**") dated 11 October 2016 and 25 October 2016 in relation to the HK\$3,880,000,000 zero coupon convertible bonds due 2021 (the "**2016 CBs**"), and the announcement of the Company dated 28 April 2021 in relation to the adjustment to the conversion price of the 2016 CBs (collectively, the "**CB Announcements**"); and
- (ii) the announcement of the Company dated 25 August 2021 in relation to the interim results of the Company for the 6 months ended 30 June 2021 containing details of the Interim Dividend.

Unless otherwise defined, capitalized terms used herein shall have the same meanings as those defined in the CB Announcements.

Notice is hereby given that pursuant to the provisions on adjustment to the price per Convertible Share at which the 2016 CBs may be converted into the Shares (the "**Conversion Price**") as stated in the terms and conditions of the 2016 CBs, the Conversion Price of the 2016 CBs has been adjusted from HK\$5.28 per Share to HK\$5.06 per Share as a result of the distribution of Interim Dividend in cash (the "**Adjustment**").

The Adjustment has become effective from 24 September 2021, being the day of the Interim Dividend in cash to be paid.

The Adjustment has been computed in accordance with clause 6(C)(iii)(B) of the terms and conditions of the 2016 CBs.

All other terms of the 2016 CBs remain unchanged. As at the date of this announcement, the outstanding principal amount of the 2016 CBs is HK\$124,000,000. The 2016 CBs entitle the holders thereof to convert the outstanding 2016 CBs into 24,505,928 Shares after the Adjustment.
