### **UNAUDITED OPERATING FIGURES FOR THE TEN MONTHS ENDED 31 OCTOBER 2021**

This announcement is made by Kaisa Group Holdings Ltd. (the “**Company**”, together with its subsidiaries, the “**Group**”) pursuant to the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “**Listing Rules**”) on a voluntary basis.

The board of directors (the “**Board**”) of the Company is pleased to announce the certain unaudited operating figures of the Group for the ten months ended 31 October 2021.

The Group recorded contracted sales of approximately RMB8,195 million with contracted gross floor area (the “**GFA**”) of approximately 432,073 sq.m. in October 2021.

The total contracted sales of the Group for the ten months ended 31 October 2021 amounted to approximately RMB95,744 million with the total contracted GFA of approximately 5,587,263 sq.m., representing an increase of approximately 23.2% and 24.1% as compared with corresponding period in 2020, respectively.

The preliminary figures disclosed above are unaudited and are based on preliminary internal information of the Group which are subject to change and, if required, necessary adjustments and may differ from those appear in the audited or unaudited consolidated financial statements of the Group to be published by the Company on yearly or half-yearly basis.
