PROFIT WARNING EXPECTED DECREASE IN LOSS

This announcement is made by Affluent Partners Holdings Limited (the “**Company**”, together with its subsidiaries, the “**Group**”) pursuant to Rule 13.09(2)(a) of the Rules Governing the Listing of Securities (the “**Listing Rules**”) on The Stock Exchange of Hong Kong Limited (the “**Stock Exchange**”) and the Inside Information Provisions (as defined under the Listing Rules) under Part XIVA of the Securities and Future Ordinance (Chapter 571 of the Laws of Hong Kong).

The board (the “**Board**”) of directors (the “**Directors**”) of the Company wishes to inform the shareholders of the Company (the “**Shareholders**”) and potential investors that, based on the preliminary assessment of the unaudited consolidated management accounts of the Group, the Group is expected to record a significant decrease in loss attributable to equity holders of the Company by less than 65% for the six months ended 30 September 2021 as compared with the loss of approximately HK\$43.6 million attributable to equity holders of the Company for the six months ended 30 September 2020. The significant decrease in loss was mainly attributable to the following factors for the six months ended 30 September 2021:

- (i) the increase in gross profit due to the increase in sales of pearls and jewellery products; and
- (ii) the substantial decrease in administrative expenses.

As the interim results of the Group for the six months ended 30 September 2021 are not yet finalized, the information contained in this announcement should only be treated as a preliminary assessment by the Board based on the information currently available to the Group. The information contained in this announcement is not based on any figure or information that has been audited or reviewed by the auditors of the Company. Shareholders
