EXTENSION OF COMPLETION OF MAJOR TRANSACTION IN RELATION TO THE CONSTRUCTION AGREEMENT

Reference is made to the announcement of Cirtek Holdings Limited (the “**Company**”) dated 9 October 2020 (the “**Announcement**”) and the circular dated 25 November 2020 (the “**Circular**”), in relation to, among other things, the Construction Agreement. Unless the context requires otherwise, capitalised terms used in this announcement shall have the same meanings as those defined in the Announcement and Circular.

This announcement is made pursuant to the disclosure obligations of the Company under Rule 14.36 of the Listing Rules.

Pursuant to the terms of the Construction Agreement, completion of the Work shall take place within 365 calendar days from the Commencement Date. However, the Company has been informed by the Contractor that the construction of the New Bangladesh Factory has been delayed due to, among other things, the outbreak of COVID-19. The Contractor and the Company has agreed with a revised completion schedule and pursuant to which the completion of the Work shall be extended to on or before 31 March 2022.

Save for the above, the information contained in the Announcement and Circular remains unchanged in all respects. Depending on the COVID-19 pandemic development in Bangladesh, the Construction Agreement may be subject to further delay. The Company will make further announcement(s) to update the Shareholders as to the status of Completion as and when appropriate.
