1. The shipment volume of vehicle lens sets decreased by 15.5% YoY, which was mainly due to the shortage of the key components in the auto supply chain and the strong shipment volume performance brought by the pandemic mitigation in the same period of last year.
2. The shipment volume of handset camera module increased by 14.6% YoY, which was mainly due to the low base of shipment volume brought by the shortage of the key components in the smartphone supply chain in the same period of last year.
