UNAUDITED OPERATING DATA FOR THE TWELVE MONTHS ENDED 31 DECEMBER 2021

The board of directors (the “**Board**”) of Sinic Holdings (Group) Company Limited (the “**Company**”) is pleased to announce that the contracted sales amount of the Company and its subsidiaries (the “**Group**”), together with its joint ventures and associates, for the twelve months ended 31 December 2021 was approximately RMB81.49 billion, of which approximately RMB558 million was recorded in December 2021. From January to December 2021, the contracted sales area was approximately 5,361,080 sq.m., with an average selling price of RMB15,200 per sq.m..

The preliminary data disclosed above is unaudited and is based on the summary of management information of the Group and its joint ventures and associates, which may differ from the data to be disclosed in the audited or unaudited financial statements to be published by the Company on yearly or half-yearly basis or are subject to changes due to various uncertainties during the process of collection and collating of such preliminary data.
