### **UNAUDITED OPERATING FIGURES FOR THE YEAR ENDED 31 DECEMBER 2021**

The board (the “**Board**”) of directors (the “**Directors**”) of Top Spring International Holdings Limited (the “**Company**”) is pleased to announce certain unaudited operating figures of the Company and its subsidiaries (the “**Group**”) for the year ended 31 December 2021.

- For the year ended 31 December 2021, the pre-sales of the Group were approximately HK\$1,709.6 million, among which, pre-sales of properties and pre-sales of car park units were approximately HK\$1,701.3 million and approximately HK\$8.3 million, respectively, with the pre-sales properties’ gross floor area of approximately 25,527 sq.m., and the average selling price of pre-sales properties was approximately HK\$66,644 per sq.m..

The above operating information is unaudited, which was prepared according to the preliminary internal information of the Group. Given that various uncertainties may exist in the process of collecting such pre-sales figures, such operating information may be different from those to be disclosed in the audited or unaudited consolidated financial statements published by the Company on an annual or a semi-annual basis.
