According to the public information available to the Board, the HKEx is a company incorporated in Hong Kong with limited liability and its shares are listed on the main board of the Stock Exchange (stock code: 388). HKEx is a recognised exchange controller under the SFO. HKEx operates the only recognised stock and futures markets in Hong Kong through its wholly-owned subsidiaries and is the frontline regulator of listed issuers in Hong Kong. In collaboration with the Shanghai and Shenzhen stock exchanges, HKEx operates Stock Connect, which gives investors in the Hong Kong and Mainland securities markets access to each other's markets. HKEx also operates recognised clearing houses in Hong Kong and provides integrated clearing and settlement services as well as depository and nominee services to their participants. HKEx also provides market data through its data dissemination entity.

Information of AIA

According to the public information available to the Board, AIA is a company incorporated in Hong Kong with limited liability and its shares are listed on the main board of the Stock Exchange (stock code: 1299). AIA and its subsidiaries is a life insurance based financial services provider operating in 18 markets and its principal activity is the writing of life insurance business, providing life insurance, accident and health insurance and savings plans throughout Asia, and distributing related investment and other financial services products to its customers.

Information of LINK REIT

According to the public information available to the Board, LINK REIT is a collective investment scheme authorised under section 104 of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong) and is governed by a First Amending and Restating Deed entered into on 8 February 2021, its shares are listed on the main board of the Stock Exchange (stock code: 823). The principal activity of LINK REIT and its subsidiaries is investing in real estate and may be undertaking property development and related activities in respect of all types of developments.
