The board of directors (the "**Board**") of the Company wishes to inform the shareholders (the "**Shareholders**") and potential investors of the Company that, based on the information currently available to the Company and the preliminary review by the Board of the unaudited consolidated management accounts of the Group for the six months ended 31 December 2021, the Group is expected to record a loss attributable to equity owner of the Company ranging from approximately HK\$12 million to HK\$15 million, as compared to the loss attributable to equity owner of the Group for the corresponding period in 2020 in the amount of HK\$7.51 million. The increase of loss of the Group was primarily due to the combined effect of:

- 1. Deteriorate in solar power business segment results to approximately HK\$7.9 million profit (excluding the effect of expected credit loss) for the six months ended 31 December 2021, as compared to approximately HK\$11.6 million profit for the six months ended 31 December 2020.
- 2. Improvement in electrical distribution system segment results to approximately HK\$8.4 million profit (excluding the effect of expected credit loss) for the six months ended 31 December 2021, as compared to approximately HK\$7.4 million profit for the six months ended 31 December 2020.
- 3. Increase in allowance of expected credit loss in respect of trade receivables and contract assets increased from HK\$1.8 million for the six months ended 31 December 2020 to approximately HK\$5 million for the six months ended 31 December 2021.
