UNAUDITED OPERATING FIGURES FOR JANUARY 2022

The board of directors (the “**Board**”) of Sanxun Holdings Group Limited (the “**Company**”) wishes to provide the shareholders of the Company and potential investors with a sales update containing certain operating data of the Group for the one month ended 31 January 2022. For the one month ended 31 January 2022, the aggregate contracted sales of the Company, its subsidiaries and associated companies (the “**Group**”) was approximately RMB297 million, the aggregate contracted gross floor area was 35,846 sq.m. and the average selling price was approximately RMB8,287 per sq.m..
