## **Election of Means of Receipt of Corporate Communications**

Pursuant to the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited and the Bye-laws of Wong's International Holdings Limited (王氏國際集團有限公司) (the "Company"), we are writing to seek your election in relation to the following matters regarding the corporate communications ("Corporate Communications") to be published and despatched by the Company in the future.

Corporate Communications include any documents issued or to be issued by the Company for your information or action, including but not limited to: (a) directors' reports, annual accounts together with the auditors' reports and, where applicable, summary financial reports; (b) interim reports and, where applicable, summary interim reports; (c) notices of meetings; (d) listing documents; (e) circulars; (f) proxy forms; and (g) reply slips.

## You may choose:

- to access all future Corporate Communications by electronic means through the Company's website ("Website Version") instead
  of receiving printed copies by mail; or
- (ii) to receive by mail printed copies of all future Corporate Communications in both English and Chinese.

In support of environmental protection, we recommend you to elect for the Website Version. Even if you have elected for the Website Version, you reserve the right at any time by giving reasonable prior notice in writing to Tricor Standard Limited, the Hong Kong branch share registrar of the Company ("Hong Kong Branch Share Registrar") to change your choice.

Please tick the appropriate box on the enclosed reply form ("**Reply Form**") and sign and return it by post or by hand to the Company c/o the Hong Kong Branch Share Registrar, Tricor Standard Limited at Level 54, Hopewell Centre, 183 Queen's Road East, Hong Kong, on or before 31 March 2022. If you post your Reply Form in Hong Kong, you may use the mailing label in the Reply Form and need not affix a stamp on the envelope when returning your Reply Form. Otherwise, please affix an appropriate stamp.

If the Company does not receive a duly completed and signed Reply Form from you (or another response from you indicating that you object to receiving the Website Version of Corporate Communications) on or before 31 March 2022, you will be deemed, until you inform the Company otherwise by reasonable prior notice in writing at the office of the Hong Kong Branch Share Registrar at the above address or by email to <a href="wine-econ@hk.tricorglobal.com">wine-econ@hk.tricorglobal.com</a>, to have elected to receive all future Corporate Communications by Website Version instead of receiving them in printed form. In that event, when the Company makes a Corporate Communication, it will only send you a notification that the Corporate Communication has been made available on the Company's website. The notification will be sent to you by email or by post at your address as it appears in the Company's register of members maintained by the Hong Kong Branch Share Registrar.

You may at any time by reasonable prior notice in writing to the Company c/o the Hong Kong Branch Share Registrar at the above address or by email to wih-ecom@hk.tricorglobal.com elect to receive future Corporate Communications in printed form instead of by Website Version, or by Website Version instead of in printed form. If you have elected (or are deemed to have elected) to receive Corporate Communications by Website Version and for any reason have difficulty in receiving or gaining access to Corporate Communications on the Company's website, the Company will upon request send the relevant Corporate Communications to you in printed form free of charge.

Please note that all future Corporate Communications in both English and Chinese will be available (a) in printed form from the Company or the Hong Kong Branch Share Registrar upon request and (b) on the Company's website at www.wih.com.hk and the website of The Stock Exchange of Hong Kong Limited at www.hkexnews.hk respectively.
