I. MAJOR OPERATING DATA FROM JANUARY TO FEBRUARY 2022

During the Spring Festival of 2022, the Company organized its production in a scientific manner, tapped into its management efficacy to maintain stable and efficient production and operation. According to the preliminary estimates of the Company, from January to February 2022, the Company’s realised total operating revenue was approximately RMB76.2 billion, representing a year-on-year increase of approximately 40%; realised net profit attributable to shareholders of the listed company was approximately RMB950 million, representing a year-on-year increase of approximately 150%.
