II. MALLS THAT ARE IN OPENING PREPARATION AS OF THE FOURTH QUARTER OF 2021

As of 31 December 2021, the Company had 19 pipeline Portfolio Shopping Malls (of which 16 were Owned Portfolio Shopping Malls and 3 were Leased Portfolio Shopping Malls), and the planned construction area amounted to approximately 2.90 million sq.m. (subject to the final construction area as approved in the government permit documents). Among the pipeline Managed Shopping Malls, the Company obtained land use rights/land parcels for 327 managed contractual projects.

III. REVENUE AND GROSS PROFIT MARGIN OF PORTFOLIO SHOPPING MALLS FOR 2021

The Portfolio Shopping Malls opened by the Company recorded revenue of RMB8,338,394,566.37 during the Reporting Period, representing an increase of 20.3% as compared with the same period of last year; the gross profit margin was 76.9%, which was an increase of 0.5 percentage point compared with the same period of 2020.
