Up to the date of this announcement, the Group has repurchased an aggregate principal amount of US\$15.99 million of the 2022 Notes, representing approximately 7.995% of the aggregate principal amount of the 2022 Notes originally issued. Subject to the terms and indenture of the 2022 Notes, the Repurchased Notes will be cancelled.
