## About AAG Energy Holdings Limited

AAG Energy Holdings Limited (“**AAG Energy**” or “**the Company**”, together with its subsidiaries, the “**Group**”) is a leading international energy company in the field of Coal Bed Methane (“**CBM**”) exploration and production in China. It is committed to developing and optimizing the value of unconventional gas resources to supply clean energy to support the economic development in the People's Republic of China (“**PRC**”). AAG Energy's key operating assets, Panzhuang and Mabi concessions, are located in the southwestern part of Qinshui Basin in Shanxi Province, boasting the largest proved CBM geological reserves among basins in the PRC. AAG Energy's Panzhuang concession, which is in partnership with China United Coalbed Methane Corporation Ltd. (“**CUCBM**”), is the first Sino-foreign CBM cooperative project with full-scale commercial development and production and also the most commercially advanced Sino-foreign CBM asset in the PRC. In 2020, Panzhuang concession achieved an annual CBM production of over 1 billion cubic meters in only 63 square kilometers of operating area. The Overall Development Plan (“**ODP**”) for the southern area of Mabi concession, which is in partnership with China National Petroleum Corporation (“**CNPC**”), was approved by the National Development and Reform Commission (“**NDRC**”) of the PRC in September 2018. The designed annual production capacity for commercial development is 1 billion cubic meters. After continuous improvement of resource evaluation methods and engineering technology innovations, the Group has formulated a complete main engineering technology system. The Group is accelerating the construction of CBM production capacity and will further contribute to production in the future. In addition to the existing Panzhuang and Mabi concessions, the Group is committed to building its own core competitiveness, continuously exploring and innovating in management, technology and business models, and actively building an eco-industrial chain for the natural-gas industry. Leveraging its successful experience in the commercialization of CBM and high-calibre management team, with the progress made in the commercialization of southern area of Mabi concession, the Company will continue to contribute more clean energy to society and create higher return for investors.

## 關於亞美能源控股有限公司

亞美能源控股有限公司(「**亞美能源**」或「**本公司**」，與其附屬公司一起，統稱「**本集團**」)是一家在中國煤層氣勘探開發領域處於領先地位的國際能源公司，致力於非常規天然氣資源的開發及價值優化，為中國經濟發展供應清潔能源。亞美能源的主要運營資產潘莊及馬必區塊位於山西省沁水盆地西南部，其煤層氣探明地質儲量居中國各盆地之首。亞美能源與中聯煤層氣有限責任公司(「**中聯煤**」)合作的潘莊區塊是中國首個進入全面商業開發和生產的中外合作煤層氣區塊，同時也是中國商業化程度最高的中外合作煤層氣資產，潘莊區塊於2020年在僅63平方公里的作業面積內創造了煤層氣年產突破10億方的記錄。亞美能源與中國石油天然氣集團有限公司(「**中國石油**」)合作的馬必區塊南區煤層氣對外合作項目總體開發方案(「**ODP**」)於2018年9月獲得中華人民共和國國家發展和改革委員會(「**國家發改委**」)的批復，商業開發年設計產能為10億立方米。本集團經過持續不斷地改進資源評價方法、創新工程工藝技術，形成了完善的主體工程技術體系，現正在加快煤層氣產能建設進度，未來將貢獻更多的產量。除現有的潘莊、馬必區塊外，本集團致力於打造自身的核心競爭力，不斷在管理、技術及商業模式上進行探索與創新，積極構築天然氣產業生態鏈。憑藉其在煤層氣商業化進程中成功的經驗以及優秀的管理團隊，伴隨著馬必區塊南區商業化進程的推進，本公司將繼續為社會奉獻更多的清潔能源，為投資者帶來更優的回報。

Dear Shareholders,

On behalf of the board (the “**Board**”) of directors (the “**Directors**”) of AAG Energy Holdings Limited (“**AAG Energy**” or the “**Company**”, together with its subsidiaries, collectively the “**Group**”), I am pleased to present the annual report of the Group for the year ended 31 December 2021.

### OVERVIEW

2021 is a year of rapid change. Companies have confronted new challenges brought by global climate change under extreme weather; the economic turmoil brought by the continuous recurrence of the pandemic at home and abroad, as well as changes in the China-US trade policies; and the troubles brought by the accelerated transformation of the domestic economy. Meanwhile, the transition period between new energy and traditional energy has brought unprecedented opportunities and challenges to the natural gas market and the Group in the process of achieving the “dual-carbon” national goal. In 2021, under the strong leadership of the Board, the Group advanced head-on under the complex external environment, strengthened its response and safety management under extreme weather, strictly implemented the normalized pandemic prevention and control measures, and seized the opportunities of the industry cycle under the guidance of scientific and technological innovation. The construction of the industrial ecological chain began to take shape, achieving the dual-growth model of simultaneous improvement of input and efficiency of enterprise resource elements. Financial performance of the Group in 2021 was as follows:

### 概覽

2021年是快速變化的一年，企業必須直面極端天氣下全球氣候變化帶來的挑戰，國內外疫情的持續反復，中美貿易政策變化帶來的經濟震盪，以及國內經濟加速轉型帶來的陣痛。與此同時，在國家「雙碳」目標推進過程中，新能源與傳統能源過渡期間為天然氣市場及本集團帶來了前所未有的機遇與挑戰。2021年，本集團在董事會的有力領導下，直面複雜外部環境，強化極端天氣應對和安全管理，嚴格落實常態化疫情防控措施，以科技創新為引領，抓住行業週期機遇，產業生態鏈建設初具雛形，實現了企業資源要素投入與效率同步提升的雙增長模式。2021年本集團財務表現如下：

### OVERVIEW (Continued)

Gross production in 2021 increased by 25.52% to 1,298 million cubic meters ("MMCM") (or 45.8 billion cubic feet ("bcf")) as compared to that of 2020, and sales utilization rate remained relatively high. The annual production-to-sales ratio of Panzhuang concession was 97.23%, while that of Mabi concession was 87.73%. The Group's revenue and other income for the year (including government subsidies and VAT refunds) was RMB1.991 billion, representing an increase of 55.69% compared to the same period last year, mainly due to the increase in both the sales volume and market price of natural gas. In terms of pricing, with a realized average selling price ("ASP") in Panzhuang concession of RMB1.80 per cubic meter in 2021, representing an increase of 26.76% as compared to that of RMB1.42 per cubic meter in 2020; the realized ASP in Mabi concession for 2021 increased by 21.01% to RMB1.67 per cubic meter compared to RMB1.38 per cubic meter for 2020. In 2021, the Group realized operating profit of RMB1.148 billion, profit for the year of RMB816 million, EBITDA of RMB1.545 billion and earnings per share of RMB0.24.

The Group has continued to achieve excellent performance and results in the small, medium and micro technological innovation, and has continuously promoted the growth of the output of the existing concessions and the improvement of investment efficiency. The Company will further improve the construction of various strategic pivot points of the industrial chain, bringing continuous optimization of customer structure to the Company, and ensure the full production and sales of upstream products to the maximum extent. At the same time, the Group has gradually incorporated multiple social responsibilities into its corporate goals and production functions. We will actively plot for the strategic planning of digital transformation, and take a solid step towards the digital transformation and intelligent development of the corporation. The leadership evaluation of middle and senior management personnel and the formulation of personal development plan will comprehensively improve the management skills of middle and senior management personnel, and ensure that there are talents for the future development of the Company. Through various management upgrades, the Group has laid a solid foundation for AAG Energy to complete the transformation and upgrades as well as its sustainable development.

### MAJOR RESULTS REVIEW:

#### — Health, Safety and Environment ("HSE"): Key Performance Indicators (KPIs) kept "Three-Zero" record, and Five-Year Strategic Plan for Sustainable Development is formulated and implemented

AAG Energy attaches great importance to HSE work and its obligation to fulfill social responsibility. Through the update of advanced safety production management system, the Group strengthens its safety education and training, contractor management, ecological environment management and safety culture origination, persistently strengthening the HSE awareness of its employees and enhancing HSE performance. In 2021, AAG Energy has maintained zero for lost time injury rate ("LTIR"), total recordable incident rate ("TRIR") and pollution incident in respect of its HSE performance.

### 概覽 (續)

2021年總產量相比2020年增長25.52%至12.98億立方米(即458億立方英尺)，銷售利用率仍保持較高水準，其中潘莊區塊全年產銷比為97.23%，馬必區塊全年產銷比為87.73%。本集團全年實現收入及其他收入(包括政府補貼和增值稅退稅)人民幣19.91億元，較去年同期增長55.69%，主要源自天然氣銷量和市場價格的雙增長。其中價格方面，潘莊區塊2021年平均實現銷售價格為每立方米人民幣1.80元，較2020年的每立方米人民幣1.42元增長26.76%；馬必區塊2021年平均實現銷售價格為每立方米人民幣1.67元，較2020年的每立方米人民幣1.38元增長21.01%。2021年實現經營利潤人民幣11.48億元，實現年度利潤人民幣8.16億元，EBITDA人民幣15.45億元，每股收益人民幣0.24元。

本集團持續在中小微科技創新方面取得的優異績效成果，不斷促進了存量區塊產量的增長及投資效率的提升；進一步完善的產業鏈各戰略支點構建，為公司帶來持續優化的客戶結構，最大限度保證上游全產全銷；與此同時，本集團逐步將多重社會責任納入企業目標與生產函數；積極佈局數字化轉型戰略規劃，向企業數字化轉型、智慧化發展邁出堅實一步；中高層管理人員領導力盤點及個人發展計劃的制定，將全面提升中高層管理人員的管理技能，為公司未來的發展提供人才保障。本集團通過多措並舉的管理升級為亞美能源完成轉型升級及可持續發展奠定了更加堅實的基礎。

### 主要業績回顧：

#### — 健康、安全及環境("HSE")：關鍵績效指標保持「三零」記錄，制定並推進落實《可持續發展五年戰略規劃》

亞美能源高度重視HSE工作及履行社會責任的義務，通過先進性安全生產管理體系更新，加強安全教育培訓、承包商管理、生態環境管理和安全文化建設，持續強化員工健康安全環保意識，提升健康安全環保業績。2021年亞美能源一如既往保持損失工時事故("LTIR")為零、總可記錄事故("TRIR")為零、環境污染事故為零的健康安全環保績效。

#### — Health, Safety and Environment ("HSE"): Key Performance Indicators (KPIs) kept "Three-Zero" record, and Five-Year Strategic Plan for Sustainable Development is formulated and implemented (Continued)

The Group always adheres to the core value of sustainable development. In 2021, the Company further improved the sustainable development governance system, optimized the sustainable development governance structure, stimulated the systematic management of ESG information, incorporated ESG management into the Company's business operations, promoted the implementation of the Five-Year Strategic Plan for Sustainable Development, and formed the initial settings of KPIs related to ESG environmental objectives. The Group adhered to the concept of green and sustainable development to promote corporate transformation and upgrading.

#### — Panzhuang Concession: Consolidate Geological Research and Actively Promote the Preparation for Large-Scale Development of Thin Coal Seams

In 2021, the gross production of Panzhuang concession reached 1,175 MMCM (41.5 bcf), exceeding the original target of 1,080 MMCM (38.1 bcf), representing a year-on-year increase of 21.46%. A total of 62 wells were drilled in 2021, including 1 thin seam parameter well. The Panzhuang concession has basically identified the geological resource characteristics of thin coal seams, verified the adaptability of drilling, fracturing and pumping technologies of thin coal seams, and provided support for the development of thin coal seams at the Panzhuang concession.

#### — Mabi Concession: Continue to Optimize Technology Development Programs, With Record-High Annual Drilling and Annual Yield

Mabi concession continued to improve resource evaluation methods, continuously promoted engineering technology innovation. While promoting the effective development and utilization of the southern area of Mabi concession, it also preliminarily verified the development potential of the northern area of the Mabi concession, laying a foundation for the preparation of the overall development plan and the effective development of resources in the northern area of Mabi concession. In 2021, the total production volume of Mabi concession reached 123 MMCM (4.3 bcf), exceeding the original target of 120 MMCM (4.2 bcf), representing a year-on-year increase of 84.22%. A total of 190 wells were drilled in 2021, representing an increase of 192.31% as compared to 2020, a record-high for the Mabi concession. During the year, the development practice once again proved that the sweet spot in Mabi concession was accurately identified, the engineering process was highly adaptable, the technical indicators were well accomplished and the production results met expectations. The new wells drilled in 2021 will make good contribution to production in 2022.

### 主要業績回顧：(續)

#### — 健康、安全及環境("HSE")：關鍵績效指標保持「三零」記錄，制定並推進落實《可持續發展五年戰略規劃》(續)

本集團始終堅守可持續發展的核心價值理念，2021年公司進一步完善可持續發展治理體系，優化可持續發展治理架構，同時推動ESG信息體系化管理，將ESG管理納入公司業務運營，推進制定《可持續發展五年戰略規劃》，初步設定ESG環境目標相關關鍵績效指標，堅持以綠色可持續發展理念推進企業轉型升級。

#### — 潘莊區塊：夯實地質研究，積極推進薄煤層規模開發準備工作

2021年潘莊區塊總產量達到了11.75億立方米(415億立方英尺)，超出了原定的10.8億立方米(381億立方英尺)目標，同比2020年增長了21.46%。2021年共完成鑽井62口，其中包括1口薄煤層參數井。潘莊區塊現已基本查明薄煤層的地質資源特徵，驗證了薄煤層的鑽井、壓裂與排採技術的適應性，為潘莊區塊薄煤層開發提供了支撐。

#### — 馬必區塊：持續優化技術開發方案，年鑽井數及年產量創新高

馬必區塊持續改進資源評價方法，不斷推進工程工藝技術創新。在促進馬必區塊南區有效開發利用的同時，也初步驗證了馬必區塊北區開發潛力，為馬必區塊北區總體開發方案的編制及資源的有效開發奠定了基礎。2021年馬必區塊總產量達到了1.23億立方米(43億立方英尺)，超出了原定的1.2億立方米(42億立方英尺)目標，同比2020年增長了84.22%。2021年共完成鑽井190口，較2020年增長192.31%，再創馬必區塊鑽井數新高。本年度開發實踐再次證明，馬必區塊富集區識別準確、工程工藝適應性強、技術指標完成優良、產量結果到達預期。2021年新鑽井將在2022年貢獻較大的產量。

#### — Corporate Management: Leverage on Technological Innovation and Industrial Ecological Chain to Further Enterprise Transformation and Upgrading

In 2021, the Group insisted on leveraging the technological innovation, continued to carry out research on industrial technological innovation, dynamically adjusted and optimised exploration and development plans. The Group completed the research on excellent and fast drilling technology for long extended horizontal wells, research and testing of large-scale fracturing technology, research on development potential of thin coal seams and research on engineering adaptability. Through the organization of research, field trials and the promotion and application of the results, the Group has effectively promoted the quality and efficiency of investment in existing businesses, and has accumulated replicable core technologies and experience for the exploration and development of new concessions.

In 2021, AAG Energy preliminarily completed the construction of the "natural gas industry ecological chain" strategic pivot point. Based on the characteristics of unconventional natural gas resources in the upstream, the Group promoted the acquisition of new concessions and new resources, and inspected and investigated CBM block projects in Shanxi, Henan, Xinjiang and other regions, laying the foundation for obtaining high-quality concessions, investment, mergers and acquisitions, and cooperation. The midstream relied on the key pipelines leading to Henan, promoted the interconnection of external pipelines, and ensured the high-quality output of gas volume in Panzhuang concession and multi-channel output of gas volume in Mabi concession. The Company built up the capability of direct control over the production capacity and storage in downstream, and carried out multi-form and all-round cooperation with enterprises such as city gas companies and important customers, so as to increase the market share and control power of the downstream market. The formulation of the entire industrial ecological chain in upstream, midstream and downstream has begun to take shape.

Meanwhile, AAG Energy has comprehensively carried out the strategic work arrangement of green and sustainable development, improved and disintegrated the Five-Year Strategic Plan for Sustainable Development into the annual implementation plan, and included energy conservation, emission reduction and consumption lessening into the performance assessment indicators, aiming to achieve the goal of green and long-term development and fulfill the corporate social responsibility.

### 主要業績回顧：(續)

#### — 企業管理：以技術創新為抓手，產業生態鏈為支點推進企業轉型升級

2021年，本集團堅持以科技創新為抓手，持續開展產業技術創新課題研究，動態調整優化勘探開發方案，完成了長支水平井優快鑽井技術研究、大規模壓裂技術研究與試驗、薄煤層開發潛力及工程適應性研究等專項課題研究。通過組織研究、現場試驗及成果推廣應用，有效帶動存量業務投資提質增效，為新區塊勘探開發積澱了可複製的核心技術和經驗。

2021年亞美能源初步完成「天然氣產業生態鏈」戰略支點打造，上游結合非常規天然氣資源特點，推進新區塊、新資源的獲取工作，考察調研山西、河南、新疆等多地煤層氣區塊項目，為獲取優質區塊、投資並購及合作打下基礎；中游依托通往河南關鍵管輸路由，推進外輸管線的互聯互通，保障潘莊區塊氣量的高品質輸出及馬必區塊氣量的多通道輸出；下游構建產能與存儲的直控能力，與城燃公司、重要客戶等企業開展多形式全方位合作，提升下游市場的佔有率與掌控力。上、中、下游全產業生態鏈建設初具雛形。

與此同時，亞美能源全面展開綠色可持續發展戰略工作安排，完善並分解《可持續發展五年戰略規劃》至年度可實施計劃，將節能減排降耗列入績效考核指標，旨在以綠色長遠發展為目標，踐行企業的社會責任。

### PROPOSED DIVIDEND

The Group will consistently implement its dividend policy to share the outstanding achievements of AAG Energy with all shareholders. In view of the strong operational and financial performance, the Board recommended the payment of a dividend of RMB0.0589 per share (representing approximately HKD0.0724 per share) for the year ended 31 December 2021. The Company shall utilize its continuous strong capital position and growing cash flow from operations to pay the dividend. The Company's persistent strong business outlook will support its continuous payment of dividends in the future.

### BUSINESS OUTLOOK

With the further clarification of China's carbon neutrality and carbon peak targets and the arrival of the low-carbon economy era, the demand for natural gas will continue to grow and the consumption market has great potential. In 2022, AAG Energy will further consolidate the foundation of existing business, increase investment and development efforts in existing concessions, and continue to improve quality and efficiency through technological and management innovation. The Group will actively expand new concessions and incremental businesses, explore the core competitiveness of innovative technologies, thus achieve sizable clean energy to increase reserves and production, and assist the country's green and low-carbon industrial transformation.

At the beginning of 2022, based on the development level of the energy industry and the Group's own development scale, in order to better implement the "Four Alterations" core strategy of "development of full industrial chain, new-and-high technologies, internationalization and financial development" of natural gas energy, the Group and Xinjiang Xintai Natural Gas Co., Ltd. (新疆鑫泰天然氣股份有限公司) jointly established an energy research company, with a view to comprehensively improving technological innovation capabilities to lead the transformation and upgrade of the energy industry. Focusing on the "four new fields" of new energy, new technology, new materials and new equipment, the joint venture strives to become a world-class and domestic leading industry technology research and development and achievement application team by striving to increase scientific and technological research, technology transformation and application promotion, providing the driving force for the Group's leap-forward development and building its core competitiveness.

### 建議股息

本集團將持續貫徹股息政策，與所有股東分享亞美能源的卓越成就。鑒於強勁的運營和財務表現，董事會建議派付截至2021年12月31日止年度股息每股人民幣0.0589元，相當於每股約港幣0.0724元。本公司持續強勁的資金實力及來自於運營的增長現金流，以支付本次派付股息。本公司業務前景的持續強勁，可支援本公司在未來繼續派付股息。

### 業務前景展望

2022年伊始，基於能源行業的發展水準和本集團自身的發展規模，為更好實施以「天然氣能源全產業鏈化、高新科技化、國際化、金融化」的「四化」核心戰略，本集團與新疆鑫泰天然氣股份有限公司合資設立能源研究公司，以期全面提升技術創新能力，引領能源產業轉型升級。合資公司圍繞新能源、新技術、新材料、新裝備的「四新領域」，通過加大科技攻關、技術轉化和應用推廣等方面的工作力度，力爭打造國際一流、國內領先的行業技術研發與成果運用團隊，為集團跨越式發展提供原動力，構建核心競爭力。

### BUSINESS REVIEW

As climate change becomes increasingly severe, green and low-carbon development strategies have attracted extensive attention. According to the “Natural Gas Analysis and Forecast 2021–2024” report issued by the International Energy Agency, the global natural gas demand will show an increasing trend in the next few years.

In 2021, under the influence of extreme weather and the international oil price went out of the trough, the natural gas market showed a stronger peak season and a less-than-sluggish low season. 2021 is also the first year for China to widely promote the development of natural gas under the “14th Five-Year Plan”. With the promotion of the “dual carbon” goal, natural gas consumption has grown rapidly. The fundamentals of the development of the domestic natural gas industry continue to improve with vibrant performance. In 2021, the apparent consumption of natural gas in China reached 372.6 billion cubic meters, representing an increase of 12.7% as compared with that of 2020.

By the end of 2020, the Group took the lead in establishing a development strategy to set up the existing business in the concessions and increasing development efforts, and made full use of industrial advantages to achieve excellent performance. In terms of production, the Group's gross production in 2021 increased by 25.52% from that of 2020 to 1,298 MMCM (or 45.8 bcf), including 1,175 MMCM (or 41.5 bcf) of production from Panzhuang concession and 123 MMCM (or 4.3 bcf) of production from Mabi concession.

In terms of investment, the actual capital expenditure in 2021 was RMB859 million as compared with the annual budget of RMB967 million. Compared to 2020, drilling and fracturing activities in 2021 continued to increase by 62.58% and 25.53% to 252 wells and 147 wells respectively. At the same time, we continued to focus on reducing costs and improving profitability. The average drilling cost per well of a single lateral horizontal well (“SLH”) decreased as compared with 2020, of which the average drilling cost of SLH wells in 3# coal seam was RMB2.54 million, representing a decrease of 8.63% as compared with RMB2.78 million in 2020, and the average drilling cost of SLH wells in 15# coal seam was RMB2.7 million, representing a decrease of 5.26% as compared with RMB2.85 million in 2020. The average drilling cost per well of a pad drilling well (“PDW”) decreased by 10.34% from RMB0.87 million in 2020 to RMB0.78 million.

### 業務回顧

隨著氣候變化問題的日益嚴重，綠色低碳的發展戰略受到廣泛關注。根據國際能源署發佈的《天然氣分析及展望2021–2024》報告顯示，未來幾年全球天然氣需求將呈現增長的趨勢。

2021年，受極端天氣的影響，加之國際油價走出低谷，天然氣市場出現了旺季更旺、淡季不淡的行情。2021年也是中國全面推進「十四五」天然氣大發展的開局之年，隨著「雙碳」目標的推動，天然氣消費快速增長。國內天然氣行業發展的基本面持續向好，充滿活力。2021年，中國天然氣表觀消費量達到3,726億方，相比2020年增長12.7%。

本集團先行一步，於2020年底確立深耕存量區塊、加大開發力度的發展策略，充分利用行業紅利，獲得卓越績效。在產量方面，本集團2021年總產量相比2020年增長了25.52%達到12.98億立方米（即458億立方英尺），其中包括潘莊區塊的產量11.75億立方米（即415億立方英尺）和馬必區塊的產量1.23億立方米（即43億立方英尺）。

在投資方面，相比全年預算人民幣9.67億元的資本性支出，2021年實際的資本支出為人民幣8.59億元。2021年鑽井及壓裂工程工作量與2020年相比繼續分別增長62.58%、23.53%至252口、147口。同時，我們持續致力於降低成本，提升利潤空間。單支水平井（「SLH」）的平均單井鑽井成本較2020年有所下降，其中3#煤層SLH井的平均單井鑽井成本為人民幣254萬元，較2020年的人民幣278萬元下降8.63%，15#煤層SLH井的平均單井鑽井成本為人民幣270萬元，較2020年的人民幣285萬元下降5.26%。叢式井（「PDW」）的平均單井鑽井成本較2020年的人民幣87萬元下降10.34%至人民幣78萬元。

In terms of market sales, the Group's realized ASP in 2021 was RMB1.79 per cubic meter, of which realized ASP in Panzhuang concession was RMB1.80 per cubic meter (an increase of 26.76% from RMB1.42 per cubic meter in 2020), and realized ASP in Mabi concession was RMB1.67 per cubic meter (an increase of 21.01% from RMB1.38 per cubic meter in 2020).

In terms of financial results, the Group's revenue and other income (including government subsidies and VAT refund) in 2021 increased by 55.69% to RMB1.991 billion as compared to 2020, operating profit increased by 58.67% to RMB1.148 billion, profit for the year increased by 59.84% to RMB816 million, EBITDA increased by 55.25% to RMB1.545 billion, and earnings per share increased by 60.00% to RMB0.24.

Key financial indicators for the last 5 years are as follows:

在市場銷售方面，2021年本集團平均實現銷售價格為每立方米人民幣1.79元，其中潘莊區塊的平均實現銷售價格為每立方米人民幣1.80元（相比2020年的每立方米人民幣1.42元增長26.76%），馬必區塊的平均實現銷售價格為每立方米人民幣1.67元（相比2020年的每立方米人民幣1.38元增長21.01%）。

在財務業績方面，本集團2021年的收入及其他收入（包括政府補貼和增值稅退稅）相比2020年增長了55.69%至人民幣19.91億元，經營利潤增長了58.67%至人民幣11.48億元，年度利潤增長了59.84%至人民幣8.16億元，EBITDA增長了55.25%至人民幣15.45億元，每股收益增長了60.00%至人民幣0.24元。

#### 1. Panzhuang Concession

Our Panzhuang concession, which is in partnership with CUCBM, continued to be the CBM project with the highest output in China, and was listed as China's key CBM project in production under the "14th Five-Year Plan" for the development and utilization of CBM (coal mine gas) prepared by the National Energy Administration (the "NEA") and issued by the NDRC of the PRC.

##### — Production Update

In 2021, the gross production of Panzhuang concession reached 1,175 MMCM (41.5 bcf), which was 8.78% higher than the original target of 1,080 MMCM (38.1 bcf), with a 21.46% year-on-year ("YoY") increase compared to that of 967 MMCM (34.2 bcf) in 2020. The average daily gas production was 3.22 MMCM, representing an increase of 21.97% compared to that of 2.64 MMCM in 2020. By the end of 2021, there were a total of 504 wells in production, including 158 PDWs, 49 multi-lateral drilling wells ("MLD") and 297 SLHs in Panzhuang concession. Further details on production and well count are set out below in Table 1.

##### — Geological Research

The Company is committed to the geological research of CBM reservoir, and has basically identified the characteristics and minability of geological resources of CBM in thin coal seams, and verified the adaptability of drilling, fracturing and pumping technologies for CBM development in thin coal seams. The gas production performance of the 13 tested wells was satisfactory, of which 9 wells have achieved high production and stable production, with an average daily gas production per well of 6000-7000 cubic meters, and the stable daily gas production of 4 wells exceeds 10,000 cubic meters, and the daily gas production of the highest production well reaches 15,000 cubic meters, which has reached the average production level of a SLH in the major coal seam. In the future, we will accelerate the exploration progress and development scale of CBM in thin coal seams.

#### 1. 潘莊區塊

我們與中聯煤合作的潘莊區塊仍然是中國最高產的煤層氣項目，在由國家能源局（「國家能源局」）制定、國家發改委發佈的煤層氣（煤礦瓦斯）開發利用「十四五」規劃中，被列為國家在產煤層氣重點項目。

##### — 生產進展

2021年潘莊區塊的總產量達到了11.75億立方米（即415億立方英尺），較原定10.8億立方米（即381億立方英尺）的目標超產8.78%，同比2020年9.67億立方米（即342億立方英尺）增長了21.46%。平均日產氣量達322萬立方米，較2020年平均日產氣量264萬立方米增長21.97%。截至2021年底，潘莊區塊共有在產生產井504口，其中包括158口PDW，49口多分支水平井（「MLD」）和297口SLH。更多的產量資料以及井數統計請詳見下列表1。

##### — 地質研究

本公司致力於煤層氣儲層的地質研究，已基本查明薄煤層煤層氣的地質資源特征與可採性，驗證了薄煤層煤層氣開發的鑽井、壓裂與排採技術的適應性。已試驗的13口試採井產氣表現良好，其中9口井已實現高產、穩產，平均單井日產氣量為6,000-7,000立方米，4口井穩產日產氣量超過10,000立方米，產氣量最高的井日產氣量達到15,000立方米，已經達到主力煤層SLH的平均產量水平。未來我們將加快薄煤層煤層氣勘探進度和開發規模。

#### 1. Panzhuang concession (Continued)

##### — Drilling and Surface Facilities Update

In 2021, a total of 62 wells were drilled in Panzhuang concession (including 21 SLHs and 41 PDWs). The average drilling time of SLHs was only 15.97 days. At the same time of completing the thin coal seam test well, the construction of thin coal seam parameter well was initiated, which provided a basis for accelerating the preparation of the thin coal seam development plan and laid a solid foundation for the subsequent replacement and improvement of production.

Currently, the surface facilities of our Panzhuang concession include 6 gas gathering stations, 58 wellhead compressors, 68 kilometers of trunk lines and 135 kilometers of inter-well pipelines. The central gas gathering station has a secondary processing capacity of 1.20 MMCM per day, and compressors at remaining stations and wellheads have a processing capacity of 4.56 MMCM per day. The double-circuit 35kV and other power lines meet the electricity demand of Panzhuang concession, and provide a favorable guarantee for improving the CBM transmission and distribution capacity of Panzhuang concession to increase production and sales.

#### 1. 潘莊區塊(續)

##### — 鑽井及地面設施進展

2021年潘莊區塊共完成鑽井62口(其中包括21口SLH和41口PDW), SLH井平均鑽井時間僅為15.97天。在完成薄煤層試驗井同時,啟動薄煤層參數井施工,為加速薄煤層開發方案的編制提供依據,為後續產量接替及提升奠定了堅實的基礎。

目前,潘莊區塊地面設施包括6座集氣站,58臺井口壓縮機,68千米集輸管線和135千米單井管線。中央集氣站二次加壓處理能力為120萬立方米/天,其餘各站及井口壓縮機處理能力為456萬立方米/天。雙迴路的35千伏等電力線路滿足了潘莊區塊的電量需求,為提高潘莊區塊的煤層氣輸配能力,提升產量和銷量提供了有利保障。

#### 2. Mabi Concession

Our Mabi concession, which is in partnership with CNPC, was listed as China's key CBM project under construction under the "14th Five-Year Plan" for the development and utilization of CBM (coal mine gas) prepared by the NEA and issued by the NDRC, and was also one of the key CBM construction projects in Shanxi Province in 2021.

##### — Production Update

In 2021, the gross production of Mabi concession was 123 MMCM (4.3 bcf) with an average daily gas production of 0.34 MMCM, representing an increase of 86.10% compared to that of 0.1827 MMCM in 2020. By the end of 2021, there were a total of 327 wells in production, including 272 PDWs, 1 MLD and 54 SLHs in Mabi concession. Further details on production and well count are set out below in Table 1.

In 2021, a total of 190 wells were drilled (including 89 SLHs and 101 PDWs) in Mabi concession, representing an increase of 192% as compared to 2020. The drilling investment in Mabi concession reached a new high. With the maturity and stability of the two-section well type and nearbore directional technology, the average drilling time of SLH was only 14 days, and the length of the single horizontal section increased by 140 meters on average compared with 2020, representing an increase of 15%, which greatly improved the development economy.

In 2021, Mabi completed a total of 108 wells and a total of 725 stages of fracturing, representing an increase of 33% and 68%, respectively. The maturity of the fracturing process, selection of fracturing tools, and innovative and efficient management of common tubing with bottom sealing, drag and fracturing greatly improved the fracturing quality and reduced the fracturing cost. In 2021, the single-stage fracturing cost of SLH well decreased by 10% year-on-year. At the same time, the test of ultra-low-density ceramic proppant showed obvious production enhancement effect.

190 wells drilled in 2021 will commence production in 2022.

#### 2. 馬必區塊

我們與中石油合作的馬必區塊，在由國家能源局制定、國家發改委發佈的煤層氣(煤礦瓦斯)開發利用「十四五」規劃中被列為國家在建煤層氣重點項目，也是山西省2021年煤層氣重點建設項目之一。

##### — 生產進展

2021年馬必區塊的總產量為1.23億立方米(即43億立方英尺)，平均日產氣量34萬立方米，較2020年平均日產氣量18.27萬立方米增長86.10%。截至2021年底，馬必區塊共有在產井327口，其中包括272口PDW，1口MLD和54口SLH。更多的產量資料以及井數統計請詳見下列表1。

2021年馬必區塊共完成煤層氣鑽井190口(其中包括89口SLH和101口PDW)，較2020年鑽井投資工作量增長了192%，再創馬必區塊鑽井投資新高。隨著二開井型和近鑽頭導向技術趨於成熟穩定，SLH井平均鑽井時間僅為14天，單井水平段長度較2020年平均增加140米，增長了15%，大幅提高開發經濟性。

2021年馬必區塊共完成108口井、共計725級的壓裂施工，相比2020年分別增長了33%、68%。普通油管帶底封拖動壓裂工藝的成熟、壓裂工具選型、創新高效的管理，提高了壓裂質量，降低了壓裂成本，其中2021年SLH井單級壓裂費用同比下降10%；同時超低密度陶粒支撐劑試驗表現出明顯的增產效果。

2021年完井的190口井，將於2022年貢獻產量。

##### — Implementation Progress of the ODP of the Southern Area of Mabi Concession

Through continuous improvement of resource evaluation methods and continuous innovation of engineering process technology, under the high-level organization and leadership, efficient investment control and high-standard quality requirements, the Company has mastered the geological and engineering technology adapted to the characteristics of Mabi Concession, and the southern area of Mabi Concession will be effectively developed and utilized.

In 2021, the Company accelerated the construction of the No. 2 gas gathering station and regional facilities, completed a total of 11.9 kilometers of outbound pipelines, 24 kilometers of inter-well pipelines, and 43% of the main construction of the 35 kilovolt single tower double circuit and substation, which will effectively guarantee the increase of production after completion.

##### — Geology Research Progress of the Northern Area of Mabi Concession

Through continuous monitoring of the discharge and production test of three No. 3 coal SLH wells in the northern area of the Mabi concession, the three wells are currently in the stage of stable gas production, with an average daily gas production per well of 8,300 cubic meters, and the daily gas production of the highest gas production well reaches 10,000 cubic meters, which preliminarily verified the development potential of the northern area of Mabi concession. Through in-depth geological research on the northern area of Mabi concession, the Company has selected 64 square kilometers of production areas in the northern area, and is conducting 3D seismic exploration and the preparation of the development plan, which will gradually improve the effective utilization of CBM resources in the northern area in the future.

##### — 馬必南區ODP實施進展

本公司通過持續改進資源評價方法，不斷進行工程工藝技術創新，在高水準的組織領導、高效的投資管控及高標準的品質要求下，已掌握適應馬必區域特點的地質與工程技術，馬必南區將得到有效開發利用。

2021年，本公司加快了2號集氣站及區域設施的建設，已完成外輸管線11.9千米、單井管線24千米，並完成35千伏電力單塔雙迴路及變電站主體工程的43%，建成後將有效保障產量的提升。

##### — 馬必區塊北區地質研究進展

通過對馬必區塊北區3口3號煤SLH井排採試驗的持續監測，3口井目前處於穩定產氣階段，平均單井日產氣量達8,300立方米，產氣最高的井日產氣量達10,000立方米，初步驗證了馬必區塊北區的開發潛力。通過對馬必區塊北區深入地質研究，已在北區優選64平方公里的建產區，正在進行三維地震勘探及開發方案的編制，未來將逐步提高北區煤層氣資源的有效利用。

#### 3. Reserve Upgrade

Based on reports issued by Netherland Sewell & Associates Inc. ("NSAI"), an independent reserve certification company, the Group's 1P and 2P natural gas reserves as at the end of 2021 ("2021YE") were 152.0 bcf and 635.1 bcf respectively, representing a 16% decrease from the 1P reserve of 179.9 bcf as at the end of 2020 ("2020YE") and a 1% decrease from the 2P reserve of 640.6 bcf as at 2020YE. After deducting net gas production of 35.0 bcf for 2021, the 1P and 2P reserves increased by 5% and 5% respectively.

The 1P reserve and 2P reserve of Panzhuang concession were 114.7 bcf and 148.1 bcf as at 2021YE, representing a decrease of 24% and 17% respectively from the 1P reserve of 150.2 bcf and the 2P reserve of 179.4 bcf as at 2020YE. After deducting net gas production of 31.9 bcf for 2021, 1P reserves decreased by 3% and 2P reserves increased by 0.4%. The 1P reserve decreased after deducting the 2021 net gas production due to the delay in the commencement of production of some of the completed wells in 2020 to 2021. 2P reserves increased slightly due to the increase in the number of thin coal seam planned wells in the future. The increased 2P reserves will also continue to contribute to the continued high production of Panzhuang concession.

The 1P reserve and 2P reserve in Mabi concession were 37.3 bcf and 487.0 bcf as at 2021YE, representing an increase of 26% and an increase of 6% respectively from the 1P reserve of 29.7 bcf and the 2P reserve of 461.2 bcf as at 2020YE. After deducting net gas production of 3.1 bcf for 2021, the 1P reserve increased by 40% and the 2P reserve increased by 6%. Due to the acceleration of drilling operations and the commissioning of new wells in Mabi concession in 2021, the production capacity contribution from new wells has increased, resulting in a significant increase in 1P reserves. The Group's pilot test in the northern area of Mabi concession achieved good gas production results, strengthened well position deployment in the area, and optimized long-range plan ("LRP"), resulting in an increase in estimated 2P reserves.

#### 3. 儲量升級

根據獨立儲量認證公司Netherland Sewell & Associates Inc. (「NSAI」) 發佈的報告，截至2021年底，本集團的1P和2P天然氣儲量分別約為1,520億立方英尺和6,351億立方英尺，較2020年底的1P儲量1,799億立方英尺降低了16%，較2020年底的2P儲量6,406億立方英尺降低了1%。扣除2021年淨產氣量350億立方英尺後，1P儲量增長了5%，2P儲量增長了5%。

潘莊區塊2021年底的1P和2P儲量分別為1,147億立方英尺和1,481億立方英尺，較2020年底的1P儲量1,502億立方英尺降低了24%，較2020年底的2P儲量1,794億立方英尺降低了17%。扣除2021年淨產氣量319億立方英尺後，1P儲量降低了3%，2P儲量增長了0.4%。由於2020年部分完鑽的井投產時間延遲至2021年，在扣除2021年淨產氣量後，1P儲量有所下降。由於未來薄煤層規劃井數增加，2P儲量略有增長。增加的2P儲量也將繼續為潘莊區塊持續高產做貢獻。

馬必區塊2021年底的1P和2P儲量分別為373億立方英尺和4,870億立方英尺，較2020年底的1P儲量297億立方英尺增加了26%，較2020年底的2P儲量4,612億立方英尺增長了6%。扣除2021年淨產氣量31億立方英尺後，1P儲量增加了40%，2P儲量增長了6%。由於2021年加快了馬必區塊的鑽井作業及新井投產進度，提升了新井產能貢獻，使1P儲量大幅上升。本集團在馬必區塊北區進行的試探試驗獲得了良好的產氣效果，強化了該區域的井位部署力度，同時優化了長期規劃(「LRP」)，使評估的2P儲量有所增加。

### MARKET OPERATION REVIEW

In 2021, the domestic epidemic stabilised. The establishment of the national "dual carbon" goal further promoted the rapid growth of demand in the natural gas market. The growth rate of domestic natural gas production was lower than expected, and the import volume increased significantly. Driven by the continuous rebound of international oil prices and the gradual strengthening of supply and demand fundamentals, the natural gas market experienced a sluggish low season and a more prosperous peak season.

Looking back on the domestic natural gas market, the market-oriented trading system was established in an orderly manner. Driven by the service system of China Pipeline Network Corporation's shipper service system, the market supply has gradually diversified, the upstream resources are supplied through multiple channels, the midstream resources are efficiently collected and transported through "one network", and the downstream market system of "X + 1 + X" with benign competition is further improved. In 2021, the Group focused on more in-depth industry and market research to improve market sensitivity, seize the industry cycle dividends, deploy and build the industrial ecological chain, continuously optimize the customer structure, enhance the ability to resist risks, and achieve the increase in both product volume and price. The specific performance is as follows:

In 2021, the annual gross sales volume of Panzhuang concession reached 1,142 MMCM (40.4 bcf), representing a year-on-year increase of 21.10%, of which 314 MMCM (11.1 bcf) for LNG customers, 818 MMCM (28.9 bcf) for piped gas customers and 10 MMCM (0.4 bcf) for CNG customers. The annual realized ASP of Panzhuang concession was RMB1.80 per cubic meter, representing a year-on-year increase of 26.76%, and the annual production-to-sale ratio of Panzhuang concession was 97.23%.

In 2021, the annual gross sales volume of Mabi concession reached 108 MMCM (3.8 bcf), representing a year-on-year increase of 76.66%, of which 105 MMCM (3.7 bcf) of piped gas customers and 3 MMCM (0.1 bcf) of CNG customers. The annual average realized sales price of Mabi concession was RMB1.67 per cubic meter, representing a year-on-year increase of 21.01%, and the annual production-to-sale ratio of Mabi concession was 87.73%.

### 市場經營回顧

2021年國內疫情趨於穩定，國家「雙碳」目標的確立進一步推動天然氣市場需求快速增長，而國內天然氣產量增速不及預期，進口量大幅增加。在國際油價持續反彈及供需基本面逐步走強的推動下，天然氣市場出現淡季不淡、旺季更旺的行情。

回顧國內天然氣市場格局，市場化交易體系有序構建。在國家管網公司托運商服務制度推動下，形成了市場供應主體逐漸多元化，表現為上游資源多主體多渠道供應，中游「一張網」高效集輸，下游市場化良性競爭的「X+1+X」市場體系更進一步。2021年，本集團著力於更深入的行業及市場的研究，提升市場敏感度，抓住行業週期紅利，部署、建設產業生態鏈，持續優化客戶結構，增強抗風險能力，實現了產品量價齊漲，具體表現如下：

2021年，潘莊區塊全年總銷售氣量達到11.42億立方米（即404億立方英尺），同比增長21.10%，其中LNG客戶3.14億立方米（111億立方英尺）、管道氣客戶8.18億立方米（289億立方英尺）、CNG客戶0.1億立方米（4億立方英尺），潘莊區塊全年平均實現銷售價格為人民幣1.80元每立方米，同比上漲26.76%，潘莊區塊全年產銷比為97.23%。

2021年，馬必區塊全年總銷售氣量達到1.08億立方米（即38億立方英尺），同比上漲76.66%，其中管道氣客戶1.05億立方米（37億立方英尺）、CNG客戶0.03億立方米（1億立方英尺），馬必區塊全年平均實現銷售價格為人民幣1.67元每立方米，同比上漲21.01%，馬必區塊全年產銷比為87.73%。

#### 1. Strictly carry out normalized prevention and control and comprehensively expand the scope of epidemic prevention and control

The overall situation of the pandemic in China has generally stabilized, but there is a situation of high local concentration and spread across the country. Although the epidemic has entered the stage of normalized prevention and control, the situation of epidemic prevention and control is still severe. The Company adhered to and implemented the prevention and control requirements of local governments at all levels and industry management departments, adopted strong measures, and continued to achieve the “three zero” epidemic prevention results of “zero confirmed case, zero suspected case and zero infection”. On this basis, the Company comprehensively expanded the scope of epidemic prevention and control. In terms of supply chain, the Company strictly controlled suppliers to ensure the safety of material supply in the epidemic time; In terms of market operation, the Company will improve its sensitivity to market changes, make plans in advance, avoid the recurrence of production fluctuations due to the impact of the pandemic, comprehensively ensure the Company’s safe production, and achieve a new record high in the Company’s performance.

#### 2. Health, Safety and Environment (“HSE”)

The Group placed great value on HSE and made efforts on assuming its social responsibilities. 2021 is a year of rapid development for the Company’s business. HSE work is full of challenges. By updating the safety production standardization system, and strengthening safety education and training, contractor management, ecological and environmental management and safety culture construction, the Group continues to strengthen the HSE awareness of employees. In 2021, the Group continued to maintain zero lost time injury rate (“LTIR”), zero total recordable incident rate (“TRIR”) and zero environmental pollution incident rate in respect of the HSE performance. As of 31 December 2021, the Group has achieved extraordinary results of a total of 7 years and 117 days without lost time injury.

#### 1. 嚴格進行常態化防控，全面拓展疫情防控範圍

國內疫情總體趨穩，但呈現局部高度聚集、全國多點散發的情況。雖進入疫情常態化防控階段，但疫情防控形勢依然嚴峻。本公司堅持遵守、並貫徹落實屬地各級政府和行業管理部門的防控要求，採取強有力的措施，繼續實現了「零確診、零疑似、零感染」的「三零」防疫成果。在此基礎上，本公司全面拓展疫情防控範圍，在供應鏈方面，本公司嚴格管控供應商，保障疫情時期下的物資供應安全；在市場經營方面，提高對市場變化的敏感度，提前佈局，避免再次出現因疫情衝擊而帶來的產量波動，全面保障公司安全生產的開展，實現公司業績的再創新高。

#### 2. 健康、安全、環境(HSE)

本集團高度重視HSE工作及履行社會責任的義務。2021年是公司業務高速發展的一年，HSE工作充滿挑戰，通過對安全生產標準化體系更新，並加強安全教育培訓、承包商管理、生態環境管理和安全文化建設，持續強化員工的HSE意識，2021年本集團繼續保持了損失工時事故（「LTIR」）為零、總可記錄事故（「TRIR」）為零、環境污染事故為零的健康安全環保績效。截至2021年12月31日，本集團取得了累計7年零117天無損失工時事故的優秀安全業績。

#### 3. Quality and Efficiency Improvement Through Technological Innovation

The Group is committed to improving quality and efficiency through technological innovation. In Panzhuang concession, combined with the actual production situation, the negative pressure extraction technology was adopted for the production wells that have a greater impact on the coal mine area, which accelerated the extraction of CBM and improved the recovery rate of CBM. The daily production volume of the three tested wells was 0.002-0.004 MMCM, and the efficiency was obvious. In Mabi concession, a number of small and micro technology innovations in the selection of deep well drainage equipment and the optimization of pipe column structure have been formed, extending the inspection and pump cycle. For deep well drainage, the three stages of "drainage and pressure reduction", "gas exploration and production improvement" and "quantitative and stable production" have been summarized and the relevant factors of geological conditions have been strengthened, providing strong support for the current stable production and subsequent evaluation.

#### 4. Focus on Improving Internal Management

The Group insists that talents are the primary resources and attaches great importance to the cultivation and development of talents. In 2021, the Group conducted a systematic review of middle and senior management team and formulated a team and personal development implementation plan, so as to cultivate and improve the professional skills and management skills of middle and senior management of the Company in a more targeted manner, providing an effective guarantee for the future development of the Company. In addition to talent development factors, the digital economy is leading the upgrading and transformation of traditional industries. In 2021, the Group organized and implemented digital research and compiled the "Five-Year Plan for Digital Development", which laid a good foundation for the Company's digital transformation and will also become a strong cornerstone for the Group's industrial development.

#### 3. 以技術創新為手段的提質增效

本集團致力於以技術創新為手段的提質增效。在潘莊區塊，結合生產實際情況，對受煤礦區域影響較大的生產井採用負壓抽採技術，加速了煤層氣的抽採，提高了煤層氣的採收率，試驗的3口井日增產氣量在0.2-0.4萬方，增效明顯。在馬必區塊，形成了關於深井排採設備選型及管柱結構優化方面的多項小微技術創新，延長了檢泵週期，並針對深井排採，總結了「排水降壓」、「見氣提產」及「定量穩產」三個階段與地質條件的強相關因素，為當前的穩產及後期的評價提供強力支持。

#### 4. 著力提升內部管理水平

本集團堅持人才是第一資源，重視人才的培養與發展，2021年，本集團對中高層管理人員進行了系統性盤點並制定團隊及個人發展實施方案，更具針對性的培養、提升本公司中高層管理人員的專業技能、管理技能，為公司未來的發展提供有效保障。除人才發展因素外，數字經濟正在引領傳統產業的升級與轉型，2021年本集團組織實施數字化調研並編制了《數字化發展五年規劃》，其為實現公司數字化轉型奠定了良好基礎，也將成為本集團產業發展強有力的基石。

#### 5. Five-Year Strategic Plan for Sustainable Development

The Group always adheres to the core value of sustainable development and actively improves the sustainable development management system. The Group has established an ESG organizational structure with the Board as the highest decision-making level, the ESG working group as the main body of responsibility, and the ESG executive management group and its subordinate divisions as the main body of execution. In 2021, under the leadership of the ESG working group of the Board, the Company sorted out and analyzed the ESG management status, and further improved the Company's sustainable development governance system, optimized the sustainable development governance structure, refined and implemented the sustainable development function and division of labor, promoted the systematic management of ESG information at the same time, collected ESG information on a quarterly basis for business operation, conducted daily management of potential ESG risks, incorporated ESG management into the Company's business operation, promoted the implementation of the Five-Year Strategic Plan for Sustainable Development, and initially formed the key performance indicators of ESG environmental objectives. The Company will lay a solid foundation for ESG management to meet higher compliance requirements and capital market requirements and to make greater contributions to environmental protection.

#### 6. Strengthening Integrated Construction and Building an Ecological Chain of Natural Gas Industry

Through the integrated construction of upstream, midstream and downstream, AAG Energy has initially formed an upstream natural gas industry ecological chain with advanced technology as the core element, strengthened the investment management and control upgrading of the existing Panzhuang and Mabi concessions, actively explored the acquisition of new concessions and new resources, guaranteed market access through the midstream transmission and distribution pipelines, and strengthened the development of market customers downstream, continuously consolidated the Group's core competitiveness, and strengthened the ability to respond to market and resist risks.

AAG Energy continues to explore and innovate in management, technology and business models, and promotes innovation and maximization of synergistic benefits from the perspective of natural gas industry ecological chain, aiming to achieve continuous acquisition and development of upstream resources, stabilize midstream output, and expansion of downstream market, so as to build the core competitiveness of the Group and build an ecological chain of natural gas industry.

#### 5. 可持續發展五年戰略規劃

本集團始終堅守可持續發展的核心價值理念，積極完善可持續發展管理體系。本集團已建立以董事會為最高決策層級，以 ESG 工作組為責任主體，以 ESG 執行管理組及其下設分組等為執行主體的 ESG 組織架構。2021 年在董事會 ESG 工作組的領導下，對 ESG 管理現狀進行了梳理與分析，對標國內外同行，進一步完善公司可持續發展治理體系，優化可持續發展治理架構，細化落實可持續發展職能與分工，同時推動 ESG 信息體系化管理，對業務運營進行季度 ESG 信息收集，對潛在 ESG 風險進行日常管理，將 ESG 管理不斷納入公司業務運營，推進落實《可持續發展五年戰略規劃》、初步設定 ESG 環境目標相關關鍵績效指標。為 ESG 管理滿足更高的合規要求、資本市場要求，為環境保護作出更大的貢獻奠定堅實的保障。

#### 6. 加強一體化建設，構築天然氣產業生態鏈

亞美能源通過上、中、下游的一體化建設，目前已初步形成上游以先進技術為核心要素，加強對現有潘莊、馬必區塊的投資管控升級、積極探索新區塊與新資源的獲取，中游通過輸配管線，保障市場通路，下游加大市場客戶開發力度的天然氣產業生態鏈，不斷夯實本集團的核心競爭力，加強市場應對與風險抵抗的能力。

亞美能源在管理、技術、商業模式上不斷探索與創新，用天然氣產業生態鏈的視角，促進創新、協同效益最大化，旨在實現上游資源的持續獲取與開發，中游穩定輸出，下游市場拓展，全力打造本集團的核心競爭力，構築天然氣產業生態鏈。

*Revenue.* Our revenue increased by RMB701 million or 67.47% from RMB1.038 billion in 2020 to RMB1.739 billion in 2021. The increase was mainly due to the increase in realized ASP and net sales volume as a result of the increase in production volume in Panzhuang and Mabi concessions, as well as the increase in revenue due to the new energy trading and LNG processing and sales businesses. The gross production volume of Panzhuang concession increased by 21.46% from 967 MMCM in 2020 to 1,175 MMCM in 2021; realized ASP increased from RMB1.42 per cubic meter in 2020 to RMB1.80 per cubic meter in 2021. The gross production volume of Mabi concession increased by 84.22% from 67 MMCM in 2020 to 123 MMCM in 2021; realized ASP increased from RMB1.38 per cubic meter in 2020 to RMB1.67 per cubic meter in 2021.

*Subsidy income.* Our subsidy income decreased from RMB155 million in 2020 to RMB112 million in 2021, representing a decrease of RMB43 million or 27.99%, mainly due to the lower criteria set by the subsidizing authorities.

*VAT refund.* Our VAT refund increased by RMB55 million or 64.33% from RMB85 million in 2020 to RMB140 million in 2021, mainly due to the increase in realized ASP and net sales volume of Panzhuang and Mabi concessions.

*Other gains, net.* Our other gains increased by RMB15.93 million or 760.24% from RMB2.09 million in 2020 to RMB18.02 million in 2021, primarily due to the investment income arising from disposal of financial assets.

*收入。*我們的收入由2020年的人民幣10.38億元增加了人民幣7.01億元或67.47%至2021年的人民幣17.39億元。該增加主要是來自於潘莊區塊和馬必區塊的平均實現銷售價格增加及產量增加導致的淨銷量增加，以及新增能源貿易及LNG加工銷售業務導致收入增加。潘莊區塊的總產量由2020年的9.67億立方米增長了21.46%至2021年的11.75億立方米；平均實現銷售價格從2020年的每立方米人民幣1.42元增加至2021年的每立方米人民幣1.80元。馬必區塊的總產量由2020年的0.67億立方米增長了84.22%至2021年的1.23億立方米；平均實現銷售價格從2020年的每立方米人民幣1.38元增加至2021年的每立方米人民幣1.67元。

*Operating expenses.* Our operating expenses increased by RMB304 million or 54.47% from RMB557 million in 2020 to RMB861 million in 2021, primarily due to the increase in depreciation and amortization as a result of the increase in production wells, the increase in materials, services and logistics as a result of the increase in production wells, the newly incurred sales costs of LNG, and the newly incurred exploration expenses.

- *Depreciation and amortisation.* Our depreciation and amortization increased by RMB125 million or 46.12% from RMB271 million in 2020 to RMB396 million in 2021, mainly due to the increase in production wells and production volume in Panzhuang and Mabi concessions.
- *Employee benefit expenses.* Our employee benefit expenses increased by RMB30 million or 40.25% from RMB73 million in 2020 to RMB103 million in 2021, primarily due to the increase in wages and bonuses.
- *Exploration expenses.* Our exploration expenses were RMB50.28 million, primarily due to the permanent well closure in Mabi concession.
- *Materials, services and logistics.* Our materials, services and logistics expenses increased by RMB93 million or 48.64% from RMB191 million in 2020 to RMB284 million in 2021, primarily due to the increase in repair, wastewater treatment and other operating costs as a result of more wells coming into production and increased production, and the newly increased sales costs of LNG.
- *Net impairment losses on financial assets.* Our net impairment losses on financial assets were RMB7.60 million and RMB9.76 million in 2020 and 2021 respectively, primarily due to the expected credit losses on trade receivables and other receivables.
- *Others.* Our other expenses were RMB14.19 million and RMB17.82 million in 2020 and 2021 respectively.

*經營開支。*我們的經營開支由2020年的人民幣5.57億元增加了人民幣3.04億元或54.47%至2021年的人民幣8.61億元，主要是由於生產井增加導致的折舊及攤銷增加，生產井增加導致的材料、服務及物流增加，新增的LNG銷售成本，以及新增的勘探開支所致。

**EBITDA.** Our EBITDA increased by RMB550 million or 55.25% from RMB995 million in 2020 to RMB1.545 billion in 2021. The increase was primarily due to the increase in realized ASP and the increase in net sales volume as a result of the increase in production volume in Panzhuang and Mabi concessions, but partially offset by the decrease in subsidy income, the increase in materials, services and logistics, the newly incurred sales costs of LNG and the newly incurred exploration expenses. In conclusion, higher production and realized ASP have led to an increase in EBITDA, the magnitude of which was smaller than the increase in revenue. The EBITDA for 2020 amounted to RMB995 million, including non-operation related business development and legal consulting service expenses of RMB1.07 million. The EBITDA for 2021 amounted to RMB1.545 billion, including non-operating related business development and legal consulting service expenses of RMB7.00 million. The EBITDA of Panzhuang concession increased by RMB484 million or 48.73% from RMB993 million in 2020 to RMB1.477 billion in 2021. The increase in EBITDA of Panzhuang concession in 2021 was mainly due to the increase in production volume and realized ASP, but partially offset by the decrease in subsidy income and the increase in materials, services and logistics. The EBITDA of Mabi concession increased by RMB59.38 million or 419.37% from RMB14.16 million in 2020 to RMB73.54 million in 2021. The increase in EBITDA of Mabi concession in 2021 was primarily due to the increase in production and realized ASP, but partially offset by the newly incurred exploration expenses.

**Profit from operations.** As a result of the foregoing, our profit from operations increased by RMB424 million or 58.67% from RMB724 million in 2020 to RMB1.148 billion in 2021.

**Finance income.** Our finance income decreased by RMB8.72 million or 26.22% from RMB33.24 million in 2020 to RMB24.52 million in 2021, primarily due to the decrease in cash and bank balances.

**Finance costs.** Our finance costs were RMB4.83 million and RMB5.75 million in 2020 and 2021, respectively.

**EBITDA。**我們的EBITDA由2020年的人民幣9.95億元增加了人民幣5.50億元或55.25%至2021年的人民幣15.45億元。該增加主要是由於潘莊區塊和馬必區塊的平均實現銷售價格增加及產量增加導致的淨銷量增加，惟部分被補貼收入減少，材料、服務及物流增加，新增的LNG銷售成本以及新增的勘探開支所抵銷。概括而言，更高的產量和平均實現銷售價格導致EBITDA的增加，但幅度小於收入的增加幅度。2020年的EBITDA人民幣9.95億元包括非營運相關的業務發展和法律諮詢服務費開支人民幣107萬元。2021年的EBITDA人民幣15.45億元包括非營運相關的業務發展和法律諮詢服務費開支人民幣700萬元。潘莊區塊的EBITDA由2020年的人民幣9.93億元增加了人民幣4.84億元或48.73%至2021年的人民幣14.77億元。潘莊區塊2021年的EBITDA增加主要是由於產量和平均實現銷售價格增加，惟部分被補貼收入減少以及材料、服務及物流增加所抵銷。馬必區塊的EBITDA由2020年的人民幣1,416萬元增加了人民幣5,938萬元或419.37%至2021年的人民幣7,354萬元。馬必區塊2021年的EBITDA增加主要是由於產量和平均實現銷售價格增加，惟部分被新增的勘探開支所抵銷。

**財務費用。**我們2020年和2021年的財務費用分別為人民幣483萬元和人民幣575萬元。

*Exchange losses.* Our exchange losses decreased from RMB9.46 million in 2020 to RMB8.60 million in 2021, primarily due to the foreign exchange gains of monetary items in foreign currency arising from the exchange rate fluctuations for foreign currency against RMB.

*Share of net loss of associates accounted for using the equity method.* Our share of net loss of associates accounted for using the equity method was RMB14.05 million in 2021.

*Profit before income tax.* Our profit before income tax increased by RMB401 million, or 54.10%, from RMB743 million in 2020 to RMB1.144 billion in 2021, primarily due to the factors affecting EBITDA as described above, partially offset by the increase in depreciation and amortization expenses, the decrease in finance income, the increase in finance costs, exchange losses and share of net loss of associates accounted for using the equity method incurred.

*Income tax expense.* Our income tax expenses increased by RMB97 million or 41.49% from RMB232 million in 2020 to RMB329 million in 2021, mainly due to the increase in profit before income tax of Panzhuang concession and the increase in deferred income tax expenses of Mabi concession in 2021.

*Profit for the year.* Our profit for the year increased by RMB306 million or 59.84% from RMB510 million in 2020 to RMB816 million in 2021, mainly due to the factors affecting profit before income tax stated above but partially offset by the increase in income tax expense.

### EBITDA AND ADJUSTED EBITDA

We provide a reconciliation of EBITDA and adjusted EBITDA to profit for the year, which is the most directly comparable financial performance calculated and presented in accordance with HKFRS. EBITDA refers to earnings before finance income, finance costs, exchange gains/losses, share of net loss of associates accounted for using the equity method, income tax and depreciation and amortization. Adjusted EBITDA refers to EBITDA adjusted to exclude non-cash expenses, non-recurring items or non-operation-related expenses to demonstrate EBITDA of the Group's core operations.

*匯兌損失。*我們的匯兌損失由2020年的人民幣946萬元減少至2021年的人民幣860萬元，主要是由於外幣貨幣性項目因外幣對人民幣匯率波動而形成的外幣折算收益所致。

*應佔按權益法入賬的聯營公司投資虧損。*我們2021年的應佔按權益法入賬的聯營公司投資虧損為人民幣1,405萬元。

*除所得稅前利潤。*我們的除所得稅前利潤由2020年的人民幣7.43億元增加了人民幣4.01億元或54.10%至2021年的人民幣11.44億元，主要是因為上述影響EBITDA的因素，惟部分被折舊及攤銷開支增加、財務收益減少、財務費用增加、匯兌損失和應佔按權益法入賬的聯營公司投資虧損所抵銷。

*所得稅費用。*我們的所得稅費用由2020年的人民幣2.32億元增加了人民幣0.97億元或41.49%至2021年的人民幣3.29億元，主要是由於2021年潘莊區塊的除所得稅前利潤增加及馬必區塊的遞延所得稅費用增加所致。

*年度利潤。*我們的年度利潤由2020年人民幣5.10億元增加了人民幣3.06億元或59.84%至2021年人民幣8.16億元，主要是由於上述影響除所得稅前利潤的因素所致，惟部分被所得稅費用增加所抵銷。

We have included EBITDA and adjusted EBITDA as we believe they are financial measures commonly used in the oil and gas industry. We believe that EBITDA and adjusted EBITDA are used as supplemental financial measures by our management, investors, research analysts, bankers and others to assess our operating performance, cash flow and return on capital as compared to those of other companies in our industry, and our financing ability. However, EBITDA and adjusted EBITDA should not be considered in isolation or construed as alternatives to profit from operations or any other measure of performance or as indicators of our operating performance or profitability. EBITDA and adjusted EBITDA are unable to account for income tax, share of net loss of associates accounted for using the equity method, exchange gains/losses, finance income, finance costs and depreciation and amortization.

The following table sets forth a reconciliation of EBITDA and adjusted EBITDA to profit for the year.

Our EBITDA increased by RMB550 million or 55.25% from RMB995 million in 2020 to RMB1.545 billion in 2021. The increase was primarily due to the increase in realized ASP and the increase in net sales volume as a result of the increase in production volume in Panzhuang and Mabi concessions, but partially offset by the decrease in subsidy income, the increase in materials, services and logistics, the newly incurred sales costs of LNG and the newly incurred exploration expenses. In conclusion, higher production and realized ASP have led to an increase in EBITDA, the magnitude of which was smaller than the increase in revenue.

Our adjusted EBITDA increased by RMB556 million or 55.79% from RMB996 million in 2020 to RMB1.552 billion in 2021. The increase was due to the aforementioned reasons for the increase in EBITDA coupled with the increase in non-operation-related business development and legal consulting service expenses.

### LIQUIDITY AND CAPITAL RESOURCES

The Group's financial management department is responsible for the financing and fund management policies related to the overall operations of the Group. Our investment funds were mainly derived from cash generated from operating activities.

As at 31 December 2021, we had cash and bank balances of RMB1.887 billion (31 December 2020: RMB1.846 billion).

Save as the information disclosed above or otherwise in this annual report, the Group had no outstanding mortgage, pledge, debentures or other loan capital issued or agreed to be issued, bank overdrafts, borrowings, liabilities under acceptance or other similar liabilities, hire purchase and finance lease commitments, or any guarantee or other material contingent liabilities as at 31 December 2021.

### 流動資金及資本資源

#### Operating activities

Net cash generated from operating activities in 2021 was RMB1.363 billion, mainly due to profit before income tax of RMB1.144 billion, depreciation and amortization of RMB397 million and exploration expenses of RMB50.28 million. These items were offset by income tax paid of RMB210 million and share of net loss of associates accounted for using the equity method of RMB14.05 million.

Net cash generated from operating activities in 2020 was RMB534 million, mainly due to profit before income tax of RMB743 million and depreciation and amortization of RMB271 million. These items were offset by income tax paid of RMB124 million and an increase in trade and other receivables of RMB375 million.

#### 經營活動

於2021年，經營活動所得現金淨額為人民幣13.63億元，主要是由於除所得稅前利潤人民幣11.44億元，折舊及攤銷人民幣3.97億元以及勘探開支人民幣5,028萬元。該等項目被已付所得稅人民幣2.10億元和應佔按權益法入賬的聯營公司投資虧損人民幣1,405萬元所抵銷。

於2020年，經營活動所得現金淨額為人民幣5.34億元，主要是由於除所得稅前利潤人民幣7.43億元和折舊及攤銷人民幣2.71億元。該等項目被已付所得稅人民幣1.24億元、應收賬款及其他應收款增加人民幣3.75億元所抵銷。

#### Investing activities

Net cash used in investing activities in 2021 was RMB1.168 billion, mainly comprised of purchases of property, plant and equipment of RMB699 million, investments in associates of RMB234 million, purchases of term deposits with maturity over 3 months of RMB200 million. The purchase of property, plant and equipment mainly comprised of payment for more wells drilled, additional well head compressors and construction of gas gathering stations and power facilities.

Net cash used in investing activities in 2020 was RMB431 million, mainly comprised of purchases of property, plant and equipment of RMB504 million, offset by the decrease in term deposits with maturity over 3 months of RMB47.31 million and the interest received of RMB29.27 million. The purchase of property, plant and equipment mainly comprised of payment for more wells drilled, additional well head compressors and construction of gas gathering stations and power facilities.

#### Financing activities

Net cash used in financing activities in 2021 was RMB356 million, which was mainly due to the payment of dividend of RMB351 million for year ended 31 December 2020 and repayment of lease liabilities of RMB6.19 million.

Net cash used in financing activities in 2020 was RMB368 million, which was mainly due to the payment of dividend of RMB359 million for the year ended 31 December 2019 and repayment of lease liabilities of RMB8.9 million.

#### Cash and bank balances

We had cash and bank balances of RMB1.846 billion and RMB1.887 billion as at 31 December 2020 and 2021, respectively. Our cash and bank balances consist of cash on hand, cash at banks and restricted bank deposits. As at 31 December 2020 and 2021, approximately 30.30% and 0.84% of our cash and bank balances were held in Hong Kong dollars or US dollars, respectively.

#### 投資活動

於2021年，投資活動所用現金淨額為11.68億元，主要包括購買人民幣6.99億元的不動產、工廠及設備，投資聯營公司人民幣2.34億元，購買三個月以上定期存款人民幣2.00億元。購買不動產、工廠及設備主要包括支付更多已鑽探的井、添置井口增壓機及興建集氣站和電力設施。

於2020年，投資活動所用現金淨額為4.31億元，主要包括購買人民幣5.04億元的不動產、工廠及設備，被三個月以上定期存款減少人民幣4,731萬元、已收利息人民幣2,927萬元所抵銷。購買不動產、工廠及設備主要包括支付更多已鑽探的井、添置井口增壓機及興建集氣站和電力設施。

#### 融資活動

於2021年，融資活動所用的現金淨額為人民幣3.56億元，主要用於支付截至2020年12月31日止年度的股息人民幣3.51億元及償還租賃負債人民幣619萬元。

於2020年，融資活動所用的現金淨額為人民幣3.68億元，主要用於支付截至2019年12月31日止年度的股息人民幣3.59億元及償還租賃負債人民幣890萬元。

#### 現金及銀行結餘

於2020年及2021年12月31日，我們的現金及銀行結餘分別為人民幣18.46億元及人民幣18.87億元。我們的現金及銀行結餘包括結存現金、銀行存款及受限制銀行存款。於2020年及2021年12月31日，我們有約30.30%及0.84%的現金及銀行結餘分別以港元或美元持有。

### FINANCIAL RISK FACTORS

The operating activities of the Group expose to a variety of financial risks: credit risk, market risk (includes foreign exchange risk), liquidity risk and concentration risk. The overall risk management program of the Group focuses on the unpredictability of financial markets and seeks to minimize potential adverse effects on the financial performance of the Group.

#### Credit risk

Credit risk of the Group arises from cash at bank, trade and other receivables and other financial assets at amortised cost.

As the majority of the cash at bank are placed with state-owned and international banks and financial institutions in the PRC and Hong Kong, and there has been no recent history of default in relation to these banks and financial institutions, the corresponding credit risk is relatively low.

The Group has controls in place to assess the credit quality of its customers, taking into account of their financial positions, past experience and other factors. The Group's sales were only made to the customers with good credit history. The utilisation of credit limits is regularly monitored.

#### Foreign exchange risk

The Group is exposed to foreign exchange risk arising from various currency exposures, particularly with respect to US dollar. Foreign exchange risk arises when future commercial transactions or recognized assets or liabilities are denominated in a currency other than the entity's functional currency.

Prior to 30 April 2016, we were exposed to non-cash foreign exchange risks arising from retranslation of inter-company loans denominated in US dollar. To manage the foreign exchange risk, the management decided to execute a debt restructuring on 30 April 2016 by converting the inter-company loans into perpetual loans through entering into perpetual loan agreements between respective group companies such that the perpetual loans do not bear interest and the lenders cannot request repayment. Upon completion of this debt restructuring, any foreign exchange difference arising from the retranslation of these US dollar denominated perpetual loans was recognized in equity in the consolidated financial statements.

### 財務風險因素

本集團的經營活動面臨各種財務風險：信用風險、市場風險（包括外匯風險）、流動性風險及集中風險。本集團的整體風險管理計劃專注於金融市場的不可預測性，並致力減低對本集團財務表現的潛在不利影響。

#### 信用風險

本集團的信用風險來自銀行存款、應收賬款及其他應收款以及以攤餘成本計量的其他金融資產。

由於大部分銀行存款存放於中國及香港的國有及國際銀行及金融機構，且該類銀行及金融機構近期並無違約記錄，相應信用風險相對較低。

本集團實施控制措施以評估客戶的信用資質，考慮其財務狀況、過往經驗及其他因素。本集團只向具有良好信貸記錄的客戶進行銷售。信用限額的使用會受定期監控。

#### 外匯風險

本集團須承受各種貨幣所產生外匯風險，尤以美元為甚。當未來商業交易或已確認資產或負債以實體功能貨幣以外的貨幣計值，則會產生外匯風險。

2016年4月30日之前，本集團承受的非現金外匯風險來自重新折算的以美元計價的公司間貸款。為了管理外匯風險，管理層決定於2016年4月30日執行債務重組，通過將公司間貸款轉為永久性貸款。所屬的集團公司各自簽訂永久貸款協定，永續貸款不承計利息並且貸款方不得要求償還。在此次債務重組完成時，由這些美元永續貸款轉換產生的任何匯兌差異在合併財務報表確認為權益。

#### Foreign exchange risk (Continued)

The Group manages its foreign exchange risk by closely monitoring the movement of the foreign exchange rates and companies' internal accounts denominated in US dollar.

As at 31 December 2021, if RMB had weakened/strengthened by 1% against US dollar, with all other variables being held constant, profit before income tax for the year would have been RMB1,187,000 (31 December 2020: RMB1,649,000) higher/lower, respectively, mainly as a result of foreign exchange gains/losses on translation of US\$ denominated receivables and payables held by our entities with their functional currency as RMB.

### SIGNIFICANT INVESTMENTS

The Group did not hold any significant investments for the year ended 31 December 2021.

### ACQUISITION AND DISPOSAL OF SUBSIDIARIES OR ASSOCIATES

The details of acquisition of associates by the Group are disclosed in note 9 to the section headed "Consolidated Financial Statements" of this annual report. Save as disclosed above, the Group had no other acquisition or disposal of subsidiaries or associates for the year ended 31 December 2021.

### IMPACT OF 2021 POLICY

On 3 June 2021, the Shanxi Provincial Government issued the "Approval Procedure for Coal-Formed Gas Mining Projects in Shanxi Province" (《山西省煤成氣開採項目審批流程》), which requires that, according to the characteristics of coal-formed gas projects, the coal-formed gas mining process shall be divided into four stages: acquisition of mining rights, exploration, development and production, and relinquishment. Through optimization of the approval procedure, the approval time frame is considerably shortened, further accelerating the development progress of CBM exploration and development.

On 24 October 2021, the Central Committee of the Communist Party of China and the State Council issued the "Opinions on Fully and Accurately Implementing the New Development Concept to Work on Carbon Peak and Carbon Neutrality" (《關於完整準確全面貫徹新發展理念做好碳達峰、碳中和工作的意見》), which requires arrangement and deployment for the dual-carbon work at national level, and the construction of a clean, low-carbon, safe and efficient energy system. As the most clean and low-carbon fossil energy, natural gas is a key way to achieve the adjustment of the energy industry structure. As an upstream CBM exploration and development enterprise, the Group will benefit from the dual effects of policies and market in the current and long term in the future, and further increase the release of CBM production capacity and economic benefits.

#### 外匯風險(續)

本集團密切監控匯率變動及美元公司內部往來款賬戶，以管理外匯風險。

於2021年12月31日，如人民幣兌美元貶值／升值1%，而所有其他可變因素保持不變，則除所得稅前年度利潤將分別增加／減少人民幣1,187,000元(2020年12月31日：人民幣1,649,000元)，主要原因是將本集團實體所持以美元計值的往來款換算為其功能貨幣人民幣所產生的匯兌收益／損失。

### 重大投資

截至2021年12月31日止年度，本集團並未有任何重大投資。

### 收購及出售附屬公司或聯營公司

截至2021年12月31日止年度，本集團收購聯營公司之詳情載於本年報「合併財務報表」一節附註9。除上文所披露者外，本集團並無其他收購或出售附屬公司或聯營公司之事項。

### 2021年政策影響

2021年6月3日，山西省政府出台了《山西省煤成氣開採項目審批流程》，要求按照煤成氣項目特點，將煤成氣開採環節劃分為礦業權取得、勘查、開發生產、區塊退出四個階段，通過優化審批流程，極大壓縮了審批時限，進一步加速了煤層氣勘探開發進度。

2021年10月24日，中共中央、國務院印發了《關於完整準確全面貫徹新發展理念做好碳達峰、碳中和工作的意見》，從國家層面對雙碳工作進行安排部署，要求構建清潔低碳、安全高效的能源體系，而天然氣作為最清潔低碳的化石能源，是能源產業結構調整的重要實現途徑。本集團作為煤層氣上游勘探開發企業，在當前及未來較長時期內，將得益於政策和市場雙重效應，加大提升煤層氣產能釋放，連帶提升經濟效益。

### OUTLOOK AND GUIDANCE FOR 2022

Notwithstanding the resurgence of the COVID-19 pandemic in some regions, global economy is anticipated to recover gradually. According to the forecast in the World Economic Outlook Report published by the International Monetary Fund (“IMF”) in January 2022, global economy is expected to grow by 4.4% in 2022. With the steady recovery of the domestic economy and a clear dual carbon goal, natural gas, as a clean and low-carbon energy, will become the major growth point of energy structure adjustment and the main force of low-carbon transformation. China’s natural gas consumption will continue to experience rapid growth.

The Group will continue to strengthen the investment and development strategy of the existing CBM concessions, striving to build an ecological chain of the entire natural gas industry while strengthening the development of CBM transmission and distribution capabilities, thus lowering the market risks of the products. Meanwhile, by leveraging its advantages in CBM exploration and development technology and industry, the Group intends to further expand its upstream resources.

Driven by the dual-carbon goals, the Group will continue to strengthen the ESG management system by further integrating the strategic objectives of sustainable development into the development planning system of AAG Energy, setting up strategic objectives with sustainable development as the core, breaking down the work implementation plan and promoting the implementation. For investment related to development and construction in the future, the Group will continue to focus on scientific and technological innovation by conducting more research on green technology development, facilitating the process of green development.

The impact of the COVID-19 pandemic has not been eliminated, and yet challenges and opportunities coexist in the post-epidemic era. In 2022, the Group will continue to regularly prevent and control the epidemic, striving to maintain the “three zero” record of “zero confirmed case, zero suspected case and zero infection”, with a focus on increasing investment and development of traditional CBM projects led by technological innovation, strengthening the building of the ecological chain of the entire natural gas industry, making unremitting efforts to facilitate cost reduction and higher efficiency for the Company, hence achieving continuous growth in production and net profit.

For 2022, we are pleased to present the latest goals as follows:

### 2022年展望及指引

儘管局部地區新冠疫情捲土重來，但全球經濟有望逐步復甦，根據國際貨幣基金組織（「IMF」）在2022年1月發佈的《世界經濟展望報告》中預測，全球經濟在2022年增長為4.4%。隨著國內經濟穩定恢復，及雙碳目標的明確，作為清潔低碳能源的天然氣將成為能源結構調整的主要增長點和低碳轉型的主力軍，中國天然氣消費將繼續快速增長。

本集團將延續並加強現有煤層氣區塊投資開發發展策略，著力構築天然氣全產業生態鏈，持續加強煤層氣輸配能力建設，降低產品面臨的市場風險。同時，本集團意在憑藉自身在煤層氣勘探開發技術及產業上的優勢，進一步拓展上游資源。

在雙碳目標的推動下，本集團將不斷強化ESG管理體系，將可持續發展戰略目標進一步融入亞美能源發展規劃體系，建立以可持續發展為核心的戰略目標，分解工作行動實施計劃並推進落實。在未來投資開發建設中，本集團將繼續致力於科學技術創新，加強綠色開發技術研究，推進綠色開發進程。

新冠疫情的影響並未退去，後疫情時代挑戰與機遇並存，2022年，本集團將繼續做好疫情的常態化防控，努力保持「零確診、零疑似、零感染」的「三零」記錄，專注於以科技創新為引領的傳統煤層氣項目，強化投資及開發，加強天然氣全產業生態鏈的建設，並堅持不懈地努力推動公司降本增效，繼續實現產量、淨利潤持續增長。

對於2022年，我們欣然呈報更新目標如下：

#### Panzhuang Concession

The Group will continue to strengthen investment in Panzhuang concession in 2022, details are as follows:

- The Group will implement the full year plan upon the related government approvals on Panzhuang concession, including the plans of completing pre-drilling construction of 16 well sites, the drilling work of 61 new wells, the fracturing construction work of 63 new wells, the pumping equipment purchase and commencing production of 72 new wells, as well as implementing related ancillary surface facilities engineering.

Among them, the Group plans to complete the drilling work of 39 new wells in thin coal seams, the fracturing construction work of 50 new wells, the procurement of drainage and production facilities and the commissioning of 50 new wells.

- With the scheduled project implementation and related government approvals, the gross production of Panzhuang concession in 2022 is expected to be 1,188 MMCM (42.0 bcf).
- Due to the frequent coal mining activities in the surrounding coal mines adjoin Panzhuang concession, the Company will continue to strengthen communication and cooperation with these coal mines in 2022, to optimize mutual guarantee agreements and continue to identify new development opportunities and cooperation channels.

#### Mabi Concession

The Group will continue to invest in Mabi concession in 2022, details are as follows:

- In Mabi concession, the Group will continue to enhance the investment and construction per the ODP of the southern area of Mabi concession and optimize the development of the northern area. In 2022, we plan to implement drilling of 176 CBM wells in Mabi concession (including 158 wells in the southern area and 18 wells in the northern area), and will also focus on the development and construction in the area around No. 2 gas gathering station.
- With the scheduled project implementation and related government approvals, the gross production of Mabi concession in 2022 is expected to be 254 MMCM (9.0 bcf).

### 2022年展望及指引(續)

#### 潘莊區塊

2022年，本集團將在潘莊區塊繼續加強投資，具體如下：

- 潘莊區塊在政府相關審批基礎上，開始實施全年計劃，計劃完成16座井場的鑽前工程、61口新井的鑽井作業、63口新井的壓裂施工作業、排採設備採購及72口新井投產，以及實施相應的地面配套設施工程。

其中，在薄煤層計劃完成39口新井的鑽井作業，50口新井的壓裂施工作業、排採設施採購及50口新井投產。

- 基於預期的項目執行和相關的政府審批，潘莊區塊2022年總產量的預期為11.88億立方米(即420億立方英尺)。
- 由於潘莊區塊的週邊煤礦採煤活動頻繁，2022年公司會繼續加強與週邊煤礦的溝通合作，完善互保協議及繼續尋求新的發展機會及合作途徑。

#### 馬必區塊

2022年，本集團將在馬必區塊繼續加大投資，具體如下：

- 在馬必區塊，本集團將繼續堅定不移地強化馬必南區ODP投資建設及優化北區的開發，2022年計劃在馬必區塊新鑽176口煤層氣井(其中包括南區158口和北區18口)，同時重點圍繞2號集氣站區域進行開發建設。
- 基於預期的項目執行和相關的政府審批，馬必區塊2022年總產量的預期為2.54億立方米(即90億立方英尺)。

#### Mabi Concession (Continued)

- According to the Measures for the Administration of Exploration and Exploitation of Coalbed Methane in Shanxi Province (《山西省煤層氣勘查開採管理辦法》) issued by the People's Government of Shanxi Province, the exploration license for Mabi concession, which will be renewed in 2022, will reduce the area of exploration rights in the unproved reserves area by 25%. The reduced area is a resource-weak area. The reduction will not have any impact on the Group's reserves. The Group will continue to update the progress of mining rights.

According to the development plan of Panzhuang concession and Mabi concession mentioned above, the Group estimates to incur capital expenditures of approximately RMB1.578 billion in 2022, which will be financed by its own cash flow. The Group will assess the capital investment plan for 2022 from time to time, and will make necessary disclosure in the interim results for 2022 for any change.

The Group is highly confident in focusing on and dealing with uncertainties, as well as sustainably committed to cost reduction and efficiency enhancement to deliver promising operating results. Meanwhile, we will continue to enhance technological innovation, thereby laying a solid foundation for the stable production and development of Panzhuang concession and the large-scale development of Mabi concession. Besides, the Group will base on its groundbreaking technological advantages to identify new development opportunities mainly in China's market as planned and actively expand new concessions and businesses. The Group firmly believes that the pursuit of excellence in existing concessions and the selection of quality new concessions and businesses opportunities will provide clean energy for more clients and relevant communities and create higher return for our shareholders.

### 2022年展望及指引(續)

#### 馬必區塊(續)

- 根據山西省人民政府下發的《山西省煤層氣勘查開採管理辦法》，馬必區塊於2022年將更新的探礦證將核減未探明儲量區域25%的探礦權面積，核減面積區域為資源薄弱區，核減後不對本集團造成儲量影響，本集團將持續更新礦權進展情況。

根據上述潘莊區塊和馬必區塊的開發計劃，本集團預計將在2022年投入資本性支出約人民幣15.78億元，這些資金將由自身的現金流來解決。本集團將不時評估2022年的資本性投資計劃，並且一旦有必要將在2022年中期業績中披露任何變化。

本集團非常有信心繼續聚焦和應對不確定性，致力於可持續性降本增效，取得更好的經營業績。同時我們將持續推進技術創新，為潘莊區塊的穩產與發展，馬必區塊的大規模開發奠定良好基礎。本集團還將依據規劃，著重聚焦中國市場，以突破性技術優勢為基礎，尋求新的發展機遇，積極拓展新區塊與新業務。本集團堅信，對現有區塊的精益求精，對新區塊、新業務機遇的博觀約取，將為更多的客戶和相關社區提供清潔能源，為股東帶來更好的回報。

The shares of the Company were listed on the Main Board of the Stock Exchange of Hong Kong Limited (the "Stock Exchange") on 23 June 2015 with net proceeds from the initial public offering ("IPO") of approximately RMB1.5069 billion, after deduction of the underwriting commission and other expenses. The Company applied the proceeds from the Listing in accordance with the proposed applications as set out in the section headed "Future Plans and Use of Proceeds — Use of Proceeds" in the prospectus of the Company dated 11 June 2015.

### MAJOR CUSTOMERS AND SUPPLIERS

For the year ended 31 December 2021, the sales to the Group's five largest customers accounted for 46.7% of the total sales for the year, in which the sales to the largest customer represented 10.14%. For the year ended 31 December 2021, the Group's five largest customers were principally engaged in the exploration and exploitation of CBM, liquefaction and processing of CBM, and sales of town gas. The Group and its five largest customers have maintained a relationship for 1 to 2 years and even longer. The credit term granted to the Group's major customers for trade receivables is generally 30 to 90 days, which is consistent with that granted to other customers. In response to the risk of the Group's dependence on major customers in peak-shaving of natural gas, the Group has taken targeted measures to add other customers for peak-shaving and establish a long-term and stable relationship with its customers.

For the year ended 31 December 2021, the purchases from the Group's five largest suppliers accounted for 27.62% of the total purchases for the year in which the purchases from the largest supplier represented 7.57%.

None of the directors of the Company or any of their close associates or any substantial shareholders (which, to the best knowledge of the directors, own more than 5% of the Company's share capital) had any beneficial interest in the Group's five largest customers and suppliers.

For the year ended 31 December 2021, there was no material and significant dispute between the Group and its suppliers and/or customers.

### 主要客戶及供應商

### PRE-IPO SHARE OPTION SCHEME

The Company adopted a pre-IPO share option scheme (the “**Pre-IPO Share Option Scheme**”) on 31 March 2015, the principal terms (such as the purpose, participants and consideration for accepting any options) of which are set out in the section headed “Statutory and General Information — Pre-IPO Share Option Scheme” in Appendix V to the prospectus of the Company dated 11 June 2015 (the “**Prospectus**”).

The Pre-IPO Share Option Scheme is valid from its effective date to the earlier of the Listing Date or the date of completion of the Pre-IPO change of control and no further options will be granted under it thereafter. Options granted during the term of the Pre-IPO Share Option Scheme may be terminated in accordance with any of the provisions described in the Pre-IPO Share Option Scheme. Each option will lapse on the date specified under the Pre-IPO Share Option Scheme, but in any event the exercise period of the options shall not exceed five years from the date of vesting of the relevant options.

The maximum number of Shares issued and to be issued upon exercise of the options granted under the Pre-IPO Share Option Scheme to any person (including exercised and outstanding options) pursuant to the Pre-IPO Share Option Scheme and any other share compensation arrangements adopted by the Company shall not exceed 3.0% of the Shares in issue from time to time.

The Post-IPO RSU Scheme is valid and effective for a term of 10 years from 5 June 2015 (the “**Scheme Period**”), after which period no further restricted share units (“**RSUs**”) shall be granted or accepted, but the provisions of such scheme shall remain in full force and effect in order to give effect to the vesting of RSUs granted and accepted prior to the expiration of the Scheme Period.

The Post-IPO RSU Scheme Limit may be refreshed from time to time subject to prior Shareholders’ approval, but in any event, the total number of Shares that may underlie the RSUs granted following the date of approval of the refreshed limit (the “**New Approval Date**”) under the limit as refreshed from time to time must not exceed 2% of the number of Shares in issue as at the New Approval Date.

On 18 December 2015, the Company granted an aggregate of 41,234,696 RSUs to certain connected grantees and non-connected grantees of the Group pursuant to the Post-IPO RSU Scheme. Subsequently the grant of RSUs to three connected grantees was approved by the independent shareholders at the extraordinary general meeting held on 22 January 2016. On 31 January 2016, an aggregate of 19,865,199 RSUs were accepted by the connected grantees and an aggregate of 21,199,297 RSUs were accepted by the non-connected grantees, respectively.

On 24 March 2017, the Board granted an aggregate of 26,333,182 RSUs to certain connected grantees and non-connected grantees of the Group pursuant to the Post-IPO RSU Scheme. Subsequently the grant of RSUs to six connected grantees was approved by the independent shareholders at the extraordinary general meeting held on 9 May 2017. On 31 May 2017, an aggregate of 26,333,182 RSUs were accepted by the relevant grantees.

At the 2020 AGM, a specific mandate was granted to the Directors to exercise all the powers of the Company to grant RSUs pursuant to the Post-IPO RSU Scheme in respect of the underlying Shares not exceeding 2% (i.e. the Directors were authorized to exercise the powers of the Company to grant the RSUs involving a maximum number of 67,871,647 underlying Shares) of the Shares in issue as at the date of the 2020 AGM during the period from the date of approving the Mandate at that meeting up to the conclusion of the next AGM.

### OUTSTANDING RSUs AS AT 31 DECEMBER 2021

During the reporting period, no RSUs have been granted, vested, lapsed or cancelled. As at 31 December 2021, there were no outstanding RSUs.

As at the date of this annual report, pursuant to the specific mandate obtained by the Board, the total number of securities available for issue under the Scheme were 67,871,647, representing approximately 2.0% of the issued shares. However, this specific mandate will expire at the conclusion of the 2021 AGM.

- (1) On 28 January 2021, the Company entered into the Cooperation Framework Agreement with Urumqi Xintai Jinggong Construction Engineering Co., Ltd (烏魯木齊鑫泰精工建設工程有限公司) ("XTJG") ("2021 Cooperation Framework Agreement"), pursuant to which, XTJG and its associates may bid for the Group's coalbed methane (the "CBM") development projects as construction contractor for the provision of construction services in accordance with the invited bidding or competitive negotiation procedures of the Group from time to time. The final price and transaction terms entered into between the Group and XTJG and/or its associates are subject to the invited bidding or competitive negotiation procedures which apply to both connected persons and independent third parties of the Group.

As Xinjiang Xintai Natural Gas Co., Ltd. (新疆鑫泰天然氣股份有限公司) ("XTRQ") holds 100% equity interests in XTJG, and XTRQ holds approximately 56.96% of the total issued share capital of the Company through Sichuan Liming Energy Development Co., Ltd. and Liming Holding Limited. Therefore, XTJG is the contact person of XTRQ and a connected person of the Company, and the transactions contemplated under the 2021 Cooperation Framework Agreement constitute a continuing connected transaction of the Company under Chapter 14A of the Listing Rules.

Background and purpose of entering into the 2021 Cooperation Framework Agreement: With the increase in production output of the Group of both the Panzhuang and Mabi concessions in the past few years, demand for the Construction Services increased accordingly. XTJG is a reputable contractor in the industry with experience in handling various construction projects as an independent contractor for CBM projects. XTJG's participation in the bidding or competitive negotiations will increase the competitiveness between other construction contractors and will accordingly allow the Group to reduce its procurement risks and ensure quality services provided by the construction contractors.

Under the 2021 Cooperation Framework Agreement, the total transaction amount under the agreement shall not exceed RMB24,500,800, and the agreement shall be valid from 28 January 2021 to 31 December 2021.

For the year ended 31 December 2021, the total contract value of the execution agreement entered into between the Group and XTJG under the 2021 Cooperation Framework Agreement was approximately RMB19,718,525, and the total transaction amount for the year accordingly was RMB17,522,089.

### ANNUAL REVIEW BY INDEPENDENT NON-EXECUTIVE DIRECTORS AND THE AUDITOR

The independent non-executive directors of the Company have reviewed the above continuing connected transactions in accordance with the Listing Rules, and confirmed that the continuing connected transactions:

During the year under review, the Company has complied with the disclosure requirements under Chapter 14A of the Listing Rules.

### SUFFICIENCY OF PUBLIC FLOAT

Based on information that is publicly available to the Company and within the knowledge of its Directors, the Board confirms that the Company has maintained the sufficiency of public float as required under the Listing Rules at all times for the year ended 31 December 2021 and as of the date of this annual report.

### DIRECTORS' INTERESTS IN A COMPETING BUSINESS

As at 31 December 2021 none of the Directors or their respective associates had engaged in or had any interest in any business which competes or likely to compete with the business of the Group.

### SIGNIFICANT LEGAL PROCEEDINGS AND COMPLIANCE MATTERS

For the year ended 31 December 2021 the Company was not engaged in any litigation or arbitration of material importance.

For the year ended 31 December 2021 the Company obtained all the material licenses, permits and approvals necessary for the development stage of Panzhuang concession; and for the Southern area of Mabi concession (131 sq km), except for the mining license which is still pending, all material licenses have been obtained. The "3 in 1" proposal of the proven reserves in the Northern area of Mabi concession was approved in 2021, whereas the material licenses, such as the approval of the environmental assessment report were handled in 2021, other related works have been progressing well.

For the year ended 31 December 2021 and up to the date of this report, to the best knowledge of the Directors, the Group complied with applicable laws and regulations in all material respects.

### HUMAN RESOURCES MANAGEMENT

The management believes that talent is the basis for corporate development. Through the implementation of the “Leadership Censoring and Development Program for Middle and Senior Managers”, the Group has been able to enhance its understanding from different perspective and to conduct leadership improvement planning with precise teaching. Through the echelon building of talents and the development of employee training system, the Group provides a platform and assistance for the development of employees’ personal potential and career path. In addition, the Group provides its employees with competitive remuneration packages and various benefits in line with industry practice. At the same time, the Group creates a good working environment, and establishes teamwork spirit among employees. The Group regularly reviews human resources policies to ensure that the policies align with market practice and comply with regulatory requirements. As at 31 December 2021, the Group employed 503 employees (including five disabled persons), with two of them based in Hong Kong. The total employee benefit expenses (excluding termination compensation) for 2021 was approximately RMB103 million. Details are set out in note 21 to the section headed “Notes to Consolidated Financial Statements” of this annual report.

### EVENTS AFTER THE YEAR ENDED 31 DECEMBER 2021

On 18 January 2022, the Group entered into an agreement with XTRQ, pursuant to which the Group and XTRQ agreed to make a capital contribution of RMB24.5 million and RMB25.5 million to establish a company, representing 49.0% and 51.0% of the total capital contribution, respectively. On 30 March 2022, the Group entered into a capital increase agreement with XTRQ, pursuant to which the Group and XTRQ agreed to contribute additional RMB122.5 million and RMB127.5 million, respectively. Subsequent to the capital increase, the share of equity held by the Group and XTRQ remains unchanged. For details, please refer to the announcement of the Company dated 18 January 2022 and the announcement of the Company dated 30 March 2022.

Saved as the above and as disclosed in the section headed “Consolidated Financial Statements” of this annual report, there were no subsequent events between the end of the reporting period and the date of this annual report that would have a material impact on the Group.

於2022年1月18日，本集團與新天然氣訂立協議，據此，本集團及新天然氣已同意出資人民幣24,500,000元及人民幣25,500,000元成立一間公司，分別佔出資總額的49.0%及51.0%。於2022年3月30日，本集團與新天然氣訂立增資協議。據此，本集團及新天然氣已同意增資人民幣122,500,000元及人民幣127,500,000元。增資後，本集團與新天然氣持股比例保持不變。詳情請參閱本公司日期為2022年1月18日的公告及本公司日期為2022年3月30日的公告。

The Board is pleased to present this corporate governance report for the year ended 31 December 2021 (the “Review Period”).

### CORPORATE GOVERNANCE

The Company is committed to maintaining high standards of corporate governance to safeguard the interests of the Shareholders and to enhance our corporate value and accountability. The Company has adopted the Corporate Governance Code (the “CG Code”) contained in Appendix 14 to the Rules Governing the Listing of Securities (the “Listing Rules”) on The Stock Exchange of Hong Kong Limited (the “Stock Exchange”) as its own code of corporate governance. The Company has complied with all applicable provisions under the CG Code during the year ended 31 December 2021. The Company will continue to review and monitor its corporate governance practices to ensure compliance with the CG Code.

### THE BOARD

#### Responsibilities of the Board

The Board is responsible for the overall leadership of the Group, oversees the Group’s strategic decisions and monitors business and performance. The Board has delegated the authority and responsibility for day-to-day management and operation of the Group to the senior management of the Group. To oversee particular aspects of the Company’s affairs, the Board has established four Board committees and a working group under the Board, namely the Audit Committee (the “Audit Committee”), the Remuneration Committee (the “Remuneration Committee”), the Nomination Committee (the “Nomination Committee”) and the strategic development committee (the “Strategic Development Committee”) (together, the “Board Committees”) and the ESG Working Group. The Board has delegated to the Board Committees and ESG Working Group responsibilities as set out in their respective terms of reference.

The Board’s composition is in compliance with the requirements under Rule 3.10A of the Listing Rules that the number of independent non-executive directors must represent at least one-third of the Board. The Board believes that the balance between executive Directors and the non-executive Directors is reasonable and adequate to provide sufficient checks and balances that safeguard the interests of the Shareholders and the Group.

All Directors shall ensure that they carry out duties in good faith, in compliance with applicable laws and regulations, and in the interests of the Company and its shareholders at all times.

#### Appointment, Re-election and Removal of Directors

The procedures and process of appointment, re-election and removal of directors are set out in the Articles. The Nomination Committee is responsible for reviewing the Board composition, monitoring the appointment, re-election and succession planning of Directors.

Each of the executive Directors, non-executive Directors and independent non-executive Directors has entered into a service agreement or a letter of appointment with the Company. There are currently seven members in the Board, the term of service for each of them is three years from the date of appointment or re-appointment. Such term is subject to re-election by the Company at an annual general meeting upon retirement. The Articles provide that any Director appointed by the Board to fill a casual vacancy in the Board shall hold office until the first general meeting of the Company after his appointment and shall then be eligible for re-election at such meeting. Besides, any Director appointed by the Board as an addition to the existing Board shall hold office only until the next following annual general meeting of the Company and shall then be eligible for re-election. In accordance with the Articles, at every annual general meeting of the Company, one third of the Directors for the time being or, if their number is not three or a multiple of three, then the number nearest to but not less than one-third shall retire from office by rotation provided that every Director (including those appointed for a specific term) shall be subject to retirement by rotation at least once every three years and being eligible offer themselves for re-election.

In accordance with the Articles, Mr. Zhang Jianbing, Mr. Huang Min and Mr. Tai Kwok Leung, Alexander shall retire by rotation and being eligible, have offered themselves for re-election at the forthcoming annual general meeting.

根據細則，在即將到來的股東週年大會上，張艦兵先生、黃敏先生及戴國良先生將輪值退任並符合資格申請應選連任。

#### Board Meetings

The Company adopts the practice of holding board meetings regularly, at least four times a year, and at approximately quarterly intervals. Notices of not less than 14 days will be given for all regular board meetings to provide all Directors with an opportunity to attend and include matters in the agenda for a regular meeting.

For other Board and committee meetings, reasonable notice will generally be given. The agenda and accompanying board papers are dispatched to the Directors or committee members three days before the meetings to ensure that they have sufficient time to review the papers and be adequately prepared for the meetings. When directors or committee members are unable to attend a meeting, they will be advised of the matters to be discussed and given an opportunity to make their views known to the chairman of the Board prior to the meeting.

Minutes of the Board meetings and Board Committee meetings will be recorded in sufficient detail the matters considered by the Board and the Board Committees and the decisions reached, including any concerns raised by the Directors. Draft minutes of each Board meeting and Board Committee meeting are/will be sent to the Directors for comments within a reasonable time after the date on which the meeting is held.

#### Chairman and Chief Executive

Under code provision C.2.1 of the CG Code, the roles of chairman and chief executive should be separate and performed by different individuals.

The chairman of the Board and the president of the Company are currently two separate positions held by Mr. Ming Zaiyuan as the chairman of the Board and Mr. Yan Danhua as the president, with clear distinction in responsibilities. The chairman of the Board is responsible for providing strategic advice and guidance on the business development of the Group, while the president is responsible for the day-to-day operations of the Group.

#### Model Code for Securities Transactions

The Company has adopted the "Model Code for Securities Transactions by Directors of Listed Issuers" (the "Model Code") as set out in Appendix 10 to the Listing Rules as its own code of conduct regarding Directors' securities transactions. Having made specific enquiries of all Directors, each of the Directors has confirmed that they have complied with the required standards as set out in the Model Code for the year ended 31 December 2021.

The Company also established written guidelines on terms no less exacting than the Model Code (the "Employees Written Guidelines") for securities transactions by relevant employees who are likely to possess inside information of the Company in respect of their dealings in the Company's securities. No incident of non-compliance of the Employees Written Guidelines by the relevant employees was noted by the Company during the Review Period.

#### Delegation by the Board

The Board reserves for its decision-making authorities on all major matters of the Company, including: approval and monitoring of all policy matters, overall strategies and budgets, internal control and risk management systems, material transactions (in particular those that may involve conflict of interests), financial information, appointment of Directors and other significant financial and operational matters. Directors could have recourse to seek independent professional advice in performing their duties at the Company's expense and are encouraged to access and to consult with the Company's senior management independently.

根據企業管治守則條款第C.2.1條規定，主席與行政總裁的職務必須分開，並由不同人士擔任。

本公司董事會主席及公司總裁現為兩個獨立職位，分別由明再遠先生擔任董事會主席，由嚴丹華先生擔任公司總裁，分工清晰明確。董事會主席負責就本集團業務發展提供策略意見和指導，而公司總裁則負責集團日常運營。

#### 證券交易的標準守則

本公司已採取了上市規則附錄十所載之「上市發行人董事進行證券交易標準守則」（「標準守則」）作為其董事進行證券交易操守守則。經向全體董事做出特定查詢後，所有董事確認彼等於截至2021年12月31日止年度已遵守標準守則所載的規定標準。

本公司還就買賣本公司證券且可能持有本公司內幕消息的相關員工進行的證券交易，制定了一套不低於標準守則的書面指引（「員工書面指引」）。在回顧期內本公司未發現相關僱員違反員工書面指引的事件發生。

#### 董事會授權

董事會保留對本公司所有重要事項的決定權，包括批准和監督所有政策事宜、整體策略及預算、內部監控及風險管理系統、重大交易（尤其是涉及利益衝突）、財務資料、委任董事及其他重大財務和運營事宜。董事可在履行職責時徵求獨立專業意見，相關費用由本公司承擔。本公司也鼓勵董事單獨約見本公司高級管理人員並向其進行徵詢。

The daily management, administration and operation of the Group are delegated to the senior management. The delegated functions and responsibilities are periodically reviewed by the Board. Approval has to be obtained from the Board prior to any significant transactions entered into by the management.

#### Corporate Governance Function

The Board recognizes that corporate governance should be the collective responsibility of Directors and the corporate governance duties include:

- (a) to develop and review the Company's policies and practices on corporate governance;
- (b) to review and monitor the training and continuous professional development of Directors and senior management of the Company;
- (c) to review and monitor the Company's policies and practices on compliance with legal and regulatory requirements;
- (d) to develop, review and monitor the code of conduct and compliance manual (if any) applicable to employees of the Company and Directors; and

### RISK MANAGEMENT AND INTERNAL CONTROL

#### Responsibility of the Board

The Board acknowledges that it is the responsibility of the Board for ensuring that the Company establishes and maintains appropriate and effective risk management and internal control systems and reviewing the effectiveness of such systems on an annual basis. The Board is also aware of the fact that such systems are designed to manage rather than eliminate the risk of failure to achieve business objectives, and can only provide reasonable assurance and not absolute assurance against material misstatement or loss.

#### The Risk Management and Internal Control Systems

The Company adopted the three lines of defence model in the management of risk. Operational management form the core of the first line of defence as they contact with the risk sources in the first place. They are responsible for identifying, reporting and preliminarily managing risks in their daily operations. Our second line of defence is the risk management function, comprised of Legal, HSE departments etc., aiming to facilitate and monitor the implementation of effective risk management practices by operational management throughout the Company. Our internal audit function is the core of the third line of defence and mainly responsible for checking, auditing and monitoring the work performed by the first and second lines of defence.

The Company's risks are identified from business processes in our established enterprise-wide risk assessment methodologies. Key responsible personnel for the management of risk in each of the business process are selected as interviewees to identify the risks to form our risk universe. Each risk within the risk universe is assessed in terms of likelihood of occurrence and the significance of impact, taken into account the current internal controls in place to mitigate these risks. The risk assessment results are reported to senior management and the Board for them to evaluate whether risks have been appropriately managed and decide on our priorities in risk management, based on the Company's risk appetite, and in particular how much risks the Company is willing to take for the achievement of its strategy and business objectives, the availability of resources for risk mitigation, and the effectiveness of current internal control system.

### 風險管理及內部監控

#### 風險管理及內部監控系統

本公司採取三道防線模式管理風險。營運管理人員是第一道防線的核心，因為一旦出現風險，彼等首當其衝。營運管理人員負責識別、報告及初步管理日常營運中存在的風險。第二道防線是由法務、HSE等職能承擔的風險管理職能，旨在推動及監察營運管理人員在本公司高效實施風險管理措施。內部審核功能是第三道防線，主要負責檢查、審核及監察第一及第二道防線的工作。

根據我們建立的全面風險評估辦法，本公司從業務流程出發，推進風險識別。各個業務流程中的主要負責人被選作受訪者，識別流程中的風險，並匯總形成最終風險清單。風險清單中的各風險按發生的可能性及影響的程度評價，並列入目前降低該等風險所採用的內部監控。風險評估結果向高級管理層及董事會彙報，以根據公司的風險偏好，尤其公司願意為其戰略和經營目標的實現承擔多少風險，降低風險的資源利用和現行內部控制系統的有效性等因素來評估風險是否被適當管理和決定風險管理的優先次序。

#### The Risk Management and Internal Control Systems

(Continued)

The Company's internal control system is based on Internal Control — Integrated Framework of the Committee of Sponsoring Organisations of the Treadway Commission, and has five components, namely Control Environment, Risk Assessment, Control Activities, Information and Communication, and Monitoring Activities. The system intends to facilitate the design and functioning of good control practices and reduce the likelihood and impact of risks to an acceptably low level, in order for us to achieve our objectives in operations, reporting, and compliance.

Any material internal control defects identified are timely communicated and carefully evaluated for their potential impacts. The departments or functions who are owners of these controls, are required to propose corrective measures and obtain approval from management before implementation. The implementation statuses are monitored by both management and the internal audit function to ensure these control defects are properly resolved in a timely manner. The Company has also established policies and procedures for the handling and dissemination of inside information. The information to be disclosed should be properly reviewed and approved by our compliance functions and management to ensure its appropriateness and accuracy, and is closely monitored after disclosure.

During the Review Period, the Company continuously upgraded its internal control system starting from corporate governance, organisation structure and business process through risk identification and assessment, thereby reducing operational risk while further enhancing operational efficiency of the Company at the same time.

我們及時就所識別的重大內部監控瑕疵進行溝通，並審慎評價潛在影響。身為監控責任人的部門須提出糾正措施，並於實施前獲得管理層批准。管理層及內部審核部門監察實施情況，確保及時妥善解決監控瑕疵。本公司亦制定處理及傳播內幕消息的政策及程式。將予披露的資料由合規部及管理層妥為審閱及批准，確保合適準確，並於披露後密切監察。

在回顧期內，公司從公司治理、組織結構、業務流程出發，通過風險識別、風險評估等途徑，不斷對公司的內控制度進行了升級，在降低了公司運營風險的同時也進一步提升了公司的運營效率。

#### Internal Audit Function

In order to enhance the Company's adaptability to the business environment, The Company established the Risk Control and Compliance Department, which is responsible for providing effective legal professional support for various legal matters of the Company, handling corporate information disclosure and legal compliance management, as well as providing value-added internal audit and consulting services for independent review, in January 2021 by merging the functions of the former Legal Affairs Department, the Board of Directors' Office and the Audit and Supervision Department. The internal audit function reports to the Company Secretary in respect of administration and directly to the Board and the Audit Committee in respect of operation. The internal audit function still has the independence required to conduct audit business.

The Company's internal audit function plays a major role in the monitoring of the Company's internal governance processes, i.e., to provide independent assurance that the Company's risk management, governance and internal control processes are operating effectively. The major tasks of this function include providing assurance on the effectiveness of the Company's governance, risk management and internal controls in areas of operations, safeguarding of assets, reporting, and compliance, and conducting risk-based audits of the Company and its subsidiaries on a regular basis with recommended action plans to audit findings. This function also provides consulting services in risk management and internal control related issues within the Company.

During the Review Period, the Company's internal audit function conducted annual independent full scope risk assessment update and internal audit for selected areas, and reported to the management and the Board.

#### Review of the Effectiveness and Adequacy of Our Systems

The Company prepares and submits reports to the Board in relation to risk and control at least annually, detailing how risks have been managed and internal controls been designed and implemented in accordance with the established risk and control frameworks, to keep our overall risk exposures within risk appetite and achieve our business objectives. The Board reviews the reasonableness of these reports and representations from management and makes sufficient enquiries whenever they feel necessary, before reaching their conclusions.

During the Review Period, the Board has conducted a review of the effectiveness of the Company's risk management and internal control systems with the application of the above review process, and considered our risk management and internal control systems effective and adequate in both design and operations.

### EXTERNAL AUDITORS AND AUDITOR'S REMUNERATION

The statement by the external auditor of the Company regarding their reporting responsibilities on the consolidated financial statements of the Company is set out in the section headed "Independent Auditor's Report" of this annual report.

#### Convening of Extraordinary General Meetings ("EGM") by Shareholders

Pursuant to the Articles, the Board may, whenever it thinks fit, convene an EGM. An EGM shall also be convened on the requisition of one or more shareholders of the Company holding, at the date of deposit of the requisition, not less than one tenth of the paid up capital of the Company having the right of voting at general meetings. Such requisition shall be made in writing to the Board or the company secretary of the Company for the purpose of requiring an EGM to be called by the Board for the transaction of any business specified in such requisition. The Directors shall within two (2) months after the deposit of such requisition proceed duly to convene such meeting. If within 21 days of such deposit the Board fails to proceed to convene such meeting, the requisitionist(s) himself (themselves) may do so in the same manner, and all reasonable expenses incurred by the requisitionist(s) as a result of the failure of the Board shall be reimbursed to the requisitionist(s) by the Company.

#### Putting Forward Proposals at General Meetings

The Board is not aware of any provisions allowing the shareholders of the Company to put forward proposals at general meetings of the Company under the Articles and the Cayman Islands Companies Act (2021 version). Shareholders who wish to put forward proposals at general meeting may refer to the preceding paragraph to make a written requisition to require the convening of an extraordinary general meeting of the Company.

### 1. GENERAL INFORMATION

AAG Energy Holdings Limited (the “Company”) and its subsidiaries (collectively, the “Group”) are principally engaged in exploration, development and production of coalbed methane (“CBM”) in the People’s Republic of China (the “PRC”). The Company is an exempted company incorporated in the Cayman Islands with limited liability on 23 December 2014. The address of the Company’s registered office is P.O. Box 31119, Grand Pavilion, Hibiscus Way, 802 West Bay Road, Grand Cayman, KY1-1205, Cayman Islands.

The Group conducts its business through two Production Sharing Contracts (“PSC”) entered into with China United Coalbed Methane Corporation Ltd. (“CUCBM”) and China National Petroleum Corporation (“CNPC”) (authorizing its subsidiary PetroChina Company Limited (“PetroChina”)) for Panzhuang and Mabi concessions respectively in Qinshui Basin, Shanxi Province of the PRC.

The Overall Development Plan (“ODP”) of Panzhuang concession was approved by the National Development and Reform Commission (“NDRC”) of the PRC on 28 November 2011, which allowed Panzhuang concession to enter into commercial development phase. On 1 November 2016, Panzhuang concession entered into production phase after the Joint Management Committee (“JMC”) approved and announced based on the terms of Panzhuang PSC. The ODP of the Southern Area of Mabi concession was approved by NDRC in September 2018. With this approval, the Southern Area of Mabi concession is eligible for commercial development. On 1 January 2020, the Southern Area of Mabi concession entered into production phase after the JMC approved and announced based on the terms of Mabi PSC. As at 31 December 2021, the Northern Area of Mabi concession was still in exploration phase.

The Company’s initial public offering (“IPO”) of its shares on the Main Board of the Stock Exchange of Hong Kong Limited was completed on 23 June 2015.

### 1. 一般資料

亞美能源控股有限公司(「本公司」)及其附屬公司(統稱「本集團」)主要在中華人民共和國(「中國」)從事煤層氣(「CBM」)的勘探、開發及生產。本公司於2014年12月23日在開曼群島註冊成立為獲豁免有限公司。本公司的註冊辦事處地址為P.O. Box 31119, Grand Pavilion, Hibiscus Way, 802 West Bay Road, Grand Cayman, KY1-1205, Cayman Islands。

本集團通過與中聯煤層氣有限責任公司(「CUCBM」)及中國石油天然氣集團有限公司(「CNPC」)(授權其子公司中國石油天然氣股份有限公司(「中石油」))分別就中國山西省沁水盆地潘莊和馬必區塊訂立的兩份產品分成合同(「產品分成合同」)開展業務。

潘莊區塊的總體開發方案(「ODP」)於2011年11月28日獲中國國家發展和改革委員會(「國家發改委」)批准，允許潘莊區塊進入商業開發階段。於2016年11月1日，潘莊區塊在獲聯合管理委員會(「聯合管理委員會」)基於潘莊產品分成合同條款的批准和宣告之後，進入生產階段。馬必區塊南區ODP於2018年9月獲國家發改委批復。自此，馬必區塊南區具備了商業開發的條件。於2020年1月1日，馬必區塊南區在獲聯合管理委員會基於馬必產品分成合同條款的批准和宣告之後，進入生產階段。於2021年12月31日，馬必區塊北區仍處於勘探階段。

本公司於2015年6月23日在香港聯合交易所有限公司主板完成首次公開發售(「首次公開發售」)。

In 2018, Liming Holding Limited (“Liming”), an indirect wholly owned subsidiary, controlled through Sichuan Liming Energy Development Co., Ltd. (“Sichuan Liming”), of Xinjiang Xintai Natural Gas Co., Ltd. (“XTRQ”), a company incorporated in the PRC and listed on the Shanghai Stock Exchange (stock code: 603393), acquired approximately 50.5% of issued shares of the Company.

The Directors regard Liming, Sichuan Liming and XTRQ as its immediate parent entity, intermediate parent entity and the ultimate parent entity of the Company respectively subsequent to the completion of the takeover (“Change of Control”).

### 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The principal accounting policies applied in the preparation of these consolidated financial statements are set out below. These policies have been consistently applied to all the years presented, unless otherwise stated.

#### 2.1 Basis of preparation

The consolidated financial statements of the Group have been prepared in accordance with all applicable Hong Kong Financial Reporting Standards (“HKFRS”) and requirements of the Hong Kong Companies ordinance Cap.622. The consolidated financial statements have been prepared under the historical cost convention.

The consolidated financial statements are presented in Renminbi (“RMB”) unless otherwise stated.

The preparation of the financial statements in conformity with HKFRS requires the use of certain critical accounting estimates. It also requires management to exercise its judgement in the process of applying the Group’s accounting policies. The areas involving a higher degree of judgement or complexity, or areas where assumptions and estimates are significant to the consolidated financial statements are disclosed in Note 4.

於2018年，新疆鑫泰天然氣股份有限公司(「新天然氣」，於中國註冊成立的公司，於上海證券交易所上市(股份代號：603393))通過四川利明能源開發有限責任公司(「四川利明」)持有的間接全資附屬公司香港利明控股有限公司(「利明」)收購本公司約50.5%已發行股份。

收購完成後，董事將利明、四川利明及新天然氣分別視為本公司的直接控股公司、中間控股公司及最終控股公司(「控制權變更」)。

### 2. 重要會計政策摘要

編製本合併財務報表採用的主要會計政策載於下文，除另有說明外，此等政策在所列報的所有年度內貫徹使用。

#### 2.1 編製基準

本集團的合併財務報表已根據所有適用香港財務報告準則(「香港財務報告準則」)及《香港公司條例》第622章的規定編製。合併財務報表根據歷史成本法編製。

除另有說明外，合併財務報表以人民幣(「人民幣」)列報。

編製符合香港財務報告準則的財務報表需要使用若干關鍵會計估計。亦需要管理層在應用本集團的會計政策過程中行使其判斷。涉及高度的判斷或高度複雜性的範疇，或涉及對合併財務報表作出重大假設和估計的範疇，在附註4中披露。

#### 2.2 Subsidiaries

A subsidiary is an entity (including a structured entity) over which the Group has control. The Group controls an entity where the Group is exposed to, or has rights to, variable returns from its involvement with the entity and has the ability to affect those returns through its power to direct the activities of the entity. Subsidiaries are fully consolidated from the date on which control is transferred to the Group. They are deconsolidated from the date that control ceases.

Intra-group transactions, balances and unrealised gains on transactions between group companies are eliminated. Unrealised losses are also eliminated unless the transaction provides evidence of an impairment of the transferred asset. When necessary, amounts reported by subsidiaries have been adjusted to conform with the Group's accounting policies.

#### 2.3 Production Sharing Contract

The Group's exploration, development and production activities are primarily conducted through PSCs which establish joint control over the exploration, development and production activities. Each participant is entitled to a predetermined share of the related output and bears an agreed share of the costs.

The consolidated financial statements reflects:

- (i) The Group's assets used in joint operations;
- (ii) Any liabilities that the Group has incurred;
- (iii) Any income from the sale or use the Group's share of the output of the production, together with its share of any expenses incurred in the production; and
- (iv) Any expenses that the Group has incurred in respect of its interest in the production.

#### 2.2 附屬公司

附屬公司是指本集團對其有控制權的實體(包括結構性實體)。當本集團因參與該實體而接受或享有可變回報的權益，並有能力通過其權力指揮實體活動而影響該回報時，則本集團對該實體具有控制權。附屬公司自控制權轉移至本集團之日起全面合併入賬。子公司在控制權終止之日起停止合併入賬。

集團內部交易，集團公司間交易產生的結餘及未變現收益會相互抵銷。未變現虧損也會抵銷，除非此交易提供了轉移資產減值的證據。於必要時會對附屬公司所呈報金額作出調整以符合本集團的會計政策。

#### 2.3 產品分成合同

本集團的勘探、開發及生產活動主要通過產品分成合同進行，而產品分成合同確立了對勘探、開發及生產活動的共同控制權。各參與者均享有產量的預定份額及承擔協定的成本。

合併財務報表反映了：

- (i) 本集團用於共同業務的資產；
- (ii) 本集團產生的任何負債；
- (iii) 銷售或使用本集團應佔產量產生的任何收入，連同其生產過程中的產生的任何費用；及
- (iv) 本集團就其產品權益產生的任何費用。

#### 2.3 Production Sharing Contract (Continued)

The Group's PSCs comprise of three phases: the exploration phase, development phase and production phase. Costs incurred with respect to exploration activities within the PSC contract areas are solely borne by the Group. All costs incurred subsequent to the date of the approval of ODP are treated as development costs and provided by the Group and the PSC partners in the proportion of their respective participating interests. Operating costs incurred for the production operation shall be borne by the Group and the PSC partners in proportion to their share of the output of the CBM productions in each concession.

Pursuant to the Panzhuang and Mabi PSCs, the annual gross production of CBM, after payment of value-added tax ("VAT") and royalties, is allocated into Cost Recovery CBM and Remainder CBM.

#### (a) Cost Recovery CBM

Cost Recovery CBM is the CBM allocated to the Group and the PSC partners for recovery of the operating costs, as well as the exploration costs and development costs. 70% and 80% of annual gross production of CBM is deemed as Cost Recovery CBM under the Panzhuang and Mabi PSC, respectively. Cost Recovery CBM is allocated until all costs incurred by each party have been fully recovered. Cost Recovery CBM is allocated as follows:

- (i) Prior to the production phase, Cost Recovery CBM is firstly applied to recover costs incurred during the exploration phase of the PSC and once such costs have been fully recovered, Cost Recovery CBM is allocated to recover costs incurred during the development phase.

#### 2.3 產品分成合同(續)

本集團的產品分成合同包含三個階段：勘探階段、開發階段及生產階段。就產品分成合同區域的勘探活動所產生成本全部由本集團承擔。總體開發方案獲批日之後所產生全部成本視作開發成本並由本集團及產品分成合同合作方按其各自參與權益比例分擔。生產運營所產生的營運成本應由本集團及產品分成合同合作方按其應佔各區塊煤層氣產量的比例承擔。

根據潘莊和馬必的產品分成合同，煤層氣的年度總產量經扣減增值稅（「增值稅」）及礦區土地使用費後分配至費用回收氣及餘額氣。

#### (a) 費用回收氣

費用回收氣為分配於本集團和產品分成合同合作方以回收經營成本，勘探成本以及開發成本的煤層氣。潘莊及馬必產品分成合同下分別有70%和80%的煤層氣年度總產量被視為費用回收氣。費用回收氣獲分配直至各方產生的全部成本已收回為止。費用回收氣分配如下：

- (i) 生產階段前，費用回收氣首先用於收回產品分成合同勘探階段所產生成本，一旦有關成本全部回收，費用回收氣將分配至開發階段產生的成本。

##### (a) Cost Recovery CBM (Continued)

- (ii) After the PSC enters the production phase, Cost Recovery CBM is allocated according to the following mechanism:

Operating cost recovery: payment in kind for the operating costs actually incurred but not yet recovered by each party.

Exploration and development cost recovery: after operating costs have been fully recovered, the Cost Recovery CBM is allocated to the Group and the PSC partners for the recovery of exploration and development costs. Exploration costs, 100% of which are borne by the Group, are fully recovered before development costs can be recovered. Upon the full recovery of exploration costs, any remaining Cost Recovery CBM is allocated between the Group and the PSC partners for the recovery of development costs according to the respective participating interests in the CBM concessions.

For the purpose of recovery, exploration costs do not include any interest, while development costs include a deemed interest calculated at a fixed compound interest rate of 9% per annum.

- (ii) 產品分成合同進入生產階段之後，費用回收氣根據以下機制分配：

經營成本回收：對實際發生但各方尚未收回的各類經營成本的支付。

勘探及開發成本回收：經營成本全部回收之後，費用回收氣將分配至本集團和產品分成合同合作方，以回收勘探和開發成本。勘探成本（100%由本集團承擔）於開發成本回收之前全部回收。回收全部勘探成本後，任何剩餘的費用回收氣根據本集團和產品分成合同合作方按其應佔各區塊參與權益在兩者之間分配以收回開發成本。

就回收目的而言，勘探成本不包括任何利息，而開發成本包括按9%的固定複合年利率計算的認定利息。

##### (b) Remainder CBM

Remainder CBM represents the remainder annual gross CBM production after payment of VAT, royalties and allocation to Cost Recovery CBM.

The Remainder CBM is further divided into allocable remainder CBM and share CBM. The allocable remainder CBM equals to the total remainder CBM multiplied by a factor (X) and the share CBM equals the Remainder CBM minus the allocable remainder CBM. The factor (X) is determined in accordance with a set of successive incremental tiers on the basis of the annual gross CBM production as set out in the PSCs. The allocable remainder CBM is allocated between the Group and the PSC partner according to the respective participating interest in the PSC. Share CBM is allocated 100% to the PSC partner.

#### 2.4 Segment reporting

Operating segments are reported in a manner consistent with the internal reporting provided to the chief operating decision-maker. The chief operating decision-maker, who is responsible for allocating resources and assessing performance of the operating segments, has been identified as the directors and chief executive of the Company.

#### 2.5 Foreign currency translation

##### (a) Functional and presentation currency

Items included in the financial statements of each of the Group's entities are measured using the currency of primary economic environment in which the entity operates (the "functional currency"). The functional currency of the Company is US\$, whereas the functional currency of the production sharing projects in the PRC is RMB. The consolidated financial statements are presented in RMB.

##### (b) 餘額氣

餘額氣為煤層氣總年產量扣除增值稅、礦區土地使用費及費用回收氣分配後的餘額。

餘額氣進一步分為分成氣和留成氣。分成氣等於總剩餘氣乘以一個係數(X)，而留成氣等於餘額氣減分成氣。係數(X)根據產品分成合同所載以煤層氣總年產量為基礎的一系列滑動階梯決定。分成氣根據本集團與產品分成合同合作方各自於產品分成合同的參與權益之間分配。留成氣100%分配於產品分成合同合作方。

#### 2.4 分部報告

經營分部的報告方式與向主要營運決策者提供的內部報告方式一致。董事和本公司首席執行官被認定為主要營運決策者，負責分配資源並評估經營分部的業績。

#### 2.5 外幣折算

##### (a) 功能及列報貨幣

本集團各主體的財務報表所列項目均以該主體營運所在主要經濟環境的貨幣(「功能貨幣」)計量。本公司的功能貨幣是美元，而在中國的產品分成合同項目的功能貨幣是人民幣。合併財務報表以人民幣列報。

##### (b) Transactions and balances

Foreign currency transactions are translated into the functional currency using the exchange rates prevailing at the dates of the transactions. Foreign exchange gains and losses resulting from the settlement of such transactions and from the translation at year-end exchange rates of monetary assets and liabilities denominated in foreign currencies are recognised in the consolidated statements of comprehensive income.

Foreign exchange gains and losses that relate to cash and cash equivalents are presented in the consolidated statements of comprehensive income within "exchange gains/(losses)".

##### (c) Group companies

The results and financial positions of all the group entities (none of which has the currency of a hyper-inflationary economy) that have a functional currency different from the presentation currency are translated into the presentation currency as follows:

- (i) assets and liabilities for each balance sheet presented are translated at the closing rate at the date of that balance sheet;
- (ii) income and expenses for each statement of comprehensive income are translated at average exchange rates (unless this is not a reasonable approximation of the cumulative effect of the rates prevailing on the transaction dates, in which case income and expenses are translated at the rate on the dates of the transactions); and
- (iii) all resulting currency translation differences are recognised in other comprehensive income ("OCI").

##### (b) 交易及結餘

外幣交易採用交易日的適用匯率換算為功能貨幣。結算此類交易產生的匯兌利得和損失以及按年終匯率換算以外幣計價的貨幣資產及負債產生的匯兌利得和損失在合併綜合收益表確認。

有關現金及現金等價物的匯兌盈虧於合併綜合收益表以「匯兌收益/(損失)」列報。

##### (c) 集團公司

功能貨幣與列報貨幣不同的所有集團實體(當中無惡性通貨膨脹經濟下的貨幣)的業績及財務狀況按以下方式換算為列報貨幣:

- (i) 每份資產負債表中的資產和負債按資產負債表日的收市匯率換算;

#### 2.6 Property, plant and equipment

Property, plant and equipment, other than exploration and evaluation assets and construction in progress, are stated at historical cost less accumulated depreciation and impairment. Historical cost includes expenditures that are directly attributable to the acquisition of the items.

Subsequent costs are included in the asset's carrying amount or recognised as a separate asset, as appropriate, only when it is probable that future economic benefits associated with the item will flow to the Group and the cost of the item can be measured reliably. The carrying amount of the replaced part is derecognised. All other repairs and maintenance are charged in the consolidated statements of comprehensive income during the financial period in which they are incurred.

Other than gas properties, depreciation of each asset is calculated using the straight-line method to allocate its cost less its residual value over its estimated useful life. The estimated useful lives of property, plant and equipment are as follows:

不動產、工廠及設備(勘探和評估資產及在建工程除外)均以歷史成本減去累計折舊和減值列示。歷史成本包括直接歸屬於收購項目的所有開支。

後續成本僅會在與項目有關的未來經濟利益很可能流入本集團，而該項目的成本可以被可靠計量時，方會計入資產的賬面價值或確認為一項單獨資產(如適用)。已替換部分的賬面價值予以終止確認。所有其他維修和維護費在產生之財務期間計入合併綜合收益表。

除了天然氣資產，各資產的折舊按其成本減剩餘價值在其估計使用年期中以直線法計算。不動產、工廠及設備的估計使用年期如下：

Construction in progress represents development costs occurred after the technical feasibility and commercial viability of extracting a mineral resource are demonstrable and the buildings, machinery and equipment for which the construction work has not been completed. It is carried at cost which includes construction expenditures and other direct costs less any impairment losses. Upon completion, the development costs recorded in construction in progress are transferred to gas properties. No depreciation is provided for construction in progress until they are completed and available for use.

Spare parts are accounted for as property, plant and equipment when (a) they can be used only in connection with an item of property, plant and equipment; or (b) the Group expects to use them during more than one year. Other spare parts are classified as inventory.

Gains and losses on disposals are determined by comparing proceeds with the carrying amount and are recognised within "other gains/(losses)" in the consolidated statements of comprehensive income.

#### 2.7 Exploration and evaluation assets

Exploration and evaluation expenditures mainly include acquisition of rights to explore, topographical, geological, geochemical and geophysical studies, exploratory drilling, sampling and activities in relation to evaluating the technical feasibility and commercial viability of extracting a mineral resource.

During initial stage of a project, exploration and evaluation expenditures are expensed as incurred. Expenditure on a project after it has reached a stage at which there is a high degree of confidence in its viability is capitalised as exploration and evaluation assets. If a project does not prove viable, all irrecoverable expenditures associated with the project are expensed in the consolidated statements of comprehensive income.

在建工程指就開採礦產資源進行技術可行性及商業可行性之後所產生的開發成本以及建造工程尚未完工的樓宇、機器及設備。在建工程以成本列示，成本包括建造開支及其他直接成本扣除任何減值損失。於完工後，計入在建工程的開發成本轉入天然氣資產。在建工程在完工並投入使用之前不計提折舊。

當備件(a)僅用於一項不動產、工廠及設備；或(b)本集團預期該設備的使用年限超過一年時，作為不動產、工廠及設備列示。其他備件分類為存貨。

處置的收益和損失按所得款項與賬面價值的差額確定，並於合併綜合收益表中的「其他利得／(損失)」中確認。

#### 2.7 勘探及評估資產

勘探及評估開支主要包括勘探權的購買，地形、地質、地球化學和地球物理研究，勘探鑽井、取樣以及有關評估技術可行性和商業開採礦產資源的可行性的活動的支出。

在項目的最初階段，勘探和評估開支於產生時支銷。項目達到確信可行階段後，其開支作為勘探及評估資產撥充資本。若項目經證實不可行，與該項目有關的所有不可回收開支於合併綜合收益表中列示。

#### 2.7 Exploration and evaluation assets (Continued)

Costs of exploratory wells are capitalised and evaluated for economic viability within one year after completion of drilling. The related well costs are expensed as dry holes if it is determined that such economic viability is not attained.

Exploration and evaluation assets are measured at cost less impairment provisions. Exploration and evaluation assets are reclassified to gas properties when the technical feasibility and commercial viability of extracting a mineral resource are demonstrable.

Exploration and evaluation assets are assessed for impairment when facts and circumstances suggest that the carrying amount of an exploration and evaluation asset may exceed its recoverable amount, and also tested for impairment immediately prior to reclassification to gas properties.

#### 2.8 Gas properties

Gas properties include drilling costs, exploration and evaluation costs, development costs and other direct costs attributable to the gas production properties. Gas properties are depreciated based on the unit of production method. Unit of production rates are based on proved and probable gas reserves estimated to be recoverable from whole concessions based on the current terms of the respective PSC and taking into account estimated future development costs necessary to bring those reserves into production.

#### 2.9 Intangible assets

Intangible assets represent computer software. Acquired computer software are capitalised on the basis of the costs incurred to acquire and bring to use the specific software. These costs are amortised using the straight-line method over their estimated useful lives ranging from 3 to 10 years.

勘探井成本於佔採完成後一年內予以資本化並評價其經濟可行性。如果被證實此經濟可行性無法達成，相關井成本作為乾井支銷。

勘探及評估資產以成本減減值撥備計量。當證實技術上可行和商業開採礦產資源可行後，勘探及評估資產會重分類至天然氣資產。

當事實及實際情況顯示勘探及評估資產的賬面價值可能超過其可回收金額時，將對勘探及評估資產進行減值評估，亦會於重分類至天然氣資產前進行減值測試。

#### 2.8 天然氣資產

天然氣資產包括鑽井成本，勘探及評估成本，開發成本和其他歸屬於天然氣生產資產的直接成本。天然氣資產基於單位生產法計提折舊。單位生產法下的折舊率根據各產品分成合同現行條款，按證實及概算天然氣儲量的估計可採量計算並考慮生產該等儲量所需的估計未來開發成本。

#### 2.9 無形資產

無形資產是指電腦軟件。購入的電腦軟件按購入該指定軟體並將其投入使用所產生的成本予以資本化。該成本按三至十年的估計可使用年限以直線法攤銷。

#### 2.10 Impairment of non-financial assets

Assets that are subject to depreciation or amortisation are reviewed for impairment whenever events or changes in circumstances indicate that their carrying amount may not be recoverable. An impairment loss is recognised for the amount by which the asset's carrying amount exceeds its recoverable amount. The recoverable amount is the higher of an asset's fair value less costs to sell and value in use. For the purposes of assessing impairment, assets are grouped at the lowest levels for which there are separately identifiable cash flows which are largely independently of the cash flows from other assets or group of assets (cash-generating units). Non-financial assets other than goodwill that suffered an impairment are reviewed for possible reversal of the impairment at each balance sheet date.

#### 2.11 Investments in associates

Associates are all entities over which the Group has significant influence but not control or joint control. This is generally the case where the Group holds between 20% and 50% of the voting rights.

Investments in associates are accounted for using the equity method of accounting, after initially being recognised at cost.

Under the equity method of accounting, the investments are initially recognised at cost and adjusted thereafter to recognise the Group's share of the post-acquisition profits or losses of the investee in profit or loss, and the Group's share of movements in other comprehensive income of the investee in other comprehensive income. Dividends received or receivable from associates are recognised as a reduction in the carrying amount of the investment.

Where the Group's share of losses in an equity-accounted investment equals or exceeds its interest in the entity, including any other unsecured long-term receivables, the Group does not recognise further losses, unless it has incurred obligations or made payments on behalf of the other entity.

對於須做折舊或攤銷的資產，當有事件出現或情況改變預示賬面價值不能收回時要進行減值測試。減值虧損按照該資產的賬面價值超出其可回收金額的差額確認。可回收金額按照該資產的公允價值扣除出售成本或使用價值中較高者確認。就評估減值而言，資產將按可單獨識別並大致上獨立於其他資產或資產組別的現金流量的最低層級（現金產生單位）進行分組。除商譽外，已出現減值的非金融資產在各資產負債表日就是否可能轉回減值進行檢查。

#### 2.11 對聯營公司投資

聯營公司指所有本集團對其有重大影響力而無控制權的主體，通常附帶有20%至50%投票權的股權。

對聯營公司投資初始以成本確認後，以權益法入賬。

根據權益法，投資初始以成本確認。本集團應佔聯營公司購買後利潤或虧損於損益表內確認，而應佔其購買後的其他綜合收益變動則於其他綜合收益內確認，並相應調整投資賬面值。已收或應收聯營公司的股息確認為投資賬面值的減少。

如本集團應佔一家聯營公司的虧損等於或超過其在該聯營公司的權益，包括任何其他無抵押應收款，本集團不會確認進一步虧損，除非本集團對聯營公司已產生法律或推定債務或已代聯營公司作出付款。

#### 2.11 Investments in associates (Continued)

Unrealised gains on transactions between the Group and its associates are eliminated to the extent of the Group's interest in these entities. Unrealised losses are also eliminated unless the transaction provides evidence of an impairment of the asset transferred. Accounting policies of equity-accounted investees have been changed where necessary to ensure consistency with the policies adopted by the Group.

The carrying amount of equity-accounted investments is tested for impairment in accordance with the policy described in Note 2.10.

#### 2.12 Financial assets

##### (a) Classification

The Group classifies its financial assets in the following measurement categories:

- those to be measured subsequently at fair value (either through OCI or through profit or loss), and
- those to be measured at amortised cost.

The classification depends on the entity's business model for managing the financial assets and the contractual terms of the cash flows.

The Group reclassifies debt investments when and only when its business model for managing those assets changes.

Regular way purchases and sales of financial assets are recognised on trade-date, the date on which the Group commits to purchase or sell the asset. Financial assets are derecognised when the rights to receive cash flows from the financial assets have expired or have been transferred and the Group has transferred substantially all the risks and rewards of ownership.

##### (c) Measurement

At initial recognition, the Group measures a financial asset at its fair value plus, in the case of a financial asset not at fair value through profit or loss (FVPL), transaction costs that are directly attributable to the acquisition of the financial asset. Transaction costs of financial assets carried at FVPL are expensed in profit or loss.

Any gain or loss arising on derecognition is recognised directly in profit or loss and presented in other gains/(losses) together with foreign exchange gains and losses. Impairment losses are presented as separate line item in the statement of profit or loss.

When the financial asset is derecognised, the cumulative gain or loss previously recognised in OCI is reclassified from equity to profit or loss and recognised in other gains/(losses). Interest income from these financial assets is included in finance income using the effective interest rate method. Foreign exchange gains and losses are presented in other gains/(losses) and impairment expenses are presented as separate line item in the statement of profit or loss.

##### (d) Impairment

The Group assesses on a forward-looking basis the expected credit losses associated with its debt instruments carried at amortised cost and FVOCI. The impairment methodology applied depends on whether there has been a significant increase in credit risk.

#### 2.13 Inventories

##### (a) Material, spare parts and consumables with low value

Material, spare parts and consumables with low value are stated at the lower of cost and net realisable value. Cost is determined using the weighted average cost method. Net realisable value is the estimated selling price in the ordinary course of business, less applicable variable selling expenses.

##### (b) Raw materials, work in progress and finished goods

Raw materials, work in progress and finished goods are stated at the lower of cost and net realisable value. Cost comprises raw material costs, pipeline transportation costs associated with purchasing raw materials and outsourced processing costs. Costs are assigned to individual items of inventory on the basis of weighted average costs. Net realisable value is the estimated selling price in the ordinary course of business less the estimated costs of completion and the estimated costs necessary to make the sale.

#### 2.14 Trade and other receivables

Trade receivables are amounts due from customers for gas sold in the ordinary course of business. Trade receivables are recognised initially at the amount of consideration that is unconditional unless they contain significant financing components, when they are recognised at fair value. The Group holds the trade receivables with the objective to collect the contractual cash flows and therefore measures them subsequently at amortised cost using the effective interest method.

Other receivables are mainly government grants due from government and PSC partners and cash call due from PSC partners, which are recognised initially at fair value and subsequently measured at amortised cost using the effective interest method, less provision for impairment.

See Note 11 for further information about the Group's accounting for trade and other receivables and Note 3.1(a) for a description of the Group's impairment policies.

##### (b) 原材料、在產品及產成品

原材料、在產品及產成品按成本與可變現淨值的較低者列示。成本包括原材料成本、與採購原材料相關的管道運輸成本以及委託加工成本，按照加權平均法進行分配。可變現淨值是日常業務中的估計售價減估計完工成本和估計進行銷售所需的成本所得。

#### 2.14 應收賬款及其他應收款

應收賬款為在日常經營活動中就煤層氣銷售而應收客戶的款項。應收賬款按可無條件獲得的對價金額進行初始確認，但當其包含重大融資成分時，按公允價值進行初始確認。本集團持有應收賬款的目的是收取合同現金流量，因此後續使用實際利率法按攤餘成本計量應收賬款。

其他應收款主要是應從政府及產品分成合同合作方收取的政府補助，以及應產品分成合同合作方收取的現金籌款。其他應收款初始按公允價值計量，隨後採用實際利率法按照攤餘成本扣除減值準備計量。

#### 2.15 Cash and cash equivalents

Cash and cash equivalents include cash on hand, deposits held at call with banks and term deposits with original maturities of three months or less.

#### 2.16 Share capital

Ordinary shares are classified as equity (Note 14).

Incremental costs directly attributable to the issuance of new shares or options are shown in equity as a deduction, net of tax, from the proceeds.

#### 2.17 Trade payables

Trade payables are obligations to pay for goods or services that have been acquired in the ordinary course of business from suppliers. Trade payables are presented as current liabilities unless payment is not due within 12 months after the reporting period.

Trade payables are recognised initially at fair value and subsequently measured at amortised cost using the effective interest method.

#### 2.18 Current and deferred income tax

The income tax expense for the period comprises current and deferred tax. Tax is recognised in the consolidated statements of comprehensive income, except to the extent that it relates to items recognised in OCI or directly in equity. In this case, the tax is also recognised in OCI or directly in equity, respectively.

##### (a) Current income tax

The current income tax charge is calculated on the basis of the tax laws enacted or substantively enacted at the balance sheet date in the countries where the Group companies operate and generate taxable income. Management periodically evaluates positions taken in tax returns with respect to situations in which applicable tax regulation is subject to interpretation. It establishes provisions where appropriate on the basis of amounts expected to be paid to the tax authorities.

現金及現金等價物包括現金、可隨時支取的銀行存款及原到期期限為三個月或以下的定期存款。

#### 2.16 股本

普通股分類為權益(附註14)。

直接歸屬於發行新股或購股權的新增成本從所得款項中扣減(已扣除稅款)。

#### 2.17 應付賬款

應付賬款是在日常經營活動中，因接受供應商提供的商品或服務而承擔的債務。除非付款期限在一年以上，應付賬款列示為流動負債。

應付賬款按照公允價值進行初始確認，其後使用實際利率法按攤銷成本計量。

#### 2.18 當期及遞延所得稅

所得稅開支包含當期稅項和遞延稅項。稅項在合併綜合收益表內確認，但與其他綜合收益或直接在權益確認的項目有關的稅項除外。在此情況下，稅項分別在其他綜合收益或者直接權益內確認。

##### (a) 當期所得稅

當期所得稅支出根據集團公司營運所在及產生應課稅收入的國家與結算日已頒佈或實質已頒佈的稅務法規計算。管理層就使用稅務法規所規定的情況定期評估稅務狀況，並在適用情況下根據需向稅務機關支付的稅款設定撥備。

##### (b) Deferred income tax

###### *Inside basis differences*

Deferred income tax is recognised, using the liability method, on temporary differences arising between the tax bases of assets and liabilities and their carrying amounts in the consolidated financial statements. However, deferred tax liabilities are not recognised if they arise from the initial recognition of goodwill, the deferred income tax is not accounted for if it arises from initial recognition of an asset or liability in a transaction other than a business combination that at the time of the transaction affects neither accounting nor taxable profit or loss. Deferred income tax is determined using tax rates (and laws) that have been enacted or substantively enacted by the balance sheet date and are expected to apply when the related deferred income tax asset is realised or the deferred income tax liability is settled.

Deferred income tax assets are recognised only to the extent that it is probable that future taxable profit will be available to utilise those temporary differences and losses.

###### *Outside basis differences*

Deferred income tax liabilities are provided on taxable temporary differences arising from investments in subsidiaries and joint arrangements, except for deferred income tax liability where the timing of the reversal of the temporary difference is controlled by the Group and it is probable that the temporary difference will not reverse in the foreseeable future.

Deferred income tax assets are recognised on deductible temporary differences arising from investments in subsidiaries and joint arrangements only to the extent that it is probable the temporary difference will reverse in the future and there is sufficient taxable profit available against which the temporary difference can be utilised.

###### *內在差異*

遞延所得稅利用負債法就資產和負債的稅基與資產和負債在合併財務報表中的賬面價值的差額所產生的暫時性差異而確認。然而倘遞延稅項負債因初始確認商譽而產生，則不會確認有關遞延稅項負債，若遞延所得稅來自交易(不包含業務合併)中對資產和負債的初始確認，而在交易中不影響會計損益或應課稅利潤或虧損，亦不進行確認。遞延所得稅採用在結算日前已頒佈或實質上已頒佈，並根據有關遞延所得稅資產變現或遞延所得稅負債結算時預期將會適用的稅率(及法例)予以確定。

遞延所得稅資產僅在未來可能產生應課稅利潤以使用暫時性差異和虧損的情況下予以確認。

###### *外在差異*

遞延所得稅負債按於附屬公司及合營安排的投資所產生應課稅暫時差額作依據，除非轉回的遞延所得稅負債暫時差異的時間由本集團控制，並在可見將來不大可能轉回暫時差異者除外。

遞延所得稅資產就與附屬公司及合營安排的投資所產生的可扣減暫時差異予以確認，僅在暫時差異很可能將於日後轉回，並有充足的應課稅利潤抵銷可用的暫時差異時方可確認。

##### (c) Offsetting

Deferred tax assets and tax liabilities are offset where there is a legally enforceable right to offset current tax assets and tax liabilities and where the deferred tax balances relate to the same taxation authority. Current tax assets and tax liabilities are offset where the Group has a legally enforceable right to offset and intends either to settle on a net basis, or to realise the asset and settle the liability simultaneously.

#### 2.19 Employee benefits

Liabilities for wages and salaries, including non-monetary benefits, that are expected to be settled wholly within 12 months after the end of the period in which the employees render the related service are recognised in respect of employees' services up to the end of the reporting period and are measured at the amounts expected to be paid when the liabilities are settled.

The Group participates in defined contribution plans operated by relevant government authorities. A defined contribution plan is a pension plan which the Group pays to the relevant government authorities contributions calculated according to the bases and percentage prescribed. When employees retire, the relevant government authorities are obliged to pay the pensions to them. The Group has no legal or constructive obligations to pay further contributions if the fund does not hold sufficient assets to pay all employees the benefits relating to employee service in the current and prior periods. The contributions are recognised and allocated to related cost of assets and expenses based on different beneficiaries. There were no forfeited contributions (by employers on behalf of employees who leave the scheme prior to vesting fully in such contributions) to offset existing contributions under the defined contribution schemes.

All Chinese employees of the Group also participate in other social security plans, including medical, housing and other welfare benefits, organised and administered by the government authorities. According to the relevant regulations, the premiums and welfare benefit contributions that should be borne by the Group are calculated based on percentages of the total salary of employees, subject to a certain ceiling, and are paid to the labor and social welfare authorities.

##### (c) 抵銷

當有法定可執行權力將當期稅項資產與稅項負債抵銷，且遞延稅項餘額涉及同一稅務機關時，則可將遞延稅項資產與稅項負債互相抵銷。當本集團有法定可執行的抵銷權且有意向以淨額基準結算，或實現資產並同時結算負債，則可將當期稅項資產與稅項負債互相抵銷。

#### 2.19 僱員福利

預期將在僱員提供相關服務的期間結束後12個月內完全結算的工資及薪金負債(包括非貨幣性福利)在僱員提供相關服務的期間確認，並按負債結算時預期支付的金額計量。

本集團參與由相關政府機關運營的設定提存計劃。設定提存計劃為本集團向相關政府機關支付根據規定的基數和百分比計算供款的退休金計劃。當僱員退休時，相關政府機關有義務向其支付退休金。如果該基金沒有足夠資產向所有僱員就其在當期及以往期間的僱員服務支付福利，本集團亦無法定或推定責任支付進一步供款。供款根據不同受益者確認並分配至資產的相關成本及費用。在設定提存計劃下，無已被沒收的供款(即僱員在有關供款歸其所有前退出該計劃，由僱主代僱員處理的供款)，可用於抵減現有的供款水平。

本集團的所有中國員工亦參與政府機關組織及管理的其他社會保障計劃，包括醫療、住房及其他福利。根據有關規定，本集團須承擔的保險及福利計劃供款根據僱員薪金總額的比例且在不超過規定上限的基礎計算，並向勞動及社會福利機構繳納。

#### 2.20 Revenue recognition

Revenue is measured at the fair value of the consideration received or receivable, and represents amounts receivable for goods supplied, stated net of discounts and VAT.

##### Sales of gas

The Group produces and sells gas. Sales of gas are recognised when control of the gas has transferred, being when the gas is delivered to the customers. The amount of revenue is recognised based on the terms of the PSCs and gas sales agreements.

#### 2.21 Government grants

Grants from the government are recognised at their fair value where there is reasonable assurance that the grant will be received and the Group will comply with all attached conditions.

Government grants that are receivable as compensation for expenses or losses already incurred with no future related costs, such as refund of VAT paid and subsidies granted according to CBM production, are recognised in profit or loss in the period in which they become receivable. Note 20 provides further information on how the Group accounts for government grants.

政府補助按公允價值合理確認將可收到補助，並且本集團符合所有附帶條件時方可確認。

政府補助為已產生的開支或虧損並且無日後相關成本的補償，如退回已付增值稅及按煤層氣生產授予的補貼，並於其成為應收款期間確認為損益。附註20提供有關本集團如何入賬政府補助的進一步資料。

The Group operates two equity-settled share-based compensation plans, under which the Group receives services from employees as consideration for equity instruments (options and restricted share unit) of the Company. The fair value of the employee services received in exchange for the grant of the options and restricted share unit is recognised as an expense. The total amount to be expensed is determined by reference to the fair value of the options and restricted share unit granted:

- including any market performance conditions (for example, an entity's share price);
- excluding the impact of any service and non-market performance vesting conditions (for example, profitability, sales growth targets and remaining as an employee of the Group over a specified time period); and
- including the impact of any non-vesting conditions (for example, the requirement for employees to save or to hold shares for a specified period of time).

The total expense is recognised over the vesting period, which is the period over which all of the specified vesting conditions are to be satisfied. At the end of each reporting period, the Group revises its estimates of the number of the equity instruments that are expected to vest based on the non-marketing performance and service conditions. It recognises the impact of the revision to original estimates, if any, in the consolidated statements of comprehensive income, with a corresponding adjustment to equity.

When the options are exercised, the Company issues new shares. The proceeds received from the exercise of options net of any directly attributable transaction costs are credited to share capital (and share premium).

If a grant of equity instruments is cancelled or settled during the vesting period, the Company shall account for the cancellation or settlement as an acceleration of vesting, and shall therefore recognise immediately the amount that otherwise would have been recognised for services received over the remainder of the vesting period.

##### (b) Share-based payment transactions among group entities

The grant by the Company of its equity instruments to the employees of subsidiary undertakings in the Group is treated as a capital contribution. The fair value of employee services received, measured by reference to the grant date fair value, is recognised over the vesting period as an increase to investment in subsidiary undertakings, with a corresponding credit to equity in the parent company entity accounts.

#### 2.23 Interest income

Interest income is presented as finance income where it is earned from financial assets that are held for cash management purposes. Interest income is calculated by applying the effective interest rate.

Asset retirement obligation for environmental restoration is recognised when: the Group has a present constructive obligation as a result of past events; it is probable that an outflow of resources will be required to settle the obligation and the amount has been reliably estimated.

Where there are a number of similar obligations, the likelihood that an outflow will be required in settlement is determined by considering the class of obligations as a whole. Asset retirement obligation is recognised even if the likelihood of an outflow with respect to any one item included in the same class of obligations may be small.

Asset retirement obligation are measured at the present value of the expenditures expected to be required to settle the obligation using a pre-tax rate that reflects current market assessments of the time value of money and the risks specific to the obligation. The increase in the provision due to passage of time is recognised as interest expense.

#### 2.25 Lease

Leases are recognised as a right-of-use asset and a corresponding liability at the date at which the leased asset is available for use by the Group.

Contracts may contain both lease and non-lease components. The Group allocates the consideration in the contract to the lease and non-lease components based on their relative stand-alone prices.

Assets and liabilities arising from a lease are initially measured on a present value basis. Lease liabilities include the net present value of the following lease payments:

- fixed payments (including in-substance fixed payments), less any lease incentives receivable;
- variable lease payment that are based on an index or a rate, initially measured using the index or rate as at the commencement date;

Lease payments to be made under reasonably certain extension options are also included in the measurement of the liability.

The lease payments are discounted using the interest rate implicit in the lease. If that rate cannot be readily determined, which is generally the case for leases in the Group, the lessee's incremental borrowing rate is used, being the rate that the individual lessee would have to pay to borrow the funds necessary to obtain an asset of similar value to the right-of-use asset in a similar economic environment with similar terms, security and conditions.

To determine the incremental borrowing rate, the Group:

- where possible, uses recent third-party financing received by the individual lessee as a starting point, adjusted to reflect changes in financing conditions since third party financing was received;
- uses a build-up approach that starts with a risk-free interest rate adjusted for credit risk for leases held by the Group, which does not have recent third party financing; and
- makes adjustments specific to the lease, e.g. term, country, currency and security.

The Group is exposed to potential future increases in variable lease payments based on an index or rate, which are not included in the lease liability until they take effect. When adjustments to lease payments based on an index or rate take effect, the lease liability is reassessed and adjusted against the right-of-use asset.

Lease payments are allocated between principal and finance cost. The finance cost is charged to consolidated statement of comprehensive income over the lease period so as to produce a constant periodic rate of interest on the remaining balance of the liability for each period.

Right-of-use assets are measured at cost comprising the following:

- the amount of the initial measurement of lease liability;
- any lease payments made at or before the commencement date less any lease incentives received;
- any initial direct costs; and
- restoration costs.

Right-of-use assets are generally depreciated over the shorter of the asset's useful life and the lease term on a straight-line basis. If the Group is reasonably certain to exercise a purchase option, the right-of-use asset is depreciated over the underlying asset's useful life. While the Group revalues its land and buildings that are presented within property, plant and equipment, it has chosen not to do so for the right-of-use buildings held by the Group.

Payments associated with short-term leases of buildings and all leases of low-value assets are recognised on a straight-line basis as an expense in consolidated statement of comprehensive income. Short-term leases are leases with a lease term of 12 months or less. Low-value assets comprise IT equipment and small items of office furniture.

租賃付款額在本金和融資費用之間進行分攤。融資費用在租賃期內計入合併綜合收益表，以按照固定的週期性利率對各期間負債餘額計算利息。

使用權資產按成本計量，包括：

- 租賃負債的初始計量金額；
- 在租賃期開始日或之前支付的租賃付款額扣除收到的租賃激勵；
- 初始直接費用；及
- 復原成本。

使用權資產一般在資產的使用壽命與租賃期兩者孰短的期間內按直線法計提折舊。如本集團合理確定會行使購買權，則在標的資產的使用壽命期間內對使用權資產計提折舊。本集團對列報為不動產、廠房及設備的土地和建築物的價值進行重估，但未選擇重估所持有的使用權建築物的價值。

與短期樓宇租賃及所有低價值資產租賃相關的付款額按直線法確認為費用，計入合併綜合收益表。短期租賃是指租賃期為12個月或者小於12個月的租賃。低價值資產包括IT設備和小型辦公傢俱。

Dividends distribution to the Company's shareholders is recognised as a liability in the Group's financial statements in the period in which the dividends are approved by the Company's shareholders.

### 3. FINANCIAL RISK MANAGEMENT

#### 3.1 Financial risk factors

The Group's activities expose it to a variety of financial risks: credit risk, market risk (including foreign exchange risk), liquidity risk and concentration risk. The Group's overall risk management program focuses on the unpredictability of financial markets and seeks to minimise potential adverse effects on the Group's financial performance.

##### (a) Credit risk

###### (i) Risk management

Credit risk of the Group arises from cash at bank, trade and other receivables and other financial assets at amortised cost.

As the majority of the cash at bank are placed with state-owned and international banks and financial institutions in the PRC and Hong Kong, and there has been no recent history of default in relation to these banks and financial institutions, the corresponding credit risk is relatively low.

The Group has controls in place to assess the credit quality of its customers, taking into account of their financial positions, past experience and other factors. The Group's sales were only made to the customers with good credit history. The utilisation of credit limits is regularly monitored.

本集團的信用風險來自銀行存款、應收賬款及其他應收款以及以攤餘成本計量的其他金融資產。

由於大部分銀行存款存放於中國及香港的國有及國際銀行及金融機構，且該類銀行及金融機構近期並無違約記錄，相應信用風險相對較低。

本集團實施控制措施以評估客戶的信用資質，考慮其財務狀況、過往經驗及其他因素。本集團只向具有良好信貸記錄的客戶進行銷售。信用限額的使用會受定期監控。

The Group assesses the expected credit losses on an individual basis and grouped basis. As for the grouped basis, trade receivables have been grouped based on shared credit risk characteristics, and then recalculates their respective historical credit loss information. The historical credit loss rate are adjusted to reflect current and forward-looking information on macroeconomic factors affecting the ability of the customers to settle the receivables. The Group has identified the consumer price index to be the most relevant factors and accordingly adjusts the historical loss rate based on expected changes in these factors.

Impairment losses on trade receivables are presented as net impairment losses within operating profit. Subsequent recoveries of amounts previously written off are credited against the same line item.

To measure the expected credit losses of notes receivables, the Group calculates the expected credit loss based on the default risk exposure and the lifetime expected credit loss rate, with the consideration of the historical credit loss experience, the current situation and the forecast of future economic conditions. Considering all of the notes receivables are bank acceptance bills and there is no default experience in the past, the Group does not recognise any impairment.

For other receivables, the Group recognises a loss allowance equal to 12-month ECLs unless there has been a significant increase in credit risk of the other receivables since initial recognition or the other receivables not determined to have low credit risk at the reporting date, in which cases the loss allowance is measured at an amount equal to lifetime ECLs.

##### (b) Market risk

###### *Foreign exchange risk*

The Group is exposed to foreign exchange risk arising from various currency exposures, primarily with respect to US\$. Foreign exchange risk arises when future commercial transactions or recognised assets or liabilities are denominated in a currency other than the entity's functional currency.

Prior to 30 April 2016, the Group was exposed to non-cash foreign exchange risk arising from retranslation of US\$ denominated inter-company loans. To manage the foreign exchange risk, management decided to execute a debt restructuring on 30 April 2016 by converting the inter-company loans into perpetual loans through entering into perpetual loan agreements between respective group companies such that the perpetual loans do not bear interest and the lenders can not request repayment. Upon completion of this debt restructuring, any foreign exchange differences arising from retranslation of these US\$ denominated perpetual loans are recognised in equity in the consolidated financial statements.

The Group manages its foreign exchange risk by closely monitoring the movement of the foreign currency rates, and by monitoring the amount of the US\$ intracompany accounts.

As at 31 December 2021, if RMB had weakened/strengthened by 1% against the US\$ with all other variables held constant, profit before income tax for the year would have been RMB1,187,000 (31 December 2020: RMB1,649,000) higher/lower, respectively, mainly as a result of foreign exchange gains/losses on translation of US\$ denominated receivables and payables held by the Group entities with their functional currency as RMB.

##### (b) 市場風險

###### *外匯風險*

本集團須承受各種貨幣所產生外匯風險，尤以美元為甚。當未來商業交易或已確認資產或負債以實體功能貨幣以外的貨幣計值，則會產生外匯風險。

2016年4月30日之前，本集團承受的非現金外匯風險來自重新折算的以美元計價的公司間貸款。為了管理外匯風險，管理層決定於2016年4月30日執行債務重組，通過將公司間貸款轉為永久性貸款。所屬的集團公司各自簽訂永久貸款協定，永續貸款不承計利息並且貸款方不得要求償還。在此次債務重組完成時，由這些美元永續貸款轉換產生的任何匯兌差異在合併財務報表確認為權益。

本集團密切監控匯率變動及美元公司內部往來款賬戶，以管理外匯風險。

於2021年12月31日，如人民幣兌美元貶值／升值1%，而所有其他可變因素保持不變，則除所得稅前年度利潤將分別增加／減少人民幣1,187,000元（2020年12月31日：人民幣1,649,000元），主要原因是將本集團實體所持以美元計值的公司內部往來款換算為其功能貨幣人民幣所產生的匯兌收益／損失。

##### (d) Concentration risk

Revenue of the Group is mainly derived from Panzhuang concession. Any disruption to the operation of the concession may have a material adverse impact to the result of operation and the financial position of the Group.

During the year, 46.7% of the Group's revenue was derived from sales made to the top five customers (2020: 61.1%). In the event that these customers terminate their business relationship with the Group and the Group fails to find new customers, it may have a material adverse impact on the Group's financial position and result of operations.

##### (c) 流動性風險

##### (d) 集中風險

本集團的收入主要來自潘莊區塊。該區塊營運的任何中斷，均可能對本集團的經營業績及財務狀況造成重大不利影響。

本年內，本集團46.7%的收入來自向前五名客戶作出的銷售(2020年：61.1%)。若該等客戶終止與本集團的業務關係，而本集團未能尋得新客戶，則本集團的財務狀況及經營業績會受到重大不利影響。

#### 3.2 Capital management

The Group's objectives when managing capital are to safeguard the Group's ability to continue as a going concern in order to provide returns for the shareholders and benefits for other stakeholders and to maintain an optimal capital structure to reduce the cost of capital.

In order to maintain or adjust the capital structure, the Group may adjust the amount of dividends paid to shareholders, return capital to shareholders or issue new shares.

The Group monitors capital by using debt-to-asset ratio analysis. This ratio is calculated as amount of total liabilities divided by total assets as shown in the consolidated balance sheet. The debt-to-asset ratio at 31 December 2021 and 2020 is 20.5% and 15.3%, respectively.

#### 3.3 Fair value estimation

The measurement of fair value uses different level of inputs to valuation technique. Such inputs are categorised into three levels within a fair value hierarchy as follows:

- Quoted prices (unadjusted) in active markets for identical assets or liabilities (level 1).
- Inputs other than quoted prices included within level 1 that are observable for the asset or liability, either directly (that is, as prices) or indirectly (that is, derived from prices) (level 2).
- Inputs for the asset or liability that are not based on observable market data (that is, unobservable inputs) (level 3).

### 3. 財務風險管理(續)

#### 3.2 資本管理

本集團的資本管理目標旨在保障本集團能夠持續經營，為股東提供回報及為其他利益相關者提供利益，同時維持最佳的資本結構以減少資本成本。

為了維持或調整資本結構，本集團可能會調整支付給股東的股利金額、向股東返還資本或發行新股。

本集團利用資產負債率分析監控資本。該比率按合併資產負債表列示的負債總額除以資產總額計算。本集團在2021年12月31日及2020年12月31日的資產負債率分別為20.5%和15.3%。

#### 3.3 公允價值估計

公允價值的計量使用不同等級輸入數據的估值技術。該等輸入數據在公允價值等級內分為三個層次，如下所示：

- 相同資產或負債在活躍市場上的報價(未調整)(第1層)。
- 除了第1層所包括的報價外，該資產和負債的可觀察的其他輸入，可為直接(即例如價格)或間接(即源自價格)(第2層)。

### 4. CRITICAL ACCOUNTING ESTIMATES AND JUDGEMENTS

Estimates and judgments are continually evaluated and are based on historical experience and other factors, including expectations of future events that are believed to be reasonable under the circumstances. The Group makes estimates and assumptions concerning the future. The resulting accounting estimates will, by definition, seldom equal the related actual results. The estimates and assumptions that have a significant risk of causing a material adjustment to the carrying amounts of assets and liabilities within the next financial year are discussed below.

#### 4.1 Estimation of proved and probable gas reserves

Proved gas reserves are those quantities of CBM that by analysis of geoscience and engineering data can be estimated with reasonable certainty to be commercially recoverable, from a given date forward and under defined economic conditions, operating methods, and government regulations. Probable gas reserves are those additional reserves of CBM that analysis of geoscience and engineering data indicate are less likely to be recovered than proved reserves but more certain to be recovered than possible reserves.

The Group's reserve estimates were prepared for each concession area and include only CBM that the Group believes can be reasonably produced within current economic and operating conditions. Reserves cannot be measured exactly. Reserve estimates are based on many factors that require evaluation by the engineers interpreting the available data, as well as price and other economic factors. The reliability of these estimates at any point in time depends on both the quality and quantity of the technical and economic data, and the production performance as well as engineering judgement. Consequently, reserve estimates are subject to revision as additional data become available. Well tests and engineering studies will likely improve the reliability of the reserve estimate. The evolution of technology may also result in the application of improved recovery techniques such as supplemental or enhanced recovery projects, or both, which have the potential to increase reserves beyond those envisioned during the early years of a reservoir's producing life.

### 4. 關鍵會計估計及判斷

估計及判斷是根據過往經驗及其他因素（包括在某些情況下對未來事件的合理預測）進行持續評估。本集團對未來作出評估及假設。顧名思義，會計估計極少與相關的實際結果相同。對下個財務年度的資產與負債的賬面價值造成重大調整的估計與假設討論如下。

#### 4.1 證實及概算煤層氣儲量的估計

證實煤層氣儲量是通過分析地質科學及工程資料，自某特定日期起在限定經濟條件、經營條件及政府監管下，可合理確定作為商業性開採的估計煤層氣數量。概算煤層氣儲量是地質科學及工程資料分析顯示其與證實儲量相比回收的可能性更低，但與可能儲量相比回收可能性更加確切的煤層氣儲量。

本集團的儲量估計按各區塊編製，僅包括本集團認為在現行經濟及經營條件下可合理生產的煤層氣。儲量無法精確計算。儲量估計基於工程師對可用數據的解釋以評估的諸多因素，同時考慮價格及其他經濟因素。任何時間點的估計可靠性取決於技術及經濟數據的質量和數量、生產表現以及工程判斷。因此，儲量估計在可獲得額外資料時進行修訂。井的測試及工程研究可能提高儲量估計的可靠性。技術發展也可能導致應用經改良的採氣技術，例如補充或經提升開採項目（或一併採用），該技術具有使儲量增至超過氣藏生產週期初期儲量的潛力。

#### 4.1 Estimation of proved and probable gas reserves (Continued)

Proved and probable reserves are key elements in the Group's investment decision-making process. They are also an important element in testing for impairment. A reduction in proved and probable reserves will increase depreciation and amortisation charges (assuming constant production) and reduce net profit. Proved and probable reserve estimates are subject to revision, either upward or downward based on new information, such as from development drilling and production activities or from changes in economic factors, including gas prices, contract terms or development plans.

In general, changes in the technical maturity of gas reserves resulting from new information becoming available from exploration, development and production activities and change in gas price have tended to be the most significant cause of annual revisions.

#### 4.2 Impairment of exploration and evaluation assets

Exploration and evaluation assets are capitalised on a field-by-field basis and are assessed for impairment when circumstances suggest that the carrying amount may exceed its recoverable amount. This assessment involves judgment as to (i) the period for which the Group has the right to explore in the specific area has expired during the period or will expire in the near future, and is not expected to be renewed; and (ii) substantive expenditure on further exploration for and evaluation of mineral resources in the specific area is neither budgeted nor planned; and (iii) exploration for and evaluation of mineral resources in the specific area have not led to the discovery of commercially viable quantities of mineral resources and the Group has decided to discontinue such activities in the specific area; and (iv) sufficient data exist to indicate that, although a development in the specific area is likely to proceed, the carrying amount of the exploration and evaluation asset is unlikely to be recovered in full from successful development or by sale. While conducting an impairment review of its assets, the Group makes certain judgments in making assumptions about the future gas prices, reserves and future development and production costs. Changes in these estimates could require a material change on the carrying amount of exploration and evaluation assets.

### 4. 關鍵會計估計及判斷(續)

#### 4.1 證實及概算煤層氣儲量的估計(續)

證實及概算儲量是本集團投資決策過程中的關鍵元素，也是減值測試的重要元素。證實及概算儲量減少將增加折舊及攤銷費用(假設產量不變)，並減少淨利潤。證實及概算儲量估計可根據新資料(例如來自開發鑽探和生產活動或者天然氣價格、合同條款以及開發方案等經濟因素變動)而向上或向下調整。

一般而言，因勘探、開發及生產活動取得最新資料而令煤層氣儲量的技術成熟度變動以及天然氣價格變動是導致每年作出修訂的最重要原因。

#### 4.2 勘探及評估資產減值

勘探及評估資產按氣田基準撥充資本，當發生賬面價值超過可收回金額的情況評估減值。相關評估涉及有關以下各項的判斷：(i)在特定區域的探礦權期內已經或將於近期屆滿，並預期不會續期；及(ii)對進一步勘探及評估特定區域礦產資源的大量開支既無預算亦無規劃；及(iii)在特定區域勘探及評估礦產資源未發現商業上有利的礦產資源數量，而本集團決定終止在該區域的活動；及(iv)有充分資料顯示，儘管可能在特定區域進行開發，但勘探及評估資產的賬面價值不可能在成功開發或銷售中全數收回。在進行資產減值討論時，本集團就有關煤層氣未來價格、儲量及未來開發和生產成本的假設進行若干判斷。該估計變動可能導致勘探及評估資產的賬面價值產生重大變動。

#### 4.3 Impairment of gas properties, gas gathering stations and relating facilities and construction in progress

Gas properties, gas gathering stations and relating facilities and construction in progress are reviewed for impairment whenever events or changes in circumstances indicate that the carrying amount may not be recoverable. An impairment loss is recognised for the amount by which the asset's carrying amount exceeds its recoverable amount. The recoverable amount is the higher of an asset's fair value less costs to sell or value in use. In estimating the recoverable amounts of assets, various assumptions, including future cash flow to be associated with the assets and discounted rates, are made. If future events do not correspond to such assumptions, the recoverable amounts will be revised and this may have impacts on the Group's result of operation or financial position.

#### 4.4 Income taxes and deferred tax

The Group is subject to income taxes in several jurisdictions. Significant judgement is required in determining the worldwide provision for income taxes. There are certain transactions and calculations for which the ultimate tax determination is uncertain during the ordinary course of business. The Group recognises liabilities for anticipated tax audit issues based on estimates of whether additional taxes will be due. Where the final tax outcome of these matters is different from the amounts that were initially recorded, such differences will be reflected in the income tax expense and deferred tax provisions in the period in which such determination is made.

In addition, the realisation of future income tax assets is dependent on the Group's ability to generate sufficient taxable income in future years to utilise income tax benefits and tax loss carry-forwards. Deviations of future profitability from estimates or in the income tax rate would result in adjustments to the value of future income tax assets and liabilities that could have a significant effect on the income tax expenses.

#### 4.3 天然氣資產、集氣站及相關設施和在建工程減值

天然氣資產、集氣站及相關設施和在建工程會在事項發生或情況出現變化而導致賬面價值可能不能收回時，評估是否減值。減值虧損按有關資產的賬面價值超過其可收回金額的數額確認。可收回金額為資產的公允價值減去銷售成本或使用價值中的較高值。評估資產的可回收金額時，會作出多項假設(包括與資產相關的未來現金流量及貼現率)。若將來情況與該假設不相符，將修訂可收回金額，而此舉可能會對本集團的經營業績或財務狀況造成影響。

#### 4.4 所得稅及遞延稅項

本集團須在多個司法權區繳納所得稅。對於所得稅的全球撥備須作出重大判斷。在正常業務過程中，若干交易及計算的最終稅務結果並不確定。本集團根據是否須繳納額外稅項的估計對預期稅項審核事宜確認負債。若該事宜的最終稅務結果與最初記錄的金額不符，該差額將在相關期間的所得稅開支和遞延稅項撥備中反映。

此外，未來所得稅資產的實現，取決於本集團未來年度是否產生足夠的應課稅收入，以使用所得稅收益及稅項虧損結轉的能力而定。若將來盈利能力偏離估計或所得稅率，則須對未來所得稅資產及負債的價值作出調整，此舉可能對所得稅開支構成重大影響。

#### 4.5 Impairment of financial assets

The loss allowances for financial assets are based on assumptions about risk of default and expected loss rates. The Group uses judgement in making these assumptions and selecting the inputs to the impairment calculation, based on the Group's past history existing market conditions as well as forward-looking estimates at the end of each reporting period. Details of the key assumptions and inputs used are disclosed in Note 3.1(a).

### 5. SEGMENT INFORMATION

The chief operating decision-maker ("CODM") has been identified as the directors and chief executive of the Company who review the Group's internal reporting in order to assess performance and allocate resources. The CODM has determined the operating segments based on these reports.

The Group's operating segments are defined by PSCs, which is the basis by which the CODM makes decisions about resources to be allocated and assesses their performance. The financial information of the two concessions under the relating PSCs has been separated to present segment information to be reviewed by the CODM.

The measurement of results and assets of the operating segments are the same as those described in the summary of significant accounting policies. The CODM evaluates the performance of the operating segments of the PSCs based on profit before income tax, depreciation and amortisation, finance income, finance costs and exchange gains/(losses) ("EBITDA").

#### 4.5 金融資產減值

金融資產的損失撥備是基於有關違約風險和預期損失率的假設。本集團在做出這些假設時運用判斷，並根據過去的歷史、現有的市場狀況以及每個報告期末的前瞻性估計選擇計算減值的輸入值。註釋3.1(a)中披露了所使用的關鍵假設和輸入值的詳細信息。

### 5. 分部資料

主要營運決策者(「主要營運決策者」)為本公司的董事及總裁，負責審閱本集團的內部報告以評估表現和分配資源。主要營運決策者已根據該等報告確定經營分部。

本集團的經營分部按產品分成合同界定，這是主要營運決策者做出資源分配決定及評估其表現的基準。產品分成合同下兩區塊的財務資料已分為不同的分部資料列示，以供主要營運決策者審閱。

經營分部的業績及資產的計量方法與重要會計政策摘要中所述相同。主要營運決策者根據除所得稅、折舊及攤銷、財務收益、財務費用及匯兌收益/(損失)前的利潤(「EBITDA」)評估產品分成合同經營分部的表現。
