(A) INTRODUCTION

The purpose of this circular is to provide you with the AGM Notice, and the information regarding the resolutions to be proposed at the AGM relating to, among others, (i) the reelection of the Directors who are going to retire and stand for re-election at the AGM; and (ii) the grant to the Directors of the Issue Mandate (as defined below), the Repurchase Mandate (as defined below) and the extension of the Issue Mandate (as defined below) to include the Shares repurchased under the Repurchase Mandate (as defined below), if any.

(B) RE-ELECTION OF DIRECTORS

In accordance with Bye-laws 87(1) and 87(2), Mr. Lau Man Tak and Mr. Eric Lee Hon Man shall retire by rotation, and being eligible, have expressed their willingness to offer themselves for re-election at the AGM.

Mr. Lam Chun Kit was appointed by the Board as a Non-executive Director with effect from 16 February 2022. In accordance with Bye-law 86(2), Mr. Lam Chun Kit shall hold office only until the next following general meeting of the Company. He, being eligible, has offered himself for re-election at the AGM.

The Nomination Committee has reviewed the structure and composition of the Board, the confirmations and disclosures given by the Directors, the qualifications, skills and experience, time commitment and contribution of the retiring Directors with reference to the Company's Board Diversity Policy and Nomination Policy. The Nomination Committee has assessed the independence of Mr. Lau Man Tak and Mr. Eric Lee Hon Man based on reviewing their written confirmations of independence to the Company pursuant to Rule 3.13 of the Listing Rules and confirmed that they remain independent. The Board, having considered the recommendation of the Nomination Committee, is of the view that Mr. Lau Man Tak, Mr. Eric Lee Hon Man and Mr. Lam Chun Kit will bring valuable perspectives, knowledge, skills and experience to the Board for its efficient and effective functioning and their appointment will contribute to the diversity of the Board appropriate to the requirements of the Company's business.

The biographical details of all the retiring Directors are set out in Appendix I to this circular.

(C) GENERAL MANDATES TO ISSUE AND REPURCHASE SHARES

At the last annual general meeting of the Company held on Friday, 21 May 2021, general mandates were granted to the Directors to exercise the powers of the Company to allot, issue and deal with additional Shares and repurchase issued and fully paid Shares. These general mandates will lapse at the conclusion of the AGM and therefore, ordinary resolutions will be proposed at the AGM to grant fresh general mandates as follows:

- (i) to grant to the Directors a general and unconditional mandate to allot, issue and deal with additional Shares not exceeding twenty per cent (20%) of the total number of Shares in issue as at the date of the passing of the relevant ordinary resolution (i.e. not exceeding 84,970,000 Shares based on the total number of Shares in issue of 424,850,000 Shares as at the Latest Practicable Date and on the assumption that no further Shares will be issued and allotted prior to the passing of the relevant ordinary resolution at the AGM) (the "Issue Mandate");

PRECAUTIONARY MEASURES FOR THE ANNUAL GENERAL MEETING

The health of our Shareholders, staff and other participants of the AGM (the "Stakeholders") is of paramount importance to us. In view of the ongoing Novel Coronavirus (COVID-19) pandemic, the Company will implement the following precautionary measures at the AGM to protect the Stakeholders from the risk of infection, which include but not limited to:

- (i) Compulsory body temperature checks will be conducted for every attendee at the entrance of the meeting venue. To enable the Shareholders to make an informed decision on the re-election of the retiring Directors, we set out below the biographical details of the retiring Directors for the information of Shareholders.

1. Mr. Lau Man Tak (aged 52)

Mr. Lau Man Tak ("Mr. Lau") has been appointed as an Independent Non-executive Director since 28 September 2017. He is also the chairman of the Audit Committee, and a member of the Remuneration Committee and the Nomination Committee.

Mr. Lau graduated from the Hong Kong Polytechnic University with a bachelor's degree of arts in accountancy in November 1991. Mr. Lau has more than 20 years of experience in finance and accounting. He is an associate member of the Hong Kong Institute of Certified Public Accountants and a fellow member of each of the Association of Chartered Certified Accountants in United Kingdom, The Hong Kong Institute of Directors and the Hong Kong Securities and Investment Institute.

Mr. Lau is currently the chairman and a non-executive director of REF Holdings Limited ("REF") (stock code: 1631), a company listed on the Main Board of the Stock Exchange. He is also an independent non-executive director of Kingston Financial Group Limited ("Kingston Group") (stock code: 1031), a company listed on the Main Board of the Stock Exchange. Mr. Lau was an executive director and chairman of TEM Holdings Limited ("TEM") since 2015 and was re-designated as a director in January 2021 upon the withdrawal of the listing of TEM by way of privatisation. He was also an independent non-executive director of Chinese Food and Beverage Group Limited since February 2019 until his resignation upon its cancellation of listing on GEM of the Stock Exchange on 13 July 2021.

As aforesaid, Mr. Lau is an independent non-executive director of Kingston Group. Meanwhile, (i) Mrs. Chu Yuet Wah, being the controlling shareholder of the Company, also holds board position and has controlling interests in Kingston Group; and (ii) Mr. Kingston Chu Chun Ho, being an Executive Director and the Chairman of the Company, also holds board position in Kingston Group.

Mr. Lau was a director of the following companies, which were all incorporated in Hong Kong prior to their respective dissolution:

Notes:

- (1) Keng Fong Sin Kee Construction and Investment Company Limited ("Keng Fong") (presently known as ZH International Holdings Limited) (stock code: 185) was the ultimate holding company of the subject companies and Mr. Lau was the financial controller of Keng Fong and its group companies ("Keng Fong Group"). Because of the Asia financial crisis in around 1998, the business of Keng Fong Group was heavily affected and Keng Fong Group did not repay its loans. Therefore, the board of directors of Keng Fong decided to wind up the subject companies by means of creditors' voluntary winding up.
- (2) Mr. Lau was the financial controller of Keng Fong Group, the holding company of Kingford Investment Company, Limited ("Kingford"). Because of the Asia financial crisis in around 1998, the business of Keng Fong Group was heavily affected and Kingford did not pay its rent. Therefore, Kingford's then landlord sued against Kingford for the recovery of the sum of approximately HK\$0.4 million, being arrears of rent for the period from 1 November 2000 to 30 April 2001.
- (3) Mr. Lau was the financial controller of Keng Fong Group. Keng Fong invested in On Line Education Limited ("On Line Education") and nominated Mr. Lau as a director of On Line Education. However, Mr. Lau had never been involved in the management of the company. Later, On Line Education's business declined and On Line Education did not pay its employees their wages. Therefore, the employees brought an action against On Line Education in the Labour Tribunal for outstanding wages in arrears in the aggregate sum of approximately HK\$1.3 million.

Mr. Lau confirmed that there is no wrongful act on his part leading to the dissolutions of the above companies and is not aware of any actual or potential claim that has been or will be made against him as a result of the dissolutions, and that his involvement in these companies was part and parcel of his services and that no misconduct or misfeasance had been involved in the dissolution of these companies.

In addition, the Company engaged REF to provide typesetting, translation and printing services (the "Printing Services") to the Company in respect of its announcements, circulars, interim reports and annual reports. On the other hand, the Company provided coordination service for re-instatement work ("Coordination Service") to REF during 2021. The terms of Printing Services and Coordination Service have been negotiated and settled directly with the staff of REF, in which process Mr. Lau has not been involved. The transaction amounts incurred for the Printing Services and Coordination Service were HK\$276,852 and HK\$80,000 respectively in 2021 and were not material to Mr. Lau, REF and the Company. Mr. Lau has confirmed that he did not receive any of the transaction amount for the Printing Services in person, as the transaction amount went to REF as its revenue. He has also confirmed that he did not pay any of the transaction amount for the Coordination Service in person, as the transaction amount was entirely paid by REF.

As at the Latest Practicable Date, the Company does not have any relationship with REF in terms of shareholding, save that Mr. Lau is the chairman, non-executive director and the substantial shareholder holding 75% corporate interests in REF.

The Company confirmed that Mr. Lau has provided his confirmation of independence that he complied with Rule 3.13 of the Listing Rules for the year ended 31 December 2021 and up to the Latest Practicable Date.

As far as Rule 3.13 of the Listing Rules is concerned, the Company submitted that:

- (i) REF has never expressed that it provided the Printing Services in the capacity of professional adviser. The Printing Services involved no professional advisory elements and were provided in the way and features directed and instructed by the Company based on its specific requirements only. In fact, there is no provision in the service agreement stipulating that REF is providing any professional advice to the Company when delivering the Printing Services to the Company. Although Mr. Lau is a non-executive director of REF, he is not considered by the Company to be falling within the definition of Rule 3.13(3) of the Listing Rules as REF has not been a professional adviser to the Company; and
- (ii) neither Mr. Lau nor REF has subsisted any material interest in any principal business activities of, nor any one of them has been involved in any material business dealings with the Company, its holding company or their respective subsidiaries or with any core connected persons of the Company as at the Latest Practicable Date save for the Printing Services and Coordination Service.

Save as disclosed above, as at the Latest Practicable Date, Mr. Lau (i) did not hold any other major appointments and has not held any position or directorship in any other public listed companies during the last three years preceding the Latest Practicable Date; (ii) did not have any relationship with any Directors, senior management, or substantial or controlling shareholders of the Company; and (iii) did not hold any other position with the Company and its subsidiaries.

As at the Latest Practicable Date, Mr. Lau did not have any interest in the Shares within the meaning of Part XV of the SFO.

Pursuant to Mr. Lau's letter of appointment with the Company, his appointment has been renewed for three years commencing from 28 September 2020 up to and including 27 September 2023. Mr. Lau is subject to retirement by rotation and re-election at the annual general meeting of the Company at least once every three years in accordance with the Bye-laws.

For the year ended 31 December 2021, Mr. Lau is entitled to an annual director's fee of HK\$240,000 for acting as an Independent Non-executive Director, which is determined with reference to his duties and responsibilities in the Company, the remuneration policy of the Company and the prevailing market situation (subject to review by the Board from time to time).

2. Mr. Eric Lee Hon Man (aged 55)

Mr. Eric Lee Hon Man ("Mr. Lee") has been appointed as an Independent Non-executive Director since 28 September 2017. He is the chairman of the Nomination Committee, and a member of the Audit Committee and the Remuneration Committee.

Mr. Lee is currently an independent non-executive director of REF. He is also employed by Alliance Capital Partners Limited, a company engaging in advising on corporate finance and dealing in securities, as managing director. Mr. Lee graduated from the University of Birmingham, the United Kingdom with a bachelor's degree of engineering in electronic and electrical engineering in July 1988 and obtained a master's degree in business administration from the Chinese University of Hong Kong in December 1993.

Mr. Lee has over 20 years of experience in the corporate finance industry. He was an independent non-executive director of TEM since April 2016 until his resignation in January 2021 upon the withdrawal of the listing of TEM by way of privatization. From March 2017 to June 2020, Mr. Lee worked at Orient Capital (Hong Kong) Limited, a company engaging in advising on corporate finance, as managing director of investment banking department. From August 2015 to February 2017, Mr. Lee worked at LY Capital Limited, a company engaging in advising on corporate finance, as a director. From April 2002 to November 2014, Mr. Lee worked at First Shanghai Capital Limited, a company engaging in advising on corporate finance, and his last position was managing director. From July 1997 to March 2002, Mr. Lee worked at DBS Asia Capital Limited, a company engaging in advising on corporate finance, and his last position was vice president.

As aforesaid, Mr. Lee is an independent non-executive director of REF. Meanwhile, the Company engaged REF to provide typesetting, translation and printing services (the "Printing Services") to the Company in respect of its announcements, circulars, interim reports and annual reports. On the other hand, the Company provided coordination service for re-instatement work ("Coordination Service") to REF during 2021. The terms of Printing Services and Coordination Service have been negotiated and settled directly with the staff of REF, in which process Mr. Lee has not been involved. The transaction amounts incurred for the Printing Services and Coordination Service were HK\$276,852 and HK\$80,000 respectively in 2021 and were not material to Mr. Lee, REF and the Company. Mr. Lee has confirmed that he did not receive any of the transaction amount for the Printing Services in person, as the transaction amount went to REF as its revenue. He has also confirmed that he did not pay any of the transaction amount for the Coordination Service in person, as the transaction amount was entirely paid by REF.

As at the Latest Practicable Date, the Company does not have any relationship with REF in terms of shareholding, save that Mr. Lee is an independent non-executive director of REF.

The Company confirmed that Mr. Lee has provided his confirmation of independence that he complied with Rule 3.13 of the Listing Rules for the year ended 31 December 2021 and up to the Latest Practicable Date.

As far as Rule 3.13 of the Listing Rules is concerned, the Company submitted that:

- (i) REF has never expressed that it provided the Printing Services in the capacity of professional adviser. The Printing Services involved no professional advisory elements and were provided in the way and features directed and instructed by the Company based on its specific requirements only. In fact, there is no provision in the service agreement stipulating that REF is providing any professional advice to the Company when delivering the Printing Services to the Company. Although Mr. Lee is an independent non-executive director of REF, he is not considered by the Company to be falling within the definition of Rule 3.13(3) of the Listing Rules as REF has not been a professional adviser to the Company; and
- (ii) neither Mr. Lee nor REF has subsisted any material interest in any principal business activities of, nor any one of them has been involved in any material business dealings with the Company, its holding company or their respective subsidiaries or with any core connected persons of the Company as at the Latest Practicable Date save for the Printing Services and Coordination Service.

Save as disclosed above, as at the Latest Practicable Date, Mr. Lee (i) did not hold any other major appointments and has not held any position or directorship in any other public listed companies during the last three years preceding the Latest Practicable Date; (ii) did not have any relationship with any Directors, senior management, or substantial or controlling shareholders of the Company; and (iii) did not hold any other position with the Company and its subsidiaries.

As at the Latest Practicable Date, Mr. Lee did not have any interest in the Shares within the meaning of Part XV of the SFO.

Pursuant to Mr. Lee's letter of appointment with the Company, his appointment has been renewed for three years commencing from 28 September 2020 up to and including 27 September 2023. Mr. Lee is subject to retirement by rotation and re-election at the annual general meeting of the Company at least once every three years in accordance with the Bye-laws.

For the year ended 31 December 2021, Mr. Lee is entitled to an annual director's fee of HK\$240,000 for acting as an Independent Non-executive Director, which is determined with reference to his duties and responsibilities in the Company, the remuneration policy of the Company and the prevailing market situation (subject to review by the Board from time to time).

3. Mr. Lam Chun Kit (aged 48)

Mr. Lam Chun Kit ("Mr. Lam") was appointed as a Non-Executive Director with effect from 16 February 2022. He is the financial controller of VMS Investment Group Limited ("VMS"), which is an asset management company specializing in private equity, structured financing and M&A transactions.

Before that, Mr. Lam worked in a private group engaging in investment properties and oil and gas industry as head of finance control, and in international audit firms over 10 years. Mr. Lam has developed extensive experience in finance and accounting, treasury, tax and corporate governance. Mr. Lam graduated from The Hong Kong Polytechnic University with a bachelor's degree of Arts in Accountancy. He is also a member of The Hong Kong Institute of Certified Public Accountants.

Save as disclosed above and the fact that VMS's related company, VMS Securities Limited, was one of the joint financial advisers appointed by the Board to advise the Company on the disposal of the property and facility management services of the Group in Hong Kong (including the provision of ancillary services) during the period from September 2021 to January 2022, as at the Latest Practicable Date, Mr. Lam (i) did not hold any other major appointments and has not held any position or directorship in any other public listed companies during the last three years preceding the Latest Practicable Date; (ii) did not have any relationship with any Directors, senior management, or substantial or controlling shareholders of the Company; and (iii) did not hold any other position with the Company and its subsidiaries.

As at the Latest Practicable Date, Mr. Lam did not have any interest in the Shares within the meaning of Part XV of the SFO.

Pursuant to Mr. Lam's letter of appointment with the Company, he is appointed for a term of one year commencing from 16 February 2022 up to and including 15 February 2023 (which is renewable upon expiry). Mr. Lam is subject to retirement by rotation and reelection at the annual general meeting of the Company at least once every three years in accordance with the Bye-laws of the Company. He is entitled to receive an annual Director's fee of HK\$600,000 for acting as a Non-executive Director, which is determined with reference to his duties and responsibilities in the Company, the remuneration policy of the Company and the prevailing market conditions (subject to review by the Board from time to time).

Save as disclosed above, there is no information to be disclosed pursuant to the requirements of Rules 13.51(2)(h) to 13.51(2)(v) of the Listing Rules nor are there any other matters that need to be brought to the attention of the Shareholders in respect of the re-election of the abovenamed retiring Directors.

APPENDIX II EXPLANATORY STATEMENT ON REPURCHASE MANDATE

This appendix contains the explanatory statement, as required under the Listing Rules, to provide to the Shareholders with the requisite information in connection with the Repurchase Mandate.

1. SHARE CAPITAL

As at the Latest Practicable Date, the issued share capital of the Company comprised 424,850,000 fully paid Shares and 80,000,000 convertible preference shares.

Subject to the passing of the ordinary resolution no. 4(2) set out in the AGM Notice for approving the Repurchase Mandate and on the basis that no further Shares will be issued or repurchased prior to the AGM, the Company would be allowed under the Repurchase Mandate to repurchase a maximum of 42,485,000 Shares during the period in which the Repurchase Mandate remains in force. Any Shares repurchased pursuant to the Repurchase Mandate must be fully paid-up.

2. REASONS FOR REPURCHASES

The Directors believe that the Repurchase Mandate is in the interests of the Company and the Shareholders as a whole. Such repurchases may, depending on market conditions and funding arrangements at that time, lead to an enhancement of the net assets and/or earnings per Share. The Directors will decide on the number of Shares to be repurchased on each occasion and the price and other terms upon which the same is repurchased at relevant time having regard to the circumstances then pertaining and they will do so only when they believe that such repurchases will benefit the Company and the Shareholders as a whole. At present, the Directors have no intention to repurchase any Shares.

3. FUNDING OF REPURCHASES

In repurchasing Shares, the Company will only apply funds legally available for such purpose in accordance with the Bye-laws and the applicable laws of Bermuda. It is envisaged that such repurchases would be paid out of the capital paid up on the repurchased Shares, or the funds of the Company otherwise available for dividend or distribution, or the proceeds of a fresh issue of Shares made for the purpose. Any premium payable on a repurchase would be provided out of funds of the Company otherwise available for dividend or distribution or the Company's share premium account.

In the event that the Repurchase Mandate were to be exercised in full at any time during the period which the Repurchase Mandate remains in force, there might be a material adverse impact on the working capital but possibly not the gearing position of the Company as compared to the consolidated financial position of the Company as at 31 December 2021 (being the date to which the latest published audited consolidated financial statements of the Company were made up). The Directors do not propose to exercise the Repurchase Mandate to such an extent as would, in the circumstances, have a material adverse impact on the working capital or the gearing position of the Company which in the opinion of the Directors is from time to time appropriate for the Company.

4. CONNECTED PERSONS AND DIRECTORS' UNDERTAKING

None of the Directors nor, to the best of their knowledge having made all reasonable enquiries, any of their associates have any present intention to sell Shares to the Company in the event that the Repurchase Mandate is approved by the Shareholders.

No core connected persons of the Company have notified the Company that they have a present intention to sell Shares to the Company, or have undertaken not to do so, in the event that the Repurchase Mandate is approved by the Shareholders.

The Directors have undertaken to the Stock Exchange that, so far as the same may be applicable, they will exercise the powers of the Company to make repurchases pursuant to the Repurchase Mandate in accordance with the Listing Rules, the Bye-laws and the applicable laws of Bermuda.

5. EFFECT OF THE TAKEOVERS CODE

If, as a result of a repurchase of Shares, a Shareholder's proportionate interest in the voting rights of the Company is increased, such increase will be treated as an acquisition for the purpose of Rule 32 of the Takeovers Code. Accordingly, a Shareholder, or a group of Shareholders acting in concert (within the meaning of the Takeovers Code), may obtain or consolidate control of the Company and become obliged to make a mandatory offer in accordance with Rule 26 of the Takeovers Code.

As at the Latest Practicable Date, Mrs. Chu Yuet Wah ("Mrs. Chu") was interested in 225,518,633 Shares, representing approximately 53.08% of the total number of Shares in issue, through her wholly and beneficially owned company, Champ Key Holdings Limited.

In the event that the Repurchase Mandate was to be exercised in full, then (if the present shareholdings otherwise remained the same) the shareholding in the Company of Mrs. Chu would increase to approximately 58.98% of the total number of Shares in issue. It is considered that such increase will not give rise to an obligation to make a mandatory offer under Rule 26 of the Takeovers Code. The Directors have no present intention to exercise the Repurchase Mandate to such an extent as would give rise to this obligation.

The Directors do not intend to exercise the Repurchase Mandate to an extent which will result in the number of Shares held in the hands of the public falling below the prescribed limit under the Listing Rules.
