Please note that you may change your choice of means of receipt of the Corporate Communications at any time, free of charge by giving reasonable prior notice, by completing and returning to the Branch Share Registrar the completed Instruction Slip using one of the above-mentioned methods. A copy of the Instruction Slip will be sent to you together with future Corporate Communications or can be obtained from the Branch Share Registrar.
