(海光信息技術股份有限公司), has recently issued the joint certification certificate of the General Software and Hardware Adaption Certification Center for NewLink RPA V4.0, independently developed by Beijing Newlink Technology Co., Ltd., a subsidiary of the Company, and UnionTech Software Technology Co., Ltd. (統信軟件技術有限公司), together with each of Shanghai Zhaoxin Semiconductor Co., Ltd. (上海兆芯集成電路有限公司) and Hygon Information Technology Co., Ltd. (海光信息技術股份有限公司) has issued the joint certification certificate of the General Software and Hardware Adaption Certification Center for NewLink RPA Integrated Machine V4.0. In the future, while continuously and actively expanding its product advantages, the Company will continue to take innovative technologies including artificial intelligence and big data analysis as the core drive and make efforts to promote the application of innovative solutions and products represented by NewLink RPA series to more physical industries, so as to support the acceleration of digital transformation of more physical industries.
