### **VOLUNTARY ANNOUNCEMENT REMITTANCE OF FUNDS TO TRUSTEE FOR REPAYMENT OF OUTSTANDING US\$200,000,000 11.875% SENIOR NOTES DUE 2022**

This announcement is made by Dexin China Holdings Company Limited (the “**Company**”) on a voluntary basis.

Reference is made to the announcements of the Company dated 20 January 2020, 21 January 2020, 23 January 2020 and 19 April 2022 (collectively, the “**Announcements**”) relating to the issuance of the US\$200,000,000 11.875% senior notes due 2022 (the “**2022 Notes**”), the listing thereof on The Stock Exchange of Hong Kong Limited and the remittance of funds for repayment of the 2022 Notes. Unless otherwise defined, capitalised terms used herein shall have the same meanings as defined in the Announcements.

On 20 April 2022, the Company has deposited all necessary funds to the trustee for repayment of the 2022 Notes in full on 22 April 2022 at their outstanding principal amount together with interest accrued to the maturity date, being 23 April 2022.

The Company considers that there will be no material impact on its financial position as a result of the redemption of the 2022 Notes at maturity. Upon completion of the redemption, the 2022 Notes will be cancelled and delisted from the Stock Exchange.
