#### Election of Language and Means of Receipt of Corporate Communications

Pursuant to Rules 2.07A and 2.07B of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the "Listing Rules"), the Companies Ordinance, Chapter 622 of the Laws of Hong Kong, and the articles of association of Hong Kong Ferry (Holdings) Company Limited (the "Company"), the Company is making available the following options for you to elect for the receipt of future corporate communication(s) of the Company (the "Corporate Communication(s)"), which means any document(s) issued or to be issued by the Company for the information or action of holders of any of its securities as defined in Rule 1.01 of the Listing Rules, including but not limited to the directors' report, annual accounts together with a copy of the auditor's report (and where applicable, the summary financial report), the interim report (and where applicable, the summary interim report), notices of meetings, listing documents, circulars and proxy forms in the following manners:

- (ii) to receive the printed English version of all future Corporate Communications only; or

- (iv) to receive both the printed English and Chinese versions of all future Corporate Communications.

In support of environmental protection and for the purpose of saving printing and mailing costs, the Company recommends you to elect to receive all future Corporate Communications by electronic means.
