Chairman's Statement

主席報告

Dear Shareholders,

On behalf of the board (the "Board") of directors (the "Directors") of Kangda International Environmental Company Limited (the "Company") together with its subsidiaries (collectively, the "Group"), I am pleased to present the annual report of the Group for the year ended 31 December 2021 to you.

RESULTS REVIEW

In 2021, when the pandemic rebounded rapidly in most parts of the world amidst the impact of variants of COVID-19, the Chinese government insisted on safeguarding people's health as its core concern and successfully contained the rebound and spread of the pandemic by maintaining high-intensity pandemic prevention and control measures. While enhancing the wastewater-related regulation as an important tool for pandemic prevention and control, the country is also concerned about the long-term development of the wastewater treatment industry as one of the foundations for building a beautiful China. National ministries and commissions, including the State Council and the National Development and Reform Commission, successively released the Guiding Opinions on Promoting the Recycling of Sewage (《關於推進污水資源化利用的指導意見》), the Urban Wastewater Treatment and Recycling Program for the "14th FiveYear Plan" Period (《"十四五"城鎮污水處理及資源化利用發展規劃》), the Water-saving Social Construction Planning for the "14th FiveYear Plan" Period (《"十四五"節水型社會建設規劃》), the Comprehensive Management Planning for the Water Environment of Key River Basins for the "14th FiveYear Plan" Period (《"十四五"重點流域水環境綜合治理規劃》), the Comprehensive Work Plan for Energy Conservation and Emission Reduction for the "14th FiveYear Plan" Period (《"十四五"節能減排綜合工作方案》) and other policy documents during the year, which clearly stated the targets for wastewater collection, treatment and recycling by 2025 and by 2035.

After the peak construction period in the past few years, the Group's wastewater treatment facility projects under construction have been completed and commenced commercial operation in an orderly manner, significantly enhancing the Group's wastewater treatment capacity. The actual treatment volume of wastewater for the year increased to 1,262.4 million tonnes, representing an increase of approximately 11% as compared to 2020. Due to the higher gross profit margin of the wastewater treatment operation business, even though the total revenue for the year decreased by approximately 12% to RMB2,919.0 million as compared to the previous year due to the decrease in revenue from construction services, the gross profit for the year still increased slightly by approximately 1% to RMB1,335.3 million as compared to the previous year, and the overall gross profit margin of the Group improved to 46% from 40% last year.

尊敬的各位股東：

本人僅代表康達國際環保有限公司(「本公司」)連同其附屬公司(統稱「本集團」)董事(「董事」)會(「董事會」)，欣然向閣下提呈本集團截至二零二一年十二月三十一日止年度的年報。

業績回顧

在二零二一年，當全球大部份地區疫情在變種新型冠狀病毒的衝擊中急速反彈的時候，中國政府堅持以維護人民健康為核心，通過維持高強度的疫情防控措施，成功遏制了疫情的反彈和擴散。國家以提升污水相關監管作為疫情防控的重要手段的同時，亦關注污水處理行業的長遠發展，並以此作為建設美麗中國的基礎之一。包括國務院及國家發展改革委等國家部委於年內先後發佈了《關於推進污水資源化利用的指導意見》、《「十四五」城鎮污水處理及資源化利用發展規劃》、《「十四五」節水型社會建設規劃》、《「十四五」重點流域水環境綜合治理規劃》、《「十四五」節能減排綜合工作方案》等政策文件，明確提出了到2025年及到2035年，關於污水收集、處理及再生利用的目標。

經過過去數年的建造高峰期後，本集團的在建污水處理設施項目陸續有序完成及投入商業營運，大幅提升了集團的污水處理能力。本年度污水實際處理量提升至1,262.4百萬噸，較二零二零年度增加約11%。由於污水處理運營業務的毛利率較高，即使本年度總收益因為建設服務收益下降而較上年度下跌約12%至人民幣2,919.0百萬元，本年度毛利仍然較上年度小幅上升約1%至人民幣1,335.3百萬元，本集團整體毛利率亦由去年的40%提升至46%。

Chairman's Statement

With the unremitting efforts of the management, the Group has retained positive operating cash flow for three consecutive years and achieved RMB320 million for the year, representing a year-on-year increase of approximately 31%, laying a solid foundation for the Group's stable recovery to achieve a virtuous cycle. On the other hand, due to the increase in administrative and other expenses and finance costs, in particular, the total amount of tax exemptions and concessions granted to wastewater treatment enterprises by the national governments at various levels due to the impact from the pandemic decreased by more than RMB40 million year-on-year, the profit attributable to equity shareholders of the Group for the year decreased to RMB412.8 million, representing a decrease of approximately 12% as compared with that of 2020. Basic earnings per share for the year was RMB19.29 cents. As at 31 December 2021, the Group's net asset value per share was RMB2.53, representing an increase of approximately 4% as compared to the same period last year.

DEVELOPMENT STRATEGY AND FUTURE OUTLOOK

The Group will seize the opportunities provided by the national policies, continue to focus on the development of the main business of municipal wastewater treatment, and deepen energy saving and consumption reduction measures by enhancing the wastewater treatment volume and treatment standard. By exploring wastewater resource recycling and reclaimed water utilization business, it will help the country achieve its goals of pollution prevention, water management and utilization, as well as energy saving and emission reduction while increasing the Group's revenue and profit, creating greater value for the Shareholders.

In terms of financial resources, the Group will continue to optimize its debt structure and develop financing channels to reduce financing costs. In early 2022, the Group obtained a green loan of US\$16 million in total certified by the Hong Kong Quality Assurance Agency, which is the first green financing completed by the Group in Hong Kong and embodies the Group's green business concept of water-oriented environmental pollution management in its corporate financing activities.

Finally, I would like to take this opportunity to express our gratitude to all the Shareholders and all the collaborative partners of our Group for their dedicated support to the Group's development, and also to all staff of our Group for their endeavors and contributions made during the year.

在管理層的不懈努力下，本集團連續三年保留經營性現金流為正數，本年度實現人民幣320百萬元，同比提升約31%，為本集團穩健康復實現良性循環奠定了堅實基礎。另一方面，由於行政及其他開支及財務費用的上升，特別是國家各級政府因為疫情影響給予污水處理企業的稅費減免和優惠總額同比減少超過人民幣40百萬元，所以令本年度本集團權益股東應佔溢利下降至人民幣412.8百萬元，較二零二零年度減少約12%。本年度每股基本盈利為人民幣19.29分。於二零二一年十二月三十一日，本集團每股資產淨值為人民幣2.53元，較去年同期增加約4%。

本集團發展策略及未來展望

本集團將抓緊國家政策提供的機會，繼續專注發展市政污水處理主業，通過提升污水處理量及處理標準，深化節能降耗措施，及探索包括污水資源化和再生水利用業務等方式，在幫助國家達成污染防治、水資源管理和利用及節能減排等目標的同時增加集團收入與利潤，為股東創造更大價值。

財務資源方面，本集團將持續優化債務結構及開拓融資渠道以降低融資成本。於二零二二年初，本集團取得由香港品質保證局認證，合共1,600萬美元的綠色貸款，是本集團首次於香港完成的綠色融資，將本集團的綠色業務概念——以水為本的環境污染治理體現於企業融資活動之中。

最後，本人亦借此機會衷心感謝本集團的全體股東及所有合作夥伴對於本集團的發展一直給予的支持，並向本集團全體員工於年內作出的努力和貢獻致以敬意。

BUSINESS REVIEW

During the year ended 31 December 2021 (the "Reporting Period"), the Group's principal business activities remained focusing on the Urban Water Treatment, followed by the existing projects of Water Environment Comprehensive Remediation and the Rural Water Improvement.

The scope of Urban Water Treatment includes the design, construction, upgrade and operation of wastewater treatment plants (the "WTPs"), reclaimed water treatment plant (the "RWTPs"), sludge treatment plants (the "STPs"), water distribution plants (the "WDPs"), and in the operation and maintenance of wastewater treatment facilities entrusted by governments (the "O&M"). The Group's business has covered the overall industry chain in Urban Water Treatment industry by executing contracts of Build-Operate-Transfer ("BOT"), Transfer-Operate-Transfer (the "TOT"), Public-Private-Partnership (the "PPP"), Build-Own-Operate (the "BOO"), Engineering-Procurement-Construction (the "EPC") and O&M. The Group had 101 service concession arrangement projects under operation while its operational treatment capacity was over 4 million tons per day as at 31 December 2021.

The scope of Water Environment Comprehensive Remediation includes river harnessing and improvement, foul water body treatment and sponge city construction. The Group engages in Water Environment Comprehensive Remediation by executing previously signed contracts of PPP and EPC.

The scope of Rural Water Improvement includes the construction and operation related to "the Water Environment Facilities of Beautiful Village" such as: wastewater treatment facilities and pipeline construction for collecting wastewater so as to achieve rural living environment improvement. The Group started to carry out this business since 2016 by executing the contracts of PPP.

In the future, the Group will continuously focus on the business of Urban Water Treatment to get steady cash flows and invest in high-quality, value-adding upstream and downstream businesses of water industry. The Group is very confident about the Group's prospects and future profitability and we will dedicate more efforts to enhance the profitability and effectiveness of the Group.

業務回顧

截至二零二一年十二月三十一日止年度(「報告期」)，本集團主要業務仍集中在城鎮水務領域，兼顧水環境綜合治理及鄉村污水治理等領域的現有項目。

城鎮水務的範圍包括設計、建設、升級及營運污水處理廠(「污水處理廠」)、再生水處理廠(「再生水處理廠」)、污泥處理廠(「污泥處理廠」)、供水廠(「供水廠」)及營運及維護政府委託的污水處理設施(「運營及維護」)。本集團業務通過執行建設—運營—移交(「BOT」)、移交—運營—移交(「TOT」)、公私營合作(「PPP」)、建設—擁有一運營(「BOO」)、設計—採購—施工(「EPC」)以及運營及維護合約，已覆蓋城鎮水務行業的整體產業鏈。於二零二一年十二月三十一日，本集團在運營服務特許經營安排項目達到101個，在運營處理能力突破每日四百萬噸。

水環境綜合治理的範圍包括流域綜合治理及改善、黑臭水體處理及海綿城市建設等。本集團通過執行過往已簽訂的PPP和EPC合約，從事水環境綜合治理業務。

鄉村污水治理的範圍包括建設及營運「美麗鄉村水環境設施」，例如：污水處理設施設備和污水收集管網建設以達至鄉村居住環境改善。本集團於二零一六年開始通過執行PPP合約開展此類業務。

未來，本集團將繼續以獲得穩定現金流的城鎮水務業務為發展重心，同時擇優投資水務產業鏈上下游的增值領域。本集團對前景及未來的盈利能力充滿信心，並且我們將更加努力提升本集團的盈利能力和效益。

1.1 Urban Water Treatment

As at 31 December 2021, the Group had entered into a total of 113 service concession arrangements projects, including 107 wastewater treatment plants, 1 water distribution plant, 3 sludge treatment plants and 2 reclaimed water treatment plants. The Group will further expand its Urban Water Treatment chain in the future, in order to improve its profitability and competitiveness.

1.1 城鎮水務

於二零二一年十二月三十一日，本集團共訂立113個服務特許經營安排項目，包括107個污水處理廠，1個供水廠，3個污泥處理廠及2個再生水處理廠。未來本集團將通過進一步擴展城鎮水務處理產業鏈，實現盈利能力與競爭力的提升。

1.1.1 Operation Services

As at 31 December 2021, the Group had 96 wastewater treatment projects, 2 reclaimed water treatment projects and 3 sludge treatment projects in operation in Mainland China. Total daily treatment capacity of wastewater treatment plants, reclaimed water treatment plants, and sludge treatment plants in operation for the year ended 31 December 2021 reached 3,961,500 tonnes (2020: 3,766,500 tonnes), 65,000 tonnes (2020: 65,000 tonnes), and 550 tonnes (2020: 550 tonnes), respectively. For the year ended 31 December 2021, the annualized utilization rate for wastewater and reclaimed water treatment plants in operation was approximately 86% (2020: 83%). The actual average water treatment tariff for the year ended 31 December 2021 was approximately RMB1.49 per tonne (2020: approximately RMB1.46 per tonne). The actual aggregate processing volume for the year ended 31 December 2021 was 1,262.4 million tonnes, representing an increase of 11% as compared to the same period last year (year ended 31 December 2020: 1,133.6 million tonnes), which was in line with the increase in treatment capacity.

Total operation revenue of the Group's Urban Water Treatment services recorded for the year ended 31 December 2021 was RMB1,185.9 million, representing an increase of approximately 13% as compared to the same period of last year (year ended 31 December 2020: RMB1,053.4 million). The corresponding increase was primarily due to the increase in the number of commencement of operation of new water treatment projects through construction.

1.1.2 Construction Services

The Group entered into a number of service concession arrangements under BOT, BOO and PPP contracts in relation to its Urban Water Treatment business. Under the International Financial Reporting Interpretation Committee 12 Service Concession Arrangements, the Group recognises the construction revenue with reference to the fair value of the construction service delivered in the building phase. The fair value of such service is estimated on a cost-plus basis with reference to a prevailing market rate of gross margin at the inception date of service concession agreement. Construction revenue from BOT, BOO, PPP and EPC projects is recognised by using the percentage-of-completion method.

1.1.1 運營服務

於二零二一年十二月三十一日，本集團在中國內地有96個運營中的污水處理項目、2個再生水處理項目及3個污泥處理項目。截至二零二一年十二月三十一日止年度，運營中污水處理廠、再生水處理廠及污泥處理廠的每日總處理量分別為3,961,500噸（二零二零年：3,766,500噸）、65,000噸（二零二零年：65,000噸）及550噸（二零二零年：550噸）。截至二零二一年十二月三十一日止年度，運營中污水處理廠及再生水處理廠的年使用率約為86%（二零二零年：83%）。截至二零二一年十二月三十一日止年度的實際平均水處理費約為每噸人民幣1.49元（二零二零年：約為每噸人民幣1.46元）。截至二零二一年十二月三十一日止年度的實際總處理量為1,262.4百萬噸，同比增加11%（截至二零二零年十二月三十一日止年度：1,133.6百萬噸），與處理能力的增加相符。

本集團截至二零二一年十二月三十一日止年度城鎮水務服務的總運營收益為人民幣1,185.9百萬元，較去年同期增長約13%（截至二零二零年十二月三十一日止年度：人民幣1,053.4百萬元），相關增加主要由於通過建設新增污水處理項目開始運營的數量增加。

1.1.2 建設服務

本集團城鎮水務業務以BOT、BOO及PPP合約訂立多項服務特許經營安排。根據國際財務報告詮釋委員會詮釋第12號服務特許經營安排，本集團經參考於建設階段交付的建設服務的公平值確認建設收益。有關服務的公平值乃按成本加成基準並參考服務特許經營協議開始生效日期的毛利率的通行市場比率估計。BOT、BOO、PPP及EPC項目的建設收益採用完工百分比法確認。

For the year ended 31 December 2021, construction revenue was recognised for 25 projects, including 20 wastewater treatment plants, 2 water distribution plants, 1 reclaimed water treatment plant, and 2 sludge treatment plants, which were mainly located in Shandong, Shanxi provinces, and the city of Tianjin in Mainland China. Total construction revenue of those projects for the year ended 31 December 2021 was RMB780.7 million, representing a year-on-year decrease of approximately 35% (year ended 31 December 2020: RMB1,192.9 million). The corresponding decrease was primarily due to a decrease in the project numbers during the main construction period. As at 31 December 2021, the total daily treatment capacity of the service concession arrangements plants, which were still in the construction stage, was 210,500 tonnes, including 180,500 tonnes of wastewater treatment plants and 30,000 tonnes of water distribution plants.

1.2 Water Environment Comprehensive Remediation

In the year of 2021, the Group continued to devote efforts to implementing the existing projects of Water Environment Comprehensive Remediation. As at 31 December 2021, most of the projects have been completed. The Group devoted efforts to lower the risk and enhance the reasonable profit for the existing projects. The Group will integrate resources to execute the Water Environment Comprehensive Remediation projects under the contracts of EPC and O&M.

The Group had 7 Water Environment Comprehensive Remediation projects under construction during the year ended 31 December 2021. The projects were mainly located in Jiangxi and Shandong provinces in Mainland China. For the year ended 31 December 2021, total revenue of those projects was RMB147.7 million, representing a year-on-year decrease of approximately 53% (year ended 31 December 2020: RMB311.7 million). The corresponding decrease was primarily due to the completion of partial existing EPC projects.

截至二零二一年十二月三十一日止年度，已就25個項目確認建設收益，包括20個污水處理廠、2個供水廠、1個再生水處理廠及2個污泥處理廠，主要位於中國內地的山東省、山西省及天津市。截至二零二一年十二月三十一日止年度，該等項目的總建設收益為人民幣780.7百萬元，同比減少約35%（截至二零二零年十二月三十一日止年度：人民幣1,192.9百萬元），相應減少主要由於處於主體施工期的項目數量減少。於二零二一年十二月三十一日，該等服務特許經營安排廠房（仍在建設階段）的每日總處理量為210,500噸，包括污水處理廠180,500噸及供水廠30,000噸。

1.2 水環境綜合治理

二零二一年，本集團繼續致力於執行現有水環境綜合治理項目。於二零二一年十二月三十一日，大部分項目已經完工。本集團仍致力於降低現有項目的風險並提升合理利潤。本集團將整合資源，以執行EPC與運營及維護合約下的水環境綜合治理項目。

截至二零二一年十二月三十一日止年度，本集團有7個處於建設階段的水環境綜合治理項目，主要位於中國內地的江西省及山東省。截至二零二一年十二月三十一日止年度，該等項目總收益為人民幣147.7百萬元，同比減少約53%（截至二零二零年十二月三十一日止年度：人民幣311.7百萬元），相應減少主要由於部分現有EPC項目完工。

1.3 Rural Water Improvement

In the year of 2021, the Group disposed 1 Rural Water Improvement project in Guizhou province. As at 31 December 2021, the existing 2 projects of Rural Water Improvement which were under construction were located in Guangdong province in Mainland China. For the year ended 31 December 2021, total revenue of those projects was RMB102.9 million, representing a year-on-year decrease of approximately 15% (year ended 31 December 2020: RMB121.2 million). The corresponding decrease was primarily due to net impact of the decrease in the construction work of existing projects and the increased operation revenue due to the partial operation of these two projects.

FINANCIAL ANALYSIS

Revenue

For the year ended 31 December 2021, the Group recorded a revenue of RMB2,919.0 million, representing a decrease of approximately 12% as compared to the previous corresponding period of RMB3,332.4 million. The decrease was mainly due to the decrease in construction revenue of RMB604.6 million, which was partially offset by the increase in operation revenue of RMB142.2 million, and the increase in financial income of RMB49.0 million. The decrease in construction revenue was mainly due to the decrease in the number of projects during the main construction period of Urban Water Treatment services, and the completion of partial existing EPC projects of Water Environment Comprehensive Remediation services. The increase in operation revenue was mainly due to the increase in commencement of operation of new BOT and upgrade projects of Urban Water Treatment. The increase in financial income was mainly due to the increase in the financial assets.

Cost of Sales

The Group's cost of sales for the year ended 31 December 2021 amounted to RMB1,583.7 million, including construction costs of RMB824.7 million and operation costs of water treatment plants of RMB759.0 million, representing a decrease of approximately 21% as compared to the previous corresponding period of RMB2,006.8 million. The decrease was due to the decrease in construction costs. The decrease in construction costs was mainly due to the decrease in the construction work of existing projects which was in line with the decrease in construction revenue. The increase in operation cost was in line with the increase of daily wastewater treatment capacity.

1.3 鄉村污水治理

二零二一年，本集團處置了1個位於貴州省的鄉村污水治理項目。於二零二一年十二月三十一日，位於中國內地廣東省的2個現有鄉村污水治理項目均處於在建階段。截至二零二一年十二月三十一日止年度，該等項目總收益為人民幣102.9百萬元，同比減少約15%（截至二零二零年十二月三十一日止年度：人民幣121.2百萬元），相應減少主要由於現有項目建設工程完工量的減少以及這兩個項目部分運營帶來運營收入增加的淨影響。

財務分析

收益

截至二零二一年十二月三十一日止年度，本集團錄得收益人民幣2,919.0百萬元，較去年同期的人民幣3,332.4百萬元減少約12%。該減少主要是由於建設收益減少人民幣604.6百萬元，並被運營收益增加人民幣142.2百萬元及金融收益增加人民幣49.0百萬元部份抵銷。建設收益減少主要是由於城鎮水務服務處於主體施工期的項目數量減少，以及水環境綜合治理服務的部分現有EPC項目的完工。運營收益的增加主要是由於城鎮水務新增BOT項目及提標改造項目開始運營的數量增加。金融收益增加主要是由於金融資產的增加。

銷售成本

截至二零二一年十二月三十一日止年度，本集團的銷售成本為人民幣1,583.7百萬元（包括建設成本人民幣824.7百萬元及水處理廠的運營成本人民幣759.0百萬元），較去年同期的人民幣2,006.8百萬元減少約21%。該減少主要是由於建設成本的減少。該建設成本的減少主要是由於現有項目建設工程的減少，與建設收益的減少相符合。該運營成本的增加與日污水處理能力的增加相符合。

Gross Profit Margin

For the year ended 31 December 2021, the Group's gross profit margin was approximately 46%, representing an increase of 6 percentage points as compared to the previous corresponding period of approximately 40%. The increase was primarily due to the increase in the proportion of operation revenue and financial income recognized in this period.

Other Income and Gains

The Group recorded other income and gains of RMB106.6 million for the year ended 31 December 2021, representing a minor decrease as compared to the previous corresponding period of RMB107.2 million. The amount for the Reporting Period primarily included government grants of RMB60.5 million, which mainly comprised of VAT refund under "Notice on the Issuing of the Catalogue of Value-Added Tax Preferences for Products and Labor Services Involving the Comprehensive Utilization of Resources (Cai Shui [2015] No. 78)"* (關於印發《資源綜合利用產品和勞務增值稅優惠目錄》的通知(財稅[2015]78號文)) and grants for environmental protection, bank interest income of RMB2.6 million, interest income of RMB23.6 million from loans to third parties and a joint venture, gains on foreign exchanges of RMB7.3 million, other investment income of RMB8.5 million.

Selling and Distribution Expenses

The Group's selling and distribution expenses for the year ended 31 December 2021 was RMB1.1 million, representing a significant decrease of approximately 56% as compared to RMB2.5 million in the previous corresponding period, which was a result of stringent management and cost control.

Administrative Expenses

The Group's administrative expenses for the year ended 31 December 2021 was RMB246.0 million, representing an increase of approximately 13% as compared to the previous corresponding period of RMB217.6 million. The increase was mainly due to the increase in staff costs and professional fees. The increase in staff costs was primarily due to the increased numbers of operating wastewater treatment plants.

Other Expenses

Other expenses for the year ended 31 December 2021 was RMB76.4 million, representing a large increase as compared to the previous corresponding period of RMB35.9 million. The increase was mainly due to increase in impairment losses, non-operating expenses, and losses on disposal of subsidiaries recognised in the Reporting Period.

毛利率

截至二零二一年十二月三十一日止年度，本集團毛利率約46%，較去年同期約40%的毛利率上升了6個百分點。該增加主要是由於本期確認的運營收益及金融收益的佔比增加。

其他收入及收益

截至二零二一年十二月三十一日止年度，本集團錄得其他收入及收益人民幣106.6百萬元，較去年同期的人民幣107.2百萬元略有下降。報告期內的金額主要包括政府補助人民幣60.5百萬元，其主要組成部分包括「關於印發《資源綜合利用產品和勞務增值稅優惠目錄》的通知(財稅[2015]78號文)」項下增值稅退稅以及環保補貼、銀行利息收入人民幣2.6百萬元、向第三方及一家合營企業貸款而收取的利息收入人民幣23.6百萬元、外匯交易收益人民幣7.3百萬元、其他投資收入人民幣8.5百萬元。

銷售及分銷開支

截至二零二一年十二月三十一日止年度，本集團銷售及分銷開支為人民幣1.1百萬元，較去年同期的人民幣2.5百萬元大幅減少約56%，乃由於嚴格的管理和成本控制。

行政開支

截至二零二一年十二月三十一日止年度，本集團的行政開支為人民幣246.0百萬元，較去年同期的人民幣217.6百萬元增加約13%。該增加主要是由於員工成本及專業費用的增加。員工成本增加主要是由於污水處理廠運營項目數量的增加。

其他開支

截至二零二一年十二月三十一日止年度，本集團的其他開支為人民幣76.4百萬元，較去年同期的人民幣35.9百萬元大幅增加。該增加主要是由於減值損失、營業外支出和本報告期確認的子公司處置損失增加。

Finance Costs

The Group's finance costs for the year ended 31 December 2021 of RMB565.7 million mainly comprised interests on interest-bearing bank and other borrowings and corporate bonds, representing a slight increase as compared to RMB561.8 million in the previous corresponding period. The increase in finance costs was mainly due to the increase of average interest-bearing bank and other borrowing and corporate bonds. The average balance of interest-bearing bank and other borrowings and corporate bonds increased by RMB180.2 million and the average interest rate was 6.04%, representing a decrease of 0.07 percentage points as compared to that in the previous corresponding period. The decrease in average interest rate was mainly due to the increase in short-term interest-bearing bank and repayment of the corporate bonds. The Group will further seek practical ways to optimize loan structure, expand financing channels and methods and lower the average interest rate in the coming year.

Share of Profits and Losses of Associates

The Group's share of losses of associates for the year ended 31 December 2021 was RMB0.3 million, representing a major decrease as compared to share of losses of associates of RMB2.7 million in the previous corresponding period. The Group will further execute practical ways to reduce the losses brought by the associates.

Share of Profits and Losses of Joint ventures

Share of losses of joint ventures for the year ended 31 December 2021 was RMB2.2 million, representing a major decrease as compared to share of losses of joint ventures of RMB4.8 million in the previous corresponding period. The Group will further execute practical ways to reduce the losses brought by the joint ventures.

Income Tax Expense

Income tax expense for the year ended 31 December 2021 included the current PRC income tax of RMB44.3 million and deferred tax expenses of RMB87.8 million, which were RMB34.2 million and RMB103.1 million for the previous corresponding period, respectively. The Group's effective tax rate for the year ended 31 December 2021 was approximately 24%, representing an increase of 1 percentage points as compared with approximately 23% for the previous corresponding period, which was mainly due to the decrease in effect of lower tax rates for specific provinces or enacted by local authority.

融資成本

截至二零二一年十二月三十一日止年度，本集團的融資成本人民幣565.7百萬元，主要包括計息銀行借款和其他借款及公司債券產生的利息，較去年同期人民幣561.8百萬元略微增加。融資成本增加主要是由於平均計息銀行借款和其他借款及公司債券增加。平均計息銀行借款和其他借款及公司債券餘額增加人民幣180.2百萬元，平均借款利率為6.04%，較去年同期減少0.07個百分點。該平均借款及債券利率的減少主要是由於短期借款增加及公司債券的償還。本集團將進一步尋求可行措施優化貸款結構，拓展融資渠道和方式及降低明年的平均借款及債券利率。

分佔聯營公司溢利及虧損

截至二零二一年十二月三十一日止年度，本集團分佔聯營公司虧損為人民幣0.3百萬元，較去年同期分佔聯營公司虧損人民幣2.7百萬元大幅減少。本集團將進一步執行可行措施以減少聯營公司帶來的虧損。

分佔合營企業溢利及虧損

截至二零二一年十二月三十一日止年度，本集團分佔合營企業虧損為人民幣2.2百萬元，較去年同期分佔聯營公司虧損人民幣4.8百萬元大幅減少。本集團將進一步執行可行措施以減少合營企業帶來的虧損。

所得稅開支

截至二零二一年十二月三十一日止年度的所得稅開支包括當期中國所得稅人民幣44.3百萬元及遞延稅項開支人民幣87.8百萬元，而去年同期分別為人民幣34.2百萬元及人民幣103.1百萬元。本集團截至二零二一年十二月三十一日止年度的實際稅率約為24%，較去年同期的約23%上升1個百分點，主要由於指定省份或當地機關頒佈的較低稅率的影響減少。

Trade and Bills Receivables

As at 31 December 2021, the Group's trade and bills receivables of RMB1,776.6 million (31 December 2020: RMB1,527.0 million) mainly arose from the provision of wastewater treatment and sludge treatment services for Urban Water Treatment projects as well as construction services for the Group's Water Environment Comprehensive Remediation projects. The balance increased by RMB249.6 million, mainly due to (i) the increase in Urban Water Treatment projects receivables of approximately RMB401.1 million, (ii) the net decrease of Water Environment Comprehensive Remediation projects receivables of approximately RMB145.9 million, which included EPC project receivables of approximately RMB46.9 million arising from the progress billing and cash collected from EPC and Build-Transfer projects of approximately RMB192.8 million, and (iii) the increase in Rural Water Improvement projects receivables of approximately RMB10.0 million.

Prepayments, Other Receivables and Other Assets

As at 31 December 2021, the Group's prepayments, other receivables and other assets of RMB855.1 million (31 December 2020: RMB791.2 million) increased by RMB63.9 million, mainly arising from the increase in other operational receivables and accrued interests of approximately RMB140.9 million, the decrease in prepayments and deposits of approximately RMB31.6 million related to the construction of wastewater treatment plants, the decrease in deductible input VAT of approximately RMB24.4 million, and decrease in loans to a third party of approximately RMB10.0 million.

Other Payables and Accruals

As at 31 December 2021, the Group's other payables and accruals of RMB278.2 million (31 December 2020: RMB240.2 million) increased by RMB38.0 million, which was mainly due to the increase in salary and welfare payables, acquisition of non-controlling interests payables, and amounts due to related parties.

Liquidity and Financial Resources

The Group's principal liquidity and capital requirements primarily relate to investments in Urban Water Treatment projects, Water Environment Comprehensive Remediation projects, and Rural Water Improvement projects, merger and acquisition of subsidiaries, costs and expenses related to the operation and maintenance of the Group's facilities, working capital and general corporate purpose.

As at 31 December 2021, the carrying amount of the Group's cash and cash equivalents was RMB289.9 million, representing a decrease of approximately RMB140.4 million as compared to RMB430.3 million as at 31 December 2020, which was mainly due to the net cash inflows of RMB320.2 million from operating activities, the net cash outflows used in financing activities of RMB337.9 million, settlements of acquisition and investing payables of RMB1.8 million and cash outflows of RMB149.4 million for purchases of property, plant and equipment and intangible assets in investing activities, cash outflows of RMB118.3 million for increase in pledged deposits, repurchase of other current financial assets of RMB133.5 million, cash inflows of RMB13.5 million for disposal of subsidiaries from investing activities, and cash inflows of RMB0.4 million for disposal of property, plant and equipment and intangible assets from investing activities.

As at 31 December 2021, the Group's total interest-bearing debts increased to RMB9,469.7 million (31 December 2020: RMB9,272.8 million), which comprised of bank and other borrowings only (31 December 2020: bank and other borrowings of RMB8,688.5 million and corporate bonds of RMB584.3 million). As at 31 December 2021, 66.2% (31 December 2020: 75.6%) of the Group's interest-bearing debts are long term; over 59% of interest-bearing bank and other borrowings bear interest at floating rates.

As at 31 December 2021, the Group had banking facilities amounting to RMB58,417.5 million, of which RMB49,552.6 million have not been utilized. The unutilized amount of RMB49,332.6 million were mainly limited to be utilized on environmental protection infrastructure and comprehensive management.

本集團的主要流動及資本需求主要與投資城鎮水務項目、水環境綜合治理項目及鄉村污水治理項目、合併及收購附屬公司、運營及維護本集團設施相關的成本及開支、營運資金及一般公司用途有關。

於二零二一年十二月三十一日，本集團現金及現金等價物的賬面值為人民幣289.9百萬元，較二零二零年十二月三十一日的人民幣430.3百萬元減少約人民幣140.4百萬元，主要是由於經營活動現金淨流入人民幣320.2百萬元，融資活動現金淨流出人民幣337.9百萬元，就收購付款及支付投資款項人民幣1.8百萬元，投資活動購置物業、廠房及設備以及無形資產的現金流出人民幣149.4百萬元，投資活動抵押存款增加導致現金流出人民幣118.3百萬元，投資活動贖回其他流動金融資產流入人民幣133.5百萬元，投資活動處置附屬公司導致現金流入人民幣13.5百萬元，投資活動處置物業、廠房及設備以及無形資產的現金流入人民幣0.4百萬元。

As at 31 December 2021, the gearing ratio of the Group (calculated by total liabilities divided by total assets) slightly decreased to 70.4%, while the gearing ratio was 71.0% as at 31 December 2020.

Charges on the Group's Assets

Outstanding balance of interest-bearing bank and other borrowings as at 31 December 2021 was approximately RMB9,469.7 million, which were repayable within one month to twenty-four years and were secured by financial receivables, service concession intangible assets, property, plant and equipment, trade receivables, contract assets and pledged deposits of which the total amounts of the pledge of assets amounted to RMB9,286.6 million.

Capital Expenditure

During the year ended 31 December 2021, the Group's total capital expenditure were RMB649.4 million, compared to RMB1,171.0 million in 2020, primarily including the consideration of approximately RMB636.5 million for construction and acquisition of BOT, TOT, BOO and PPP projects and the consideration of approximately RMB11.8 million for acquisition of equity interests in subsidiaries, and an associate.

EMPLOYEES AND REMUNERATION POLICIES

The Group had 2,426 employees as at 31 December 2021. The remuneration package of the Group is generally determined with reference to market conditions and individual performance. Salaries are normally reviewed annually based on performance appraisals and other relevant factors. The Group provides external and internal training programs to its employees.

In respect of pension scheme contributions, the Group adopts a defined contribution plan. The Group's contributions to the defined contribution plan are recognised as expenses when incurred. Forfeited contributions (by employers on behalf of employees who leave the scheme prior to vesting fully in such contributions) may not be used by the Group and its subsidiaries to reduce the existing level of contributions.

CONTINGENT LIABILITIES

As at 31 December 2021, the Group did not have any significant contingent liabilities (31 December 2020: Nil).

FOREIGN EXCHANGE RISK

Majority of the subsidiaries of the Company operate in the PRC with most of the transactions denominated and settled in RMB. As at 31 December 2021, except for the bank deposits and certain amount of interest-bearing bank borrowings denominated in foreign currencies, the Group did not have significant foreign currency exposure from its operations. Currently, the Group has not used derivative financial instruments to hedge its foreign currency risk.

CORPORATE GOVERNANCE PRACTICES

The Group also took initiative to enhance efforts in fund management, financial risk control, project investment decisions, legal risk control, information disclosure and maintenance of investor relationship to strive for more effective and transparent management in accordance with the CG Code.

ACCOUNTABILITY AND AUDIT

The Directors acknowledge their responsibility for preparing the consolidated financial statements of the Company for the year ended 31 December 2021. The Directors consider that the Group has adequate resources to continue in business for the foreseeable future and are not aware of material uncertainties that may cast significant doubt on the Company's ability to continue as a going concern.

The Board is responsible for presenting a balanced, clear and understandable assessment of annual and interim reports, inside information announcements and other disclosures required under the Listing Rules and other statutory and regulatory requirements.

The management has provided to the Board such explanation and information as are necessary to enable the Board to carry out an informed assessment of the Company's consolidated financial statements, which are put to the Board for approval.

RISK MANAGEMENT AND INTERNAL CONTROL

The Board is solely responsible for the risk management and internal control system to protect the interests of the Company and the Shareholders as a whole. To achieve its aim, the Board monitors and approves the strategies and policies of the Group's risk management and internal control systems. The purpose of the relevant strategies and policies is to evaluate and determine the nature and extent of risks to make it suitable for the Group's strategic objectives and risk endurance. The main target is to provide reasonable assurance against material misstatement or loss, rather than eliminate the risk of failure to achieve business objectives. To this end, management continues to allocate resources for an internal control and risk management system compatible with the COSO (Committee of Sponsoring Organizations of the Treadway Commission) standards to provide reasonable, though not absolute, assurance against material misstatement or loss and to manage rather than eliminate the risk of failure in the operating system of the Group and in achieving business objectives by the Group.

The Board, through the Audit Committee, has continuously monitored and annually reviewed the effectiveness of risk management and internal control system of the Group and its subsidiaries, and is of the view that the existing risk management and internal control system is sufficient and effective. The review covered all material aspects with regard to control, including financial control, operational control and compliance control. The internal audit reports submitted to the Audit Committee by the Group also covered aspects of risk management and internal control. The Board is not aware of any significant areas of concern which may affect the Shareholders, and believes that the Group has fully complied with the code provisions on internal controls, including compliance with legal and regulatory requirements, as set forth in the CG Code. The Board, through the appraisal performed by the Audit Committee, reviewed the adequacy of resources, staff qualifications and experience, training programs received by the staff and budget of the Group's accounting, internal auditing and financial reporting function at the Board meeting. In light of the Group's nature of business and the recommendations on the Board's role in risk management, the Group has developed risk management system and policies, and established a risk control department, which is responsible for the Group's risk management, to communicate and assess the Group's risk profile and material risks, and track the progress of mitigation plans and initiatives of material risks and report on detailed examinations of specific risks as required.

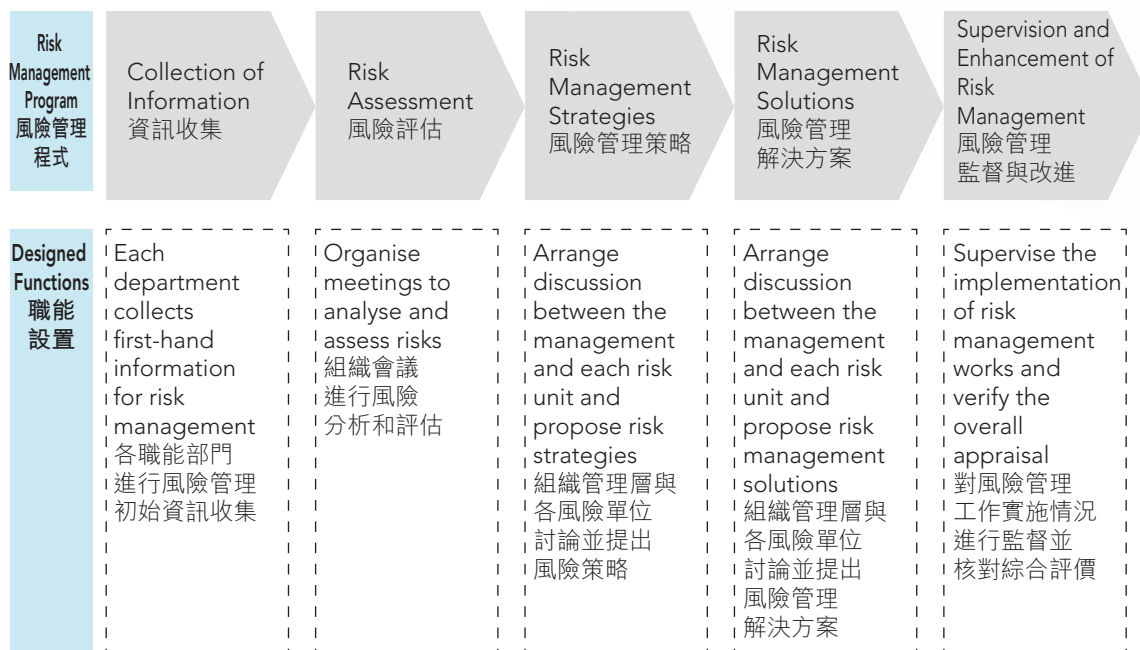

SUPERVISION AND ENHANCEMENT OF RISK MANAGEMENT

The Group has set up basic procedures that cover the whole process of risk management, connecting the channels of communication of risk management information along the reporting lines and among various departments and business units to ensure timely, accurate and complete sharing of information and this has laid the foundation for the supervision and enhancement of risk management.

The senior management of the Group, focusing on material risks, material matters and material decisions, important management matters and the business flow, supervises the work relating to the first-hand information collection for risk management, risk assessment, risk management strategies, critical control activities and the implementation of risk management solutions. The internal audit and inspection department carries out an annual review and examination on the implementation of the works on risk management by different departments and business units and its effectiveness for the year, assesses risk management strategies and evaluates inter-departmental risk management solutions and business units' risk management solutions, proposes suggestions for adjustments and recommendations for improvements and issues evaluation and recommendation reports which will be sent to the relevant senior management in a timely manner.

MATERIAL RISKS THE GROUP MAY FACE

In 2021, during the course of business planning, we identified material risks that the Group may face which include risk of delayed collection, risk of breach of agreement by governments, risk in relation to short-term borrowing solvency, risk in relation to amount of water intake and water quality and risk in relation to litigation disputes.

The potential risk of delayed collection arises from the impact of the general market environment, the inability of the government to pay large sums due to financial constraints, resulting in damage to the Company's interests and extension of the collection period. The Group's corresponding measures on such risk include maintaining good relationship with the government, and urging the operating subsidiaries to duly complete regular reconciliation.

風險管理的監督與改進

本集團已建立貫穿於整個風險管理基本流程，連接各上下級、各部門和業務單位的風險管理資訊溝通管道，確保資訊溝通的及時、準確、完整，為風險管理監督與改進奠定基礎。

本集團的高級管理層以重大風險、重大事件和重大決策、重要管理及業務流程為重點，對風險管理初始資訊收集、風險評估、風險管理策略、關鍵控制活動及風險管理解決方案的實施情況進行監督。內審稽核部每年組織對各部門和業務單位風險管理工作實施情況和有效性進行一次年度檢查和檢驗，對風險管理策略進行評估，對跨部門和業務單位的風險管理解決方案進行評價，提出調整或改進建議，出具評價和建議報告，及時報送相關高級管理層。

本集團可能面臨的重大風險

於二零二一年，我們在業務規劃過程中識別本集團可能面臨的重大風險包括延期收款風險、政府違約風險、短期借款償債能力風險、進水水量及水質風險及訴訟糾紛風險。

延期收款的潛在風險的產生原因為由於市場大環境影響，政府財政緊縮導致無法支付大筆款項導致公司利益受損，收款期延長。本集團應對有關風險的措施包括與政府保持良好關係，並督促運營子公司做好定期對帳工作。

The potential risk of breach of agreement by governments arises from economic losses due to fiscal stress of local government and unilateral non-compliance with stipulated terms. The Group's corresponding measures on such risk include maintaining good communication with local governments and entering into cooperation memorandum for follow-up and coordination.

The potential risk in relation to short-term borrowing solvency arises from the rapid development of the Company, causing a lack of liquidity, unreasonable debt structure, lack of financing ability and excessive cost of capital acquisition. The Group's corresponding measures on such risk include enhancing profitability and operating cash flow, improving quality of asset, optimizing debt structure and formulating reasonable debt repayment plans.

The potential risk in relation to the amount of water intake and water quality arises from lack of proper monitoring of water quality and timely adjustment of technique, resulting in a larger difference in the amount of water and non-compliance with intake water quality. The Group's corresponding measures on such risk include in-depth research on government planning, enhancing the monitoring of intake water quality and timely adjustment of technique based on water intake.

The potential risk in relation to litigation disputes arises from the incomprehensive dispute resolution mechanism, not solving disputes by making full use of litigation / arbitration or insufficient awareness on monitoring disputes. As a result, the Company loses the best timing to deal with disputes. The Group's corresponding measures on such risk include formulating a comprehensive dispute resolution mechanism, seeking assistance from professionals, dealing with disputes by means of litigation / arbitration, monitoring and properly handling disputes.

政府違約的潛在風險的產生原因為地方財政緊張或單方面未按規定條款執行而造成的經濟損失。本集團應對有關風險的措施包括與地方政府保持良好溝通，及簽訂合作備忘錄跟進協調。

短期借款償債能力的潛在風險的產生原因為公司發展迅速，導致資金流動性匱乏，負債結構不合理，融資能力不足及資金獲取成本過高。本集團應對有關風險的措施包括提高盈利能力與經營現金流量水平，提高資產質量，優化債務結構並制定合理償債計劃。

進水水量及水質的潛在風險的產生原因為進水水質監測不到位，工藝調整不合時，導致水量差異較大，水質不達標。本集團應對有關風險的措施包括深入研究政府規劃，加強進水水質監測，並及時根據進水情況調整工藝。

訴訟糾紛的潛在風險的產生原因為糾紛處理機制不完善，未充分運用訴訟／仲裁手段解決糾紛，或對糾紛事項監測關注不足，導致公司喪失最佳應對時機。本集團應對有關風險的措施包括完善糾紛應對機制，尋求專業人士協助及運用訴訟／仲裁處理糾紛，監測糾紛事項並妥善處置。

On 25 September 2020, Kangda Investment (Hong Kong) Company Limited ("Kangda Investment (Hong Kong)"), an indirectly wholly-owned subsidiary of the Company, entered into a framework construction services agreement (the "Construction Services Agreement") with Jiangxi Silver Dragon, pursuant to which, the parties agreed that Jiangxi Silver Dragon may be selected to provide civil works, construction, installation works and supply of equipment for projects of the Group relating to the construction, upgrading, reconstruction and expansion of wastewater treatment facilities through a tender process in compliance with the applicable laws and regulations in the PRC. The term of the Construction Services Agreement commenced from the date of the Construction Services Agreement and ending on 31 December 2022. Jiangxi Silver Dragon is a non-wholly owned subsidiary of China Water, a substantial shareholder of the Company. Therefore, Jiangxi Silver Dragon is an associate of China Water and a connected person of the Company. The transactions in relation to the Construction Services Agreement constitute continuous connected transactions of the Company under Chapter 14A of the Listing Rules, and the Company's independent shareholders approved the continuing connected transactions in relation to the Construction Service Agreement in the extraordinary general meeting of the Company held on 16 November 2020. The annual caps under the Construction Services Agreement for the period commenced from the date of the Construction Services Agreement and ended on 31 December 2020 and years ending 31 December 2021 and 2022 are RMB180 million, RMB300 million and RMB300 million, respectively. The Company has complied with the disclosure requirements in accordance with the Listing Rules. Further details of the Construction Services Agreement were set out in the announcement of the Company dated 25 September 2020 and circular dated 30 October 2020.

2.1 BASIS OF PREPARATION

These financial statements have been prepared in accordance with International Financial Reporting Standards (“IFRSs”) (which include all International Financial Reporting Standards, International Accounting Standards (“IASs”) and Interpretations) issued by the International Accounting Standards Board (“IASB”), accounting principles generally accepted in Hong Kong and the disclosure requirements of the Hong Kong Companies Ordinance.

The financial statements have been prepared under the historical cost convention, except for equity investments designed at fair value through other comprehensive income which have been measured at fair value. These financial statements are presented in Renminbi (“RMB”) and all values are rounded to the nearest thousand except when otherwise indicated.

Going concern

As at 31 December 2021, the Group’s current liabilities exceeded its current assets by approximately RMB185,439,000 (31 December 2020: net current assets: RMB293,821,000). In addition, the Group has contracted capital commitments of RMB198,144,000 and commitments in respect of service concession arrangements of RMB2,442,938,000. Part of such commitments is expected to be due in the foreseeable future. The directors of the Company have considered the Group’s available sources of funds as at the date of approval of these consolidated financial statements, which are as follows:

- Unutilised banking facilities available to the Group that the directors of the Company are confident of them being able to be continuously renewed upon their respective expirations in the foreseeable future based on the Group’s past experience and good credit standing;
- Unutilised facilities to issue domestic short-term notes by the Group as approved by the relevant PRC government authorities;
- Cash inflows arising from the Group’s activities subsequent to 31 December 2021; and
- Other available sources of financing from banks, financial institutions and other institutions given the Group’s credit history.

In light of the available funding as mentioned above, and after taking into account the operating performance of the Group and cash flow projection prepared by the directors of the Company. The directors of the Company are confident that the Group will have sufficient working capital to meet with its financial obligations and operation requirements in the foreseeable future of at least up to 31 December 2022. Hence the directors of the Company are of the opinion that it is appropriate to prepare these consolidated financial statements under the going concern basis.

Basis of consolidation

The consolidated financial statements include the financial statements of the Group for the year ended 31 December 2021. A subsidiary is an entity (including a structured entity), directly or indirectly, controlled by the Company. Control is achieved when the Group is exposed, or has rights, to variable returns from its involvement with the investee and has the ability to affect those returns through its power over the investee (i.e., existing rights that give the Group the current ability to direct the relevant activities of the investee).

When the Company has, directly or indirectly, less than a majority of the voting or similar rights of an investee, the Group considers all relevant facts and circumstances in assessing whether it has power over an investee, including:

- (a) the contractual arrangement with the other vote holders of the investee;
- (b) rights arising from other contractual arrangements; and
- (c) the Group's voting rights and potential voting rights.

The financial statements of the subsidiaries are prepared for the same reporting period as the Company, using consistent accounting policies. The results of subsidiaries are consolidated from the date on which the Group obtains control, and continue to be consolidated until the date that such control ceases.

Profit or loss and each component of other comprehensive income are attributed to the owners of the parent of the Group and to the non-controlling interests, even if this results in the non-controlling interests having a deficit balance. All intra-group assets and liabilities, equity, income, expenses and cash flows relating to transactions between members of the Group are eliminated in full on consolidation.

The Group reassesses whether or not it controls an investee if facts and circumstances indicate that there are changes to one or more of the three elements of control described above. A change in the ownership interest of a subsidiary, without a loss of control, is accounted for as an equity transaction.

If the Group loses control over a subsidiary, it derecognises (i) the assets (including goodwill) and liabilities of the subsidiary, (ii) the carrying amount of any non-controlling interest and (iii) the cumulative translation differences recorded in equity; and recognises (i) the fair value of the consideration received, (ii) the fair value of any investment retained and (iii) any resulting surplus or deficit in profit or loss. The Group's share of components previously recognised in other comprehensive income is reclassified to profit or loss or retained profits, as appropriate, on the same basis as would be required if the Group had directly disposed of the related assets or liabilities.

The nature and the impact of the revised IFRSs are described below:

- (a) Amendments to IFRS 9, IAS 39, IFRS 7, IFRS 4 and IFRS 16 address issues not dealt with in the previous amendments which affect financial reporting when an existing interest rate benchmark is replaced with an alternative risk-free rate ("RFR"). The Phase 2 amendments provide a practical expedient to allow the effective interest rate to be updated without adjusting the carrying amount of financial assets and liabilities when accounting for changes in the basis for determining the contractual cash flows of financial assets and liabilities, if the change is a direct consequence of the interest rate benchmark reform and the new basis for determining the contractual cash flows is economically equivalent to the previous basis immediately preceding the change. In addition, the amendments permit changes required by the interest rate benchmark reform to be made to hedge designations and hedge documentation without the hedging relationship being discontinued. Any gains or losses that could arise on transition are dealt with through the normal requirements of IFRS 9 to measure and recognise hedge ineffectiveness. The amendments also provide a temporary relief to entities from having to meet the separately identifiable requirement when an RFR is designated as a risk component. The relief allows an entity, upon designation of the hedge, to assume that the separately identifiable requirement is met, provided the entity reasonably expects the RFR risk component to become separately identifiable within the next 24 months. Furthermore, the amendments require an entity to disclose additional information to enable users of financial statements to understand the effect of interest rate benchmark reform on an entity's financial instruments and risk management strategy.

經修訂國際財務報告準則之性質及影響說明如下：

- (a) 當現行利率基準以其他無風險利率(「無風險利率」)替代時會影響財務報告時，國際財務報告準則第9號、國際會計準則第39號、國際財務報告準則第7號、國際財務報告準則第4號及國際財務報告準則第16號(修訂本)解決先前修訂中未涉及的問題。第二階段修訂本提供實際權宜方法，於入賬釐定金融資產及負債合約現金流量的基準變動時，倘變動因利率基準改革直接引致，且釐定合約現金流量的新基準經濟上相當於緊接變動前的先前基準，在不調整金融資產及負債賬面值的情況下更新實際利率。此外，該等修訂本允許利率基準改革要求就對沖名稱及對沖文件作出的變動，而不中斷對沖關係。過渡期間可能產生的任何損益均透過國際財務報告準則第9號的正常要求進行處理，以計量及確認對沖無效性。當無風險利率被指定為風險組成部分時，該等修訂本亦暫時寬免實體須符合可單獨識別的規定。寬免允許實體於指定對沖時假設符合可單獨識別的規定，前提是實體合理預期無風險利率風險成分於未來24個月內將可單獨識別。此外，該等修訂本亦要求實體披露其他資料，以使財務報表的使用者能夠了解利率基準改革對實體金融工具及風險管理策略的影響。

The Group had certain interest-bearing bank borrowings denominated in United States dollars based on the London Interbank Offered Rate ("LIBOR") as at 31 December 2021. For the LIBOR-based borrowings, since the interest rates of these instruments were not replaced by RFRs during the year, the amendments did not have any impact on the financial position and performance of the Group. If the interest rates of these borrowings are replaced by RFRs in a future period, the Group will apply the above-mentioned practical expedient upon the modification of these instruments provided that the "economically equivalent" criterion is met. Additional information about the transition and the associated risks is disclosed in note 39 to the financial statements.

(b) Amendment to IFRS 16 issued in April 2021 extends the availability of the practical expedient for lessees to elect not to apply lease modification accounting for rent concessions arising as a direct consequence of the covid-19 pandemic by 12 months. Accordingly, the practical expedient applies to rent concessions for which any reduction in lease payments affects only payments originally due on or before 30 June 2022, provided the other conditions for applying the practical expedient are met. The amendment is effective retrospectively for annual periods beginning on or after 1 April 2021 with any cumulative effect of initially applying the amendment recognised as an adjustment to the opening balance of retained profits at the beginning of the current accounting period. Earlier application is permitted.

The Group has early adopted the amendment on 1 January 2021. However, the Group has not received covid-19-related rent concessions and plans to apply the practical expedient when it becomes applicable within the allowed period of application.

本集團於二零二一年十二月三十一日持有根據倫敦銀行同業拆息(「倫敦銀行同業拆息」)以美元計值的若干計息銀行借貸。就以倫敦銀行同業拆息為基礎的借貸而言，由於年內並無以無風險利率替代該等借貸的利率，該等修訂本對本集團的財務狀況及表現概無任何影響。倘該等借貸的利率於未來期間以無風險利率替代，本集團將於修改有關工具時採用上述實際權宜方法，惟須滿足「經濟上相當」的標準。有關過渡期及相關風險的更多資料於財務報表附註39中披露。

(b) 二零二一年四月頒佈的國際財務報告準則第16號(修訂本)將承租人可選擇實際權宜方法而不採用租賃變更的方法來核算因COVID-19疫情直接導致的租金寬減延長了12個月。因此，在滿足應用實際權宜方法的其他條件下，實際權宜方法適用於租金的寬減為原定於二零二二年六月三十日前到期的租賃付款額。該修訂本適用於二零二一年四月一日或之後開始的年度期間，且追溯應用，並將首次應用該修訂本之累計影響確認為目前會計期間開始時對期初留存溢利結餘作出的調整。該修訂本允許提前應用。

本集團已於二零二一年一月一日提早採納該修訂本。然而，本集團尚未收到COVID-19相關租金寬減，並計劃在允許的適用期限內適用時採用實際權宜方法。

Further information about those IFRSs that are expected to be applicable to the Group is described below.

Amendments to IFRS 3 are intended to replace a reference to the previous *Framework for the Preparation and Presentation of Financial Statements* with a reference to the *Conceptual Framework for Financial Reporting* issued in March 2018 without significantly changing its requirements. The amendments also add to IFRS 3 an exception to its recognition principle for an entity to refer to the Conceptual Framework to determine what constitutes an asset or a liability. The exception specifies that, for liabilities and contingent liabilities that would be within the scope of IAS 37 or IFRIC 21 if they were incurred separately rather than assumed in a business combination, an entity applying IFRS 3 should refer to IAS 37 or IFRIC 21 respectively instead of the Conceptual Framework. Furthermore, the amendments clarify that contingent assets do not qualify for recognition at the acquisition date. The Group expects to adopt the amendments prospectively from 1 January 2022. Since the amendments apply prospectively to business combinations for which the acquisition date is on or after the date of first application, the Group will not be affected by these amendments on the date of transition.

Amendments to IFRS 10 and IAS 28 address an inconsistency between the requirements in IFRS 10 and in IAS 28 in dealing with the sale or contribution of assets between an investor and its associate or joint venture. The amendments require a full recognition of a gain or loss resulting from a downstream transaction when the sale or contribution of assets between an investor and its associate or joint venture constitutes a business. For a transaction involving assets that do not constitute a business, a gain or loss resulting from the transaction is recognised in the investor's profit or loss only to the extent of the unrelated investor's interest in that associate or joint venture. The amendments are to be applied prospectively. The previous mandatory effective date of amendments to IFRS 10 and IAS 28 was removed by the IASB in December 2015 and a new mandatory effective date will be determined after the completion of a broader review of accounting for associates and joint ventures. However, the amendments are available for adoption now.

國際財務報告準則第3號(修訂本)旨在以二零一八年三月發佈財務報告概念框架的提述取代先前的編製及呈列財務報表的提述，而無需重大改變其要求。該等修訂亦為國際財務報告準則第3號增加確認原則的例外，實體可參考概念框架釐定資產或負債的構成要素。該例外情況規定，對於單獨而非於業務合併中承擔且屬於國際會計準則第37號或國際財務報告詮釋委員會第21號的負債及或然負債，採用國際財務報告準則第3號的實體應分別提述國際會計準則第37號或國際財務報告詮釋委員會第21號，而非概念框架。此外，該等修訂澄清或然資產於收購日期不符合確認資格。本集團預期自二零二二年一月一日起前瞻採用該等修訂。由於該等修訂可能對收購日期為首次採納日期或之後的業務合併前瞻性採納，本集團於過渡日期將不會受到該等修訂的影響。

國際財務報告準則第10號及國際會計準則第28號(修訂本)針對國際財務報告準則第10號及國際會計準則第28號之間有關投資者與其聯營公司或合營公司之間資產出售或注資兩者規定之不一致情況。該等修訂規定，當投資者與其聯營公司或合營公司之間的資產出售或注資構成一項業務時，須全數確認下游交易產生的收益或虧損。當交易涉及不構成一項業務之資產時，由該交易產生之收益或虧損於該投資者之損益內確認，惟僅以不相關投資者於該聯營公司或合營公司之權益為限。該等修訂已前瞻應用。國際會計準則理事會已於二零一五年十二月剔除國際財務報告準則第10號及國際會計準則第28號(修訂本)的以往強制生效日期，而新的強制生效日期將於對聯營公司及合營公司的會計處理完成更廣泛的檢討後釐定。然而，該等修訂現時可供採納。

IFRS 17 is a comprehensive new accounting standard for insurance contracts covering recognition and measurement, presentation and disclosure. Once effective, IFRS 17 will replace the existing IFRS 4 *Insurance Contracts*. The standard applies to all types of insurance contracts (i.e., life, non-life, direct insurance and re-insurance), regardless of the type of entities that issue them, as well as to certain guarantees and financial instruments with discretionary participation features. A few scope exceptions will apply. The overall objective of the standard is to provide an accounting model for insurance contracts that is more useful and consistent for insurers. In contrast to the requirements in IFRS 4, which are largely based on grandfathering previous local accounting policies, the standard provides a comprehensive model for insurance contracts, covering all relevant accounting aspects. The core of the standard is the general model, supplemented by:

- a specific adaptation for contracts with direct participation features (the variable fee approach); and
- a simplified approach (the premium allocation approach) mainly for short-duration contracts.

IFRS 17 is effective for reporting periods beginning on or after 1 January 2023. Early application is permitted, provided the entity also applies IFRS 9 and IFRS 15 on or before the date it first applies IFRS 17. The standard is not expected to have any impact on the Group.

Amendments to IFRS 17 include changes to simplify certain requirements in the standard and make financial performance easier to explain. The amendments also provide additional reliefs to reduce the effort required for the transition to IFRS 17. In addition, the amendments defer the effective date of IFRS 17 to annual reporting periods beginning on or after 1 January 2023 with earlier application permitted. As a result of the deferral, the IASB issued the amendments to IFRS 4 to extend the temporary exemption that permits insurers to apply IAS 39 rather than IFRS 9 for annual periods beginning before 1 January 2023. The amendments are not expected to have any impact on the Group.

國際財務報告準則第17號為一項綜合性的全新的適用於保險合約的會計準則，包含了確認及計量、呈列及披露。國際財務報告準則第17號一旦生效將取代現有國際財務報告準則第4號保險合約。該準則適用於各類保險合約(如壽險、非壽險、直接保險及再保險)，不論該等合約是由何類實體簽發的，同時亦適用於具有相機分紅特徵的部分擔保合約及金融工具。存在少數適用範圍例外的情形。該準則的總體目標是為保險人提供一個更實用和更一致的保險合約會計模型。相對於國際財務報告準則第4號(該準則主要沿用過往地方會計政策)的規定，該準則為保險合約提供一套綜合性模型，涵蓋所有相關會計方面。該準則的核心為一般模型，由以下各項進行補充：

- 具有直接分紅特徵的合約的特定模型(浮動收費法)；及
- 主要適用於短期合約的簡化模型(保費分配法)。

國際財務報告準則第17號於二零二三年一月一日或之後開始的報告期間生效。若實體於首次應用國際財務報告準則第17號當日或之前亦應用國際財務報告準則第9號及國際財務報告準則第15號，則可提早應用國際財務報告準則第17號。該準則預期將不會對貴集團造成任何影響。

國際財務報告準則第17號(修訂本)旨在對準則中的部分要求進行簡化，並使財務業績更易於解釋。該等修訂亦提供額外豁免，以減少企業在國際財務報告準則第17號過渡期間的工作量。此外，該等修訂自二零二三年一月一日起或之後開始的報告期間生效，並允許提早採用。由於推遲，國際會計準則理事會發佈了國際財務報告準則第4號修訂案，以延長臨時豁免時間，允許保險公司在二零二三年一月一日之前開始的報告期間採用國際會計準則第39號以代替國際財務報告準則第9號。該等修訂預期不會對本集團產生任何影響。

Amendments to IAS 1 *Classification of Liabilities as Current or Non-current* clarify the requirements for classifying liabilities as current or non-current. The amendments specify that if an entity's right to defer settlement of a liability is subject to the entity complying with specified conditions, the entity has a right to defer settlement of the liability at the end of the reporting period if it complies with those conditions at that date. Classification of a liability is unaffected by the likelihood that the entity will exercise its right to defer settlement of the liability. The amendments also clarify the situations that are considered a settlement of a liability. The amendments are effective for annual periods beginning on or after 1 January 2023 and shall be applied retrospectively. Earlier application is permitted. The amendments are not expected to have any significant impact on the Group's financial statements.

Amendments to IAS 1 *Disclosure of Accounting Policies* require entities to disclose their material accounting policy information rather than their significant accounting policies. Accounting policy information is material if, when considered together with other information included in an entity's financial statements, it can reasonably be expected to influence decisions that the primary users of general purpose financial statements make on the basis of those financial statements. Amendments to IFRS Practice Statement 2 provide non-mandatory guidance on how to apply the concept of materiality to accounting policy disclosures. Amendments to IAS 1 are effective for annual periods beginning on or after 1 January 2023 and earlier application is permitted. Since the guidance provided in the amendments to IFRS Practice Statement 2 is non-mandatory, an effective date for these amendments is not necessary. The Group is currently assessing the impact of the amendments on the Group's accounting policy disclosures.

國際會計準則第1號(修訂本)披露會計政策要求企業披露重要會計政策信息，而非重大會計政策。倘連同實體財務報表內其他資料一併考慮，會計政策資料可以合理預期會影響通用財務報表的主要使用者根據該等財務報表所作出的決定，則該會計政策資料屬重大。國際財務報告準則實務公告2號(修訂本)就如何將重要性的概念應用於會計政策披露提供非強制性指引。國際會計準則第1號(修訂本)於二零二三年或之後開始之年度期間生效，並允許提前採納。由於國際財務報告準則實務公告2號(修訂本)中所提供的指引為非強制性，因此該等修訂本的生效日期並非必要。本集團目前正評估該等修訂本對本集團會計政策披露的影響。

Amendments to IAS 8 clarify the distinction between changes in accounting estimates and changes in accounting policies. Accounting estimates are defined as monetary amounts in financial statements that are subject to measurement uncertainty. The amendments also clarify how entities use measurement techniques and inputs to develop accounting estimates. The amendments are effective for annual reporting periods beginning on or after 1 January 2023 and apply to changes in accounting policies and changes in accounting estimates that occur on or after the start of that period. Earlier application is permitted. The amendments are not expected to have any significant impact on the Group's financial statements.

Amendments to IAS 12 narrow the scope of the initial recognition exception so that it no longer applies to transactions that give rise to equal taxable and deductible temporary differences, such as leases and decommissioning obligations. Therefore, entities are required to recognise a deferred tax asset and a deferred tax liability for temporary differences arising from these transactions. The amendments are effective for annual reporting periods beginning on or after 1 January 2023 and shall be applied to transactions related to leases and decommissioning obligations at the beginning of the earliest comparative period presented, with any cumulative effect recognised as an adjustment to the opening balance of retained profits or other component of equity as appropriate at that date. In addition, the amendments shall be applied prospectively to transactions other than leases and decommissioning obligations. Earlier application is permitted.

The Group has applied the initial recognition exception and did not recognise a deferred tax asset and a deferred tax liability for temporary differences for transactions related to leases. Upon initial application of these amendments, the Group will recognise a deferred tax asset and a deferred tax liability for deductible and taxable temporary differences associated with right-of-use assets and lease liabilities, and recognise the cumulative effect of initially applying the amendments as an adjustment to the opening balance of retained profits at the beginning of the earliest comparative period presented.

國際會計準則第8號(修訂本)澄清會計政策估計變動與會計政策變動之間的區別。會計估計的定義為在計量不明朗因素的財務報表之貨幣金額。該等修訂亦澄清實體如何使用計量技巧及輸入以制定會計估計。該等修訂於二零二三年或之後開始之年度期間生效，並適用於該期間開始時或之後發生的會計政策變動及會計估計變動，且允許提前採納。預計該等修訂將不會對本集團的財務報表產生任何重大影響。

國際會計準則第12號(修訂本)縮小初始確認豁免範圍，使其不再適用於產生相等的應課稅及可扣減暫時差異的交易，如租賃及退役責任。因此，實體被要求就該等交易產生的暫時差異確認遞延稅項資產及遞延稅項負債。該等修訂於二零二三年或之後開始之年度期間生效，並於最早呈現的比較期開始時適用於與租賃及退役責任有關的交易，任何累計影響於該日確認為對保留溢利的期初結餘或權益的其他組成部分(如適用)的調整。此外，該等修訂將預先應用於租賃及退役責任以外的交易，且允許提前採納。

本集團已採用初始確認豁免，並無就與租賃有關的交易的暫時差異確認遞延稅項資產及遞延稅項負債。首次採納該等修訂時，本集團將就與使用權資產及租賃負債有關的可扣減及應課稅暫時差異確認遞延稅項資產及遞延稅項負債，並確認首次採納該等修訂的累計影響，作為對最早呈現的比較期初保留溢利結餘的調整。

Amendments to IAS 16 prohibit an entity from deducting from the cost of an item of property, plant and equipment any proceeds from selling items produced while bringing that asset to the location and condition necessary for it to be capable of operating in the manner intended by management. Instead, an entity recognises the proceeds from selling any such items, and the cost of those items, in profit or loss. The amendments are effective for annual periods beginning on or after 1 January 2022 and shall be applied retrospectively only to items of property, plant and equipment made available for use on or after the beginning of the earliest period presented in the financial statements in which the entity first applies the amendments. Earlier application is permitted. The amendments are not expected to have any significant impact on the Group's financial statements.

Amendments to IAS 37 clarify that for the purpose of assessing whether a contract is onerous under IAS 37, the cost of fulfilling the contract comprises the costs that relate directly to the contract. Costs that relate directly to a contract include both the incremental costs of fulfilling that contract (e.g., direct labour and materials) and an allocation of other costs that relate directly to fulfilling that contract (e.g., an allocation of the depreciation charge for an item of property, plant and equipment used in fulfilling the contract as well as contract management and supervision costs). General and administrative costs do not relate directly to a contract and are excluded unless they are explicitly chargeable to the counterparty under the contract. The amendments are effective for annual periods beginning on or after 1 January 2022 and shall be applied to contracts for which an entity has not yet fulfilled all its obligations at the beginning of the annual reporting period in which it first applies the amendments. Earlier application is permitted. Any cumulative effect of initially applying the amendments shall be recognised as an adjustment to the opening equity at the date of initial application without restating the comparative information. The amendments are not expected to have any significant impact on the Group's financial statements.

Annual Improvements to IFRS Standards 2018–2020 sets out amendments to IFRS 1, IFRS 9, Illustrative Examples accompanying IFRS 16, and IAS 41. Details of the amendments that are expected to be applicable to the Group are as follows:

- IFRS 9 *Financial Instruments*: clarifies the fees that an entity includes when assessing whether the terms of a new or modified financial liability are substantially different from the terms of the original financial liability. These fees include only those paid or received between the borrower and the lender, including fees paid or received by either the borrower or lender on the other's behalf. An entity applies the amendment to financial liabilities that are modified or exchanged on or after the beginning of the annual reporting period in which the entity first applies the amendment. The amendment is effective for annual periods beginning on or after 1 January 2022. Earlier application is permitted. The amendment is not expected to have a significant impact on the Group's financial statements.
- IFRS 16 *Leases*: removes the illustration of payments from the lessor relating to leasehold improvements in Illustrative Example 13 accompanying IFRS 16. This removes potential confusion regarding the treatment of lease incentives when applying IFRS 16.

Investments in associates and joint ventures

An associate is an entity in which the Group has a long term interest of generally not less than 20% of the equity voting rights and over which it is in a position to exercise significant influence. Significant influence is the power to participate in the financial and operating policy decisions of the investee, but is not control or joint control over those policies.

A joint venture is a type of joint arrangement whereby the parties that have joint control of the arrangement have rights to the net assets of the joint venture. Joint control is the contractually agreed sharing of control of an arrangement, which exists only when decisions about the relevant activities require the unanimous consent of the parties sharing control.

The Group's investments in associates and joint ventures are stated in the consolidated statement of financial position at the Group's share of net assets under the equity method of accounting, less any impairment losses. Adjustments are made to bring into line any dissimilar accounting policies that may exist.

The Group's share of the post-acquisition results and other comprehensive income of associates and joint ventures is included in the consolidated statement of profit or loss and other comprehensive income. In addition, when there has been a change recognised directly in the equity of the associate or joint venture, the Group recognises its share of any changes, when applicable, in the consolidated statement of changes in equity. Unrealised gains and losses resulting from transactions between the Group and its associates or joint ventures are eliminated to the extent of the Group's investments in the associates or joint ventures, except where unrealised losses provide evidence of an impairment of the assets transferred. Goodwill arising from the acquisition of associates or joint ventures is included as part of the Group's investments in associates or joint ventures.

If an investment in an associate becomes an investment in a joint venture or vice versa, the retained interest is not remeasured. Instead, the investment continues to be accounted for under the equity method. In all other cases, upon loss of significant influence over the associate or joint control over the joint venture, the Group measures and recognises any retained investment at its fair value. Any difference between the carrying amount of the associate or joint venture upon loss of significant influence or joint control and the fair value of the retained investment and proceeds from disposal is recognised in profit or loss.

When an investment in an associate or a joint venture is classified as held for sale, it is accounted for in accordance with IFRS 5 *Non-current Assets Held for Sale and Discontinued Operations*.

Business combinations and goodwill

Business combinations are accounted for using the acquisition method. The consideration transferred is measured at the acquisition date fair value which is the sum of the acquisition date fair values of assets transferred by the Group, liabilities assumed by the Group to the former owners of the acquiree and the equity interests issued by the Group in exchange for control of the acquiree. For each business combination, the Group elects whether to measure the non-controlling interests in the acquiree that are present ownership interests and entitle their holders to a proportionate share of net assets in the event of liquidation at fair value or at the proportionate share of the acquiree's identifiable net assets. All other components of non-controlling interests are measured at fair value. Acquisition-related costs are expensed as incurred.

The Group determines that it has acquired a business when the acquired set of activities and assets includes an input and a substantive process that together significantly contribute to the ability to create outputs.

When the Group acquires a business, it assesses the financial assets and liabilities assumed for appropriate classification and designation in accordance with the contractual terms, economic circumstances and pertinent conditions as at the acquisition date. This includes the separation of embedded derivatives in host contracts of the acquiree.

業務合併使用收購法入賬。轉讓代價按收購日期的公平值計量，該公平值為本集團於收購日期所轉資產的公平值、本集團向被收購方的原擁有人承擔的負債及本集團就換取被收購方控制權而發行的股本權益的總和。就各項業務合併而言，本集團選擇是否以公平值或於被收購方可識別資產淨值的應佔比例，計量於被收購方的非控股權益，即賦予持有人在清盤時按比例分佔資產淨值的現有擁有權權益。非控股權益的所有其他組成部分均按公平值計量。收購相關成本於產生時列為開支。

If the business combination is achieved in stages, the previously held equity interest is remeasured at its acquisition date fair value and any resulting gain or loss is recognised in profit or loss.

Any contingent consideration to be transferred by the acquirer is recognised at fair value at the acquisition date. Contingent consideration classified as an asset or liability is measured at fair value with changes in fair value recognised in profit or loss. Contingent consideration that is classified as equity is not remeasured and subsequent settlement is accounted for within equity.

Goodwill is initially measured at cost, being the excess of the aggregate of the consideration transferred, the amount recognised for non-controlling interests and any fair value of the Group's previously held equity interests in the acquiree over the identifiable assets acquired and liabilities assumed. If the sum of this consideration and other items is lower than the fair value of the net assets acquired, the difference is, after reassessment, recognised in profit or loss as a gain on bargain purchase.

After initial recognition, goodwill is measured at cost less any accumulated impairment losses. Goodwill is tested for impairment annually or more frequently if events or changes in circumstances indicate that the carrying value may be impaired. The Group performs its annual impairment test of goodwill as at 31 December. For the purpose of impairment testing, goodwill acquired in a business combination is, from the acquisition date, allocated to each of the Group's cash-generating units, or groups of cash-generating units, that are expected to benefit from the synergies of the combination, irrespective of whether other assets or liabilities of the Group are assigned to those units or groups of units.

Impairment is determined by assessing the recoverable amount of the cash-generating unit (or group of cash-generating units) to which the goodwill relates. Where the recoverable amount of the cash-generating unit (or group of cash-generating units) is less than the carrying amount, an impairment loss is recognised. An impairment loss recognised for goodwill is not reversed in a subsequent period.

Where goodwill has been allocated to a cash-generating unit (or group of cash-generating units) and part of the operation within that unit is disposed of, the goodwill associated with the operation disposed of is included in the carrying amount of the operation when determining the gain or loss on the disposal. Goodwill disposed of in these circumstances is measured based on the relative value of the operation disposed of and the portion of the cash-generating unit retained.

Fair value measurement

The Group measures its equity investments at fair value at the end of each reporting period. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The fair value measurement is based on the presumption that the transaction to sell the asset or transfer the liability takes place either in the principal market for the asset or liability, or in the absence of a principal market, in the most advantageous market for the asset or liability. The principal or the most advantageous market must be accessible by the Group. The fair value of an asset or a liability is measured using the assumptions that market participants would use when pricing the asset or liability, assuming that market participants act in their economic best interest.

A fair value measurement of a non-financial asset takes into account a market participant's ability to generate economic benefits by using the asset in its highest and best use or by selling it to another market participant that would use the asset in its highest and best use.

The Group uses valuation techniques that are appropriate in the circumstances and for which sufficient data are available to measure fair value, maximising the use of relevant observable inputs and minimising the use of unobservable inputs.

Where an indication of impairment exists, or when annual impairment testing for an asset is required (other than inventories, contract assets, deferred tax assets, financial assets, investment properties, and non-current assets), the asset's recoverable amount is estimated. An asset's recoverable amount is the higher of the asset's or cash-generating unit's value in use and its fair value less costs of disposal, and is determined for an individual asset, unless the asset does not generate cash inflows that are largely independent of those from other assets or groups of assets, in which case the recoverable amount is determined for the cash-generating unit to which the asset belongs. In testing a cash-generating unit for impairment, a portion of the carrying amount of a corporate asset (e.g., a headquarters building) is allocated to an individual cash-generating unit if it can be allocated on a reasonable and consistent basis or, otherwise, to the smallest group of cash-generating units.

An impairment loss is recognised only if the carrying amount of an asset exceeds its recoverable amount. In assessing value in use, the estimated future cash flows are discounted to their present value using a pre-tax discount rate that reflects current market assessments of the time value of money and the risks specific to the asset. An impairment loss is charged to profit or loss in the period in which it arises in those expense categories consistent with the function of the impaired asset.

An assessment is made at the end of each reporting period as to whether there is an indication that previously recognised impairment losses may no longer exist or may have decreased. If such an indication exists, the recoverable amount is estimated. A previously recognised impairment loss of an asset other than goodwill is reversed only if there has been a change in the estimates used to determine the recoverable amount of that asset, but not to an amount higher than the carrying amount that would have been determined (net of any depreciation/amortisation) had no impairment loss been recognised for the asset in prior years. A reversal of such an impairment loss is credited to profit or loss in the period in which it arises.

Property, plant and equipment and depreciation

Property, plant and equipment, other than construction in progress, are stated at cost less accumulated depreciation and any impairment losses. When an item of property, plant and equipment is classified as held for sale or when it is part of a disposal group classified as held for sale, it is not depreciated and is accounted for in accordance with IFRS 5. The cost of an item of property, plant and equipment comprises its purchase price and any directly attributable costs of bringing the asset to its working condition and location for its intended use.

Expenditure incurred after items of property, plant and equipment have been put into operation, such as repairs and maintenance, is normally charged to profit or loss in the period in which it is incurred. In situations where the recognition criteria are satisfied, the expenditure for a major inspection is capitalised in the carrying amount of the asset as a replacement. Where significant parts of property, plant and equipment are required to be replaced at intervals, the Group recognises such parts as individual assets with specific useful lives and depreciates them accordingly.

Depreciation is calculated on the straight-line basis to write off the cost of each item of property, plant and equipment to its residual value over its estimated useful life. The principal annual rates used for this purpose are as follows:

An item of property, plant and equipment including any significant part initially recognised is derecognised upon disposal or when no future economic benefits are expected from its use or disposal. Any gain or loss on disposal or retirement recognised in profit or loss in the year the asset is derecognised is the difference between the net sales proceeds and the carrying amount of the relevant asset.

Construction in progress represents a building under construction, which is stated at cost less any impairment losses, and is not depreciated. Cost comprises the direct costs of construction and capitalised borrowing costs on related borrowed funds during the period of construction. Construction in progress is reclassified to the appropriate category of property, plant and equipment when completed and ready for use.

Investment properties

Investment properties are interests in land and buildings (including the leasehold property held as a right-of-use asset which would otherwise meet the definition of an investment property) held to earn rental income and/or for capital appreciation, rather than for use in the production or supply of goods or services or for administrative purposes; or for sale in the ordinary course of business. Such properties are measured initially at cost, including transaction costs. Subsequent to initial recognition, investment properties are stated at cost less accumulated depreciation and any impairment losses.

Depreciation is calculated on the straight-line basis to write off the cost of each item of such properties to its residual value over its estimated useful life. The principal annual rate used for this purpose is as follows:

Intangible assets (other than goodwill)

Intangible assets acquired separately are measured on initial recognition at cost. The cost of intangible assets acquired in a business combination is the fair value at the date of acquisition. The useful lives of intangible assets are assessed to be either finite or indefinite. Intangible assets with finite lives are subsequently amortised over the useful economic life and assessed for impairment whenever there is an indication that the intangible asset may be impaired. The amortisation period and the amortisation method for an intangible asset with a finite useful life are reviewed at least at each financial year end.

Software

Purchased software is stated at cost less any impairment losses and is amortised on the straight-line basis over its estimated useful life of 10 years.

Research and development costs

All research costs are charged to profit or loss as incurred.

Expenditure incurred on projects to develop new products is capitalised and deferred only when the Group can demonstrate the technical feasibility of completing the intangible asset so that it will be available for use or sale, its intention to complete and its ability to use or sell the asset, how the asset will generate future economic benefits, the availability of resources to complete the project and the ability to measure reliably the expenditure during the development. Product development expenditure which does not meet these criteria is expensed when incurred.

Deferred development costs are stated at cost less any impairment losses and are amortised using the straight-line basis over the commercial lives of the underlying products not exceeding five to seven years, commencing from the date when the products are put into commercial production.

Operating concessions

For details of the accounting policy of operating concessions, please refer to "Service concession arrangements" below.

Operating contract rights

Operating contract rights represent the fair value of operating rights of WTPs or RWTPs acquired through business combination. These intangible assets are amortised on the straight-line basis over the remaining period of the operating contract rights.

軟件

所有研發開支於產生時自損益中扣除。

發展新產品項目引致的支出，只在本集團可證明完成該項無形資產以供使用或出售在技術上可行，本身亦有意完成該項資產及有能力使用或出售該項資產，以及該項資產日後如何帶來經濟利益，備有所需資源完成項目及有能力可靠計量發展過程所需支出的情況下，方予以資本化及遞延。不符合此等準則的產品發展支出，將於產生時列作支銷。

遞延發展成本乃按成本減任何減值虧損列賬，並於相關產品自投入商業生產當日起計不超過五至七年的商業壽命內按直線法攤銷。

運營合約權利

運營合約權利指透過業務合併所取得污水處理廠或再生水處理廠運營權的公平值。該等無形資產於運營合約權利的剩餘年期內按直線法攤銷。

Leases

The Group assesses at contract inception whether a contract is, or contains, a lease. A contract is, or contains, a lease if the contract conveys the right to control the use of an identified asset for a period of time in exchange for consideration.

Group as a lessee

The Group applies a single recognition and measurement approach for all leases, except for short-term leases and leases of low-value assets. The Group recognises lease liabilities to make lease payments and right-of-use assets representing the right to use the underlying assets.

(a) Right-of-use assets

Right-of-use assets are recognised at the commencement date of the lease (that is the date the underlying asset is available for use). Right-of-use assets are measured at cost, less any accumulated depreciation and any impairment losses, and adjusted for any remeasurement of lease liabilities. The cost of right-of-use assets includes the amount of lease liabilities recognised, initial direct costs incurred, and lease payments made at or before the commencement date less any lease incentives received. Right-of-use assets are depreciated on a straight-line basis over the shorter of the lease terms and the estimated useful lives of the assets as follows:

(b) Lease liabilities

Lease liabilities are recognised at the commencement date of the lease at the present value of lease payments to be made over the lease term. The lease payments include fixed payments (including in-substance fixed payments) less any lease incentives receivable, variable lease payments that depend on an index or a rate, and amounts expected to be paid under residual value guarantees. The lease payments also include the exercise price of a purchase option reasonably certain to be exercised by the Group and payments of penalties for termination of a lease, if the lease term reflects the Group exercising the option to terminate the lease. The variable lease payments that do not depend on an index or a rate are recognised as an expense in the period in which the event or condition that triggers the payment occurs.

In calculating the present value of lease payments, the Group uses its incremental borrowing rate at the lease commencement date because the interest rate implicit in the lease is not readily determinable. After the commencement date, the amount of lease liabilities is increased to reflect the accretion of interest and reduced for the lease payments made. In addition, the carrying amount of lease liabilities is remeasured if there is a modification, a change in the lease term, a change in lease payments (e.g., a change to future lease payments resulting from a change in an index or rate) or a change in assessment of an option to purchase the underlying asset.

The Group's lease liabilities are included in interest-bearing bank and other borrowings.

(b) 租賃負債

租賃負債於租賃開始日期按租賃期內作出的租賃付款之現值計予以確認。租賃付款包括固定付款(包括實質固定付款)減任何應收租賃優惠、取決於某一指數或比率的可變租賃付款，以及預期在剩餘價值擔保下支付的金額。租賃付款亦包括合理確定將由本集團行使的購買選擇權之行使價，及為終止租賃而支付的罰款(倘租賃期反映本集團正行使終止權)。並非取決於某一指數或比率的可變租賃付款於導致付款的事件或條件發生的期間確認為開支。

(c) Short-term leases and leases of low-value assets

The Group applies the short-term lease recognition exemption to its short-term leases of office properties (that is those leases that have a lease term of 12 months or less from the commencement date and do not contain a purchase option). It also applies the recognition exemption for leases of low-value assets to leases of office properties that are considered to be of low value.

Lease payments on short-term leases and leases of low-value assets are recognised as an expense on a straight-line basis over the lease term.

Group as a lessor

When the Group acts as a lessor, it classifies at lease inception (or when there is a lease modification) each of its leases as either an operating lease or a finance lease.

Leases in which the Group does not transfer substantially all the risks and rewards incidental to ownership of an asset are classified as operating leases. When a contract contains lease and non-lease components, the Group allocates the consideration in the contract to each component on a relative stand-alone selling price basis. Rental income is accounted for on a straight-line basis over the lease terms and is included in other income and gains in the consolidated statement of profit or loss and other comprehensive income due to its nature. Initial direct costs incurred in negotiating and arranging an operating lease are added to the carrying amount of the leased asset and recognised over the lease term on the same basis as rental income. Contingent rents are recognised as other income and gains in the period in which they are earned.

(c) 短期租賃及低價值資產租賃

本集團將短期租賃確認豁免應用辦公物業的短期租賃(即自租賃開始日期起計租期為十二個月或以下,並且不包含購買選擇權的租賃)。其亦應用於被視為低價值的辦公物業的低價值資產租賃。

短期租賃的租賃款項及低價值資產租賃在租期內按直線法確認為支出。

本集團作為出租人

當本集團作為出租人時,本集團在租賃開始時(或當存在租賃變更時)將其各租賃分類為經營租賃或融資租賃。

Service concession arrangements

The Group has entered into a number of service concession arrangements with the Grantors. The service concession arrangements consist of Build-Operate-Transfer (the "BOT") arrangements and Transfer-Operate-Transfer (the "TOT") arrangements. Under the BOT arrangements, the Group carries out construction work of the WTPs, RWTPs, WDPs, STPs or other municipal infrastructure for the Grantors and receives in return the rights to operate the service project concerned for a specified period of time (the "operation period") in accordance with the pre-established conditions set by the Grantors, and the service project should be transferred to the Grantors with nil consideration at the end of the operation period. A TOT arrangement is similar to a BOT arrangement, except that the Group pays consideration for the rights to operate the WTPs, RWTPs, WDPs, STPs or other municipal infrastructure that have been built.

Consideration given by the Grantors

A financial asset (financial receivable) is recognised to the extent that the Group has an unconditional right to receive cash or another financial asset from or at the direction of the Grantors for the construction services rendered and/or the consideration paid and payable by the Group for the rights to operate WTPs, and the Grantors have little, if any, discretion to avoid payment, usually because the agreements are enforceable by law. The Group has an unconditional right to receive cash or another financial asset if nothing other than the passage of time is required before payment of the consideration is due and the Grantors contractually guarantee to pay the Group specified or determinable amounts even if the payment is contingent on the Group ensuring that the infrastructure meets specified quality of efficiency requirements. The financial asset (financial receivable) is accounted for in accordance with the policy set out for *Financial assets at amortised cost (debt instruments)* under "Investments and other financial assets" below.

服務特許經營安排

本集團與授予人訂立多項服務特許經營安排。服務特許經營安排包括建設 — 運營 — 移交(「BOT」)安排及移交 — 運營 — 移交(「TOT」)安排。根據BOT安排，本集團為授予人開展污水處理廠、再生水處理廠、供水廠、污泥處理廠或其他市政基礎設施的建設工程，並根據授予人預先設定的條件獲得於指定期間(「經營期間」)經營有關服務項目的權利作為回報，而有關服務項目應於經營期末無償轉讓予授予人。TOT安排與BOT安排類似，惟本集團須就已建立的污水處理廠、再生水處理廠、供水廠、污泥處理廠或其他市政基礎設施的經營權支付代價。

授予人支付的代價

倘本集團於擁有無條件權利就所提供的建設服務及／或本集團就污水處理廠的經營權利已付及應付的代價向授予人或按授予人的指示收取現金或另一項金融資產，且授予人避免付款的酌情權很小(如有)(通常由於協議可按法律強制執行)，則會確認金融資產(金融應收款項)。倘於代價到期支付前隨時間流逝外並無其他規定，且授予人以合約方式擔保向本集團支付特定或可釐定金額，即使付款須以本集團確保基礎設施符合特定的有效質量要求為條件，本集團仍擁有無條件權利收取現金或其他金融資產。金融資產(金融應收款項)乃根據下文「投資及其他金融資產」項下按攤銷成本計量之金融資產(債務工具)所載的政策入賬。

Consideration given by the Grantors (Continued)

An intangible asset (operating concession) is recognised to the extent that the Group receives the rights to charge users of public service or the grantors remunerate the Group on the basis of the extent of use of the WTPs, RWTPs, WDPs, STPs or other municipal infrastructure by users, but with no guarantees as to the amounts that will be paid to the Group, which is not an unconditional right to receive cash because the amounts are contingent on the extent that the public use the service. The intangible asset (operating concession) is accounted for in accordance with the policy set out for “intangible assets” above, which is amortised on a straight-line basis over the terms of operation ranging from 25 to 30 years.

If the Group is paid for the construction services partly by a financial asset and partly by an intangible asset, then each component of the consideration is accounted for separately and is recognised initially at the fair value of the consideration.

Construction or upgrade services

Costs relating to construction or upgrade services comprise direct materials, the costs of subcontracting, direct labour and an appropriate proportion of variable and fixed construction overheads. Revenue from the construction or upgrade services under the BOT agreements is estimated on a cost-plus basis with reference to the prevailing market rate of gross margin at the date of the agreement applicable to similar construction services rendered in similar locations, and is recognised using the percentage of completion method, measured by reference to the proportion of costs incurred to date to the estimated total cost of the relevant contract.

Operating services

Revenue relating to operating services is accounted for in accordance with the policy for “Revenue recognition” below. Costs for operating services are expensed in the period in which they are incurred.

授予人支付的代價(續)

無形資產(經營特許權)只有在本集團獲得權利可向公共服務使用者收費或授予人按照使用者使用污水處理廠、再生水處理廠、供水廠、污泥處理廠或其他市政基礎設施的情況對本集團作出補償(但不保證將支付予本集團的金額)時亦予確認,此項權利並非收取現金的無條件權利,因金額視乎公眾使用服務的程度而定。該項無形資產乃根據上文「無形資產」所載政策入賬,乃於介乎25至30年的經營年期內按直線法攤銷。

倘本集團就建設服務獲支付的代價部分為一項金融資產及部分為一項無形資產,則代價的各組成部分須分開入賬,初步按代價的公平值確認。

建設或改造服務

有關建設或改造服務的成本包括直接物料、分包成本、直接勞工及合適比例的浮動及固定間接成本。BOT協議項下建設或改造服務的收益乃參考於協議日期在類似地點提供類似建設服務適用的現行市場毛利率,按成本加成基準估計,並採用竣工百分比法(參考至今所產生成本佔相關合約估計成本總額的比例計量)確認。

經營服務

有關經營服務的收益乃根據下文「收益確認」所載有關政策入賬。經營服務的成本於其產生期間列為開支。

Investments and other financial assets

Initial recognition and measurement

Financial assets are classified, at initial recognition, as subsequently measured at amortised cost, fair value through other comprehensive income, and fair value through profit or loss.

The classification of financial assets at initial recognition depends on the financial asset's contractual cash flow characteristics and the Group's business model for managing them. With the exception of trade receivables that do not contain a significant financing component or for which the Group has applied the practical expedient of not adjusting the effect of a significant financing component, the Group initially measures a financial asset at its fair value plus in the case of a financial asset not at fair value through profit or loss, transaction costs. Trade receivables that do not contain a significant financing component or for which the Group has applied the practical expedient are measured at the transaction price determined under IFRS 15 in accordance with the policies set out for "Revenue recognition" below.

In order for a financial asset to be classified and measured at amortised cost or fair value through other comprehensive income, it needs to give rise to cash flows that are solely payments of principal and interest ("SPPI") on the principal amount outstanding. Financial assets with cash flows that are not SPPI are classified and measured at fair value through profit or loss, irrespective of the business model.

The Group's business model for managing financial assets refers to how it manages its financial assets in order to generate cash flows. The business model determines whether cash flows will result from collecting contractual cash flows, selling the financial assets, or both. Financial assets classified and measured at amortised cost are held within a business model with the objective to hold financial assets in order to collect contractual cash flows, while financial assets classified and measured at fair value through other comprehensive income are held within a business model with the objective of both holding to collect contractual cash flows and selling. Financial assets which are not held within the aforementioned business models are classified and measured at fair value through profit or loss.

投資及其他金融資產

初步確認及計量

金融資產於初始確認時分類為其後按攤銷成本計量及按公平值計入其他全面收益以及按公平值計入損益的金融資產。

於初始確認時，金融資產分類取決於金融資產的合約現金流量特點及本集團管理該等金融資產的業務模式。除並無重大融資成分或本集團已應用並無調整重大融資成分影響的實際權宜方法貿易應收款項外，本集團按公平值加上(倘金融資產並非按公平值計入損益)交易成本計量金融資產。並無重大融資成分或本集團已應用實際權宜方法的貿易應收款項根據下文「收入確認」所載的政策按國際財務報告準則第15號釐定的交易價格計量。

按攤銷成本或通過其他全面收益公平值計量及分類的金融資產，產生的現金流量應僅為支付本金及未償還的本金產生的利息(「SPPI」)(僅為支付本金及利息)。現金流量並非SPPI的金融資產，不論其業務模式如何，均按公平值計入損益分類及計量。

本集團管理金融資產的業務模式指其如何管理其金融資產以產生現金流量。業務模式確定現金流量是否來自收集合約現金流量、出售金融資產，或兩者兼有。按攤銷成本分類及計量的金融資產在旨在持有金融資產以收取合約現金流量的業務模式內持有，而按公平值計入其他全面收益分類及計量的金融資產則在旨在持有以收集合約現金流量及出售的業務模式內持有。並非在上述業務模式內持有的金融資產則以按公平值計入損益分類及計量。

All regular way purchases and sales of financial assets are recognised on the trade date, that is, the date that the Group commits to purchase or sell the asset. Regular way purchases or sales are purchases or sales of financial assets that require delivery of assets within the period generally established by regulation or convention in the marketplace.

Subsequent measurement

The subsequent measurement of financial assets depends on their classification as follows:

Financial assets at amortised cost (debt instruments)

Financial assets at amortised cost are subsequently measured using the effective interest method and are subject to impairment. Gains and losses are recognised in profit or loss when the asset is derecognised, modified or impaired.

Financial assets at fair value through other comprehensive income (debt instruments)

For debt investments at fair value through other comprehensive income, interest income, foreign exchange revaluation and impairment losses or reversals are recognised in profit or loss and computed in the same manner as for financial assets measured at amortised cost. The remaining fair value changes are recognised in other comprehensive income. Upon derecognition, the cumulative fair value change recognised in other comprehensive income is recycled to profit or loss.

Financial assets designated at fair value through other comprehensive income (equity investments)

Upon initial recognition, the Group can elect to classify irrevocably its equity investments as equity investments designated at fair value through other comprehensive income when they meet the definition of equity under IAS 32 *Financial Instruments: Presentation* and are not held for trading. The classification is determined on an instrument-by-instrument basis.

Gains and losses on these financial assets are never recycled to profit or loss. Dividends are recognised as other income in profit or loss when the right of payment has been established, it is probable that the economic benefits associated with the dividend will flow to the Group and the amount of the dividend can be measured reliably, except when the Group benefits from such proceeds as a recovery of part of the cost of the financial asset, in which case, such gains are recorded in other comprehensive income. Equity investments designated at fair value through other comprehensive income are not subject to impairment assessment.

Financial assets at fair value through profit or loss

Financial assets at fair value through profit or loss are carried in the consolidated statement of financial position at fair value with net changes in fair value recognised in profit or loss.

This category includes derivative instruments and equity investments which the Group had not irrevocably elected to classify at fair value through other comprehensive income. Dividends on equity investments classified as financial assets at fair value through profit or loss are also recognised as other income in profit or loss when the right of payment has been established, it is probable that the economic benefits associated with the dividend will flow to the Group and the amount of the dividend can be measured reliably.

A derivative embedded in a hybrid contract, with a financial liability or non-financial host, is separated from the host and accounted for as a separate derivative if the economic characteristics and risks are not closely related to the host; a separate instrument with the same terms as the embedded derivative would meet the definition of a derivative; and the hybrid contract is not measured at fair value through profit or loss. Embedded derivatives are measured at fair value with changes in fair value recognised in profit or loss. Reassessment only occurs if there is either a change in the terms of the contract that significantly modifies the cash flows that would otherwise be required or a reclassification of a financial asset out of the fair value through profit or loss category.

該等金融資產的收益及虧損概不會被重新計入損益。當確立支付權時，股息於損益中確認為其他收入，與股息相關的經濟利益很可能會流入本集團，而股息金額亦可靠計量，惟當本集團於作為收回金融資產一部分成本的所得款項中獲益時則除外，於此等情況下，該等收益於其他全面收益入賬。指定為按公平值計入其他全面收益的股權投資不受減值評估影響。

按公平值計入損益的金融資產

按公平值計入損益的金融資產按公平值於綜合財務狀況表列賬，而公平值變動淨額於損益中確認。

該類別包括本集團並無不可撤銷地選擇按公平值計入其他全面收益進行分類的衍生工具及股權投資。當支付權確立時，歸類為按公平值計入損益金融資產的股權投資的股息亦於損益中確認為其他收入。與股息相關的經濟利益可能會流入本集團，而股息金額能可靠計量。

當嵌入混合合約(包含金融負債或非金融主權)的衍生工具具備與主體不緊密相關的經濟特徵及風險；具備與嵌入式衍生工具相同條款的單獨工具符合衍生工具的定義；且混合合約並非按公平價值計量且其變動計入損益，則該衍生工具與主體分開並作為單獨衍生工具列賬。嵌入式衍生工具按公平價值計量，且其變動計入損益。僅當合約條款出現變動，大幅改變其他情況下所需現金流量時；或當原分類至按公平價值列賬且其變動計入損益的金融資產獲重新分類時，方進行重新評估。

A derivative embedded within a hybrid contract containing a financial asset host is not accounted for separately. The financial asset host together with the embedded derivative is required to be classified in its entirety as a financial asset at fair value through profit or loss.

Derecognition of financial assets

A financial asset (or, where applicable, a part of a financial asset or part of a group of similar financial assets) is primarily derecognised (i.e., removed from the Group's consolidated statement of financial position) when:

- the rights to receive cash flows from the asset have expired; or
- the Group has transferred its rights to receive cash flows from the asset or has assumed an obligation to pay the received cash flows in full without material delay to a third party under a "pass-through" arrangement; and either (a) the Group has transferred substantially all the risks and rewards of the asset, or (b) the Group has neither transferred nor retained substantially all the risks and rewards of the asset, but has transferred control of the asset.

When the Group has transferred its rights to receive cash flows from an asset or has entered into a pass-through arrangement, it evaluates if, and to what extent, it has retained the risk and rewards of ownership of the asset. In that case, the Group also recognises an associated liability. Continuing involvement that takes the form of a guarantee over the transferred asset is measured at the lower of the original carrying amount of the asset and the maximum amount of consideration that the Group could be required to repay.

Impairment of financial assets

The Group recognises an allowance for expected credit losses (“ECLs”) for all debt instruments not held at fair value through profit or loss. ECLs are based on the difference between the contractual cash flows due in accordance with the contract and all the cash flows that the Group expects to receive, discounted at an approximation of the original effective interest rate. The expected cash flows will include cash flows from the sale of collateral held or other credit enhancements that are integral to the contractual terms.

General approach

ECLs are recognised in two stages. For credit exposures for which there has not been a significant increase in credit risk since initial recognition, ECLs are provided for credit losses that result from default events that are possible within the next 12 months (a 12-month ECL). For those credit exposures for which there has been a significant increase in credit risk since initial recognition, a loss allowance is required for credit losses expected over the remaining life of the exposure, irrespective of the timing of the default (a lifetime ECL).

At each reporting date, the Group assesses whether the credit risk on a financial instrument has increased significantly since initial recognition. When making the assessment, the Group compares the risk of a default occurring on the financial instrument as at the reporting date with the risk of a default occurring on the financial instrument as at the date of initial recognition and considers reasonable and supportable information that is available without undue cost or effort, including historical and forward-looking information.

The various group companies have different credit policies depending on the requirements of their markets in which they operate and the businesses they engage in. However, in certain cases, the Group may also consider a financial asset to be in default when internal or external information indicates that the Group is unlikely to receive the outstanding contractual amounts in full before taking into account any credit enhancements held by the Group. A financial asset is written off when there is no reasonable expectation of recovering the contractual cash flows.

金融資產減值

本集團確認對並非按公平價值計入損益的所有債務工具預期信貸虧損(「預期信貸虧損」)的撥備。預期信貸虧損乃基於根據合約到期的合約現金流量與本集團預期收取的所有現金流量之間的差額而釐定，並以原實際利率的近似值貼現。預期現金流量將包括出售所持抵押的現金流量或組成合約條款的其他信貸提升措施。

一般方式

預期信貸虧損分兩個階段確認。對於自初始確認概無重大增加的信貸風險，預期信貸虧損乃是為於未來12個月內可能來自違約事件的預期信貸虧損(12個月預期信貸虧損)而計提。對於該等自首次確認後顯著增加的信貸風險，必須為預期於剩餘年期產生的信貸虧損作出虧損撥備，毋須考慮違約事件發生的時間(全期預期信貸虧損)。

於各報告日期，本集團評估信貸風險自初始確認以來是否顯著上升。於評估時，本集團會比較金融工具於報告日期發生違約的風險與金融工具於初始確認日期發生違約的風險。作出評估時，本集團會考慮合理及具支持性的資料，包括過往經驗及毋須花費不必要成本或努力獲取的前瞻性資料。

各集團公司訂有不同的信貸政策，視乎其業務營運所在市場及所從事業務的要求而定。然而，在若干情況下，倘內部或外部資料顯示，在計及本集團持有的任何信貸提升措施前，本集團不大可能悉數收回未償還合約款項，則本集團亦可認為金融資產已違約。倘無法合理預期收回合約現金流量，則撇銷金融資產。

Debt investments at fair value through other comprehensive income and financial assets at amortised cost are subject to impairment under the general approach and they are classified within the following stages for measurement of ECLs except for trade receivables and contract assets which apply the simplified approach as detailed below.

- Stage 1 Financial instruments for which credit risk has not increased significantly since initial recognition and for which the loss allowance is measured at an amount equal to 12-month ECLs
- Stage 2 Financial instruments for which credit risk has increased significantly since initial recognition but that are not credit-impaired financial assets and for which the loss allowance is measured at an amount equal to lifetime ECLs
- Stage 3 Financial assets that are credit-impaired at the reporting date (but that are not purchased or originated credit-impaired) and for which the loss allowance is measured at an amount equal to lifetime ECLs

Simplified approach

For trade receivables and contract assets that do not contain a significant financing component or when the Group applies the practical expedient of not adjusting the effect of a significant financing component, the Group applies the simplified approach in calculating ECLs. Under the simplified approach, the Group does not track changes in credit risk, but instead recognises a loss allowance based on lifetime ECLs at each reporting date. The Group has established a provision matrix that is based on its historical credit loss experience, adjusted for forward-looking factors specific to the debtors and the economic environment.

For trade receivables and contract assets that contain a significant financing component and lease receivables, the Group chooses as its accounting policy to adopt the simplified approach in calculating ECLs with policies as described above.

簡化方法

就並無重大融資成分或本集團應用實際權宜方法未調整重大融資成分影響的貿易應收款項及票據而言，本集團於計算預期信貸虧損時應用簡化方法。根據簡化方法，本集團並無追溯信貸風險變動，而是根據各報告日期的全期預期信貸虧損確認虧損撥備。本集團已設立根據其過往信貸虧損經驗計算的撥備矩陣，並按債務人特定的前瞻性因素及經濟環境作出調整。

就貿易應收款項及包含重大融資部分及應收租賃條款的合約資產而言，本集團選擇採取簡化方法計算上述政策的預期信貸虧損作為其會計政策。

Financial liabilities

Initial recognition and measurement

Financial liabilities are classified, at initial recognition, as financial liabilities at fair value through profit or loss, loans and borrowings, payables, or as derivatives designated as hedging instruments in an effective hedge, as appropriate.

All financial liabilities are recognised initially at fair value and, in the case of loans and borrowings and payables, net of directly attributable transaction costs.

The Group's financial liabilities include trade and bills payables, other payables, interest-bearing bank and other borrowings, and corporate bonds.

Subsequent measurement

The subsequent measurement of financial liabilities depends on their classification as follows:

Financial liabilities at amortised cost (loans and borrowings)

After initial recognition, interest-bearing bank and other borrowings are subsequently measured at amortised cost, using the effective interest rate method unless the effect of discounting would be immaterial, in which case they are stated at cost. Gains and losses are recognised in profit or loss when the liabilities are derecognised as well as through the effective interest rate amortisation process.

Amortised cost is calculated by taking into account any discount or premium on acquisition and fees or costs that are an integral part of the effective interest rate. The effective interest rate amortisation is included in finance costs in profit or loss.

Derecognition of financial liabilities

A financial liability is derecognised when the obligation under the liability is discharged or cancelled, or expires.

When an existing financial liability is replaced by another from the same lender on substantially different terms, or the terms of an existing liability are substantially modified, such an exchange or modification is treated as a derecognition of the original liability and a recognition of a new liability, and the difference between the respective carrying amounts is recognised in profit or loss.

金融負債於初步確認時分類為按公平值計入損益的金融負債、貸款及借款、應付款項或於實際對沖指定為對沖工具的衍生工具(如適當)。

所有金融負債初步按公平值確認，而如屬貸款及借款以及應付款項，則扣除直接應佔交易成本。

本集團的金融負債包括貿易應付款項及應付票據、其他應付款項、計息銀行及其他借款及公司債券。

其後計量

金融負債的其後計量按如下分類進行：

按攤銷成本計量之金融負債(貸款及借款)

於初步確認後，計息銀行及其他借款其後採用實際利率法按攤銷成本計量，惟倘折現並無重大影響，則按成本列賬。當終止確認負債時及在採用實際利率法的攤銷過程中，收益及虧損會在損益內確認。

計算攤銷成本時須計及收購時的任何折讓或溢價，且包括組成實際利率不可缺少的費用或成本。實際利率攤銷計入損益的融資成本。

終止確認金融負債

倘金融負債的責任被解除、取消或到期，則會終止確認金融負債。

倘現有金融負債被來自同一貸款人的另一項與現有大部分條款不相同的負債所替代，或現有負債的條款大部分被修訂，該項交換或修訂作為終止確認原有負債及確認新負債處理，兩者相應賬面值的差額於損益內確認。

Offsetting of financial instruments

Financial assets and financial liabilities are offset and the net amount is reported in the consolidated statement of financial position if there is a currently enforceable legal right to offset the recognised amounts and there is an intention to settle on a net basis, or to realise the assets and settle the liabilities simultaneously.

Inventories

Inventories are stated at the lower of cost and net realisable value. Cost is determined on the first-in, first-out basis. Net realisable value is based on estimated selling prices less any estimated costs to be incurred to completion and disposal.

Cash and cash equivalents

For the purpose of the consolidated statement of cash flows, cash and cash equivalents comprise cash on hand and demand deposits, and short term highly liquid investments that are readily convertible into known amounts of cash, are subject to an insignificant risk of changes in value, and have a short maturity of generally within three months when acquired, less bank overdrafts which are repayable on demand and form an integral part of the Group's cash management.

For the purpose of the consolidated statement of financial position, cash and cash equivalents comprise cash on hand and at banks, including term deposits, and assets similar in nature to cash, which are not restricted as to use.

Provisions

A provision is recognised when a present obligation (legal or constructive) has arisen as a result of a past event and it is probable that a future outflow of resources will be required to settle the obligation, provided that a reliable estimate can be made of the amount of the obligation.

When the effect of discounting is material, the amount recognised for a provision is the present value at the end of reporting period of the future expenditures expected to be required to settle the obligation. The increase in the discounted present value amount arising from the passage of time is included in finance costs in profit or loss.

抵銷金融工具

倘現行存在合法可強制執行的權利以抵銷已確認金融資產及金融負債金額及有意按淨額基準結算，或可同時變現資產並結算負債，則金融資產及金融負債可互相抵銷，抵銷淨額於綜合財務狀況表內呈報。

存貨

存貨按成本與可變現淨值中較低者列賬。成本按先進先出基準釐定。可變現淨值按估計售價減完成及出售時產生的任何估計成本計算。

現金及現金等價物

就綜合現金流量表而言，現金及現金等價物包括手頭現金及活期存款，以及可隨時兌換為已知數額現金、無重大價值變動風險及一般於購入後三個月內的較短期限到期的短期及高流動性投資，扣除須按要求償還且構成本集團現金管理整體的部份的銀行透支。

就綜合財務狀況表而言，現金及現金等價物包括用途不受限制的手頭現金及銀行存款(包括定期存款及與現金性質相似的資產)。

撥備

倘因過往事件須承擔現時責任(法定或推定)，而履行該責任可能導致未來資源外流，假設該責任所涉金額能夠可靠估計，則確認撥備。

倘折現影響重大，則確認為撥備的金額為預期履行責任所需未來開支於報告期末的現值。因時間推移而產生的折現現值增加計入損益表的融資成本內。

A contingent liability recognised in a business combination is initially measured at its fair value. Subsequently, it is measured at the higher of (i) the amount that would be recognised in accordance with the general policy for provisions above; and (ii) the amount initially recognised less, when appropriate, the amount of income recognised in accordance with the policy for revenue recognition.

Income tax

Income tax comprises current and deferred tax. Income tax relating to items recognised outside profit or loss is recognised outside profit or loss, either in other comprehensive income or directly in equity.

Current tax assets and liabilities are measured at the amount expected to be recovered from or paid to the taxation authorities, based on tax rates (and tax laws) that have been enacted or substantively enacted by the end of the year, taking into consideration interpretations and practices prevailing in the countries in which the Group operates.

Deferred tax is provided, using the liability method, on all temporary differences at the end of the reporting period between the tax bases of assets and liabilities and their carrying amounts for financial reporting purposes.

Deferred tax liabilities are recognised for all taxable temporary differences, except:

- when the deferred tax liability arises from the initial recognition of goodwill or an asset or liability in a transaction that is not a business combination and, at the time of the transaction, affects neither the accounting profit nor taxable profit or loss; and
- in respect of taxable temporary differences associated with investments in subsidiaries, associates and joint ventures, when the timing of the reversal of the temporary differences can be controlled and it is probable that the temporary differences will not reverse in the foreseeable future.

於業務合併中確認的或然負債初步按其公平值計量，其後則按(i)將根據上述一般撥備政策確認的金額；與(ii)初步確認金額減(指在適當情況下)根據收益確認政策確認的收益金額兩者中的較高值計量。

所得稅

所得稅包括即期及遞延稅項。與於損益以外確認的項目相關的所得稅於損益以外確認，即於其他全面收益或直接於權益確認。

即期稅項資產及負債，乃根據於年末已實施或大致實施的稅率(及稅法)，考慮到本集團經營所在國家現行詮釋及慣例，以預期可自稅務機關收回或向稅務機關支付的金額計量。

Deferred tax assets are recognised for all deductible temporary differences, and the carryforward of unused tax credits and any unused tax losses. Deferred tax assets are recognised to the extent that it is probable that taxable profit will be available against which the deductible temporary differences, and the carryforward of unused tax credits and unused tax losses can be utilised, except:

- when the deferred tax asset relating to the deductible temporary differences arises from the initial recognition of an asset or liability in a transaction that is not a business combination and, at the time of the transaction, affects neither the accounting profit nor taxable profit or loss; and
- in respect of deductible temporary differences associated with investments in subsidiaries, associates and joint ventures, deferred tax assets are only recognised to the extent that it is probable that the temporary differences will reverse in the foreseeable future and taxable profit will be available against which the temporary differences can be utilised.

The carrying amount of deferred tax assets is reviewed at the end of each reporting period and reduced to the extent that it is no longer probable that sufficient taxable profit will be available to allow all or part of the deferred tax asset to be utilised. Unrecognised deferred tax assets are reassessed at the end of each reporting period and are recognised to the extent that it has become probable that sufficient taxable profit will be available to allow all or part of the deferred tax asset to be recovered.

Deferred tax assets and liabilities are measured at the tax rates that are expected to apply to the period when the asset is realised or the liability is settled, based on tax rates (and tax laws) that have been enacted or substantively enacted by the end of the reporting period.

Deferred tax assets and deferred tax liabilities are offset if and only if the Group has a legally enforceable right to set off current tax assets and current tax liabilities and the deferred tax assets and deferred tax liabilities relate to income taxes levied by the same taxation authority on either the same taxable entity or different taxable entities which intend either to settle current tax liabilities and assets on a net basis, or to realise the assets and settle the liabilities simultaneously, in each future period in which significant amounts of deferred tax liabilities or assets are expected to be settled or recovered.

Government grants

Government grants are recognised at their fair value where there is reasonable assurance that the grant will be received and all attaching conditions will be complied with. When the grant relates to an expense item, it is recognised as income on a systematic basis over the periods that the costs, for which it is intended to compensate, are expensed.

Where the grant relates to an asset, the fair value is credited to a deferred income account and is released to profit or loss over the expected useful life of the relevant asset by equal annual instalments or deducted from the carrying amount of the asset and released to profit or loss by way of a reduced depreciation charge.

Where the Group receives grants of non-monetary assets, the grants are recorded at the fair value of the non-monetary assets and released to the profit or loss over the expected useful lives of the relevant assets by equal annual instalments.

政府補助

Revenue recognition

Revenue from contracts with customers

Revenue from contracts with customers is recognised when control of goods or services is transferred to the customers at an amount that reflects the consideration to which the Group expects to be entitled in exchange for those goods or services.

When the consideration in a contract includes a variable amount, the amount of consideration is estimated to which the Group will be entitled in exchange for transferring the goods or services to the customer. The variable consideration is estimated at contract inception and constrained until it is highly probable that a significant revenue reversal in the amount of cumulative revenue recognised will not occur when the associated uncertainty with the variable consideration is subsequently resolved.

When the contract contains a financing component which provides the customer with a significant benefit of financing the transfer of goods or services to the customer for more than one year, revenue is measured at the present value of the amount receivable, discounted using the discount rate that would be reflected in a separate financing transaction between the Group and the customer at contract inception. When the contract contains a financing component which provides the Group with a significant financial benefit for more than one year, revenue recognised under the contract includes the interest expense accreted on the contract liability under the effective interest method. For a contract where the period between the payment by the customer and the transfer of the promised goods or services is one year or less, the transaction price is not adjusted for the effects of a significant financing component, using the practical expedient in IFRS 15.

來自客戶合約的收益

來自客戶合約的收益乃於商品或服務的控制權轉讓予客戶時確認，該金額能反映本集團預期就交換該等商品或服務有權獲得的代價。

當合約中的代價包含可變金額時，代價金額於本集團向客戶轉讓商品或服務而有權獲得交換時估計。可變代價於合約開始時估計並受到約束，直至與可變代價相關的不確定因素得到解決時，確認的累積收益金額極有可能不會發生重大收益回撥。

當合約中包含融資成分，該融資成分為客戶提供超過一年的商品或服務轉讓融資的重大利益時，收益按應收款項的現值計量，使用貼現率折現，該貼現率將反映在本集團與客戶在合約開始時的單獨融資交易中。當合約中包含融資部分，該融資部分為在本集團提供了一年以上的重大財務利益時，合約項下確認的收益包括按實際利息法在合約負債上加算的利息。就客戶付款至轉讓承諾商品或者服務的期限為一年或者更短的合約而言，交易價格採用國際財務報告準則第15號中實際權宜方法，不會對重大融資部分的影響作出調整。

(a) BOT arrangements

Revenue from the construction services under the BOT agreements is estimated on a cost-plus basis with reference to the prevailing market rate of gross margin at the date of the agreement applicable to similar construction services rendered in similar locations, and is recognised using the percentage of completion method, measured by reference to the proportion of costs incurred to date to the estimated total cost of the relevant contract.

(b) EPC arrangements

Revenue from the provision of construction services is recognised over time, using an input method to measure progress towards complete satisfaction of the service, because the Group's performance creates or enhances an asset that the customer controls as the asset is created or enhanced. The input method recognises revenue based on the proportion of the actual costs incurred relative to the estimated total costs for satisfaction of the construction services.

Claims to customers are amounts that the Group seeks to collect from the customers as reimbursement of costs and margins for scope of works not included in the original construction contract. Claims are accounted for as variable consideration and constrained until it is highly probable that a significant revenue reversal in the amount of cumulative revenue recognised will not occur when the associated uncertainty with the variable consideration is subsequently resolved. The Group uses the expected value method to estimate the amounts of claims because this method best predicts the amount of variable consideration to which the Group will be entitled.

(c) Provision of operation services

Revenue from the provision of operation services is recognised over the scheduled period on a straight-line basis because the customer simultaneously receives and consumes the benefits provided by the Group.

(a) BOT安排

BOT協議項下建設服務的收益乃參考於協議日期在類似地點提供類似建設服務適用的現行市場毛利率，按成本加成基準估計，並採用竣工百分比法(參考至今所產生成本佔相關合約估計成本總額的比例計量)確認。

(b) EPC安排

提供建設服務的收入隨著時間的推移而確認，服務的收益將繼續使用計量完全達成服務進度的投入法，因為本集團的業績創造或增強了客戶在資產創建或增強時控制的資產。投入法根據實際發生的成本佔建設服務滿足估計總成本的比例確認收入。

向客戶索賠金額乃本集團尋求從客戶處收取的金額，以作為原始建設合約中未包含工程範圍的成本及保證金的補償。索賠作為可變代價進行會計處理並受到約束，直至與可變代價相關的不確定因素得到解決時，確認的累積收益金額極有可能不會發生重大收益回撥。本集團使用預期價值法估計索償金額，因為該方法為預測本集團將有權獲得可變代價金額的最佳方法。

Other income

Rental income is recognised on a time proportion basis over the lease terms. Variable lease payments that do not depend on an index or a rate are recognised as income in the accounting period in which they are incurred.

Interest income is recognised on an accrual basis using the effective interest method by applying the rate that exactly discounts the estimated future cash receipts over the expected life of the financial instrument or a shorter period, when appropriate, to the net carrying amount of the financial asset.

Dividend income is recognised when the shareholders' right to receive payment has been established, it is probable that the economic benefits associated with the dividend will flow to the Group and the amount of the dividend can be measured reliably.

Contract assets

A contract asset is the right to consideration in exchange for goods or services transferred to the customer. If the Group performs by transferring goods or services to a customer before the customer pays consideration or before payment is due, a contract asset is recognised for the earned consideration that is conditional. Contract assets are subject to impairment assessment, details of which are included in the accounting policies for impairment of financial assets.

Contract liabilities

A contract liability is recognised when a payment is received or a payment is due (whichever is earlier) from a customer before the Group transfers the related goods or services. Contract liabilities are recognised as revenue when the Group performs under the contract (i.e., transfers control of the related goods or services to the customer).

租賃收益已按時間比例於租賃期間獲確認。並非取決於某一指數或比率的可變租賃付款於其產生的會計期間確認為收入。

利息收益按應計基準使用實際利率法確認，透過應用於金融工具的預期期限或較短期間(如適用)其已估算未來現金流量的利率準確變現至金融資產的賬面淨值。

股息收入於股東收取付款權利實施後予以確認，與股息相關的經濟利益很可能流入本集團且股息金額能夠可靠計量。

合約資產

合約資產乃就換取已向客戶轉讓的貨品或服務而收取代價的權利。倘本集團於客戶支付代價或付款到期前將貨品或服務轉讓予客戶，則就附帶條件的已賺取代價確認合約資產。合約資產須作減值評估，其詳情載於金融資產減值的會計政策。

Contract costs

Other than the costs which are capitalised as inventories, property, plant and equipment and intangible assets, costs incurred to fulfil a contract with a customer are capitalised as an asset if all of the following criteria are met:

- (a) The costs relate directly to a contract or to an anticipated contract that the entity can specifically identify.
- (b) The costs generate or enhance resources of the entity that will be used in satisfying (or in continuing to satisfy) performance obligations in the future.
- (c) The costs are expected to be recovered.

The capitalised contract costs are amortised and charged to profit or loss on a systematic basis that is consistent with the transfer to the customer of the goods or services to which the asset relates. Other contract costs are expensed as incurred.

Share-based payments

The Company operates a share option scheme for the purpose of providing incentives and rewards to eligible participants who contribute to the success of the Group's operations. Employees (including directors) of the Group receive remuneration in the form of share-based payments, whereby employees render services as consideration for equity instruments ("equity-settled transactions").

The cost of equity-settled transactions with employees for grants is measured by reference to the fair value at the date at which they are granted. The fair value is determined by an external valuer using a binomial model.

除作為存貨、物業、廠房及設備及無形資產資本化的成本外，倘若符合以下所有條件，履行與客戶的合約成本則資本化為資產：

以股份為基礎的付款

本公司設有購股權計劃，旨在向為本集團業務成功作出貢獻的合資格參與者提供獎勵及回報。本集團僱員(包括董事)按以股份為基礎的付款形式收取酬金，而僱員則提供服務作為股本工具的代價(「股權結算交易」)。

因授予而與僱員進行股權結算交易的成本，乃參考購股權授出之日的公平值計量。公平值乃由外部估值師採用二項式模型釐定。

The cost of equity-settled transactions is recognised in employee benefit expense, together with a corresponding increase in equity, over the period in which the performance and/or service conditions are fulfilled. The cumulative expense recognised for equity-settled transactions at the end of each reporting period until the vesting date reflects the extent to which the vesting period has expired and the Group's best estimate of the number of equity instruments that will ultimately vest. The charge or credit to the consolidated statement of profit or loss and other comprehensive income for a period represents the movement in the cumulative expense recognised as at the beginning and end of that period.

Service and non-market performance conditions are not taken into account when determining the grant date fair value of awards, but the likelihood of the conditions being met is assessed as part of the Group's best estimate of the number of equity instruments that will ultimately vest. Market performance conditions are reflected within the grant date fair value. Any other conditions attached to an award, but without an associated service requirement, are considered to be non-vesting conditions. Non-vesting conditions are reflected in the fair value of an award and lead to an immediate expensing of an award unless there are also service and/or performance conditions.

For awards that do not ultimately vest because non-market performance and/or service conditions have not been met, no expense is recognised. Where awards include a market or non-vesting condition, the transactions are treated as vesting irrespective of whether the market or non-vesting condition is satisfied, provided that all other performance and/or service conditions are satisfied.

Where the terms of an equity-settled award are modified, as a minimum an expense is recognised as if the terms had not been modified, if the original terms of the award are met. In addition, an expense is recognised for any modification that increases the total fair value of the share-based payments, or is otherwise beneficial to the employee as measured at the date of modification.

在釐定獎勵於授予日期的公平值時，服務及非市場績效條件均不予考慮，但會評估符合該等條件的可能性，作為本集團就最終將予歸屬的股本工具數目作出最佳估計的部分工作。市場績效條件在授予日期公平值中反映。某項獎勵附帶的任何其他條件(但並無相關的服務要求)被視為非歸屬條件。非歸屬條件在獎勵的公平值中反映，並導致即時支銷獎勵，除非同時存在服務及／或績效條件。

Where an equity-settled award is cancelled, it is treated as if it had vested on the date of cancellation, and any expense not yet recognised for the award is recognised immediately. This includes any award where non-vesting conditions within the control of either the Group or the employee are not met. However, if a new award is substituted for the cancelled award, and is designated as a replacement award on the date that it is granted, the cancelled and new awards are treated as if they were a modification of the original award, as described in the previous paragraph.

The dilutive effect of outstanding options is reflected as additional share dilution in the computation of earnings per share.

Other employee benefits

Pension schemes

The employees of the Group's subsidiaries which operate in Mainland China are required to participate in a central pension scheme operated by the local municipal government. These subsidiaries are required to contribute a certain percentage of their payroll costs to the central pension scheme. The contributions are charged to profit or loss as they become payable in accordance with the rules of the central pension scheme. The employer contributions vest fully once made.

The Group also operates a defined contribution Mandatory Provident Fund retirement benefit scheme in Hong Kong (the "MPF Scheme") under the Hong Kong Mandatory Provident Fund Schemes Ordinance for those employees who are eligible to participate in the MPF Scheme. Contributions are made based on a percentage of the employees' basic salaries and are charged to the profit or loss as they become payable in accordance with the rules of the MPF Scheme. The assets of the MPF Scheme are held separately from those of the Group in an independently administered fund. The Group's employer contributions vest fully with the employees when contributed into the MPF Scheme.

其他僱員福利

退休金計劃

本集團於中國內地經營的附屬公司僱員須參與地方市政府設立的中央退休金計劃。該等附屬公司須按工資的一定百分比向中央退休金計劃供款。供款於按照中央退休金計劃的規定須予支付時計入損益。僱主之供款於其作出時即悉數歸屬。

本集團亦遵照香港強制性公積金計劃條例，在香港為該等合資格參與強積金計劃之僱員設立一項定額供款強制性公積金退休福利計劃(「強積金計劃」)。供款按僱員基本薪金之某一百分比計算，並於根據強積金計劃規則須支付時自損益表扣除。強積金計劃資產由獨立管理基金保管，與本集團資產分開持有。本集團對強積金計劃作出之僱主供款悉數歸屬於僱員。

Short term employee benefits

Short term employee benefit obligations are measured on an undiscounted basis and are expensed as the related service is provided.

Housing fund and other social insurances

The Group has participated in defined social security contribution schemes for its employees pursuant to the relevant laws and regulations of the PRC. These include a housing fund, basic medical insurance, unemployment insurance, injury insurance and maternity insurance. The Group makes monthly contributions to the housing fund and other social insurances. The contributions are charged to profit or loss on an accrual basis. The Group has no further obligations beyond the contributions made.

Termination benefits

Termination benefits are recognised at the earlier of when the Group can no longer withdraw the offer of those benefits and when the Group recognises restructuring costs involving the payment of termination benefits.

Borrowing costs

Borrowing costs directly attributable to the acquisition, construction or production of qualifying assets, i.e., assets that necessarily take a substantial period of time to get ready for their intended use or sale, are capitalised as part of the cost of those assets. The capitalisation of such borrowing costs ceases when the assets are substantially ready for their intended use or sale. Investment income earned on the temporary investment of specific borrowings pending their expenditure on qualifying assets is deducted from the borrowing costs capitalised. All other borrowing costs are expensed in the period in which they are incurred. Borrowing costs consist of interest and other costs that an entity incurs in connection with the borrowing of funds.

Dividends

Final dividends are recognised as a liability when they are approved by the shareholders in a general meeting.

Interim dividends are simultaneously proposed and declared, because the Company's memorandum and articles of association grant the directors the authority to declare interim dividends. Consequently, interim dividends are recognised immediately as a liability when they are proposed and declared.

短期僱員福利

短期僱員福利責任按未貼現基準計量，並在提供相關服務時支銷。

住房公積金及其他社會保險

本集團已根據中國有關法律法規為其僱員參與定額社會保障供款計劃，包括住房公積金、基本醫療保險、失業保險、工傷保險和生育保險。本集團每月向住房公積金及其他社會保險作出供款。有關供款按照應計基準自損益扣除。本集團除作出供款外並無其他責任。

終止福利

終止福利於本集團不再能撤銷提供該等福利及本集團確認涉及支付終止福利時的重組成本(以較早者為準)時確認。

借款成本

收購、建造或生產合資格資產(即需經過相當長時間才可供作其擬定用途或出售的資產)的直接應佔借款成本按該等資產的部分成本予以資本化。當資產大致可作其擬定用途或出售時，該等借款成本終止作資本化。在特定借款用作合資格資產的開支前將其暫時投資所賺取的投資收入乃自資本化借款成本中扣除。所有其他借款成本於產生期間支銷。借款成本包括實體就借入資金產生的利息和其他成本。

股息

末期股息經股東在股東大會上批准後，則確認為負債。

由於本公司的組織章程大綱及細則授予董事權力宣派中期股息，故中期股息乃同時建議及宣派。因此，中期股息乃於建議及宣派時即時確認為負債。

Foreign currencies

The consolidated financial statements are presented in RMB, which is the Company's functional currency. Each entity in the Group determines its own functional currency and items included in the financial statements of each entity are measured using that functional currency. Foreign currency transactions recorded by the entities in the Group are initially recorded using their respective functional currency rates prevailing at the dates of the transactions. Monetary assets and liabilities denominated in foreign currencies are translated at the functional currency rates of exchange ruling at the end of the year. Differences arising on settlement or translation of monetary items are recognised in profit or loss.

Non-monetary items that are measured in terms of historical cost in a foreign currency are translated using the exchange rates at the dates of the initial transactions. Non-monetary items measured at fair value in a foreign currency are translated using the exchange rates at the date when the fair value was measured. The gain or loss arising on translation of a non-monetary item measured at fair value is treated in line with the recognition of the gain or loss on change in fair value of the item (i.e., translation difference on the item whose fair value gain or loss is recognised in other comprehensive income or profit or loss is also recognised in other comprehensive income or profit or loss, respectively).

In determining the exchange rate on initial recognition of the related asset, expense or income on the derecognition of a non-monetary asset or non-monetary liability relating to an advance consideration, the date of initial transaction is the date on which the Group initially recognises the non-monetary asset or non-monetary liability arising from the advance consideration. If there are multiple payments or receipts in advance, the Group determines the transaction date for each payment or receipt of the advance consideration.

As at the end of the year, the assets and liabilities of the entities whose functional currencies differ from the presentation currency are translated into RMB at the exchange rates prevailing at the end of the reporting period and the consolidated statements of profit or loss are translated into RMB at the exchange rates that approximate to those prevailing at the dates of the transactions.

(i) Accounting for service concession arrangements

The Group engages in certain service concession arrangements in which the Group carries out construction work of the WTPs, RWTPs, WDPs, STPs or other municipal infrastructure for the Grantors and receives in return the rights to operate the WTPs, RWTPs, WDPs, STPs or other municipal infrastructure concerned in accordance with the pre-established conditions set by the Grantors. In accordance with IFRIC 12 *Service Concession Arrangements*, the WTPs, RWTPs, WDPs, STPs or other municipal infrastructure under the service concession arrangements may be classified as intangible assets or financial assets. The WTPs, RWTPs, WDPs, STPs or other municipal infrastructure are classified as intangible assets if the Group receives a right (a licence) to charge users of the public service or if the Grantors remunerate the Group on the basis of the extent of use of the WTPs, RWTPs, WDPs, STPs or other municipal infrastructure by users, but with no guarantees as to the amounts that will be paid to the Group. Whenever only part of the investment by the Group under these service concession arrangements is covered by a payment commitment from the Grantors, it is recognised as a financial receivable up to the amount guaranteed by the Grantors, and as an intangible asset for the balance. The Group recognises a financial receivable if it has an unconditional contractual right under the service concession arrangements to receive a determinable amount of payments during the concession period irrespective of the usage of the WTPs, RWTPs, WDPs, STPs or other municipal infrastructure.

本集團經營若干服務特許經營安排，據此，本集團為授予人進行污水處理廠、再生水處理廠、供水廠、污泥處理廠或其他市政基礎設施的建設工程，以根據授予人先前訂下的條件取得經營污水處理廠、再生水處理廠、供水廠、污泥處理廠或其他市政基礎設施的權利作為回報。根據國際財務報告詮釋委員會詮釋第12號*服務特許經營安排*，服務特許經營安排項下的污水處理廠、再生水處理廠、供水廠、污泥處理廠或其他市政基礎設施可分類為無形資產或金融資產。污水處理廠、再生水處理廠、供水廠、污泥處理廠或其他市政基礎設施於本集團獲得權利(權限)向公用服務使用者收取費用或授予人按照使用者使用污水處理廠、再生水處理廠、供水廠、污泥處理廠或其他市政基礎設施的情況對本集團作出補償(但不保證將支付予本集團的金額)時分類為無形資產。倘本集團於這些服務特許經營安排下的投資只有部分可由授予人的付款承諾彌補，則按授予人保證的最高金額確認為金融應收款項，而餘額則確認為無形資產。如本集團根據服務特許權安排獲得無條件合約權利於特許經營期間收取可確定數額的款項(不論污水處理廠、再生水處理廠、供水廠、污泥處理廠或其他市政基礎設施的用途)，將確認金融應收款項。

Subsequent to initial recognition, the financial receivable is measured at amortised cost using the effective interest method.

Revenue from the construction service under the terms of service concession arrangements is estimated on a cost-plus basis with reference to a prevailing market rate of gross margin at the date of agreement applicable to similar construction services rendered in similar locations, and is recognised on the percentage of completion method, measured by reference to the proportion of costs incurred to date to the estimated total cost of the relevant contract. The Group's prevailing margins of gross construction margin were valued by Crowe Horwath First Trust Appraisal Pte Ltd ("Crowe Horwath"), an independent third-party valuer that has appropriate qualifications and recent experience in the valuation of gross construction margin.

When the Group receives a payment during the concession period, it will apportion such payment among (i) a repayment of the financial receivables (if any), which will be used to reduce the carrying amount of the financial receivables on the statement of financial position, (ii) interest income, which will be recognised as revenue in profit or loss and (iii) revenue from operating and maintaining the WTPs, RWTPs, WDPs, STPs or other municipal infrastructure in profit or loss.

Judgement is also exercised in determining the fair value of the financial receivables. Discount rates, estimates of future cash flows and other factors are used in the valuation process.

服務特許經營安排條款下的建設服務收益乃參考適用於協議日期在類似地點提供類似建設服務現行的市場毛利率，按成本加成基準估計，並按竣工百分比法(參考至今所產生成本佔相關合約估計成本總額的比例計量)確認。本集團建設毛利潤率的當時費率由獨立第三方估值師 Crowe Horwath First Trust Appraisal Pte Ltd (「國富浩華」) 估值；該估值師具有評估建設毛利潤率方面的合適資格及近期經驗。

本集團於特許經營期內收到款項時，會將有關款項分配至(i)償還金融應收款項(如有)，用以減少財務狀況表金融應收款項的賬面值，(ii)利息收入(將於損益確認為收益)及(iii)污水處理廠、再生水處理廠、供水廠、污泥處理廠或其他市政基礎設施運營及維護收益(於損益確認)。

(ii) Accounting for EPC arrangements

The Group seeks to collect claims from the customers as reimbursement of costs and margins for scope of works not included in the original construction contract, which give rise to variable consideration. The Group determined that the expected value method is the appropriate method to use in estimating the variable consideration for claims in construction services, given there is a wide range of possible outcomes which are subject to negotiations with third parties.

Before including any amount of variable consideration in the transaction price, the Group considers whether the amount of variable consideration is constrained. The Group determined that the estimates of variable consideration are not constrained based on its historical experience, current negotiations with customers, profitability of the head contracts of the customers and the current economic conditions.

Withholding tax arising from the distribution of dividends

The Group's determination as to whether to accrue for withholding taxes arising from the distributions of dividends from certain subsidiaries according to the relevant tax jurisdictions is subject to judgement on the timing of the payment of the dividends or on whether certain subsidiaries of the Group are determined to be Chinese resident enterprises by the PRC governing tax authorities in the future. Management considered that it is not probable that the Group's subsidiaries in the PRC will distribute retained profits as at the end of the year in the foreseeable future, and accordingly no additional provision for withholding tax was made. Where the final outcome of these matters is different from the amounts originally rewarded, the difference will impact the deferred tax provision in the period in which the difference arises.

(ii) EPC 安排的會計處理

本集團尋求向客戶收取賠償，作為原始建設合約未包含工程範圍的成本及保證金的補償，從而產生可變代價。鑒於存在多種可能結果需要與第三方協商，本集團認為預期價值法為用於估計建設服務索償可變代價的最佳方法。

將任何數額可變代價納入交易價格之前，本集團會考慮可變代價金額是否受到約束。根據歷史經驗、與客戶的當前談判、客戶總承包的盈利能力及當前經濟狀況，本集團認為可變代價的估計不受約束。

派發股息產生的預扣稅

本集團釐定是否根據相關稅務司法權區累計若干附屬公司派發股息產生的預扣稅，乃視乎對派付股息的時間或中國規管稅務機關會否於日後釐定本集團若干附屬公司為中國居民企業的判斷而定。管理層認為於可見將來，本集團的中國附屬公司將不大可能於年末派發保留溢利，故並無作出額外預扣稅撥備。如該等事宜的最終結果與原先獲獎勵的金額不同，有關差額將對出現差額期間的遞延稅項撥備造成影響。

Estimation uncertainty

The key assumptions concerning the future and other key sources of estimation uncertainty at the end of the year, that have a significant risk of causing a material adjustment to the carrying amounts of assets and liabilities within the next financial year, are described below.

Useful lives and residual values of items of property, plant and equipment

In determining the useful lives and residual values of items of property, plant and equipment, the Group periodically reviews the changes in market conditions, expected physical wear and tear, and the maintenance of the asset. The estimation of the useful life of the asset is based on historical experience of the Group with similar assets that are used in a similar way. Depreciation amount will be adjusted if the estimated useful lives and/or the residual values of items of property, plant and equipment are different from previous estimation. Useful lives and residual values are reviewed, at the end of the year, based on changes in circumstances.

Current income tax and deferred income tax

The Group is subject to income taxes in Hong Kong and Mainland China. Estimation is required in determining the provision for taxation. There are many transactions and calculations for which the ultimate tax determination is uncertain during the ordinary course of business. Where the final tax outcome of these matters is different from the amounts originally recorded, the differences will impact on the current income tax and deferred income tax in the periods in which the differences arise. Deferred tax assets relating to certain temporary differences or unused tax losses are recognised as management considers it is probable that future taxable profit will be available against which the temporary differences or the unused losses can be utilised.

The realisation of the deferred tax assets mainly depends on whether sufficient future profits will be available in the future. In cases where the actual future profits generated are less than expected, a material reversal of deferred tax assets may arise, which will be recognised in profit or loss in the period in which such a reversal takes place. Details of deferred tax assets are contained in note 20 to the consolidated financial statements.

下文闡述有重大風險可能導致下一財政年度資產及負債的賬面值作重大調整的與日後有關的重要假設及於年末其他重要的估計不確定性來源。

物業、廠房及設備項目的可使用年期及剩餘價值

在釐定物業、廠房及設備項目的可使用年期及剩餘價值時，本集團會定期檢討資產的市場情況變動、預期實物耗損及維護。資產的可使用年期乃根據本集團過往按類似方式使用的類似資產的經驗估計。如物業、廠房及設備項目的估計可使用年期及／或剩餘價值與先前的估計不同，將對折舊金額作出調整。可使用年期及剩餘價值會根據情況變動於年末檢討。

即期所得稅及遞延所得稅

本集團須在香港及中國內地繳付所得稅。在釐定稅項撥備時須作出估計。在日常業務過程中，很多交易及計算的最終稅項釐定並不確定。當有關事項的末期稅項結果有別於初始記錄金額時，有關差額將影響即期所得稅及差異產生期間的遞延所得稅撥備。與若干暫時差額或未動用稅務虧損有關的遞延稅項資產於管理層認為日後可能有可供動用暫時差額或未動用稅務虧損的應課稅溢利時確認。

遞延稅項資產的變現主要取決於未來是否有可供動用的充足未來溢利。如產生的實際未來溢利較預期為少，可能會出現重大遞延稅項資產撥回，撥回於產生期間在損益確認。遞延稅項資產的詳情載於綜合財務報表附註20。

Percentage of completion of construction services

The Group recognises revenue according to the percentage of completion of individual contracts of construction works, which requires estimation to be made by management. The stage of completion is estimated by reference to the actual costs incurred over the total budgeted costs. Due to the nature of the activity undertaken in construction works, the date on which the activity commences and the date on which the activity completes usually fall into different accounting periods. Hence, the Group reviews and revises the percentage of completion of construction works. Where the actual contract revenue is less than expected or actual contract costs are more than expected, a foreseeable loss may arise.

Estimation of total budgeted costs and cost to completion for construction services

Total budgeted costs for construction contracts comprise (i) direct material costs and direct labour, (ii) costs of subcontracting, and (iii) an appropriation of variable and fixed construction overheads. In estimating the total budgeted costs for construction contracts, management refers to information such as (i) current offers from sub-contractors and suppliers, (ii) recent offers agreed with sub-contractors and suppliers, and (iii) professional estimation on material costs, labour costs and other costs.

Provision for expected credit losses on trade receivables, financial receivables and contract assets

The Group uses a provision matrix to calculate ECLs for trade receivables, financial receivables and contract assets. The provision rates are based on days past due for groupings of various customer segments that have similar loss patterns (i.e., by geography, product type, customer type and rating, and coverage by letters of credit and other forms of credit insurance).

建設服務竣工百分比

本集團根據建設工程個別合約的竣工百分比確認收益，而該確認需要管理層作出估計。竣工階段經參考總預算成本產生的實際成本後進行估計。由於建設工程所進行活動的性質，活動開始日期及活動竣工日期一般屬於不同會計期間。因此，本集團會對建設工程竣工百分比進行審閱及修訂。如實際合約收益低於預期或實際合約成本高於預期，則可能產生可預見虧損。

建設服務的預算成本總額及完工成本估計

建設合約的總預算成本包括(i)直接物料成本及直接工資、(ii)分包成本，及(iii)適當比例的可變及固定建設費用。估計建設合約的總預算成本時，管理層會參考有關資料，例如(i)分包商及供應商的目前報價、(ii)分包商及供應商協定的近期報價、及(iii)有關物料成本、勞工成本及其他成本的專業估計。

貿易應收款項、金融應收款項及合約資產預期信貸虧損撥備

本集團使用撥備矩陣計算貿易應收款項、金融應收款項及合約資產預期信貸虧損撥備。撥備率乃根據具備類似虧損型態(即按地區、產品類別及評級以及以信用證及其他信用保險形式的保障劃分)的各類客戶分部逾期日數計算。

The provision matrix is initially based on the Group's historical observed default rates. The Group will calibrate the matrix to adjust the historical credit loss experience with forward-looking information. For instance, if forecast economic conditions (i.e., gross domestic products) are expected to deteriorate over the next year which can lead to an increased number of defaults in the manufacturing sector, the historical default rates are adjusted. At each reporting date, the historical observed default rates are updated and changes in the forward-looking estimates are analysed.

The assessment of the correlation among historical observed default rates, forecast economic conditions and ECLs is a significant estimate. The amount of ECLs is sensitive to changes in circumstances and forecast economic conditions. The Group's historical credit loss experience and forecast of economic conditions may also not be representative of a customer's actual default in the future. The information about the ECLs on the Group's financial receivables, trade receivables and contract assets is disclosed in note 19, note 21 and note 23 to the financial statements, respectively.

Financial receivables

Estimation is exercised in determining the fair values of the financial receivables at initial recognition. These fair values are computed on the discounted cash flow method using a discount rate based upon the market-related rate for a similar instrument as at the date of initial recognition. The assumptions and estimates used can materially affect the fair values of the financial receivables.

Impairment of goodwill

The Group determines whether goodwill is impaired at least on an annual basis. This requires an estimation of the value in use of the cash-generating units to which the goodwill is allocated. Estimating the value in use requires the Group to make an estimate of the expected future cash flows from the cash-generating units and also to choose a suitable discount rate in order to calculate the present value of those cash flows. Further details are given in note 18.

貿易應收款項、金融應收款項及合約資產預期信貸虧損撥備(續)

撥備矩陣最初基於本集團觀察所得的歷史違約率計算。本集團將透過調整矩陣方式，藉以透過前瞻性資料對過往信貸虧損經驗作出調整。例如，倘預測經濟狀況(即國內生產總值)預計將於未來一年內惡化，可能導致製造分部違約數量增加，過往違約率因而得到調整。於各報告日期，觀察所得的歷史違約率將會更新，並分析前瞻性評估變動。

觀察所得的歷史違約率、預測經濟狀況及預期信貸虧損之間的關聯性評估屬一項重大估計。預期信貸虧損金額對環境變化及預測經濟狀況表現敏感。本集團歷史信貸虧損經驗及對經濟狀況所作預測可能未必意味著客戶日後實際違約。有關本集團金融應收款項、貿易應收款項及合約資產的預期信貸虧損的資料分別於財務報表附註19、附註21及附註23披露。

金融應收款項

在釐定金融應收款項於初步確認的公平值時會作出估計。有關公平值乃根據於初步確認日期類似工具的市場相關利率按照使用貼現率的貼現現金流量法計算。使用的假設及估計可能對金融應收款項的公平值產生重大影響。

商譽減值

本集團最少每年一次釐定商譽有否減值。此舉須估計獲分配商譽的現金產生單位的使用價值。本集團估計使用價值，須要估計現金產生單位的預期未來現金流量，以及須選出合適的貼現率，以計算該等現金流量的現值。進一步詳情載於附註18。

Leases — Estimating the incremental borrowing rate

The Group cannot readily determine the interest rate implicit in a lease, and therefore, it uses an incremental borrowing rate (“IBR”) to measure lease liabilities. The IBR is the rate of interest that the Group would have to pay to borrow over a similar term, and with a similar security, the funds necessary to obtain an asset of a similar value to the right-of-use asset in a similar economic environment. The IBR therefore reflects what the Group “would have to pay”, which requires estimation when no observable rates are available (such as for subsidiaries that do not enter into financing transactions) or when it needs to be adjusted to reflect the terms and conditions of the lease. The Group estimates the IBR using observable inputs when available and is required to make certain entity-specific estimates.

Impairment of non-financial assets (other than goodwill)

The Group assesses whether there are any indicators of impairment for all non-financial assets (including the right-of-use assets) at the end of each reporting period. Indefinite life intangible assets are tested for impairment annually and at other times when such an indicator exists. Other non-financial assets are tested for impairment when there are indicators that the carrying amounts may not be recoverable. An impairment exists when the carrying value of an asset or a cash-generating unit exceeds its recoverable amount, which is the higher of its fair value less costs of disposal and its value in use. The calculation of the fair value less costs of disposal is based on available data from binding sales transactions in an arm’s length transaction of similar assets or observable market prices less incremental costs for disposing of the asset. When value in use calculations are undertaken, management must estimate the expected future cash flows from the asset or cash-generating unit and choose a suitable discount rate in order to calculate the present value of those cash flows.

租賃 — 估計增量借款利率

本集團未能輕易釐定租賃的隱含利率，因此，其使用增量借款利率(「IBR」)計量租賃負債。IBR為本集團於類似經濟環境中為取得與使用權資產價值相近之資產，而以類似抵押品於類似期間借入所需資金應支付之利率。因此，IBR反映了本集團「應支付」的利率，當無可觀察的利率時(如就並無訂立融資交易的附屬公司而言)或當須對利率進行調整以反映租賃的條款及條件時，則須作出利率估計。當可觀察輸入數據可用時，本集團使用可觀察輸入數據估算IBR並須作出若干實體特定的估計。

非金融資產(商譽除外)減值

本集團於各報告期末評估全部非金融資產(包括使用權資產)是否存在任何減值跡象。具無限年期的無形資產將於每年及出現減值跡象時進行減值測試。其他非金融資產將於有跡象顯示其賬面值可能不可收回時進行減值測試。當一項資產或現金產生單位的賬面值超過其可收回金額時即存在減值，減值為其公平值減出售成本與其使用價值兩者中的較高者。公平值減出售成本乃根據來自類似資產公平交易的受約束銷售交易的可用數據或可觀察市價減出售資產的增量成本計算。採用使用價值計算時，管理層必須估計來自資產或現金產生單位的未來預計現金流量，並選擇適當的折現率，以計算上述現金流量現值。

3. OPERATING SEGMENT INFORMATION

For management purposes, the Group's operating businesses are structured and managed separately according to their nature. Each of the Group's operating segments represents a strategic business unit that provides services which are subject to risks and returns that are different from those of the other operating segments. Summary details of the operating segments are as follows:

- (a) the segment of Urban Water Treatment engages in the design, construction, upgrade and operation of WTPs, RWTPs, STPs and WDPs, and in the operation and maintenance of waste water treatment facilities entrusted by governments ("O&M");
- (b) the segment of Water Environment Comprehensive Remediation engages in river harnessing and improvement, foul water body treatment, sponge city construction; and
- (c) the segment of Rural Water Improvement engages in the construction and operation related to "the Water Environment Facilities of Beautiful Village" such as: waste water treatment facilities and pipeline construction for collecting waste water so as to achieve rural living environment improvement.

3. 經營分部資料

為方便管理，本集團經營業務的結構及管理乃按其性質分開處理。本集團各經營分部代表一個戰略業務單位，提供的服務涉及的風險及回報與其他經營分部不同。經營分部的詳情概述如下：

The Group has entered into a number of service concession arrangements with the Grantors on a BOT or a TOT basis in respect of its WTPs, RWTPs, WDPs, STPs or other municipal infrastructure. These service concession arrangements generally involve the Group as an operator in (i) constructing WTPs, RWTPs, WDPs, STPs or other municipal infrastructure for those arrangements on a BOT basis; (ii) paying a specific amount for those arrangements on a TOT basis; and (iii) operating WTPs, RWTPs, WDPs, STPs or other municipal infrastructure on behalf of the Grantors for periods ranging from 17 to 30 years (the "Service Concession Periods"), and the Group will be paid for its services over the Service Concession Periods at prices stipulated through a pricing mechanism.

The Group carries out construction works of other municipal infrastructure under EPC arrangements and agrees with EPC customers to enter into a settled agreement for the construction work during the construction.

Revenue represents: (i) an appropriate proportion of contract revenue from construction contracts under BOT arrangements, EPC arrangements and other construction service projects, net of tax and government surcharges; (ii) revenue from operation of WTPs, RWTPs, WDPs, STPs or other municipal infrastructure under BOT arrangements and TOT arrangements and the provision of Operation and Maintenance services; (iii) revenue from sales of water purifying materials; and (iv) financial income on financial receivables. Pursuant to The PRC Enterprise Income Tax Law Implementing Regulations (中華人民共和國企業所得稅法實施條例), most of the subsidiaries established in the PRC, engaged in the operations of waste water treatment projects, are eligible for tax holiday of a three-year full exemption followed by a three-year half exemption commencing from their respective first years of generating operating revenue (the "3+3 Tax Holiday"). At the end of the year, these subsidiaries were qualified for the 3+3 Tax Holiday or in the process of preparation and submission of the required documents to the respective tax authorities to apply for the 3+3 Tax Holiday.

Pursuant to Caishui [2011] No.58 Circular of the Ministry of Finance, the State Administration of Taxation, the General Administration of Customs on Issues Relating to Preferential Tax Policies for the Development of the Western Region (財政部、國家稅務總局、海關總署關於西部大開發稅收優惠政策問題的通知), certain subsidiaries operated in the western region of Mainland China are entitled to a preferential corporate income tax rate of 15%, provided that the main business of the subsidiaries belongs to the industrial projects stipulated in the Catalogue of Encouraged Industries in the Western Region, and such main business income accounts for more than 70% of the total income of the subsidiaries.

Under the relevant PRC Corporate Income Tax Law and respective regulations, except for the preferential treatments available to certain subsidiaries as mentioned above, other subsidiaries within the Group were subject to corporate income tax at the statutory rate of 25%.

Pursuant to the rules and regulations of the Cayman Islands and the British Virgin Islands, the Group is not subject to any income tax in the Cayman Islands and British Virgin Islands.

Impairment testing of goodwill

Goodwill acquired through business combinations in the amount of approximately RMB60,219,000 as at 31 December 2021 has been allocated to the cash-generating units of "waste water treatment plant" and "the manufacture of chemicals for waste water treatment" for impairment testing.

The recoverable amounts of the cash-generating units of "waste water treatment plant" and "the manufacture of chemicals for waste water treatment" have been determined based on a value in use calculation using cash flow projections based on a financial budget covering a three-year period approved by the Group. The pre-tax discount rate applied to the cash flow projections is 10.67%.

In the annual goodwill impairment assessment, the Group concluded that the carrying amount of “the manufacture of chemicals for waste water treatment” exceeded its recoverable amount and recorded impairment losses of RMB1,894,000 during the year ended 31 December 2021.

Assumptions were used in the value in use calculation of the “waste water treatment plant” and “the manufacture of chemicals for waste water treatment” cash-generating units for 31 December 2021. The following describes each key assumption on which management has based its cash flow projections to undertake impairment testing of goodwill:

Budgeted gross margins — The basis used to determine the value assigned to the budgeted gross margins is the average gross margins achieved in the year immediately before the budget year, increased for expected efficiency improvements, and expected market development.

Discount rates — The discount rates used are before tax and reflect specific risks relating to the relevant units.

Price inflation — The basis used to determine the value assigned to price inflation is the forecast price indices during the budget year for the relevant markets.

The values assigned to the key assumptions on market development of waste water treatment plant and the manufacture of chemicals for waste water treatment, discount rates and price inflation are consistent with external information sources.

The Group also has tax losses arising in Mainland China of RMB289,511,000 (2020: RMB280,554,000) that will expire in one to five years for offsetting against future taxable profits.

Pursuant to the PRC Corporate Income Tax Law, a 10% withholding tax is levied on dividends declared to foreign investors from the foreign investment enterprises established in Mainland China. The requirement is effective from 1 January 2008 and applies to earnings after 31 December 2007. A lower withholding tax rate may be applied if there is a tax treaty between Mainland China and the jurisdiction of the foreign investors. For the Group, the applicable rate is 5% or 10%. The Group is therefore liable to withholding taxes on dividends distributed by those subsidiaries established in Mainland China in respect of earnings generated from 1 January 2008.

At 31 December 2021, no deferred tax liability has been recognised for withholding taxes that would be payable on unremitted earnings that are subject to withholding taxes of the Group's subsidiaries established in Mainland China. In the opinion of the directors, it is not probable that these subsidiaries will distribute such earnings in the foreseeable future. The aggregate amount of temporary differences associated with investments in subsidiaries in Mainland China for which deferred tax liabilities have not been recognised totalled approximately RMB3,428,807,000 at 31 December 2021 (2020: RMB2,975,947,000).

There are no income tax consequences attaching to the payment of dividends by the Company to its shareholders.

At the end of the year, the finance department analyses the movements in the values of financial instruments and determines the major inputs applied in the valuation. The valuation is reviewed and approved by the chief financial officer.

The fair values of the financial assets and liabilities are included at the amount at which the instrument could be exchanged in a current transaction between willing parties, other than in a forced or liquidation sale. The following methods and assumptions were used to estimate the fair values:

The fair values of the non-current portion of financial receivables, prepayments, other receivables and other assets, trade and bills payables, interest-bearing bank and other borrowings, and corporate bonds have been calculated by discounting the expected future cash flows using rates currently available for instruments with similar terms, credit risk and remaining maturities. The changes in fair value as a result of the Group's own non-performance risks for trade and bills payables, interest-bearing bank and other borrowings, and corporate bonds as at the end of the year were assessed to be insignificant.

The fair values of unlisted equity investments designated at fair value through other comprehensive income have been estimated using a market-based valuation technique based on assumptions that are not supported by observable market prices or rates. The valuation requires the directors to determine comparable public companies (peers) based on industry, size, leverage and strategy, and to calculate an appropriate price multiple, such as price to book value (P/B), for each comparable company identified. The multiple is calculated by dividing the enterprise value of the comparable company by book value measure. The trading multiple is then discounted for considerations such as illiquidity and size differences between the comparable companies based on company-specific facts and circumstances. The discounted multiple is applied to the corresponding P/B of the unlisted equity investments to measure the fair value. The directors believe that the estimated fair values resulting from the valuation technique, which are recorded in the consolidated statement of financial position, and the related changes in fair values, which are recorded in other comprehensive income, are reasonable, and that they were the most appropriate values at the end of the reporting period.

39. FINANCIAL RISK MANAGEMENT OBJECTIVES AND POLICIES

The Group's principal financial instruments comprise interest-bearing bank and other borrowings, corporate bonds, cash and cash equivalents and pledged deposits. The main purpose of these financial instruments is to raise finance for the Group's operations. The Group has various other financial assets and liabilities such as financial receivables, trade and bills receivables and trade and bills payables, which arise directly from its operations.

The main risks arising from the Group's financial instruments are interest rate risk, credit risk, liquidity risk and foreign currency risk. Generally, the senior management of the Company meets regularly to analyse and formulate measures to manage the Group's exposure to these risks. In addition, the board of directors of the Company holds meetings regularly to analyse and approve the proposals made by the senior management of the Company. Generally, the Group introduces conservative strategies on its risk management. As the Group's exposure to these risks is kept to a minimum, the Group has not used any derivatives and other instruments for hedging purposes. The Group does not hold or issue derivative financial instruments for trading purposes. The board of directors of the Company reviews and agrees policies for managing these risks and they are summarised below.

(a) Interest rate risk

The Group's exposure to the risk of changes in market interest rates relates primarily to the Group's long term debt obligations with floating interest rates.

The Group regularly reviews and monitors the mix of fixed and floating interest rate borrowings in order to manage its interest rate risk. The Group's interest-bearing bank and other borrowings, corporate bonds, pledged deposits and cash and cash equivalents are stated at amortised cost and not revalued on a periodic basis. Floating rate interest income and expenses are credited/charged to profit or loss as earned/incurred.

If there would be a general increase/decrease in the market interest rates by one percentage point, with all other variables held constant, the Group's consolidated pre-tax profit would have decreased/increased by approximately RMB49,809,000 and RMB48,845,000 for the years ended 31 December 2021 and 2020, respectively, and there would be no impact on other components of the consolidated equity, except for retained profits, of the Group. The sensitivity analysis above has been determined assuming that the change in market interest rates had occurred at the end of the year and had applied the exposure to interest rate risk to those financial instruments in existence at that date.

(b) Credit risk

The carrying amounts of cash and cash equivalents, pledged deposits, trade and bills receivables, financial receivables and financial assets included in prepayments, other receivables and other assets represent the Group's maximum exposure to credit risk in relation to these financial assets. Substantially all of the Group's cash and cash equivalents and pledged deposits are held in major financial institutions located in Mainland China and Hong Kong, which management believes are of high credit quality. The Group has policies to control the size of the deposits to be placed with various reputable financial institutions according to their market reputation, operating scale and financial background with a view to limiting the credit exposure to each financial institution to an acceptable level.

The Group trades only with recognised and creditworthy third parties. In addition, receivable balances are monitored on an ongoing basis and the Group's exposure to bad debts is not significant.

As the Group's major customers are either PRC government authorities or agencies at the provincial and local levels or other state-owned enterprises, the Group believes that they are reliable and of high credit quality and hence, there is no significant credit risk with these customers. The senior management of the Company keeps reviewing and assessing the creditworthiness of the Group's existing customers on an ongoing basis.

Further quantitative data in respect of the Group's exposure to credit risk arising from trade receivables are disclosed in note 21 to the financial statements.

(b) 信用風險

現金及現金等價物、抵押存款、貿易應收款項及應收票據、金融應收款項及計入預付款項、其他應收款項及其他資產的金融資產的賬面值為本集團就該等金融資產所承受的最大信用風險。本集團絕大部分現金及現金等價物和抵押存款乃存放於位於中國內地及香港且管理層相信具有高信貸質素的主要金融機構。本集團設有政策根據不同知名金融機構的市場聲譽、運營規模和財政背景控制將存放於該等金融機構的存款數量，旨在將各金融機構的信用風險限制在可接受水平。

本集團僅與獲認可且信用可靠的第三方進行交易。此外，會持續監察應收款項結餘，而本集團的壞賬風險不大。

由於本集團主要客戶為中國省級及地方政府機構或代理或其他國有企業，本集團相信彼等可信賴及具有高信用質素，故該等客戶並無重大信用風險。本公司高級管理層會不斷檢討及評估本集團現有客戶的信用可靠性。

(e) Capital management

The Group's primary objectives for managing capital are to safeguard the Group's ability to continue as a going concern and to maintain healthy capital ratio in order to support its business and maximise shareholders' value.

The Group sets the amount of capital in proportion to risk. The Group manages its capital structure and makes adjustments to it in light of changes in economic conditions and the risk characteristics of the underlying assets. In order to maintain or adjust the capital structure, the Group may adjust the amount of dividends paid to shareholders, return capital to shareholders, issue new shares or sell assets to reduce debts. No change was made in the objectives, policies or processes for managing capital during the year.

The Group monitors capital using a gearing ratio, which is net debt divided by the capital plus net debt. Net debt includes trade and bills payables, certain other payables and accruals, interest-bearing bank and other borrowings, corporate bonds less cash and cash equivalents and pledged deposits. Capital includes the equity attributable to owners of the parent and non-controlling interests as stated in the consolidated statement of financial position.

The Group's strategy is to maintain the gearing ratio at a healthy capital level in order to support its businesses. The principal strategies adopted by the Group include, but are not limited to, reviewing future cash flow requirements and the ability to meet debt repayment schedules when they fall due, maintaining a reasonable level of available banking facilities and adjusting investment plans and financing plans, if necessary.
