Your proxy will also be entitled to vote at his discretion on any resolution properly put to the AGM other than those referred to in the notice convening the AGM.
- 6. This form of proxy must be signed by you or your attorney duly authorised in writing. In the case of a corporation, this form of proxy must be either under its common seal or under the hand of its director(s) or duly authorised attorney(s). If this form of proxy is signed by an attorney of the shareholder of the Company, the power of attorney authorizing that attorney to sign or other authorisation document must be notarised.
- More than one proxy may be appointed to attend and vote at the AGM on your behalf.
- 8. Any changes made to this proxy form shall be initialled by the person who signs this form.
- 9. In order to be valid, this form of proxy together with the power of attorney or other authorisation document (if any) must be deposited at the registered office of the Company (for holders of domestic shares of the Company), or at the Company's H share registrar, Computershare Hong Kong Investor Services Limited of 17M Floor, Hopewell Center, 183 Queen's Road East, Wanchai, Hong Kong, (for holders of H shares of the Company), not less than 24 hours before the time appointed for holding the AGM or any adjournment thereof (as the case may be).
- 10. Shareholders of the Company or their proxies attending the AGM shall produce their identity documents.
- 11. A proxy need not be a shareholder of the Company but must attend the AGM in person to represent you.
- Where there are joint registered holders of any share of the Company, any one of such joint holders may vote at the AGM, either personally or by proxy, in respect of such share as if he were solely entitled thereto provided that if more than one of such joint registered holders be present at the AGM personally or by proxy, the person whose name stands first on the register of shareholders in respect of such share shall alone be entitled to vote in respect thereof.
- 13. Completion and delivery of this form of proxy will not preclude you from attending and voting at the AGM or any adjournment thereof should you so wish. In the event that you attend the AGM, this form of proxy will be deemed to have been revoked.
