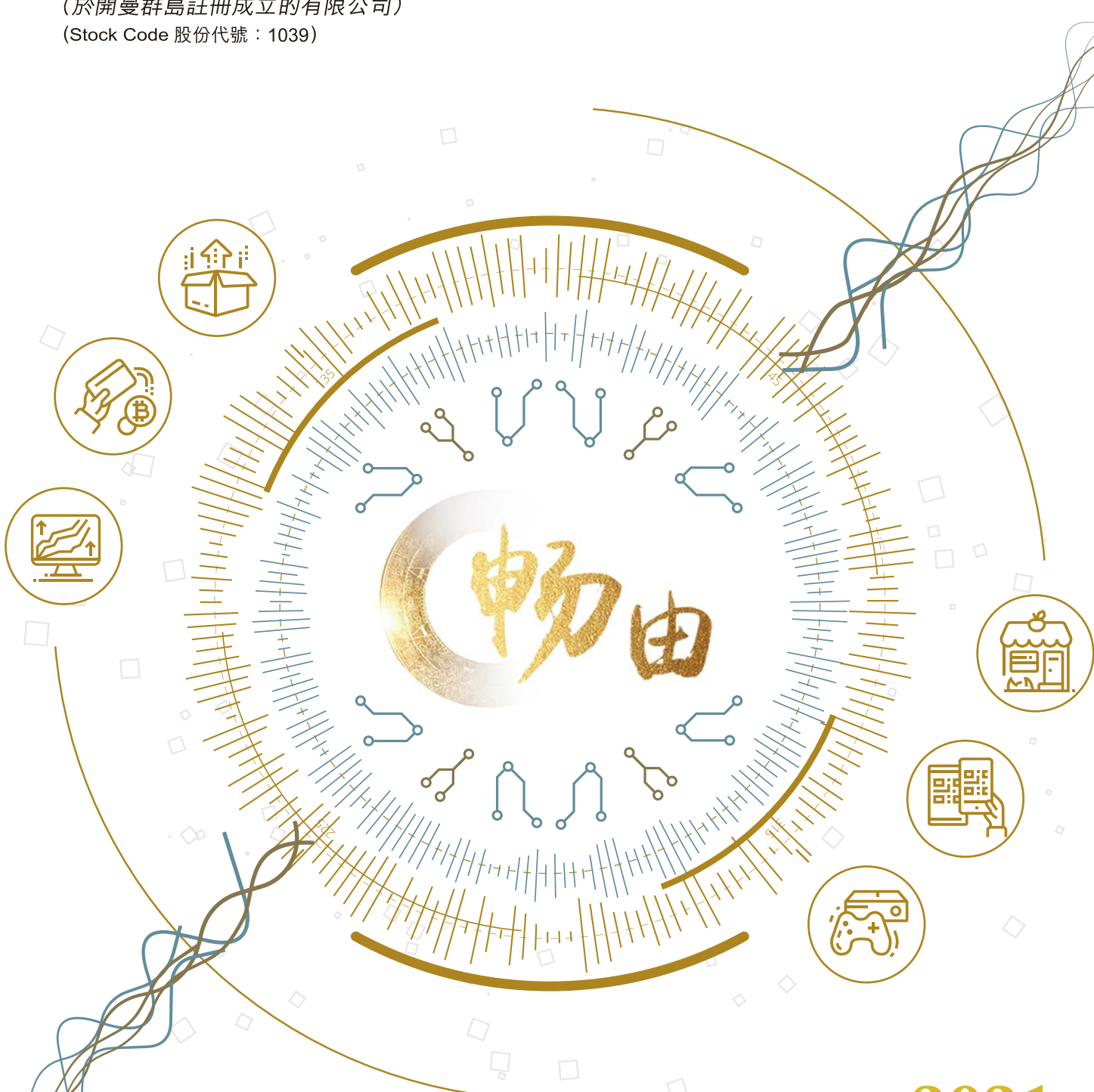

# GROUP INTRODUCTION

## 集團介紹

Changyou Alliance Group Limited (HK01039; Hong Kong Stock Exchange's website: <http://www.hkex.com.hk>) (the "Company" and, together with its subsidiaries, collectively the "Group"), together with CCB International, UnionPay Merchant, China Mobile, Bank of China and China Eastern Airlines formed a joint venture to develop a global "Digital Point Business Ecosystem Alliance" (the "Changyou Platform") and to create a new blue ocean of a brand new, sustainable and recyclable digital-points ecosystem by applying digital points as financial assets.

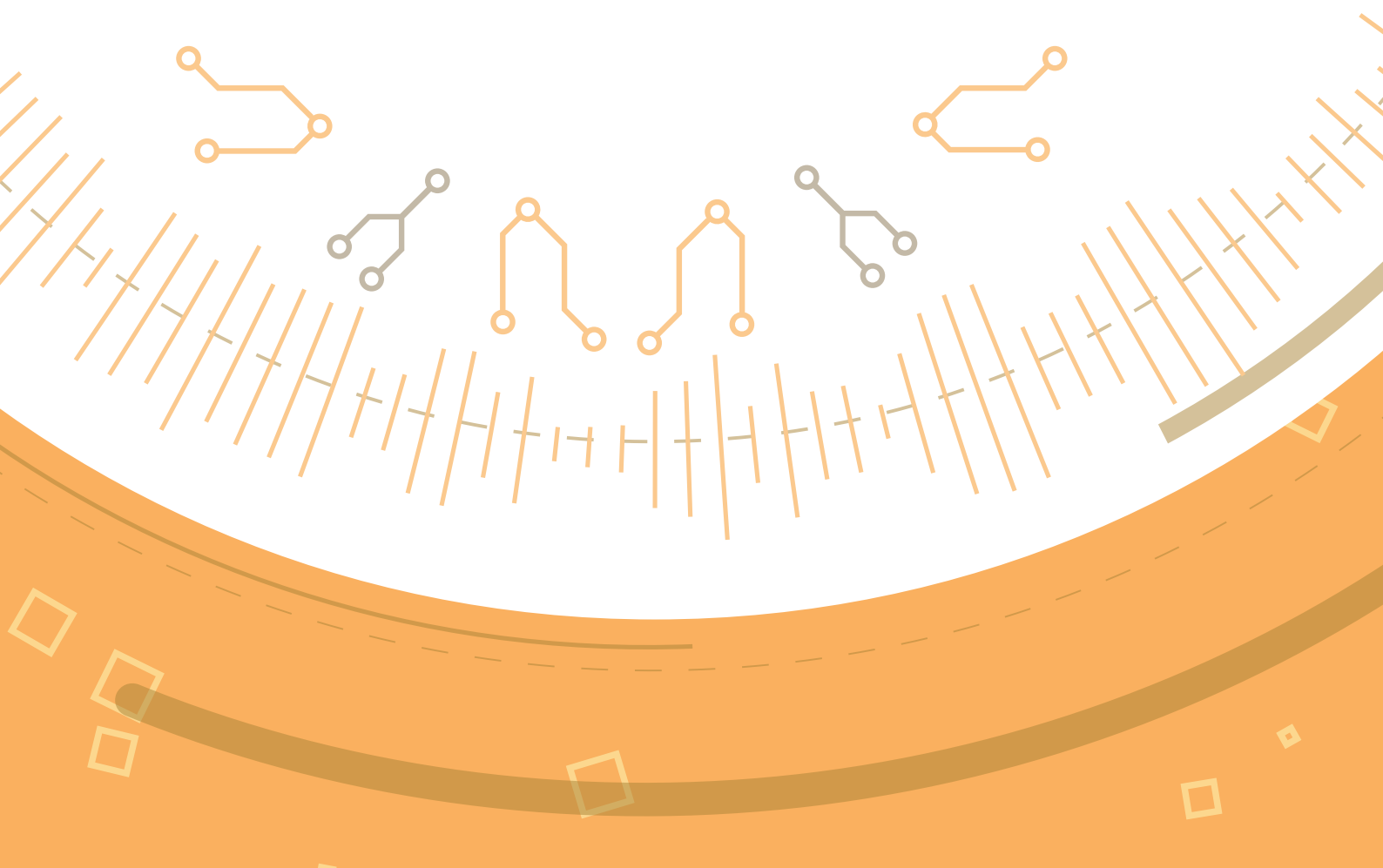

# BRAND INTRODUCTION OF THE CHANGYOU PLATFORM

## 暢由平台品牌簡介

The Digital Point Ecosystem Alliance operational platform ("Changyou platform") was jointly initiated by the Group, CCB International and UnionPay Merchant, with investment from Bank of China, China Mobile and China Eastern Airlines. The Changyou platform will make use of the abundant points resources of the six founding shareholders to integrate its respective digital points, which are virtual assets that have broad application prospects. The Changyou platform also aims to employ advanced technology such as big data and blockchain to build the "Digital Point Business Ecosystem Alliance" and "Virtual Asset Circulation and Settlement System", which will be available globally. Through the continuous global expansion of the platform, digital points will certainly be an important component of the asset virtualization of internet digital inclusive financing. The digital points as virtual assets will bring brand new experience for the Group and its customers for assets trading with high efficiency, high level of security, intelligence and low cost, as well as settlement and preservation. Changyou symbolizes the internet technology entering into a new phase and is one of the platforms which demonstrates the future of financial industry ecosystems.

暢由平台(「暢由平台」)是由本集團聯合建銀國際、銀聯商務共同發起，特邀中國銀行、中國移動、以及東方航空共同投資的數字積分生態聯盟運營平台。該平台將依托六大創始股東的龐大積分資源體，有效匯聚數字積分這一具有廣闊應用前景的虛擬資產，運用大數據和區塊鏈等先進科技手段，打造面向全球的「數字積分商業生態聯盟」和「虛擬資產流通結算體系」。通過暢由平台持續地全球化延展，數字積分必將成為互聯網數字普惠金融虛擬資產化的重要載體。數字積分虛擬資產將給本集團及其客戶帶來高效率、高安全性、智能化和低成本的資產交易以及結算保存的全新體驗。暢由是互聯網走向的標誌，也是未來金融商業生態的示範平台。

# CHAIRMAN'S STATEMENT

## 主席報告





In 2021, despite the continuous spreading of the global epidemic and the international political turmoil, China had a good start of the 14th Five-Year Plan through scientific coordination, effective prevention and control, and continuous economic and social development, with China's national economy recording a steady rise and achieving new results in quality development. According to the National Bureau of Statistics of China, China's GDP reached RMB114,367 billion in 2021, an increase of 8.1% year-on-year, and the Chinese economy showed a stable recovery throughout the year.

Changyou Alliance Group Limited (the “Company” or “Changyou”, and together with its subsidiaries, the “Group”) has capitalised on its years of experience in the e-commerce business to grasp market opportunities and enter the digital points business segment and industry, with its business continuously expanding into diversified and large markets. In the second half of 2017, the Group formed the Changyou Alliance with CCB International (Holdings) Limited, China UnionPay Merchant Services Company Limited, Bank of China Group Investment Limited, China Mobile (Hong Kong) Group Limited and China Eastern Airlines Corporation Limited. Meanwhile, to better promote our corporate image and in line with the Group's strategic focus on the development of Changyou, the English name of the Company has been changed from “Fortunet e-Commerce Group Limited” to “Changyou Alliance Group Limited” and the Company has adopted “暢由聯盟集團有限公司” as its dual foreign name in Chinese in place of “鑫網易商集團有限公司” with effect from 3 June 2020.

The Changyou Platform is an important part of the Group's business. The platform is specifically developed for electronic trade and aims to integrate the digital membership points, resources and strategic advantages of the business partners in the Changyou Alliance, maximise the value of digital points as virtual assets and preserve the interests for platform users. The Group strives to develop the Changyou Platform as an integrative and secured platform. In recent years, with the development of blockchain, big data, artificial intelligence and SaaS technology, digital assets have received increasing recognition from the industry as a type of secured asset. By leveraging advanced technologies such as blockchain, big data analysis and artificial intelligence, the Changyou Alliance aims to develop a safe and stable global financial platform for the issuance, storage, circulation, and payment settlement of blockchain tokenisation of assets.

With the increasing improvement of business models and consumption scenarios, the Changyou Platform has undergone rapid development since its launch, with more diversified products and services, expansion of scale, gradually covering a wide range of consumption scenarios and daily service business scope, and increasing number of users. For the year ended 31 December 2021, the cumulative number of registered users of the Changyou Platform amounted to approximately 96.69 million, representing an increase of approximately 38.19 million or 65% as compared with the total number of registered users as at 31 December 2020 (For the year ended 31 December 2020: approximately 58.50 million).



二零二一年，在全球疫情持續擴散及國際政治局勢動盪的影響下，中國通過科學統籌、有效防控，經濟社會取得不斷發展，中國國民經濟穩中有升，高質量發展取得新成效，實現了「十四五」的良好開局。據國家統計局披露，二零二一年，中國國內生產總值達人民幣1,143,670億元，同比增長8.1%，全年中國經濟呈現穩定恢復態勢。

暢由聯盟集團有限公司（「本公司」或「暢由」）及其附屬公司（統稱為「本集團」）從事電子商貿業務多年，積極把握市場機遇，進軍數字積分業務部分及行業，業務持續向多元化、大型化市場拓展。於二零一七年下半年，本集團聯合建銀國際（控股）有限公司、銀聯商務股份有限公司共同發起，及特邀中銀集團投資有限公司、中國移動（香港）集團有限公司、中國東方航空股份有限公司共同組建暢由聯盟。與此同時，為更好地推廣本集團企業形象，更好地發展暢由的戰略焦點，自二零二零年六月三日起，本集團的英文名稱已由「Fortunet e-Commerce Group Limited」正式更改為「Changyou Alliance Group Limited」，且本公司已採納「暢由聯盟集團有限公司」作為本公司的中文雙重外國名稱，取代中文名稱「鑫網易商集團有限公司」。

暢由平台是本集團業務的重要組成部分，該平台專為電子交易而開發，旨在整合業務夥伴在暢由聯盟的數字會員積分、資源及戰略優勢，發揮數字積分作為虛擬資產的最大價值，同時保障平台用戶的權益，致力使暢由平台成為一體化及安全的平台。近年來，隨著區塊鏈、大數據、人工智能及SaaS技術的發展，數字資產作為有安全保護的資產類別受到越來越多行業內的認可。暢由聯盟依託區塊鏈、大數據分析及人工智能等先進技術，致力於打造一個面向全球的資產區塊鏈通證的發行、存儲、流通交易、支付結算及安全穩定的商業金融平台。

隨著商業模式及消費場景的日益完善，暢由平台自推出以來得到迅速發展，產品及服務類別愈加豐富，規模不斷擴大，逐漸覆蓋多種消費場景及日常服務業務範圍，用戶數量持續大幅增加。截至二零二一年十二月三十一日止年度，暢由平台累計註冊用戶約9,669萬，較二零二零年十二月三十一日增長約3,819萬（二零二一年十二月三十一日止年度：約5,850萬人），增幅約65%。



## Chairman's Statement 主席報告

For the year ended 31 December 2021, the gross profit margin of business operations and the Changyou Platform of Changyou Alliance increased to 11.1% (For the year ended 31 December 2020: approximately 0.4%). The Group is expanding the application of eco-resources, strengthening the foundation of the application of digital assets, leveraging the marketing and operational advantages of the Changyou Platform, and enhancing customer retention and activity to achieve stable revenue and long-term profit growth for the Group.

# MANAGEMENT DISCUSSION AND ANALYSIS

## 管理層討論及分析



## BUSINESS REVIEW

The Group has capitalised on its years of experience in the e-commerce business, which has enabled the Group to grasp market opportunities and enter the digital points business segment and industry. In the second half of 2017, the Group formed the Changyou digital point business ecosystem alliance (the “**Changyou Alliance**”) with CCB International (Holdings) Limited (“**CCB International**”), China UnionPay Merchant Services Company Limited (“**UnionPay Merchant**”), Bank of China Group Investment Limited (“**Bank of China**”), China Mobile (Hong Kong) Group Limited (“**China Mobile**”) and China Eastern Airlines Corporation Limited (“**China Eastern Airlines**”).

The Group’s electronic platform, “Changyou” (the “**Changyou Platform**”) aims to integrate the digital membership points, resources and strategic advantages of the business partners in the Changyou Alliance. The Group strives to develop the Changyou Platform as an integrative and secured platform, so as to preserve and maximise the value of digital points as virtual assets for the users. With the development of blockchain technology, digital assets as a secured asset have received increasing recognition from the industry. By leveraging advanced technologies such as blockchain and big data analysis, the Changyou Alliance aims to develop a global financial platform built on blockchain for the issuance, circulation, storage payment and settlement of the tokens.

Since its launch, the Changyou Platform has undergone rapid development, with an increasing number of users, more diversified products and services, as well as optimised business models and consumption scenarios. In 2021, the Group undertook to refine its business model with an aim to improve its gross profit. As such, although the total revenue from the business operations of Changyou Alliance and the Changyou Platform (collectively, the “**Digital Point Business**”) decreased to approximately RMB114.2 million for the year ended 31 December 2021 (2020: approximately RMB268.8 million), representing a decrease of approximately RMB154.6 million or approximately 57.5% as compared to 2020, the gross profit from the business operations of the Changyou Alliance and the Changyou Platform increased to approximately RMB12.7 million for the year ended 31 December 2021 (2020: approximately RMB1.0 million), representing an increase of approximately RMB11.7 million or approximately 11.1 times as compared to 2020.

The gross merchandise volume of the Digital Point Business amounted to approximately RMB157.3 million for the year ended 31 December 2021 (2020: approximately RMB440.1 million), representing a decrease of approximately RMB282.8 million (approximately 64.3%) over the same period of last year. The Group is currently negotiating with a number of potential business partners so as to enhance the Changyou Platform and expand the scope of its Digital Point Business into other sectors.

## 業務回顧

本集團利用其於電子商貿業務的多年經驗，把握市場機遇及進軍數字積分業務板塊及行業。於二零一七年下半年，聯合建銀國際(控股)有限公司(「**建銀國際**」)、銀聯商務股份有限公司(「**銀聯商務**」)共同發起，及特邀中銀集團投資有限公司(「**中國銀行**」)、中國移動(香港)集團有限公司(「**中國移動**」)、中國東方航空股份有限公司(「**東方航空**」)共同組建暢由數字積分商業生態聯盟(「**暢由聯盟**」)。

本集團的電子平台「暢由」(「**暢由平台**」)旨在整合業務夥伴在暢由聯盟的數字會員積分、資源及戰略優勢。本集團致力使暢由平台成為一體化及安全的平台，保障用戶的權益，發揮數字積分作為虛擬資產的最大價值。隨著區塊鏈技術的發展，數字資產作為有安全保護的資產類別受到越來越多行業內的認可。暢由聯盟依託區塊鏈、大數據分析等先進技術，致力於打造一個基於區塊鏈的全球金融平台，以發行、流通交易、存儲付款及代幣結算。

暢由平台自推出以來發展迅速，用戶數量大幅增加、產品及服務類別愈加豐富、商業模式及消費場景日益完善。於二零二一年，本集團進行完善其業務模式，旨在提高其毛利。因此，雖然截至二零二一年十二月三十一日止年度，來自暢由聯盟及暢由平台的業務營運(統稱「**數字積分業務**」)的總收入減少至約人民幣114.2百萬元(二零二零年：約人民幣268.8百萬元)，較二零二零年減少約人民幣154.6百萬元，減幅約57.5%。截至二零二一年十二月三十一日止年度，暢由聯盟及暢由平台業務營運產生的毛利增加至約人民幣12.7百萬元(二零二零年：約人民幣1.0百萬元)，較二零二零年增加約人民幣11.7百萬元或約11.1倍。

截至二零二一年十二月三十一日止年度，數字積分業務線上線下交易總額達約人民幣157.3百萬元(二零二零年：約人民幣440.1百萬元)，較去年同期減少約人民幣282.8百萬元(約64.3%)。本集團現正與若干潛在業務夥伴磋商，以提升暢由平台並擴大其數字積分業務範圍至其他行業。



## BUSINESS SEGMENTS

### Financial cooperation business

Driven by advanced technologies such as big data, blockchain, cloud computing and artificial intelligence, the financial industry has gradually entered the stage of industry transformation from the rapid development, fintech has become the norm. Meanwhile, benefited from the enhancing digitalisation of financial institutions, digital financial products and tools will obtain enormous development opportunities. In order to create a commercial financial platform, Changyou continues to strengthen its efforts in issuance, exchange and settlement of digital points. Users can monetise Changyou digital points via Changyou Pay (暢由付) on the Changyou platform. Meanwhile, leveraging on Changyou's standardised, low-cost and efficient Changyou point services for small and medium-sized enterprises and top key account ("KA") merchants with digital points, and provides marketing solutions and technical support.

The Group offers points consumption services and points cashier output services to the Changyou Alliance and other alliances utilising the Digital Points Business. In 2021, the Changyou Platform leveraged the marketing and operational advantages with its shareholders and KA channels, and provided China UnionPay with the operational and promotional services to promote and market its mobile app "雲閃付", the services penetrate into the app of Changyou's shareholders and KA channel and the APPs of their respective provincial companies and other platforms that can bring traffic. Based on the cross-marketing model, in order to improve the loyalty and enhance the activeness of the users, the users will be granted benefits as a gift. At the same time, the Group actively developed a SaaS platform based on points issuance and cross-sales with UnionPay, the SaaS targets to deliver marketing, solutions and system support for small and medium-sized merchants and KA merchants. The Group also actively extended the breadth of points sources by connecting the loyalty program of various enterprises. Under the rich ecology, the Changyou Platform also introduced price immediate reduction and red pockets digital point as a new digital point resources with a view to exploring more diversified means for the use of digital points. In addition, the Changyou Platform also secured a significant number of application ecological resources, established the foundation of digital assets application, and promoted the circulation of digital assets. The Group covering more than a thousand business scenarios, and reaching 100,000 offline outlets.

For its instalment business, the Group's products has been enriched with the introduction of top brand suppliers to meet various levels of consumer needs and trading habits, and consumer loyalty and conversion of digital points are respectively maximised and facilitated. During the year ended 31 December 2021 (the "Reporting Period"), financial cooperation business of the Group continued to grow with the expansion of its UnionPay channels combined with channel activities, such as UnionPay – Centralized Operation Center project, Pay Full for Immediate Reduction of Changyou Mobile QuickPass, Mobile QuickPass-Changyou China Mobile Red Packet Promotion Project as well as UnionPay Customer Acquisition activities.

### 業務板塊

#### 金融合作業務

在大數據、區塊鏈、雲計算、人工智能等前沿技術的帶動下，金融行業從快速發展逐漸進入了行業轉型階段，金融科技成為常態。與此同時，受惠於金融機構數字化程度的不斷提升，亦為數字化金融產品和工具提供了巨大的發展機遇。為創造一個商業金融平台，暢由在數字積分的發行、兌換和結算領域持續發力。在暢由平台上，用戶可以通過暢由付，讓暢由數字積分實現資產價值；同時，憑藉暢由積分服務標準化、低成本、高效率的能力，為中小型企業及龍頭重點（「KA」）商戶賦能，提供營銷解決方案及技術支持。



本集團向暢由聯盟及使用數字積分業務的其他聯盟用戶提供積分消費服務及積分收款輸出服務。二零二一年，暢由平台發揮在其股東單位和 KA 渠道的營銷和運營優勢，為銀聯銀行提供的運營推廣服務，以促進及推銷其手機 app「雲閃付」，該等服務滲透到暢由股東單位和 KA 渠道以及彼等各自省公司 APP 以及可帶來流量的其他平台。通過這種交叉營銷模式，為提高用戶忠誠度及提高用戶積極性，用戶將獲授福利作為禮品。同時，本集團積極研發基於積分發行的 SaaS 銷平台，並與銀聯交叉銷售，SaaS 目標乃為中小商戶及 KA 商戶提供營銷、解決方案和系統支持。破局積分源廣度，接入多間不同企業的忠誠度計劃，依據豐富的生態，暢由平台亦推出價格立減及紅包數字積分作為新數字積分資源，以探索更多多樣化的數字積分使用方法。此外，暢由平台還獲得大量拓展應用生態資源，建立數字資產應用的基礎，促進數字資產流通，覆蓋業務場景逾千，線下網點達十萬量級。

分期業務方面，本集團不斷豐富產品結構，引進龍頭品牌供應商，滿足不同層次消費者需求，培養交易習慣，最大化的增加消費者粘性和提升轉化。於截至二零二一年十二月三十一日止年度（「報告期」）內，本集團拓展銀聯渠道，配合渠道活動，帶動金融合作業務持續增長，如銀聯一集運中心項目，暢由雲閃付滿立減活動，雲閃付一暢由中移動紅包促活以及銀聯拉新活動項目。



### Entertainment

To continue to expand the scenarios of the Group's Digital Points Business and build a more solid customer base, as well as to achieve the acquisition and conversion of target customers, during the Reporting Period, the Group vigorously expanded its application ecosystem, established sub-businesses covering video and audio, lifestyle services, games and entertainment and prioritised the development of entertainment scenarios, strengthened its retail business and cooperation with brands, and has achieved good results.

In the Group's development of online entertainment scenarios, two games with over 100 million downloads were promoted through collaboration. In the next stage, the Changyou Platform will continue to stabilise the promotion channels of the abovementioned games. Meanwhile, the Changyou Platform has conducted a detailed analysis of the population in the entertainment scenario on an ongoing basis and further diversified and captured different user profiles, precisely located its target user groups, and accurately delivered the promotion content through the development of membership benefits for members of entertainment platforms such as games and live streaming as well as props exchange.

During the Reporting Period, the Group communicated and contacted 220 merchants, including important partners and well-known companies. The Group will continue to update the cooperation plan with its partners and upgrade the operation plan.

為持續拓寬數字積分業務場景，並打造更加堅固的客戶基礎，實現主題人群的獲取和轉化，報告期內，本集團大力拓展應用生態，構建了涵蓋影音視頻、生活服務、遊戲娛樂等領域的子業務，在文娛場景構建、零售、品牌聯營等方面著重發力，亦取得良好成績。

在本集團線上娛樂場景開發中，針對兩款遊戲下載量過億的遊戲進行合作推廣。在下一階段，暢由平台將繼續穩定上述遊戲的推廣渠道。同時，暢由平台持續對文娛場景內人群進行詳細分析，通過開發遊戲、直播等娛樂平台會員權益與道具兌換，進一步多元化及把握不同用戶的信息，精準定位主題人群，準確輸出推廣內容。

報告期內，本集團溝通接洽商家 220 家，其中包括重要合作方及知名公司。集團將與合作方持續更新合作方案，升級運營方案。

## Retail

The Group has continued to develop its retail business by further expanding the development of consumer user interface including interface for catering, offline entertainment, travel services, tourism services and department stores, established cooperation relationships with large companies and continued to enrich the provision of products relating to clothing, food, housing and transportation. The Group has developed in key cities in the PRC as well as online and offline markets to centralise its business and further broadened its application channels for the business of Changyou points. During the Reporting Period, the Group completed the signing for direct cooperations with approximately 7,600 products, and improved the supply chain of the six major cross-industry interests and physical products. As for the catering industry, the Group adjusted its development plan from focusing on key urban business districts to key catering brands, and had chosen a fast food restaurant chain as a pilot scheme in Nanjing and Shanghai for initial testing and implementation. At the same time, the Group also continued to communicate with more chain restaurant brands.

## Joint Brand Business Operations

Financial institutions relied on the operational capabilities and product advantages of the Changyou Platform to carry out joint marketing activities through vertical use scenario and points exchange process, the marketing makes full use of various promotion channels to reach users in multiple ways, and offers users plentiful supply of products and services while also enhancing user experience and improving overall operational efficiency and transaction volume. During the Reporting Period, the Group alliances with a number of large enterprises, the mature commercialised product models together with the strong resource support from the Changyou Platform greatly boosted the orders and the users' conversion rate during the new users registration marketing campaigns jointly held with China Mobile and UnionPay.

## Travel related businesses

### Public Transportation Services

During the Reporting Period, the Group's public transportation services were steadily promoted with the introduction of daily service support such as travel vouchers, public transportation deduction vouchers and monthly bicycle pass and the addition of Wechat riding business scenario. During the Reporting Period, travel vouchers provided by the Group and which may be redeemed by customers using Changyou points have covered more than 10 provinces and cities across the country. At the same time, the Group continued to enrich scenic spot ticket redemption vouchers and tourist privileges to meet more users' needs for urban travel. The Changyou Platform actively expands livelihood scenarios, improves user conversion rate and vitality, and ultimately retains users in the private domain of the Changyou ecology.

## 零售

本集團在零售業務部分持續發展，不斷擴展包括餐飲美食、線下娛樂、出行服務、旅遊服務及百貨等消費場景搭建，與大廠建立合作，不斷豐富衣食住行的生活權益。在全國範圍內的重點城市集中佈局，線上線下同步發展，進一步拓寬了暢由積分業務應用渠道。報告期內，本集團共計完成了約 7,600 個商品，健全了暢由六大異業權益及實體商品的供應鏈庫。餐飲方面，本集團從城市重點商圈佈局，調整為重點餐飲品牌發展，並以一間快餐連鎖店作為試點在南京、上海首次測試上線施行。同時，本集團亦正與更多餐飲連鎖品牌持續溝通。

## 品牌聯營業務

依託暢由平台的運營能力及產品優勢，通過垂直場景和積分兌換流程開展聯合營銷活動，充分利用各推廣渠道，多途徑觸達用戶，在為用戶提供豐富產品與服務的同時，也實現了用戶的體驗升級，提升了整體的經營效率及交易額。報告期內，集團與多家大型企業強強聯合，成熟的商業化產品模型連同暢由平台強大的資源支持，聯合中移動與銀聯進行的拉新活動中，大大提升訂單及提升用戶轉化率。

## 出行相關服務

### 公共交通服務

報告期內，本集團公共交通服務穩步推進，推出乘車券、公共交通抵扣券、單車月卡等日常服務支持並新增微信乘車業務場景。報告期內，本集團暢由積分兌換乘車券業務已覆蓋全國超過 10 個省市。同時，本集團不斷豐富景區門票兌換券、遊客尊享權益等，以滿足更多用戶城市出行需求。暢由平台積極拓展民生場景，提升用戶轉化率和活力，最終將用戶留存在暢由生態的私域中。



### Personal Car Owner Services

The Group has entered into cooperation agreements with many industry-leading carpark service brands to provide parking payment and refuelling services, regular maintenance and repair and car washing services. During the Reporting Period, the Group introduced a number of industry-leading suppliers as partners, opening up the major scenarios of high-frequency cars such as parking, charging, and payment and providing immediate reduction for parking and other activities. At the same time, the Changyou Platform continued to enhance technical innovation, strengthened the management of the research and development process, improved the quality of project delivery, further enforced the monitoring of system operation conditions, provided timely warning and rapid repair for operational faults, and completed the monitoring of operational data, customer complaints and real-time business complaint process optimization.

## FINANCIAL REVIEW

### Revenue

The Group recorded a consolidated revenue of approximately RMB114.2 million (2020: approximately RMB268.8 million), representing a decrease of approximately 57.5% as compared to 2020. During the year ended 31 December 2021, the Company targeted to provide its products to customers with higher profit margins. Revenue from products with lower profit margins or offered at the most favourable price was reduced gradually, which resulted in a decrease in the Group's revenue for the year ended 31 December 2021. The Company believes that the business strategy of increasing the gross profit margin of revenue will be advantageous to the development of the Digital Points Business.

### Gross profit

Gross profit for the year ended 31 December 2021 amounted to approximately RMB12.7 million (2020: approximately RMB1.0 million). Since the Company changed its business strategy to providing its products to customers with higher profit margins, the gross profit margin was eventually increased to approximately 11.1% (2020: approximately 0.4%).

### Other income

Other income of the Group for the year ended 31 December 2021 was approximately RMB0.6 million (2020: approximately RMB0.7 million). A detailed breakdown of the factors contributing to the other income of the Group is disclosed in note 5 to the financial statements as disclosed in this report.

### Impairment (loss)/gain of trade and other receivables

Impairment loss of the Group for the year ended 31 December 2021 was approximately RMB0.9 million, which mainly represents impairment loss of trade and other receivables during the year ended 31 December 2021. Recoveries of other receivables were recognised in 2020, there was no such recoveries recognised during the year ended 31 December 2021 (2020: impairment gain of trade and other receivables of approximately RMB29.7 million).

### 個人車主服務

本集團與多個行業龍頭汽車服務品牌簽訂合作協議，提供停車繳費、加油服務、定期保養和維護及洗車服務。報告期內，本集團引入了多個行業領先的供應商為合作夥伴，打通停車、充電、繳費等高頻車主場景，提供停車立減優惠等活動。同時，暢由平台不斷提升技術革新，加強研發流程管理，提升項目交付質量，加強系統運行狀況監控，針對運行故障及時預警，快速修復，並完成運營資料監控、客訴問題以及即時業務投訴流程優化。

## 財務回顧

### 收入

本集團錄得綜合收入約人民幣114.2百萬元(二零二零年：約人民幣268.8百萬元)，較二零二零減少約57.5%。截至二零二一年十二月三十一日止年度，本公司的目標是向利潤率更高的客戶提供產品。截至二零二一年十二月三十一日止年度，利潤率較低或向客戶提供最優惠價格的產品的收入逐漸減少，導致本集團收入減少。本公司認為，提高收入毛利率的業務策略將有利於發展數字積分業務。

### 毛利

截至二零二一年十二月三十一日止年度，毛利約為人民幣12.7百萬元(二零二零年：約人民幣1.0百萬元)。由於本公司改變其業務策略，向利潤率更高的客戶提供產品，毛利率最終提高至約11.1%(二零二零年：約0.4%)。

### 其他收入

截至二零二一年十二月三十一日止年度，本集團的其他收入達約人民幣0.6百萬元(二零二零年：約人民幣0.7百萬元)。貢獻本集團其他收入的因素的詳細分類於本報告所披露財務報表附註5中披露。

### 貿易及其他應收款項減值(虧損)/收益

截至二零二一年十二月三十一日止年度，本集團的減值虧損達約人民幣0.9百萬元，主要為截至二零二一年十二月三十一日止年度內貿易及其他應收款項減值虧損。於二零二零年已確認收回其他應收款項，而於截至二零二一年十二月三十一日止年度並無確認有關收回款項(二零二零年：貿易及其他應收款項減值收益約人民幣29.7百萬元)。



### Selling and distribution expenses

Selling and distribution expenses of the Group for the year ended 31 December 2021 decreased to approximately RMB24.2 million (2020: approximately RMB25.3 million). The decrease was mainly attributable to reduced sales and promotion activities for the Changyou Platform during the year ended 31 December 2021.

### Administrative expenses

The Group's administrative expenses for the year ended 31 December 2021 increased to approximately RMB51.9 million (2020: approximately RMB45.0 million). The increase was mainly attributable to the development of software as a service (the "SaaS") business and cost of employee layoffs during the year ended 31 December 2021.

### Research and development costs

Research and development costs of the Group for the year ended 31 December 2021 increased to approximately RMB39.0 million (2020: approximately RMB36.2 million). The increase was mainly attributable to the increase in staff costs for research and development activities and cost of employee layoffs during the year ended 31 December 2021.

### Finance costs

The Group incurred finance costs of approximately RMB20.4 million for the year ended 31 December 2021 (2020: approximately RMB6.4 million). A detailed breakdown of the factors contributing to the finance costs of the Group is disclosed in note 6(a) to the financial statements as disclosed in this report.

### Taxation

No income tax expenses was recorded for the years ended 31 December 2021 and 31 December 2020.

## LIQUIDITY AND FINANCIAL RESOURCES

As at 31 December 2021, cash and cash equivalents of the Group were approximately RMB50.4 million (as at 31 December 2020: approximately RMB152.3 million). As compared to 2020, cash and cash equivalents decreased by approximately RMB101.9 million, mainly due to net cash outflow arising from operating activities of approximately RMB103.4 million (2020: approximately RMB104.2 million), net cash outflow arising from investing activities of approximately RMB0.5 million (2020: net cash inflow of approximately RMB30.4 million) and net cash inflow from financing activities of approximately RMB3.8 million (2020: approximately RMB94.7 million).

### 銷售及分銷開支

截至二零二一年十二月三十一日止年度，本集團的銷售及分銷開支減少至約人民幣24.2百萬元（二零二零年：約人民幣25.3百萬元）。該減少主要歸因於截至二零二一年十二月三十一日止年度減少暢由平台的銷售及推廣活動。

### 行政開支

截至二零二一年十二月三十一日止年度，本集團的行政開支增加至約人民幣51.9百萬元（二零二零年：約人民幣45.0百萬元）。該增加主要歸因於發展軟件即服務（「SaaS」）業務及截至二零二一年十二月三十一日止年度僱員裁減成本所致。

### 研發成本

截至二零二一年十二月三十一日止年度，本集團的研發成本增加至約人民幣39.0百萬元（二零二零年：約人民幣36.2百萬元）。該增加主要由於截至二零二一年十二月三十一日止年度研發活動的員工成本增加及僱員裁減成本所致。

### 融資成本

本集團於截至二零二一年十二月三十一日止年度產生的融資成本約為人民幣20.4百萬元（二零二零年：約人民幣6.4百萬元）。本集團融資成本產生因素的詳細分類於本報告所披露財務報表附註6(a)中披露。

### 稅項

截至二零二一年十二月三十一日及二零二零年十二月三十一日止年度並無錄得所得稅開支。

### 流動資金及財務資源

於二零二一年十二月三十一日，本集團的現金及現金等值項目約為人民幣50.4百萬元（於二零二零年十二月三十一日：約人民幣152.3百萬元）。與二零二零年相比，現金及現金等值項目減少約人民幣101.9百萬元，主要由於經營活動產生現金流出淨額約人民幣103.4百萬元（二零二零年：約人民幣104.2百萬元）、投資活動產生現金流出淨額約人民幣0.5百萬元（二零二零年：淨現金流入約人民幣30.4百萬元）及融資活動現金流入淨額約人民幣3.8百萬元（二零二零年：約人民幣94.7百萬元）所致。

### Convertible Bonds

In view of the increasing popularity of consumer spending with digital points, the successful experience of the Group in developing the Changyou Platform and the robust performance and growth of the Changyou Platform, the Company intended to issue HK\$126.0 million 3.5% convertible bonds (the “**2020 Convertible Bonds**”) to Century Investment (Holding) Limited (“**CIH**”), the net proceeds of which was intended to be utilised to expand the Digital Point Business into the Hong Kong and overseas markets by developing an additional new digital point electronic platform with Hong Kong and overseas as the target markets (the “**New International Changyou Platform**”).

On 29 July 2020, the Company entered into a subscription agreement with CIH, pursuant to which the Company shall issue the 2020 Convertible Bonds to CIH. The 2020 Convertible Bonds bear interest at 3.5% per annum and will mature on the date falling three years after the first issue date of the 2020 Convertible Bonds. For further details of the transaction, please refer to the announcement of the Company dated 29 July 2020 and the circular of the Company dated 17 September 2020.

The issuance of the 2020 Convertible Bonds was completed on 19 October 2020.

As at 31 December 2021, the actual uses of the proceeds from the issuance of the 2020 Convertible Bonds were as follows:

### Issue of Warrants

On 26 March 2018, the Company and CIH, the substantial shareholder of the Company, entered into a warrant subscription agreement, pursuant to which the Company shall issue 298,000,000 warrants (“Warrants”) to CIH at a subscription price of HK\$0.01 per Warrant. The Company received the subscription price of HK\$2,980,000. For further details of the transaction, please refer to the announcements of the Company dated 26 March 2018 and 27 June 2018, respectively, and the circular of the Company dated 5 July 2018. The Warrants were issued on 18 September 2018. The net proceeds from the issue of Warrants (after deduction of relevant expenses) of approximately HK\$1,480,000 was fully utilised for the development of the Changyou Platform during the year ended 31 December 2018.

Upon the fulfilment of certain conditions, the Warrants are exercisable in full or in part at any time between the period commencing on the date that is six months after the date of the issue of the Warrants and ending on the earliest of (i) the date on which all Warrants have been exercised in full; and (ii) the date that is the fifth anniversary date of the issue date of such Warrants. None of the Warrants were exercised during the year ended 31 December 2021. However, the Company is of the view that CIH has demonstrated continuous support and motivation to improve the Company’s financial performance. CIH will continue to introduce strategic partners to the Group so as to further enhance the performance.

### Share options

On 7 August 2018, the Company granted 72,000,000 share options to Cheng Jerome, the chairman and an executive Director. For further details of the transaction, please refer to the announcement of the Company dated 4 May 2018 and the circular of the Company dated 15 June 2018. No option was exercised during the year ended 31 December 2021.

### Deemed disposal of equity interest in a subsidiary

On 29 July 2020, PCL entered into a subscription agreement with an investor (“New Investor”), pursuant to which, among other things, PCL conditionally agreed to allot and issue, and the New Investor conditionally agreed to subscribe for or shall procure the nominee of the New Investor to subscribe for, not less than 61,078,767 but not more than 73,287,671 shares of PCL at the subscription price of not less than US\$35,670,000 but not more than US\$42,800,000 (the “2020 Subscription”). The net proceeds expected to be raised upon the completion of the 2020 Subscription was intended to be utilised for, among other things, the development and expansion of the Digital Point Business and the Existing PRC Changyou Platform. The subscription price payable for the 2020 Subscription was determined after arm’s length negotiations between PCL and the New Investor on the basis of the pre-money valuation of US\$593 million. For further details of the 2020 Subscription, please refer to the announcement of the Company dated 29 July 2020 and the circular of the Company dated 22 September 2020.

### 發行認股權證

於二零二零年七月二十九日，分海與一名投資者（「新投資者」）訂立認購協議，據此（其中包括），分海有條件同意配發及發行，及新投資者有條件同意認購（或將促使新投資者代名人認購）不少於61,078,767股但不多於73,287,671股分海股份，認購價不少於35,670,000美元但不多於42,800,000美元（「二零二零年認購事項」）。預期於二零二零年認購事項完成時將籌集的所得款項淨額擬用於（其中包括）開發及擴展數字積分業務及現有中國暢由平台。就二零二零年認購事項應付的認購價乃由分海與新投資者基於投資前估值593百萬美元並按公平原則磋商後釐定。有關二零二零年認購事項的進一步詳情，請參閱本公司日期為二零二零年七月二十九日的公佈及本公司日期為二零二零年九月二十二日的通函。

As at the date of this report, the 2020 Subscription had yet to be completed and no proceeds from the 2020 Subscription were received. PCL and the New Investor are using all reasonable efforts within their respective capacity to satisfy the conditions precedent of the 2020 Subscription by 30 June 2022 (being the long stop date of the 2020 Subscription).

Assuming the maximum proceeds of US\$42.8 million (equivalent to approximately RMB277 million) are raised from the 2020 Subscription, it is expected that the proceeds will be applied as follows and will be fully utilised by June 2024:

The Group believes that risk management practices are important and uses its best effort to ensure they are sufficient to mitigate risks present in our operations and financial position. The following are the principal risks and uncertainties of our business:

- Our Digital Point Business depends on our ability to maintain our existing relationships and to develop new relationships with business partners, cooperation platforms and suppliers as part of the business ecosystem of the Changyou Platform. As such, the quality and diversity of the goods and services available on the Changyou Platform depend on our relationship with and the performance of such business partners, cooperation platforms and suppliers. The Group has been continually looking for new opportunities to diversify, improve and develop the Changyou Platform, and will continue to expand its connections and networks and to increase our competitiveness in the market;
- Our Digital Point Business is subject to rapid market changes and the potential development of new business models and the entry of new and well-funded competitors. Although the Group has been successful in capturing market opportunities, in order to remain competitive, we need to stay updated of the constantly evolving industry trends and to enhance and improve the responsiveness, functionality and features of our Changyou Platform. In order to attract and retain users and maintain our competitiveness, the Group will continue to invest significant resources in our research and development to improve our existing systems, enhance our technology infrastructure, and establish and enrich our big data and blockchain technologies;
- As the Group is continuously expanding its businesses in China, it is required to comply with the new applicable laws and regulations that are specifically relevant to the Group's business, such as laws and regulations relating to online commerce, interchange on digital points on the online platform and distribution content, data protection, internet information security, intellectual property, etc. There are substantial uncertainties and restrictions with respect to the interpretation and application of such laws and regulations in China. The Company will continue to monitor and identify changes in the relevant laws and regulations, so as to take appropriate actions or measures to ensure the Company is in compliance with such laws and regulations;

In light of the operational risks and financial risks associated with the COVID-19 pandemic, the Group has proactively adopted and implemented various strategies and contingency plans in response to the COVID-19 pandemic.

### PROSPECTS

The Changyou Platform is a digital assets platform which serves issuance, circulation, payment and settlement of digital assets which can be tokenised and a gate point for point redemption. Leveraging on the smart business environment, the Group utilises the channel and customer resources of the Changyou Platform and bring the new resources to merchant, insights into the intrinsic needs of enterprises and achieve network synergy and win-win cooperation.

In 2022, the Group will further deepen and expand its two-wheel drive strategy to consolidate resource allocation of digital asset resources and explore further the application ecology. The Group will focus on main site operation under the strategic model of "One Body and Two Wings". The operation center is responsible for the operation of the main site APPs and public account, with an aim to build a high-quality supply chain and provide operational solutions to its business partners. The Group will focus on point utilization improvement for merchants to enhance their sales Changyou Platform revitalise users for point transactions, and bring into traffic for card organisations, banks and consumption finance. Relying on Changyou Platform two basic businesses, the Group will seek additional profits from the digital point utilisation enhancement business model under the bonus point transaction scenario. For our business clients, the Group will provide banks and insurance companies with rewards and marketing activities support, such as the parking and charging rewards for car owners. The Group integrates the marketing resources of Business organisations, and continues to expand cooperation population and reward business with banks.

### 前景

暢由平台是一個數字資產平台，為可通証化數字資產提供發行、流通、支付和結算服務，是積分兌換的流量入口。藉助智能商業環境的大勢，本集團利用暢由平台的渠道和客戶資源，為商戶帶來新資源，洞察企業的內在需求，實現雙效協同和合作共贏。

二零二二年，本集團將進一步深化和擴大雙輪驅動策略，夯實數字資產資源配置，拓展應用生態。圍繞主站運營，繼續堅持一體兩翼的戰略佈局，運營中心負責主站 APP 及公眾號的運營，打造優質供應鏈，並支撐各合作渠道的運營解決方案；聚焦提高對商戶的積分使用率，提升暢由平台銷售額；盤活用戶積分交易，為卡組織、銀行、消費金融實現引流。依託暢由平台兩個基礎業務，在積分交易場景中，從數字積分利用提升業務模式中尋求額外利潤。就業務客戶而言，本集團將為銀行及保險公司提供獎勵和營銷活動支持，如為車主提供停車及充電獎勵。本集團整合商業機構的營銷資源，繼續擴張與銀行的合作人群及獎勵業務。

The Group will continue to strengthen its service provider role in UnionPay and banking channels, including cooperation in entertainment and audio-visual, public transportation, parking and refueling, mass consumption, user promotion, active card users, event operations and supply chain. By exploring and combining the business needs of UnionPay, banks and payment institutions in new year and riding on the existing business models, we will expand in-depth cooperation with the respective. By leveraging the flexible mechanism and the advantages of interconnection of Changyou Platform, the Group aims to achieve the goal of “maintaining existing business and expanding new business” for business growth and deepen the joint cooperation model of “building periphery and promoting synergy”.

In addition, the Group will also strengthen business cooperation and resource linkage with large enterprises to form a brand cooperation effect. The Group will also strive to improve users' activeness and improve all parties' return by creating business linkage between merchandise and sales aspects, the Group will utilise the exclusive and unique quality rewards of the KA merchants such as head restaurants, big retail, transportation and travel to enhance their cooperation with UnionPay, banks and payment institutions. The Group will continue to expand national and regional cooperation with quality merchants and rewards. So as to solidify its position as the service provider for the provision of products and services. The Group will establish direct and deeply customised equity cooperation with top brands in related industries to expand the brand influence of Changyou and continuously increase the loyalty and activity level of Changyou's point users.

The impact of the COVID-19 pandemic on the global economy has been far-reaching and has led to disruptions to many businesses across various industries. The development of the New International Changyou Platform is expected to be delayed under current situation. However the management of the Company is initiating a discussion with CIH, a substantial shareholder of the Company. The parties intend to enter into a memorandum of undertaking with a purpose of exploring the potential cooperation of establishing a joint venture to operate the New International Changyou Platform. Each party will contribute their resources so as to mitigate the risks and reduce the time to bring the New International Changyou Platform online in 2022.

Looking ahead, the Group will grasp the huge opportunities brought by the rapid development of the Internet, big data, artificial intelligence and SaaS and other cutting-edge technologies, make good use of the synergy brought by policy support, complement its own technology, products, services and business model to create a benchmark cross-industry digital point marketing platform with points free of circulation, and make it a corporate mission to explore the value of points and realise the efficient aggregation and flow of points, and move forward towards the vision of empowering merchants and promoting the upgrade of their business capabilities, so as to bring long-term sustainable returns to its shareholders and investors and the society.

此外，本集團亦將加強與大型企業的業務合作和資源聯動，形成品牌合作效應。本集團亦致力於透過創建商品端與營銷端之間的業務聯動而提高用戶積極性及提升各方的回報，本集團將利用 KA 商戶的獨家和獨特的品質獎勵，如頭部餐飲、大零售、交通出行，以提高彼等與銀聯、銀行及支付機構的合作。本集團將持續拓展全國性和區域性的優質商戶和獎勵。為鞏固其作為提供產品及服務的服務提供商地位，本集團將與相關行業的 Top 品牌建立直接、深度定制的權益合作，擴大暢由的品牌影響力，不斷提升暢由積分用戶的忠誠與活躍度。

新冠肺炎對全球經濟產生的影響深遠，並導致各行業眾多業務中斷。按當前形勢，預計新國際暢由平台的開發將被推遲。然而，本公司管理層正與 CIH (本公司主要股東) 展開討論，雙方擬訂立諒解備忘錄，旨在探索透過成立一間合營企業營運新國際暢由平台的潛在合作。各方將貢獻其資源，以降低風險及縮短二零二二年新國際暢由平台上線時間。

展望未來，本集團將緊抓互聯網、大數據、人工智能及 SaaS 等前沿技術高速發展帶來的巨大機遇，利用好政策支持帶來的協同效應，配合自身的技術、產品、服務及商業模式，打造出具有標杆意義的通用異業數字積分營銷平台，以挖掘積分價值，實現積分高效彙聚和流轉作為企業使命，朝著賦能商戶，推動商戶經營能力升級的願景目標奮勇前進，為其股東及投資者以及社會帶來長遠可持續性的回報。



## IMPACT OF THE COVID-19 PANDEMIC AND THE GROUP'S MEASURES

Since the beginning of 2020, the impact of the COVID-19 pandemic on the global economy has been far-reaching and has led to disruptions to many businesses across various industries. During the year 2020, our business operations experienced short-term disruptions at the early stage of the COVID-19 outbreak, due to measures imposed by the Chinese government to respond to the pandemic, including among other things, the nationwide lockdowns imposed by the Chinese government, as well as the mandatory suspension of business operations in China, where our businesses are principally based.

However, owing to the effective control of the COVID-19 outbreak in China at a rather early stage, the impact of the COVID-19 pandemic on the Group has been minimal. While the Group had recorded a year-on-year decrease in revenue of approximately 57.5% for the year ended 31 December 2021 as compared to 2020, such decrease was not resulted from the impact of the COVID-19 outbreak but was primarily due to the steps taken by the Group to refine its business model with an aim to improve its gross profit. By (i) providing its products to customers with higher profit margins and (ii) gradually reducing sales to customers with lower profit margins or offered at the most favourable price, which resulted in the decrease in revenue, the Group's gross profit from the business operations of Changyou Alliance and the Changyou Platform increased to approximately RMB12.7 million for the year ended 31 December 2021 (2020: approximately RMB1.0 million), representing an increase of approximately RMB11.7 million or approximately 11.1 times as compared to 2020.

As at 31 December 2021, the cash and cash equivalents the Group amounted to approximately RMB50.4 million, which saw a year-on-year decrease by approximately 66.9%. Furthermore, as at 31 December 2021, the current ratio (being total current assets divided by total current liabilities) of the Group is approximately 1.33. As a result, despite the economic downturn caused by the COVID-19 pandemic, the Group was able to maintain sufficient liquidity position at the end of the year 2021, and had focused our resources to fund our operations and fulfil our financial obligations in relation to the Existing PRC Changyou Business. That being said, although we are able to continue to develop and maintain the Existing PRC Changyou Platform, the development of the New International Changyou Platform is expected to be delayed as the Group will need to further assess the uncertainties of the impact of COVID-19 on the development progress and the business operations of investors and business partners, and the prospects of consumer spending in relation to the New International Changyou Platform.

## 新冠肺炎疫情的影響及本集團採取的措施

自二零二零年初以來，新冠肺炎疫情對全球經濟產生的影響深遠，並導致各行業眾多業務中斷。於二零二零年，我們的業務營運於新冠肺炎爆發初期階段遭受短期中斷，由於中國政府採取應對疫情的措施，包括(其中包括)中國政府實施的全國性封鎖，以及強制暫停我們業務主要所在的中國的業務營運。

然而，由於中國在較早階段對新冠肺炎爆發進行有效控制，新冠肺炎疫情對本集團的影響甚微。儘管本集團亦錄得截至二零二一年十二月三十一日止年度的收入較二零二零年同比減少約57.5%，該減少並非由於新冠肺炎爆發的影響所致，而主要由於本集團採取改善其業務模式的措施，旨在提高其毛利。透過(i)向利潤率更高的客戶提供產品及(ii)逐漸減少向利潤率較低或以最優惠價格提供產品的客戶的銷售，導致收入減少，於截至二零二一年十二月三十一日止年度，本集團來自暢由聯盟及暢由平台業務營運的毛利增加至約人民幣12.7百萬元(二零二零年：約人民幣1.0百萬元)，較二零二零年增加約人民幣11.7百萬元或約11.1倍。

於二零二一年十二月三十一日，本集團現金及現金等值項目約為人民幣50.4百萬元，同比減少約66.9%。此外，於二零二一年十二月三十一日，本集團的流動比率(即總流動資產除以總流動負債)約為1.33。因此，儘管新冠肺炎疫情導致經濟衰退，本集團於二零二一年底能夠維持充足流動資金，並集中資源為營運提供資金及履行對與現有中國暢由業務有關的財務責任。儘管如此，雖然我們能夠繼續發展及維持現有中國暢由平台，由於本集團將需要進一步評估新冠肺炎對投資者及業務夥伴的發展進度及業務營運的影響的不確定性，以及有關新國際暢由平台的消費者的消費前景，新國際暢由平台的發展預期將會延遲。

From 1998 to 2008, Mr. Cheng worked for BEA Systems, Inc., a company specialized in enterprise infrastructure software products which was acquired by Oracle Corporation in 2008, as principal consulting engineer in BEA France, as managing consulting engineer in BEA France, as pre-sales consulting manager in BEA APAC region and as senior manager of BEA Technology Centre in Beijing, China.

In June 2008, Mr. Cheng joined Oracle Systems Hong Kong Limited as the senior manager of soft development and served as Principal Solution Architect of Oracle Fusion Middleware world wide architecture team from May 2010 to December 2014.

**Mr. Yuan Weitao**, aged 56, was appointed as the executive Director on 25 March 2015. He joined OPCo in September 2014 and currently serves as a director and executive vice president of OPCo, and a director of Century East Network Limited (“**CEN**”). CEN is a non-wholly owned subsidiary of CIH, being a substantial shareholder of the Company. On 18 February 2021, Mr. Yuan re-appointed as a director of CIH. Mr. Yuan graduated from Tsinghua University with a bachelor’s degree in engineering in 1989 and a master’s degree in engineering in 1992. He has working experience of over 20 years in international trade, telecommunications and media industries. Mr. Yuan joined China National Electronics Import & Export Company (中國電子進出口總公司), administered by the Ministry of Mechanical Electronic Devices of the People’s Republic of China, after his graduation and worked in its overseas subsidiary as a marketing manager in 1994. The Company was incorporated in the Cayman Islands on 21 May 2008 under The Companies Law, Cap. 22 (Law 3 of 1961, as consolidated and revised) of the Cayman Islands (“**Companies Law**”) with limited liability. The shares of the Company (the “**Shares**”) were listed on the Main Board of The Stock Exchange of Hong Kong Limited (the “**Stock Exchange**”) on 24 September 2010.

During the financial year ended 31 December 2016, the Group formed a series of joint ventures with the respective subsidiaries of CCB International, UnionPay Merchant, China Mobile, Bank of China and China Eastern Airlines, the joint venture companies which now form part of the Group. For further details of the formation of the joint ventures, please refer to the announcements of the Company dated 22 June 2016, 25 July 2016, 30 August 2016, 13 September 2016, 29 November 2016, 7 December 2016 and 30 June 2017, respectively.

### PRINCIPAL ACTIVITIES

The principal activity of the Company is investment holding. Details of the principal activities of its subsidiaries are set out in note 14 to the financial statements.

These discussions form part of this Directors’ report.

### RESULTS AND DISTRIBUTION

The results of the Group for the year ended 31 December 2021 are set out in the financial statements on pages 71 to 72. The Board does not recommend the payment of any final dividend for the year ended 31 December 2021.

## DIVIDEND POLICY

The Company should maintain adequate cash reserves for meeting its working capital requirements and future growth as well as its shareholder value in recommending or declaring dividend. The declaration of payment and the amount of dividend will be made at the discretion of the Board and will depend on the Group's results of operations, earnings, financial condition, cash requirements and availability, future capital expenditure and development requirements, business conditions and strategies, interests of shareholders, any restrictions on payment of dividends and any other factors that the Board may consider relevant. The Company does not have any pre-determined dividend distribution ratio. The Board will review the dividend policy as appropriate from time to time.

## RESERVES AND DISTRIBUTABLE RESERVES

Movements in the reserves of the Group during the year ended 31 December 2021 are set out on page 76 of this report and in note 25 to the financial statements.

Under the Companies Law of the Cayman Islands, the share premium of the Company may be distributable provided that immediately following the date on which the dividend is proposed to be distributed, the Company will be in a position to pay off its debts as and when they fall due in the ordinary course of business. In accordance with the article 134 of the Articles, dividends may be declared and paid out of the profits of the Company or from any reserve set aside from profits which the Directors determined is no longer needed. As at 31 December 2021, the Company had no reserve available for distribution to shareholders of the Company.

## SHARE CAPITAL

Changes in share capital of the Company for the year ended 31 December 2021 are set out in note 25(c) to the financial statements.

## PRE-EMPTIVE RIGHTS

There is no provision for pre-emptive rights under the Articles or the laws of the Cayman Islands which would oblige the Company to offer new Shares to existing shareholders on a pro-rata basis.

## 優先購買權

根據細則或開曼群島法例，並無載列有關本公司須按比例向現有股東提呈發售新股份之優先購買權規定。

## SHARE OPTION SCHEME

The share option scheme adopted by the Company on 28 June 2010 have expired on 24 September 2020 (the **"2010 Share Option Scheme"**). All outstanding share options granted but not yet exercised under the 2010 Share Option Scheme will continue to be valid and exercisable in accordance with the rules of the 2010 Share Option Scheme. In relation to any options granted under the 2010 Share Option Scheme, the exercise price is determined by the Directors, and will not be less than the highest of (i) the closing price of the Shares as stated in the daily quotation sheets of the Stock Exchange on the date of offer of an option (**"Offer Date"**); (ii) the average closing price of the Shares as stated in the daily quotation sheets of the Stock Exchange for the five business days immediately preceding the Offer Date; and (iii) the nominal value of the Share. The 2010 Share Option Scheme does not contain any minimum period(s) for which an option must be held before it can be exercised. However, at the time of granting of the options, the Board may specify any such minimum period(s). No options may be exercised more than 10 years from the date of grant.

As at 31 December 2021, 72,000,000 share options granted to Cheng Jerome, the chairman and executive Director, under the 2010 Share Option Scheme remained outstanding.

With a view to allowing the Company to grant share options to eligible participants as incentives or rewards to recognise and acknowledge their contributions to the Group, the Company approved and adopted a new share option scheme at the annual general meeting of the Company held on 3 June 2020 (the **"2020 Share Option Scheme"**). The 2020 Share Option Scheme will be valid and effective for the period commencing on the date of adoption of the 2020 Share Option Scheme (being 3 June 2020) and ending on the 10th anniversary of such adoption date (both dates inclusive), after which no further share options will be offered but the rules of the 2020 Share Option Scheme will in all other respects remain in full force and effect. As at the date of this report, the remaining life of the 2020 Share Option Scheme is approximately 8.25 years.

## 購股權計劃

為允許本公司向合資格參與者授出購股權作為其對本集團作出貢獻的鼓勵或獎賞，本公司於二零二零年六月三日舉行的股東週年大會上批准及採納一項新購股權計劃(「二零二零年購股權計劃」)。由二零二零年購股權計劃採納日期(二零二零年六月三日)起直至該採納日期十週年(包括首尾兩日)，二零二零年購股權計劃將具有十足效力，該期間結束後不會再授出購股權，惟二零二零年購股權計劃規則將於所有其他方面具有十足效力及效用。於本報告日期，二零二零年購股權計劃餘下年期約為 8.25 年。

Under the 2020 Share Option Scheme, the Board may grant share options to the Group's employees, chief executives, officers, directors, substantial shareholders, advisors, consultants, agents, suppliers, customers, distributors and such other persons who, in the sole opinion of the Board, will contribute or have contributed to the Group. For any share options granted to Directors, chief executives or substantial shareholders of the Company or any of their respective associates will be subject to the approval by the independent non-executive Directors (excluding any independent non-executive Director who is the proposed grantee). As at the date of this report, the total number of Shares available for issue under the 2020 Share Option Scheme was 181,095,327 Shares, representing 10% of the aggregate number of Shares in issue as at 3 June 2020 and as at the date of this report. The number of Shares issued and to be issued upon the exercise of share options granted under the 2020 Share Option Scheme and other schemes of the Company to an individual in any 12-month period Offer Date shall not exceed 1% of the aggregate number of Shares in issue Offer Date, without prior approval from the shareholders of the Company. The amount payable by an eligible participant on acceptance of a share option is HK\$1.00, which will be payable within 30 business days after the date of grant.

The exercise price in relation to each share option will be determined by the Board, but in any event must be at least the highest of (i) the closing price of the Shares as stated in the daily quotation sheets of the Stock Exchange on the Offer Date; (ii) the average closing price of the Shares as stated in the daily quotation sheets of the Stock Exchange for the five business days immediately preceding the Offer Date; and (iii) the nominal value of a Share. Unless otherwise determined by the Board, there is no minimum period for which a share option must be held and/or any performance targets which must be achieved before a share option can be exercised. No option may be exercised more than 10 years from the date of grant.

As at 31 December 2021 and as at the date of this report, no option has been granted under the 2020 Share Option Scheme.

To maintain its market competitiveness within the industry, the Group aims at delivering constantly high standards and high quality products and services to its customers. During the year under review, there was no material and significant dispute between the Group and its suppliers and/or customers.

### RETIREMENT SCHEME

The Group operates a Mandatory Provident Fund Scheme ("MPF Scheme") under the Hong Kong Mandatory Provident Fund Schemes Ordinance for employees employed under the jurisdiction of the Hong Kong Employment Ordinance. The MPF Scheme is a defined contribution retirement scheme administered by independent trustees. Under the MPF Scheme, each of the employer and employee are required to make contributions of 5% of the employees' relevant income to the scheme, subject to a cap of monthly relevant income of HK\$30,000. Contributions made to the scheme are vested immediately.

The employees of the subsidiaries in China participate in the retirement schemes operated by the local authorities. The subsidiaries are required to contribute a certain percentage of their salaries to these schemes to pay the benefits. The only obligation of the Group in respect to these schemes is the required contributions under the schemes. For the year ended 31 December 2021, the Group's total contributions to the retirement schemes charged in the income statement amounted to approximately RMB6.4 million (2020: approximately RMB0.8 million). Details of the Group's retirement scheme and the basis of calculation are set out in note 6(b) to the financial statements.

### CODE ON CORPORATE GOVERNANCE PRACTICES

The Company is committed to the establishment of good corporate governance practices and procedures with a view to enhancing investor confidence and the Company's accountability and transparency. The Company therefore strives to attain and maintain effective corporate governance practices and procedures. Throughout the year ended 31 December 2021 and save as disclosed in this report, the Company has complied with the code provisions as set out in the Corporate Governance Code and Corporate Governance Report (the "CG Code") contained in Appendix 14 to the Listing Rules. 自願還款 : 分海應於獲得墊付的貸款後及償還日期前任何時間全部或部分提前償還該貸款(連同其應計之所有利息)，不計及任何罰金。

再借 : 分海可根據融資協議的條款再借已提前償還或償還循環貸款融資的任何部分，惟於融資期限任何時候(i)並無發生融資協議所載的任何違約事件；及(ii)所有貸款的未償還本金總額不得超過100百萬港元。

As at 31 December 2021, PCL is owned as to 47.24% by Pointsea Holdings Company Limited (“**Pointsea Holdings**”), 15.75% by Joy Empire Holdings Ltd, 15.75% by Extra Step Investments Limited, 15.75% by China Eastern Airlines E-Commerce Co., Ltd, 2.76% by Zhongjin Qizhi (Shanghai) Equity Investment Centre (Limited Partnership)\* (中金祺智(上海)股權投資中心(有限合夥)), and 2.76% by Senran Investment HK Company Limited. Pointsea Holdings is owned as to 80% by Treasure Ease Holdings Limited (“**Treasure Ease**”) and as to 20% by Easylink Payment Network (Hong Kong) Company Limited. Treasure Ease is owned as to 50.1% by the Company, 30% by Fin-Tech Company Limited (“**Fin-Tech**”) and 19.9% by Chance Talent Management Limited. The Board considers that PCL is a subsidiary of the Company through its power to control the board of directors of PCL. CIH, being a substantial shareholder of the Company, holds the entire issued share capital of Fin-Tech. PCL is therefore a connected person of the Company under Rule 14A.16 of the Listing Rules and the grant of the revolving loan facility constitutes a continuing connected transaction of the Company under Chapter 14A of the Listing Rules.

For further details of the transaction, please refer to the announcement of the Company dated 20 April 2021 and the circular of the Company dated 12 May 2021.

The proposed annual cap in respect of the revolving loan facility under the 2021 Facility Agreement for each financial year of the Company shall not exceed HK\$100 million.

As at 31 December 2021, the outstanding principal amount of the revolving loan is HK\$75,000,000 which is the highest outstanding principal amount of the revolving loan during the year ended 31 December 2021.

The independent non-executive Directors have reviewed and confirmed that the continuing connected transactions set out above has been entered into:

- (i) not in the ordinary and usual course of business of the Group;
- (ii) on normal commercial terms; and
- (iii) in accordance with the terms of the Facility Agreement, and on terms that are fair and reasonable and in the interests of the shareholders of the Company as a whole.

於二零二一年十二月三十一日，分海由分海控股有限公司（「分海控股」）、Joy Empire Holdings Ltd、Extra Step Investments Limited、東方航空電子商務有限公司、中金祺智(上海)股權投資中心(有限合夥)以及森然投資(香港)有限公司分別持有47.24%、15.75%、15.75%、15.75%、2.76%及2.76%。分海控股分別由寶怡控股有限公司（「寶怡」）及好易聯支付網絡(香港)有限公司擁有80%及20%。寶怡由本公司、Fin-Tech Company Limited（「**Fin-Tech**」）及Chance Talent Management Limited分別擁有50.1%、30%及19.9%。董事會認為，分海為本公司一間附屬公司，透過其權利控制分海董事會。CIH，作為本公司主要股東，持有 Fin-Tech全部已發行股本。因此，根據上市規則第14A.16條，分海為本公司的關連人士及授出循環貸款融資構成上市規則第14A章項下本公司持續關連交易。

二零二一年融資協議項下循環貸款融資於本公司每個財政年度的建議年度上限不超過100百萬港元。

## 企業管治報告

### CORPORATE GOVERNANCE PRACTICES

The Company is committed to the establishment of good corporate governance practices and procedures with a view to being a transparent and responsible organisation which is open and accountable to the Company's shareholders. The Board strives to adhere to the principles of corporate governance and has adopted sound corporate governance practices to meet the legal and commercial standards, focusing on areas such as internal control, fair disclosure and accountability to all shareholders to ensure the transparency and accountability of all operations of the Company. The Company believes that effective corporate governance is an essential factor to create more value for its shareholders. The Board will continue to review and improve the corporate governance practices of the Group from time to time to ensure that the Group is led by an effective Board in order to optimise return for shareholders.

Save as disclosed in this report, the Company had complied with the CG Code as set out in Appendix 14 to the Listing Rules throughout the year ended 31 December 2021.

### THE BOARD

The Board consists of six Directors, two of whom are executive Directors, one of whom is a non-executive Director and three of whom are independent non-executive Directors. The functions and duties conferred on the Board include convening shareholders' meetings and reporting on the work of the Board to the shareholders at shareholders' meetings as may be required by applicable laws, implementing resolutions passed at shareholders' meetings, determining the Company's business plans and investment plans, formulating the Company's annual budget and final accounts, formulating the Company's proposals for dividend and bonus distributions as well as exercising other powers, functions and duties as conferred on it by the Articles and applicable laws. The management team is delegated with the authorities and responsibilities by the Board for the day-to-day management and operations of the Group. The Board meets regularly to review the financial and operating performance of the Company, and considers and approves the overall strategies and policies of the Company. The composition of the Board is well balanced with the directors having sound industry knowledge, extensive corporate and strategic planning experience and/or expertise relevant to the business of the Group. The executive Directors, non-executive Director and independent non-executive Directors bring a variety of experience and expertise to the Company.

### 企業管治常規

本公司承諾建立良好的企業管治常規及程序，冀能成為一家具透明度及問責性的機構，以開放態度向本公司股東負責。董事會致力於遵守企業管治原則並已採納良好的企業管治常規，以符合法律及商業準則，專注於例如內部監控、公平披露及向所有股東負責等領域，以確保本公司所有業務之透明度及問責性。本公司相信，有效的企業管治是為股東創造更多價值之基礎。董事會將繼續不時檢討及改善本集團之企業管治常規，以確保本集團由有效董事會領導以為股東帶來最大回報。

除本報告所披露者外，於截至二零二一年十二月三十一日止年度本公司已遵守上市規則附錄14所載的企業管治守則。

### 董事會

董事會由六名董事組成，即兩名執行董事、一名非執行董事及三名獨立非執行董事。董事會之功能及職責包括根據適用法律之可能規定召開股東大會並於會上向股東報告董事會之工作，實施股東大會上通過之決議案，釐定本公司之業務計劃及投資計劃，制定本公司之年度預算及最終賬目，制定本公司之股息及花紅分派建議以及行使細則及適用法律賦予董事會之其他權力、功能及職責。董事會授予管理層團隊授權及責任負責本集團之日常管理及經營。董事會定期會面，以檢討本公司之財務及經營表現，並審議及批准本公司之總體策略及政策。董事會之成員各有所長，而董事對於本集團所從事業務均具備充分行業知識、豐富的企業及策略規劃經驗及／或專門技術。執行董事、非執行董事及獨立非執行董事為本公司帶來不同的經驗及專門技術。

The list of directors (by category) is also disclosed in all corporate communications issued by the Company pursuant to the Listing Rules from time to time. The independent non-executive Directors are expressly identified in all corporate communications pursuant to the Listing Rules.

During the year ended 31 December 2021, the Board at all times met the requirements of the Listing Rules relating to the appointment of at least three independent non-executive directors with at least one independent non-executive director possessing appropriate professional qualifications or accounting or related financial management expertise, and the independent non-executive directors represented over one-third of the Board.

The Company has received an annual confirmation of independence from each of its independent non-executive Directors pursuant to Rule 3.13 of the Listing Rules. Based on the contents of such confirmation, the Company considers that all three independent non-executive Directors are independent and that they have met the specific independence guidelines as set out in Rule 3.13 of the Listing Rules.

All Directors have separate and independent access to the Company’s management team to fulfill their duties and, upon reasonable request, to seek independent professional advice in appropriate circumstances, at the Company’s expense. All Directors also have access to the company secretary of the Company (“**Company Secretary**”) who is responsible for ensuring that the Board procedures, and all applicable rules and regulations, are followed. An agenda and accompanying Board/committee papers are distributed to the Directors/Board committee members with reasonable notices in advance of the meetings. Minutes of Board meetings and meetings of Board committees, which record in sufficient detail the matters considered by the Board and Board committees and decisions reached, including any concerns raised by Directors or dissenting views expressed, are kept by the Company Secretary and are open for inspection by Directors.

截至二零二一年十二月三十一日止年度，董事會一直符合上市規則有關委任至少三名獨立非執行董事，而其中至少一位獨立非執行董事具備適當之專業資格或會計或相關之財務管理專長之規定，且獨立非執行董事人數佔董事會三分之一以上。

根據上市規則第3.13條，本公司已從各位獨立非執行董事接獲年度獨立確認書。根據有關確認書之內容，本公司認為，三位獨立非執行董事均為獨立，且彼等符合上市規則第3.13條所載有關獨立性之特定指引。

所有董事可個別及獨立地與本公司的管理層團隊接洽以履行彼等之職責，並可於提出合理的要求後在適當的情況下尋求獨立專業意見，費用由本公司支付。所有董事亦可與本公司之公司秘書(「**公司秘書**」)接洽，而公司秘書乃負責確保董事會的程序及一切適用規則和規例獲得遵循。議程及隨附的董事會/委員會文件可於會議召開前事先給予合理通知下分發予董事/董事委員會成員。董事會會議及董事委員會會議的記錄詳細記錄董事會及董事委員會所考慮的事項及達致的決定，包括董事所提出的任何事項或發表的反對意見，概由公司秘書存檔，並可供董事查閱。

The Company has arranged for appropriate and sufficient insurance coverage on directors' liabilities in respect of legal actions taken against its directors arising out of corporate activities.

The Board meets regularly to review the financial and operating performance of the Company, and considers and approves the overall strategies and policies of the Company.

There is no other relationship between members of the Board and the Chairman.

Each of the executive Directors and the non-executive Director has entered into a service agreement with the Company for a term of three years, and each of the independent non-executive Directors has entered into a letter of appointment with the Company and is appointed for a term of three years.

In accordance with article 84 of the Articles, at each annual general meeting one-third of the Directors for the time being (or, if their number is not a multiple of three, the number nearest to but not less than one third) shall retire from office by rotation provided that every Director shall be subject to retirement at least once every three years. In accordance with article 84 of the Articles, each of Mr. Liu Jialin and Mr. Chan Chi Keung, Alan will retire from the office of Director by rotation and, being eligible, will offer themselves for re-election at the forthcoming annual general meeting.

#### Chairman and Chief Executive Officer

Prior to 16 June 2015, the roles and duties of the Chairman and the Chief Executive Officer of the Company were carried out by different individuals and have been clearly defined in writing. Mr. Cheng Jerome has been the Chairman of the Board since 25 March 2015 and Mr. Lai Fengcai had been the Chief Executive Officer until his resignation on 16 June 2015. The positions of Chairman and Chief Executive Officer had been held by separate persons in order to preserve independence and a balance of views and judgement. With the support of the management team, the Chairman is responsible for ensuring that the Directors receive adequate, complete and reliable information in a timely manner and appropriate briefing on issues arising at Board meetings. The Chief Executive Officer focuses on implementing objectives, policies and strategies approved and delegated by the Board and is in charge of the Company's day-to-day management and operations. The Chief Executive Officer is also responsible for developing strategic plans and formulating the organisational structure, control systems and internal procedures and processes for the Board's approval.

Since the resignation of Mr. Lai Fengcai as Chief Executive Officer on 16 June 2015, the position of Chief Executive Officer has not been filled up. The Company is in the process of identifying a suitable candidate to assume the role as Chief Executive Officer of the Company.

本公司已安排適合及充足保險，以覆蓋董事就企業活動期間產生對董事所提出法律訴訟的責任。

董事會定期會面，以檢討本公司之財務及經營表現，並審議及批准本公司之總體策略及政策。

董事會成員與主席之間並無其他關係。

各執行董事及非執行董事已與本公司訂立服務協議，為期三年，及每位獨立非執行董事已與本公司訂立委聘書，其委任為期三年。

根據細則第84條，於每次股東週年大會上，當時之三分之一董事（倘數目並非三之倍數，則為最接近之數目，惟不得少於三分之一）須輪值告退，惟各董事均須最少每三年輪值退任一次。按照細則第84條，劉嘉凌先生及陳志強先生各自將在即將召開的股東週年大會上依章輪值退任董事，合資格並願意參加重選連任。

#### 主席及行政總裁

於二零一五年六月十六日前，本公司的主席及行政總裁的角色及職責由不同人士擔任，並以書面清楚界定。Cheng Jerome先生已自二零一五年三月二十五日起擔任董事會主席，而賴鳳彩先生曾任行政總裁直至其於二零一五年六月十六日辭任。主席及行政總裁的職位由不同人士擔任，以保持獨立性及作出判斷時有平衡意見。在管理層團隊協助下，主席確保董事能適時收到充分、完整及可靠資料及有關董事會會議上提出之事宜之適當簡介。行政總裁主要負責實行董事會批准及授權的目標、政策及策略，以及負責本公司日常管理及運作。行政總裁亦負責發展策略計劃及制訂組織架構、監控系統及內部程序及流程供董事會批准。

自賴鳳彩先生於二零一五年六月十六日辭任行政總裁以來，行政總裁職位尚無填補。本公司現正物色擔任本公司行政總裁職務之合適人選。

## CONTINUOUS PROFESSIONAL DEVELOPMENT OF DIRECTORS

The Directors keep abreast of the responsibilities as a director of the Company and of the conduct, business activities and development of the Company. Every newly appointed Director will receive a formal, comprehensive and tailored induction on the first occasion of his/her appointment to ensure appropriate understanding of the business and operations of the Company and full awareness of director's responsibilities and obligations under the Listing Rules and relevant statutory requirements.

The Directors also participated in appropriate continuous professional development to develop and refresh their knowledge and skills to ensure that their contribution to the Board remains informed and relevant. They were involved in relevant training courses at the Company's expenses. All Directors also read materials in relation to regular update to statutory requirements, Listing Rules and other relevant topics related to a listed company.

## BOARD COMMITTEES

As an integral part of sound corporate governance practices, the Board has established the following Board committees to oversee the particular aspects of the Group's affairs. Each of these committees comprises independent non-executive Directors who are being invited to join as members.

### AUDIT COMMITTEE

The Audit Committee was established on 24 September 2010 in compliance with Rules 3.21 and 3.22 of the Listing Rules and with written terms of reference in compliance with the CG Code. The primary duties of the Audit Committee are to review and monitor the Company's financial reporting and internal control principles of the Company and to provide advice and comments to the Board. The members meet regularly with the external auditors and the Company's management team for the review, supervision and discussion of the Company's financial reporting and internal control procedures and ensure that management has discharged its duty to have an effective internal control and risk management system. During the year 2021, the Audit Committee consists of three members, namely Mr. Wong Chi Keung, Mr. Liu Jialin and Mr. Chan Chi Keung, Alan, of whom were all independent non-executive Directors. Mr. Wong Chi Keung, who has appropriate professional qualifications and experience in accounting matters, was appointed as the chairman of the Audit Committee.

The Audit Committee held two meetings during the year under review to review the financial results of the Group and significant issues on the financial reporting and compliance procedures, internal control and risk management systems.

## 董事的持續專業發展

董事須時刻了解身為本公司董事的職責並遵守本公司的行為操守、跟進業務活動及本公司發展。每名新任董事將於首次接受委任時獲得正式、全面及專門為其設計的入職培訓，以確保彼等對本公司業務及運作均有適當理解，並充分知悉於上市規則及相關法定要求項下董事的職責及責任。

董事亦已參與適當的持續專業發展以發展及更新其知識及技能，從而確保彼等對董事會的貢獻為知情及相關。彼等參加相關培訓課程，費用由本公司支付。全體董事亦閱讀有關定期更新的法定規定、上市規則及上市公司所涉其他相關主題的材料。

## 董事委員會

作為優良企業管治常規的重要構成部分，董事會已成立以下的董事委員會，以監察本集團特定範疇的事務。各委員會的成員皆包括獲邀加入委員會的獨立非執行董事。

### 審核委員會

審核委員會於二零一零年九月二十四日按照上市規則第3.21及3.22條成立，並備有符合企業管治守則的書面職權範圍。審核委員會的主要職責為審閱及監察本公司的財務申報及本公司的內部監控原則，並向董事會提供建議及意見。成員定期與外部核數師及本公司管理層團隊進行會晤，以審閱、監督及討論本公司的財務申報及內部監控程序，並確保管理層履行其職責以建立有效的內部監控及風險管理系統。於二零二一年度，審核委員會由三名成員，即黃之強先生、劉嘉凌先生及陳志強先生(均為獨立非執行董事)組成。黃之強先生具備適當的專業資格及會計事宜經驗，故獲委任為審核委員會主席。

審核委員會於回顧年度已召開兩次會議，審閱本集團的財務業績及有關財務申報及合規程序、內部監控及風險管理系統的重要事宜。

The Audit Committee has reviewed the consolidated financial statements of the Group for the year ended 31 December 2021, including the accounting principles and practices adopted by the Group, the selection and appointment of the external auditors and the effectiveness of the systems of risk management and internal control of the Group.

## CORPORATE GOVERNANCE FUNCTIONS

During the year under review, the Audit Committee was also responsible for determining the policy for the corporate governance of the Company performing the corporate governance duties as below:

- to develop and review the Group's policies and practices on corporate governance and make recommendations to the Board;
- to review and monitor the training and continuous professional development of the Directors and management team;
- to review the adequacy and effectiveness of the systems of risk management and internal control of the Group;
- to review and monitor the Group's policies and practices on compliance with all legal and regulatory requirements (where applicable);
- to develop, review and monitor the relevant code of conduct and compliance manual (if any) applicable to employees and directors of the Group; and
- to review the Group's compliance with the CG Code and disclosure requirements in the Corporate Governance Report.

## REMUNERATION COMMITTEE

The Remuneration Committee was established on 24 September 2010 with written terms of reference in compliance with the CG Code. During the year 2021, the Remuneration Committee was chaired by Mr. Liu Jialin with two Directors, namely Mr. Cheng Jerome and Mr. Wong Chi Keung, as members. The principal responsibilities of the Remuneration Committee are to formulate and recommend remuneration policy to the Board, make recommendations to the Board on the Company's policy and structure for all Directors' and management team's remunerations, approve and review management's proposals with reference to the Board's corporate goals and objectives and make recommendations to the Board on the remuneration of non-executive Directors. The Board expects the Remuneration Committee to exercise independent judgment and ensure that executive Directors do not participate in the determination of their own remunerations.

The Remuneration Committee held one committee meeting during the year under review to review and made recommendation to the Board on the remuneration policy and structure of the Company and remuneration packages of Directors and senior management.

During the year 2021, the chairman was Mr. Cheng Jerome, an executive Director, with two Directors, namely Mr. Wong Chi Keung and Mr. Chan Chi Keung, Alan, as members. The Nomination Committee is responsible for determining the policy for the nomination of Directors, reviewing the structure, size and composition of the Board, making recommendation to the Board on selection of candidates for directorships, appointment and reappointment of Directors and Board succession and assessing the independence of independent non-executive Directors.

The Company adopts the board diversity policy and recognises board diversity as the key element for the achievement of its strategic goals and sustainable development. In considering the composition and diversity of the Board, the Company takes into account a number of factors from various aspects, including but not limited to gender, age, cultural and educational background, ethnicity, professional experience, skills, knowledge and length of service. All decisions regarding appointment of members of the Board will be based on the candidates' meritocracy having regard to a set of objective standards that take into account the benefits of board diversity.

Selection of candidates will be based on a set of diversity criteria, including but not limited to gender, age, cultural and educational background, ethnicity, professional experience, skills, knowledge and length of service. The ultimate decision will be made with reference to the candidates' merits and contributions to the Board.

The Nomination Committee held one meeting during the year under review to review the structure, size and composition of the Board and the independence of the independent non-executive Directors.

## INTERNAL CONTROL AND RISK MANAGEMENT

The Board is responsible for maintaining sound and effective internal control and risk management systems in order to safeguard the Group's assets and shareholders' interests, and review and monitor the effectiveness of the Company's internal control and risk management systems on a regular basis so as to ensure that internal control and risk management systems in place are adequate. The Company has established written policies and procedures applicable to all operating units to ensure the effectiveness of internal controls. The internal control framework also ensures, among other things, that the Company's operations are monitored and reviewed on a regular basis by each department to ensure any inside information and other matters are identified handled efficiently and in compliance with the Listing Rules and applicable laws and regulations. The Company also has a process of identifying, evaluating, and managing the significant risks to the achievement of its operational objectives. This process is subject to continuous improvement and has been in place since 24 September 2010 and up to the date of this report. The day-to-day operation is entrusted to the individual department, which is accountable for its own conduct and performance, and is required to strictly adhere to the policies set by the Board. The Company carries out reviews on the effectiveness of the internal control and risk management systems from time to time in order to ensure that they are able to meet and deal with the dynamic and ever changing business environment.

The risk management framework includes identifying significant risks in the Group's operation environment and evaluating the impacts of those risks on the Group's business; developing necessary measures to manage those risks; and monitoring and reviewing the effectiveness of such measures. The implementation of risk management framework of the Group was assisted by the Group's internal audit function so that the Group could ensure new and emerging risks relevant to the Group's operation are promptly identified by the management, assess the adequacy of action plans to manage these risks and monitor and evaluate the effectiveness of the action plans. These are on-going processes and the Audit Committee reviews periodically the Group's risk management systems.

The Audit Committee reported to the Board the implementation of the Group's risk management and internal control policy which, among other things, included the determination of risk factors, evaluation of risk level the Group could take and effectiveness of risk management measures. Based on the reports from internal audit function and the Audit Committee, and also the Board's review of the Group's risk management and internal control systems at least once a year, the Board believes that the existing internal control and risk management systems are adequate and effective. The Board acknowledges that it is responsible for the risk management and internal control systems and reviewing their effectiveness, and that such systems are designed to manage rather than eliminate the risk of failure to achieve business objectives, and can only provide reasonable and not absolute assurance against material misstatement or loss.

- Any two or more shareholders holding at the date of deposit of the requisition not less than one-tenth of the paid up capital of the Company carrying the right of voting at general meetings of the Company (the “**Eligible Shareholders**”) shall at all times have the right, by a written requisition signed by the Eligible Shareholders concerned (the “**Requisition**”), to require the Board to convene an extraordinary general meeting, and to put any resolution so requisitioned to vote at such extraordinary general meeting.
  - Eligible Shareholders who wish to requisition the Board to convene an extraordinary general meeting for the purpose of proposing a resolution at the extraordinary general meeting must deposit the Requisition at the principal place of business of the Company in Hong Kong at Room 1908-1916, 19/F, Sun Hung Kai Centre, 30 Harbour Road, Wanchai, Hong Kong.
  - The Requisition must state clearly the names of the Eligible Shareholders concerned, specify the objects of the meeting, and be signed by the Eligible Shareholders concerned. The Eligible Shareholders must prove their shareholdings in the Company to the satisfaction of the Company.
  - The Company will check the Requisition and verify the identities and the shareholdings of the Eligible Shareholders with the Company’s branch share registrar. If the Requisition is found to be proper and in order and in compliance with the memorandum and articles of association of the Company, the Board will within 21 days of the date of deposit of the Requisition, duly proceed to convene an extraordinary general meeting to be held within a further 21 days, for the purpose of putting any resolution(s) proposed by the Eligible Shareholders to vote at such extraordinary general meeting. However, if the Requisition has been verified as not in order and not in compliance with the memorandum and articles of association of the Company, the Eligible Shareholders concerned will be advised of this outcome and accordingly, the Board will not convene an extraordinary general meeting and will not put any resolution(s) proposed by the Eligible Shareholders to vote at any such extraordinary general meeting or any other general meeting of the Company.

- If within 21 days of the date of deposit of the Requisition, the Board has not advised the Eligible Shareholders that the Requisition is not in order and not in compliance with the memorandum and articles of association of the Company, and the Board has failed to proceed to convene an extraordinary general meeting, the Eligible Shareholders themselves (or any one or more of the Eligible Shareholders who holds more than one-half of the total voting rights of all the Eligible Shareholders who signed the Requisition) may proceed to convene the extraordinary general meeting in the same manner, as nearly as possible, as that in which general meetings may be convened by the Board in accordance with the memorandum and articles of association of the Company, provided that the extraordinary general meeting so convened must be held before the expiration of three months from the date of deposit of the Requisition. All reasonable expenses incurred by the Eligible Shareholders concerned as a result of the failure of the Board shall be reimbursed to the Eligible Shareholders concerned by the Company.

#### OPINION

## MATERIAL UNCERTAINTY RELATED TO GOING CONCERN

We draw attention to Note 2(b) to the consolidated financial statements which indicates that Group incurred net loss of RMB124,863,000 and net operating cash outflows of RMB103,394,000 during the year ended 31 December 2021, and had net liabilities of RMB62,216,000 as at 31 December 2021. The Group's ability to meet its liabilities depends on its ability to generate sufficient cash flows from future operations and/or other sources. As stated in Note 2(b), these events or conditions, along with other matters set forth in Note 2(b), indicate the existence of material uncertainties which may cast significant doubt on the Group's ability to continue as a going concern. Our conclusion is not modified in respect of this matter.

## KEY AUDIT MATTERS

Key audit matters are those matters that, in our professional judgement, were of most significance in our audit of the consolidated financial statements of the current period. These matters were addressed in the context of our audit of the consolidated financial statements as a whole, and in forming our opinion thereon, and we do not provide a separate opinion on these matters. In addition to the matter described in the Material uncertainty related to going concern section, we have determined the matter described below to be the key audit matter to be communicated in our report.

### Revenue recognition

Refer to Note 4 to the consolidated financial statements and the accounting policies in Note 2(v).

我們注意到綜合財務報表附註2(b)顯示貴集團於截至二零二一年十二月三十一日止年度產生虧損淨額人民幣124,863,000元及經營現金流出淨額人民幣103,394,000元，以及於二零二一年十二月三十一日，負債淨額為人民幣62,216,000元。貴集團償還負債的能力取決於其從未來營運及／或其他來源產生足夠現金流量的能力。誠如附註2(b)所述，該等事件或情況，連同附註2(b)載列的其他事宜，顯示存在可能對貴集團繼續持續經營業務的能力產生重大疑問的重大不明朗因素。我們不會就此發表保留意見。

## 關鍵審計事項

關鍵審計事項是根據我們的專業判斷，認為對本期綜合財務報表的審計最為重要的事項。該等事項是在我們審計整體綜合財務報表及出具意見時進行處理的。我們不會對該等事項提供單獨的意見。除與持續經營有關的重大不明朗因素一節所述的事宜外，我們確定以下事項為需要在報告中溝通的關鍵審計事項。

#### The Key Audit Matter

The principal activities of the Group are the development and operation of an electronic trading platform to promote and facilitate awards earned by customers of loyalty programmes of other companies to be exchanged globally in the form of virtual assets and credits for consumption of merchandises, games, services and other commercial transactions and other trading business. The Group mainly generates revenue in the way of sales of goods and provision of services. Revenue of RMB114,211,000 was recognised for the current year.

The Group's revenue comprises a high volume of individual transactions. The Group maintains sophisticated information technology systems to process a large volume of data arising from these transactions, including details of the date and time of delivery of the goods sold. The completeness, existence and accuracy of the Group's revenue is highly reliant on the information technology systems.

#### How the matter was addressed in our audit

Our audit procedures to assess revenue recognition included the following:

- Discussing major business scenarios available on the electronic trading platform with management and evaluating their judgements made in determining whether the Group is a principal or an agent in an arrangement and the timing of revenue recognition, by inspecting agreements with business partners/suppliers and observing operation of selected business scenarios mentioned above;
- Involving our internal information technology specialists to evaluate the design, implementation and operating effectiveness of key internal controls over the capturing and processing of revenue transactions, including the completeness, existence and accuracy of the transaction details contained within the Group's information technology systems;
- Assessing the design, implementation and operating effectiveness of key manual internal controls over revenue recognition of major business scenarios available on the electronic trading platform;

貴集團主要活動為開發及營運電子交易平台，促使其他公司客戶忠誠度計劃賺取的獎勵能以虛擬資產及授信方式在全球交換並於商品、遊戲、服務及其他商業交易及其他交易業務中使用。貴集團主要以銷售貨品和提供服務產生收入。於本年度已確認收入為人民幣114,211,000元。

貴集團的收入包括大量的個別交易。貴集團擁有複雜的信息技術系統，以處理該等交易產生的大量數據，包括所售貨品的交付日期及時間詳情。貴集團收入的完整性、存在性及準確性高度依賴信息技術系統。

#### 我們的審計如何處理該事項

我們就評估收入確認的審計程序包括以下程序：

- Conclude on the appropriateness of the directors' use of the going concern basis of accounting and, based on the audit evidence obtained, whether a material uncertainty exists related to events or conditions that may cast significant doubt on the Group's ability to continue as a going concern. If we conclude that a material uncertainty exists, we are required to draw attention in our auditor's report to the related disclosures in the consolidated financial statements or, if such disclosures are inadequate, to modify our opinion. Our conclusions are based on the audit evidence obtained up to the date of our auditor's report. However, future events or conditions may cause the Group to cease to continue as a going concern.
- Evaluate the overall presentation, structure and content of the consolidated financial statements, including the disclosures, and whether the consolidated financial statements represent the underlying transactions and events in a manner that achieves fair presentation.

We describe these matters in our auditor's report unless law or regulation precludes public disclosure about the matter or when, in extremely rare circumstances, we determine that a matter should not be communicated in our report because the adverse consequences of doing so would reasonably be expected to outweigh the public interest benefits of such communication.

# Notes to the Financial Statements

## 財務報表附註

### 1 CORPORATE INFORMATION

Changyou Alliance Group Limited (the “Company”) was incorporated in the Cayman Islands on 21 May 2008 as an exempted company with limited liability under the Companies Law, Chapter 22 (Law 3 of 1961, as consolidated and revised) of the Cayman Islands. The shares of the Company were listed on The Stock Exchange of Hong Kong Limited (the “Stock Exchange”) on 24 September 2010.

The principal activities of the Company and its subsidiaries (collectively referred to as the “Group”) are the development and operation of an electronic trading platform to promote and facilitate awards earned by customers of loyalty programmes of other companies to be exchanged globally in the form of virtual assets and credits for consumption of merchandises, games, services and other commercial transactions and other trading business.

### 2 SIGNIFICANT ACCOUNTING POLICIES

#### (a) Statement of compliance

These financial statements have been prepared in accordance with all applicable Hong Kong Financial Reporting Standards (“HKFRSs”), which collective term includes all applicable individual Hong Kong Financial Reporting Standards, Hong Kong Accounting Standards (“HKASs”) and Interpretations issued by the Hong Kong Institute of Certified Public Accountants (the “HKICPA”), accounting principles generally accepted in Hong Kong and the disclosure requirements of the Hong Kong Companies Ordinance. These financial statements also comply with the applicable disclosure provisions of the Rules Governing the Listing of Securities on the Stock Exchange (the “Listing Rules”). Significant accounting policies adopted by the Group are disclosed below.

The HKICPA has issued certain amendments to HKFRSs that are first effective or available for early adoption for the current accounting period of the Group. Note 2(c) provides information on any changes in accounting policies resulting from initial application of these developments to the extent that they are relevant to the Group for the current accounting period reflected in these financial statements.

### 1 公司資料

暢由聯盟集團有限公司(「本公司」)根據開曼群島法例第22章公司法(一九六一年第三號法例，經綜合及修訂)於二零零八年五月二十一日在開曼群島註冊成立為獲豁免有限公司。本公司股份於二零一零年九月二十四日在香港聯合交易所有限公司(「聯交所」)上市。

本公司及其附屬公司(統稱「本集團」)主要活動為開發及營運電子交易平台，促使其他公司客戶忠誠度計劃賺取的獎勵能以虛擬資產及授信方式在全球交換並於商品、遊戲、服務及其他商業交易及其他交易業務中使用。

### 2 重大會計政策

#### (a) 合規聲明

該等財務報表已根據所有適用香港財務報告準則(「香港財務報告準則」)編製，其條款包括香港會計師公會(「香港會計師公會」)頒佈的所有適用的個別香港財務報告準則、香港會計準則(「香港會計準則」)及詮釋，香港公認會計原則和香港公司條例的披露規定。該等財務報表亦符合聯交所證券上市規則(「上市規則」)的適用披露條文。本集團採納的主要會計政策於下文披露。

香港會計師公會已頒佈若干項首次生效或可供本集團於本會計期間提前採納的經修訂的香港財務報告準則。附註2(c)提供初次應用該等發展對會計政策造成的任何變動的資料，惟以該等財務報表所反映的彼等與本集團本會計期間相關者為限。

### (b) Basis of preparation of the financial statements

The consolidated financial statements of the Company for the year ended 31 December 2021 comprise the Group.

The measurement basis used in the preparation of the financial statements is the historical cost basis except for held-for-trading investments (see Note 2(f)) and derivative financial instruments (see Note 2(g)) which are stated at their fair values.

The preparation of financial statements in conformity with HKFRSs requires management to make judgements, estimates and assumptions that affect the application of policies and reported amounts of assets, liabilities, income and expenses. The estimates and associated assumptions are based on historical experience and various other factors that are believed to be reasonable under the circumstances, the results of which form the basis of making the judgements about carrying values of assets and liabilities that are not readily apparent from other sources. Actual results may differ from these estimates.

The estimates and underlying assumptions are reviewed on an ongoing basis. Revisions to accounting estimates are recognised in the period in which the estimate is revised if the revision affects only that period, or in the period of the revision and future periods if the revision affects both current and future periods.

Judgements made by management in the application of HKFRSs that have significant effect on the financial statements and major sources of estimation uncertainty are discussed in Note 3.

### (b) 財務報表編製基準

本公司截至二零二一年十二月三十一日止年度之綜合財務報表包括本集團。

編製財務報表所用的計量基準為歷史成本基準，惟持作交易用途之投資(見附註2(f))及衍生金融工具(見附註2(g))則按公平值列賬。

編製符合香港財務報告準則的財務報表時，管理層須作出判斷、估計及假設，有關判斷、估計及假設會影響政策的應用及資產、負債、收入及開支的呈報金額。該等估計及相關假設乃基於過往經驗及其他被認為合理的因素，從該基準判斷得出的資產及負債的賬面值可能與其他來源得出的賬面值並不一致。實際結果可能與該等估計不同。

該等估計及相關假設按持續基準審閱。會計估計的修訂如只影響該修訂期，則於該修訂期內確認；修訂如影響本期間及未來期間，則於修訂期間及未來期間確認。

管理層應用香港財務報告準則時所作出對財務報表有重大影響之判斷及估計不明朗因素之主要來源於附註3討論。

For the year ended 31 December 2021, the Group had net loss of RMB124,863,000 and net cash used in operating activities of RMB103,394,000, and had net liabilities of RMB62,216,000 as at 31 December 2021. The Group will be unable to meet its liabilities in full when they fall due unless it is able to generate sufficient cash flows from future operations and/or other sources, since as at 31 December 2021, the Group only had cash and cash equivalents of RMB50,426,000. These events or conditions indicate the existence of material uncertainties which may cast significant doubt on the Group's ability to continue as a going concern.

In this regard, the directors of the Company have identified various initiatives to address the Group's liquidity needs, which include the following:

- The Group continues to streamline its operations by deployment of the necessary resources to profitable business lines, including continuance in reduction of current workforce or increase in workforce only if profitable business opportunities arise;
- As described in Note 30, the Group entered into an agreement with an investor in July 2020, and the both parties shall use all reasonable efforts within their respective capacity to fulfill the conditions precedent set out in the agreement on or before 30 June 2022 or such later date as may be agreed between the both parties in writing and proceed to completion of the transaction. Up to the date of issue of these financial statements, this capital injection is still under negotiation and has not yet been completed; and/or

截至二零二一年十二月三十一日止年度，本集團虧損淨額為人民幣124,863,000元及經營活動所用現金淨額為人民幣103,394,000元，以及於二零二一年十二月三十一日，負債淨額為人民幣62,216,000元。除非本集團能夠從未來營運及／或其他來源產生足夠現金流量，否則本集團將無法悉數償還到期負債，乃因於二零二一年十二月三十一日，本集團現金及現金等值項目僅為人民幣50,426,000元。該等事件或情況顯示存在可能對本集團繼續持續經營業務的能力產生重大疑問的重大不明朗因素。

就此，本公司董事已識別多項措施以解決本集團的流動資金需求，包括以下各項：

- 本集團繼續透過向可盈利業務線部署必要資源以精簡其營運，包括繼續縮減當前勞動力，或僅在出現可盈利業務機會時增加勞動力；
- 誠如附註30所述，本集團於二零二零年七月與一名投資者訂立協議，訂約雙方將於其各自能力範圍內盡所有合理努力以於二零二二年六月三十日或訂約雙方可能書面協定的有關較後日期或之前達成協議所載的先決條件，並促使完成交易。截至該等財務報表刊發日期，該注資仍在磋商中，且尚未完成；及／或

- The Group commences discussion with its immediate and ultimate holding company, Century Investment (Holding) Limited (“Century Investment”), to provide the necessary financial support when requires, including but not limited to:
  - (i) provision of the drawdown of the Group’s unused loan facilities with Century Investment of HK\$51,000,000 (equivalent to approximately RMB41,698,000) (see Note 22); and/or
  - (ii) extension of the repayment dates of the convertible bonds issued to and loans already drawn down from Century Investment (see Notes 20 and 22).

Based on the cash flow forecast of the Group prepared by the management and assuming success of the above measures, the directors of the Company are of the opinion that the Group would have adequate funds to meet its liabilities as and when they fall due at least twelve months from the end of the reporting period. Accordingly, the directors of the Company consider it is appropriate to prepare the consolidated financial statements on a going concern basis. Should the Group be unable to continue as a going concern, adjustments would have to be made to write down the value of assets to their recoverable amounts, to provide for further liabilities which might arise and to reclassify non-current assets and non-current liabilities as current assets and current liabilities respectively. The effect of these adjustments has not been reflected in the consolidated financial statements.

- 本集團與其直接及最終控股公司Century Investment (Holding) Limited (「Century Investment」)展開討論，以於需要時提供必要財務支持，包括但不限於：

- Amendments to HKFRS 9, HKAS 39 and HKFRS 7, HKFRS 4 and HKFRS 16, *Interest Rate Benchmark Reform – phase 2*
- Amendment to HKFRS 16, *Covid-19-related rent concessions beyond 30 June 2021*

The Group previously applied the practical expedient in HKFRS 16 such that as lessee it was not required to assess whether rent concessions occurring as a direct consequence of the Covid-19 pandemic were lease modifications, if the eligibility conditions are met. One of these conditions requires the reduction in lease payments affect only payments originally due on or before a specified time limit. The 2021 amendment extends this time limit from 30 June 2021 to 30 June 2022.

None of these developments have had a material effect on how the Group's results and financial position for the current or prior periods have been prepared or presented. Other than amendment to HKFRS 16, the Group has not applied any new standard or interpretation that is not yet effective for the current accounting period.

### (d) Subsidiaries and non-controlling interests

Subsidiaries are entities controlled by the Group. The Group controls an entity when it is exposed, or has rights, to variable returns from its involvement with the entity and has the ability to affect those returns through its power over the entity. When assessing whether the Group has power, only substantive rights (held by the Group and other parties) are considered.

本集團於本會計期間已對該等財務報表應用香港會計師公會頒佈的以下香港財務報告準則的修訂：

- 香港財務報告準則第16號修訂，於二零二一年六月三十日後新冠肺炎相關租金寬減

本集團先前應用香港財務報告準則第16號的可行權宜方法，因此，倘符合資格條件，作為承租人毋須評估直接因新冠肺炎疫情而產生的租金寬減是否屬租賃修訂。其中一項條件規定租賃付款的減少僅影響原定於指定時限或之前到期的付款。二零二一年的修訂將該時限由二零二一年六月三十日延長至二零二二年六月三十日。

該等變化對本集團如何編製或呈列當前或過往期間的業績及財務狀況並無造成重大影響。除香港財務報告準則第16號修訂外，本集團並未應用任何於本會計期間尚未生效的新訂準則或詮釋。

### (d) 附屬公司及非控股權益

附屬公司指受本集團控制的實體。當本集團從參與某實體之業務獲得或有權獲得可變回報，及有能力對實體行使其權力而影響其回報，則本集團控制該實體。評估本集團是否有權力時，只考慮具體權利(由本集團及其他人士持有)。

An investment in a subsidiary is consolidated into the consolidated financial statements from the date that control commences until the date that control ceases. Intra-group balances, transactions and cash flows and any unrealised profits arising from intra-group transactions are eliminated in full in preparing the consolidated financial statements. Unrealised losses resulting from intra-group transactions are eliminated in the same way as unrealised gains but only to the extent that there is no evidence of impairment.

Non-controlling interests represent the equity interests in a subsidiary not attributable directly or indirectly to the Company, and in respect of which the Group has not agreed any additional terms with the holders of those equity interests which would result in the Group as a whole having a contractual obligation in respect of those equity interests that meets the definition of a financial liability. For each business combination, the Group can elect to measure any non-controlling interests either at fair value or at the non-controlling interests' proportionate share of the subsidiary's net identifiable assets.

Non-controlling interests are presented in the consolidated statement of financial position within equity, separately from equity attributable to the equity shareholders of the Company. Non-controlling interests in the results of the Group are presented on the face of the consolidated statement of profit or loss and the consolidated statement of profit or loss and other comprehensive income as an allocation of the total profit or loss and total comprehensive income for the year between non-controlling interests and the equity shareholders of the Company.

Changes in the Group's equity interests in a subsidiary that do not result in a loss of control are accounted for as equity transactions, whereby adjustments are made to the amounts of controlling and non-controlling interests within consolidated equity to reflect the change in relative equity interests, but no adjustments are made to goodwill and no gain or loss is recognised.

於附屬公司的投資由控制開始當日至控制終止當日綜合計入綜合財務報表。集團內公司間的交易結餘及交易，與任何因集團內公司間交易而產生的現金流量和未變現溢利均在編製綜合財務報表時全數對銷。集團內公司間交易所產生的未變現虧損以處理未變現收益的同樣方式對銷，惟僅會在無減值跡象的情況下進行。

非控股權益指附屬公司不直接或間接歸屬於本公司的股本權益，而本集團與該等股本權益的持有人並無就此協定任何附加條款使本集團整體就有關股本權益而負有符合金融負債定義的合約性義務。本集團可在逐次企業合併基礎上選擇按其公平值或非控股權益享有附屬公司可識別淨資產的份額計量任何非控股權益。

When the Group loses control of a subsidiary, it is accounted for as a disposal of the entire equity interests in that subsidiary, with a resulting gain or loss being recognised in profit or loss. Any equity interests retained in that former subsidiary at the date when control is lost is recognised at fair value and this amount is regarded as the fair value on initial recognition of a financial asset (see Note 2(f)) or, when appropriate, the cost on initial recognition of an investment in an associate or joint venture.

In the Company's statement of financial position, an investment in a subsidiary is stated at cost less impairment losses (see Note 2(k)(ii)), unless the investment is classified as held-for-sale.

### (e) Goodwill

Goodwill represents the excess of:

- (i) the aggregate of the fair value of the consideration transferred, the amount of any non-controlling interests in the acquiree and the fair value of the Group's previously held equity interests in the acquiree; over
- (ii) the net fair value of the acquiree's identifiable assets and liabilities measured as at the acquisition date.

When (ii) is greater than (i), then this excess is recognised immediately in profit or loss as a gain on a bargain purchase.

Goodwill is stated at cost less accumulated impairment losses (see Note 2(k)(ii)). Goodwill arising on a business combination is allocated to each cash-generating unit, or groups of cash generating units, that is expected to benefit from the synergies of the combination and is tested annually for impairment (see Note 2(k)(ii)).

On disposal of a cash generating unit during the year, any attributable amount of purchased goodwill is included in the calculation of the profit or loss on disposal.

當本集團喪失對附屬公司的控制權時，會當作出售於該附屬公司的全部股本權益入賬，有關損益在損益內確認。在喪失控制權之日在前附屬公司中保留的任何股本權益按公平值確認，該金額會視為金融資產初始確認的公平值(見附註2(f))或(如適用)於聯營公司或合營企業的投資初始確認的成本。

在本公司的財務狀況表內，除非於附屬公司的投資分類為持作出售，否則以成本減去減值虧損(見附註2(k)(ii))列賬。

### (e) 商譽

商譽指：

- (i) 所轉讓代價的公平值、在被收購方的任何非控股權益金額以及本集團之前在被收購方中持有的股本權益的公平值的總額，超過
- (ii) 於收購日計量被收購方的可識別資產和負債的淨公平值的金額。

倘(ii)大於(i)，則該超出的金額即時作為議價購買收益在損益內確認。

商譽按成本減累計減值虧損(見附註2(k)(ii))列賬。業務合併產生的商譽會分配予每一個預期能從業務合併協同效應獲益的現金產生單位或現金產生單位組，並每年進行減值測試(見附註2(k)(ii))。

於年內出售現金產生單位後，購買商譽的任何應佔金額計入計算出售之損益。

### (f) Other investments in equity securities

The Group's policies for investments in equity securities, other than investments in subsidiaries, associates and joint ventures, are set out below.

Investments in equity securities are recognised/derecognised on the date the Group commits to purchase/sell the investment. The investments are initially stated at fair value plus directly attributable transaction costs, except for those investments measured at fair value through profit or loss ("FVPL") for which transaction costs are recognised directly in profit or loss. For an explanation of how the Group determines fair value of financial instruments, see Note 26(e). These investments are subsequently accounted for as follows.

An investment in equity securities is classified as FVPL unless the equity investment is not held for trading purposes and on initial recognition of the investment the Group makes an irrevocable election to designate the investment at fair value through other comprehensive income ("FVOCI") (non-recycling) such that subsequent changes in fair value are recognised in other comprehensive income. Such elections are made on an instrument-by-instrument basis, but may only be made if the investment meets the definition of equity from the issuer's perspective. Where such an election is made, the amount accumulated in other comprehensive income remains in the fair value reserve (non-recycling) until the investment is disposed of. At the time of disposal, the amount accumulated in the fair value reserve (non-recycling) is transferred to retained earnings. It is not recycled through profit or loss. Dividends from an investment in equity securities, irrespective of whether classified as at FVPL or FVOCI, are recognised in profit or loss in accordance with the policy set out in Note 2(v)(iv).

### (g) Derivative financial instruments

Derivative financial instruments are recognised initially at fair value. At the end of each reporting period the fair value is remeasured. The gain or loss on remeasurement to fair value is recognised immediately in profit or loss.

除於附屬公司、聯營公司及合營企業的投資外，本集團有關股本證券投資的政策如下。

股本證券投資於本集團承諾購買／出售該投資當日確認／終止確認。該等投資初步按公平值加上直接應佔交易成本(惟按公平值計入損益(「按公平值計入損益」)且交易成本直接於損益內確認的該等投資除外)列賬。有關本集團如何釐定金融工具之公平值的說明，見附註26(e)。該等投資其後列賬如下。

於股本證券的投資分類為按公平值計入損益，除非該股本投資並非以買賣目的而持有及初始確認投資時本集團選擇指定該投資為按公平值計入其他全面收益(「按公平值計入其他全面收益」)(不可劃轉)，以致公平值其後變動於其他全面收益確認。該選擇乃以個別工具基準作出，但僅可於該投資從發行人角度而言符合權益定義時作出。倘作該選擇，則其他全面收益中累計的金額維持於公平值儲備(不可劃轉)中，直至出售投資為止。於出售時，於公平值儲備(不可劃轉)中累計的金額轉至保留盈利，並不透過損益重新歸入。來自股本證券投資的股息不論其是否分類為按公平值計入損益或按公平值計入其他全面收益，均根據附註2(v)(iv)所載政策於損益中確認。

The items of property and equipment are stated at cost less accumulated depreciation and impairment losses (see Note 2(k)(ii)).

Gains or losses arising from the retirement or disposal of an item of property and equipment are determined as the difference between the net disposal proceeds and the carrying amount of the item and are recognised in profit or loss on the date of retirement or disposal.

Depreciation is calculated to write off the cost of items of property and equipment, less their estimated residual values, if any, over their estimated useful lives as follows:

Right-of-use assets	Over the term of lease

Where parts of an item of property and equipment have different useful lives, the cost of the item is allocated on a reasonable basis between the parts and each part is depreciated separately. Both the estimated useful life of an asset and its residual value, if any, are reviewed annually.

### (i) Intangible assets (other than goodwill)

Expenditure on research and development activities is recognised as an expense in the period in which it is incurred.

Intangible assets that are acquired by the Group are stated at cost less accumulated amortisation (where the estimated useful life is finite) and impairment losses (see Note 2(k)(ii)). Amortisation of intangible assets with finite useful lives is charged to profit or loss on a straight-line basis over the assets' estimated useful lives. Both the period and method of amortisation are reviewed annually.

At inception of a contract, the Group assesses whether the contract is, or contains, a lease. A contract is, or contains, a lease if the contract conveys the right to control the use of an identified asset for a period of time in exchange for consideration. Control is conveyed where the customer has both the right to direct the use of the identified asset and to obtain substantially all of the economic benefits from that use.

#### *As a lessee*

Where the contract contains lease component(s) and non-lease component(s), the Group has elected not to separate non-lease components and accounts for each lease component and any associated non-lease components as a single lease component for all leases.

At the lease commencement date, the Group recognises a right-of-use asset and a lease liability, except for short-term leases that have a lease term of 12 months or less and leases of low-value assets. When the Group enters into a lease in respect of a low-value asset, the Group decides whether to capitalise the lease on a lease-by-lease basis. The lease payments associated with those leases which are not capitalised are recognised as an expense on a systematic basis over the lease term.

Where the lease is capitalised, the lease liability is initially recognised at the present value of the lease payments payable over the lease term, discounted using the interest rate implicit in the lease or, if that rate cannot be readily determined, using a relevant incremental borrowing rate. After initial recognition, the lease liability is measured at amortised cost and interest expense is calculated using the effective interest method. Variable lease payments that do not depend on an index or rate are not included in the measurement of the lease liability and hence are charged to profit or loss in the accounting period in which they are incurred.

#### *作為承租人*

倘合約包含租賃部分及非租賃部分，則本集團已選擇不區分非租賃部分，並將各租賃部分及任何相關非租賃部分入賬列為所有租賃的單一租賃部分。

於租賃開始日期，本集團確認使用權資產及租賃負債，惟租賃期為12個月或更短的短期租賃及低價值資產租賃除外。當本集團就低價值資產訂立租賃時，本集團按每項租賃情況決定是否將租賃資本化。與該等不作資本化租賃相關的租賃付款在租賃期內按系統基準確認為開支。

當將租賃資本化時，租賃負債初步按租賃期內應付租賃付款的現值確認，並使用租賃中隱含的利率或(倘該利率不可直接釐定)使用相關的增量借貸利率貼現。初步確認後，租賃負債按攤銷成本計量，而利息開支則採用實際利率法計算。不取決於某一指數或比率的可變租賃付款不包括在租賃負債的計量，因此於其產生的會計期間於損益中扣除。

Where applicable, the cost of the right-of-use assets also includes an estimate of costs to dismantle and remove the underlying asset or to restore the underlying asset or the site on which it is located, discounted to their present value, less any lease incentives received. The right-of-use asset is subsequently stated at cost less accumulated depreciation and impairment losses (see Notes 2(h) and 2(k)(ii)).

The lease liability is remeasured when there is a change in future lease payments arising from a change in an index or rate, or there is a change in the Group's estimate of the amount expected to be payable under a residual value guarantee, or there is a change arising from the reassessment of whether the Group will be reasonably certain to exercise a purchase, extension or termination option. When the lease liability is remeasured in this way, a corresponding adjustment is made to the carrying amount of the right-of-use asset, or is recorded in profit or loss if the carrying amount of the right-of-use asset has been reduced to zero.

The lease liability is also remeasured when there is a change in the scope of a lease or the consideration for a lease that is not originally provided for in the lease contract ("lease modification") that is not accounted for as a separate lease. In this case the lease liability is remeasured based on the revised lease payments and lease term using a revised discount rate at the effective date of the modification. The only exceptions are rent concessions that occurred as a direct consequence of the Covid-19 pandemic and met the conditions set out in paragraph 46B of HKFRS 16, *Leases*. In such cases, the Group has taken advantage of the practical expedient not to assess whether the rent concessions are lease modifications, and recognised the change in consideration as negative variable lease payments in profit or loss in the period in which the event or condition that triggers the rent concessions occurred.

In the consolidated statement of financial position, the current portion of long-term lease liabilities is determined as the present value of contractual payments that are due to be settled within twelve months after the reporting period.

### (k) Credit losses and impairment of assets

#### *(i) Credit losses from financial instruments and contract assets*

The Group recognises a loss allowance for expected credit losses ("ECLs") on financial assets measured at amortised cost (including cash and cash equivalents, and trade and other receivables) and contract assets.

Financial assets measured at fair value, including equity securities measured at FVPL, are not subject to the ECL assessment.

當租賃範疇發生變化或租賃合約原先並無規定的租賃代價發生變化(「租賃修訂」)，且未作為單獨租賃入賬時，則亦會重新計量租賃負債。於該情況下，租賃負債根據經修訂租賃付款及租賃期限，採用經修訂折現率於修訂生效日重新計量。唯一例外情況為直接因新冠肺炎疫情而產生的租金寬減，並符合香港財務報告準則第16號租賃第46B段所載的條件。於該情況下，本集團已利用可行權宜方法，不評估租金寬減是否屬租賃修訂，並於觸發租金寬減的事件或條件期間內的損益內確認代價變動為負可變租賃付款。

##### *Measurement of ECLs*

ECLs are a probability-weighted estimate of credit losses. Credit losses are measured as the present value of all expected cash shortfalls (i.e. the difference between the cash flows due to the Group in accordance with the contract and the cash flows that the Group expects to receive).

The expected cash shortfalls of trade and other receivables and contract assets are discounted using the effective interest rate determined at initial recognition or an approximation thereof where the effect of discounting is material.

The maximum period considered when estimating ECLs is the maximum contractual period over which the Group is exposed to credit risk.

In measuring ECLs, the Group takes into account reasonable and supportable information that is available without undue cost or effort. This includes information about past events, current conditions and forecasts of future economic conditions.

ECLs are measured on either of the following bases:

- 12-month ECLs: these are losses that are expected to result from possible default events within the 12 months after the reporting date; and
- lifetime ECLs: these are losses that are expected to result from all possible default events over the expected lives of the items to which the ECL model applies.

預期信貸虧損為信貸虧損可能性的加權估計。信貸虧損按所有預期現金差額(即根據合約應付本集團的現金流量與及本集團預期收取的現金流量之間的差額)的現值計量。

倘貼現影響重大，則貿易及其他應收款項以及合約資產的預期現金差額將採用於初步確認時釐定的實際利率或其近似值貼現。

估計預期信貸虧損時所考慮的最長期間為本集團所面臨信貸風險的最長合約期間。

在計量預期信貸虧損時，本集團會考慮在毋需付出過多成本及努力下即可獲得的合理可靠的資料，當中包括有關過去事件、當前狀況及未來經濟狀況預測的資料。

預期信貸虧損按下列其中一種基準計量：

- 12個月的預期信貸虧損：預期因報告日期後12個月內發生的可能違約事件導致的該等虧損；及

Loss allowances for trade receivables and contract assets are always measured at an amount equal to lifetime ECLs. ECLs on these financial assets are estimated using a provision matrix based on the Group's historical credit loss experience, adjusted for factors that are specific to the debtors and an assessment of both the current and forecast general economic conditions at the reporting date.

For all other financial instruments, the Group recognises a loss allowance equal to 12-month ECLs unless there has been a significant increase in credit risk of the financial instrument since initial recognition, in which case the loss allowance is measured at an amount equal to lifetime ECLs.

##### *Significant increases in credit risk*

In assessing whether the credit risk of a financial instrument has increased significantly since initial recognition, the Group compares the risk of default occurring on the financial instrument assessed at the reporting date with that assessed at the date of initial recognition. In making this reassessment, the Group considers that a default event occurs when the borrower is unlikely to pay its credit obligations to the Group in full, without recourse by the Group to actions such as realising security (if any is held). The Group considers both quantitative and qualitative information that is reasonable and supportable, including historical experience and forward-looking information that is available without undue cost or effort.

貿易應收款項及合約資產的虧損撥備一直按相等於整個存續期的預期信貸虧損的金額計量。該等金融資產的預期信貸虧損基於本集團過往信貸虧損經驗(並就債務人的特定因素作出調整)及於報告日期對目前及預期一般經濟狀況的評估採用撥備矩陣估計。

就所有其他金融工具而言，本集團按相等於12個月的預期信貸虧損確認虧損撥備，除非金融工具於初步確認以來的信貸風險大幅增加，在此情況下，虧損撥備按相等於整個存續期預期信貸虧損的金額計量虧損撥備。

##### *信貸風險大幅增加*

評估金融工具的信貸風險自初步確認以來有否大幅上升時，本集團會比較於報告日期及於初步確認日期評估的金融工具發生違約的風險。作出該重新評估時，本集團認為，倘借款人不大可能在本集團無追索權採取變現抵押(如持有)等行動的情況下向本集團悉數支付其信貸債務，則構成違約事件。本集團會考慮合理可靠的定量及定性資料，包括過往經驗及在無需付出過多成本或努力下即可獲得的前瞻性資料。

In particular, the following information is taken into account when assessing whether credit risk has increased significantly since initial recognition:

- failure to make payments of principal or interest on their contractually due dates;
- an actual or expected significant deterioration in a financial instrument's external or internal credit rating (if available);
- an actual or expected significant deterioration in the operating results of the debtor; and
- existing or forecast changes in the market, economic or legal environment that have a significant adverse effect on the debtor's ability to meet its obligation to the Group.

Depending on the nature of the financial instruments, the assessment of a significant increase in credit risk is performed on either an individual basis or a collective basis. When the assessment is performed on a collective basis, the financial instruments are grouped based on shared credit risk characteristics, such as past due status and credit risk ratings.

ECLs are remeasured at each reporting date to reflect changes in the financial instrument's credit risk since initial recognition. Any change in the ECL amount is recognised as an impairment gain or loss in profit or loss. The Group recognises an impairment gain or loss for all financial instruments with a corresponding adjustment to their carrying amount through a loss allowance account.

*Basis of calculation of interest income*

Interest income recognised in accordance with Note 2(v)(iii) is calculated based on the gross carrying amount of the financial asset unless the financial asset is credit-impaired, in which case interest income is calculated based on the amortised cost (i.e. the gross carrying amount less loss allowance) of the financial asset.

At each reporting date, the Group assesses whether a financial asset is credit-impaired. A financial asset is credit-impaired when one or more events that have a detrimental impact on the estimated future cash flows of the financial asset have occurred.

Evidence that a financial asset is credit-impaired includes the following observable events:

- significant financial difficulties of the debtor;
- a breach of contract, such as a default or past due event;

- significant changes in the market, economic or legal environment that have an adverse effect on the debtor.

*Write-off policy*

The gross carrying amount of a financial asset is written off (either partially or in full) to the extent that there is no realistic prospect of recovery. This is generally the case when the Group determines that the debtor does not have assets or sources of income that could generate sufficient cash flows to repay the amounts subject to the write-off.

Subsequent recoveries of an asset that was previously written off are recognised as a reversal of impairment in profit or loss in the period in which the recovery occurs.

#### (ii) *Impairment of other assets*

Internal and external sources of information are reviewed at the end of each reporting period to identify indications that the following assets may be impaired or, except in the case of goodwill, an impairment loss previously recognised no longer exists or may have decreased:

- property and equipment, including right-of-use assets;
- intangible assets;

- Calculation of recoverable amount

The recoverable amount of an asset is the greater of its fair value less costs of disposal and value in use. In assessing value in use, the estimated future cash flows are discounted to their present value using a pre-tax discount rate that reflects current market assessments of the time value of money and the risks specific to the asset. Where an asset does not generate cash inflows largely independent of those from other assets, the recoverable amount is determined for the smallest group of assets that generates cash inflows independently (i.e. a cash-generating unit).

– Recognition of impairment losses

An impairment loss is recognised in profit or loss if the carrying amount of an asset, or the cash-generating unit to which it belongs, exceeds its recoverable amount. Impairment losses recognised in respect of cash-generating units are allocated first to reduce the carrying amount of any goodwill allocated to the cash-generating unit (or group of units) and then, to reduce the carrying amount of the other assets in the unit (or group of units) on a pro rata basis, except that the carrying value of an asset will not be reduced below its individual fair value less costs of disposal (if measurable) or value in use (if determinable).

– Reversals of impairment losses

In respect of assets other than goodwill, an impairment loss is reversed if there has been a favourable change in the estimates used to determine the recoverable amount. An impairment loss in respect of goodwill is not reversed.

A reversal of an impairment loss is limited to the asset's carrying amount that would have been determined had no impairment loss been recognised in prior years. Reversals of impairment losses are credited to profit or loss in the year in which the reversals are recognised.

#### (iii) *Interim financial reporting and impairment*

Under the Listing Rules, the Group is required to prepare an interim financial report in compliance with HKAS 34, Interim financial reporting, in respect of the first six months of the financial year. At the end of the interim period, the Group applies the same impairment testing, recognition, and reversal criteria as it would at the end of the financial year (see Notes 2(k)(i) and 2(k)(ii)).

Impairment losses recognised in an interim period in respect of goodwill are not reversed in a subsequent period. This is the case even if no loss, or a smaller loss, would have been recognised had the impairment been assessed only at the end of the financial year to which the interim period relates.

### (l) Inventories and other contract costs

#### (i) *Inventories*

Inventories are assets which are held for sale in the ordinary course of business.

Inventories are carried at the lower of cost and net realisable value.

Cost is calculated using the weighted average cost formula and comprises all costs of purchase and other costs incurred in bringing the inventories to their present location and condition.

Net realisable value is the estimated selling price in the ordinary course of business less the estimated costs necessary to make the sale.

#### (iii) 中期財務報告及減值

根據上市規則，本集團須就財政年度首六個月編製符合香港會計準則第34號中期財務報告規定的中期財務報告。本集團在中期期末應用與財政年度末所應用者相同的減值測試、確認和撥回標準(見附註2(k)(i)及2(k)(ii))。

#### (i) *Inventories (continued)*

When inventories are sold, the carrying amount of those inventories is recognised as an expense in the period in which the related revenue is recognised. The amount of any write-down of inventories to net realisable value and all losses of inventories are recognised as an expense in the period of the write-down or loss occurs. The amount of any reversal of any write-down of inventories is recognised as a reduction in the amount of inventories recognised as an expense in the period in which the reversal occurs.

#### (ii) *Other contract costs*

Other contract costs are either the incremental costs of obtaining a contract with a customer or the costs to fulfil a contract with a customer which are not capitalised as inventories (see Note 2(l)(i)).

Incremental costs of obtaining a contract are those costs that the Group incurs to obtain a contract with a customer that it would not have incurred if the contract had not been obtained e.g. an incremental sales commission. Incremental costs of obtaining a contract are capitalised when incurred if the costs relate to revenue which will be recognised in a future reporting period and the costs are expected to be recovered. Other costs of obtaining a contract are expensed when incurred.

#### (i) *存貨(續)*

於出售存貨時，該等存貨的賬面值在相關收入確認的期間確認為開支。存貨撇減至可變現淨值的任何金額及存貨的所有虧損，在撇減或出現虧損的期間確認為開支。撥回任何存貨撇減的金額，會於撥回期間確認為已確認為開支之存貨金額減少。

#### (ii) *其他合約成本*

其他合約成本指未資本化為存貨的從客戶獲得合約的增量成本或履行與客戶訂立合約的成本(請參閱附註2(l)(i))。

#### (ii) Other contract costs (continued)

Costs to fulfil a contract are capitalised if the costs relate directly to an existing contract or to a specifically identifiable anticipated contract; generate or enhance resources that will be used to provide goods or services in the future; and are expected to be recovered. Costs that relate directly to an existing contract or to a specifically identifiable anticipated contract may include costs that are explicitly chargeable to the customer and other costs that are incurred only because the Group entered into the contract (for example, payments to sub-contractors). Other costs of fulfilling a contract are expensed as incurred.

Capitalised contract costs are stated at cost less accumulated amortisation and impairment losses. Impairment losses are recognised to the extent that the carrying amount of the contract cost asset exceeds the net of (i) remaining amount of consideration that the Group expects to receive in exchange for the goods or services to which the asset relates, less (ii) any costs that relate directly to providing those goods or services that have not yet been recognised as expenses.

### (m) Contract assets and contract liabilities

A contract asset is recognised when the Group recognises revenue (see Note 2(v)) before being unconditionally entitled to the consideration under the payment terms set out in the contract. Contract assets are assessed for ECLs in accordance with the policy set out in Note 2(k)(i) and are reclassified to receivables when the right to the consideration has become unconditional (see Note 2(n)).

#### (ii) 其他合約成本(續)

倘成本直接與現有合約或可特別認定的預計合約相關；產生或增加日後將用於提供貨品或服務的資源；及預期將被收回，則完成合約的成本會資本化。直接與現有合約或可特別認定的預計合約有關的成本可能包括可明確向客戶收取的成本及僅因本集團訂立合約而產生的其他成本(如向分包商付款)。完成合約的其他成本於產生時支銷。

資本化合約成本按成本減累計攤銷及減值虧損列賬。當合約成本資產的賬面值超過(i)本集團預期因交換資產相關貨品或服務而將收取的代價餘額，減(ii)尚未確認為開支之直接與提供該等貨品或服務相關的任何成本的淨額時，確認減值虧損。

### (m) 合約資產及合約負債

於本集團有無條件權利根據合約所載支付條款收取代價前，合約資產於確認收入時予以確認(見附註2(v))。合約資產根據附註2(k)(i)所載之政策就預期信貸虧損進行評估，並於收取代價的權利成為無條件時重新分類至應收款項(見附註2(n))。

A contract liability is recognised when the customer pays non-refundable consideration before the Group recognises the related revenue (see Note 2(v)). A contract liability would also be recognised if the Group has an unconditional right to receive non-refundable consideration before the Group recognises the related revenue. In such cases, a corresponding receivable would also be recognised (see Note 2(n)).

For a single contract with the customer, either a net contract asset or a net contract liability is presented. For multiple contracts, contract assets and contract liabilities of unrelated contracts are not presented on a net basis.

### (n) Trade and other receivables

A receivable is recognised when the Group has an unconditional right to receive consideration. A right to receive consideration is unconditional if only the passage of time is required before payment of that consideration is due. If revenue has been recognised before the Group has an unconditional right to receive consideration, the amount is presented as a contract asset (see Note 2(m)).

Trade receivables that do not contain a significant financing component are initially measured at their transaction price. Trade receivables that contain a significant financing component and other receivables are initially measured at fair value plus transaction costs. All receivables are subsequently stated at amortised cost, using the effective interest method and including an allowance for credit losses (see Note 2(k)(i)).

### (o) Cash and cash equivalents

Cash and cash equivalents comprise cash at bank and on hand, demand deposits with banks and other financial institutions, and short-term, highly liquid investments that are readily convertible into known amounts of cash and which are subject to an insignificant risk of changes in value. Cash and cash equivalents are assessed for ECLs in accordance with the policy set out in Note 2(k)(i).

於本集團確認相關收入前，合約負債於客戶支付不可退還代價時予以確認(見附註2(v))。倘本集團於確認相關收入時有無條件權利收取不可退還代價，則亦會確認合約負債。在該等情況下，將會確認相應收款項(見附註2(n))。

就與客戶的單一合約而言，會呈列合約資產淨值或合約負債淨額。就多份合約而言，非相關合約的合約資產及合約負債不按淨額基準呈列。

### (n) 貿易及其他應收款項

本集團具有無條件權利收取代價時確認應收款項。在該代價到期支付前，收取代價之權利僅需經過一段時間方成為無條件。倘收益於本集團有無條件權利收取代價前確認，則該金額呈列為合約資產(見附註2(m))。

貿易應收款項並不包含初始按其交易價格計量的重大融資部分。包含重大融資部分的貿易應收款項及其他應收款項初始按公平值加交易成本計量。所有應收款項隨後採用實際利率法按攤銷成本列賬，並包括信貸虧損撥備(見附註2(k)(i))。

### (o) 現金及現金等值項目

現金及現金等值項目包括銀行及手頭現金、銀行及其他金融機構的活期存款以及可隨時轉換為已知金額現金的短期高流通且價值改變風險不大的投資。現金及現金等值項目根據附註2(k)(i)所載政策進行預期信貸虧損評估。

Interest-bearing borrowings are measured initially at fair value less transaction costs. Subsequent to initial recognition, interest-bearing borrowings are stated at amortised cost using the effective interest method. Interest expense is recognised in accordance with the Group's accounting policy for borrowing costs (see Note 2(x)).

### (q) Trade and other payables

Trade and other payables are initially recognised at fair value. Subsequent to initial recognition, trade and other payables are stated at amortised cost using the effective interest method unless the effect of discounting would be immaterial, in which case they are stated at invoice amounts.

### (r) Convertible bonds

#### (i) *Convertible bonds that contain an equity component*

Convertible notes that can be converted into ordinary shares at the option of the holder, where a fixed number of shares are issued for a fixed amount of cash or other financial assets, are accounted for as compound financial instruments, i.e. they contain both a liability component and an equity component.

At initial recognition the liability component of the convertible bonds is measured at the fair value based on the future interest and principal payments, discounted at the prevailing market rate of interest for similar non-convertible instruments. The equity component is the difference between the initial fair value of the convertible bonds as a whole and the initial fair value of the liability component. Transaction costs that relate to the issue of a compound financial instrument are allocated to the liability and equity components in proportion to the allocation of proceeds.

計息借款初步按公平值減交易成本計量。初步確認後，計息借款採用實際利率法以攤銷成本列賬。利息開支根據本集團借款成本的會計政策確認(見附註2(x))。

### (q) 貿易及其他應付款項

貿易及其他應付款項初始按公平值確認。初步確認後，貿易及其他應付款項採用實際利率法按攤銷成本列賬，除非折現影響不大，於該情況下，則會按發票金額列賬。

### (r) 可換股債券

#### (i) *包含權益部分的可換股債券*

可按持有人選擇兌換為普通股的可換股債券，倘就確定金額的現金或其他金融資產發行確定數目的股份，則作為複合金融工具入賬，即同時含有負債部分及權益部分。

初步確認時，可換股債券之負債部分乃基於未來利息及本金付款按公平值計量，並按類似不可轉換工具的現行市場利率折現。權益部分為可換股債券整體的初始公平值與負債部分的初始公平值之間的差額。與發行複合金融工具相關的交易成本按分配所得款項的比例分配至負債及權益部分。

The liability component is subsequently carried at amortised cost. Interest expense recognised in profit or loss on the liability component is calculated using the effective interest method. The equity component is not remeasured and is recognised in the capital reserve until either the bonds are converted.

If the bonds are converted, the capital reserve, together with the carrying amount of the liability component at the time of conversion, is transferred to share capital and share premium as consideration for the shares issued.

#### (ii) *Other convertible bonds*

Convertible bonds which do not contain an equity component are accounted for as follows:

At initial recognition the derivative components of the convertible bonds are measured at fair value as derivative financial instruments (see Note 2(g)). Any excess of proceeds over the amount initially recognised as the derivative components are recognised as the host liability components. Transaction costs that relate to the issue of the convertible bonds are allocated to the host liability and derivative components in proportion to the allocation of proceeds. The portion of the transaction costs relating to the host liability components are recognised initially as part of the liabilities. The portion relating to the derivative components are recognised immediately in profit or loss.

The derivative components are subsequently remeasured in accordance with Note 2(g). The host liability components are subsequently carried at amortised cost. Interest expenses recognised in profit or loss on the host liability components are calculated using the effective interest method.

負債部分隨後按攤銷成本列賬。負債部分於損益確認的利息開支採用實際利息法計算。權益部分並無重新計量，並於股本儲備中確認，直至債券被轉換為止。

倘兌換債券，則兌換時之股本儲備連同負債部分賬面值轉撥至股本及股份溢價，作為發行股份的代價。

#### (ii) 其他可換股債券

不含權益部分的可換股債券按以下方式入賬：

If the bonds are converted, the shares issued are measured at fair value and any differences between the fair value of shares issued and the carrying amounts of the derivative and host liability components are recognised in profit or loss. If the bonds are redeemed, any differences between the amounts paid and the carrying amounts of both components are recognised in profit or loss.

### (s) Employee benefits

#### (i) *Short-term employee benefits and contributions to defined contribution retirement plans*

Salaries, annual bonuses, paid annual leave, contributions to defined contribution retirement plans and the cost of non-monetary benefits are accrued in the year in which the associated services are rendered by employees. Where payment or settlement is deferred and the effect would be material, these amounts are stated at their present values.

The Group's contributions to defined contribution retirement plans are charged to profit or loss when incurred.

#### (ii) *Share-based payments*

The fair value of share options granted to employees is recognised as an employee cost with a corresponding increase in capital reserve within equity. The fair value is measured at grant date using the Binomial Option Pricing Model, taking into account the terms and conditions upon which the share options were granted. Where the employees have to meet vesting conditions before becoming unconditionally entitled to the share options, the total estimated fair value of the share options is spread over the vesting period, taking into account the probability that the share options will vest.

本集團對界定供款退休計劃作出的供款於供款時扣自損益。

#### (ii) *以股份為基礎的付款*

授予僱員的購股權的公平值確認為僱員成本，而權益內的儲備亦相應增加。購股權公平值於授出日期考慮授出購股權之條款及條件後按二項式期權定價模式計量。倘僱員須於無條件享有購股權權利前達成歸屬條件，考慮到購股權獲歸屬之可能性後，購股權之估計公平值總值於歸屬期內攤分。

Any resulting adjustment to the cumulative fair value recognised in prior years is charged/credited to the profit or loss for the year of the review, unless the original employee expenses qualify for recognition as an asset, with a corresponding adjustment to the capital reserve. On vesting date, the amount recognised as an expense is adjusted to reflect the actual number of the share options that vest (with a corresponding adjustment to the capital reserve) except where forfeiture is only due to not achieving vesting conditions that relate to the market price of the Company's shares. The equity amount is recognised in the capital reserve until either the share option is exercised (when it is included in the amount recognised in share capital for the shares issued) or the share option expires (when it is released directly to retained profits).

#### (iii) *Termination benefits*

Termination benefits are recognised at the earlier of when the Group can no longer withdraw the offer of those benefits and when it recognises restructuring costs involving the payment of termination benefits.

#### (t) *Income tax*

Income tax for the year comprises current tax and movements in deferred tax assets and liabilities. Current tax and movements in deferred tax assets and liabilities are recognised in profit or loss except to the extent that they relate to business combinations, or items recognised in other comprehensive income or directly in equity, in which case the relevant amounts of tax are recognised in other comprehensive income or directly in equity, respectively.

Revenue excludes value added tax or other sales taxes and is after deduction of any trade discounts.

Further details of the Group's revenue and other income recognition policies are as follows:

#### (i) Sale of goods

Revenue is recognised when the customer takes possession of and accepts the products. If the products are a partial fulfilment of a contract covering other goods and/or services, then the amount of revenue recognised is an appropriate proportion of the total transaction price under the contract, allocated between all the goods and services promised under the contract on a relative stand-alone selling price basis.

#### (ii) Service income

Service income from the rendering of services is recognised when the services are rendered.

#### (iii) Interest income

Interest income is recognised as it accrues under the effective interest method using the rate that exactly discounts estimated future cash receipts through the expected life of the financial asset to the gross carrying amount of the financial asset. For financial assets measured at amortised cost that are not credit-impaired, the effective interest rate is applied to the gross carrying amount of the asset. For credit-impaired financial assets, the effective interest rate is applied to the amortised cost (i.e. gross carrying amount net of loss allowance) of the asset (see Note 2(k)(i)).

Foreign currency transactions during the year are translated into the functional currency of the entity to which they relate at the foreign exchange rates ruling at the transaction dates. Monetary assets and liabilities denominated in foreign currencies are translated into the functional currency of the entity to which they relate at the foreign exchange rates ruling at the end of the reporting period. Exchange gains and losses are recognised in profit or loss.

Non-monetary assets and liabilities that are measured in terms of historical cost in a foreign currency are translated into the functional currency of the entity to which they relate using the foreign exchange rates ruling at the transaction dates. The transaction date is the date on which the entity initially recognises such non-monetary assets or liabilities.

The directors of the Company consider the above is the only business of the Group, and accordingly, no segment information is presented.

The Group has ceased the e-commerce business in 2018.
- (ii) An exclusive income right obtained in 2016 from the development of a tailor-made e-commerce platform for a property developer in order to earn revenue from this property developer by assisting its property sales through the platform. In view of the slower than expected progress of the property projects under development by the above property developer, the management of the Group considered such projects may not be developed as planned. The Group has written down the carrying amount of the intangible asset to its recoverable amount of RMBNil in 2017. Despite of the efforts spent over the years, the directors of the Company consider that there is no realistic prospect to recover all or part of the consideration paid to the above property developer.

## 13 GOODWILL

In 2015, the Group acquired the 51% equity interests in Century Network Holding Limited ("Century Network") for a consideration of RMB76,392,000. The excess of the cost of the purchase over the net fair value of the identifiable net assets acquired of RMB61,013,000 was recorded as goodwill and allocated to the Century Network's e-commerce business.

As mentioned in Note 12, in view of the slower than expected growth of the e-commerce business, the Group has written down the carrying amount of the goodwill to its recoverable amount of RMBNil in 2017. The Group has ceased the e-commerce business in 2018.

The difference between the redemption value and the carrying amount of these convertible bonds amounted to a gain of RMB314,000 had been recognised in profit or loss for the year ended 31 December 2020. In July 2020, 154,691,176 ordinary shares of the Company owned by Century Investment which were pledged for the above convertible bonds had been released.

In October 2020, the Company issued convertible bonds with face value of HK\$126,000,000 (equivalent to approximately RMB108,945,000) (“CB1”) to Century Investment. Exposure to credit, liquidity, interest rate and currency risks arises in the normal course of the Group's business.

The Group's exposure to these risks and the financial risk management policies and practices used by the Group to manage these risks are described below.

### (a) Credit risk

Credit risk refers to the risk that a counterparty will default on its contractual obligations resulting in a financial loss to the Group. The Group's credit risk is primarily attributable to trade and other receivables. The Group's exposure to credit risk arising from cash and cash equivalents is limited because the counterparties are banks and financial institutions with high credit standings, for which the Group considers to represent low credit risk.

The Group does not provide any guarantees which would expose the Group to credit risk.

#### **Trade and other receivables**

The Group has established a credit risk management policy under which individual credit evaluations are performed on all debtors requiring credit over a certain amount. These evaluations focus on the debtor's past history of making payments when due and current ability to pay, and take into account information specific to the debtor as well as pertaining to the economic environment in which the debtor operates. Trade receivables are generally due immediately from the date of billing. Normally, the Group does not obtain collateral from debtors.

The Group has no significant concentration of credit risk in industries in which the debtors operate. Significant concentrations of credit risk primarily arise when the Group has significant exposure to individual debtors. At the end of the reporting period, 46.9% (2020: 67.3%) and 99.8% (2020: 98.1%) of the total trade receivables was due from the Group's largest debtor and the five largest debtors, respectively.

In July 2020, the Group, via PCL, entered into an agreement with an independent third party, pursuant to which PCL will issue not less than 61,078,767 new ordinary shares but not more than 73,287,671 new ordinary shares at a total subscription consideration of not less than USD35,670,000 but not more than USD42,800,000 to this third party. Up to the date of issue of these financial statements, the capital injection mentioned above is still under negotiation and has yet to be completed.

### 31 IMPACTS OF COVID-19 PANDEMIC

The Covid-19 pandemic since early 2020 continues to bring uncertainties to the Group's operating environment and may impact the Group's operations and financial position.

Despite of the easing of the Covid-19 pandemic in Mainland China, the Group continues to closely monitor the possible impact from the Covid-19 pandemic has on the Group's business and keep contingency measures in place and under review in the case where the Covid-19 pandemic rebounds. These contingency measures included but not limited to reassessing changes (if any) to the customers' preferences on the types of goods or services and to align the Group's procurement strategies (where necessary) to meet the customers' needs, reassessing the adequacy and sustainability of the existing suppliers, expanding the Group's supplier base in a view to procure suitable goods and services to meet customers' preferences on a timely basis, and improving the Group's cash management by expediting debtor settlements and negotiating with suppliers on payment extensions.

The exact timing of the cessation of the Covid-19 pandemic is still uncertain. Nonetheless, the directors of the Company is optimistic that the Covid-19 pandemic will eventually be under full control.

### 32 IMMEDIATE AND ULTIMATE HOLDING COMPANY

The directors of the Company consider the immediate and ultimate holding company of the Company at 31 December 2021 to be Century Investment, which is incorporated in the British Virgin Islands. This entity does not produce financial statements available for public use.
