On 23 July 2021, South Shore Holdings Limited ("the Company") was ordered to be wound up. On 11 March 2022, Ms So Kit Yee Anita, Mr Chan King Wai Leonard of Ernst & Young Transactions Limited and Edward Alexander Niles Whittaker of R&H Services Limited were appointed as the Joint and Several Liquidators (the "JLs") of the Company pursuant to an Order of the Supreme Court of Bermuda. The JLs prepared this monthly return according to the books and records available to them. The affairs, business and property of the Company are being managed by the JLs who act as agents of the Company only and without personal liabilities.
