The board (the “**Board**”) of directors (the “**Directors**”) of Datang Group Holdings Limited (the “**Company**”) is pleased to announce that the contracted sales of the Company, its subsidiaries and associates (collectively, the “**Group**”) in April 2022 was approximately RMB1.85 billion; the sales area was approximately 190,900 square metres (“**sq.m.**”); the average selling price was approximately RMB9,680 per sq.m..

From January to April 2022, the Group achieved accumulated contracted sales of approximately RMB8.29 billion; accumulated sales area of approximately 831,100 sq.m.; with an average selling price of approximately RMB9,970 per sq.m..
