时间是万物的尺度,丈量着平凡到伟大的距离。2021 年是浓墨重彩的一年,这一年新冠疫情仍然笼罩全球,世界风云 波谲云诡,人类命运休戚与共,面对百年未有之大变局,ESG 投资更加成为全球的共识、通行的理念。在此背景下, 中国 ESG 投资迎来了蓬勃发展的新阶段。2021 年,国务院国资委首次将 ESG 纳入推动企业履行社会责任重点工作, 中国交建作为 ESG 理念的持续践行者,交出了一份精彩厚重的答卷。

Time is a yardstick for all, measuring the distance from the commonplace to the consummate. The year 2021 was a different year marked by the COVID-19 pandemic raging worldwide and sudden changes in the global landscape. Mankind who shares a common future is confronted with profound changes unseen in a century. ESG investment has even become the global consensus and a prevailing concept. In this context, China's ESG investment reaches a new stage of flourishing development. In 2021, the State-owned Assets Supervision and Administration Commission of the State Council included ESG as a key task for the fulfillment of corporate social responsibility for the first time. In 2021, we built on our responsibility and strength as a key enterprise and achieved results to the satisfaction of stakeholders. We scaled new heights in terms of the value of newly signed contracts, operating income, total profit, and net profit. We ranked 61st in the Fortune Global 500, achieved "16 straight As" in the business performance assessment conducted by the State-owned Assets Supervision and Administration Commission of the State Council, and was selected as one of the first ESG demonstration enterprises in China. Getting off to a good start for high-quality development during the 14th Five-Year Plan period, we strive to build a world-class enterprise with global competitiveness regarding "technology, management and quality".

这一年,我们积极汇聚改革创效合力,知重负重,不负市场所望。心怀"国之大者",全力推进"让 世界更畅通,让城市更官居,让生活更美好"的愿景变为实景。科学谋划战略蓝图,编制出台"十四五" 总体规划, "三核五商"新中交为未来发展指明了方向;推进改革提质走深走实,完成国企改革三 年目标任务 85% 以上,实现资本结构不断优化,运维质量有效提升;深入实施"三重两大两优" 经营策略,公路业务规模重返国内第一,机场建设业务稳居行业首位,江河湖海业务达历史新高, 发展态势稳中向好;立足服务国家战略全局,继续在京津冀、雄安新区、长三角、粤港澳等区域深 耕发力;厚植全球竞争优势,马来西亚东海岸铁路、柬埔寨金港高速、科伦坡港口城等项目取得丰 硕成果;坚持科技自立自强,主导制(修)订并发布ISO国际标准3项,获得国家科技进步二等 奖1项、技术发明二等奖1项,2个国家工程研究中心纳入国家科技创新基地新序列管理,首个跨 法人组织的财务大共享中心成功运行,"数智中交"迈上新台阶。

This year, we conducted reforms and improved operational efficiency in the face of overwhelming difficulties, and lived up to the expectations of the market. Taking the responsibility as a key enterprise, we went all out to make a reality the vision of "making the world more connected, making the city more livable, and making the life better". We scientifically mapped out the strategic blueprint, and formulated the overall plan for the 14th Five-Year Plan period, with the strategy of "three core areas and five fields" pointing out the way forward. We made substantial progress in reform, completed more than 85% of the three-year goals and tasks of state-owned enterprise reform, optimized the capital structure, and improved the quality of operation and maintenance. The business strategy of "three majors, two big and two priorities" was thoroughly implemented. We again ranked first in China in terms of highway business, led the industry in terms of the airport construction business, hit a record high in terms of the river, lake and marine business, and achieved a development trend of ensuring progress while maintaining stability. While keeping a foothold in serving the national strategic interests, we continued our development in the Beijing-Tianjin-Hebei region, Xiong'an New Area, Yangtze River Delta, Guangdong-Hong Kong-Macao Greater Bay Area, etc. Building on its global competitive edge, we achieved fruitful results in projects such as East Coast Rail Link (ECRL) in Malaysia, the Phnom Penh-Sihanoukville expressway in Cambodia, and Colombo Port City. We also adhered to self-reliance in science and technology, led the formulation, revision and publication of three pieces of ISO international standards, and won one second prize for National Science and Technology Progress, and one second prize for technological invention, with our two national engineering research centers having been placed under the new sequence management of the national science and technology innovation bases. The first financial sharing center across legal persons has been put into operation, and new progress was made in "digital and smart CCCC".

这一年,我们持续深挖永续发展潜力,各美其美,不负山水所寄。深入开展安全生产专项整治三年 行动、节能环保三年行动和"平安百年品质工程"建设,扎实打通安全生产"最后一公里"专项工作, 安全环保质量形势总体平稳。围绕"双碳"目标,积极融入海洋强国、美丽中国建设,绿色低碳行 动持续实施,海上风电产业链持续完善,水利环保业务迈上新台阶;全面投身蓝天、碧水、净土保 卫战,参与长江流域综合开发治理、黄河流域生态保护和高质量发展、永定河流域治理,以生态之 笔绘就经济社会发展的美好画卷。公司承建的援埃塞俄比亚河岸绿色发展项目荣获美国《工程新闻 纪录》全球环境类最佳项目奖,冬奥可持续集装箱产品被列入科技部 2021 年国家重点研发计划"科 技冬奥"重点专项,科技支撑、机制灵活、行业领先的全国一流生态治理商"名片"擦得更亮。

This year, we continued to tap the potential of sustainable development, and contributed to environmental protection. We took further steps for the three-year action for special rectification of safe production, the threeyear action for energy conservation and environmental protection, and the "Safe Quality Engineering in One Hundred Years". Decisive progress was made in the "last mile" of work safety, and overall safety and environmental

protection guality was ensured. Centering on the "dual carbon" goal, we were actively involved in building China into a maritime power and a beautiful China. Green and low-carbon campaigns were constantly implemented, the offshore wind power industrial chain continuously improved, and new progress made in water conservancy and environmental protection. In order to keep the skies blue, waters clear, and land pollution-free, we participated in the comprehensive development and governance of the Yangtze River Basin, the ecological protection and guality development of the Yellow River Basin, and the governance of the Yongding River Basin as its contribution to economic and social development. The green riverbank development project in Ethiopia undertaken by China Communications Construction was awarded the Best Global Project Award in the Environment Category by the U.S. Engineering News-Record. The Winter Olympics sustainable container products were included in the "technologically advanced Winter Olympics" key special project in the Ministry of Science and Technology's national key R&D program in 2021. We enhanced our reputation as a national industry-leading ecological management company with high technology and flexible mechanism.

2021年12月3日,中共中央总书记、国家主席习近平同老挝人民革命党中央总书记、国家主席通伦举行视频会晤并以 视频连线形式共同见证中老铁路通车。中国交建参建的中老铁路是习近平总书记批示的"一带一路"建设重点项目,是

In addition, we established agencies for performing the duties of external directors, and developed the management system for external directors. As a result, we achieved a continuous improvement of the legal person governance institutional system, strengthening of the building of boards of directors, and standardizing of the management of external directors of subsidiaries.

12月28日,中国交建首个全专业实施的轨道交通项目——佛山市地铁2号线一期工程正式开通初期运营。该工程是广 东省首批列入国家发改委 PPP 库的重点项目,首次提出 "BOT+EPC+TOD"建设模式,线路全长 32.4 公里。公司各参 建单位积极探索新技术,形成了一批优秀科研成果,并取得发明专利、实用型专利、QC、工法、课题等共计100余项, 将该工程打造成为安全、低碳、环保的一流品质工程。此外,佛山地铁 2 号线还积极探索 TOD 城市综合开发模式,通 过一二级联动开发,打造佛山市首个 TOD 项目(湖涌 TOD 项目)以及最大 TOD 项目(林岳 TOD 综合开发项目),并 建成了未来佛山7条地铁线的轨道中枢大脑——湾华地铁控制中心。一期工程的开通运营将极大改善佛山交通出行环境, 拓展城市发展空间,促进广佛全域同城化,助力佛山全方位融入粤港澳大湾区建设,并为共建共享"轨道上的大湾区" 注入新活力。

On December 28, Foshan Metro Line 2 Phase I Project, the first fully professional rail transit project implemented by China Communications Construction, officially opened its initial operation. This Project is one of the first batch of key projects listed in the PPP database of the National Development and Reform Commission in Guangdong Province, in which, the construction mode of "BOT+EPC+TOD" is proposed for the first time, and the total length of the Line is 32.4km. Our participating units actively explored new technologies to form a number of outstanding scientific research achievements, and more than 100 invention patents/utility patents/OC/construction methods/research subjects were obtained to create this Project into a first-class quality project of safety, low carbon and environmental protection. In addition, in Foshan Metro Line 2, we also actively explored TOD urban comprehensive development mode, and the primary and secondary linkage development was used to create the first TOD project (Huyong TOD project) and the largest TOD project (Linyue TOD comprehensive development project) in Foshan, and we built Wanhua Metro Control Center, which will be the rail central brain for seven future metro lines in Foshan. The opening and operation of this Phase I Project will greatly improve the transportation environment of Foshan, including expansion of the space for urban development, promotion of the urban integration of Foshan and Guangzhou, and full integration of Foshan into the construction of the Guangdong-Hong Kong-Macao Greater Bay Area, and it will inject new vitality into the joint construction and sharing of the "Greater Bay Area on the Rail".

We insist on improving the customer service system from the three aspects: customer relationship management, customer requirements determination and customer satisfaction management, and regularly conduct customer satisfaction surveys to understand customers' opinions & suggestions and improve customer experience. For example, the CCCC Dredging (Group) Company Limited established a multi-dimensional customer service network covering headquarters, regional centers and subsidiaries. Another example, the CCCC Fourth Harbor Consultants Co., Ltd. prepared the customer satisfaction monitoring and evaluation management regulations, and the scores and satisfaction rate of satisfaction surveys were included in the quality objectives to assess strictly. Among the 785 satisfaction surveys sent out in 2021, the recovery rate was 84.3%, and the satisfaction rate was 98.6%, so their services were highly recognized by customers.

We fully protect customer privacy information by establishing a strict information protection system. In the Market Operation and Management Measures and the Government Affairs and Big Customer Commercial Docking Management Measures, we explicitly proposed that, during the management of customer relationships, we should enhance our consciousness of rule of law and confidential consciousness, including strict custody of customer information & privacy information and strict maintenance of customer business secret, and we should not disclose such information to a third party in violation of laws & regulations and corporate provisions. In 2021, our network security capability has been further improved, and our management of confidentiality and network information security ranks top among central SOEs. For example, the CCCC Fourth Harbor Engineering Company Ltd. formulated the *Confidentiality Management Regulations*, and signed the confidentiality responsibility letter with the employees according to levels to implement the confidentiality responsibility to the specific employee. Another example, the CCCC Second Highway Engineering Co., Ltd. established a customer information database, and they adhered to the principle of level-to-level storage and level-to-level access to determine the storage period according to the storage value. The Road and Bridge International Co., Ltd. formulated the Network Security Management Measures, and they applied firewall, intrusion detection defense, VPN access and other technical measures to strengthen data resources and access protection.

For example, the CCCC First Harbor Consultants Co., Ltd. established the customer complaint control procedure, in which, when the complaint is received by the Production and Operation Department, they will dispose of such complaint jointly with relevant departments, next, the safety and quality supervision department will check the execution results, and finally the human resources department will give disposal suggestions for the complainant, forming a complete closed-loop complaint resolution mechanism. For example, we issued the Implementation Plan for Advancing the "Last Mile" of Work Safety (Phase I) to deeply check and govern the potential safety hazards, and soundly promote the rectification of problems to ensure work safety. In 2021, the Company's headquarters invested RMB 59.49 million of special fund for work safety, and no major or above production safety accidents occurred, while the mortality rate for an output value of RMB 10 billion remained at the historical low of 0.2.

We constantly improve the emergency management system construction, optimize the emergency management workflow, and increase the emergency response capacity to make every effort to prevent and control major safety risks. For example, a "Big Safety and Big Emergency" system of "Work Safety + Emergency Management" has been established with great efforts, and an Emergency Command and Dispatch Center has been set up to promote the emergency management platform construction, so that emergency information could be reported directly, and emergency response capability has been improved. In 2021, four company-level emergency drills were carried out, and more than 100 items were incorporated into the engineering rescue preset force of the Ministry of Emergency Management. In 2021, one object strike accident occurred during earthwork excavation at second floor basement of a station in our project. After the occurrence, the Project Office promptly launched the emergency response plan to organize the on-site rescue and subsequent disposal. We further strengthened the safety warning education, and determined to build a safe production line to avoid similar accidents from happening again.

China Communications Construction has held annual supplier meeting, supplier open training courses and supplier on-site evaluation to deliver supply chain management philosophy and development direction to suppliers, and strengthened the training on supplier access and performance evaluation standards. Meanwhile, we have also actively conducted management and technical experience exchanges. In 2021, the Chinese Construction Industry Supply Chain Management Knowledge System, which was prepared by the research group led by CCCC and jointly composed of seven construction central state-owned enterprises, was officially released. In 2021, our energy conservation and environmental protection situation was generally stable, and there was no above general emergency environmental event.

Moreover, according to the "Institutional Construction Year" plan, we issued five regulations (including the Evaluation Measures for Ecological Environment Protection Management, the Measures for Ecological Environment Protection Leading Group, the Assessment Measures for Ecological Environment Protection, the Regulations on Headquarters Ecological Environment Protection Responsibility System, and the Regulations on Ecological Environmental Protection Responsibility Investigation) to further clarify the regulatory responsibilities. In addition, we conducted spot checks on the ecological environment protection work of all units regularly or irregularly, at least twice a year.

We strictly enforce the Environmental Protection Law of the People's Republic of China, the Interim Measures for the Supervision and Administration of Energy Conservation and Emissions Reduction of Central SOEs and other laws and regulations related to air pollution, and optimization & adjustment of technology, technical transformation & upgrading, promotion of energy conservation & environmental protection products, application of solar energy/natural gas and other clean energy are utilized by the Company to reduce waste generation and emissions. For example, in the Toll Plaza in Tuen Mun, Hong Kong, which is constructed by the China Road and Bridge Corporation, ultra-low sulphur diesel technology was applied in all machinery and generators to reduce emissions of sulphur dioxide and other gases.

We strictly regulate the environmental impact assessment of the construction projects and the construction of environmental protection facilities, and strictly implement the pollutant discharge permit standard, so our on-site sewage is discharged according to the requirements of the national standard Integrated Wastewater Discharge Standard (GB8978-1996). For example, during the construction of the North-South Expressway project in Montenegro, the wastewater discharge standards were strictly implemented. Subject to a series of control and treatments, such as sedimentation tank system, pH value regulation system and oil-water separator system, the wastewater was then discharged after meeting the standards.

Moreover, based on the principle of "source reduction, classified management, on-site disposal and emission control", we conducted the standardized treatment for various harmless wastes generated from production and life to reduce the impact on the environment. Furthermore, we actively responded to the national and local call on "Garbage Classification" and comprehensively promoted the work as follows: (i) we conducted classified storage for the household waste; (ii) we entrusted the qualified entities to receive the garbage of construction vessels so as to avoid the marine pollution; (iii) we stored the construction waste in a centralized and classified manner to implement the harmless disposal or resource utilization; (iv) we encouraged the on-site disposal of

metal waste as a construction material or tool; (v) we improved the hazardous waste category list and identification plate, and entrusted the

In 2021, our comprehensive energy consumption was 1.4982 million tons of standard coal, a slight increase from the previous year.

We strictly require each construction project to apply for a water-drawing permit according to law and pay water resource fees to obtain the water-drawing right. In the selection of water-drawing points, we avoid ecological protection areas, water protection areas and other sensitive areas; moreover, we vigorously promote water-saving technologies such as box girder water-saving health preservation to improve construction and maintenance technology, and we utilize the well point precipitation collection water resources recycling technology and the automatic spraying health preservation system to reduce water consumption; in addition, we strictly implement water resource management measures, such as separating sewage from clear water/rainwater, and recycling production of wastewater and living sewage respectively, so as to increase the utilization rate of water resources.

During the past 10 years, we have consecutively launched 143 green demonstration projects, such as "replacing coal with gas", "replacing oil with gas", distributed wind-light complementary power generation, shore power for berthing vessels, and prefabricated buildings, in which, we have eliminated about 10,000 sets of old equipment, and more than 1,000 energy conservation and environmental protection technological transformation projects have been completed.

For example, the "Green Lecture" environmental education and special training events have been held via the online training platform of "CCCC Online School", and ten "Green Lecture" training sessions have been carried out with nearly 10,000 trainees.

We actively respond to the initiative of protecting biodiversity and building a community of life, and positively participate in biodiversity protection in the place where our project is located. In South Asia, we launched the Beautiful Beaches Initiative in the Sri Lanka Colombo

Port City project. In Europe, we simultaneously launched the Tara River treatment engineering together with the North-South Expressway project in Montenegro, and regularly monitored the biodiversity of Tara River. In Africa, in the Mombasa-Nairobi Railway project, we collaborated with Kenyan professional animal organizations to arrange 14 large animal passages, 600 culverts and 61 bridges for animals to cross. In the Tema Port project in Ghana, we created a sea turtle breeding center in a dedicated area on the beach. In a word, we combine our production activities with the natural ecological environment to sketch out a beautiful picture of harmonious coexistence between man and nature.

The temporary construction channel of the Hainan Refining and Chemical project by the CCCC Fourth Harbor Consultants Co., Ltd. is adjacent to more than 200 mu of mangrove, which has the reputation of "coastal guard" and "green lung of the ocean", and the mudflat

next to the mangrove is dotted with mangrove seedlings. This mudflat was originally the first choice for the temporary construction channel of the project, as it has a short distance and it is at a low cost to run straight through it, but this will affect the growth of mangrove seedlings. In order to maximize the protection of the mangrove seedlings, which were not originally within the protection scope, the CCCC Fourth Harbor Consultants Co., Ltd. made a 120m detour through optimized design, which increased the cost and construction period, but protected the "kindergarten" for mangroves.

8月30日,陕西省凤县在建316国道酒奠梁段改建工程酒奠梁隧道发生坍塌事故,导致10名施工人员被困,情况十 分紧急。接到国家安全生产应急救援中心出警指令后,中交重庆救援队科学安排,快速行动。30分钟内先导队人员出发, 3个小时重装出动,携带120余台套设备跨越700余公里,7小时到达事故现场,20个小时钻通逃生通道,成功营救 被困人员。每一个时间节点和救援数据都体现一支国家专业队的实力与素养,展示了中国交建大国央企的责任与担当, 获得了陕西省应急厅的高度评价。

On August 30, 2021, the Jiudianliang Tunnel in the Jiudianliang Section reconstruction project of No. 316 National Highway under construction in Feng County, Shaanxi Province collapsed, and 10 workers were trapped, which is an emergency. After receiving the instructions from the National Work Safety Emergency Rescue Center, CCCC Chongqing Rescue Team made scientific arrangements and acted quickly. Their pilot team set out within 30 minutes, and the principal team departed in three hours. They carried more than 120 sets of equipment and traveled more than 700 km for seven hours, later they arrived at the accident scene. They spent 20 hours drilling through an escape channel and successfully rescued the trapped workers. Every time node and rescue data reflect the strength and quality of a national professional team, demonstrating the responsibility and assumption of China Communications Construction as a central stateowned enterprise in China, and they were highly appraised by the Department of Emergency Management of Shaanxi Province.
