POLL RESULTS OF ANNUAL GENERAL MEETING

References are made to the notice of annual general meeting (the “**Notice**”) of Yihai International Holding Ltd. (the “**Company**”) dated 20 April 2022 and the announcement dated 6 May 2022, respectively. The annual general meeting (the “**AGM**”) of the Company was held at Regency 2, Hyatt Regency Shenzhen Airport, Bao’an District, Shenzhen, PRC on Friday, 20 May 2022 at 2:00 p.m.

Unless otherwise defined, capitalised terms used in this announcement shall have the same meanings as defined in the circular of the Company dated 20 April 2022 (the “**Circular**”).

The AGM was conducted by way of voting by poll. As at the date of convening the AGM, the issued Shares and the total number of Shares entitling the holders to attend the AGM and vote on any resolutions proposed at the AGM was 1,046,900,000 Shares. Shareholders or their proxies who represent a total of 787,599,995 voting Shares of the Company, representing approximately 75.23% of the total issued Shares of the Company as at the date of the AGM, attended the AGM. Computershare Hong Kong Investor Services Limited, the Hong Kong share registrar of the Company, was appointed by the Company as the scrutineer of the AGM.

To the best knowledge, information and belief of the Board after having made all reasonable enquiries, there were no restrictions on any Shareholders to cast votes on any of the resolutions at the AGM, none of the Shareholders has any material interest in the matters considered at the AGM and is required to abstain from voting at the AGM. There were no Shares of the Company entitling the holders to attend the AGM but abstain from voting in favour as set out in Rule 13.40 of the Listing Rules. None of the Shareholders is required to abstain from voting on resolutions proposed at the AGM in accordance with the Listing Rules. None of the Shareholders have stated their intention in the circular to vote against or to abstain from voting on any of the resolutions proposed at the AGM. All directors of the Company attended the AGM in person or by means of electronic communication.

At the AGM, the following resolutions were considered and approved by way of poll by the Shareholders and their proxies, and the poll results are as follows:
