VOLUNTARY ANNOUNCEMENT BUSINESS UPDATE

The Group's Chief Executive Officer and Executive Director visited Sanya to strengthen the Group's local vocational education and training programs

This announcement is made by Fullwealth International Group Holdings Limited (the “**Company**”, together with its subsidiaries, the “**Group**”) on a voluntary basis to inform its shareholders and potential investors of the latest information about the Group.

The Group has been actively exploring and developing new business opportunities for our entertainment education business as the board (the “**Board**”) of directors (the “**Directors**”) of the Company believes it may create new growth opportunities for the Group. The Board has noted the rising demand for vocational education and training programs in the PRC and the Group has been closely monitoring the PRC vocational education market and has been engaging in discussions with the local enterprises to seek for cooperation opportunities for developing the Group’s local vocational education business.

On 24 May 2022, Ms. Liu Xinyi (“**Ms. Liu**”), the Chief Executive Officer and an executive Director of the Group, was invited to attend the Second Session and Ninth Chairman Meeting of the Young Entrepreneurs Committee of Sanya Federation of Industry and Commerce* (三亞市工商聯). Ms. Li Meiguang, the fourth-level research director of Sanya Federation of Industry and Commerce, personally came to this meeting to offer guidance. On 25 May 2022, Ms. Liu was also invited to attend the Second Meeting of the Eighth Executive Committee of Sanya City Federation of Industry and Commerce. About 150 people attended the meeting, including leaders of

the United Front Work Department of the Sanya Municipal Party Committee* (三亞市委統戰部), the Eighth Executive Committee of Sanya Federation of Industry and Commerce, the heads of the Chambers of Commerce affiliated with Sanya Federation of Industry and Commerce, and the party branch secretaries of non-public economic organizations. Ms. Liu was the first speaker as the “Outstanding Enterprise Representative” of the Federation of Industry and Commerce. The Group also received praise from the leaders at all levels of the United Front Work Department of the Sanya Municipal Party Committee for its contribution in the “0331” epidemic prevention and control battle in Sanya. Mr. Pan Guohua, a member of the Standing Committee of the Sanya Municipal Party Committee* (三亞市委常委), Minister of the United Front Work Department, and Secretary of the Party Committee of the Sanya Municipal Health Commission* (三亞市衛健委黨委), personally presented an honorary certificate to the Group.
