UNAUDITED OPERATING FIGURES FOR APRIL 2022

The board of directors (the “**Board**”) of Sanxun Holdings Group Limited (the “**Company**”) wishes to provide the shareholders of the Company and potential investors with a sales update containing certain operating data of the Group for the four months ended 30 April 2022. For the four months ended 30 April 2022, the aggregate contracted sales of the Company, its subsidiaries and associated companies (the “**Group**”) was approximately RMB979 million, the aggregate contracted gross floor area was 120,164 sq.m. and the average selling price was approximately RMB8,150.3 per sq.m..

The above-mentioned operating figures are unaudited and are based on preliminary internal information of the Group, which may differ from the figures to be disclosed in the audited or unaudited consolidated financial statements to be published by the Group on an annual or half-yearly basis due to various uncertainties during the process of collecting such information.
