**As more than 50% of the votes were cast in favour of each of the resolutions numbered 1 to 5, such resolutions were duly passed as ordinary resolutions by the shareholders of the Company (the “Shareholders”) at the AGM.**

**As more than 75% of the votes were cast in favour of the resolution numbered 6, such resolution was duly passed as special resolution by the Shareholders at the AGM.**

As at the date of the AGM, the total number of issued shares of the Company was 1,003,596,000 shares, which was the total number of shares of the Company entitling the holders to attend and vote for or against on all the proposed resolutions at the AGM. There were no shares of the Company entitling the holders to attend and abstain from voting in favour of any proposed resolutions at the AGM as set out in Rule 13.40 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “**Listing Rules**”). No shareholders were required under the Listing Rules to abstain from voting on the proposed resolutions at the AGM. There was no restriction on any Shareholders to cast votes on any of the proposed resolutions at the AGM. None of the Shareholders have stated their intention in the circular of the Company dated 29 April 2022 that they would vote against any resolution or abstain from voting at the AGM.

The Company's Hong Kong branch share registrar and transfer office in Hong Kong, Tricor Investor Services Limited, was appointed as the scrutineer for vote-taking at the AGM.

All directors of the Company attended the AGM.
