VOLUNTARY ANNOUNCEMENT SUBSTANTIAL INCREASE IN ENROLLMENT QUOTAS FOR 2022/2023 SCHOOL YEAR

This announcement is made by Hope Education Group Co., Ltd. (the “**Company**”) on a voluntary basis.

The board of directors of the Company (the “**Board**”) is pleased to present a substantial increase in the enrollment quotas of the “junior college-undergraduate” programs operated by the undergraduate institutions of the Company for 2022/2023 school year:

Enrollment quotas of the “junior college-undergraduate” programs	3,810	9,827	158%

The Board believes that the substantial increase in enrollment quotas of the “junior college-undergraduate” programs was mainly attributable to the following reasons:

- 1) Implementation of the work arrangements on “keeping jobs and protecting people’s livelihoods” as required by the central government by providing more quotas of quality higher education;
- 2) We continue to carry out the strategy of “quality-first” through quality enhancement and excellence, and higher social recognition of our quality of school operation was obtained;
- 3) Retrofitting, upgrading and expansion of the campus had been accelerated so as to provide more room through the expansion of campus.

The Company had been receiving approvals of the enrollment quotas of its regular undergraduate and junior colleges, which are expected to record a substantial increase in the future. The Company will provide update of the relevant developments in due course.

The Board wishes to remind shareholders of the Company and prospective investors that the above figures are approximate numbers based on the Group's internal statistics currently available. Differences may arise between such figures and the disclosure in subsequent results announcements, financial reports and/or other relevant corporate materials. Shareholders of the Company and prospective investors are cautioned not to unduly rely on such figures and are advised to exercise caution when dealing in the shares of the Company.
