VOLUNTARY ANNOUNCEMENT BUSINESS UPDATE

The Group's Chief Executive Officer and Executive Director visited Zhuzhou City of Hunan Province to strengthen the Group's local vocational education and training programs

This announcement is made by Fullwealth International Group Holdings Limited (the “**Company**”, together with its subsidiaries, the “**Group**”) on a voluntary basis to inform its shareholders and potential investors of the latest information about the Group.

The Group has been actively exploring and developing new business opportunities for our entertainment education business as the board (the “**Board**”) of directors (the “**Directors**”) of the Company believes it may create new growth opportunities for the Group. The Board has been closely monitoring the PRC vocational education market and has been engaging in discussions with the local government and local enterprises of Zhuzhou City to seek for cooperation opportunities for developing the Group’s local vocational education business.

On 07 June 2022, Ms. Liu Xinyi (“**Ms. Liu**”), the Chief Executive Officer and an executive Director of the Group, led a team to visit Zhuzhou city to conduct field research on the “Fullwealth International Arts and Culture Education Research Tour* (富匯國際藝術教育研學之旅)”.

In the afternoon of the same day, Jiang Xianghui, Deputy Mayor of Zhuzhou City and relevant leaders warmly

received Ms. Liu and her entourage, and held a symposium in the conference room on the 3rd floor of the municipal government. The participating leaders included Jiang Xianghui, Deputy Mayor of Zhuzhou City; Yu Huajun, Deputy Secretary-General of Zhuzhou Municipal Government; Yang Xilan, Secretary of the Party Group*(黨組) and Director of Zhuzhou Municipal Bureau of Culture, Tourism, Broadcasting and Sports* (株洲市文旅廣體局); Peng Xiyu, member of the Party Group and Deputy Director of Zhuzhou Municipal Bureau of Culture, Tourism, Broadcasting and Sports; Li Xun, member of the Party Group and Deputy Director of the Zhuzhou Municipal Bureau of Commerce* (株洲市商務局); Ma Xiaodong, Director of the Zhuzhou Cultural Property Office* (株洲市文產辦); Luo Chao, President of Zhuzhou Travel Agency Industry Association* (株洲市旅行社行業協會), and representative of the People's Congress of Tianyuan District, Zhuzhou City, etc.

Ms. Liu said: "Zhuzhou is an industrial city... Initially, landed the arts and culture education research segment and the film and television segment in Zhuzhou, and then both sides can reach in-depth cooperation in other industrial projects."

They hoped that both sides would give full play to their respective advantages and join forces strongly to strengthen the cultural and tourism industry, build and play the local cultural and tourism brands, highlight the local characteristics and highlights and to truly realize the high-quality development of Zhuzhou's cultural and tourism industry.

Ms. Liu and her entourage also inspected the capital of power --- Zhuzhou China Power Valley* (株洲中國動力谷), the national mega-class enterprise --- CRRC Zhuzhou Locomotive Co., Ltd.* (中車株洲電力機車有限公司), Zhuzhou Wooden Work Culture Exhibition Base, and Liling Porcelain Valley* (醴陵瓷谷), an intangible cultural heritage, Youxian Jiubu River Scenic Area* (攸縣酒埠江景區) and other places.
