Reference is made to (i) the announcement of Cogobuy Group (the “**Company**”) dated April 28, 2022 (the “**Announcement**”) regarding the proposed Change of Company Name and the proposed adoption of the New Memorandum and Articles of Association; (ii) the notice and the circular of the Company both dated April 28, 2022 (the “**Circular**”) regarding the holding of an annual general meeting of the Company (the “**AGM**”); and (iii) the announcement of the Company dated June 10, 2022 in relation to the poll results of the AGM (the “**Poll Results**”). Unless otherwise defined or the context otherwise requires, capitalized terms in this announcement shall have the same meanings as defined in the Announcement and the Circular.

CHANGE OF COMPANY NAME AND COMPANY WEBSITE

The board (the “**Board**”) of directors (the “**Directors**”) of the Company is pleased to announce that the English name of the Company has been changed from “Cogobuy Group” to “Ingdan, Inc.” and the Chinese name of “硬蛋創新” has been adopted as the dual foreign name of the Company in place of its existing Chinese name of “科通芯城集團” with effect from June 10, 2022. Subsequent to the passing of the special resolution regarding the Change of Company Name at the AGM held on June 10, 2022, the Certificate of Incorporation on Change of Name was issued by the Registrar of Companies in the Cayman Islands on June 10, 2022 certifying the change of English name and the dual foreign name of the Company.

In addition, the Board of the Company hereby announces that the website of the Company will be changed from “www.cogobuygroup.com” to “www.ingdangroup.com” with effect from June 16, 2022 to reflect the Change of Company name.

ADOPTION OF NEW MEMORANDUM AND ARTICLES OF ASSOCIATION

Furthermore, as set out in the Poll Results, the proposed adoption of the New Memorandum and Articles of Association will also take effect upon the Change of Company Name becoming effective.
