METASENS is a large-scale universe park with various theme planets. "METASNAKE", being the first game on METASENS, has been officially launched. Its NFT ancestral equipment recorded exceptionally high subscription volume, and an additional 2,000 NFTs will be launched in four rounds. The NFTs will be priced in BNB. In the first stage, all of the 500 NFTs have been sold, equivalent to about HK\$1,495,000. "METASNAKE" is an online battle arena game based on the classic game "Snake", where NFTs can be equipped to enhance in-game characters or traded on the official NFT marketplace for profit.
