The change is mainly attributable to net investment loss (2021: net investment gain) on financial investments for the year, comprising net unrealised losses resulting from drop in market prices (2021: net unrealised gain) and additional provision of expected credit loss, partially offset by the net fair value gain (2021: net fair value loss) recorded on the investment properties.
