The Board is pleased to announce that at the annual general meeting of the Company held on 22 June 2022 (the “**AGM**”), all proposed resolutions as set out in the Notice were duly approved and passed by Shareholders by way of poll.

No Shareholder was required under the Listing Rules to abstain from voting on any of the proposed resolutions at the AGM and there was no Shareholder who was entitled to attend the AGM but was required to abstain from voting in favour at the AGM as set out in Rule 13.40 of the Listing Rules. No Shareholder has stated his/her/its intention in the Circular to vote against or to abstain from voting on any of the proposed resolutions at the AGM.
