**POLL RESULTS OF THE ANNUAL GENERAL MEETING  
HELD ON 29 JUNE 2022**

The Board is pleased to announce that all resolutions proposed at the AGM held on 29 June 2022 were duly passed by the Shareholders by way of poll at the AGM.

The board (the “**Board**”) of directors (the “**Directors**”) of Golden Solar New Energy Technology Holdings Limited (the “**Company**”) is pleased to announce that all the resolutions as set out in the notice (the “**Notice**”) of the annual general meeting (the “**AGM**”) of the Company dated 29 April 2022 were duly passed by the shareholders of the Company (“**Shareholders**”) by way of poll at the AGM of the Company held on 29 June 2022.

As at the date of the AGM, the total number of issued shares of the Company (“**Shares**”) was 1,711,959,608. None of the shareholders were required to abstain from voting at the AGM under the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “**Listing Rules**”). In addition, there were no Shares entitling the holders to attend and abstain from voting in favour of any resolution at the AGM as set out in Rule 13.40 of the Listing Rules. None of the Shareholders have stated their intention in the Company’s circulars dated 29 April 2022 to vote against or to abstain from voting on any of the resolutions at the AGM. Accordingly, there were a total of 1,711,959,608 Shares, being all the Shares which were issued and outstanding, entitling the Shareholders to attend and vote for or against the resolutions proposed at the AGM.

Tricor Investor Services Limited, the share registrar of the Company in Hong Kong, was appointed as the scrutineer at the AGM for the purpose of the vote-taking.
