CHAIRPERSON'S STATEMENT 主席報告

On behalf of the board ("Board") of directors ("Directors") of Winson Holdings Hong Kong Limited (the "Company" or "Winson"), I am pleased to present the annual results of the Company and its subsidiaries (collectively referred to as the "Group" or "Winson Group") for the year ended 31 March 2022 ("FY2022").

The prolonged outbreak of the novel coronavirus disease ("COVID-19") since early 2020 and persisted through the whole of the FY2022 further ravaged business environment and lifestyle of the whole society. Despite some businesses have shortened opening hours or adopted remote working arrangement, which has temporarily reduced the need for hygiene services, Winson Group's hygiene services team remained committed to deliver its works to full extent where required and offer additional services to enhance hygiene standard for disease prevention and control, such as cleaning and sanitising at more frequent intervals, mist disinfection of business premises and enclosed public area, etc. throughout the FY2022 and during the pandemic outbreak. Thanks for the dedication of our management and service delivery team, the Group is able to maintain a relatively steady operating performance for FY2022 amidst the highly uncertain and unstable business environment.

Given the current harsh and rapidly changing operating environment and economic conditions, the Group has been taking a combination of strategic steps to strengthen organic growth and to explore opportunities for horizontal development.

The Group registered itself as a supplier to a public health service operator during the FY2022 and subsequently in April 2022 secured a contract for provision of waste management service to a key district hospital, which is a testimony for the standard of service that the Group is able to achieve and the service quality of the Winson brand. The Group will focus on advancing further in this new customer sector and bid for contracts for different types of hygiene related services with unwavering effort. The Group will target for public hygiene projects available in the governmental and other public service sector, such as Food and Environmental Hygiene Department, rail and other public transport operators etc. and enrich its range of service offerings, such as recycling of kitchen waste, eco-friendly hygiene services, technology-enhanced hygiene solution services and other premium environmental related services.

本人代表永順控股香港有限公司(「本公司」或「永順」)董事(「董事」)會(「董事會」)欣然提呈本公司及其附屬公司(統稱「本集團」或「永順集團」)截至2022年3月31日止年度(「2022財年」)之年度業績。

新型冠狀病毒病(「COVID-19」)自2020年初起持續爆發，於整個2022財年一直肆虐，進一步損害營商環境及社會整體的生活方式。儘管部分企業已縮短營業時間或採納遙距工作安排，暫時減少對衛生服務的需求，永順集團的衛生服務團隊依然承諾竭盡全力，於有需要時提供額外服務，為提升衛生標準，控制及預防疾病出一分力。譬如，於整個2022財年及疫情爆發期間，我們更頻繁清潔及消毒、於商業場所及公共密閉空間進行霧化消毒等。有賴管理及服務交付團隊獻身服務，本集團得以在充滿不明朗因素的不穩經濟環境下，於2022財年維持相對穩定的經營表現。

鑑於目前艱鉅及瞬息萬變的營商環境及經濟狀況，本集團一直採取一系列的戰略措施，藉以鞏固內在增長及尋求橫向發展的機會。

本集團已於2022財年登記成為公共衛生服務運營商旗下的供應商，其後於2022年4月獲得向一間主要地區醫院提供廢物處理服務的合約，證明本集團能夠達致的服務標準及永順品牌的優質服務。本集團將專注進一步拓展此新客戶界別，努力不懈爭取不同類型的衛生相關服務的合約。本集團將以政府及其他公共服務界別(例如食物環境衛生署、鐵路及其他公開交通營辦商等)的公共衛生項目為目標，並豐富其服務範圍，例如回收廚餘、環保衛生服務、技術提升衛生解決方案服務及其他優質環境相關服務。

CHAIRPERSON'S STATEMENT

Simultaneously, the Group has been exploring horizontal business development opportunities, including the possible expansion in geographic coverage and in property related synergised services. To facilitate horizontal business development plan, the Group entered into a strategic cooperation framework agreement with Lask JV Facility Management Services Limited ("Lask") to make use of each other's business network and operational expertise to identify potential business opportunities in the Guangdong-Hong Kong-Macao Greater Bay Area (the "Greater Bay Area"). Lask and its subsidiaries ("Lask Group") are principally engage in facility management services for residential, commercial and office premises, security services and horticulture services in the People's Republic of China, which highly synergise with the Group's operations in servicing the environmental hygiene needs of property owners and business operators.

The prolonged COVID-19 outbreak and its severe impacts have strongly reinforced the importance of public and personal hygiene and it is expected there will be an increase in both government spending on general environmental cleanliness and waste management (such as the municipal solid waste charging scheme and various waste reduction and recycling initiatives) and demand from private sector, including property owners and business operators. In addition, long term development plan announced by the government, including the Northern Metropolis and Lantau Tomorrow, intended to boost up supply of housing and commercial properties which will provide ample expansion opportunity for the environmental hygiene market in general. Furthermore, with the Group's established and recurring business relationship with our railway operator customer, we are in an advantageous position to tender for business opportunities associated with the various railway network extension projects. Looking further geographically, the potential strategic cooperation between the Group and Lask Group will enable us to tap into such vast market and the Group is ready to explore opportunities in technologically advanced hygiene and waste management services and other synergised property related services once travel restrictions in Hong Kong and vicinity area are relaxed. The long term outlook of the Group and the market in which we operate remains positive.

與此同時，本集團一直積極尋求展開橫向業務發展的機會，包括可能擴寬市場的地域覆蓋範圍及物業相關協同服務。為促進橫向業務發展計劃，本集團與歷思聯行設施管理服務有限公司（「歷思」）訂立戰略合作框架協議，利用彼此的業務網絡及營運專長，在粵港澳大灣區（「大灣區」）物色潛在商機。歷思及其附屬公司（「歷思集團」）主要從事在中華人民共和國提供住宅、商業及辦公室處所的設施管理服務、保安服務及園林綠化服務，與本集團就業主及商業營運商的环境衛生需求提供服務的業務有高度協同效應。

COVID-19疫情持續及其嚴重影響著實加強了公共及個人衛生的重要性，預期政府在整體環境清潔及廢物管理方面的開支（例如都市固體廢物收費計劃及多項減廢及回收措施）及私人界別（包括業主及商業營運商）的需求將雙雙增加。此外，政府所宣佈長遠發展計劃（包括北部都會區及明日大嶼）預期將增加房屋及商用物業供應，為整體環境衛生市場提供充分擴展機會。此外，憑藉本集團與鐵路營辦商客戶成熟的經常性業務關係，我們處於有利地位，可競投與多個鐵路網絡延伸項目有關的商機。放眼更遠地域，本集團與歷思集團的潛在戰略合作令我們得以進軍有關宏大市場，而本集團已作好準備，在香港及周邊地區的旅遊限制放寬時探索有關先進技術衛生及廢物管理服務及其他物業相關協同服務的機遇。本集團及我們經營所在市場的長遠前景仍然樂觀。

BUSINESS REVIEW

There had been a general increase in demand for hygiene services from customers for disease prevention and control, such as more frequent cleaning, sanitising, mist disinfections etc. since the COVID-19 outbreak, which partly counteracted the impact of remote working arrangement and shortening opening hours of commercial and dining venues which reduced the demand for cleaning and waste management services. Moreover, the Group noticed that existing and potential customers have become prudent and more price-conscious with their procurement due to the adverse impacts of the pandemic and the accompanied economic uncertainties. In response, the Group exacerbated its business development effort and submitted bids for over 350 potential new contracts during the FY2022 and the number and value of new contracts secured by the Group increased to 22 and HK\$38.1 million respectively, as compared to 15 and HK\$27.6 million for the year ended 31 March 2021 (the “Previous Year” or “FY2021”); new projects contracted during the FY2022 included a prominent 5-star hotel, a notable new shopping mall and a number of branches of an international bank. On the other hand, relatively few number of service contracts were due for renewal during the FY2022 and as a result, despite the contract renewal rate increased to 74.2% for the FY2022 from 71.4% for the Previous Year, the value of contracts renewed dropped to HK\$210.8 million as compared to HK\$773.6 million for the Previous Year; it is expected the value of contract renewal will rebound in the next year when higher proportion of service contracts become due for renewal. Overall, the Group’s value of outstanding contract works as at 31 March 2022 declined by approximately 20% from HK\$655.5 million to HK\$522.5 million.

The Group’s airline catering support services business has been temporarily suspended since March 2020 and remained so until present as a result of the COVID-19 outbreak and travel restrictions which reduced passenger traffic to negligible level. Accordingly, no revenue was recorded from this business segment for both FY2022 and the Previous Year.

業務回顧

自COVID-19疫情爆發以來，為防控疾病，客戶對進行更頻密清潔、消毒、霧化消毒等衛生服務的需求普遍增加，而此部分抵銷了遠程工作安排及商業及餐飲場所縮短營業時間令清潔服務及廢物管理需求下降所帶來的影響。此外，本集團得悉，由於疫情及隨之帶來的經濟不明朗因素之負面影響，現有及潛在客戶於採購時變得更為審慎，亦更為重視價格。有見及此，本集團於2022財年加大業務開發力道，對超過350份潛在新合約投標，本集團獲得的新合約數目及價值分別增加至22份及38.1百萬港元，而截至2021年3月31日止年度（「上一年度」或「2021財年」）則獲得15份合約，價值為27.6百萬港元。於2022財年簽訂的新合約項目包括一家知名五星級酒店、一個備受注目的全新購物中心以及一間國際銀行的若干分行。另一方面，於2022財年到期續約的服務合約數量相對較少。因此，雖然2022財年的合約續約率由上一年的71.4%增加至74.2%，但續約的合約價值下降至210.8百萬港元，而上一年度則為773.6百萬港元。預計到下一年度有較高比例的服務合約到期需要續約時，續約合約的價值將會回升。總體而言，本集團於2022年3月31日的未完成合約工程價值下降約20%，由655.5百萬港元下降至522.5百萬港元。

由於COVID-19疫情及實施旅遊限制令遊客人數跌至微不足道的水平，本集團的航空餐飲支援服務業務自2020年3月起直至現時為止一直暫時停擺。因此，2022財年及上一年度均無自此業務分部錄得收益。

MANAGEMENT DISCUSSION AND ANALYSIS 管理層討論及分析

For reasons stated above, the Group recorded a decline in revenue of HK\$56.3 million or 10.6% to approximately HK\$473.7 million for the FY2022, as compared to HK\$530.0 million for the Previous Year. However, as a result of management's strategy to promote premium and specialised services, the gross profit and gross profit margin increased to HK\$76.3 million and 16.1% for FY2022, as compared to HK\$74.8 million and 14.1% for the Previous Year respectively.

Further analysis of the Group's financial results is set out in the section "Financial Review" below.

OUTLOOK

Management considers the slight decline in revenue for the FY2022 is of temporary nature and attributable to market and economic uncertainties brought on by the pandemic. To combat the said uncertainties, the Group is proactively enriching its range of service offerings, such as recycling of kitchen waste and other environmental related services, with an aim to broaden and diversify its customer base. Also, the Group registered itself as a supplier to a public health service operator during the FY2022 and subsequently in April 2022 has been awarded a contract for waste management service for a key district hospital, which is a notable milestone for the Group's development path at a time of turmoil. Having achieved a presence in the healthcare service sector, we will continue our unwavering efforts to secure further projects for various service offerings in this new customer sector. The prolonged COVID-19 outbreak has instilled strong awareness of and the needs for public cleanliness; the Group will target for associated opportunities available in the public sector, such as Food and Environmental Hygiene Department and other governmental or public service bodies.

基於上述原因，與上一年度錄得收益530.0百萬港元相比，本集團於2022財年錄得收益減少56.3百萬港元或10.6%至約473.7百萬港元。然而，由於管理層採取策略推廣優質及專業服務，2022財年的毛利及毛利率分別增至76.3百萬港元及16.1%，而上一年度則分別為74.8百萬港元及14.1%。

有關本集團財務業績的進一步分析載列於下文「財務回顧」一節。

前景

管理層認為，2022財年收益略為下滑乃屬暫時性質，乃歸因於疫情帶來的市場及經濟不明朗因素。為應對上述不明朗因素，本集團正積極擴闊其服務提供範圍，例如回收廚餘及其他環境相關服務，務求拓展及多元化發展其客戶基礎。同時，本集團已於2022財年申請登記成為公共衛生服務運營商旗下的供應商，隨後於2022年4月簽訂有關一間主要地區醫院的廢物管理服務的合約，為本集團在動盪時期繼續發展的一個重要里程碑。在醫療服務領域建立知名度後，我們將繼續努力不懈，在此新客戶界別中爭取更多有關不同服務的項目。COVID-19疫情持續鞏固了對公共清潔的強烈意識及需求，本集團將鎖定公共界別（例如食物環境衛生署及其他政府或公共服務機構）的相關機遇。

MANAGEMENT DISCUSSION AND ANALYSIS

管理層討論及分析

At the same time, management has been exploring horizontal business development opportunities, including the possible expansion in geographic coverage and in property related synergised services. To facilitate horizontal business development plan, the Group entered into a strategic cooperation framework agreement (the “Cooperation Agreement”) with Lask on 1 November 2021 to (i) make use of each other’s business network and operational expertise to identify potential business opportunities in the Greater Bay Area; and (ii) give due consideration to engage each other as business and/or operational cooperation partner to commence business operations or to enter into business transactions in the Greater Bay Area. Lask Group is principally engage in facility management services for residential, commercial and office premises, security services and horticulture services in the People’s Republic of China. The modes of cooperation between the parties include the formation of new joint ventures and to jointly bid for and complete projects. Further details about the Cooperation Agreement and the background of Lask Group are set out in the announcement published by the Company on 1 November 2021. The Group is also keen to explore new service offerings which synergies with its current environmental hygiene and related services business, such as pest control, property security and general property management services, in the Greater Bay Area.

Looking beyond the near-term uncertainties brought on by the COVID-19 outbreak, the market outlooks remains positive and will mainly be driven by urban and transportation development plans as announced by the government, including the Northern Metropolis plan, Lantau Tomorrow, and various rail network extension projects etc., which will create strong demand for environmental hygiene and other property related services. The Group also has the advantage to avail itself to business opportunities in the Greater Bay Area from its strategic cooperation with Lask Group as previously mentioned.

與此同時，管理層正在探索業務橫向發展的機會，包括可能擴大地域覆蓋範圍及物業相關的協同服務。為促進橫向業務發展計劃，本集團於2021年11月1日與歷思訂立戰略合作框架協議（「合作協議」），以(i)利用彼此的業務網絡及營運專長，在大灣區物色潛在商機；及(ii)適當考慮相互委聘為業務及／或運營合作夥伴，在大灣區開展業務或進行業務交易。歷思集團主要從事在中華人民共和國提供住宅、商業和辦公室處所的設施管理服務、保安服務及園林綠化服務。訂約方的合作模式包括成立新合營公司以及共同競投及完成專案。有關合作協議及歷思集團背景的進一步詳情載於本公司於2021年11月1日發佈的公告。本集團亦積極探討在大灣區推出可與目前環境衛生及相關服務業務產生協同效應的新服務，包括蟲害防治、物業保安和一般物業管理服務。

儘管存在COVID-19疫情所帶來的短期不明朗因素，市場前景仍然樂觀，且政府宣佈的城市及交通發展計劃亦有助推動市場發展。有關計劃包括北部都會區發展計劃、明日大嶼及各個鐵路網絡延伸項目等，將大大增加環境衛生及其他物業相關服務的需求。此外，如前所述，本集團與歷思集團的戰略合作亦為本集團提供優勢，把握大灣區的商機。

FINANCIAL REVIEW

Revenue

For the FY2022, total revenue was approximately HK\$473.7 million, representing a decrease of approximately 10.6% (FY2021: approximately HK\$530.0 million). The decrease in revenue mainly due to unsuccessful renewal of a few major contracts.

The following is an analysis of Group's revenue by segment:

For the FY2022, revenue from environmental hygiene and related services amounted to approximately HK\$473.7 million (FY2021: approximately HK\$530.0 million). The airline catering support services was still plagued with COVID-19 for FY2022, nil revenue from this segment as same as FY2021.

Cost of Services

For the FY2022 and FY2021, the cost of services of the Group amounted to approximately HK\$397.3 million and HK\$455.2 million respectively, representing approximately 83.9% and 85.9% of the Group's revenue for the corresponding years. The cost of services of the Group comprised direct wages, consumables and sub-contracting fees.

財務回顧

收益

於2022財年，總收益約為473.7百萬港元，減幅約10.6%（2021財年：約530.0百萬港元）。收益減少乃主要由於數份主要合約未能成功續約所致。

本集團按分部劃分的收益分析如下：

於2022財年，環境衛生及相關服務收益約為473.7百萬港元（2021財年：約530.0百萬港元）。航空餐飲支援服務於2022財年繼續受COVID-19肆虐影響，故一如2021財年並無自此分部錄得收益。

服務成本

Gross Profit and Gross Profit Margin

The gross profit slightly increased from approximately HK\$74.8 million for the FY2021 to approximately HK\$76.3 million for the FY2022. The overall gross profit margin increased from approximately 14.1% for the FY2021 to approximately 16.1% for the FY2022. The following table sets forth breakdown of gross profit and gross profit margin by segment:

The gross profit of environmental hygiene and related services slightly increased by approximately 2.0% from approximately HK\$74.8 million for the FY2021 to HK\$76.3 million for the FY2022. The gross profit margin increased from approximately 14.1% for the FY2021 to 16.1% for FY2022.

環境衛生及相關服務毛利自2021財年的約74.8百萬港元略為增加約2.0%至2022財年的約76.3百萬港元。毛利率自2021財年的約14.1%增加至2022財年的16.1%。

The increase of gross profit of environmental hygiene and related services was mainly due to few major contracts that were not successful in renewal, these contracts have a relatively higher cost of services and did not achieve the Company's average gross profit margin. The loss of these contracts pulled up the average gross profit and gross profit margin as a whole. The airline catering support services was still suspended because of COVID-19 for both FY2021 and FY2022, nil gross profit contribution from this segment.

環境衛生及相關服務的毛利上升，乃主要由於數份主要合約未能成功續約，相關合約的服務成本較高，且未達到本公司的平均毛利率。損失該等合約令平均毛利及毛利率整體拉高。由於2021財年及2022財年均繼續因應COVID-19而暫停航空餐飲支援服務，故此分部並無產生毛利。

General Operating Expenses

The general operating expenses decreased by approximately 21.4% or approximately HK\$13.9 million, from approximately HK\$65.0 million for the FY2021 to approximately HK\$51.1 million for the FY2022. The decrease of general operating expenses was mainly attributable to approximately HK\$11.3 million one-off expenses including anti-epidemic allowance to staff, professional fees and charitable donation was included in the FY2021.

Finance Costs

The Group's finance costs decreased by approximately 50.0% from approximately HK\$0.2 million for the FY2021 to approximately HK\$0.1 million for the FY2022 as the Group required less external financing for working capital requirement.

Profit and Total Comprehensive Income for the Year Attributable to Owners of the Company

The Group's profit and total comprehensive income attributable to owners of the Company for each of the FY2022 and FY2021 were approximately HK\$22.1 million and HK\$73.8 million respectively, representing of approximately 4.7% and 13.9% of the respective year's total revenue. The decrease in net profit was mainly attributable to the receipt of subsidies of approximately HK\$65.5 million from government under employment support scheme for FY2021.

Capital Expenditure

During the FY2022, the Group's capital expenditure which mainly included additions in equipment and motor vehicles amounted to approximately HK\$5.9 million (FY2021: HK\$8.8 million). These capital expenditures were mainly financed by fund generated from operating activities.

一般經營開支

一般經營開支由2021財年約65.0百萬港元減少約21.4%或約13.9百萬港元至2022財年約51.1百萬港元。一般經營開支減少主要由於在2021財年計入包括僱員抗疫慰勞金、專業費用及慈善捐款的一次性開支約11.3百萬港元所致。

融資成本

本集團的融資成本由2021財年的約0.2百萬港元減少約50.0%至2022財年的約0.1百萬港元，此乃由於本集團需要較少外部資金以滿足營運資金需求。

本公司擁有人應佔年內溢利及全面收益總額

於2022財年及2021財年各年度，本公司擁有人應佔本集團溢利及全面收益總額分別約為22.1百萬港元及73.8百萬港元，佔相應年度總收益的約4.7%及13.9%。純利減少乃主要由於在2021財年獲得政府保就業計劃項下的補貼約65.5百萬港元所致。

資本開支

於2022財年，本集團資本開支(主要包括購置設備及汽車)約為5.9百萬港元(2021財年：8.8百萬港元)。該等資本開支乃主要由經營活動產生的資金撥付。

LIQUIDITY, FINANCIAL RESOURCES AND CAPITAL STRUCTURE

As at 31 March 2022, the Group's total current assets and current liabilities were approximately HK\$226.4 million (31 March 2021: HK\$238.0 million) and HK\$55.5 million (31 March 2021: HK\$52.1 million) respectively, while the current ratio was approximately 4.1 times (31 March 2021: approximately 4.6 times).

As at 31 March 2022, the Group had total assets of approximately HK\$264.2 million which were financed by total liabilities and total equity of approximately HK\$68.9 million and HK\$195.4 million respectively. As at 31 March 2022, the Group had cash and bank balance of approximately HK\$117.2 million (31 March 2021: approximately HK\$121.7 million).

The Group gearing ratio was 0.02 times as at 31 March 2022 (31 March 2021: 0.03 times), which was calculated based on the total lease liabilities and bank borrowings over total equity of the Group.

There was no change to the Company's capital structure during the year ended 31 March 2022. As at 31 March 2022, the issued share capital of the Company was HK\$6,000,000 divided into 600,000,000 shares of HK\$0.01 each (the "Shares").

EMPLOYEES, TRAINING AND REMUNERATION POLICIES

As at 31 March 2022, the Group had 1,886 (31 March 2021: 2,077) employees. The Group enters into separate employment contracts with each of the Group's employees in accordance with the applicable employment laws in Hong Kong. The remuneration package includes basic salary, bonuses and other cash allowances or subsidies. The Group conducts annual review on salary, bonuses and promotions based on the performance of each employee. The total staff costs and related expenses (including directors' remuneration) for the year ended 31 March 2022 were approximately HK\$293.7 million, representing a decrease of approximately 8.6% or approximately HK\$27.6 million as compared with approximately HK\$321.3 million for the year ended 31 March 2021.

於2022年3月31日，本集團總資產約為264.2百萬港元，由負債總額及權益總額分別約為68.9百萬港元及195.4百萬港元撥付。於2022年3月31日，本集團有現金及銀行結餘約117.2百萬港元（2021年3月31日：約121.7百萬港元）。

於2022年3月31日，本集團的資本負債比率為0.02倍（2021年3月31日：0.03倍），該資本負債比率乃根據本集團租賃負債及銀行借款總額除以權益總額計算。

截至2022年3月31日止年度，本公司的資本架構並無發生變動。於2022年3月31日，本公司的已發行股本為6,000,000港元，分為600,000,000股每股面值0.01港元的股份（「股份」）。

僱員、培訓及薪酬政策

於2022年3月31日，本集團有1,886名（2021年3月31日：2,077名）僱員。本集團根據香港適用僱傭法例與本集團每名僱員分別訂立僱傭合約。薪酬待遇包括基本薪資、花紅及其他現金津貼或補貼。本集團根據各僱員的表現對薪資、花紅和晉升進行年度檢討。截至2022年3月31日止年度的員工成本及相關開支總額（包括董事酬金）約為293.7百萬港元，較截至2021年3月31日止年度的約321.3百萬港元減少約8.6%或約27.6百萬港元。

Apart from basic remuneration, share options have been granted under the pre-IPO share option scheme to recognise the contribution to the Group by an executive Director and certain employees of the members of the Group. Further share options may be granted under share option scheme to attract and retain the best available personnel, provide additional incentive to employees (full-time and part-time), as well as promote the success of the business of the Group.

In order to provide quality services to customers, the Group provides ongoing training regularly to relevant staff across different departments with topics including but not limited to information technology, environmental protection, ISO training, safety training as well as trainings for supervisory roles, etc. Such trainings are either provided internally or by external parties.

FOREIGN EXCHANGE EXPOSURE

Since the Group generated all of the revenue and incurred most of the costs in Hong Kong dollars for the year ended 31 March 2022, there was no significant exposure to foreign exchange fluctuation and the Group did not maintain any hedging policy against foreign exchange risk. The management will consider hedging significant currency exposure should the need arise.

CONTINGENT LIABILITIES

The Group did not have any material contingent liabilities as at 31 March 2021 and 31 March 2022.

CHARGE OVER GROUP'S ASSETS

The Group's leasehold land and buildings of carrying value of approximately HK\$25.2 million as at 31 March 2022 (31 March 2021: approximately HK\$26.2 million), were pledged to secure the bank loans.

The Group has utilised and will continue to utilise such net proceeds from the Share Offer for the purposes set out in the section headed “Statement of Business Objectives and Use of Proceeds” in the prospectus of the Company dated 28 February 2017 (the “Prospectus”). As at 31 March 2022, the unutilised net proceeds amounted to approximately HK\$1.1 million, which was intended to be utilised for (i) enhancing the information technology system to strengthen operational efficiency and service qualities as to approximately HK\$0.9 million; and (ii) increasing the market penetration by strengthen the promotion of the Group's brand as to approximately HK\$0.2 million.

Due to the prolonging COVID-19 pandemic, unprecedented change has been made to the business environment socially and economically. Commercial activities and engagements have been cut out due to social distance restriction. Advertising and event sponsorship has been substantially reduced/suspended due to budget cut down and the production line from IT products manufacturer has also been suspended, resulting in delay in delivery of products. As a result, the Company's utilization plan in increasing the market penetration and enhancing the information technology system has inevitably been delayed. Under this condition, the Company will be more confident to resume the utilization plan with appropriate tools and channels for the long run. It is expected the use of unutilised net proceeds be completed by 31 March 2023.

As at 31 March 2022, the unutilised net proceeds of approximately HK\$1.1 million have been placed as interest bearing deposits with a licensed bank in Hong Kong and are intended to be applied in a manner consistent with the proposed allocations in the Prospectus.

EVENT AFTER REPORTING PERIOD

There are no significant events after the reporting period and up to the date of this annual report.

The Company continuously seeks to enhance the effectiveness of its Board by maintaining the highest standards of corporate governance and recognizing and embracing the benefits of diversity in the boardroom. The Company sees diversity as a wide concept and believes that a diversity of perspectives can be achieved through consideration of a number of factors, including skills, regional and industry experience, cultural and educational background, race, age, gender and other qualities etc. In forming its perspectives on diversity, the Company will also take into account factors based on its own business model and specific needs and disclose the rationale for the factors it uses for such purpose from time to time. The Board will give adequate consideration to the Board Diversity Policy when it identifies suitably qualified candidates to become members of the Board and will review the Board Diversity Policy on a regular basis and make such revisions as may be required to ensure its continuing effectiveness.

BOARD MEETINGS

The Board intends to hold Board meetings regularly at least four times a year at approximately quarterly intervals. Notices of not less than 14 days will be given for all regular Board meetings to provide all Directors with an opportunity to attend and propose matters to be discussed in the meeting agenda.

董事會多元化政策

董事會於2017年3月13日採納董事會多元化政策（「董事會多元化政策」）。本公司一直務求藉維持最高水準的企業管治提升其董事會效率，以及認可並確信董事會多元化的好處。本公司視多元化為一個廣寬概念，並相信要獲得多元化的視角，可以從多方面的因素考慮，包括技能、地區與行業經驗、文化及教育背景、種族、年齡、性別及其他特質等。在形成多元化視角方面，本公司亦將根據本身的業務模式及特定需求去考慮各種因素並不時披露其就此目的所考慮因素的理論依據。董事會將充分考慮董事會多元化政策以物色具備合適資格的人士擔任董事會成員，並將定期檢討董事會多元化政策及進行所須有關修訂以確保其持續有效。

董事會會議

董事會計劃每年定期召開至少四次董事會會議，大約每季一次。所有董事會例行會議通知將於會議舉行前至少14日送呈全體董事，讓其安排出席會議，並於會議議程內提議所要討論的事宜。

For other Board and Board committee meetings, reasonable notice will generally be given. The agenda and accompanying documents are dispatched to the Directors or Board committee members at least 3 days before the meetings to ensure that they have sufficient time to review the documents and be adequately prepared for the meetings.

When Directors or Board committee members are unable to attend a meeting, they will be advised of the matters to be discussed and given an opportunity to make their views known to the Chairperson prior to the meeting. Minutes of the Board meetings and Board committee meetings will be recorded in sufficient detail to include the matters considered by the Board and the Board committee and the decisions reached, including any concerns raised by the Directors. Draft minutes of each Board meeting and Board committee meeting will be sent to the Directors for comments within a reasonable time after the date on which the meeting is held.

During the year ended 31 March 2022, the Board held 6 Board meetings and passed resolutions by way of written resolutions. The attendance record of each Directors is set out in the table on page 31 of this annual report.

GENERAL MEETING

During the year ended 31 March 2022, 1 general meeting of the Company, being the 2021 annual general meeting held on 10 August 2021 (the “2021 AGM”), was held. The attendance record of each Directors is set out in the table on page 31 of this annual report.

AUDIT COMMITTEE

The Company established the Audit Committee on 21 February 2017 with written terms of reference in compliance with the Listing Rules and the CG Code. Currently, the Audit Committee comprises three independent non-executive Directors, namely Mr. Chung Koon Yan, Mr. Yuen Ching Bor Stephen and Mr. Chan Chun Sing with Mr. Chung Koon Yan being the chairperson of the Audit Committee.

Amongst other things, the primary duties of the Audit Committee are to review, in draft form, the annual report, interim report and accounts, and to provide advice and comments to the Board. In this regard, members of the Audit Committee will liaise with the Board, the senior management and auditor. The Audit Committee will also consider any significant or unusual items that are, or may need to be, reflected in such reports and accounts and give consideration to any matters that have been raised by the Company's staff responsible for the accounting and financial reporting function, compliance officer (if any) or auditor. Members of the Audit Committee are also responsible for reviewing the Group's financial reporting process, internal control and risk management systems.

The corporate governance functions are also performed by the Audit Committee. The corporate governance functions are to develop and review the Company's policies and practices on corporate governance to comply with the CG Code and make recommendations to the Board, to review and monitor the training and continuous professional development of Directors and senior management, to develop, review and monitor the code of conduct and compliance manual (if any) applicable to employees and Directors, and to review the Company's compliance with the CG Code and disclosure in the Corporate Governance Report.

The Audit Committee held 3 meetings during the year ended 31 March 2022. The attendance record of each members of the Audit Committee at the above meetings is set out in the table on page 31 of this annual report. In addition, the Audit Committee also dealt with matters by way of circulation of written resolutions during the year.

The Audit Committee has reviewed the consolidated financial statements of the Group for the year ended 31 March 2022 and is of the opinion that such consolidated financial statements complied with the applicable accounting standards, the Listing Rules, other applicable legal requirements and that adequate disclosures have been made.

Amongst other things, the primary duties of the Remuneration Committee are to make recommendations to the Board on the remuneration policies and structure of the remuneration of the Directors and senior management and to set up a formal and transparent procedure for determination of such remuneration policies.

The Remuneration Committee has adopted the approach under code provision B.1.2(c)(ii) of the CG Code (which has been re-numbered as code provision E.1.2(c)(ii) under the new CG Code that came into effect on 1 January 2022) to make recommendations to the Board on remuneration packages of the Directors and the members of senior management.

The Remuneration Committee held 2 meetings during the year ended 31 March 2022. The attendance record of each members of the Remuneration Committee is set out in the table on page 31 of this annual report.

During the year ended 31 March 2022, the Remuneration Committee performed the following works:

- discussed and reviewed the existing policy and structure of the remuneration for the Directors and senior management; and

Amongst other things, the primary duties of the Nomination Committee are to make recommendations to the Board on appointment of Directors and succession planning for the Directors. In assessing the Board composition, the Nomination Committee will take into account various aspects set out in the Board Diversity Policy.

To ensure changes to the Board composition can be managed without undue disruption, there should be a formal, considered and transparent procedure for selection, appointment and re-appointment of Directors, as well as plans in place for orderly succession (if considered necessary), including periodical review of such plans. The appointment of a new Director (to be an additional Director or fill a casual vacancy as and when it arises) or any re-appointment of Directors is a matter for decision by the Board upon the recommendation of the proposed candidate by the Nomination Committee.

The criteria to be applied in considering whether a candidate is qualified shall be his or her ability to devote sufficient time and attention to the affairs of the Company and contribute to the diversity of the Board as well as the effective carrying out by the Board of the responsibilities which, in particular, are set out as follows:

- (a) participating in Board meetings to bring an independent judgment on issues of strategy, policy, performance, accountability, resources, key appointments and standards of conducts;
- (b) taking the lead where potential conflicts of interests arise;
- (c) serving on the Audit Committee, the Remuneration Committee and the Nomination Committee (in the case of candidate for non-executive Director) and other relevant Board committees, if invited;

Convening of extraordinary general meeting on requisition by Shareholders

應股東要求召開股東特別大會

The general meetings of the Company provide an opportunity for communication between the Shareholders and the Board. An annual general meeting of the Company shall be held in each year and at the place as may be determined by the Board. Each general meeting, other than an annual general meeting, shall be called an extraordinary general meeting.

RISK MANAGEMENT AND INTERNAL CONTROL

The Board's Responsibilities for the Risk Management and Internal Control Systems

The Board acknowledges that it is responsible for the risk management and internal control systems and oversees such systems on an ongoing basis, while ensuring a review of the effectiveness of these systems of the Group is conducted at least annually. The scope of such review covers all material controls, including financial, operational and compliance controls. The Group's risk management and internal control systems are designed to managing risks rather than eliminating the risk of failure to achieve business objectives, and can only provide reasonable and not absolute assurance against material misstatement or loss.

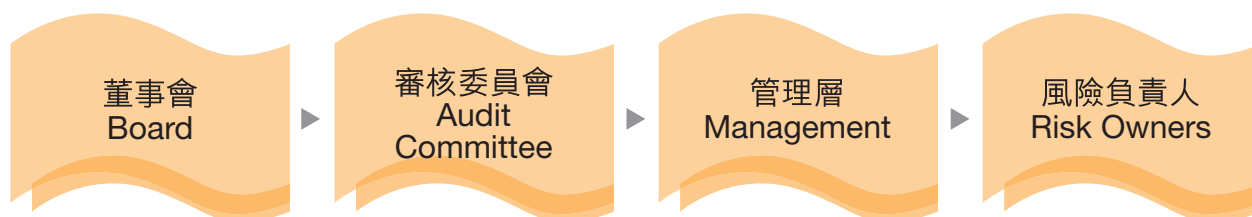

Risk assessment report and internal control review report are submitted to the Audit Committee and the Board annually. The Board, through the Audit Committee, had performed a review on the effectiveness of the Group's risk management and internal control systems, including, but not limited to, (i) the changes, in the nature and extent of significant risks and the Company's ability to respond to changes in its business and the external environment, (ii) the scope and quality of management's ongoing monitoring of risks and of the internal control systems, (iii) the extent and frequency of communication of monitoring results to the Audit Committee and the Board which enables them to assess control of the Company and the effectiveness of risk management, (iv) significant control failings or weaknesses that have been identified, and (v) the effectiveness of the Company's processes for financial reporting and Listing Rules compliance, and considered that the risk management and internal control systems were effective and adequate for the year ended 31 March 2022. No significant areas of concern that might affect the financial, operational, compliance controls, and risk management functions of the Group were identified. The scope of such review covers the adequacy of resources, qualification and experience of staff of the Group's accounting and financial reporting functions and their attitude against internal control of the Group. The Board will continue to work with the management to discuss and follow-up on the status of remediation of the internal control weaknesses and to monitor the risks of the Group in the coming years.

Procedures and Internal Controls for the Handling and Dissemination of Inside Information

In order to enhance the Group's system of handling inside information, and to ensure the truthfulness, accuracy, completeness and timeliness of its public disclosures, the Group also adopts and implements an inside information policy and procedures. Certain reasonable measures have been taken from time to time to ensure that proper safeguards exist to prevent a breach of a disclosure requirement in relation to the Group, which include:

- access of inside information is restricted to a limited number of employees on a need-to-know basis.
- transmission of inside information in electronic form should be password-protected.
- prohibit employees to discuss inside information in public area.
- code names are assigned to confidential projects so that any reference to them would not be linked to the projects themselves to minimize possibilities of unintentional leakage.
- trainings or briefings are provided to employees who will be in possession of inside information to ensure that they are fully conversant with their obligations to preserve confidentiality with reasonable care.
- confidentiality agreements are in place before the Group enters into significant negotiations.
- officers and employees other than the designated representative are prohibited to speak externally on behalf of the Company when communicating with external parties such as the media, analysts or investors.

INTERNAL AUDIT FUNCTION

The Company does not have an internal audit department. The Board has reviewed the need for an internal audit function and is of the view that in light of the size, nature and complexity of the business of the Group, as opposed to diverting resources to establish a separate internal audit department, it would be more cost effective to appoint external independent professionals to perform independent review of the adequacy and effectiveness of the risk management and internal control systems of the Group. Nevertheless, the Board will continue to review at least annually the need for an internal audit department.

COMPANY SECRETARY

The Company engaged an external professional company secretarial services provider, Uni-1 Corporate Services Limited (“Uni-1”), to provide compliance and full range of company secretarial services to the Group in order to assist the Group to cope with the changing regulatory environment and to suit difference commercial needs.

Ms. Chan Pui Shan, Bessie (“Ms. Chan”), the representative of Uni-1, has been appointed as the company secretary with effect from 13 June 2016. Her primary corporate contact person at the Company is Ms. Sze Tan Nei, an executive Director.

For the year ended 31 March 2022, Ms. Chan has undertaken not less than 15 hours of relevant professional training in accordance with Rule 3.29 of the Listing Rules.

DIRECTORS’ AND OFFICERS’ INSURANCE

The Company has arranged appropriate insurance cover in respect of potential legal actions against its Directors and officers.

EXECUTIVE DIRECTORS

Madam Ng Sing Mui (吳醒梅) (“Madam Ng”), aged 61, a co-founder of the Group, has been appointed as a Director since 31 May 2016. Madam Ng was re-designated as an executive Director on 21 February 2017 and is currently acting as the Chairperson. She is also the chairperson of the Nomination Committee and holds directorships in all subsidiaries of the Company. Madam Ng is primarily responsible for the strategic planning, operation planning and overall management of the Group.

Madam Ng has more than 30 years of experience in the environmental hygiene services industry in Hong Kong. Building the business from the ground up since December 1983, Madam Ng has held a leadership role in the overall management and business development of the Group.

Madam Ng has been a certified associate fellow of the Institute of Managers and Leaders Australia and New Zealand (formerly known as Australian Institute of Management) since September 1995 and has become a fellow member since June 2019. She was also awarded a Training Certificate on Fire Prevention (Commercial Sector) issued by the Occupational Safety & Health Council in August 2001.

Madam Ng is the mother of Ms. Sze Tan Nei and Mr. Sze Wai Lun, both are executive Directors. She is the sole director of Rich Cheer Development Limited and Sze’s Holdings Limited, both companies have disclosable interests in the Shares under the provisions in Divisions 2 and 3 of Part XV of the Securities and Futures Ordinance (Chapter 571, the Laws of Hong Kong) (the “SFO”).

Ms. Sze Tan Nei (施丹妮) (“Ms. Sze”), aged 42, joined the Group in February 2007 and was appointed as a Director on 20 June 2016. Ms. Sze was re-designated as an executive Director on 21 February 2017. She is also a member of the Remuneration Committee and holds directorships in several subsidiaries of the Company. She is primarily responsible for strategic planning, operation planning and compliance control of the Group’s business operation.

PRINCIPAL RISKS AND UNCERTAINTIES

The Group's businesses, financial condition, results of operations and growth prospects may be affected by risks and uncertainties directly or indirectly pertaining to the Group's businesses. The risk factors set out below are those that could result in the Group's businesses, financial conditions, results of operations or growth prospects differing materially from expected or historical results. Such factors are by no means exhaustive or comprehensive, and there may be other risks in addition to those shown below which are not known to the Group or which may not be material now but could turn out to be material in the future.

Strategic Risks

An occurrence of a natural disaster, widespread health epidemic or other outbreaks could have a material adverse impact on the Group's business, financial condition and results of operations.

In 2021, the COVID-19 pandemic impacted the social and economic environment worldwide. Quarantine, stay-at-home policy and transportation restriction imposed by the government may limit the demand of the airline catering supporting services.

Given that the customers from the airline catering support business only accounted for a relatively small portion of the Group's revenue, it is expected that there will not have a material adverse impact to the business overall.

Also, the worker has strengthened the environmental sanitation inspection to ensure the workplace was properly sanitized and to maintain a high-quality hygiene control in workplace. Thus, the cost of cleaning instruments may increase, which may impair the Group's profitability.

To minimize the impact from the outbreak of COVID-19, various measures have been implemented. Measures include regular meetings held to discuss the current situation and potential impact caused by COVID-19, and adopt implementation plan if necessary.

The Group has also actively explored the business development opportunities, and maintained stable business relationship with the suppliers which allow the Group to purchase the cleaning instruments at a favourable price.

主要風險及不確定性

本集團的業務、財務狀況、經營業績及增長前景可能受到直接或間接與本集團業務有關的風險及不確定性的影響。下文所載風險因素可能導致本集團的業務、財務狀況、經營業績或增長前景與預期或過往結果出現重大差異。該等因素並非詳盡或全面，並可能為本集團並不知悉的下文所述因素以外的或目前不屬重大但於日後可能變得重大的其他風險。

戰略風險

發生自然災害、廣泛蔓延的疫病或其他疫情爆發均可能會對本集團的業務、財務狀況及經營業績造成重大不利影響。

於2021年，COVID-19疫情影響全球社會及經濟環境。政府實施的檢疫、居家隔離政策及出入境限制可能會限制對航空餐飲支援服務的需求。

鑒於航空餐飲支援業務的客戶僅佔本集團收益的相對較少部分，預期不會對整體業務構成重大不利影響。

此外，員工已加強環境衛生檢查，確保工作場所妥為消毒，從而保持工作場所的高質量衛生控制。因此，清潔工具的成本可能增加，而這可能會損害本集團的盈利能力。

為盡量減低COVID-19疫情的影響，本集團已採取各種措施，包括定期舉行會議討論目前情況及COVID-19帶來的潛在影響，並在有需要時執行實施計劃。

本集團亦積極探索業務發展機會，與供應商保持穩定業務關係，使本集團能夠以優惠價格採購清潔工具。

Operational Risks

Business operations of the Group are labour-intensive and due to the locality of its customers, all of the Group's employees are employed in Hong Kong. Any shortage in the supply of workers in Hong Kong may adversely affect the Group's operations and financial performance, which may also slow down the Group's growth.

In response to the high labour turnover risks, the Group has offered competitive remuneration packages with fringe benefits and extensive training to retain competent employees and make up for the shortage in skilled workers.

The Group's revenue is mainly derived from tender contracts and there is no assurance that the existing contracts may be renewed upon expiry or new contracts may be awarded to the Group.

經營風險

本集團的業務營運屬勞動密集型，且由於客戶的所處地區使然，本集團的全部僱員均於香港聘請。香港勞工供應如出現任何短缺，或會對本集團的營運及財務表現造成不利影響及延緩本集團的增長。

為應對高勞動力流動風險，本集團提供具競爭力的薪酬待遇，提供附帶福利和廣泛的培訓，以留聘有能力的員工並補充技術工人的短缺。

本集團的收益主要來自招標合約且概無法保證現有合約於到期後會予以重續或本集團可獲得新合約。

The Group is required to submit new tenders upon expiry of the existing contracts or to bid for new contracts from time to time. In relation to the existing service contracts which are about to expire, the time frame for submitting new tenders for supplying the same services to the customer is generally three months prior to expiry of the service contract. There is no assurance that the Group will meet the mandatory tendering requirements and, in such case, the Group may not be granted the contract and therefore, the Group's business operations and financial results may be adversely affected. To response to the above risk, the Group has established a relatively broad customer base ranging from various government departments in Hong Kong and subsidiaries of multinational companies to tenants of various premises. Besides, the Group has been putting effort to build positive market reputation and develop long-term relationship with customers.

本集團於現有合約到期後須提交新標書或不時競投新合約。就將到期的現有服務合約而言，為向客戶提供相同服務而提交新標書的時段通常為服務合約到期前三個月。概無法保證本集團將會滿足強制性投標規定，而在此情況下，本集團或不會被授予合約，因此，本集團的業務營運及財務業績或會受到不利影響。為應對上述風險，本集團已建立相對廣泛的客戶群，大至香港各政府部門及跨國公司的附屬公司，小至多個物業的租戶。此外，本集團一直致力於建立良好的市場聲譽並與客戶發展長期關係。

Compliance Risks

The Group is exposed to litigation claims including employees' compensation claims and common law personal injury claims and insurance coverage of the Group may not adequately protect it against certain risks.

Through close monitoring of various legal and regulatory pronouncements from the government by its legal and compliance personnel, the Group is able to keep itself updated with various regulatory requirements and complies with local labour laws and regulations such as the Employment Ordinance and Employees' Compensation Ordinance. A comprehensive work safety management and supervision system is also established for enhancing safety performance. In addition, the management will review the insurance coverage on an ongoing basis.

Financial Risks

Please also refer to note 31 to the financial statements for the financial risks facing by the Group.

The Company treats human resources as the Group's valuable assets. Training and retaining good employees are always at top priorities.

Besides on-the-job trainings and funding for continuous learning, two committees are set up to ensure good physical and psychological health of our staffs. Workshops are held regularly to raise staff's awareness of occupational health and safety. The risk-free working environment is guaranteed by the certification of OHSAS 18001 Occupational Health and Safety Management System. In addition, the Company also organizes a range of recreational activities so as to foster team spirit.

Customers

Keeping strong relationship with the customers is critical to maintain the competitiveness of the Group.

For servicing industry with human as the main concern, it is vital to have an independent, comprehensive quality assurance mechanism in order to maintain high level of service, in which rule-of-man style and subjectivity in the old days can be eliminated. In view of this, the Company has established an evaluation mechanism with mutual assessment by internal and external teams of professionals audits. In order to achieve a set standard of service and customers' satisfaction, the work is monitored and reviewed in various aspects including provision of resources, training, infrastructure and working environment, with customers' expectation as the foundation. For services that are not up to high standard, remedial action will be advised and implemented with continuous improvement follow through. Also, preventive measure will be formulated as future guidelines.

Suppliers and Sub-contractors

The Group maintains a list of approved suppliers and sub-contractors which are selected with reference to, among other things, material/service quality, reliability and price. The Group performs annual evaluation on the Group's suppliers and sub-contractors with respect to raw materials/service quality, reliability and timely delivery.

The purpose of the Pre-IPO Share Option Scheme is to aid the Company in retaining key and senior employee of the Group. Principal terms of the Pre-IPO Share Option Scheme were set out in the Prospectus and note 26 to the financial statements. An aggregate of 192,000 share options at an exercise price of HK\$0.42 per Share, being the offer price under the Share Offer, were granted on 23 February 2017 to an executive Director and certain employees of the Group. No further options will be granted under the Pre-IPO Share Option Scheme.

(b) Participant of the Share Option Scheme

The Board may, at its absolute discretion and on such terms as it may think fit, grant any employee (full-time or part-time), director, consultant, adviser, substantial shareholder, distributor, contractor, supplier, agent, customer, business partner or service provider of the Group, options to subscribe at a price calculated in accordance with paragraph (c) below for such number of Shares as it may determine in accordance with the terms of the Share Option Scheme.

The subscription price of a Share in respect of any particular option granted under the Share Option Scheme shall be a price solely determined by the Board and notified to a participant and shall be at least the highest of: (i) the closing price of the Shares as stated in the Stock Exchange's daily quotations sheet on the date of grant of the option, which must be a business day; (ii) the average of the closing prices of the Shares as stated in the Stock Exchange's daily quotations sheets for the five business days immediately preceding the date of grant of the option; and (iii) the nominal value of Share on the date of grant of the option.

(d) Grant of options and acceptance of offers

An offer for the grant of options must be accepted within seven days inclusive of the day on which such offer was made. The amount payable by the grantee of an option to the Company on acceptance of the offer for the grant of an option is HK\$1.

(e) Maximum number of Shares of the Company available for issue

The total number of Shares available for issue under the Share Option Scheme is 60,000,000 Shares, represent 10% of the Shares in issue as at the date of this annual report.

(f) Maximum entitlement of each participant

The total number of Shares issued and to be issued upon exercise of options granted to any participant (including both exercised and outstanding options) under the Share Option Scheme or any other share option schemes of the Company in any 12-month period up to the date of grant shall not exceed 1% of the Shares in issue.

(g) Time of exercise of option

An option may be exercised in accordance with the terms of the Share Option Scheme at any time during a period as the Board may determine which shall not exceed ten years from the date of grant subject to the provisions of early termination thereof.

(h) Remaining life of the Share Option Scheme

The Share Option Scheme will remain in force for a period of ten years commencing on 21 February 2017, subject to early termination provisions contained in the Share Option Scheme.

Details of the Deed of Non-competition Undertakings have been set out in the section headed "Relationship with Controlling Shareholders — Deed of Non-competition Undertakings" in the Prospectus.

OPINION

BASIS FOR OPINION

We conducted our audit in accordance with Hong Kong Standards on Auditing ("HKSA") issued by the HKICPA. Our responsibilities under those standards are further described in the "Auditor's Responsibilities for the Audit of the Consolidated Financial Statements" section of our report. We are independent of the Group in accordance with the HKICPA's "Code of Ethics for Professional Accountants" (the "Code"), and we have fulfilled our other ethical responsibilities in accordance with the Code. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our opinion.

意見

我們已審計載於第83至159頁的永順控股香港有限公司(「貴公司」)及其附屬公司(以下統稱「貴集團」)之綜合財務報表，此等綜合財務報表包括於2022年3月31日之綜合財務狀況表與截至該日止年度之綜合全面收益表、綜合權益變動表及綜合現金流量表，以及綜合財務報表附註(包括重大會計政策概要)。

我們認為，綜合財務報表已根據香港會計師公會(「香港會計師公會」)頒佈之香港財務報告準則對 貴集團於2022年3月31日之綜合財務狀況以及截至該日止年度之綜合財務表現及綜合現金流量作出真實而公平的反映，並已根據香港公司條例的披露規定妥為編製。

意見基準

KEY AUDIT MATTERS

Key audit matters are those matters that, in our professional judgement, were of most significance in our audit of the consolidated financial statements of the current period. These matters were addressed in the context of our audit of the consolidated financial statements as a whole, and in forming our opinion thereon, and we do not provide a separate opinion on these matters.

Revenue recognition

Refer to summary of significant accounting policies in note 4.8 and note 7 to the consolidated financial statements.

Service income from provision of environmental hygiene and related services is recognised when the services are rendered. We have identified recognition of revenue as a key audit matter because revenue is one of the key performance indicators of the Group and there is an inherent risk over the recognition of revenue by the management to meet specific targets or expectations.

Our responses:

Our audit procedures to address the revenue recognition included the followings:

- evaluating the appropriateness of the recognition policy with reference to the relevant accounting standard;
- inspecting, on sample basis, customer contracts to identify terms and conditions relating to the provision of services;
- performing substantive analytical procedures to assess whether the recognised service revenue was in line with the expected level;
- inspecting service income recognised during the year, on sample basis, and comparing details of the service income being recognised with relevant the underlying documentation, including service contracts, service records and invoices; and
- assessing, on a sample basis, the service income recorded before and after the financial year end date with the relevant underlying documentation, including service contracts and service records, to verify whether the service income had been recognised in the appropriate financial period.

關鍵審計事項

關鍵審計事項是根據我們的專業判斷，認為對本期綜合財務報表的審計最為重要的事項。這些事項是在我們審計整體綜合財務報表及出具意見時進行處理的。我們不會對這些事項提供單獨的意見。

收益確認

請參閱綜合財務報表附註4.8之重大會計政策概要及附註7。

來自提供環境衛生及相關服務的服務收入乃於提供服務時確認。由於收益為貴集團其中一項主要表現指標，且存在管理層為了達到特定目標或期望而操縱收益確認的固有風險，因此我們識別收益確認為關鍵審計事項。

我們的應對：

我們就進行收益確認執行的審計程序包括以下各項：

- 參考相關會計準則評估確認政策是否適合；
- 抽樣檢查客戶合約，以識別與提供服務有關的條款及條件；
- 進行實質性分析程序，以評估已確認的服務收益是否符合預期水平；

- 抽樣評估財政年度結算日之前及之後記錄的服務收入及相關支持文件（包括服務合約及服務記錄），以核實服務收入是否已在適當的財政期間內確認。

INDEPENDENT AUDITOR'S REPORT

Impairment assessment of trade receivables

Refer to summary of significant accounting policies in note 4.6, note 5.2 and note 16 to the consolidated financial statements.

As at 31 March 2022, the Group had trade receivables amounted to HK\$104,019,000 after loss allowance of expected credit losses ("ECL") of HK\$153,000.

The loss allowance are based on management's estimate of lifetime ECL of trade receivables by taking into account the credit loss experience, ageing of overdue receivables, debtors' creditworthiness and repayment history and an assessment of both the current and forecast general economic conditions at the reporting date. All of which involve a significant degree of management judgements.

Since the assessment of ECL of trade receivables is a subjective area which requires the management's judgement and uses of estimates, and in view of the significance of the amount to the consolidated financial statements as a whole, we considered this as a key audit matter.

Our responses:

Our audit procedures in relation to the impairment assessment of trade receivables included:

- evaluating the Group's policies for estimating the credit loss allowance with reference to the requirements of HKFRS 9 Financial Instruments;
- assessing, on a sample basis, whether items in the trade receivables' ageing report were classified within the appropriate ageing bracket by comparing individual items in the report with underlying documentation;
- assessing appropriateness of management's estimate of credit loss allowance by examining the information provided by the management to derive the key parameters and assumptions of the ECL model adopted by the management, including checking historical default data, assessing management's estimated loss rates and assessing how reasonably management has incorporated forward-looking information in the ECL allowance; and
- reperforming the calculation of the loss allowance as at 31 March 2022 based on the Group's credit loss allowance policies.

貿易應收款項的減值評估

茲提述綜合財務報表附註4.6、附註5.2及附註16中的重大會計政策概要。

於2022年3月31日，扣除預期信貸虧損（「預期信貸虧損」）虧損撥備153,000港元後，貴集團的貿易應收款項為104,019,000港元。

虧損撥備以於報告日期管理層經考慮信貸虧損經驗、逾期應收款項的賬齡、債務人的信用等級及還款記錄以及對現時及預測整體經濟狀況的評估而對貿易應收款項的存續期預期信貸虧損估計為基準，上述各項均涉及管理層的重要判斷。

由於貿易應收款項預期信貸虧損的評估屬主觀範疇，其需要管理層判斷及運用估計，及鑑於相關金額對整體綜合財務報表而言屬重大，我們認為貿易應收款項預期信貸虧損為關鍵審計事項。

我們的應對：

我們關於貿易應收款項減值評估的審計程序包括：

- 參照香港財務報告準則第9號金融工具的要求評估 貴集團有關估計信貸虧損撥備的政策；
- 透過比較報告中個別項目與相關文件，抽樣評估貿易應收款項賬齡報告中的項目是否已歸類至適當的賬齡範圍內；
- 透過審查管理層提供的資料，評估管理層對信貸虧損撥備的估計是否恰當，以得出管理層採納的預期信貸虧損模式的關鍵參數及假設，包括查閱過往違約數據，評估管理層估計的虧損率及評估管理層在信貸虧損撥備中納入前瞻性信息的合理性；及
- 根據 貴集團的信貸虧損撥備政策，重新計算於2022年3月31日的虧損撥備。

OTHER INFORMATION IN THE ANNUAL REPORT

The directors are responsible for the other information. The other information comprises the information included in the Company's annual report, but does not include the consolidated financial statements and our auditor's report thereon.

Our opinion on the consolidated financial statements does not cover the other information and we do not express any form of assurance conclusion thereon. In connection with our audit of the consolidated financial statements, our responsibility is to read the other information and, in doing so, consider whether the other information is materially inconsistent with the consolidated financial statements or our knowledge obtained in the audit or otherwise appears to be materially misstated. If, based on the work we have performed, we conclude that there is a material misstatement of this other information, we are required to report that fact. We have nothing to report in this regard.

1. CORPORATE INFORMATION

Winson Holdings Hong Kong Limited (the “Company”) was incorporated in the Cayman Islands as an exempted company with limited liability on 31 May 2016. The Company’s shares are listed on the Main Board of The Stock Exchange of Hong Kong Limited (the “Stock Exchange”).

The address of the Company’s registered office is Cricket Square, Hutchins Drive, P.O. Box 2681, Grand Cayman, KY1-1111, Cayman Islands. The address of its principal place of business is Unit 01-02, 9/F., The Octagon, No. 6 Sha Tsui Road, Tsuen Wan, New Territories, Hong Kong.

The Company is an investment holding company. The principal activities of its subsidiaries (together with the Company, collectively referred to as the “Group”) are set out in note 34.

The Company’s immediate holding company is Sze’s Holdings Limited (“Sze’s Holdings”), a company incorporated in the British Virgin Islands (the “BVI”) and the entire issued share capital of Sze’s Holdings is held by Rich Cheer Development Limited, a company incorporated in Hong Kong, as the trustee of a family trust (the “Sze Family Trust”). The Sze Family Trust is a discretionary trust established by Madam Ng Sing Mui. The beneficiaries of the Sze Family Trust included, inter alia, Mr. Sze Wai Lun and Ms. Sze Tan Nei. Rich Cheer Development Limited is deemed or taken to be interested in all the shares beneficially owned by Sze’s Holdings.

3. BASIS OF PREPARATION

(a) Statement of compliance

The consolidated financial statements have been prepared in accordance with all applicable HKFRSs, Hong Kong Accounting Standards (“HKASs”) and Interpretations (hereinafter collectively referred to as the “HKFRSs”) and the disclosure requirements of the Hong Kong Companies Ordinance. In addition, the consolidated financial statements include applicable disclosures required by the Rules Governing the Listing of Securities on the Stock Exchange.

(b) Basis of measurement

The consolidated financial statements have been prepared under the historical cost basis.

(c) Functional and presentation currency

The consolidated financial statements are presented in Hong Kong Dollars (“HK\$”), which is also the functional currency of the Company and all values are rounded to the nearest thousand (“HK\$’000”) except otherwise indicated.

4. SIGNIFICANT ACCOUNTING POLICIES

4.1 Business combination and basis of consolidation

The consolidated financial statements comprise the financial statements of the Company and its subsidiaries. Inter-company transactions and balances between group companies together with unrealised profits are eliminated in full in preparing the consolidated financial statements. Unrealised losses are also eliminated unless the transaction provides evidence of impairment on the asset transferred, in which case the loss is recognised in profit or loss.

3. 編製基準

(a) 合規聲明

綜合財務報表已根據所有適用香港財務報告準則、香港會計準則(「香港會計準則」)及詮釋(下文統稱「香港財務報告準則」)以及香港公司條例的披露規定而編製。此外，綜合財務報表載有聯交所證券上市規則規定的適用披露資料。

綜合財務報表包括本公司及其附屬公司之財務報表。集團公司內公司間交易及結餘連同未變現溢利於編製綜合財務報表時悉數對銷。未變現虧損亦對銷，能提供已轉讓資產減值證據的交易除外，在此情況下虧損於損益確認。

4.2 Subsidiaries

A subsidiary is an investee over which the Company is able to exercise control. The Company controls an investee if all three of the following elements are present: (i) power over the investee, (ii) exposure, or rights, to variable returns from the investee, and (iii) the ability to use its power to affect those variable returns. Control is reassessed whenever facts and circumstances indicate that there may be a change in any of these elements of control.

In the Company's statement of financial position, interests in subsidiaries are stated at cost less impairment loss, if any. The results of subsidiaries are accounted for by the Company on the basis of dividend received and receivable.

4.3 Property, plant and equipment

Property, plant and equipment are stated at cost less accumulated depreciation and accumulated impairment losses.

The cost of property, plant and equipment includes its purchase price and the costs directly attributable to the acquisition of the items.

Subsequent costs are included in the asset's carrying amount or recognised as a separate asset, as appropriate, only when it is probable that future economic benefits associated with the item will flow to the Group and the cost of the item can be measured reliably. The carrying amount of the replaced part is derecognised. All other repairs and maintenance are recognised as an expense in profit or loss during the financial period in which they are incurred.

4.2 附屬公司

附屬公司為本公司可行使控制權的投資對象。以下三個因素全部滿足時，本公司控制該投資對象：(i)對投資對象的權力、(ii)來自投資對象可變回報的風險或權利及(iii)利用其權力影響該等可變回報的能力。當有事實或情況顯示任何該等控制因素可能出現變動時，會重新評估控制權。

於本公司財務狀況表中，於附屬公司的權益按成本減減值虧損(如有)列賬。本公司將附屬公司業績按已收及應收股息基準入賬。

4.3 物業、廠房及設備

物業、廠房及設備按成本減累計折舊及累計減值虧損列賬。

物業、廠房及設備的成本包括其購買價以及購買有關項目直接應佔的成本。

其後成本僅在與該項目有關的未來經濟利益有可能流入本集團，而該項目的成本能可靠計量時，方計入資產的賬面值或確認為獨立資產(如適用)。替代部分的賬面值不予確認。所有其他維修及保養在產生的財政期間於損益確認為開支。

The useful lives, residual value and depreciation method are reviewed, and adjusted if appropriate, at each reporting date. The useful lives are as follows:

The gain or loss on disposal of an item of property, plant and equipment is the difference between the net sale proceeds and its carrying amount, and is recognised in profit or loss on disposal.

4.4 Leases

Accounting as a lessee

All leases are required to be capitalised in the consolidated statement of financial position as right-of-use assets and lease liabilities, but accounting policy choices exist for an entity to choose not to capitalise leases which are short-term leases. The Group has elected not to recognise right-of-use assets and lease liabilities for leases for which at the commencement date have a lease term of less than 12 months. The lease payments associated with those leases have been expensed on straight-line basis over the lease term.

Right-of-use asset

The right-of-use asset should be recognised at cost and would comprise: (i) the amount of the initial measurement of the lease liability (see below for the accounting policy to account for lease liability); (ii) any lease payments made at or before the commencement date, less any lease incentives received; (iii) any initial direct costs incurred by the lessee; and (iv) an estimate of costs to be incurred by the lessee in dismantling and removing the underlying asset to the condition required by the terms and conditions of the lease, unless those costs are incurred to produce inventories.

The Group measures the right-of-use assets applying a cost model. Under the cost model, the Group measures the right-to-use at cost, less any accumulated depreciation and any impairment losses, and adjusted for any remeasurement of lease liability.

Other than the above right-of-use assets, the Group has leased a number of properties under tenancy agreements which the Group exercises its judgement and determines that it is a separate class of asset apart from the leasehold land which is held for own use. As a result, the right-of-use asset arising from the properties under tenancy agreements are carried at depreciated cost.

4.4 租賃

作為承租人的會計處理

所有租賃須於綜合財務狀況表內資本化為使用權資產及租賃負債，惟會計政策為實體提供選擇，可選擇不將屬短期租賃的租賃進行資本化。本集團已選擇不就於開始日期租賃期少於12個月的租賃確認使用權資產及租賃負債。與該等租賃相關的租賃付款已於租賃期內按直線法支銷。

使用權資產

使用權資產應按成本確認並將包括：(i)租賃負債之初始計量金額（見下文有關租賃負債入賬的會計政策）；(ii)於開始日期或之前作出之任何租賃付款減已收取之任何租賃優惠；(iii)承租人產生之任何初始直接成本及(iv)承租人將於分解及移除相關資產至租賃條款及條件規定之狀況時產生之估計成本，惟該等成本乃為生產存貨而產生則除外。

本集團應用成本模式計量使用權資產。根據成本模式，本集團按成本減任何累計折舊及任何減值虧損計量使用權資產，並就租賃負債之任何重新計量作出調整。

除以上使用權資產外，本集團已根據租賃協議租賃多項物業，而本集團行使其判斷並釐定其為持作自用的租賃土地以外的獨立類別資產。因此，租賃協議項下物業產生的使用權資產按折舊成本列賬。

Lease liability

The lease liability is recognised at the present value of the lease payments that are not paid at the date of commencement of the lease. The lease payments are discounted using the interest rate implicit in the lease, if that rate can be readily determined. If that rate cannot be readily determined, the Group uses the Group's incremental borrowing rate.

The following payments for the right-to-use the underlying asset during the lease term that are not paid at the commencement date of the lease are considered to be lease payments: (i) fixed payments less any lease incentives receivable; (ii) variable lease payments that depend on an index or a rate, initially measured using the index or rate as at commencement date; (iii) amounts expected to be payable by the lessee under residual value guarantees; (iv) the exercise price of a purchase option if the lessee is reasonably certain to exercise that option; and (v) payments of penalties for terminating the lease, if the lease term reflects the lessee exercising an option to terminate the lease.

Subsequent to the commencement date, the Group measures the lease liability by: (i) increasing the carrying amount to reflect interest on the lease liability; (ii) reducing the carrying amount to reflect the lease payments made; and (iii) remeasuring the carrying amount to reflect any reassessment or lease modifications, or to reflect revised in-substance fixed lease payments.

作為承租人的會計處理 (續) 租賃負債

租賃負債乃按於租賃開始日期尚未支付之租賃付款之現值確認。倘該利率可輕易釐定，則租賃付款須使用租賃隱含之利率貼現。倘該利率無法輕易釐定，則本集團使用本集團之增量借款利率。

於租賃期內，以下於租賃開始日期尚未支付之相關資產使用權之付款均被視為租賃付款：(i) 固定付款減任何應收租賃優惠；(ii) 基於指數或利率之可變租賃付款（初步使用於開始日期之指數或利率計量）；(iii) 承租人根據剩餘價值擔保預期應付之金額；(iv) 購買選擇權之行使價（倘承租人合理肯定行使該選擇權）；及(v) 終止租賃之罰金付款（倘租賃期反映承租人行使終止租賃之選擇權）。

於開始日期後，本集團按以下方式計量租賃負債：(i) 增加賬面值以反映租賃負債利息；(ii) 減少賬面值以反映已作出之租賃付款；及(iii) 重新計量賬面值以反映任何重新評估或租賃調整，或反映已修訂實質固定租賃付款。

When the Group revises its estimate of the term of any lease (because, for example, it re-assesses the probability of a lessee extension or termination option being exercised), it adjusts the carrying amount of the lease liability to reflect the payments to make over the revised term, which are discounted using a revised discount rate. The carrying value of lease liabilities is similarly revised when the variable element of future lease payments dependent on a rate or index is revised, except the discount rate remains unchanged. In both cases, an equivalent adjustment is made to the carrying value of the right-of-use asset, with the revised carrying amount being amortised over the remaining (revised) lease term. If the carrying amount of the right-of-use asset is adjusted to zero, any further reduction is recognised in profit or loss.

When the Group renegotiates the contractual terms of a lease with the lessor, if the renegotiation results in one or more additional assets being leased for an amount commensurate with the standalone price for the additional rights-of-use obtained, the modification is accounted for as a separate lease, in all other cases, where the renegotiated increases the scope of the lease (whether that is an extension to the lease term, or one or more additional assets being leased), the lease liability is remeasured using the discount rate applicable on the modification date, with the right-of-use asset being adjusted by the same amount. With the exception to which the practical expedient for Covid-19-Related Rent Concessions applies, if the renegotiation results in a decrease in the scope of the lease, both the carrying amount of the lease liability and right-of-use asset are reduced by the same proportion to reflect the partial or full termination of the lease with any difference recognised in profit or loss. The lease liability is then further adjusted to ensure its carrying amount reflects the amount of the renegotiated payments over the renegotiated term, with the modified lease payments discounted at the rate applicable on the modification date and the right-of-use asset is adjusted by the same amount.

租賃負債 (續)

當本集團修訂其對任何租賃期的估計時(例如,由於其重新評估承租人延期或終止選擇權獲行使的可能性),則會調整租賃負債的賬面值,以反映於經修訂期限內作出的付款,並使用經修訂貼現率貼現。當取決於利率或指數的未來租賃付款的可變部分獲修訂時,租賃負債的賬面值亦作類似修訂,惟貼現率維持不變。於兩種情況下,對使用權資產的賬面值作出相等調整,經修訂賬面值於餘下(經修訂)租賃期內攤銷。倘使用權資產的賬面值調整至零,則於損益確認任何進一步削減。

本集團與出租人重新磋商租賃合約條款時,倘重新磋商引致租用一項或多項額外資產,其金額與所獲得的額外使用權的獨立價格相稱,該項修訂入賬列作一項獨立租賃,於所有其他情況下,倘重新磋商導致租賃範圍增加(不論為延長租賃期,或租賃一項或多項額外資產),則租賃負債按於修訂日期適用的貼現率重新計量,而使用權資產則按相同金額調整。除2019冠狀病毒病相關租金寬減之實際權宜之策適用例外情況外,倘若重新磋商導致租賃範圍減少,則租賃負債的賬面值及使用權資產按相同比例減少,以反映部分或全部終止租賃,並在損益中確認任何差額。其後,進一步調整租賃負債以確保其賬面值反映於重新磋商的期限內重新磋商的款項的金額,並以在修改日期適用的匯率對經修改的租賃付款進行折現,而使用權資產則按相同金額進行調整。

Accounting as a lessor

Leases are classified as finance leases whenever the terms of the lease transfer substantially all the risks and rewards of ownership of the leased assets to the lessee. All other leases are classified as operating leases.

Rental income from operating leases is recognised in profit or loss on a straight-line basis over the term of the relevant lease. Initial direct costs incurred in negotiating and arranging an operating lease are added to the carrying amount of the leased asset and recognised as an expense on the straight-line basis over the lease term.

Any changes in the scope of the consideration for a lease that was not part of the original terms and conditions of the lease are accounted for as lease modifications. The Group accounts for a modification to an operating lease as a new lease from the effective date of the modification, recognising the remaining lease payments as income on either a straight-line basis or another systematic basis over the remaining lease term.

4.5 Inventories

Inventories are initially recognised at cost, and subsequently at the lower of cost and net realisable value. Cost comprises all costs of purchase, costs of conversion and other costs incurred in bringing the inventories to their present location and condition. Cost is calculated using the weighted average method. Net realisable value represents the estimated selling price in the ordinary course of business less the estimated costs necessary to make the sale.

凡租賃條款規定所租賃資產擁有權之絕大部分風險及回報轉移至承租人之租賃均分類為融資租賃。所有其他租賃均分類為經營租賃。

經營租賃之租金收入於有關租期以直線法於損益內確認。磋商及安排經營租賃所產生初步直接成本會計入租賃資產之賬面值，並於租期內以直線法確認為開支。

租賃代價的範圍作出不屬於原租賃條款及條件一部份的任何變動將作為租賃修訂入賬。本集團自修訂生效日起將經營租賃修訂作為新租賃入賬，租賃付款餘額於餘下租賃期內按直線法或另一系統基準確認為收入。

4.5 存貨

存貨初始按成本確認，其後按成本與可變現淨值兩者中的較低者確認。成本包括所有採購成本、轉換成本及將存貨送至彼等現有地點及達致現有狀況所產生的其他成本。成本按加權平均法計算。可變現淨值指日常業務過程中的估計售價減進行銷售必要的估計成本。

(i) Financial assets

A financial asset (unless it is a trade receivable without a significant financing component) is initially measured at fair value plus, for an item not at fair value through profit or loss, transaction costs that are directly attributable to its acquisition or issue. A trade receivable without a significant financing component is initially measured at the transaction price.

All regular way purchases and sales of financial assets are recognised on the trade date, that is, the date that the Group commits to purchase or sell the asset. Regular way purchases or sales are purchases or sales of financial assets that require delivery of assets within the period generally established by regulation or convention in the market place.

Financial assets with embedded derivatives are considered in their entirety when determining whether their cash flows are solely payment of principal and interest.

Debt instruments

Subsequent measurement of debt instruments depends on the Group's business model for managing the asset and the cash flow characteristics of the asset. The following is the measurement category into which the Group classifies its debt instruments:

Amortised cost: Assets that are held for collection of contractual cash flows where those cash flows represent solely payments of principal and interest are measured at amortised cost. Financial assets at amortised cost are subsequently measured using the effective interest method. Interest income, foreign exchange gains and losses and impairment are recognised in profit or loss. Any gain on derecognition is recognised in profit or loss.

釐定具有嵌入衍生工具的金融資產的現金流量是否僅為支付本金和利息時，應予以整體考慮。

債務工具

債務工具的其後計量視乎本集團管理該資產之業務模式及該資產之現金流量特徵而定。本集團將其債務工具分類為下列計量類別：

The Group recognises loss allowances for expected credit loss (“ECL”) on financial assets measured at amortised cost. The ECL are measured on either of the following bases: (1) 12 months ECL: these are the ECL that result from possible default events within the 12 months after the reporting date; and (2) lifetime ECL: these are ECL that result from all possible default events over the expected life of a financial instrument. The maximum period considered when estimating ECL is the maximum contractual period over which the Group is exposed to credit risk.

ECL are a probability-weighted estimate of credit losses. Credit losses are measured as the difference between all contractual cash flows that are due to the Group in accordance with the contract and all the cash flows that the Group expects to receive. The shortfall is then discounted at an approximation to the assets’ original effective interest rate.

The Group measured loss allowances for trade receivables using HKFRS 9 simplified approach and has calculated ECL based on lifetime ECL. The Group has established a provision matrix that is based on the Group’s historical credit loss experience, adjusted for forward-looking factors specific to the debtors and the economic environment.

For other financial assets at amortised cost, ECL are based on lifetime ECL except when there has not been a significant increase in credit risk since initial recognition, in which case the allowance will be based on the 12 months ECL.

When determining whether the credit risk of a financial asset has increased significantly since initial recognition and when estimating ECL, the Group considers reasonable and supportable information that is relevant and available without undue cost or effort. This includes both quantitative and qualitative information analysis, based on the Group's historical experience and informed credit assessment and including forward-looking information.

The Group assumes that the credit risk on a financial asset has increased significantly if it is more than 30 days past due.

The Group considers a financial asset to be in default when: (1) the borrower is unlikely to pay its credit obligations to the Group in full, without recourse by the Group to actions such as realising security (if any is held); or (2) the financial asset is more than 90 days past due unless the Group has reasonable and supportable information to demonstrate that a more lagging default criterion is more appropriate.

對於按攤銷成本計量的其他金融資產而言，預期信貸虧損乃基於全期預期信貸虧損。惟倘信貸風險自初始確認以來大幅增加，在此情況下撥備將以12個月預期信貸虧損為基礎。

當釐定金融資產之信貸風險是否自初始確認後大幅增加，並於估計預期信貸虧損時，本集團考慮到相關及毋須付出過多成本或努力後即可獲得之合理及可靠資料。此包括根據本集團之過往經驗及已知信貸評估得出定量及定性之資料及分析，包括前瞻性資料。

倘金融資產逾期30日以上，本集團假設金融資產的信貸風險顯著增加。

在下列情況下，本集團認為金融資產屬違約：(1) 借款人不大可能在本集團無追索權採取變現抵押（如持有）等行動的情況下向本集團悉數支付其信貸債務；或(2) 金融資產逾期90日以上，惟本集團擁有合理及可靠資料顯示一項更滯後的違約標準更為合適，則另作別論。

Depending on the nature of the financial instruments, the assessment of a significant increase in credit risk is performed on either an individual or a collective basis. When the assessment is performed on a collective basis, the financial instruments are grouped based on shared credit risk characteristics, such as past due status and credit risk ratings.

The Group considers a financial asset to be credit-impaired when:

- significant financial difficulty of the debtor;
- a breach of contract, such as a default or being more than 90 days past due unless the Group has reasonable and supportable information to demonstrate that a more lagging default criterion is more appropriate;
- the restructuring of a loan or advance by the Group on terms that the Group would not consider otherwise;
- it is probable that the debtor will enter bankruptcy or other financial reorganisation; or
- the disappearance of an active market for a security because of financial difficulties.

The Group recognises an impairment gain or loss in profit or loss for all financial instruments with a corresponding adjustment to their carrying amount through a loss allowance account.

The Group writes off a financial asset when there is information indicating that the debtor is in severe financial difficulty and there is no realistic prospect of recovery, e.g. when the debtor has been placed under liquidation or has entered into bankruptcy proceedings, or in the case of trade receivables, when the amounts are past due for a number of years. Financial assets written off may still be subject to enforcement activities under the Group's recovery procedures, taking into account legal advice where appropriate. Any recoveries made are recognised in profit or loss.

當有資料顯示債務人處於嚴重財務困難時，及並無合理預期收回時(包括債務人已被清盤或已進入破產程序，或就貿易應收款項而言，金額逾期多年，以較早者為準)，本集團將撤銷其金融資產。已撤銷的金融資產可能需根據本集團的收回程序進行法律行動，當中於適當情況下將考慮法律意見。收回的任何資產於損益內確認。

Interest income on credit-impaired financial assets is calculated based on the amortised cost (i.e. the gross carrying amount less loss allowance) of the financial asset. For non credit-impaired financial assets, interest income is calculated based on the gross carrying amount.

(iii) Financial liabilities

The Group classifies its financial liabilities, depending on the purpose for which the liabilities were incurred. Financial liabilities at amortised costs are initially measured at fair value, net of directly attributable costs incurred.

Financial liabilities at amortised cost

Financial liabilities at amortised cost including trade payables, accruals, deposits and other payables and bank borrowings are subsequently measured at amortised cost, using the effective interest method. The related interest expense is recognised in profit or loss.

Gains or losses are recognised in profit or loss when the liabilities are derecognised as well as through the amortisation process.

(iv) Effective interest method

The effective interest method is a method of calculating the amortised cost of a financial asset or financial liability and of allocating interest income or interest expense over the relevant period. The effective interest rate is the rate that exactly discounts estimated future cash receipts or payments through the expected life of the financial asset or liability, or where appropriate, a shorter period.

(vi) Derecognition

The Group derecognises a financial asset when the contractual rights to the future cash flows in relation to the financial asset expire or when the financial asset has been transferred and the transfer meets the criteria for derecognition in accordance with HKFRS 9.

Financial liabilities are derecognised when the obligation specified in the relevant contract is discharged, cancelled or expired.

4.7 Cash and cash equivalents

In the consolidated statement of cash flows, cash and cash equivalents represented cash and bank balances.

4.8 Revenue recognition

Revenue from contracts with customers is recognised when control of goods or services is transferred to the customers at an amount that reflects the consideration to which the Group expects to be entitled in exchange for those goods or services, excluding those amounts collected on behalf of third parties. Revenue is after deduction of any trade discounts.

Depending on the terms of the contract and the laws that apply to the contract, control of the goods or service may be transferred over time or at a point in time. Control of the goods or service is transferred over time if the Group's performance:

- provides all of the benefits received and consumed simultaneously by the customer;
- creates or enhances an asset that the customer controls as the Group performs; or
- does not create an asset with an alternative use to the Group and the Group has an enforceable right to payment for performance completed to date.

If control of the goods or services transfers over time, revenue is recognised over the period of the contract by reference to the progress towards complete satisfaction of that performance obligation. Otherwise, revenue is recognised at a point in time when the customer obtains control of the goods or service.

When the contract contains a financing component which provides the customer a significant benefit of financing the transfer of goods or services to the customer for more than one year, revenue is measured at the present value of the amounts receivable, discounted using the discount rate that would be reflected in a separate financing transaction between the Group and the customer at contract inception. Where the contract contains a financing component which provides a significant financing benefit to the Group, revenue recognised under that contract includes the interest expense accreted on the contract liability under the effective interest method. For contracts where the period between the payment and the transfer of the promised goods or services is one year or less, the transaction price is not adjusted for the effects of a significant financing component, using the practical expedient in HKFRS 15.

- (i) Service income is recognised in the accounting period in which the services are rendered.
- (ii) Interest income is calculated by applying the effective interest rate to the gross carrying amount of a financial asset except for financial asset that subsequently become credit-impaired. For credit-impaired financial asset, the effective interest rate is applied to the net carrying amount of the financial asset (after deduction of the loss allowance).
- (iii) Rental income under operating leases is recognised on a straight-line basis over the lease terms.
- (iv) Income from sales of goods is recognised at point in time when the goods are delivered to customers and title has passed.

Contract assets and liabilities

A contract asset represents the Group's right to consideration in exchange for services that the Group has transferred to a customer that is not yet unconditional. In contrast, a receivable represents the Group's unconditional right to consideration, i.e. only the passage of time is required before payment of that consideration is due.

A contract liability represents the Group's obligation to transfer services to a customer for which the Group has received consideration (or an amount of consideration is due) from the customer.

Contract asset is recognised when the customers retain retention money to secure the due performance of the contracts. Any amount previously recognised as a contract asset is reclassified to trade receivables at the point at which it is invoiced to the customer. If the considerations (including advances received from customers) exceeds the revenue recognised to date under the output method then the Group recognises a contract liability for the difference.

4.9 Income taxes

Income taxes for the year comprise current tax and deferred tax.

Current tax is based on the profit or loss from ordinary activities adjusted for items that are non-assessable or disallowable for income tax purposes and is calculated using tax rates that have been enacted or substantively enacted at the end of reporting period. The amount of current tax payable or receivable is the best estimate of the tax amount expected to be paid or received that reflects any uncertainty related to income tax.

Deferred tax is recognised in respect of temporary differences between the carrying amounts of assets and liabilities for financial reporting purposes and the corresponding amounts used for tax purposes. Except for initial recognition of assets and liabilities that are not part of the business combination which affect neither accounting nor taxable profits, taxable temporary differences arising on investments in subsidiaries where the Group is able to control the reversal of the temporary difference and it is probable that the temporary difference will not reverse in the foreseeable future, deferred tax liabilities are recognised for all taxable temporary differences. Deferred tax assets are recognised to the extent that it is probable that taxable profits will be available against which deductible temporary differences can be utilised, provided that the deductible temporary differences are not arises from initial recognition of assets and liabilities in a transaction other than in a business combination that affects neither taxable profit nor the accounting profit. Deferred tax is measured at the tax rates appropriate to the expected manner in which the carrying amount of the asset or liability is realised or settled and that have been enacted or substantively enacted at the end of reporting period, and reflects any uncertainty related to income taxes.

Deferred tax assets and liabilities are offset when there is a legally enforceable right to set off current tax assets against current tax liabilities and when they relate to income tax levied by the same taxation authority and the Group intends to settle its current tax assets and liabilities on a net basis.

4.9 所得稅

年內所得稅包括即期稅項及遞延稅項。

即期稅項基於毋須就利得稅課稅或不可扣減利得稅之項目作出調整之日常業務溢利或虧損，按報告期末已頒佈或實際頒佈之稅率計算。即期應付或應收稅項金額為預期將支付或收取的稅項金額之最佳估計，反映與所得稅有關的任何不確定性。

遞延稅項按作財務報告之資產與負債賬面值，與就稅務所用相應數值之暫時差額確認。除初步確認並非業務合併一部分(不會影響會計或應課稅溢利)之資產及負債外，倘於附屬公司的投資產生之應課稅暫時差額，而本集團可控制暫時差額之撥回，且暫時差額於可見將來可能不會撥回，則就所有應課稅暫時差額確認遞延稅項負債。遞延稅項資產於存在可動用可扣稅暫時差額抵銷的應課稅溢利之情況下確認，惟可抵扣暫時差額並非因初步確認交易(業務合併除外)的資產及負債而產生，且不會影響應課稅溢利或會計溢利。遞延稅項乃按適用於資產或負債之賬面值獲變現或結算的預期方式，根據於報告期末已頒佈或大致上頒佈之稅率計量，並反映與所得稅有關之任何不確定性。

當有合法可執行權利將即期稅項資產抵銷即期稅項負債，且與同一稅務機關徵收之所得稅有關。而本集團擬按淨額基準結算其即期稅項資產及負債時，則遞延稅項資產及負債可互相對銷。

The carrying amount of deferred tax assets is reviewed at each reporting date and reduced to the extent that it is no longer probable that sufficient taxable profits will be available to allow all or part of the assets to be recovered.

Income taxes are recognised in profit or loss except when they relate to items recognised in other comprehensive income in which case the taxes are also recognised in other comprehensive income or when they relate to items recognised directly in equity in which case the taxes are also recognised directly in equity.

4.10 Employee benefits

(i) Short term employee benefits

Short term employee benefits are employee benefits (other than termination benefits) that are expected to be settled wholly before twelve months after the end of the annual reporting period in which the employees render the related service. Short term employee benefits are recognised in the year when the employees render the related service.

(ii) Defined contribution retirement plan

Contributions to defined contribution retirement plans are recognised as an expense in profit or loss when the services are rendered by the employees.

(iii) Termination benefits

Termination benefits are recognised on the earlier of when the Group can no longer withdraw the offer of those benefits and when the Group recognises restructuring costs involving the payment of termination benefits.

(iv) Long service payments

The Group's net obligation in respect of long service amounts payable on cessation of employment in certain circumstances under the Hong Kong Employment Ordinance is the amount of future benefit that employees have earned in return for their service in the current and prior periods. Liabilities recognised in respect of long service payment are measured at the present value of the estimated future cash outflows expected to be made by the Group in respect of services provided by employees up to the reporting date. The cost of providing the long service payment liabilities is charged to the consolidated statement of comprehensive income. The long service payment liabilities are determined by the recent remuneration of the eligible employees based on the requirement of Hong Kong Employment Ordinance, and is reduced by entitlements accrued under the Group's retirement plans that are attributable to contributions made by the Group.

4.11 Impairment loss of non-financial assets

At the end of each reporting period, the Group reviews the carrying amounts of the following assets to determine whether there is any indication that those assets have suffered an impairment loss or an impairment loss previously recognised no longer exists or may have decreased:

- property, plant and equipment; and
- interests in subsidiaries

If the recoverable amount (i.e. the greater of the fair value less costs to sell and value in use) of an asset is estimated to be less than its carrying amount, the carrying amount of the asset is reduced to its recoverable amount. An impairment loss is recognised as an expense immediately.

Where an impairment loss subsequently reverses, the carrying amount of the asset is increased to the revised estimate of its recoverable amount, to the extent that the increased carrying amount does not exceed the carrying amount that would have been determined had no impairment loss been recognised for the asset in prior years. A reversal of an impairment loss is recognised as income immediately.

4.12 Borrowing costs

Borrowing costs attributable directly to the acquisition, construction or production of qualifying assets which require a substantial period of time to be ready for their intended use or sale, are capitalised as part of the cost of those assets. Income earned on temporary investments of specific borrowings pending their expenditure on those assets is deducted from borrowing costs capitalised. All other borrowing costs are recognised in profit or loss in the period in which they are incurred.

4.13 Government grants

Government grants are not recognised until there is reasonable assurance that the Group will comply with the conditions attaching to them and that the grants will be received.

Government grants are recognised in profit or loss on a systematic basis over the periods in which the Group recognises as expenses the related costs for which the grants are intended to compensate.

Government grants that are receivable as compensation for expenses or losses already incurred or for the purpose of giving immediate financial support to the Group with no future related costs are recognised in profit or loss in the period in which they become receivable and are recognised as other revenue, rather than reducing the related expense.

Provisions are recognised for liabilities of uncertain timing or amount when the Group has a legal or constructive as a result of a past event, which will probably result in an outflow of economic benefits that can be reliably estimated.

Where it is not probable that an outflow of economic benefits will be required, or the amount cannot be estimated reliably, the obligation is disclosed as a contingent liability, unless the probability of outflow of economic benefits is remote. Possible obligations, the existence of which will only be confirmed by the occurrence or non-occurrence of one or more uncertain future events, are also disclosed as contingent liabilities unless the probability of outflow of economic benefits is remote.

4.15 Equity-settled share-based payment transactions

The fair value of services received is determined by reference to the fair value of share options granted at the date of grant and is expensed on a straight-line basis over the vesting period, with a corresponding increase in equity under the heading of share option reserve.

At the end of the reporting period, the Group revises its estimates of the number of options that are expected to ultimately vest. The impact of the revision of the original estimates during the vesting period, if any, is recognised in profit or loss such that the cumulative expense reflects the revised estimate, with a corresponding adjustment to the share option reserve.

When share options are exercised, the amount previously recognised in share option reserve will be transferred to share premium. When the share options are forfeited after the vesting date or are still not exercised at the expiry date, the amount previously recognised in the share option reserve will be transferred to retained profits.

The measurement policies the Group uses for reporting segment results under HKFRS 8 "Operating Segments" ("HKFRS 8") are the same as those used in its consolidated financial statements prepared under HKFRSs.

In the application of the Group's accounting policies, the directors of the Company are required to make judgements, estimates and assumptions about the carrying amounts of assets and liabilities that are not readily apparent from other sources. The estimates and associated assumptions are based on historical experience and other factors that are considered to be relevant. Actual results differ from these estimates.

The key assumptions concerning the future, and other key sources of estimation uncertainty at the end of the reporting period, that have a significant risk of causing a material adjustment to the carrying amounts of assets and liabilities within the next financial year is set out below.

5.1 Estimated useful lives of property, plant and equipment

The Group determines the estimated useful lives and related depreciation charges for the Group's property, plant and equipment based on the historical experience of the actual useful lives of property, plant and equipment of similar nature and functions. The Group will revise the depreciation charge where useful lives are different to those previously estimated, or it will write-off or write-down technically obsolete or non-strategic assets that have been abandoned or sold.

The Group depreciates the property, plant and equipment in accordance with the accounting policies stated in note 4.3. The estimated useful lives reflect the directors' estimates of the periods that the Group intends to derive future economic benefits from the use of these assets.

5.2 Impairment of trade receivables

The measurement of impairment losses under HKFRS 9 for the trade receivables requires judgement when determining impairment losses.

The Group's loss allowances are based on management's estimate of the lifetime ECL, which is estimated by taking into account the credit loss experience, ageing of overdue receivables, debtors' creditworthiness and repayment history and an assessment of both the current and forecast general economic conditions at the reporting date. Changes in these estimates could have a significant impact on the loss allowance to be recognised or reversed in future years.

5.1 物業、廠房及設備估計使用年期

本集團根據對性質與功能類似之物業、廠房及設備實際使用年期的過往經驗釐定本集團物業、廠房及設備的估計使用年期與相關折舊費。倘使用年期有別於先前估計者，本集團會修訂折舊費或撇銷或撇減已棄置或出售之技術陳舊或非戰略資產。

本集團根據附註4.3所載會計政策折舊物業、廠房及設備。估計使用年期反映董事對本集團擬從使用該等資產獲得未來經濟利益期間的估計。

根據香港財務報告準則第9號對貿易應收款項釐定減值虧損計量須作出判斷。

本集團的虧損撥備以於報告日期管理層經考慮信貸虧損經驗、逾期應收款項的賬齡、債務人的信譽及還款記錄以及對現時及預測整體經濟狀況的評估而對應收款項的存續期預期信貸虧損估計為基準。相關估計的變動可能對未來年度確認或轉回的虧損撥有重大影響。

5.3 Provisions

When there is a probability that an outflow of economic benefits will occur due to a present obligation resulting from a past event, and that amount is reasonably estimate, a corresponding amount of provision is recognised in the consolidated financial statements. However, no provision is recognised for costs that need to be incurred to operate in the future.

5.4 Income taxes

The Group is subject to income taxes in Hong Kong. Significant judgement is required in determining the provision for income taxes. There are many transactions and calculations for which ultimate tax determination is uncertain during the ordinary course of business. The Group recognised liabilities for anticipated tax issues based on estimates of whether additional taxes will be due. Where the final tax outcome of these matters is different from the amounts that were initially recorded, such differences will affect the income tax and deferred tax provision in the period in which such determination is made.

6. SEGMENT INFORMATION

The information reported to the executive directors of the Company, who are the chief operating decision makers for the purpose of resources allocation and assessment of performance, is the financial information of the Group as a whole as reported under HKFRSs. The Group is currently organised into two operating divisions as follows:

On 23 February 2017, the Company has authorised to grant to 6 eligible participants to subscribe for an aggregate of 192,000 shares under the Pre-IPO Share Option Scheme. On the same date, the Company has granted share options to 6 eligible participants to subscribe for an aggregate of 192,000 shares.

The subscription price of a share in respect of any particular share option offered under the Pre-IPO Share Option Scheme shall be equal to the offer price of HK\$0.42 per share.

27. EMPLOYEE RETIREMENT BENEFITS

The Group operates a defined contribution retirement benefits scheme which is registered under the Occupational Retirement Scheme Ordinance (the “ORSO Scheme”) for certain employees, the assets of which are held separately from those of the Group in trustee-administered funds independently. The Group contributes 5% on the employee’s monthly salary to the ORSO Scheme.

The Group also operates a Mandatory Provident Fund Scheme (the “MPF Scheme”) under the Hong Kong Mandatory Provident Fund Schemes Ordinance for employees employed in Hong Kong. The MPF Scheme is a defined contribution retirement plan administered by independent trustees. Under the MPF Scheme, the employers and its employees are each required to make contributions to the plan at 5% of the employees’ relevant income, subject to a cap of monthly relevant income of HK\$30,000. Contributions to the plan vest immediately.

The retirement scheme cost recognised in profit or loss represents contributions paid or payable to the ORSO Scheme and the MPF Scheme by the Group at rates specified in the rule of the respective schemes.

As at 31 March 2022 and 2021, the Group had no significant obligation apart from the contributions as stated above and there is no forfeited contribution arose upon employees leaving the retirement benefit schemes and which were available to reduce contributions payable.

On 9 June 2022, the third reading of a bill for cancelling the Mandatory Provident Fund (“MPF”) offsetting mechanism was passed in the Legislative Council of the Hong Kong Special Administrative Region. After the bill takes effect, the Group can no longer offset employees’ long-service payments against the MPF derived from the employers’ mandatory and voluntary contributions. The offsetting mechanism will be cancelled starting from 2025. The details is yet to be announced by the government and the estimated financial effect cannot be made at the date of this report.

在損益中確認的退休計劃成本指本集團按各計劃規則規定的費率向職業退休保障計劃及強積金計劃支付或應付的供款。

於2022年及2021年3月31日，除上述供款外，本集團並無重大責任，亦並無因僱員退出退休福利計劃而產生的沒收供款，可用於減少應付供款。

於2022年6月9日，香港特別行政區立法會三讀通過取消強制性公積金(「強積金」)對沖機制法案。在相關法案生效後，本集團不能再將僱員的長期服務金與僱主的強制性及自願性供款所產生的強積金進行抵銷。對沖機制將自2025年起取消。具體細節有待政府公佈，於本報告日期，無法對財務影響作出估計。

31. FINANCIAL RISK MANAGEMENT

The Group is exposed to a variety of financial risks through its use of financial instruments in its ordinary course of operations and in its investment activities. The financial risks include credit risk, liquidity risk, interest rate risk and fair value risk.

Financial risk management is coordinated at the Group's headquarter, in close co-operation with the directors. The overall objectives in managing financial risks focus on securing the Group's short to medium term cash flows by minimising its exposure to financial markets.

It is not the Group's policy to actively engage in the trading of financial instruments for speculative purposes. It identifies ways to access financial markets and monitors the Group's financial risk exposure. Regular reports are provided to the directors of the Company.

(b) Credit risk

The Group's credit risk is primarily attributed to its trade and other receivables and cash and bank balances. Management has a credit policy in place and the exposures to these credit risks are monitored on an ongoing basis and follow-up action is taken to recover overdue debts.

The Group has concentration of credit risk with two customers with trade receivables of HK\$52,639,000 (2021: two customers of HK\$44,613,000) as at 31 March 2022.

For trade receivables, the Group reassesses the lifetime expected credit losses at the end of the reporting period to ensure the adequate impairment losses are made for significant increases in the likelihood or risk of default occurring since initial recognition.

The Group applies provision matrix to measure the expected credit losses based on collective assessment. The Group also performs individual assessment for major customers with material outstanding balances as at the end of the reporting period. As at 31 March 2022 and 2021, the expected loss rates applied in the provision matrix are determined with reference to the debtors' shared credit risk characteristics, including background of the customers and their historical payment behaviour, historical actual loss on the trade receivables and information specific to the debtors as well as pertaining to the economic environment in which the debtors operate. Expected loss rates are determined with reference to external credit ratings and benchmarking to similar risk portfolio.

(b) 信貸風險

(c) Liquidity risk

Liquidity risk relates to the risk that the Group will not be able to meet its obligations associated with its financial liabilities. The Group is exposed to liquidity risk in respect of settlement of trade and other payables and its financing obligations, and also in respect of its cash flow management.

The Group's policy is to regularly monitor its liquidity requirements and its compliance with bank covenants, to ensure the Group maintains sufficient reserves of cash and adequate committed lines of funding from major banks and financial institutions to meet its liquidity requirements in the short and longer term.

(d) Interest rate risk

The Group's interest rate risk arises from variable rate bank balances and bank borrowings. Exposure to interest rate risk exists on those balances subject to floating interest rate when there are unexpected adverse interest rate movements. The Group's policy is to manage its interest rate risk, working within an agreed framework, to ensure that there are no unduly exposures to significant interest rate movements and rates are approximately fixed when necessary.

Sensitivity analysis

The sensitivity analysis below has been determined based on the exposure to interest rates for bank borrowings at the end of the year. The analysis is prepared assuming amounts of these financial instruments outstanding at the end of the year were outstanding for the whole year. A 50 basis points increase or decrease in the prevailing rates of relevant banks is used when reporting interest rate risk internally to key management personnel and represents management's assessment of the reasonably possible change in interest rates.

If the interest rates had been 50 basis points higher/lower for variables rate bank borrowings, with all other variables were held constant, the Group's post-tax profit for the year would decrease/increase by approximately HK\$17,000 (2021: HK\$23,000).

No sensitivity analysis of bank balances of the Group is presented as the interest income from bank balances is negligible.

(e) Fair value risk

The directors of the Company consider that the carrying amounts of financial assets and financial liabilities recorded at amortised cost in the Group's financial statements approximate to their fair values.
