DISCLOSEABLE TRANSACTION ENTERING INTO OF A LEASE AGREEMENT

The Board announces that on 6 July 2022, Bright Gain, a wholly-owned subsidiary of the Company, as tenant, entered into the Lease Agreement with the Landlord which gives Bright Gain the right to use the Property for operation of a casual Cantonese restaurant for 6 years with effect from 1 September 2022 at a monthly rental of HK\$200,000 for the first three years and HK\$230,000 for the subsequent three years.

Pursuant to HKFRS16, the Company needs to recognize the right to use the Property as an acquisition of asset and as one of the applicable percentage ratios in respect of the rental payable under the Lease Agreement is more than 5% but below 25%, the entering into of the Lease Agreement constitutes a disclosable transaction for the Company under the Listing Rules. Hence, it is subject to the notification and announcement requirements but exempt from shareholders' approval requirement pursuant to Chapter 14 of the Listing Rules.

The Board announces that on 6 July 2022, Bright Gain, a wholly-owned subsidiary of the Company, as tenant, entered into the Lease Agreement with the Landlord which details are set out below.

THE LEASE AGREEMENT

Parties:	(1) Supermercado Royal, Companhia Limitada, as the Landlord; and (2) Bright Gain, a wholly-owned Macau subsidiary of the Company, as the Tenant.
Property:	Na Taipa, Rua De Nam Keng N° 614-622, Hong Cheong (Blocos 1,2,3) Rés-do-chão M&N, also known as 氹仔,南京街614-622號 雄昌花園(第一,二,三座)地下M座及N座
Term:	A period of 6 years with effect from 1 September 2022
Gross floor area:	approximately 248.4 square metres
Rental:	The Tenant is required to pay to the Landlord a rent of HK\$200,000 per month for the first three years and HK\$230,000 per month for the subsequent three years, payable on the first day of each calendar month
Rent free period:	Three months from 1 September 2022 to 30 November 2022
Deposit:	The Tenant is required to place with the Landlord a security deposit of HK\$400,000

RIGHT-OF-USE ASSETS

The above amount is calculated with reference to the present value of the aggregate lease payments including stamp duty and estimated reinstatement costs and based on a discount rate of 5.89%.

REASON OF AND BENEFIT FOR ENTERING INTO THE LEASE AGREEMENT

The Group has been operating a casual Cantonese restaurant “Good Fortune Kitchen” in a residential district in the Flower City, Cotai, Macau which targets local Macau residents since 2017. The second branch of “Good Fortune Kitchen” at The Praia is under renovation and is scheduled to commence business in the second half of 2022. In view of the growing demand and popularity of the cuisine and brand recognition, the Group plans to open another branch of “Good Fortune Kitchen” at Rua De Nam Keng, which is located in a residential district in Taipa. The Board believes that the entering into of the Lease Agreement would generate stable turnover to the Group.

The rental terms under the Lease Agreement have been determined after arm’s length negotiation between the parties and with reference to the prevailing market rent of similar properties in the nearby area. The Directors considered that the transaction contemplated under the Lease Agreement is in the ordinary and usual course of business of the Group, the terms of the Lease Agreement are on normal commercial terms and have been on an arm’s length basis between the parties, and the terms of the Lease Agreement are fair and reasonable and in the interests of the Company and the Shareholders as a whole.

INFORMATION OF THE COMPANY, THE TENANT AND THE LANDLORD

Information of the Company and the Tenant

The Company is principally engaged in the sales of food and catering, food souvenir and property investment business. Bright Gain, a company incorporated in Macau with limited liability and a wholly-owned subsidiary of the Company. Bright Gain is principally engaged in the operation of restaurants and food court counters.

Information of the Landlord

The Landlord is a company incorporated in Macau with limited liability and ultimately owned by two individual Macau residents, Chang Lok Wai and Chang Lok Meng. To the best of the Directors’ knowledge, information and belief having made all reasonable enquiry, the Landlord is principally engaged in property investment business, and it and its ultimate beneficial owner(s) are Independent Third Parties.
