If you do not complete the reply form and return it to the Hong Kong Branch Share Registrar at the address indicated above by 19 August 2022, you are deemed to have elected Website Version only, and a notification letter of the publication of the Corporate Communications on website will be sent to you. If an email address is provided by you in the reply form, an electronic version of the notification of the publication of the Corporate Communications on website will be sent to you.

You have the right at any time to change the choice of language and/or means of receipt of the Corporate Communications by reasonable prior notice in writing to the Hong Kong Branch Share Registrar by post or by e-mail at huayininternational-ecom@hk.tricorglobal.com.
