In order to be valid, this form of proxy together with the power of attorney or other authority (if any) under which it is signed, or a notarially
- 6. certified copy of such power of attorney authority, must be deposited at the Company's branch share registrar in Hong Kong, Computershare Hong Kong Investor Services Limited, at 17M Floor, Hopewell Centre, 183 Queen's Road East, Wanchai, Hong Kong, not less than 48 hours before the time for holding the meeting (i.e. no later than 11:00 a.m. on Wednesway, 24 August 2022. The completion and return of the form of proxy shall not preclude shareholders of the Company from attending and voting in person at the above meeting (or any adjourned meeting thereof) if they so wish. A proxy needs not be a shareholder of the Company.
- As there is a delay in the publication of the audited consolidated financial statements of the Company and its subsidiaries and the reports of the directors and auditor of the Company for the year ended 31 December 2021, the ordinary business of "to receive, consider and adopt the audited consolidated financial statements of the Company and its subsidiaries and the reports of the directors of the Company and auditor of the Company for the year ended 31 December 2021" will not be considered at the Meeting, and will be transacted in an adjourned annual general meeting to be held subject to further notice.
