**PARTIAL REPURCHASE AND CANCELLATION OF US\$280 MILLION
1.00 PER CENT GUARANTEED CONVERTIBLE BONDS DUE 2025
ON THE OPEN MARKET

Reference is made to the announcements (the “**Announcements**”) of Viva Biotech Holdings (the “**Company**”) dated December 18, 2020 and December 30, 2020 regarding the issuance of the US\$280 million 1.00 per cent guaranteed convertible bonds by Viva Biotech Investment Management Limited (a wholly-owned subsidiary of the Company) due 2025 (the “**Convertible Bonds**”), unless otherwise defined, capitalized terms used in this announcement have the same meanings as those defined in the Announcements.

The Company hereby announces that between January 24, 2022 and July 29, 2022, the Company has repurchased an aggregate principal amount of US\$30,000,000 of the Convertible Bonds (the “**Repurchased Convertible Bonds**”) with the rights to convert into 19,984,274 shares of the Company, representing approximately 10.71% of the aggregate principal amount of the Convertible Bonds originally issued. The board of directors of the Company (the “**Board**”) considered that there will be no material impact on the financial position of the Company as a result of the aforesaid repurchase of the Repurchased Convertible Bonds. The Board believes that the repurchase and subsequent cancellation of the Repurchased Convertible Bonds reflects the Company’s confidence in its long-term business prospects and could also enhance the return to the shareholders of the Company.

The Company expects to cancel the Repurchased Convertible Bonds as soon as possible. Immediately after the cancellation, an aggregate principal amount of US\$250,000,000 of the Convertible Bonds will remain outstanding.

Pursuant to Rule 37.48(a) of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited, the Company will make a further announcement for every subsequent 5% interval of the initial aggregate principal amount of the Convertible Bonds that have been redeemed or cancelled in accordance with the terms and conditions of the Convertible Bonds.

Holders of the Convertible Bonds and other securities of the Company as well as potential investors should exercise caution when dealing in securities of the Company.
