IF YOU WISH TO ABSTAIN FROM VOTING ON THE RESOLUTION, PLEASE PLACE A “✓” IN THE BOX MARKED “ABSTAIN”.** If the form returned is duly signed but without specific direction on the proposed resolution, the proxy is entitled to vote or abstain at his/her discretion in respect of the resolution; or if in respect of the proposed resolution there is no specific direction, the proxy is entitled, in relation to the proposed resolution, to vote or abstain at his/her discretion. A proxy will also be entitled to vote at his/her discretion on the resolution properly put to the Domestic Share Class Meeting other than those set out in the notice convening the Domestic Share Class Meeting. The shares abstained will be counted in the calculation of the required majority.

This form of proxy must be signed by you or your attorney duly authorised in writing or, in the case of a legal person, must either be executed under seal or under the hand of legal representative or an attorney duly authorised to sign the same. If this form of proxy is signed by an attorney of the appointer, the power of attorney authorising that attorney to sign, or other document of authorisation, must be notarised.
6. Where there are joint holders of any shares, the one whose name stands first in the register of members shall alone be entitled to attend and vote at the Domestic Share Class Meeting in respect of such shares.

In order to be valid, this form of proxy together with any power of attorney or other documents of authorisation (if any) must be deposited at the registered office of the Bank at No. 109 Beizhan Road, Shenhe District, Shenyang, Liaoning Province, the PRC not later than 24 hours before the time of the Domestic Share Class Meeting or any adjournment thereof.
